(57) **CLAIM**

I claim the ornamental design for a brim clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a brim clip in accordance with the present disclosure.

FIG. 2 is a rear elevation view of the brim clip depicted in FIG. 1.

FIG. 3 is a top plan view of the brim clip depicted in FIG. 1.

FIG. 4 is a bottom plan view of the brim clip depicted in FIG. 1.

FIG. 5 is a side elevation view of the brim clip depicted in FIG. 1.

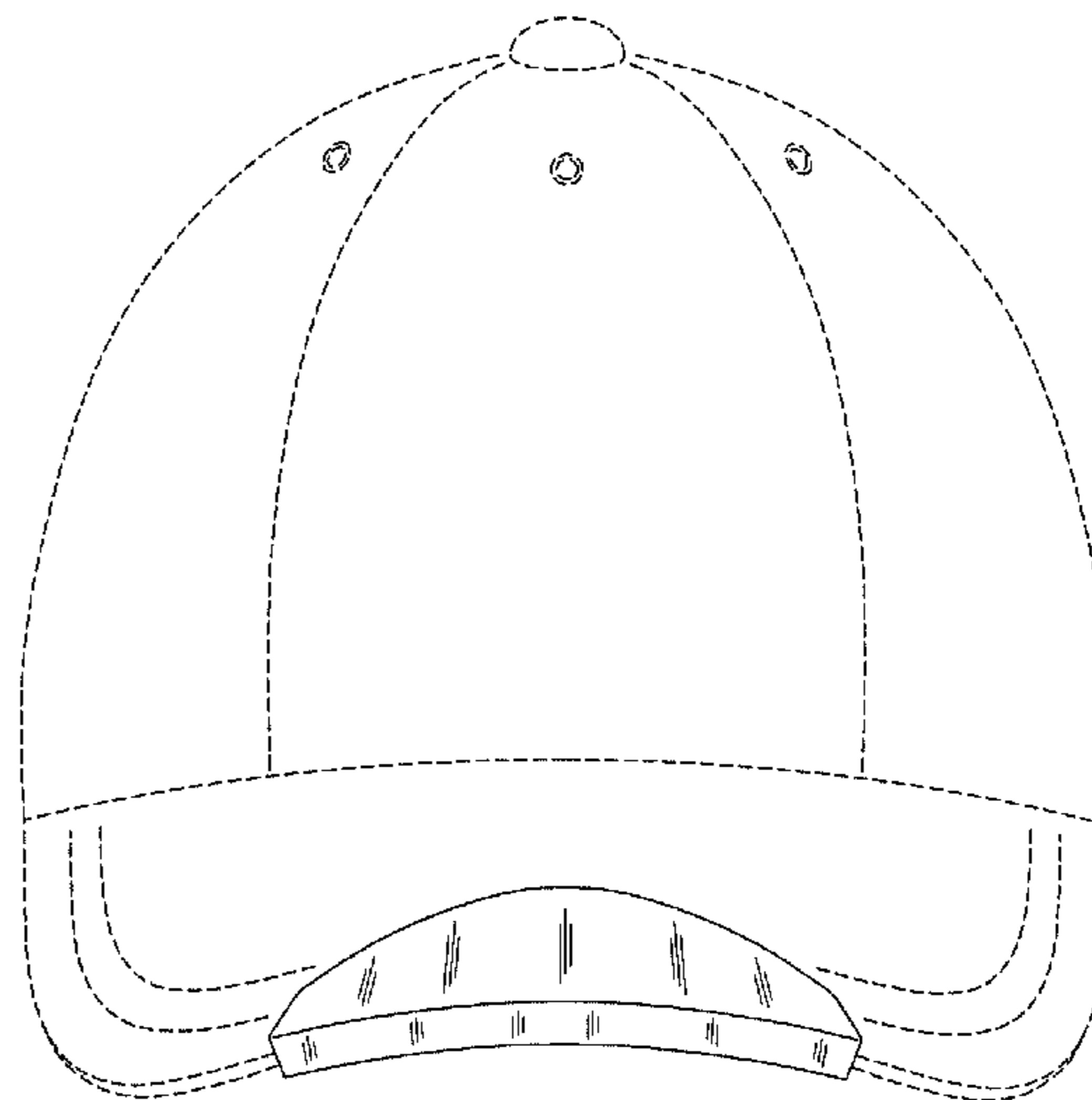
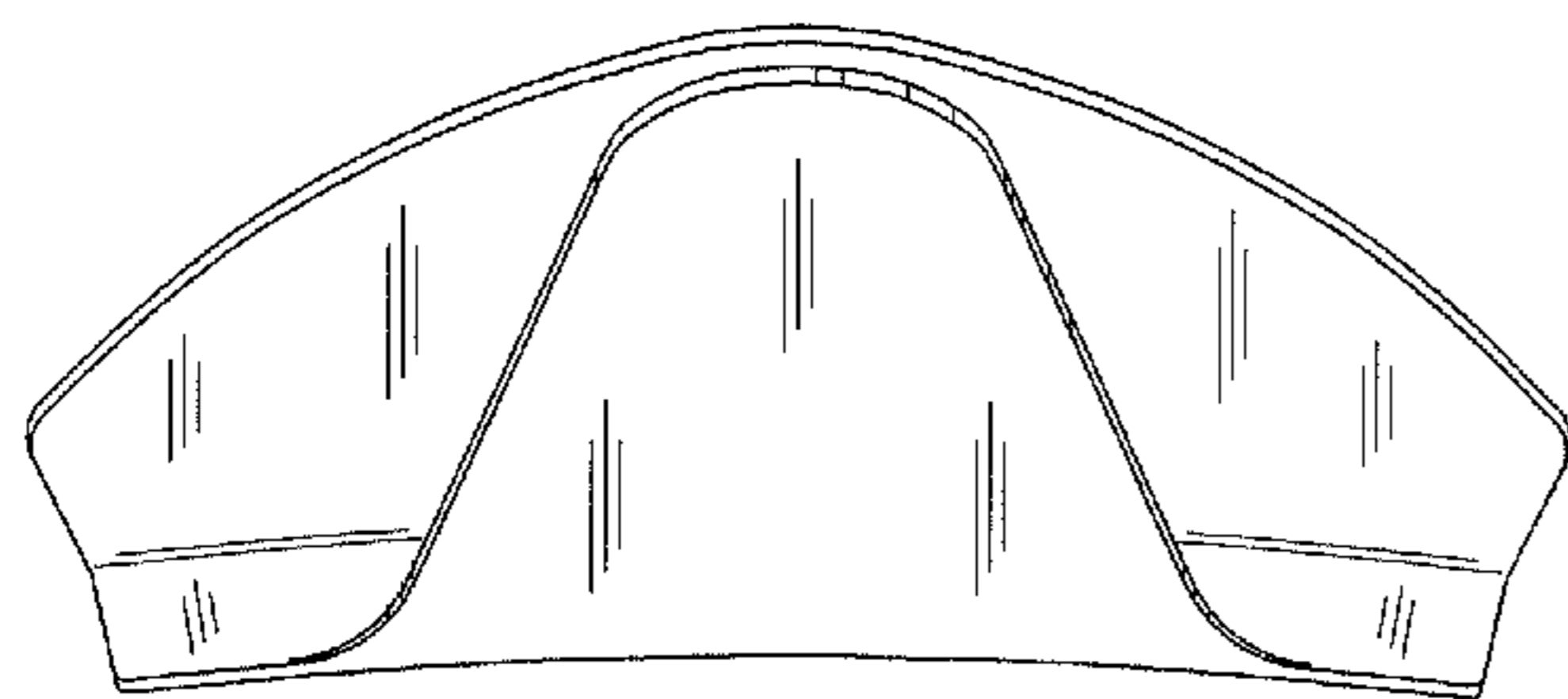
FIG. 6 is a top perspective view of the brim clip depicted in FIG. 1.

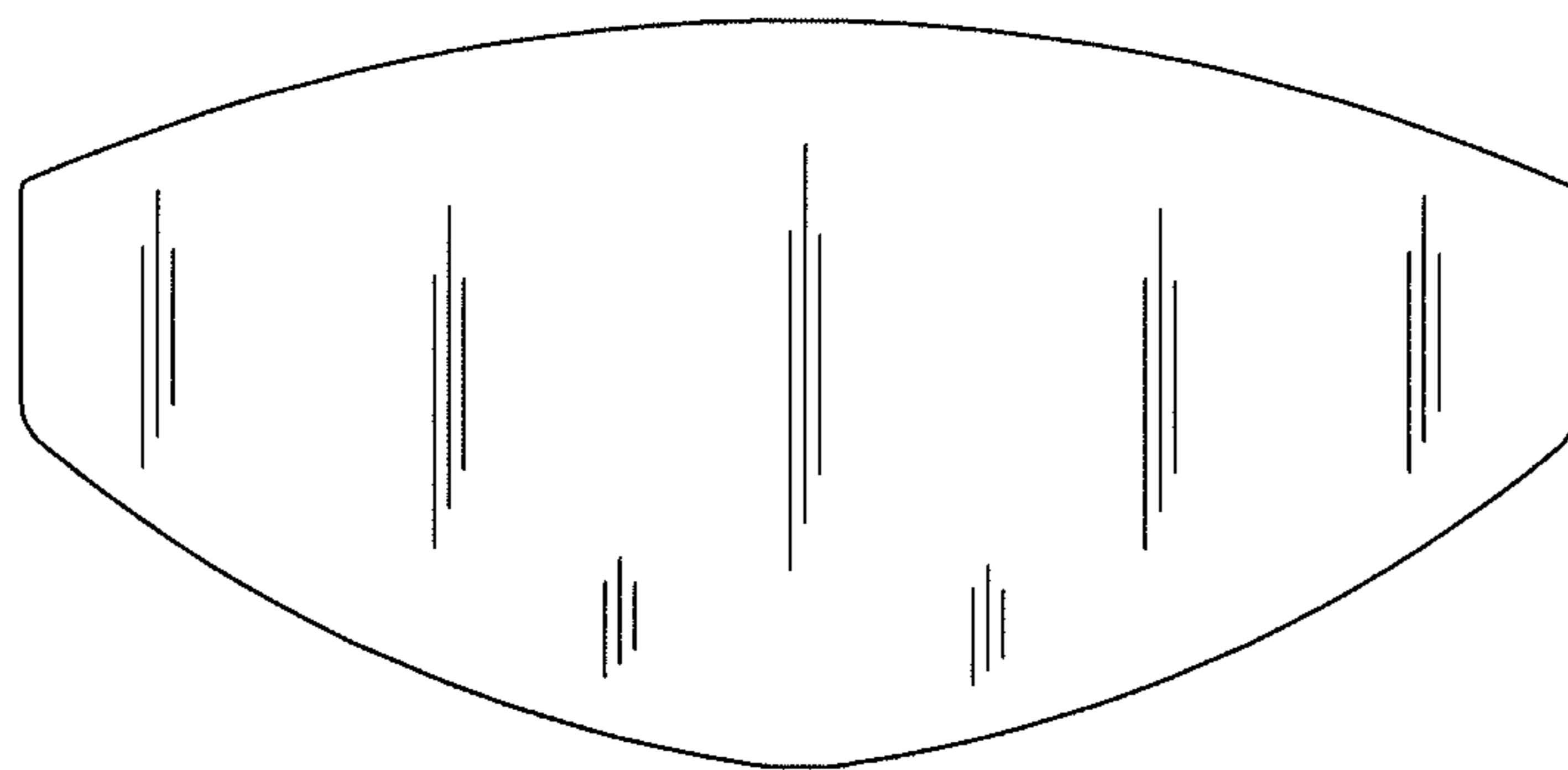

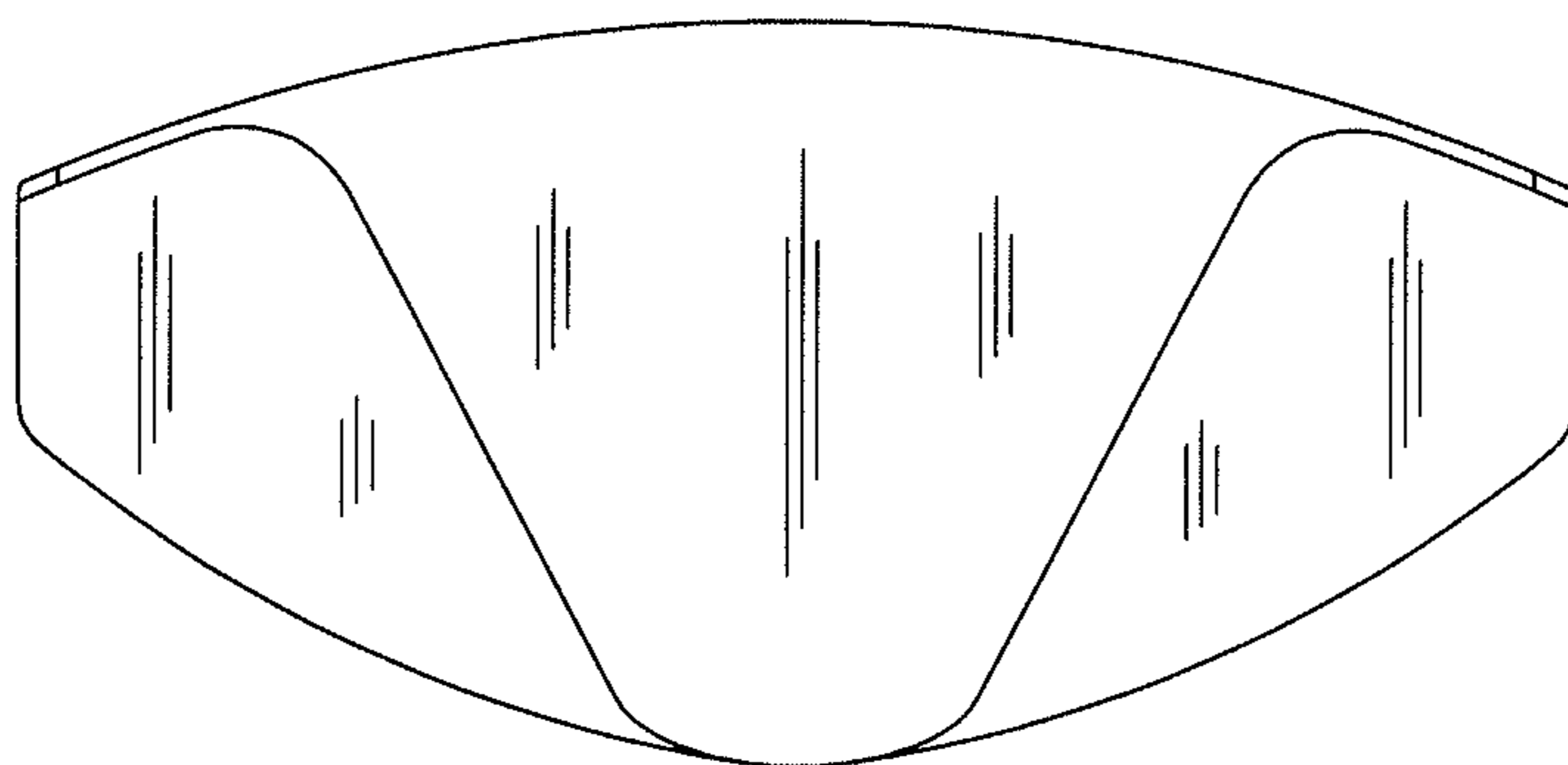

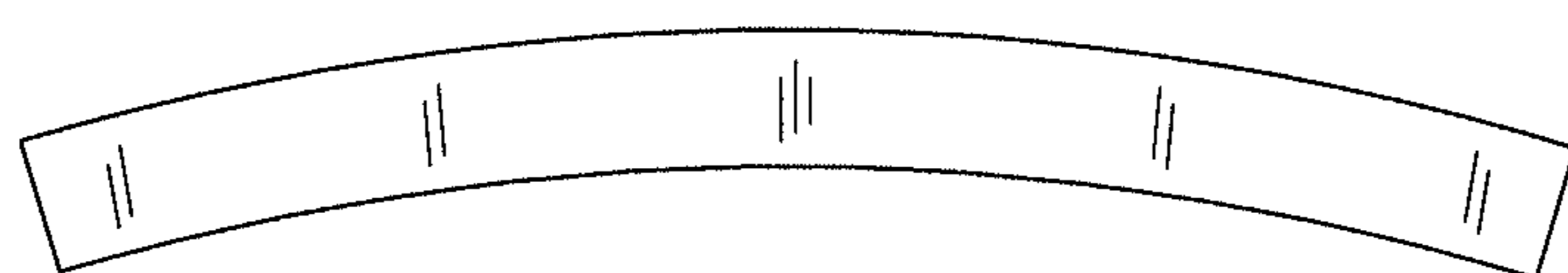

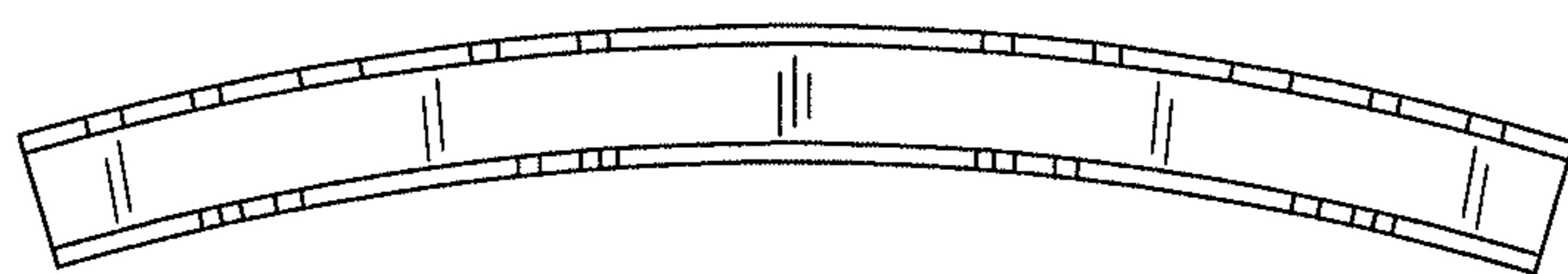

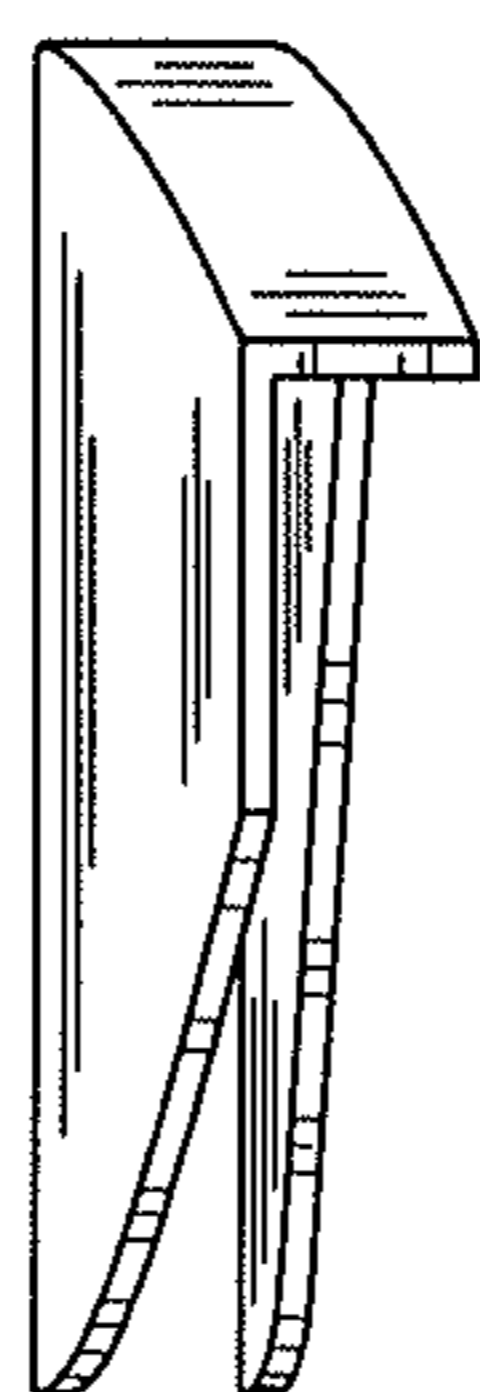

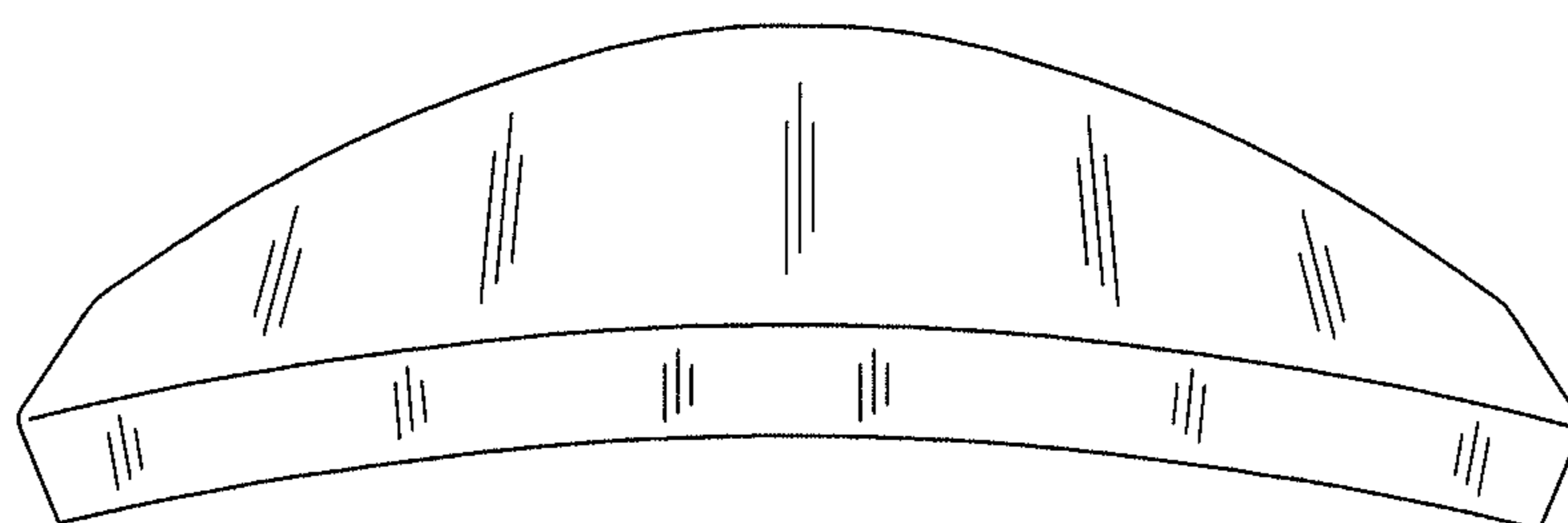

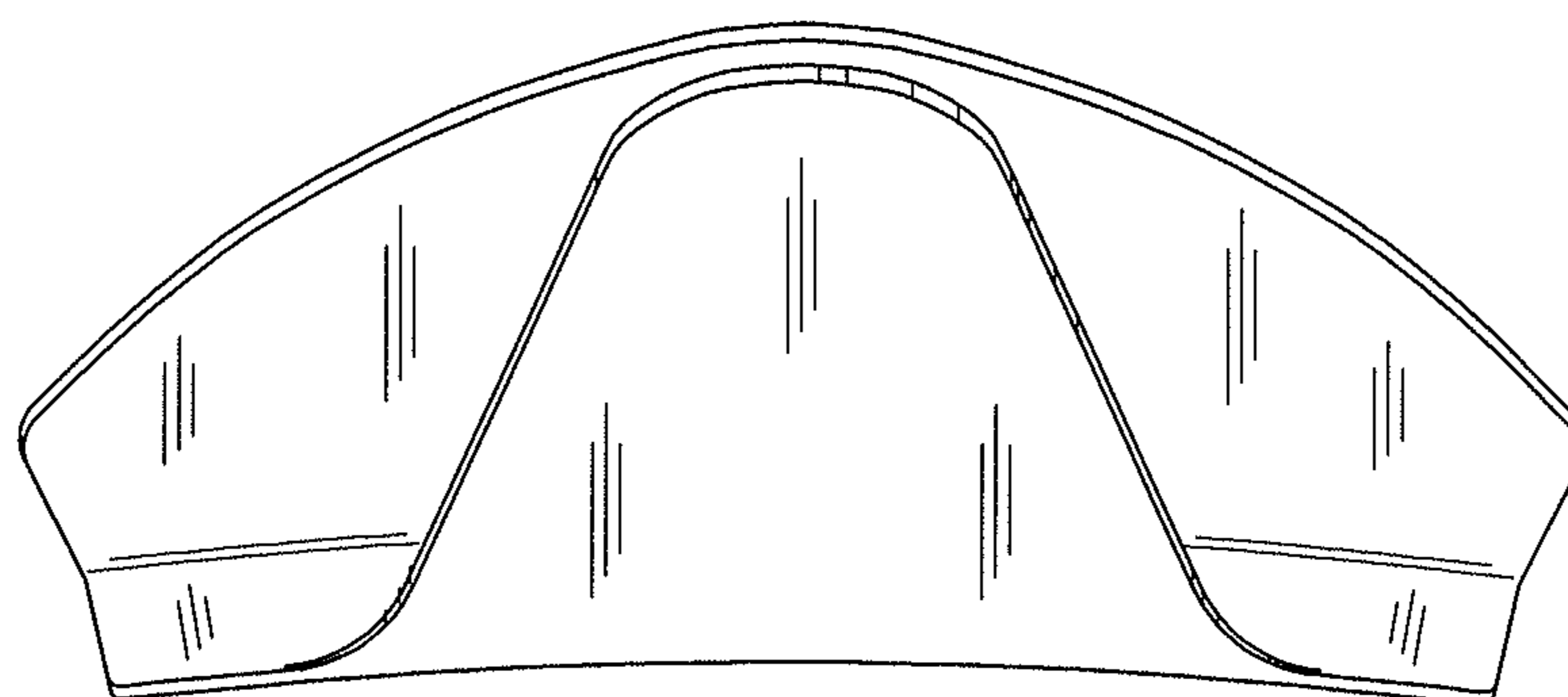

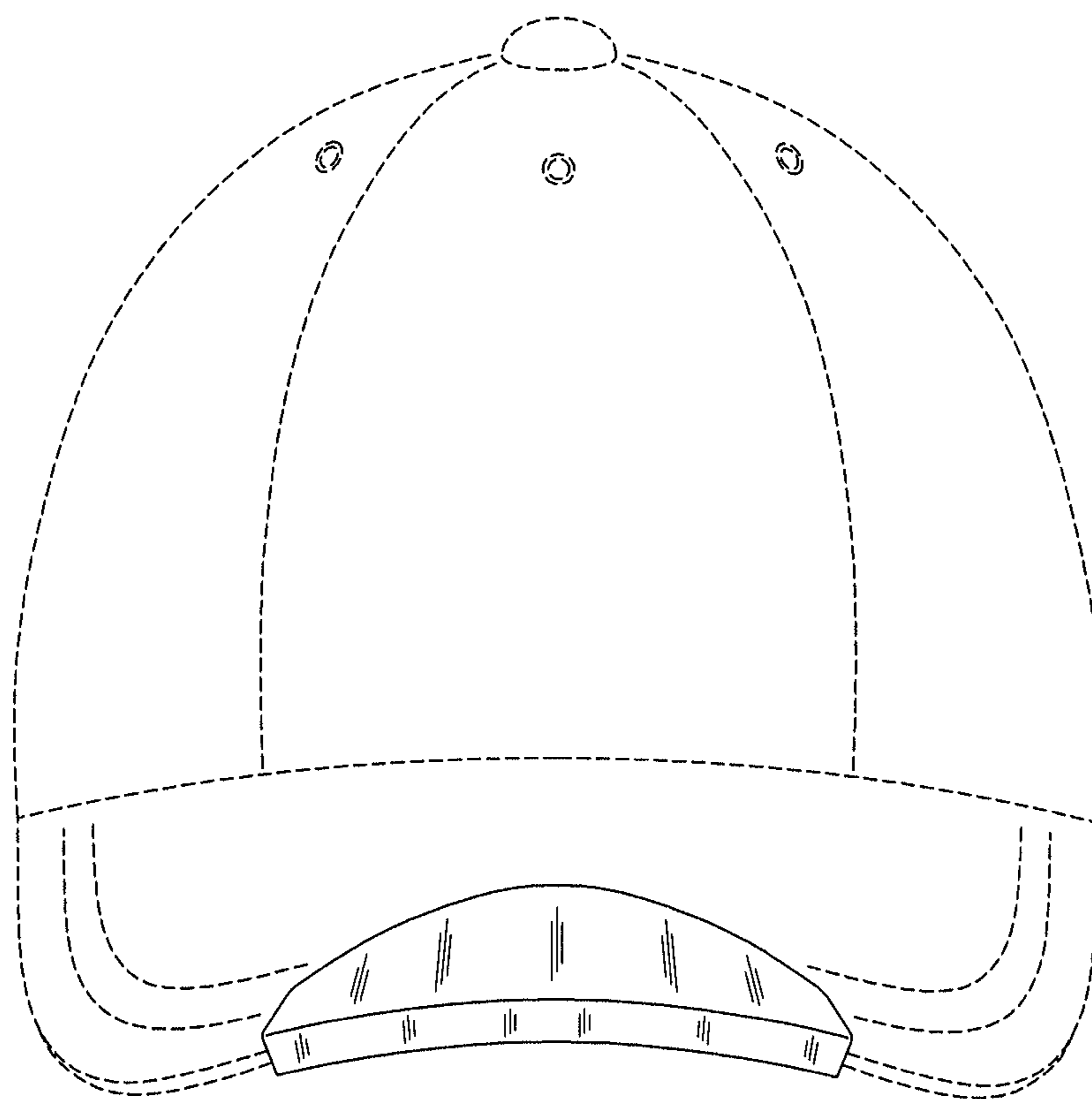
