(57) **CLAIM**

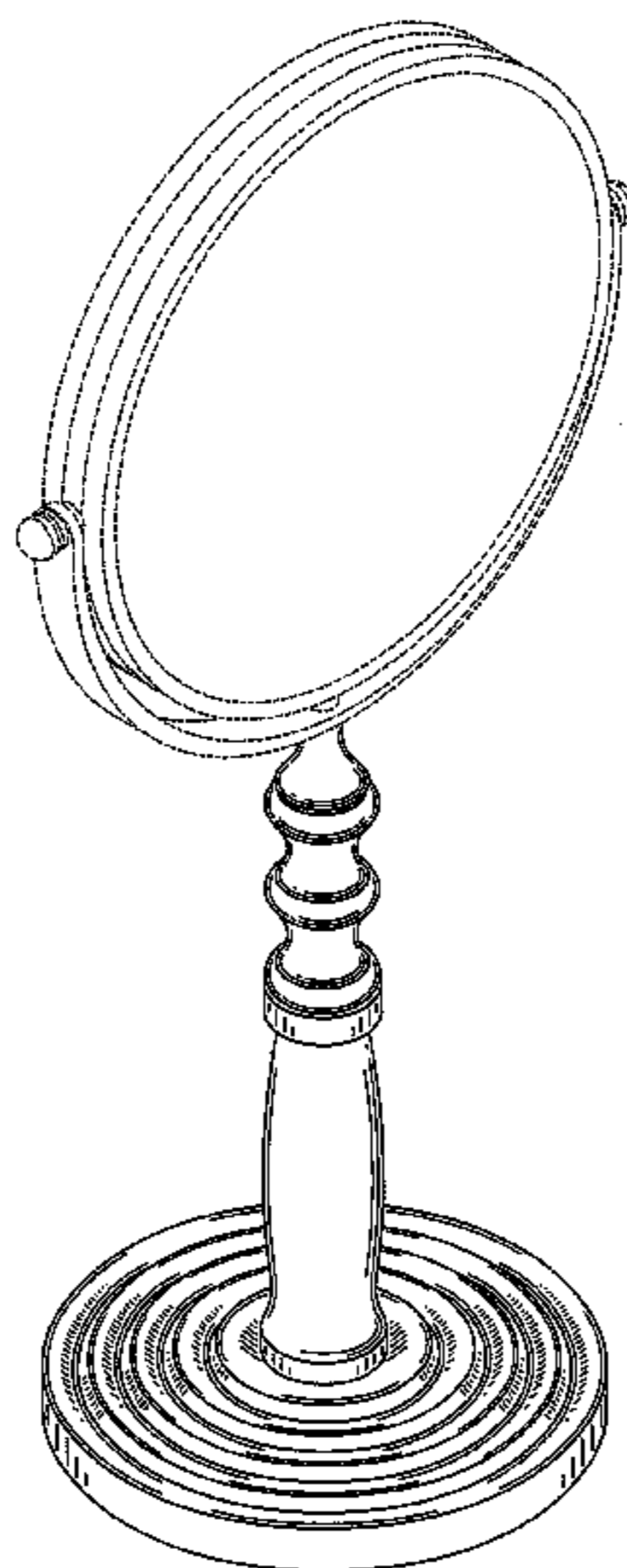
The ornamental design for a stand portion of a foldable mirror, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the present design; FIG. 2 is a front view of the present design; FIG. 3 is a rear view of the present design; FIG. 4 is a left side view of the present design, the right view of the present design being a mirror image thereof. FIG. 5 is a top view of the present design; FIG. 6 is a bottom view of the present design; and, FIG. 7 is a sectional view taken along a line 7-7 indicated in FIG. 5.

The broken lines shown are included for the purpose of illustrating environmental structure of the stand portion of a foldable mirror that forms no part of the claimed design.

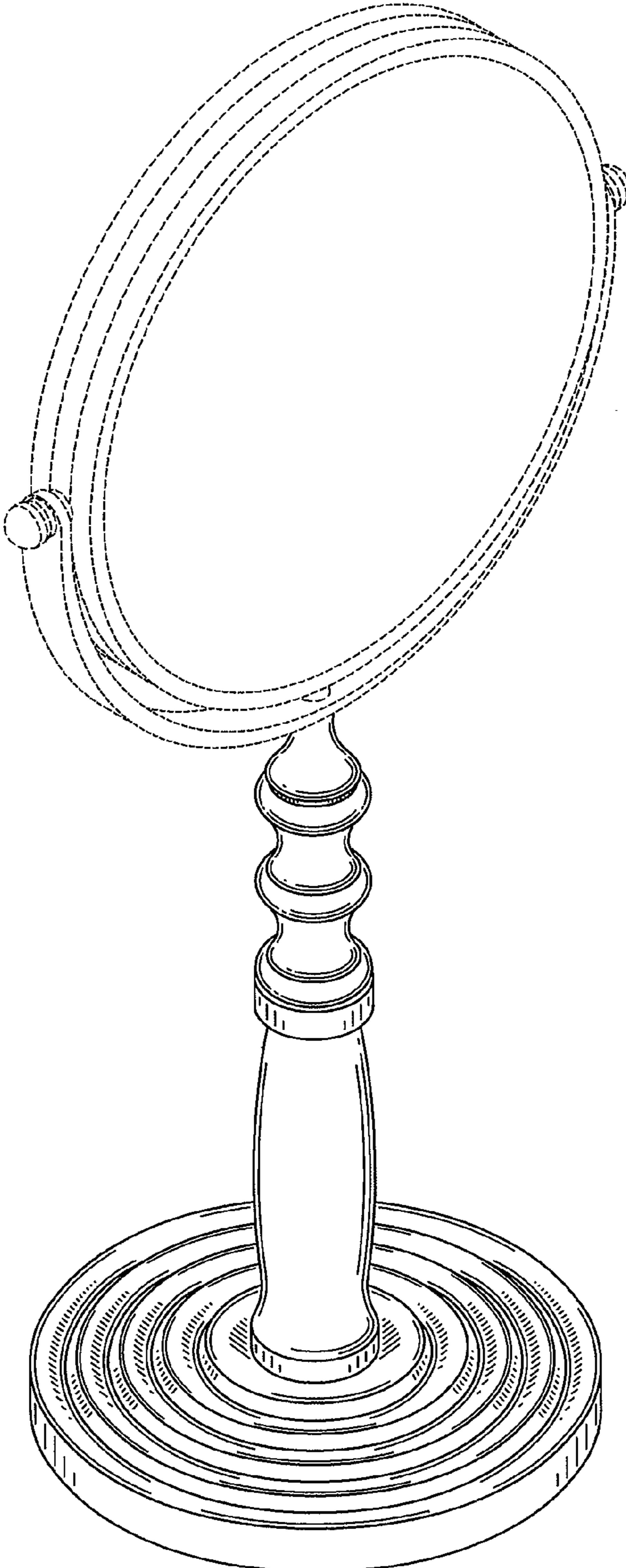

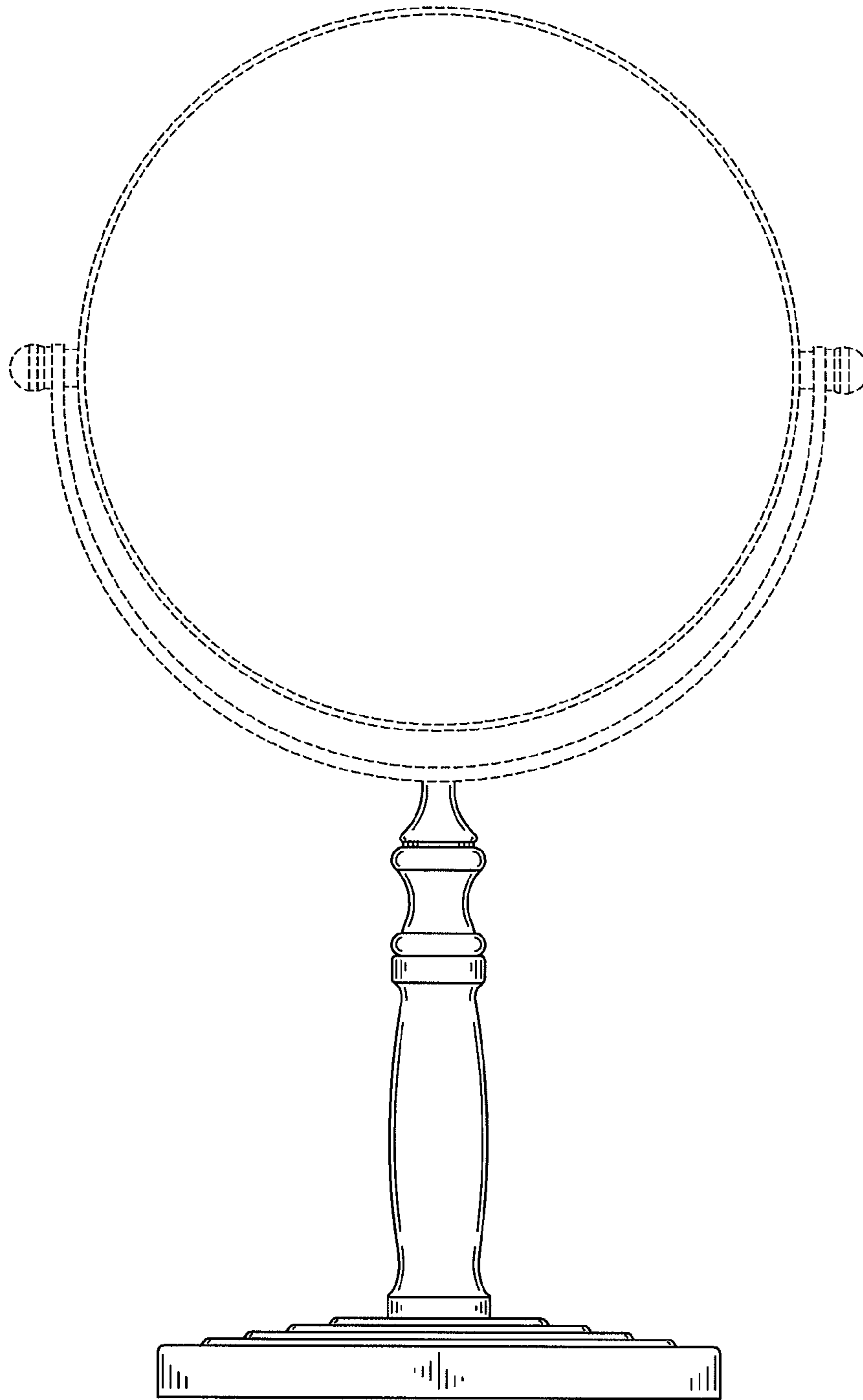

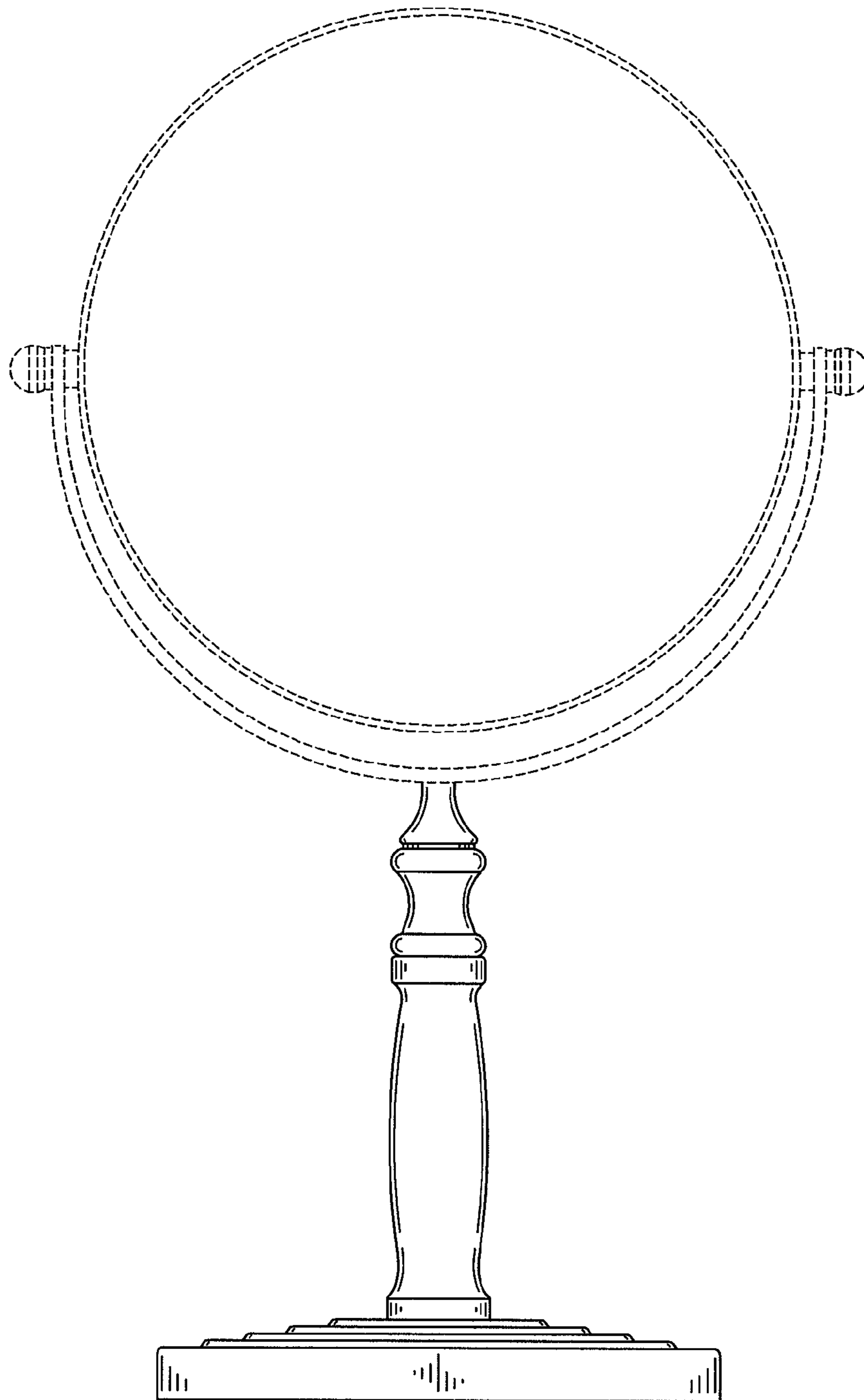

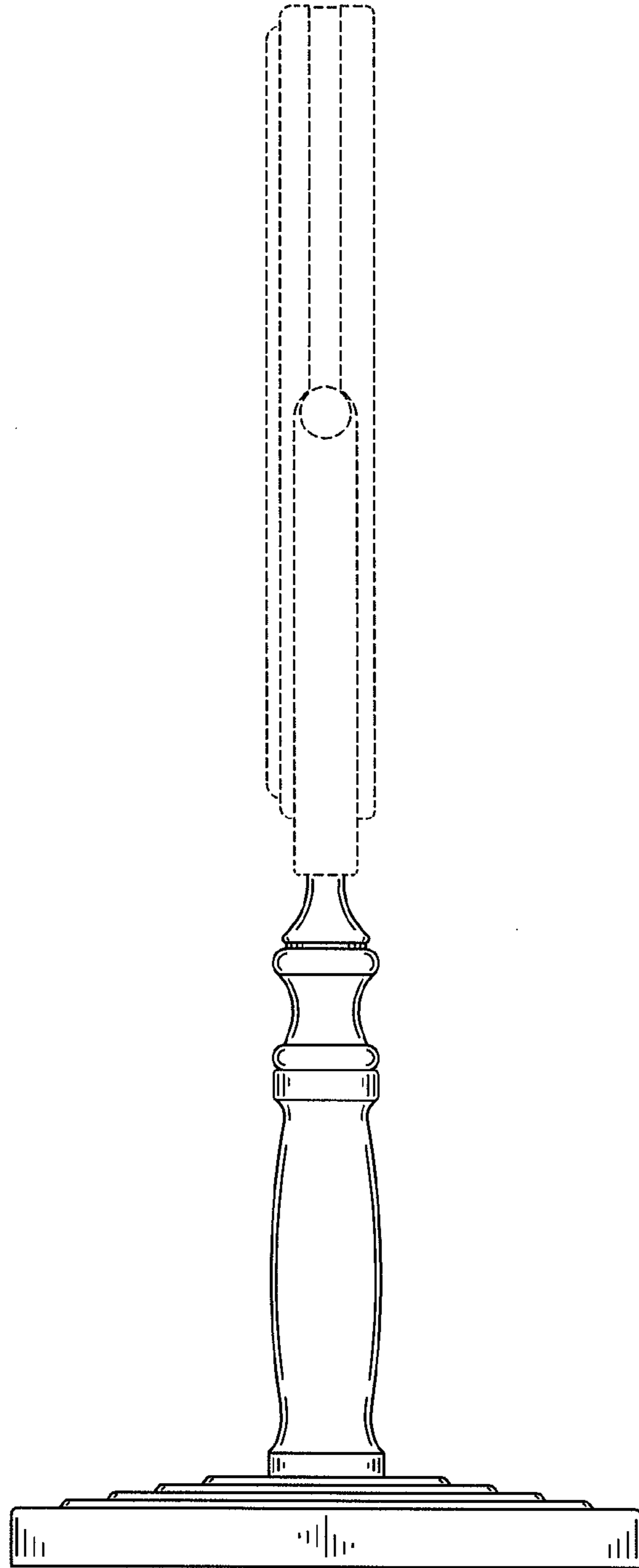

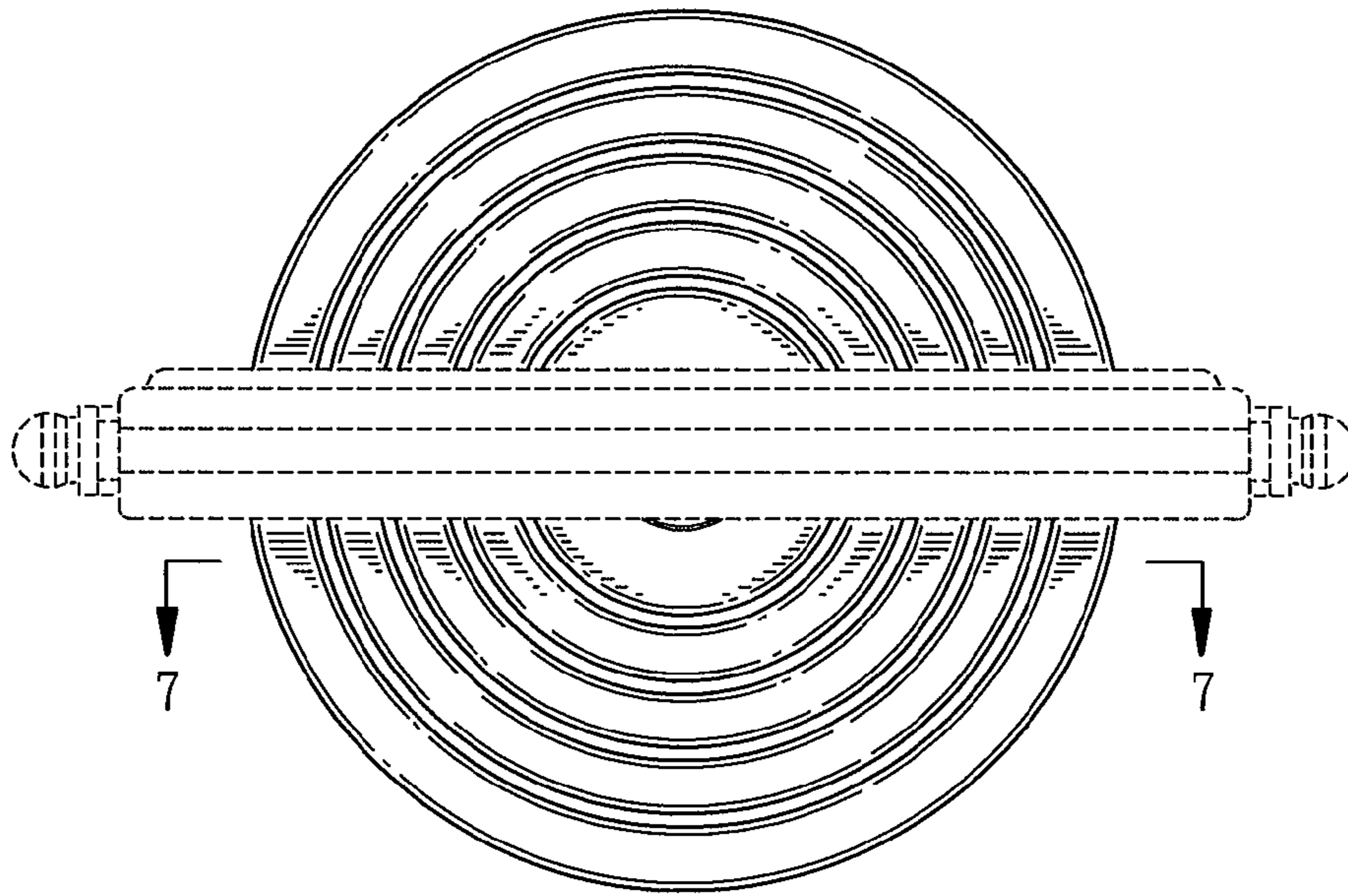

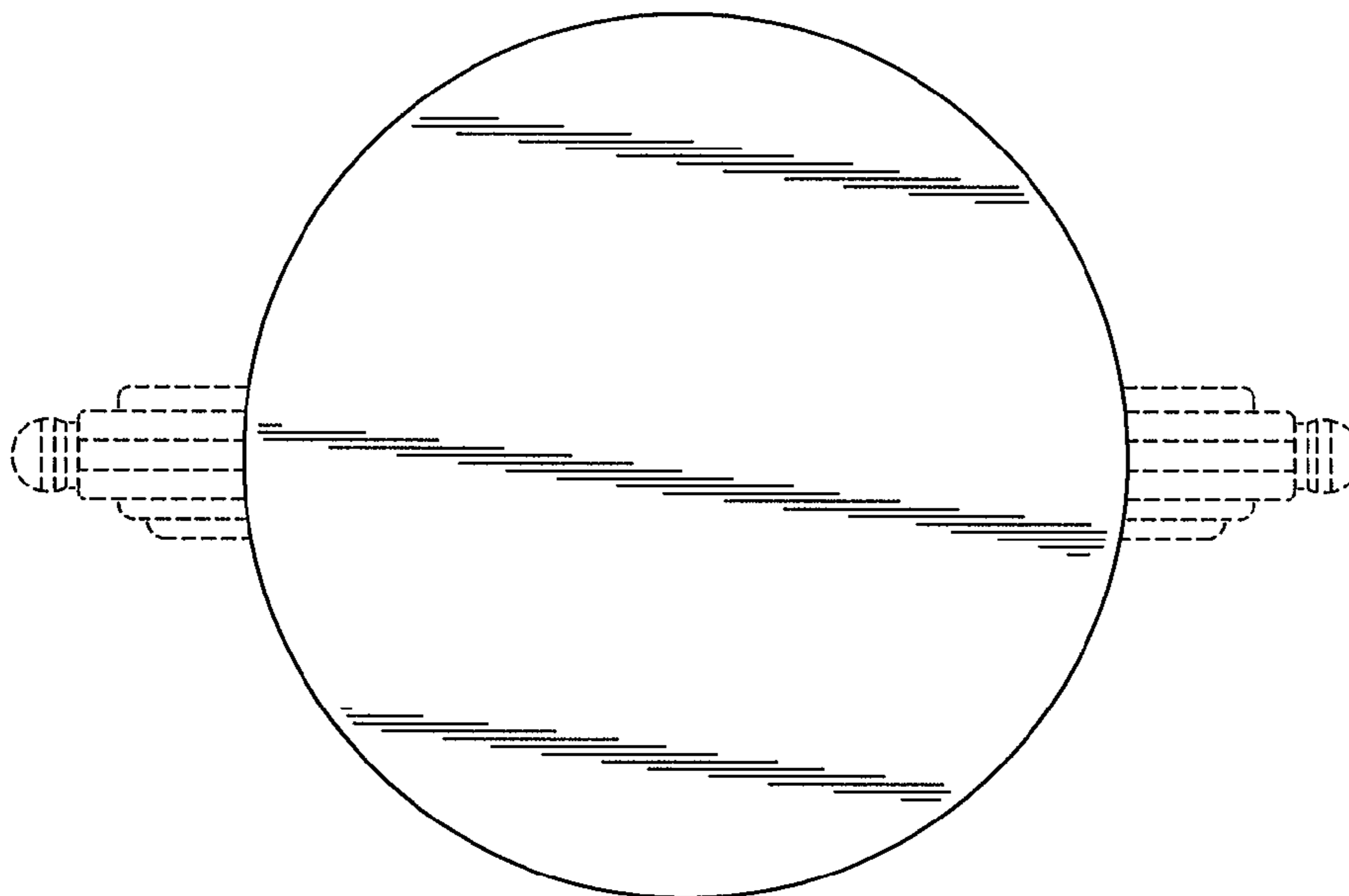

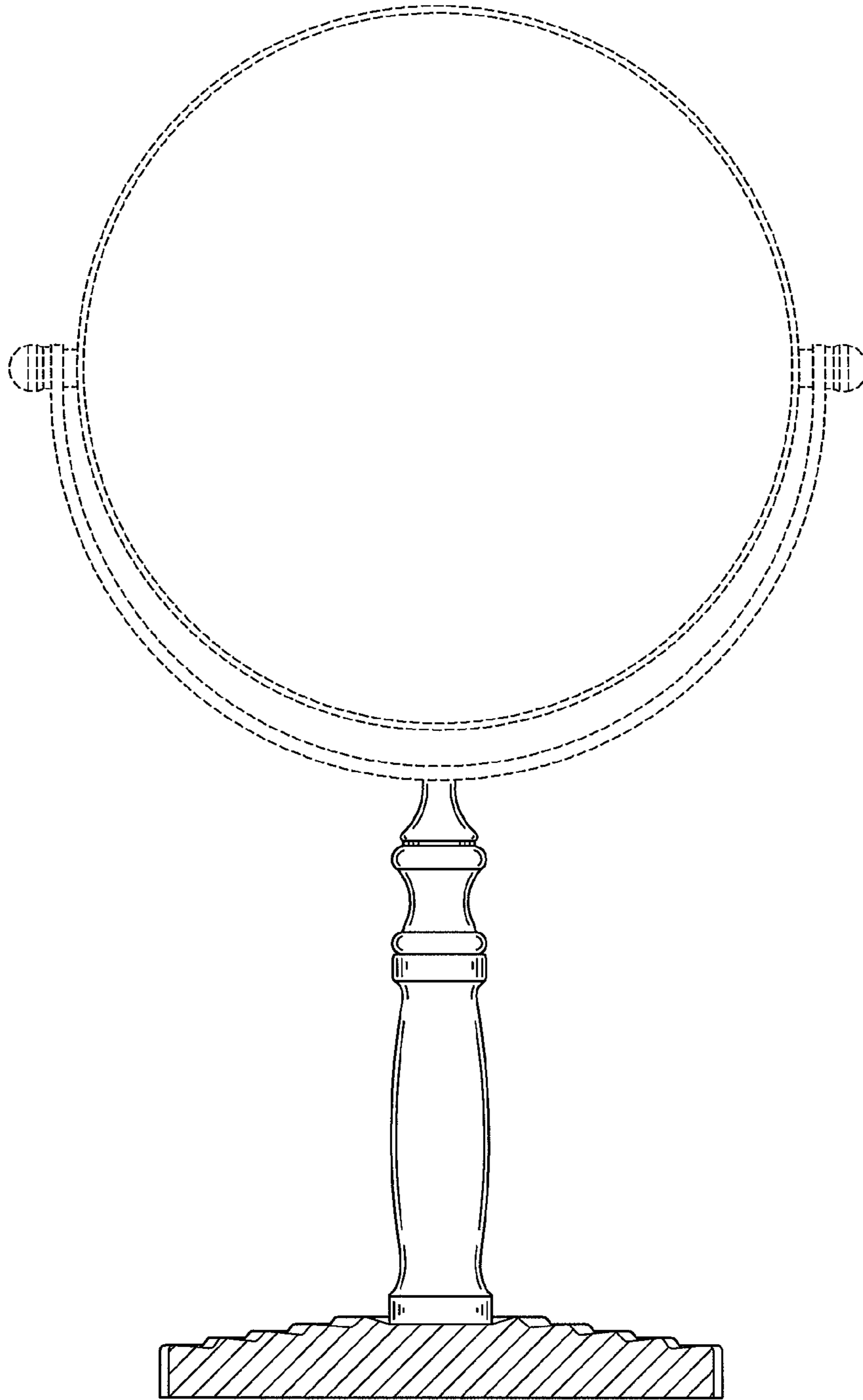
