The ornamental design for beverageware, as shown and described.

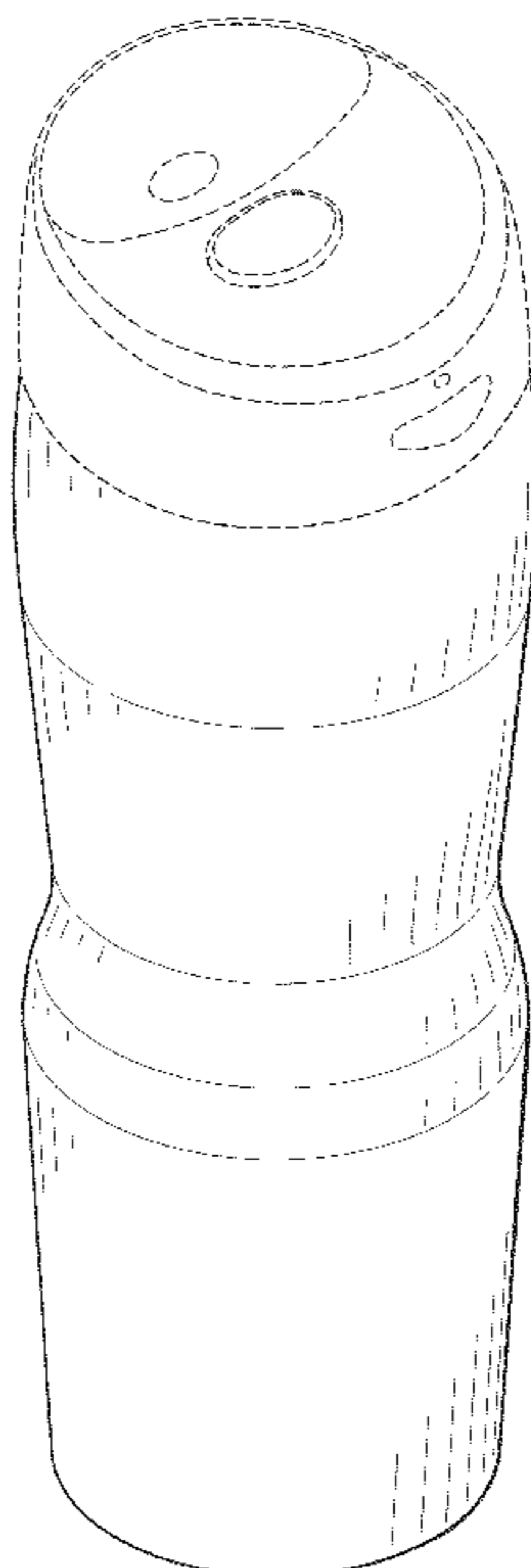
**DESCRIPTION**

FIG. 1 is a perspective view of the beverageware showing my new design with an exemplary lid;  
 FIG. 2 is a perspective view thereof with the exemplary lid of the beverageware removed;  
 FIG. 3 is a front view thereof, the rear, left-side, and right-side views forming a mirror image thereof;  
 FIG. 4 is a top view thereof; and,  
 FIG. 5 is a bottom view thereof.  
 The broken lines illustrate portions of the beverageware and form no part of the claimed design.

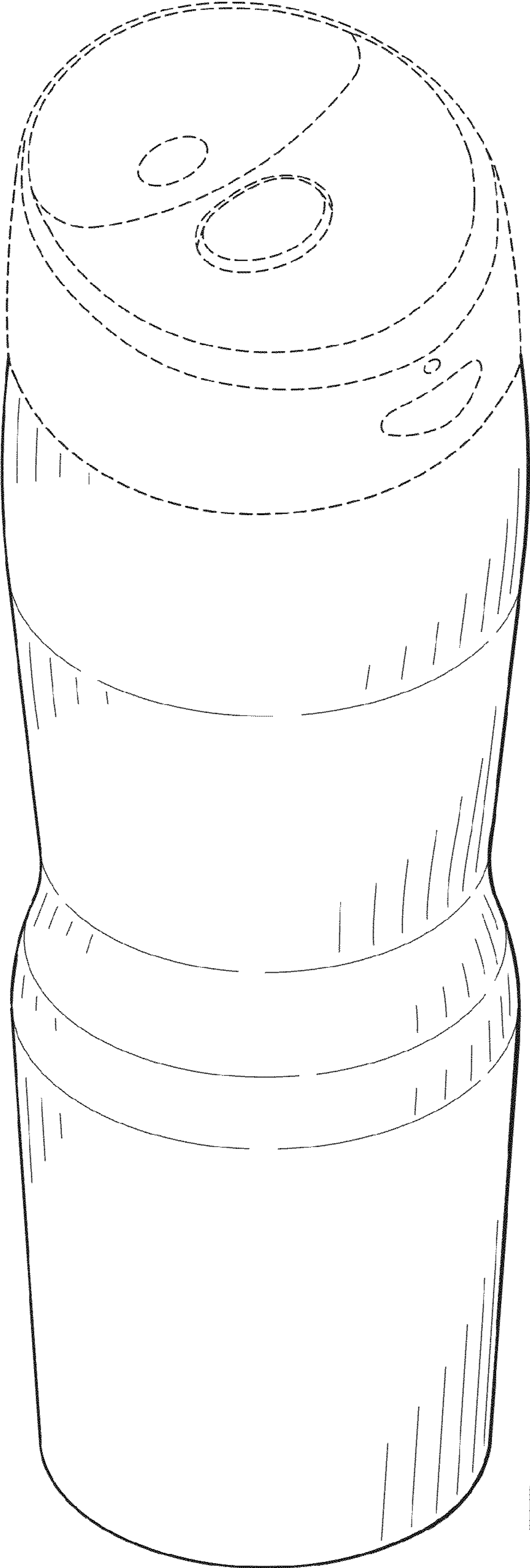

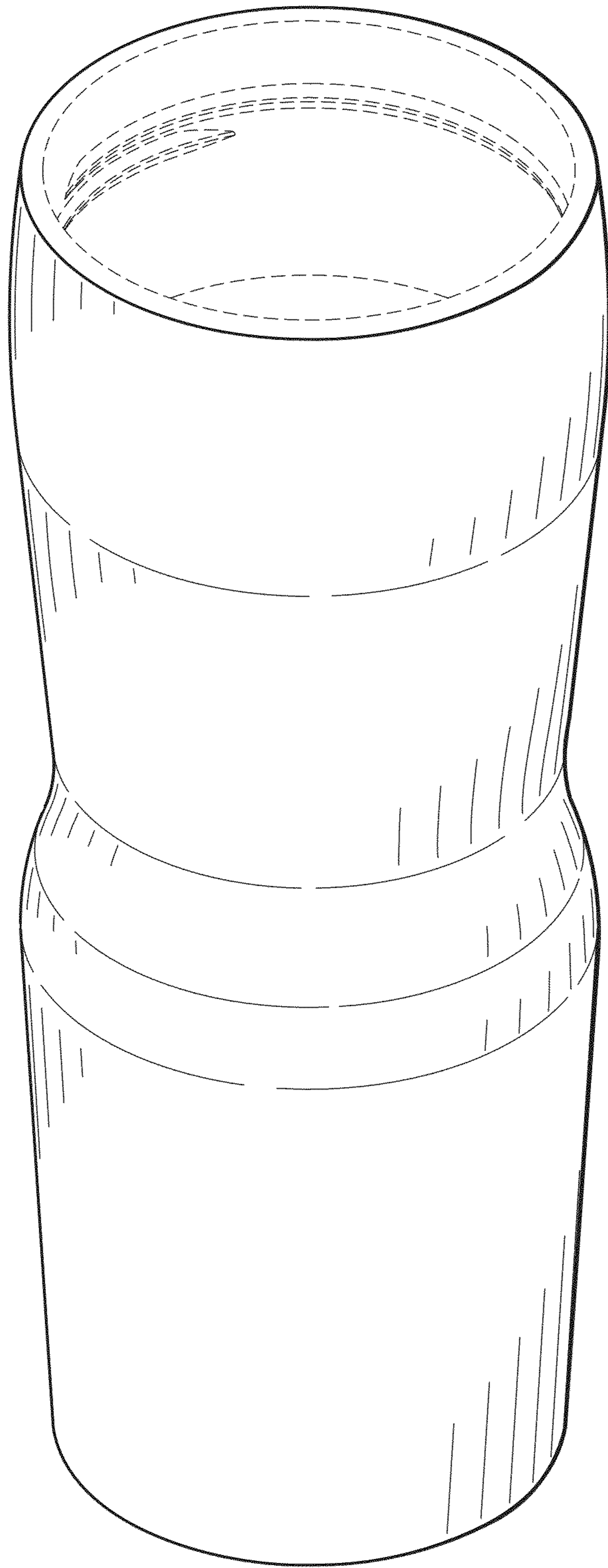

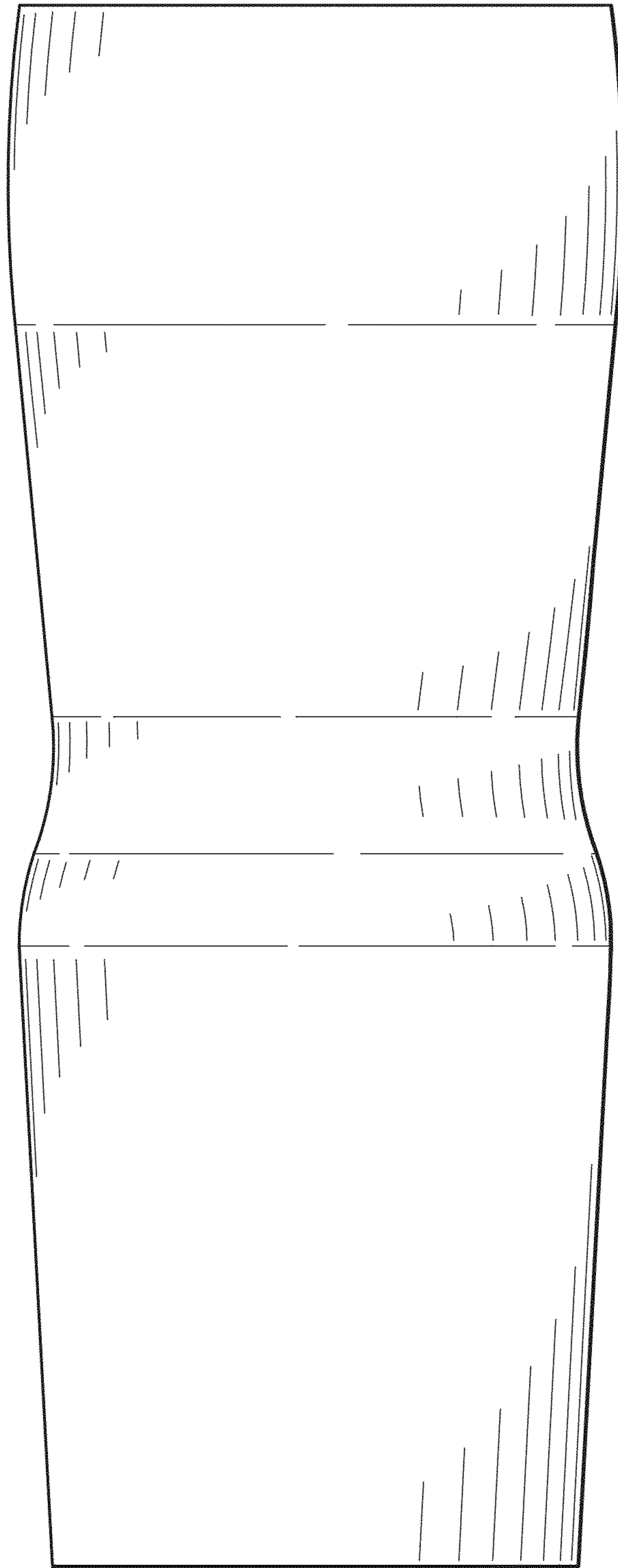

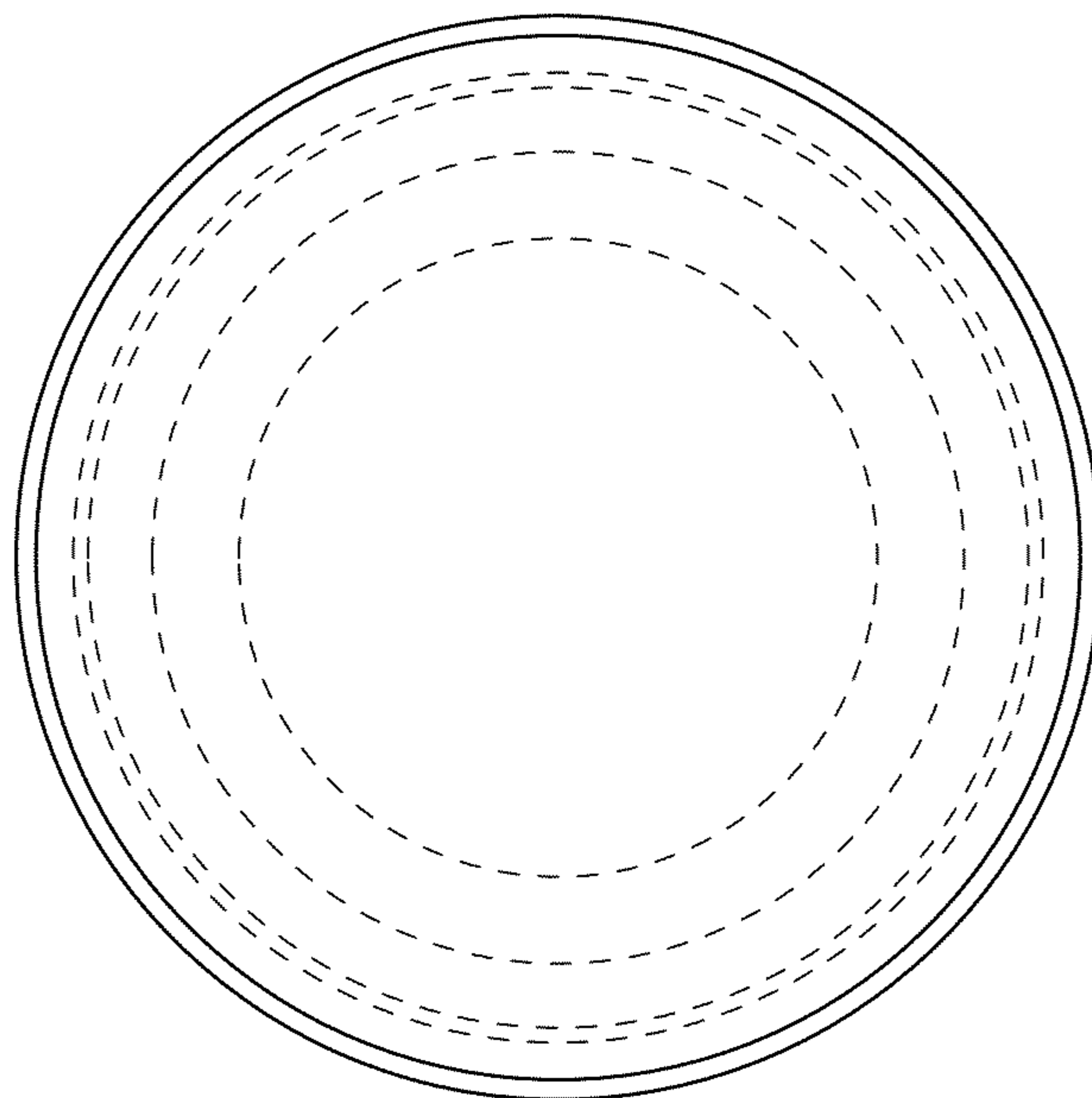

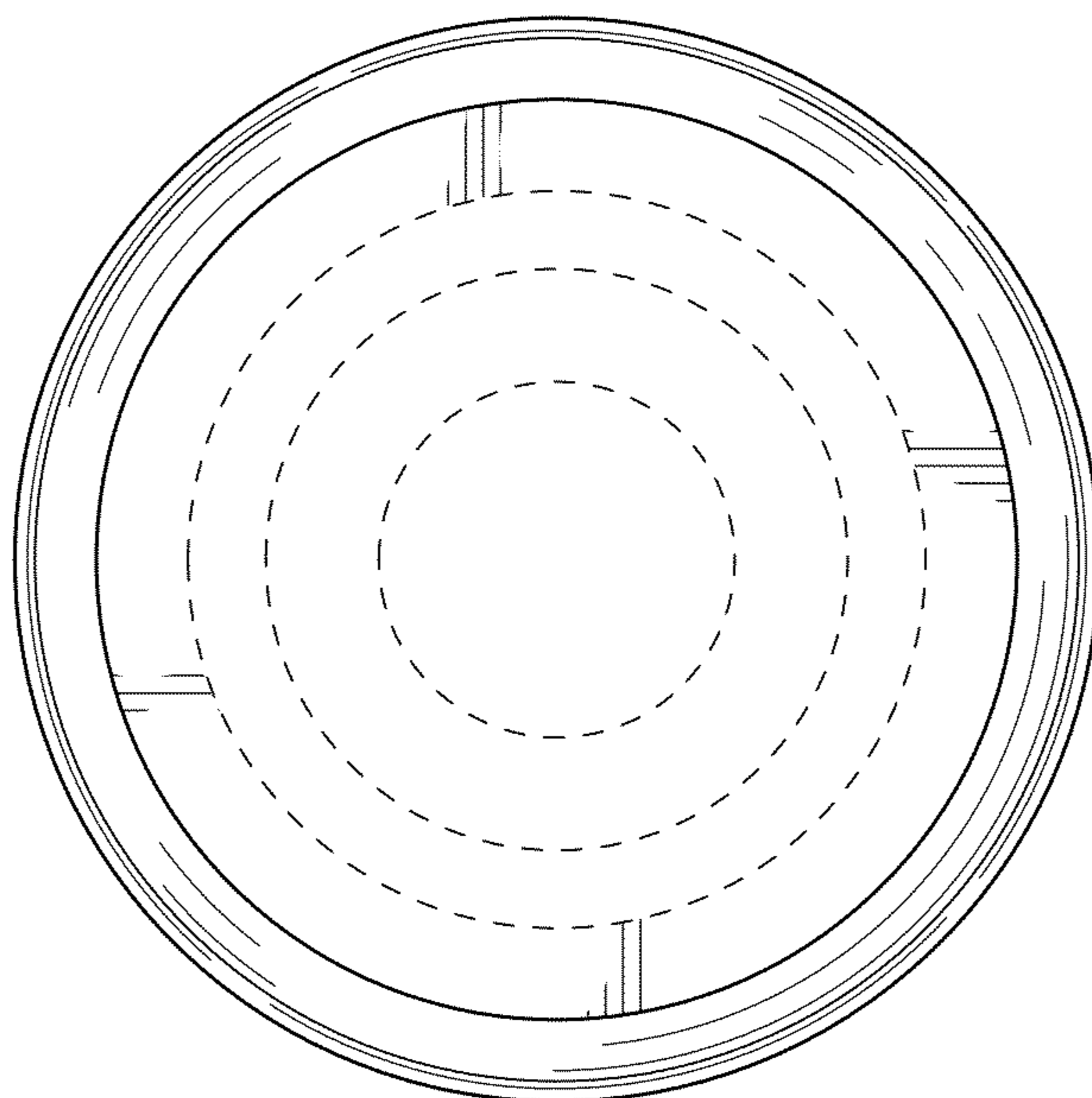
