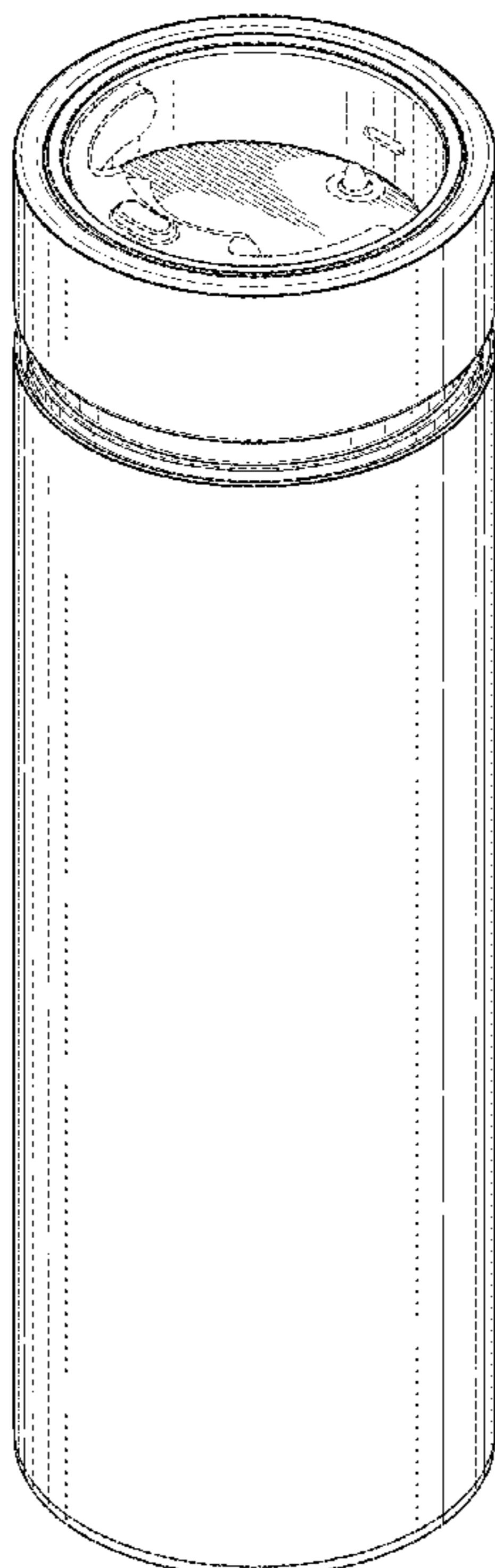

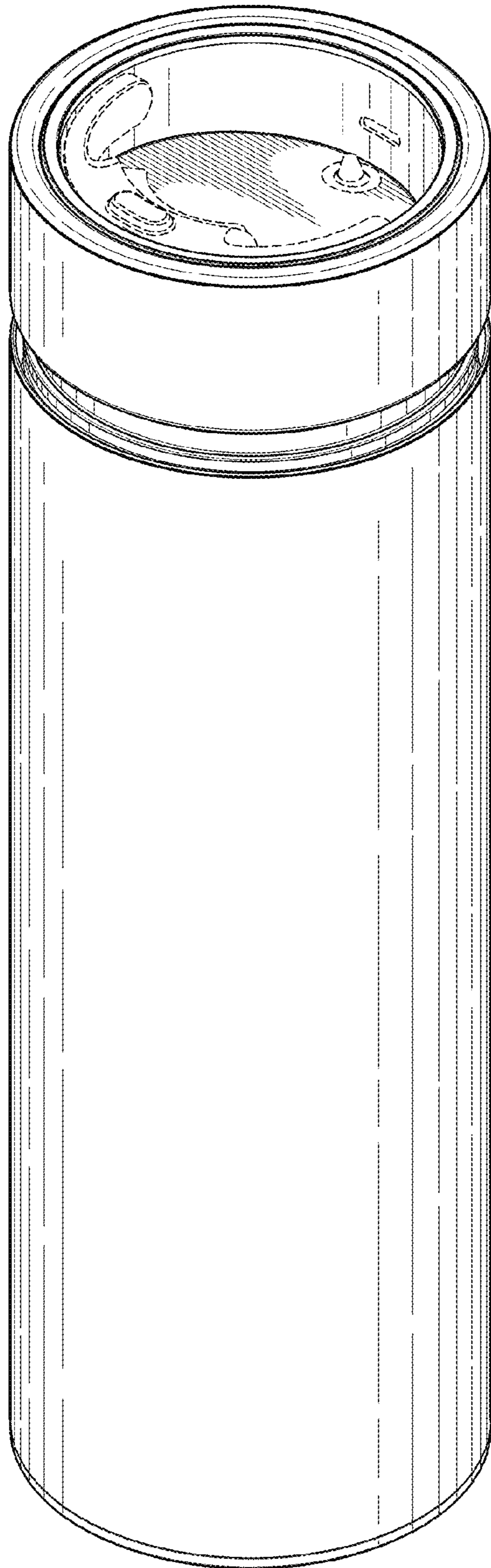
The ornamental design for a container assembly, as shown and described.

**DESCRIPTION**

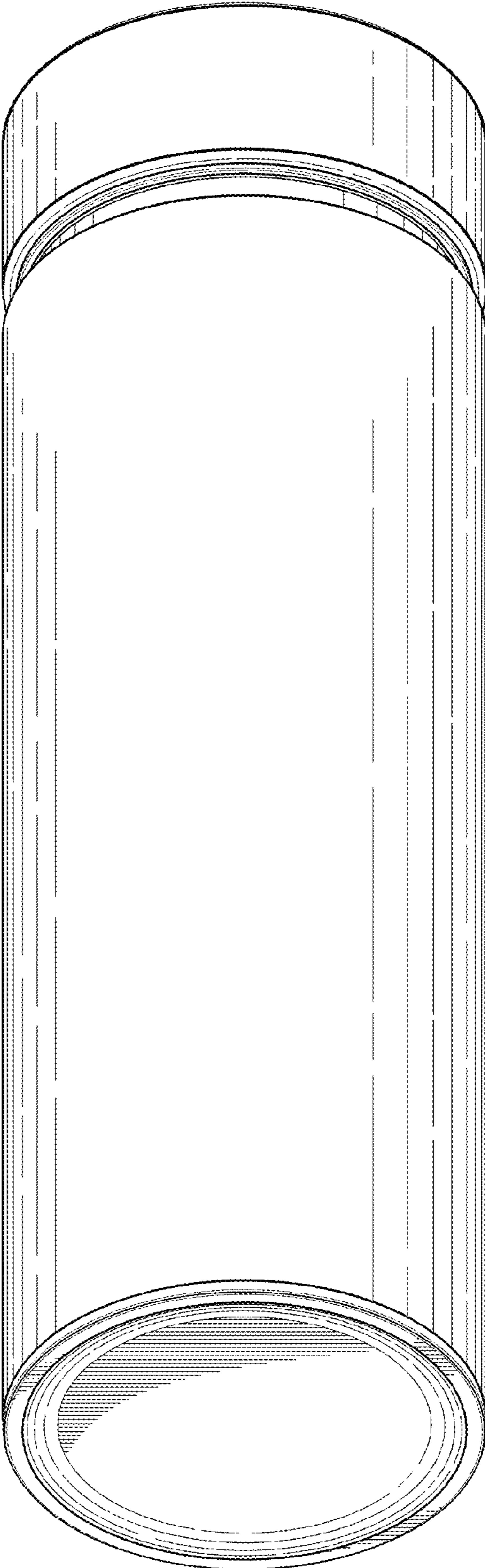

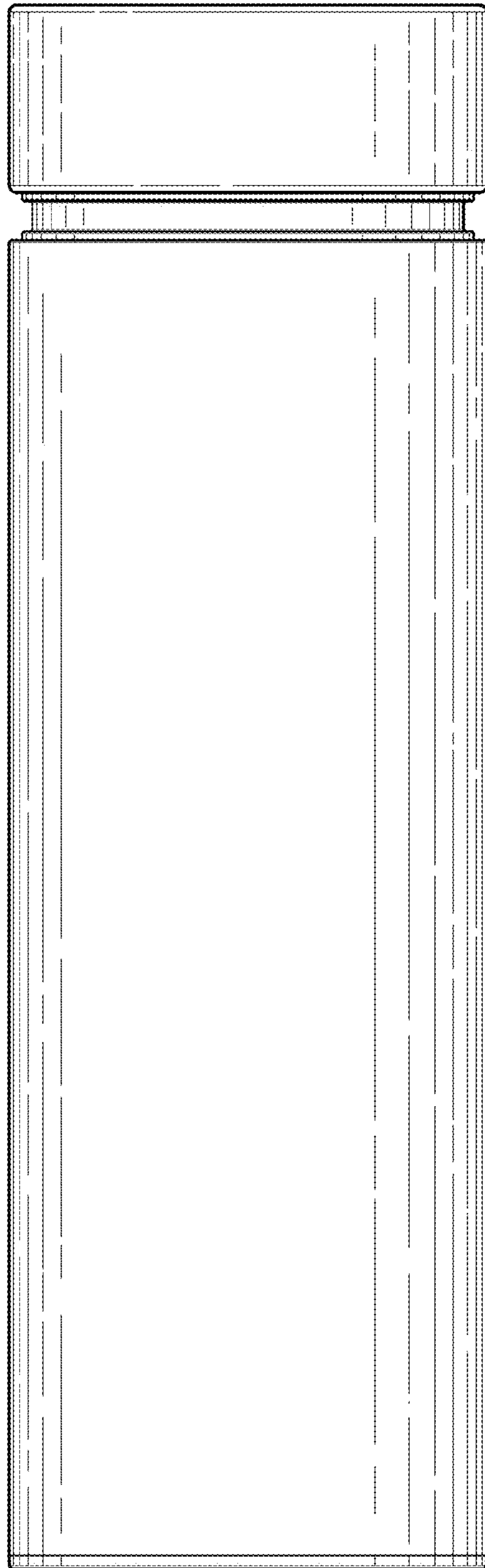




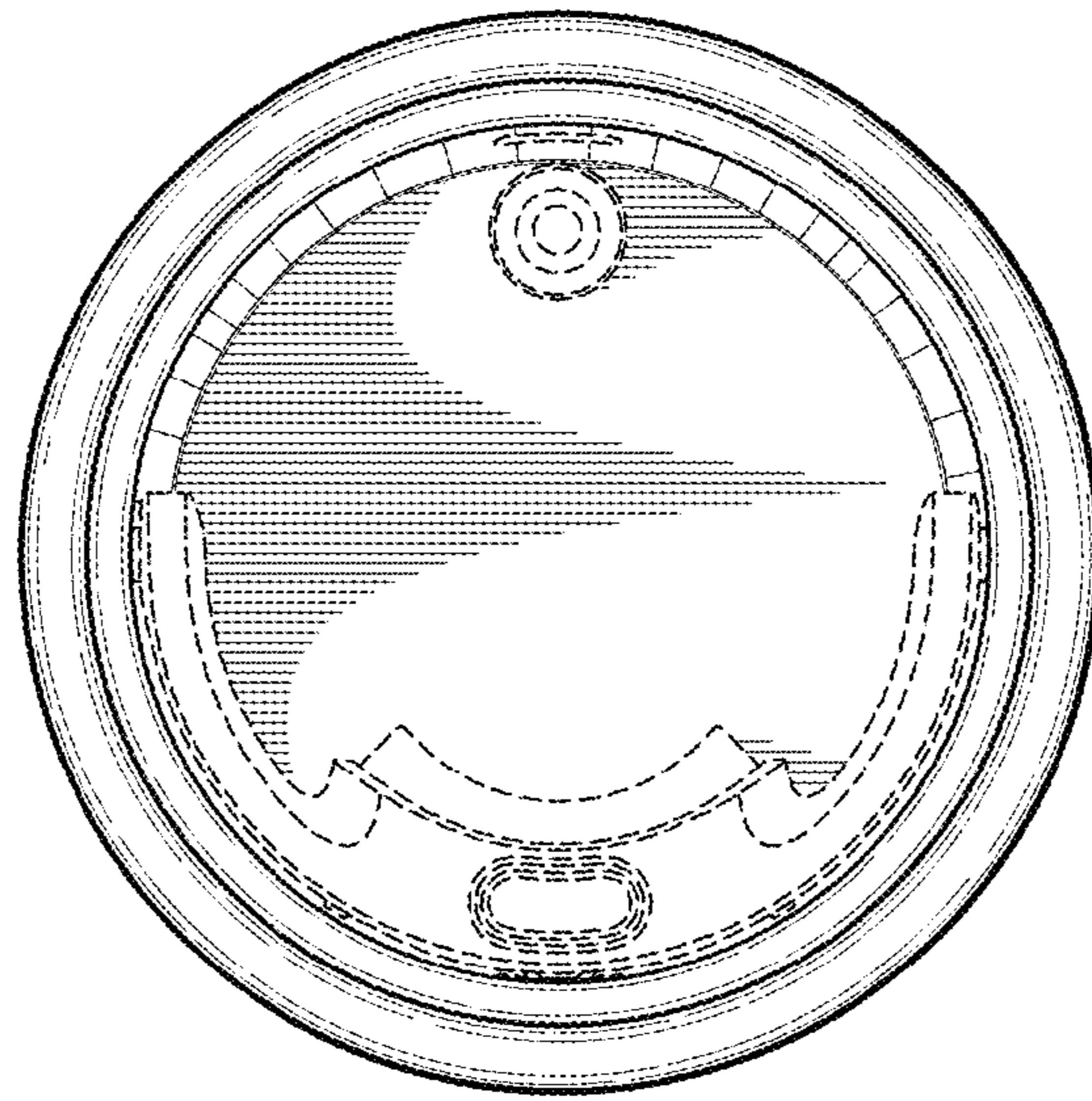

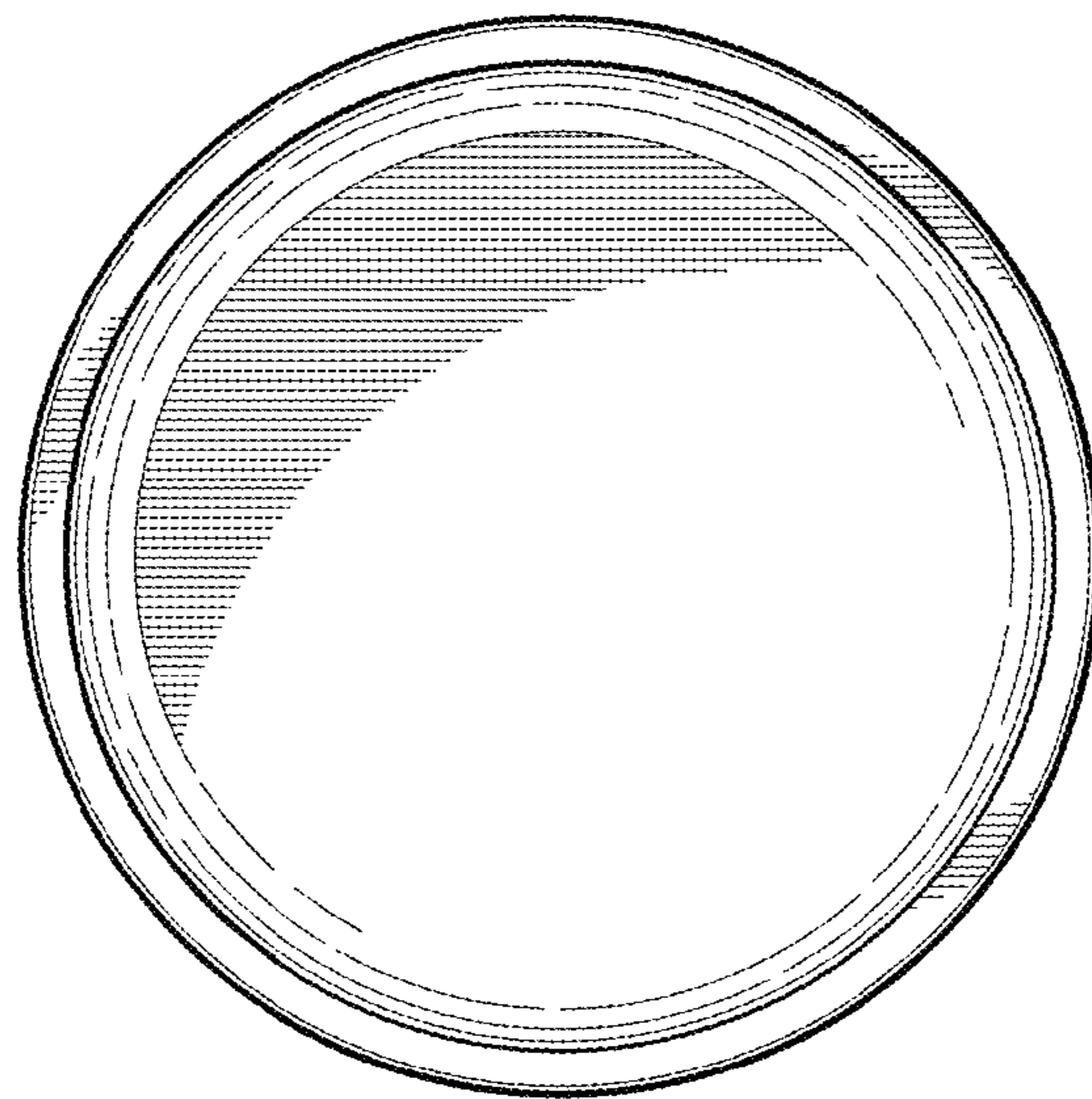
