DESCRIPTION

FIG. 23 is the first side elevational view of a blade for a sickle thereof;

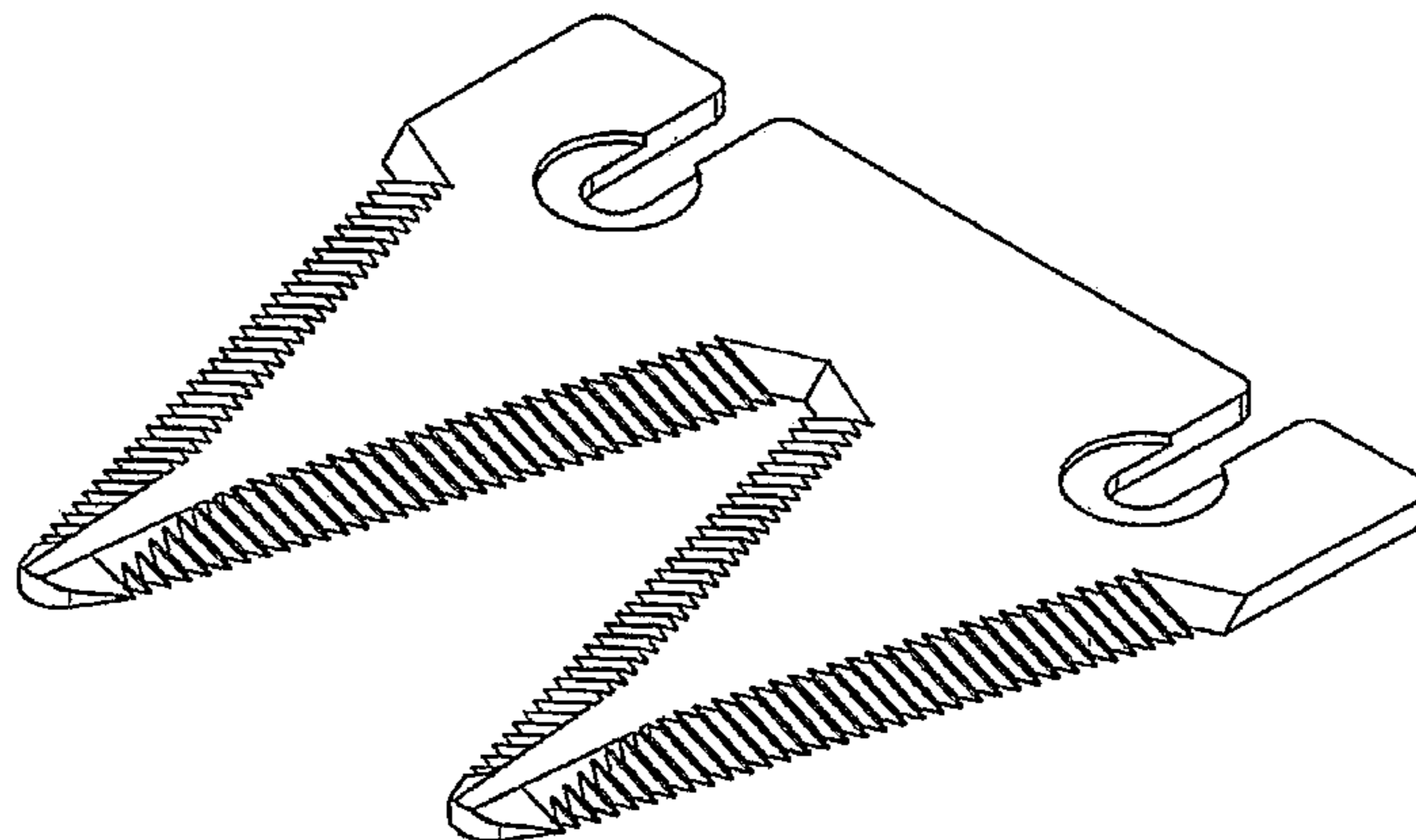
FIG. 24 is the second side elevational view of a blade for a sickle thereof;

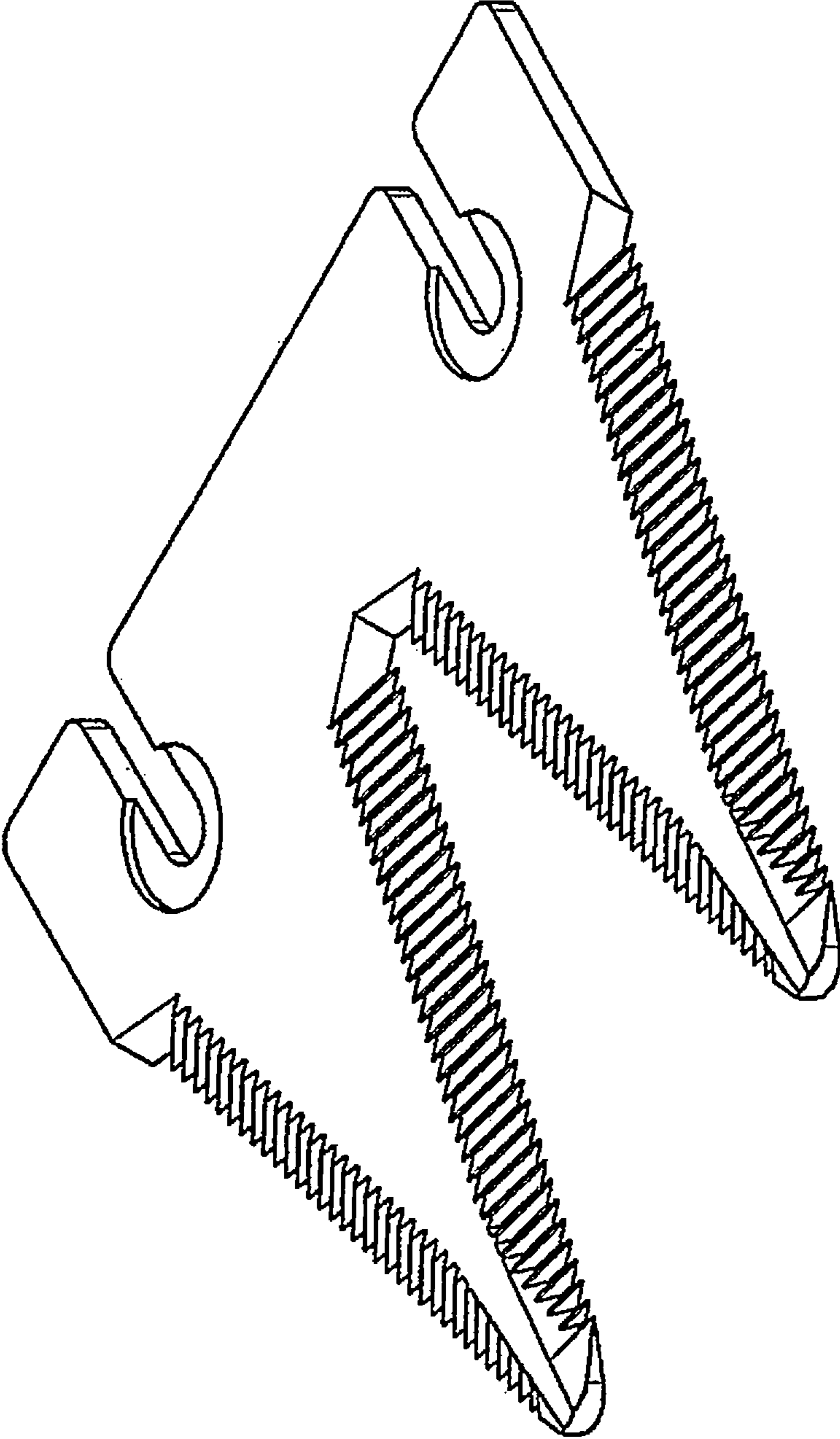

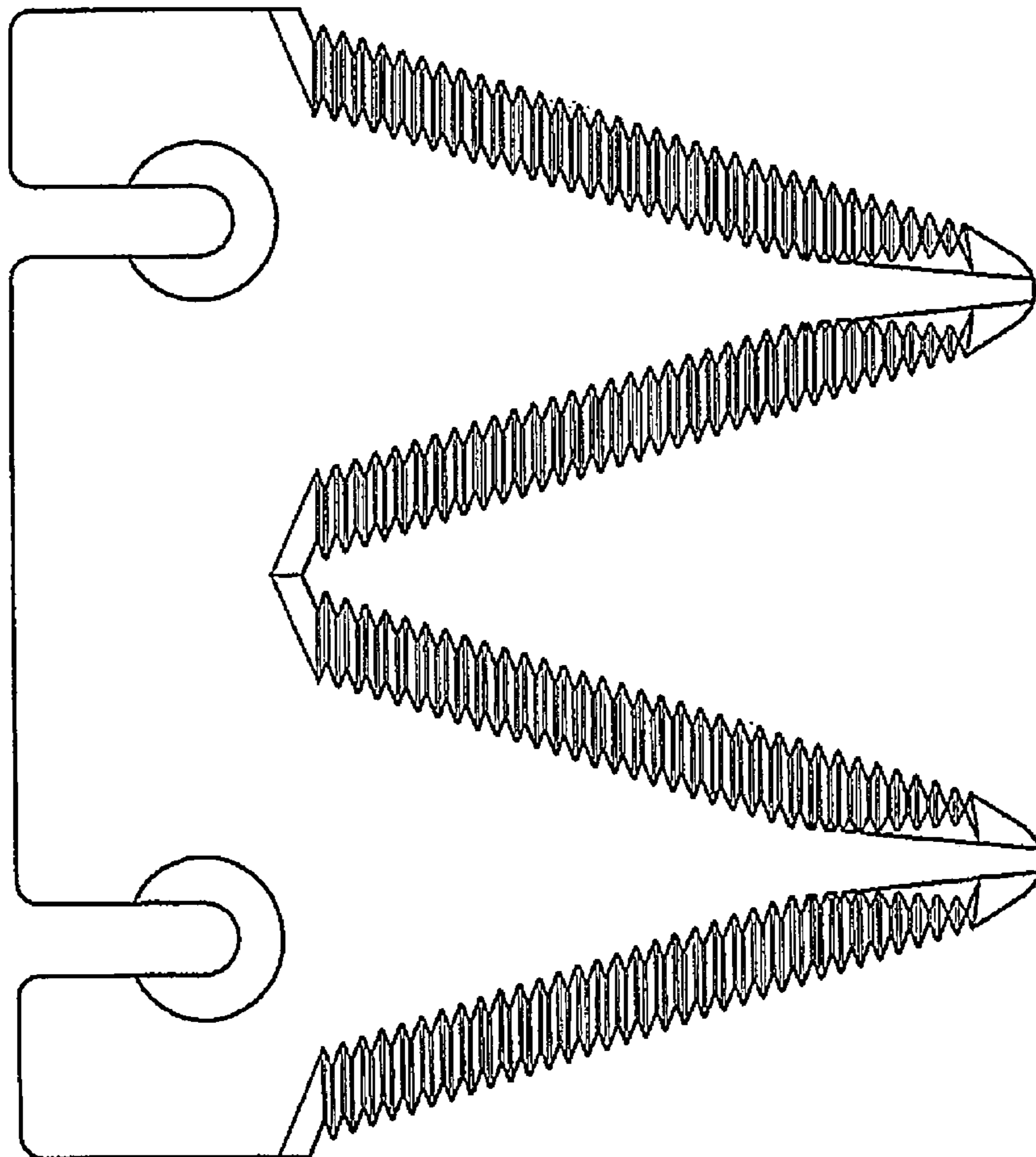

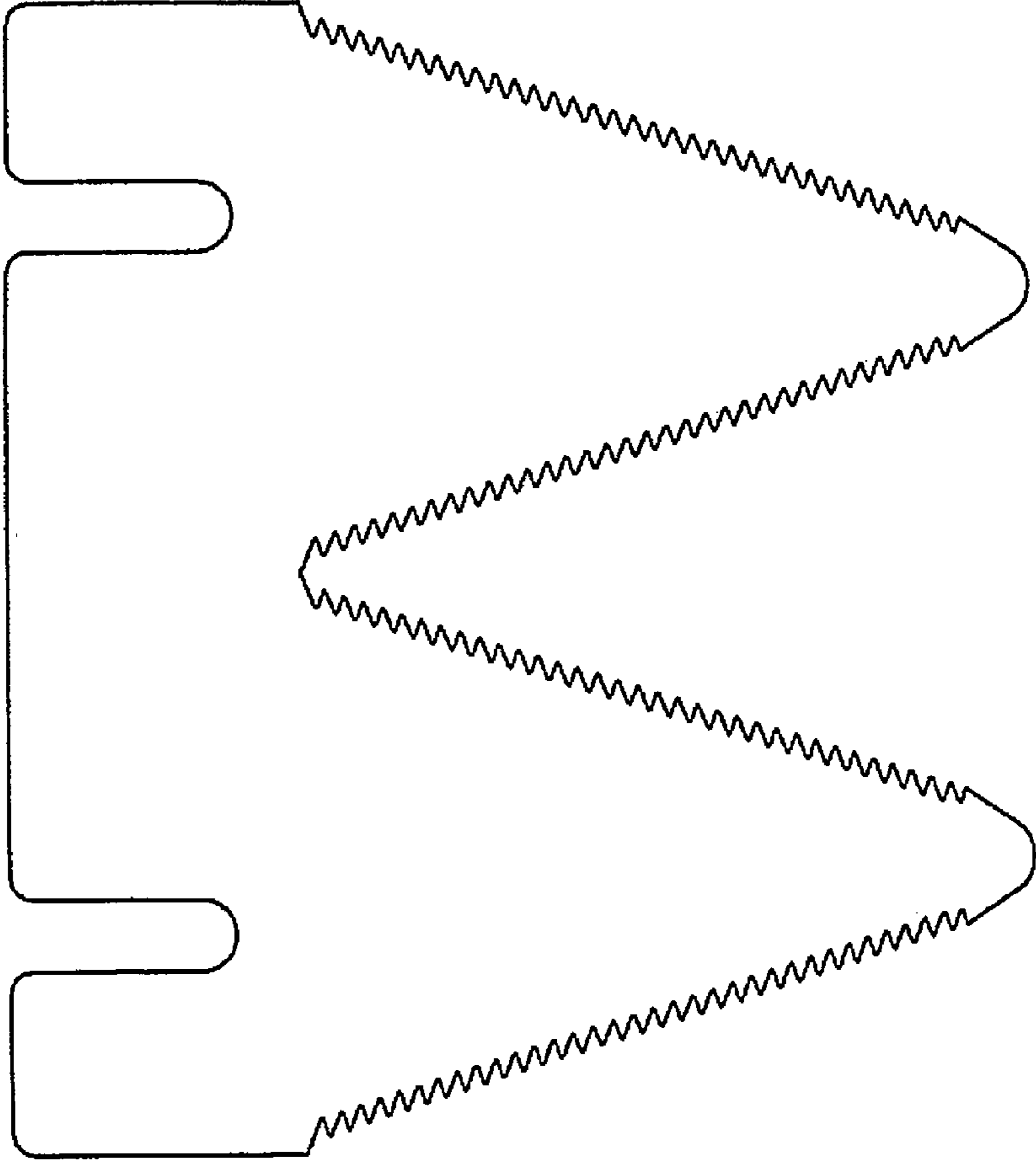

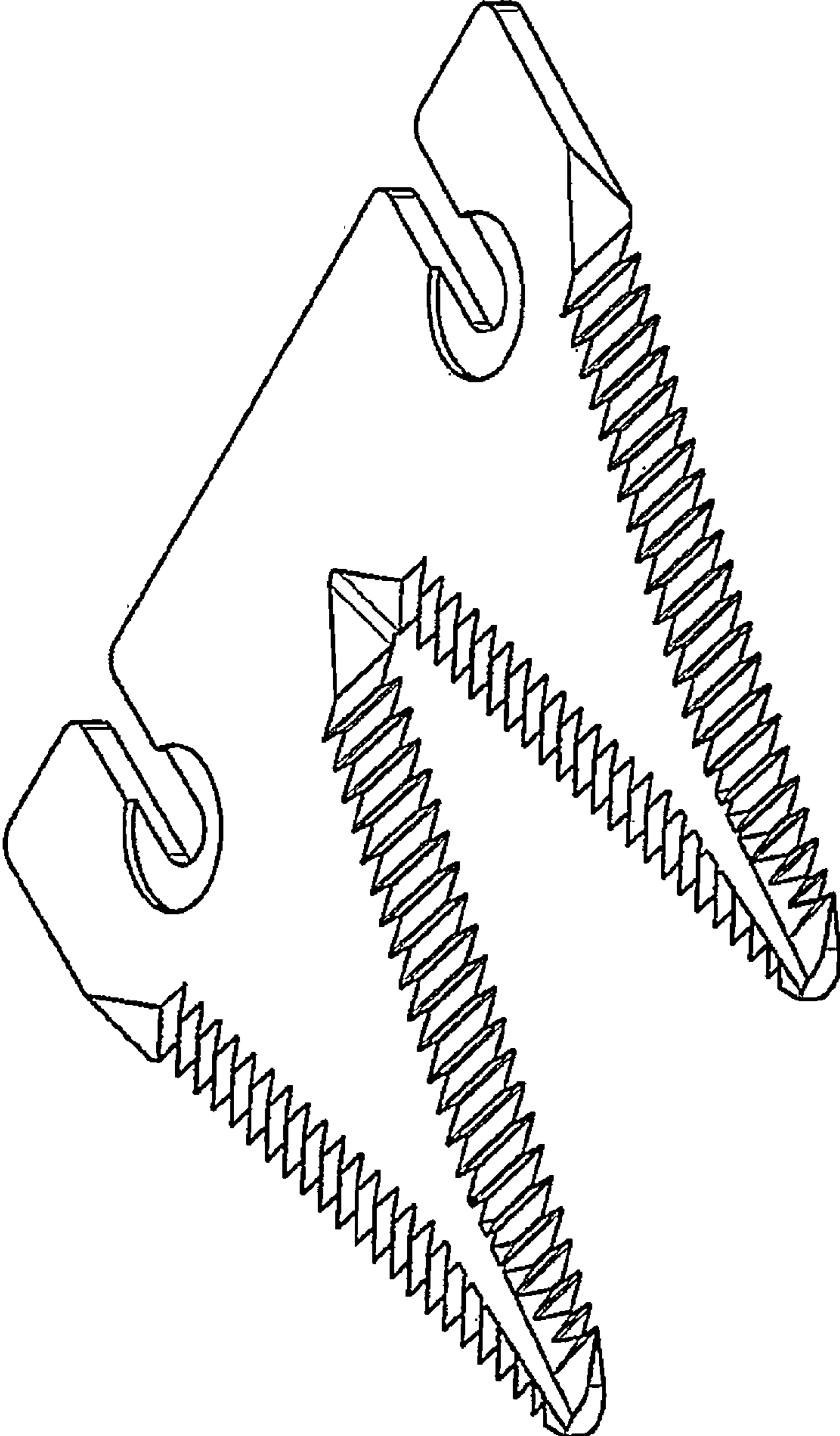

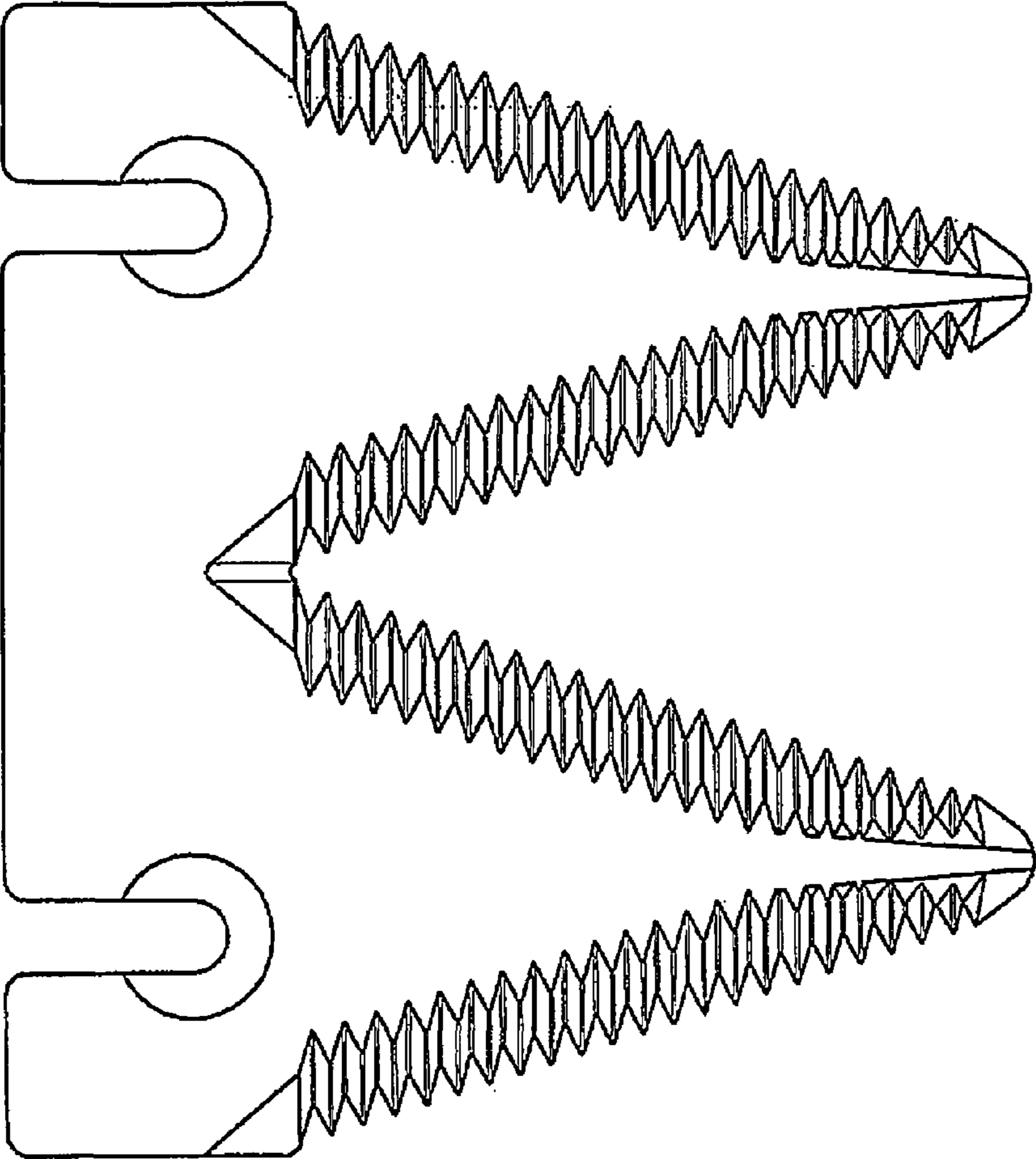

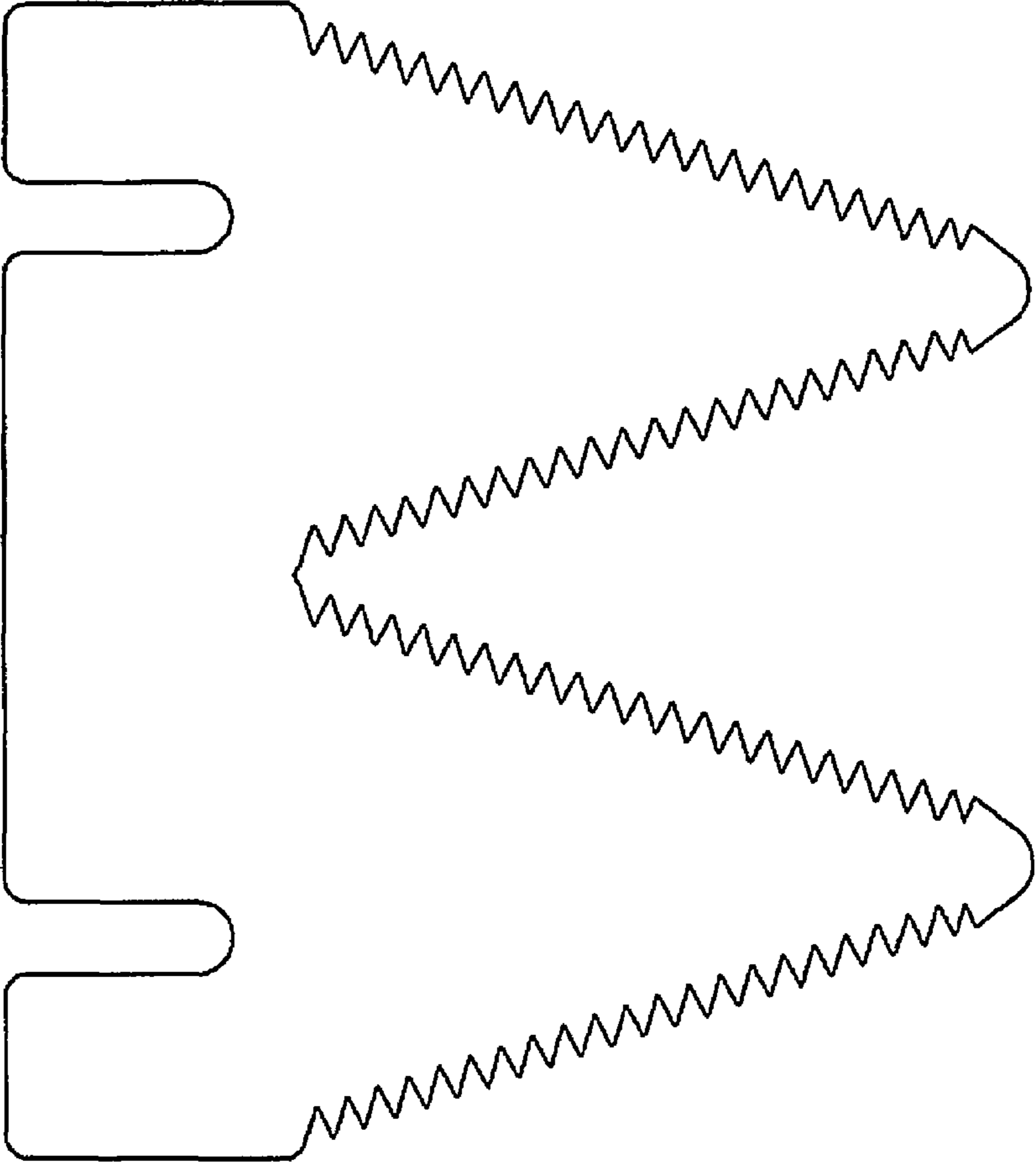

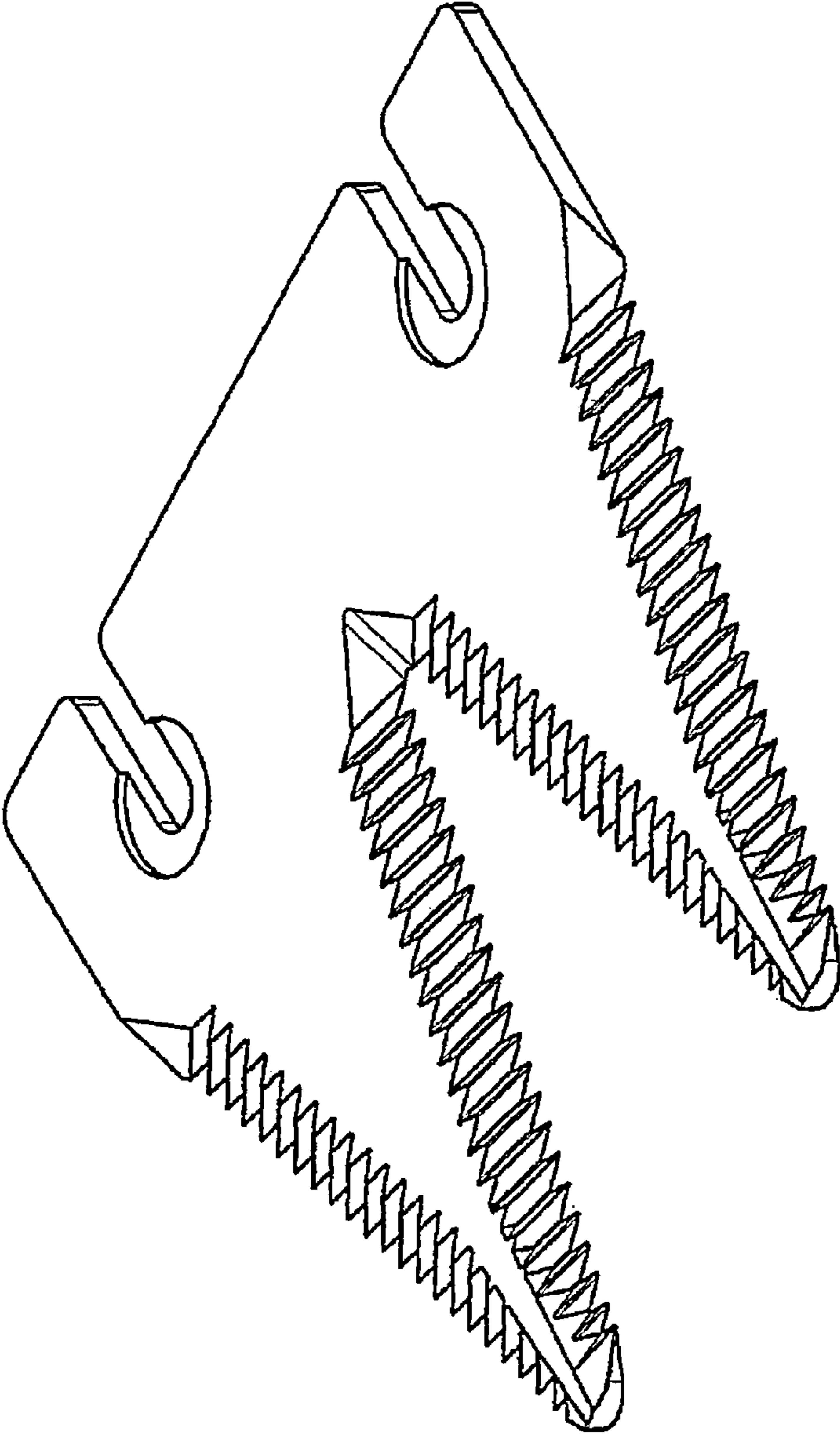

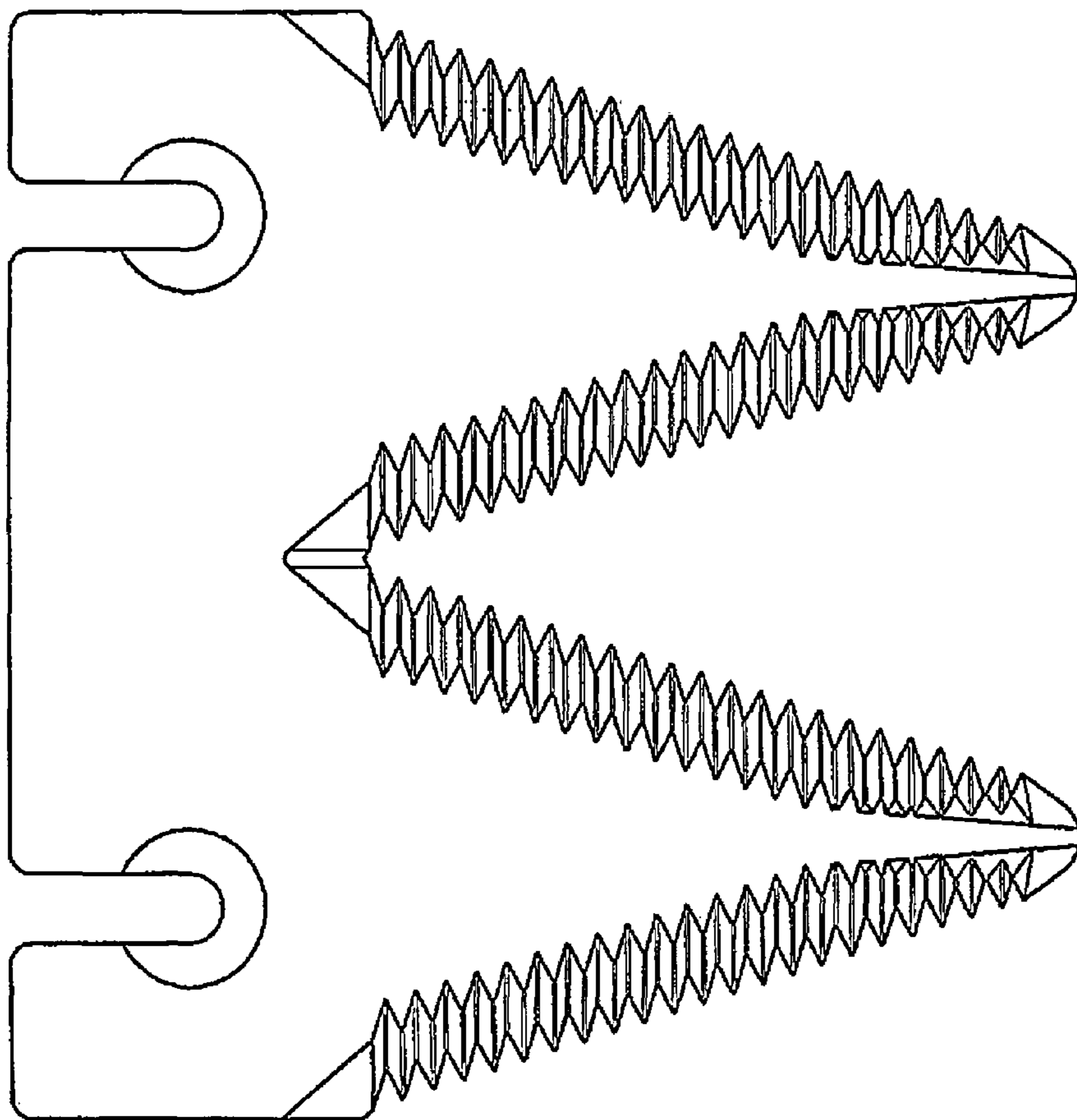

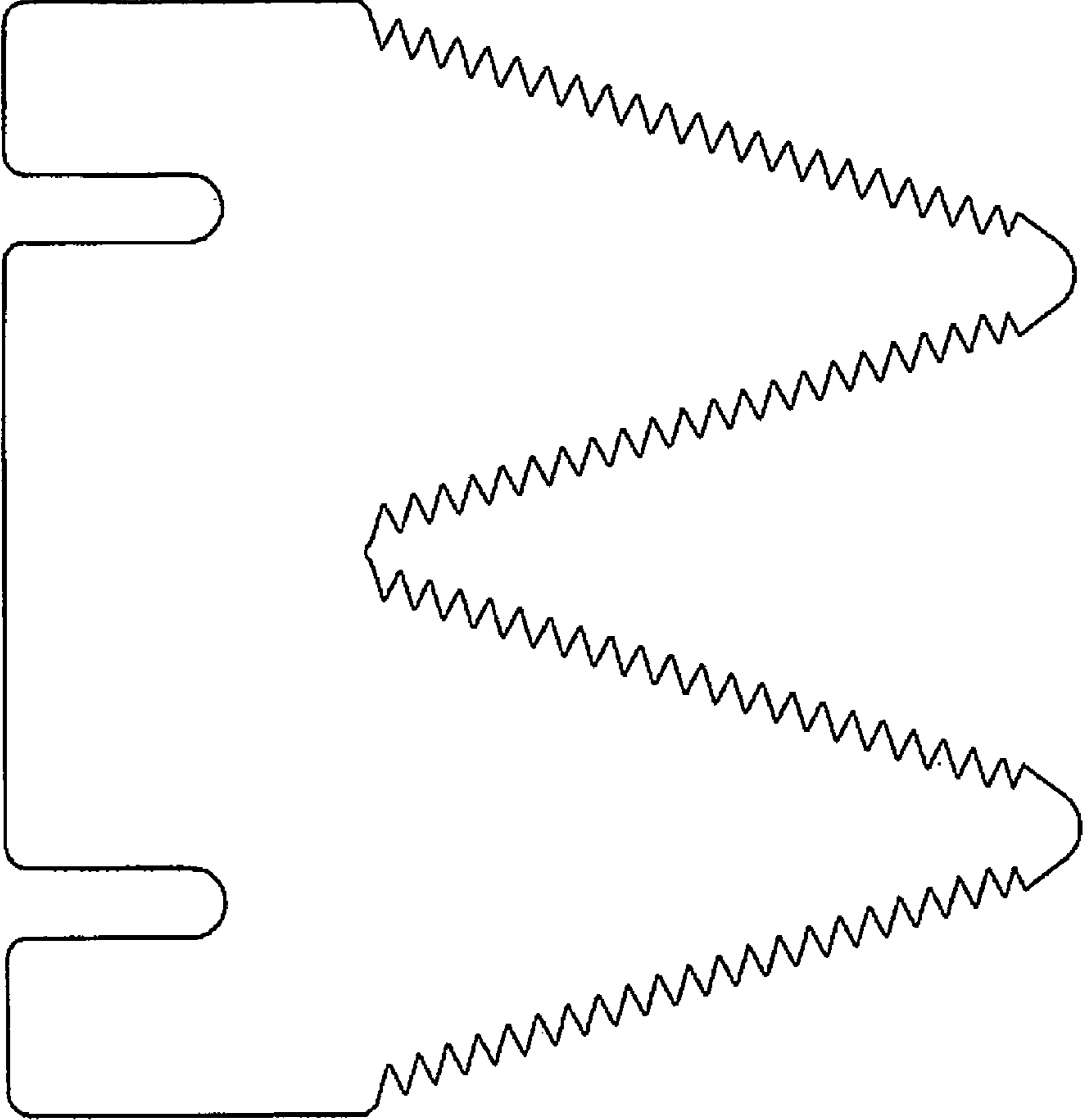

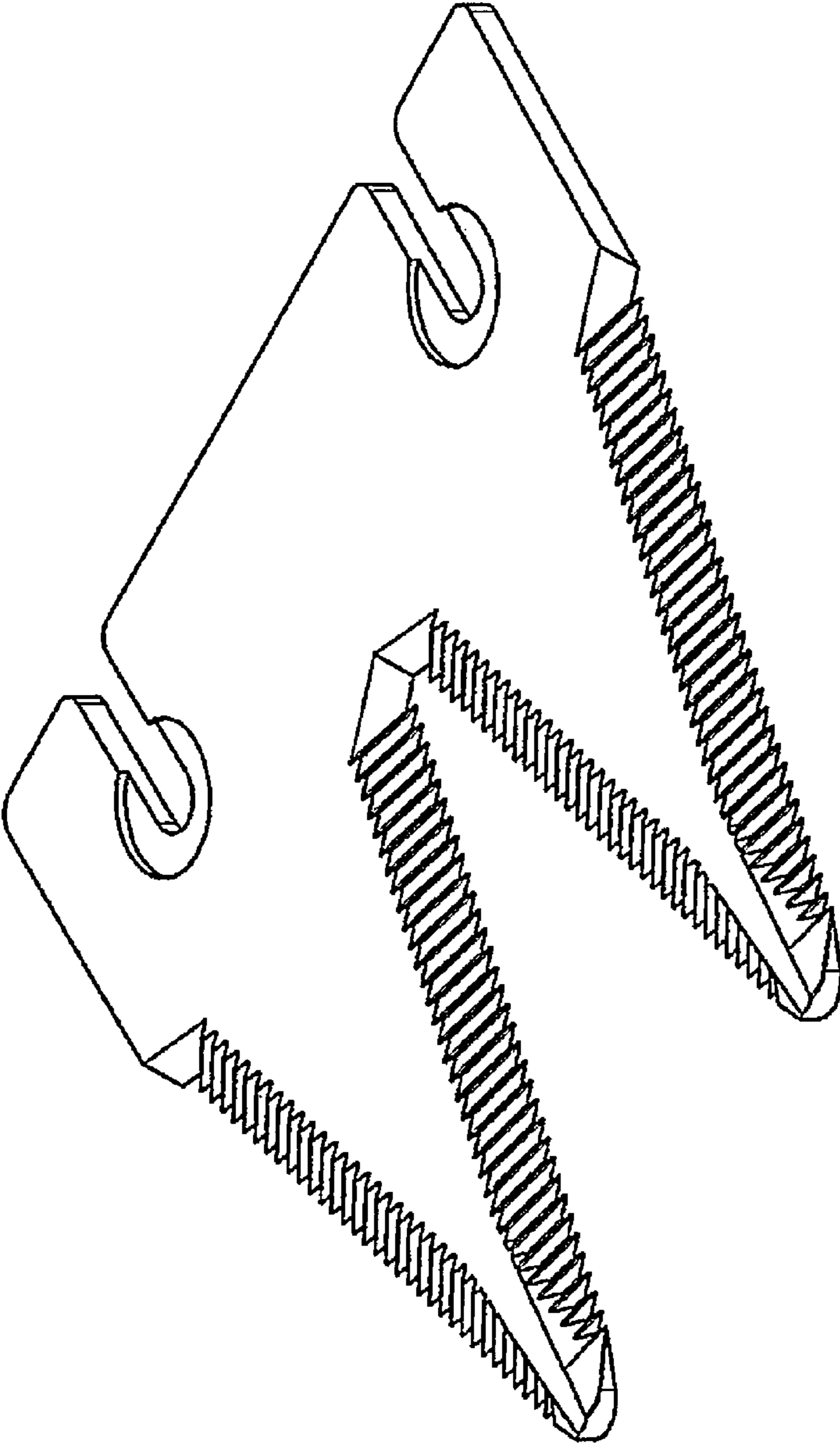

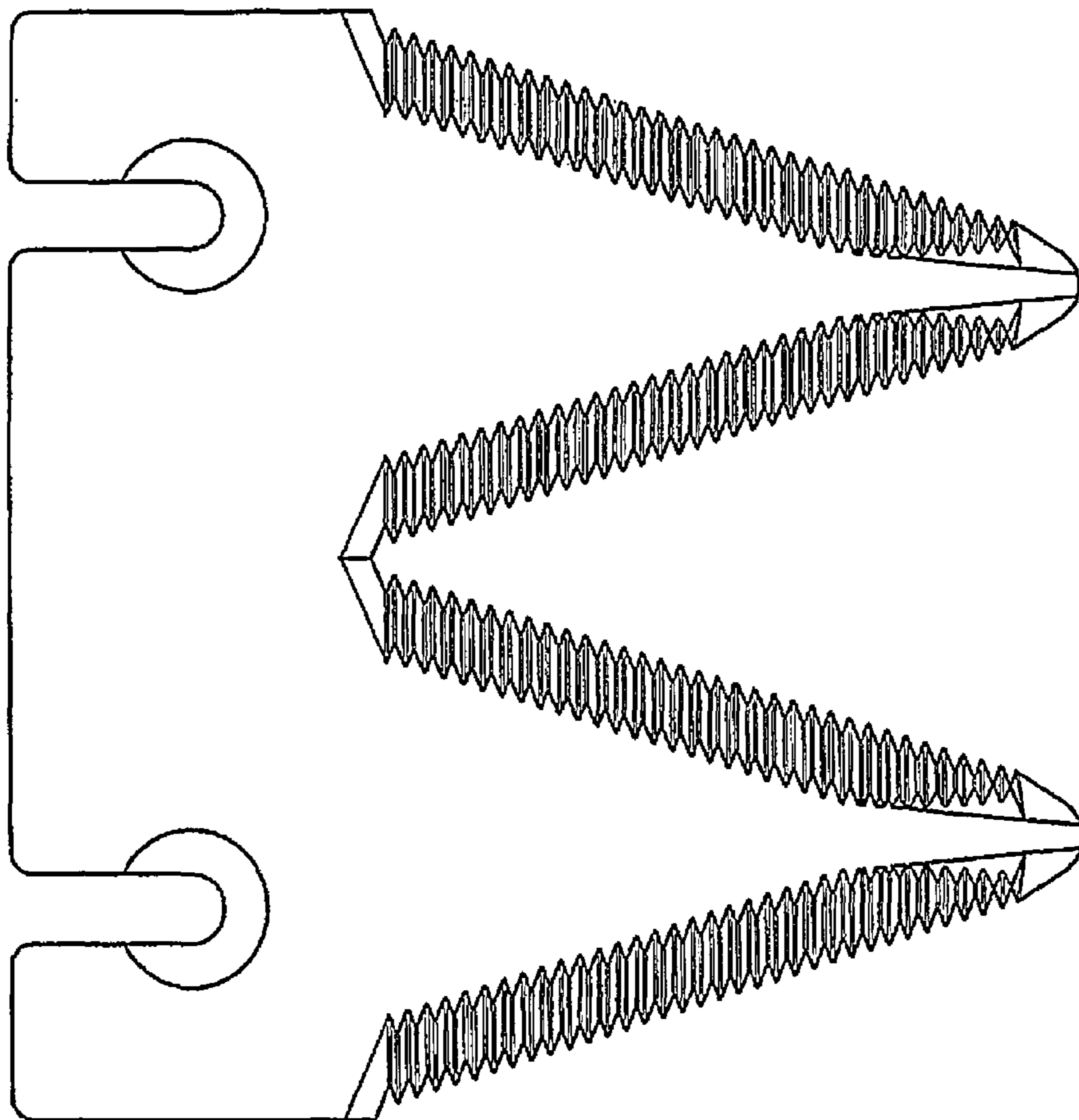

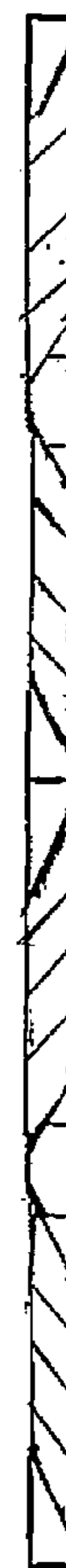

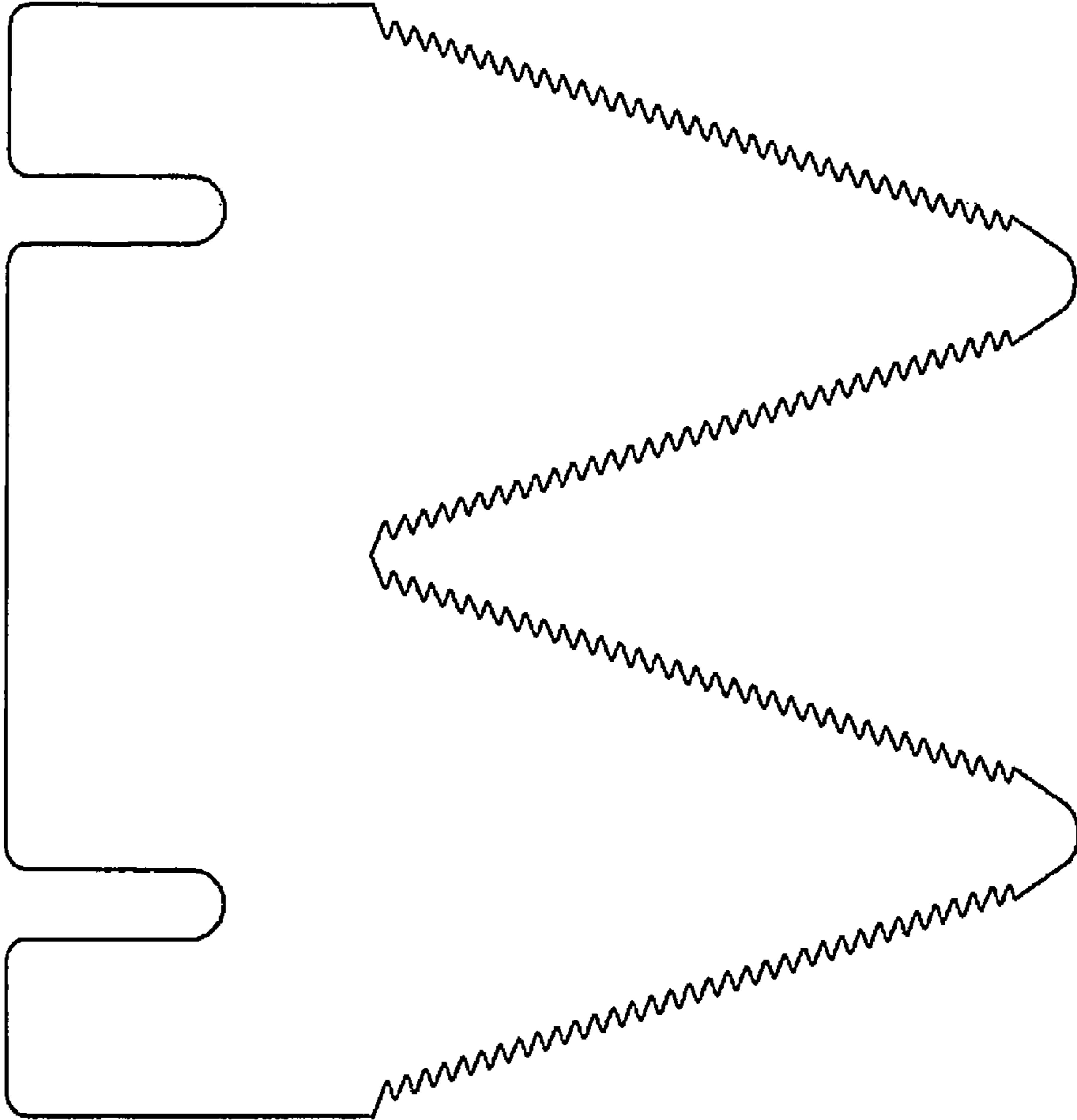
