
(57) **CLAIM**

The ornamental design for a press tool, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of the press tool of the present design;
FIG. 2 is a rear isometric view of the press tool of FIG. 1;
FIG. 3 is a right side view of the press tool of FIG. 1;
FIG. 4 is a left side view of the press tool of FIG. 1;
FIG. 5 is a top view of the press tool of FIG. 1;














































