(57) **CLAIM**

The ornamental design for a one-wheeled vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the first embodiment of the one-wheeled vehicle.

FIG. 2 is a left view of the vehicle of FIG. 1; the left and right views are mirror images.

FIG. 3 is a rear elevational view of the vehicle of FIG. 1.

FIG. 4 is a bottom view of the vehicle of FIG. 1.

FIG. 5 is a front elevational view of the vehicle of FIG. 1.

FIG. 6 is a perspective view of the vehicle of FIG. 1.

FIG. 7 is a top view of the second embodiment of the one-wheeled vehicle.

FIG. 8 is a left view of the vehicle of FIG. 7; the left and right views are mirror images.

FIG. 9 is a rear elevational view of the vehicle of FIG. 7.

FIG. 10 is a bottom view of the vehicle of FIG. 7.

FIG. 11 is a front elevational view of the vehicle of FIG. 7; and,

FIG. 12 is a perspective view of the vehicle of FIG. 7.

The objects outlined in broken lines near the bottom of the device represent functional components which are provided for context and not part of the claimed design. All other broken lines represent the bounds of the claimed design, wherein the details of the enclosed surfaces are not claimed.

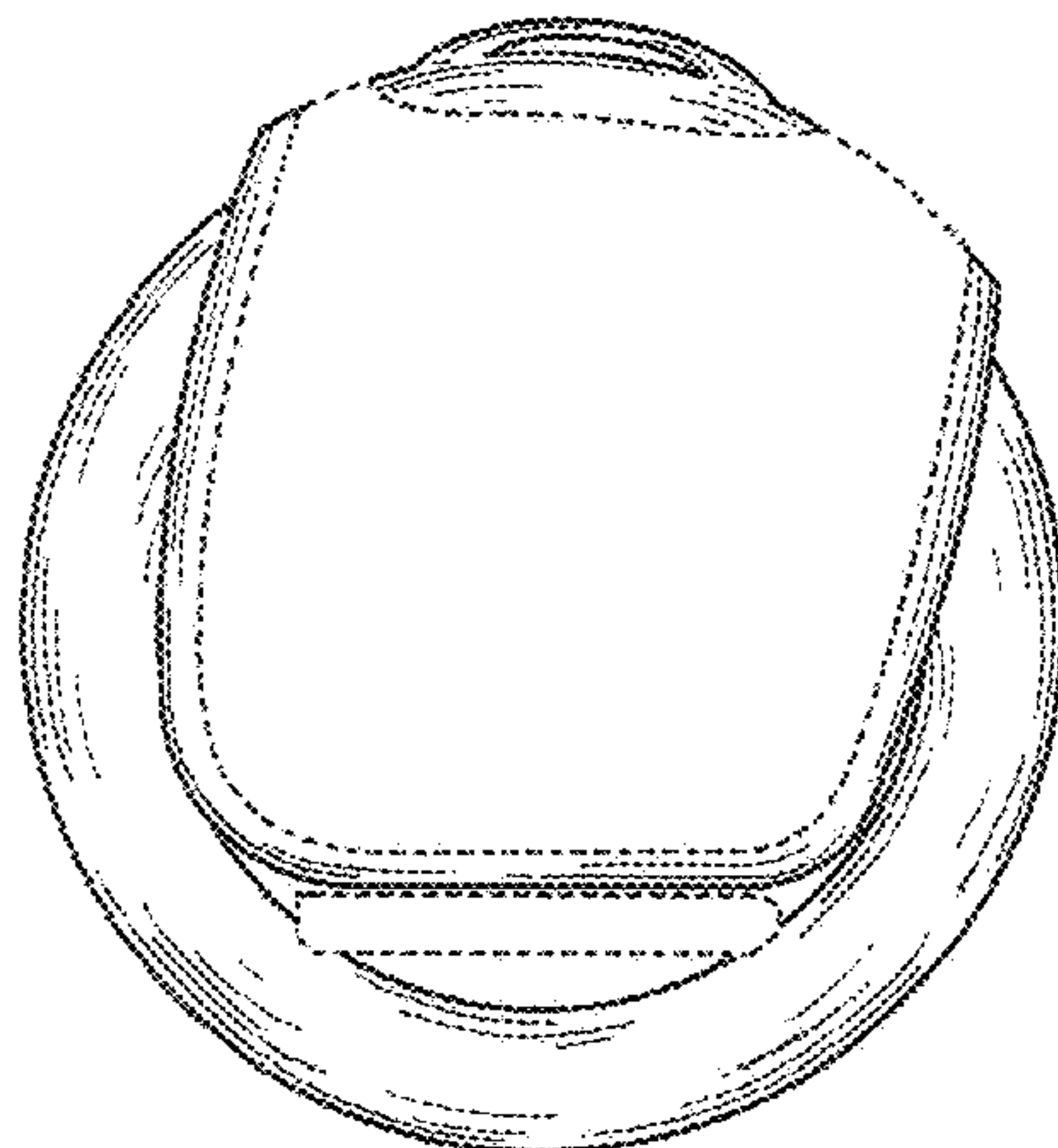

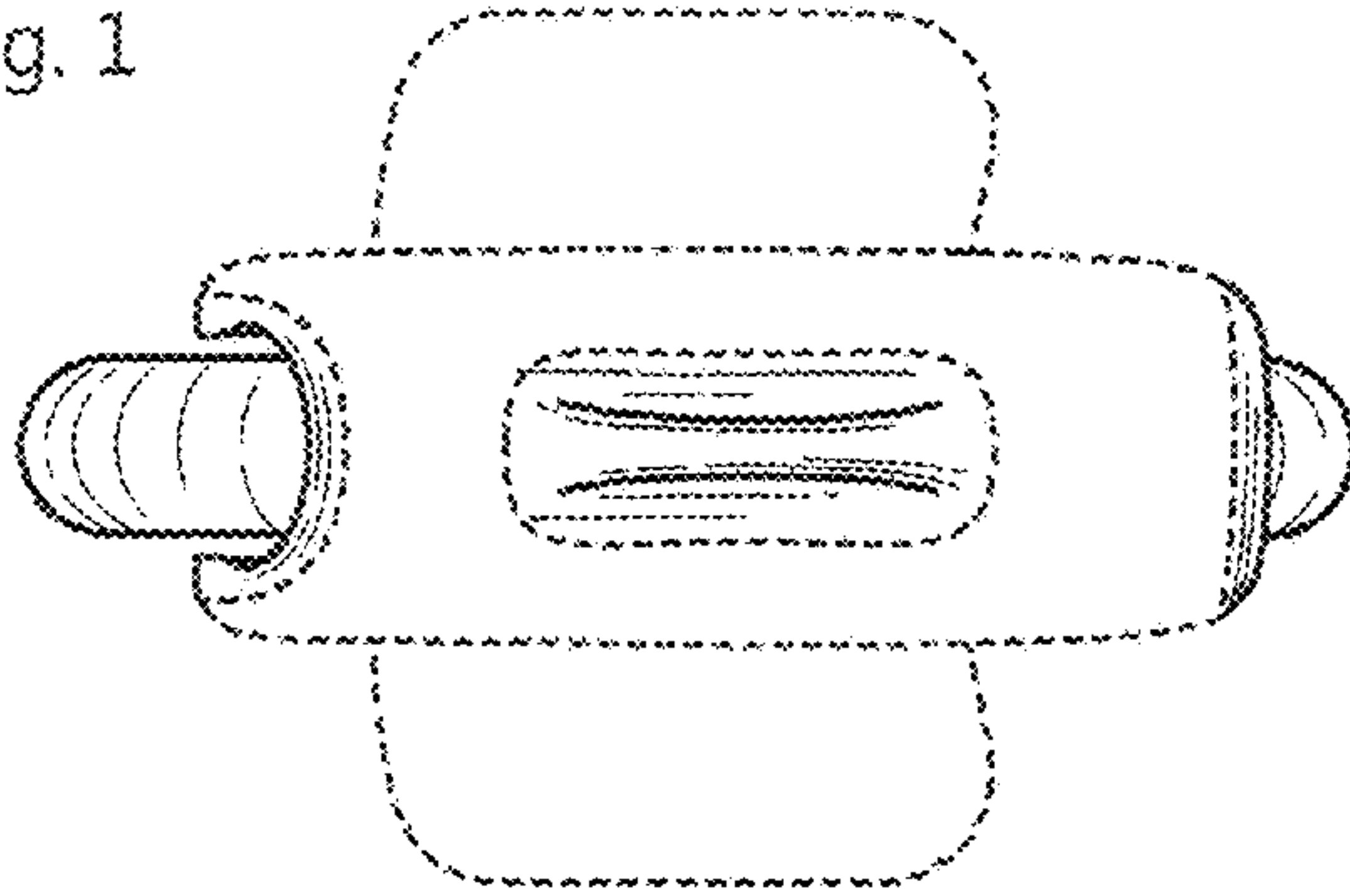

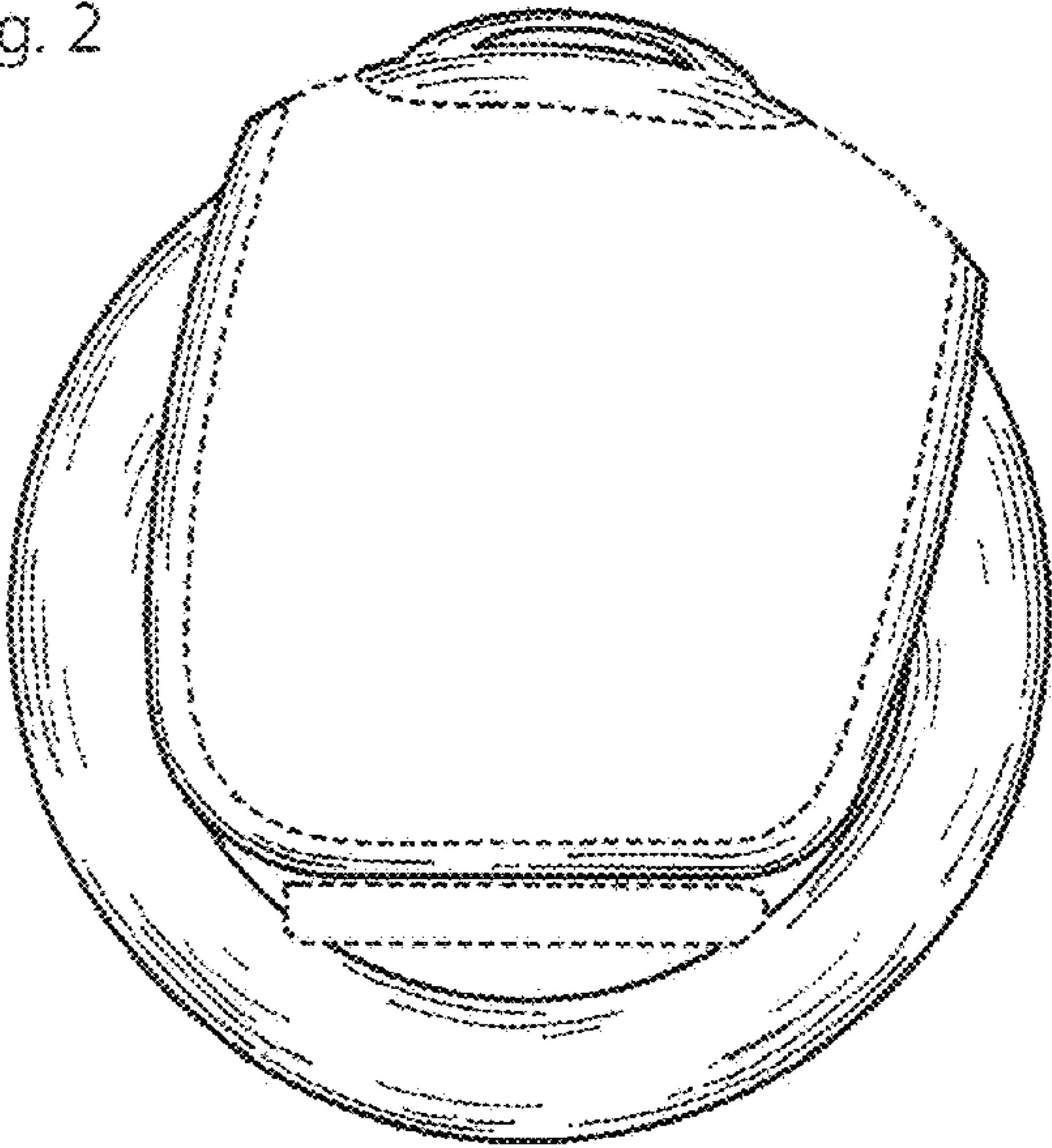

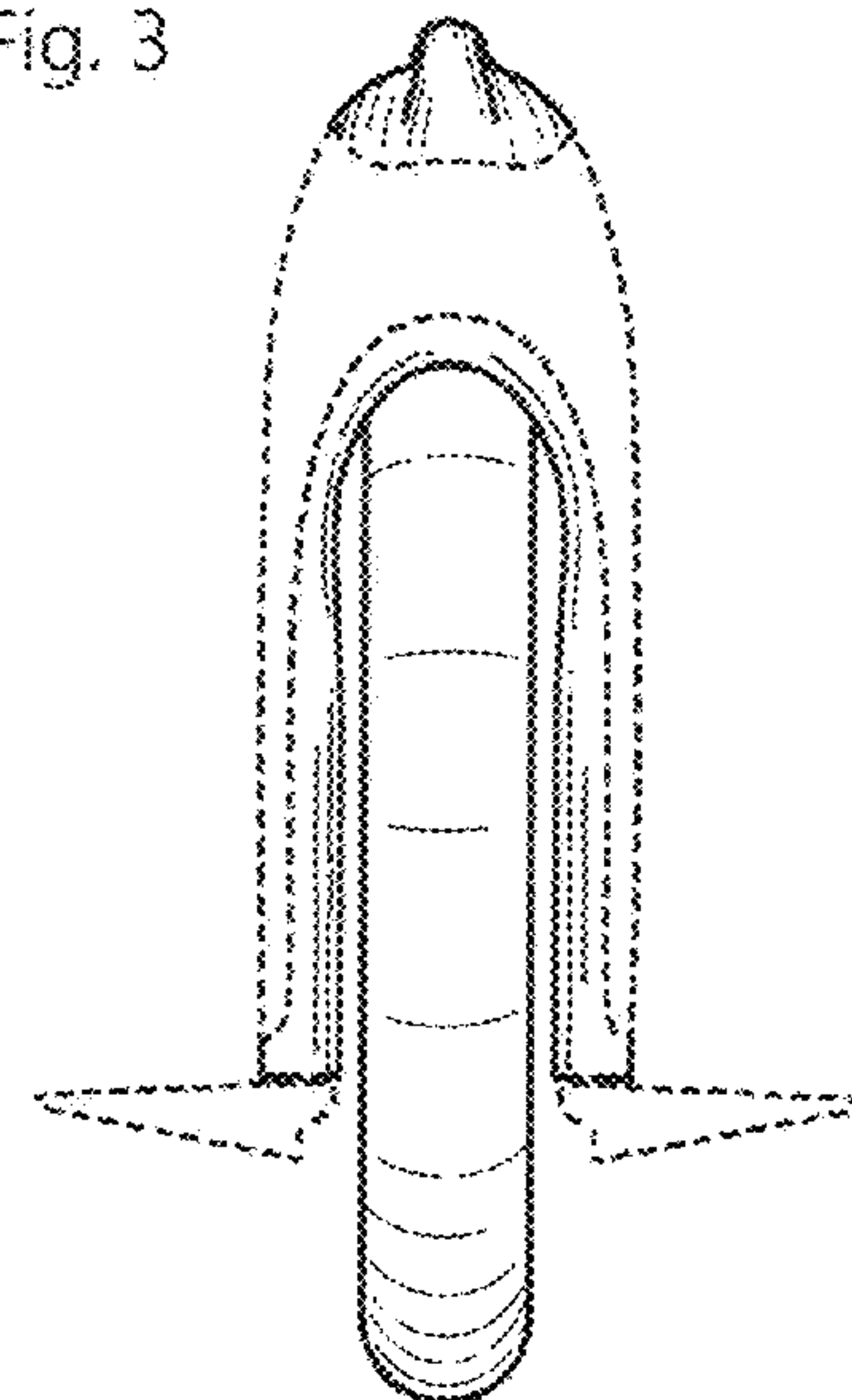

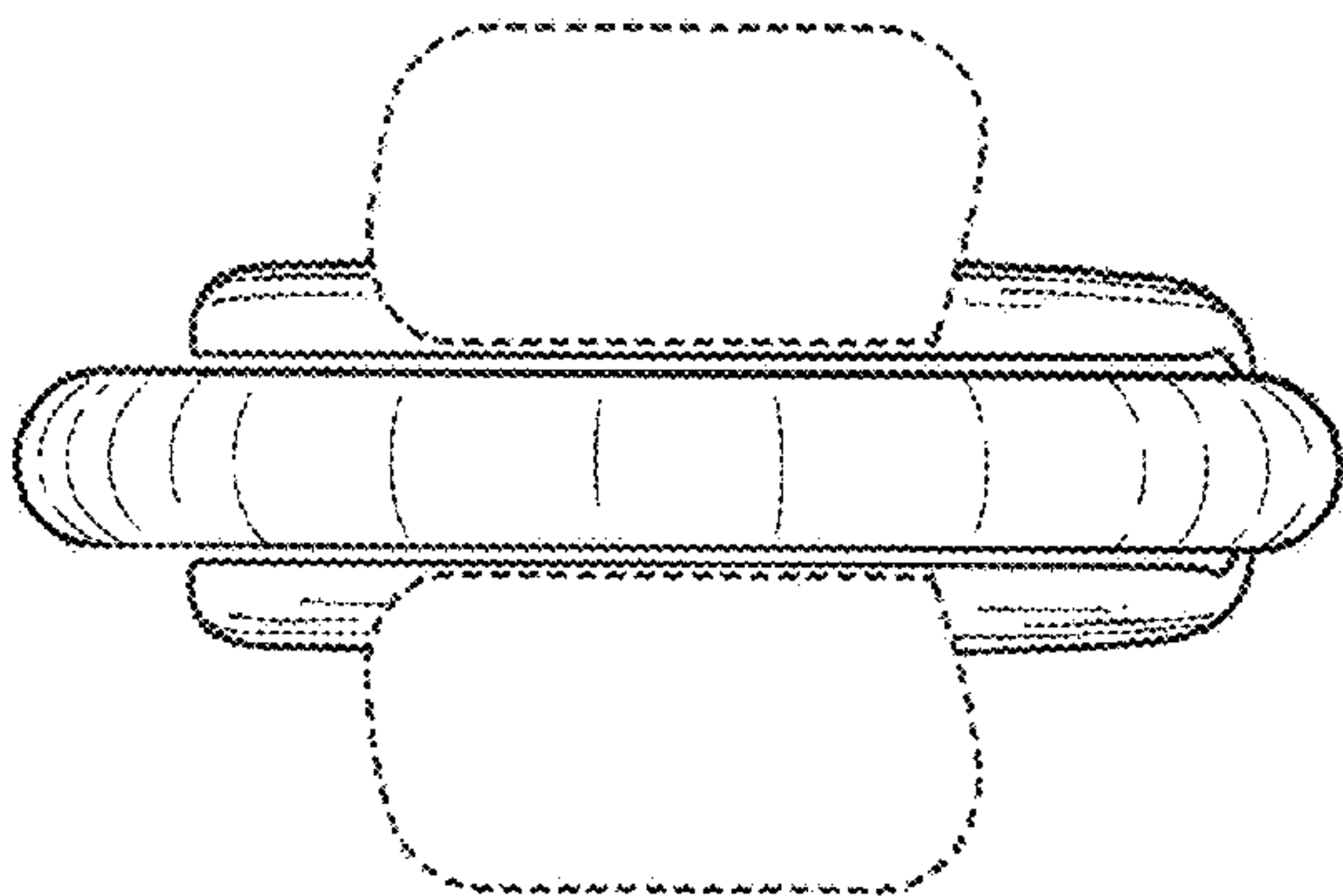

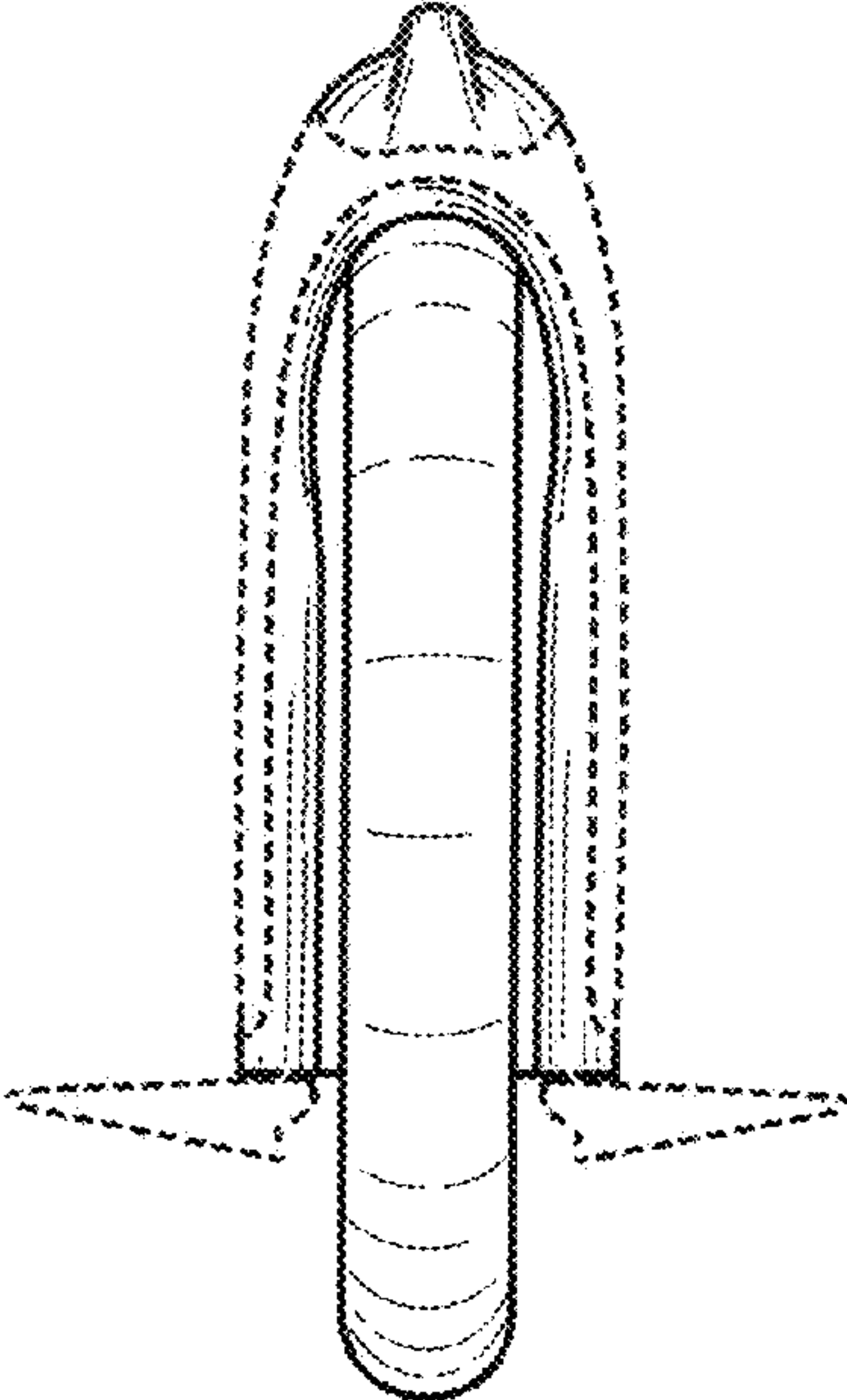

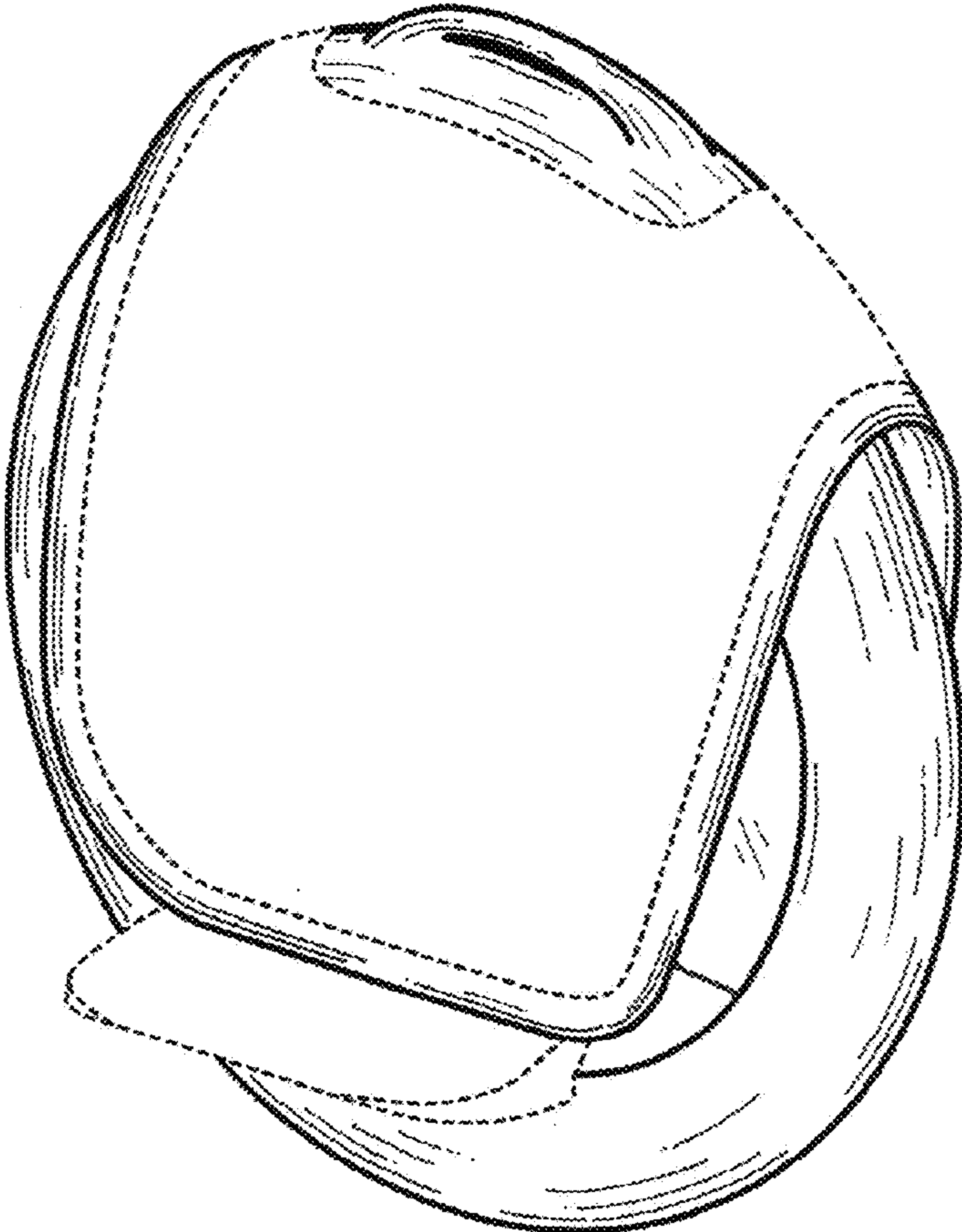

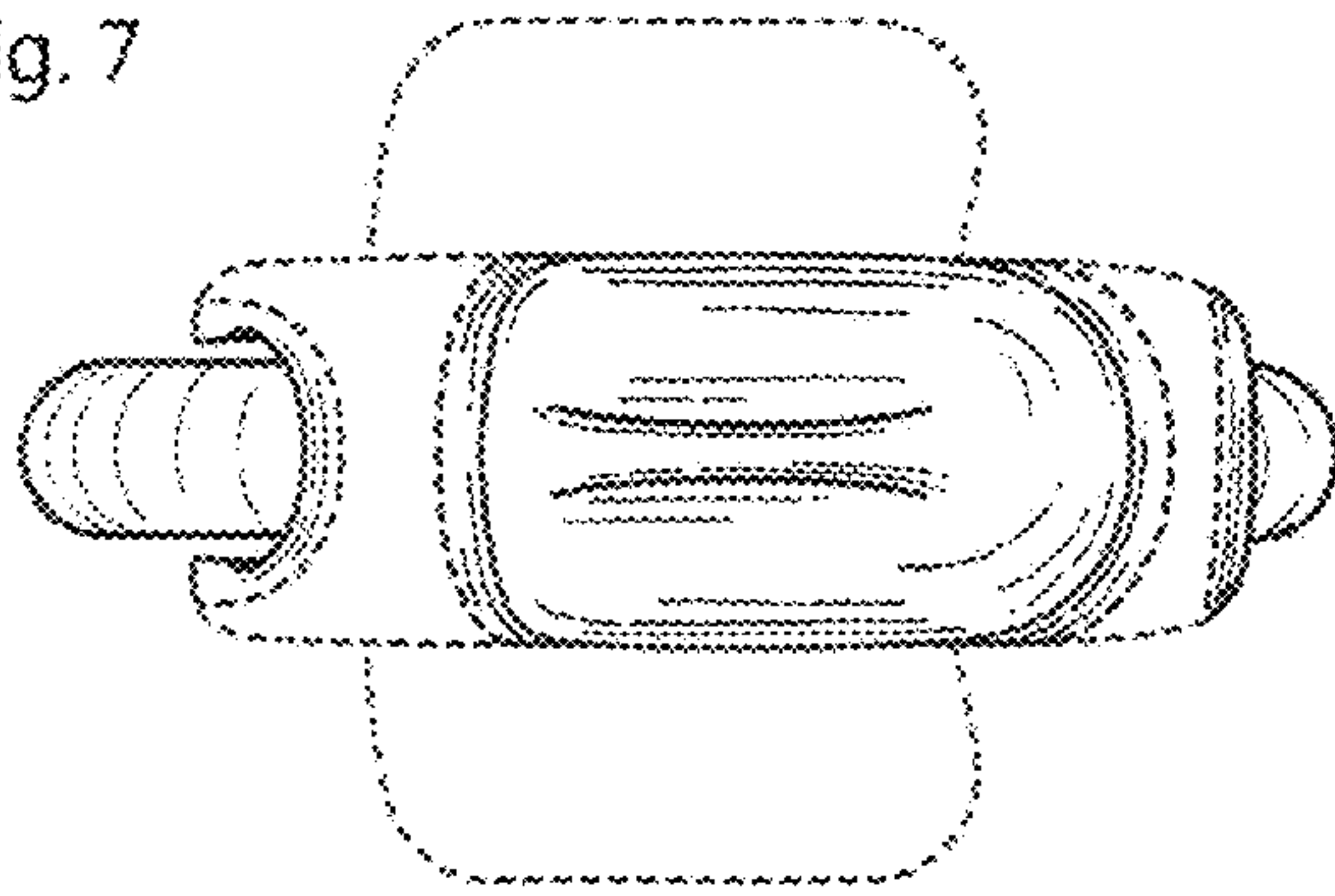

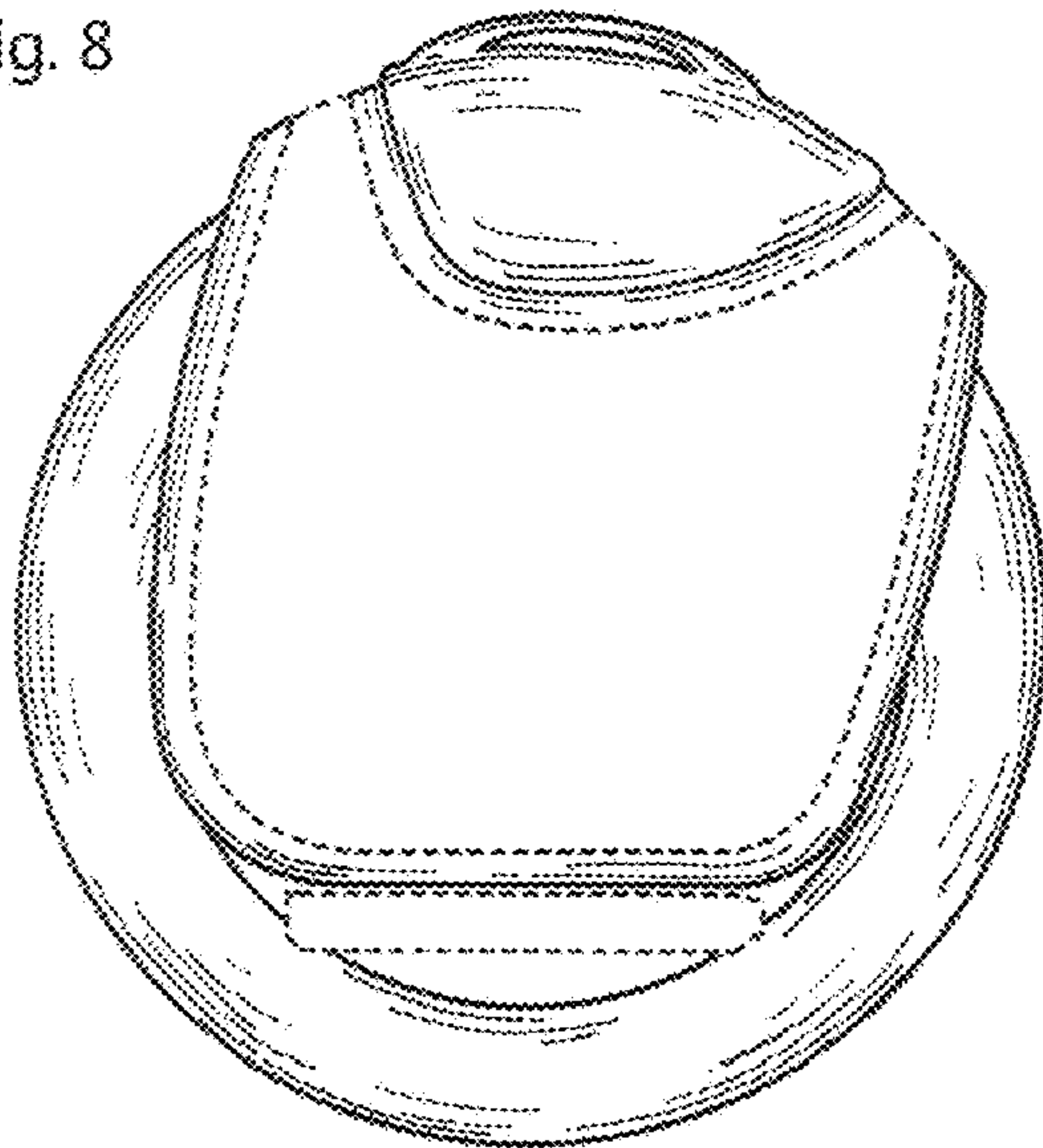

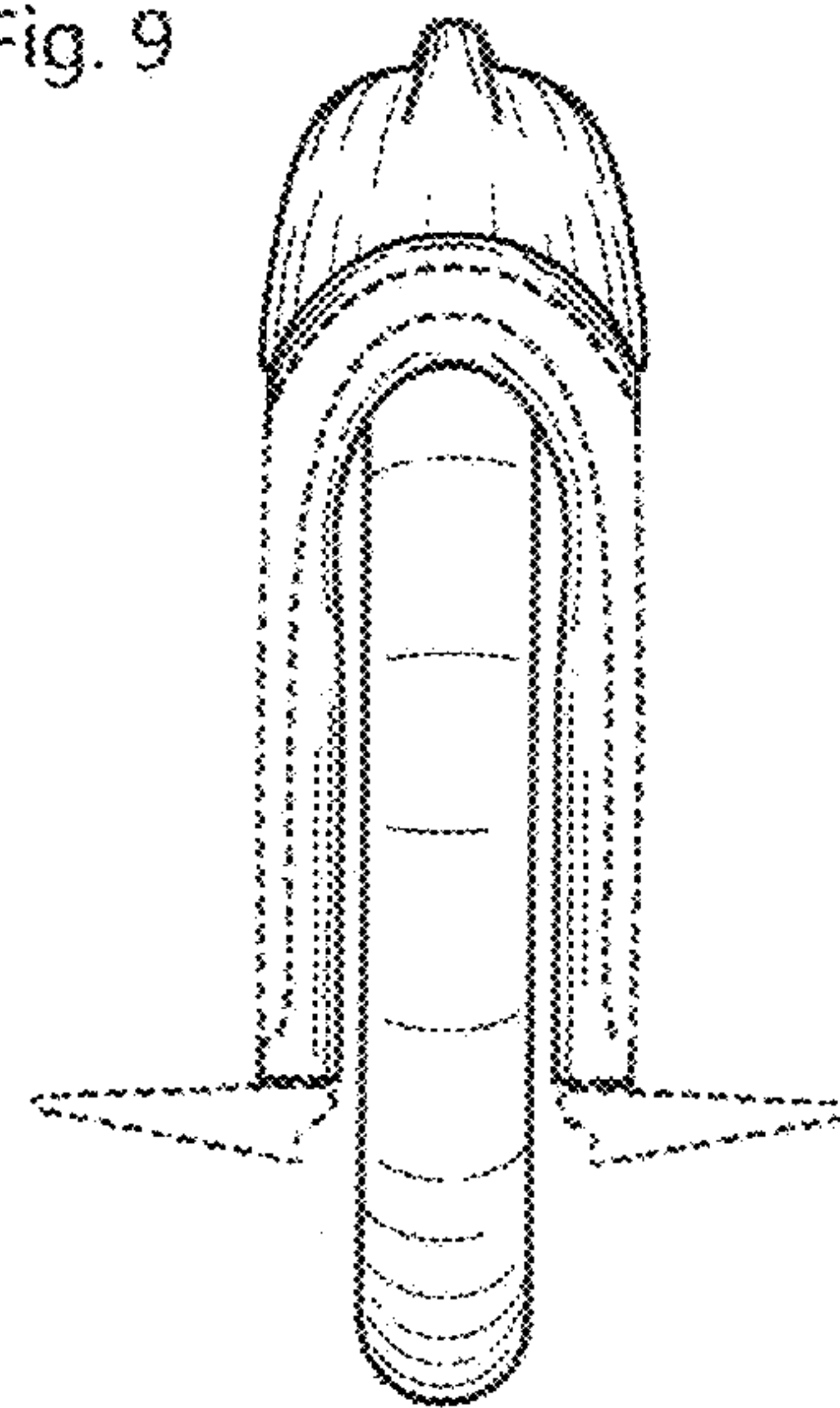

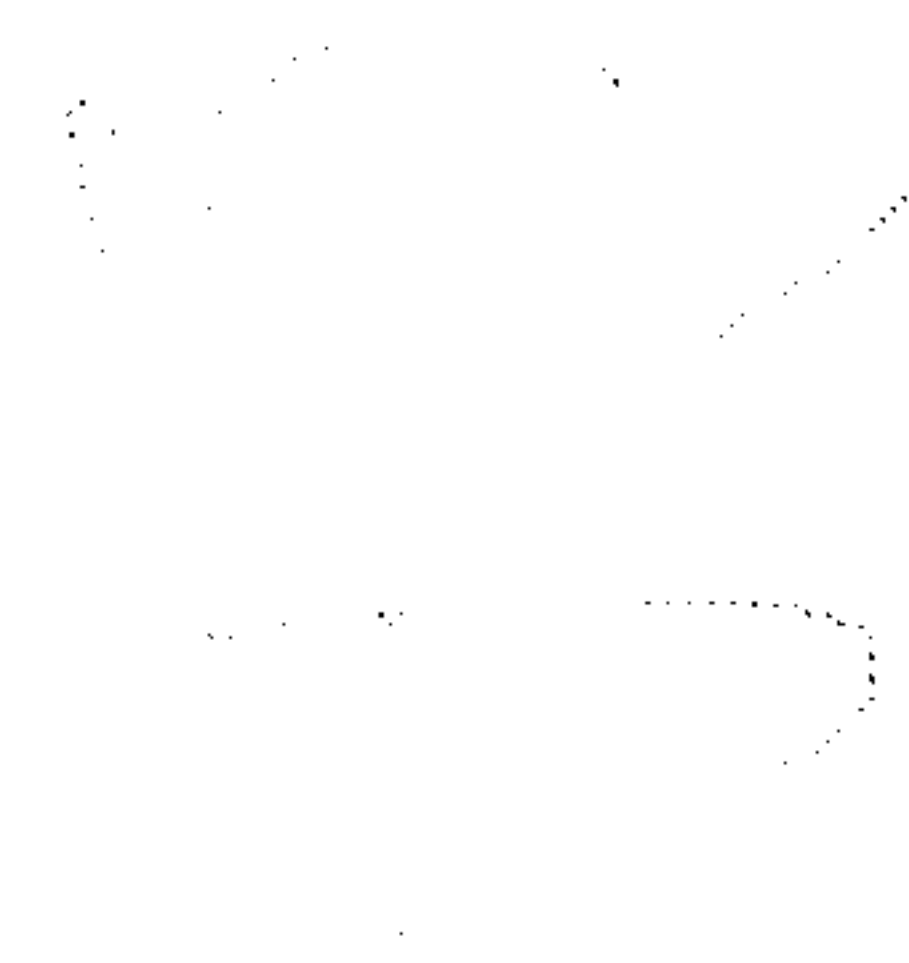
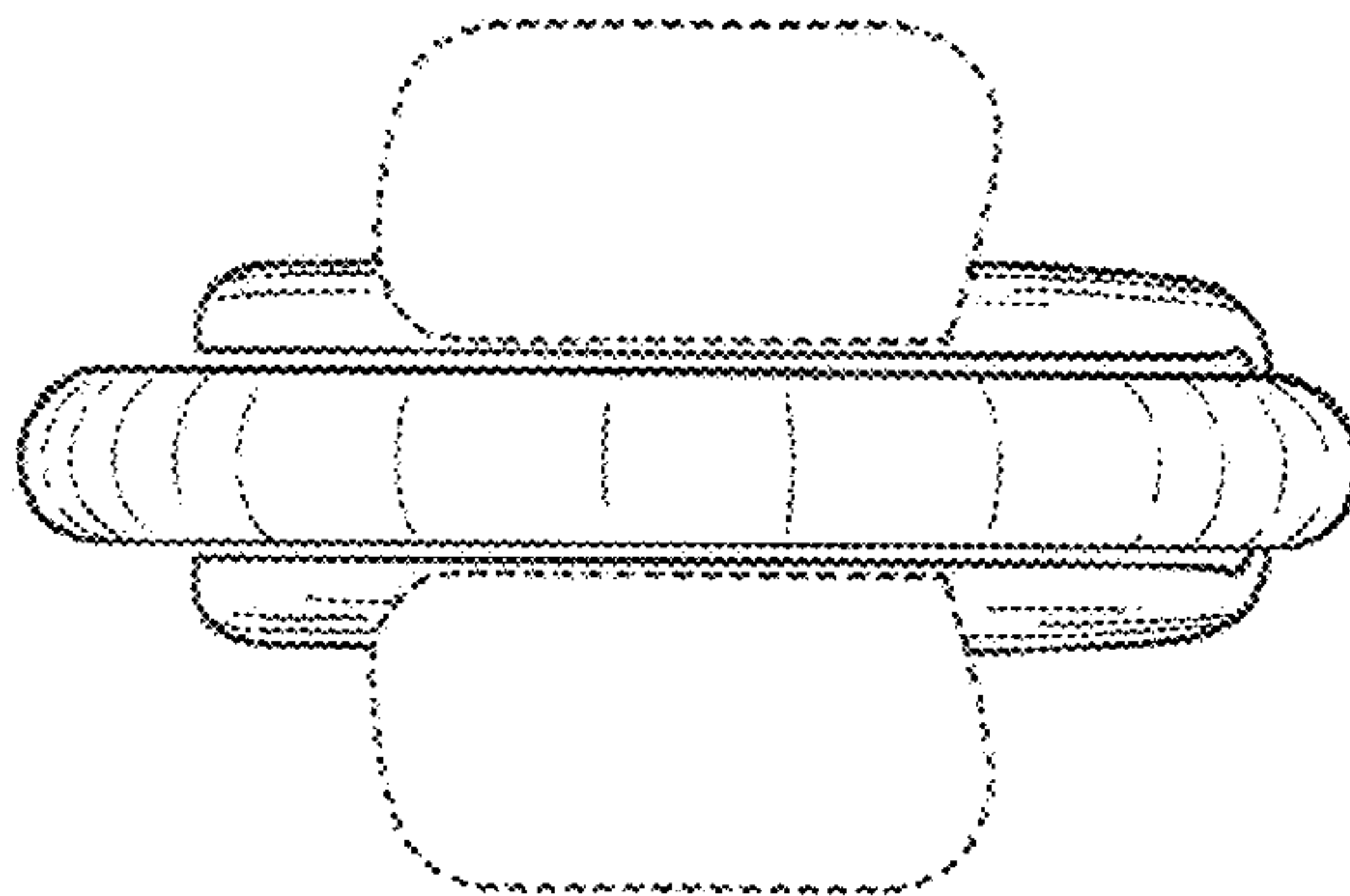

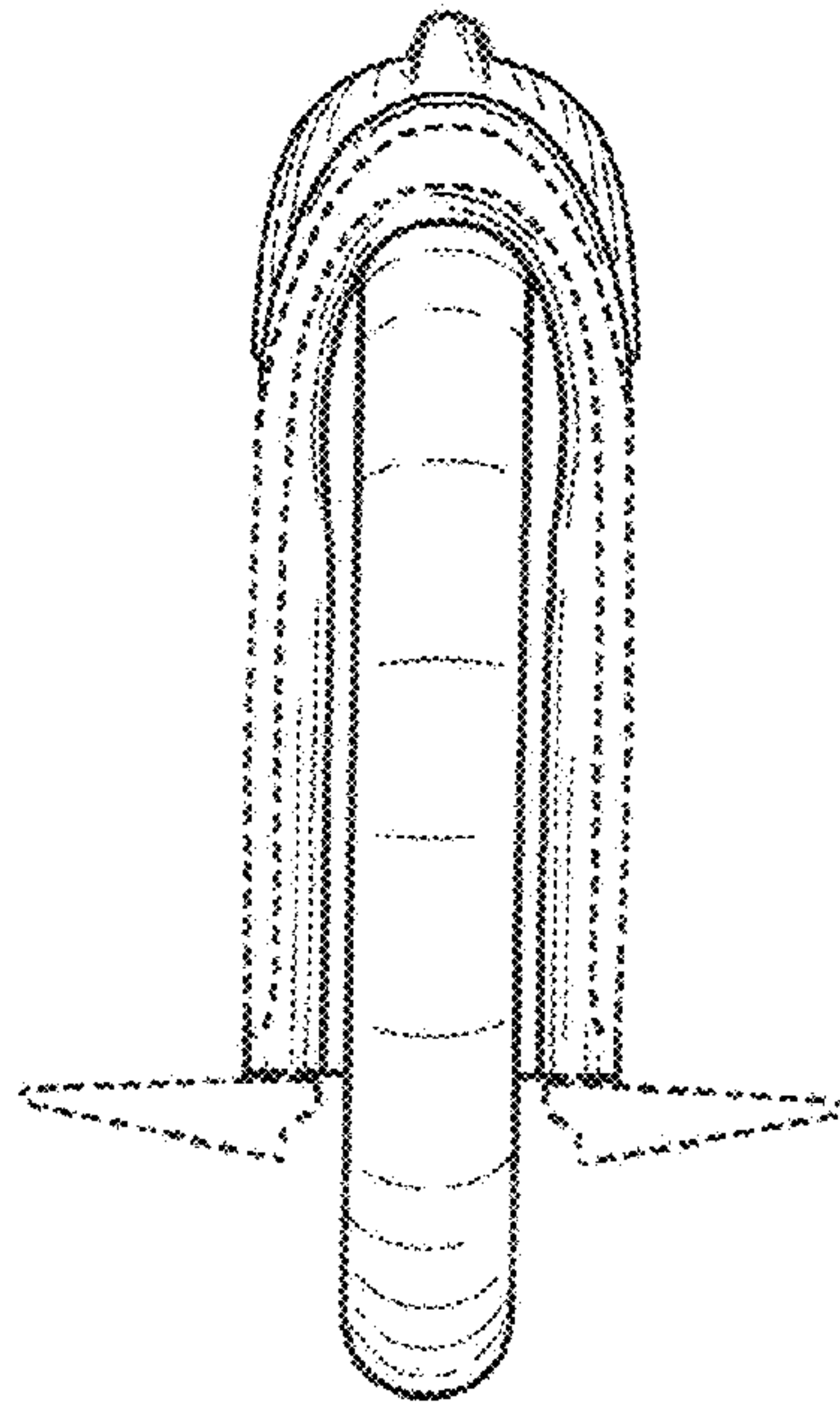
