FIG. 4 is a right side elevational view of the mobile telephone of FIG. 1;

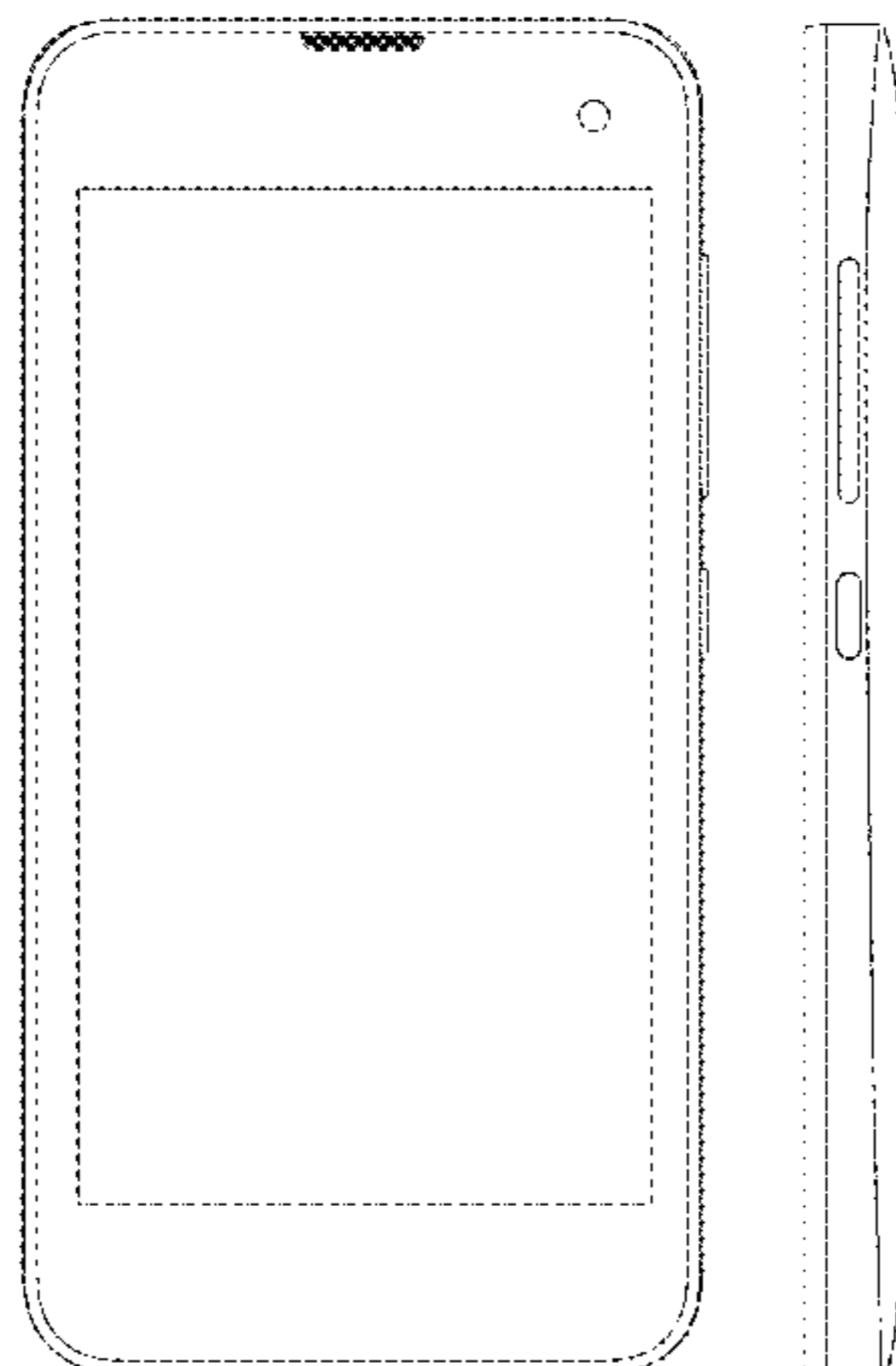
FIG. 5 is a top plan view of the mobile telephone of FIG. 1;

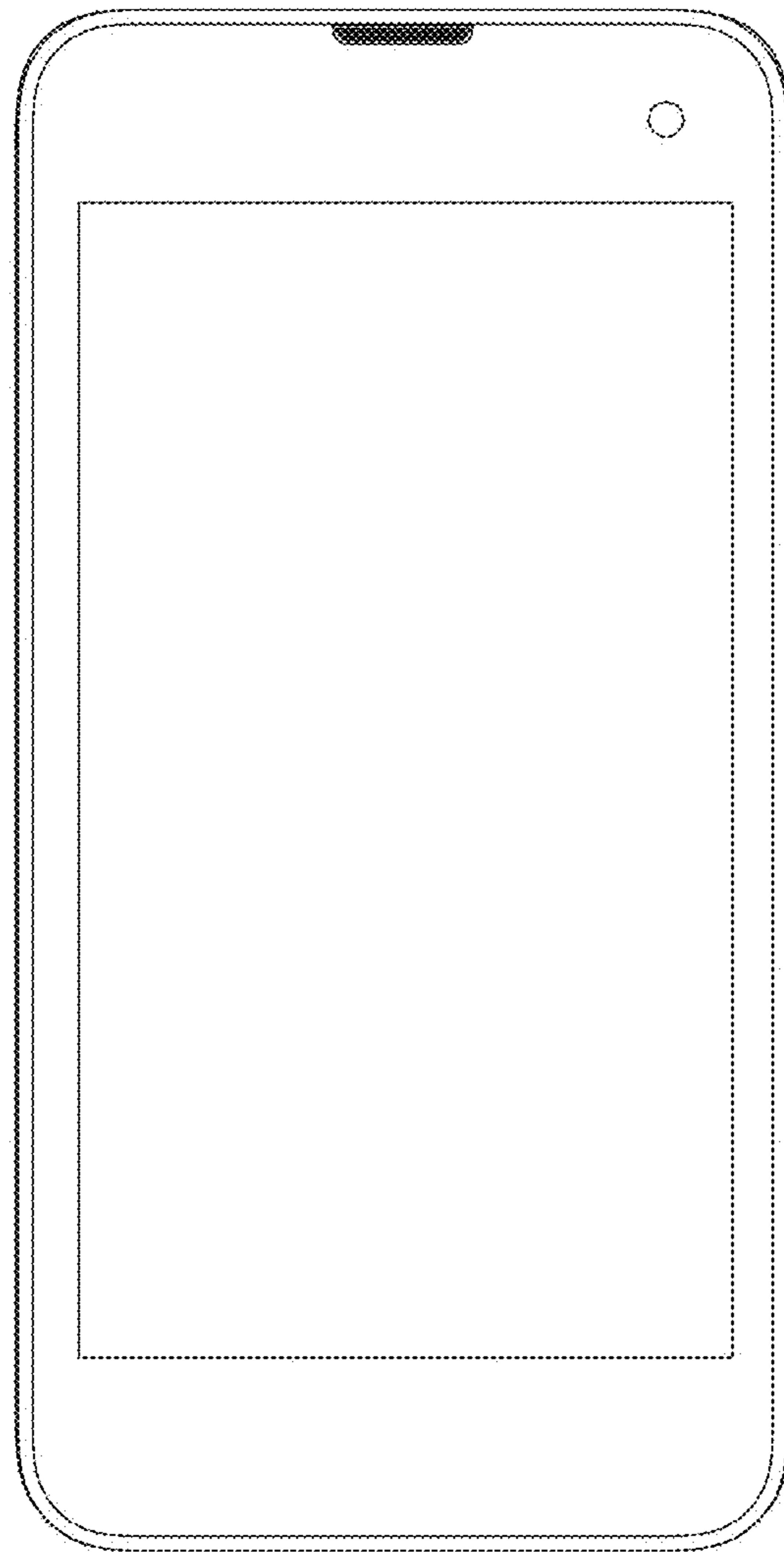

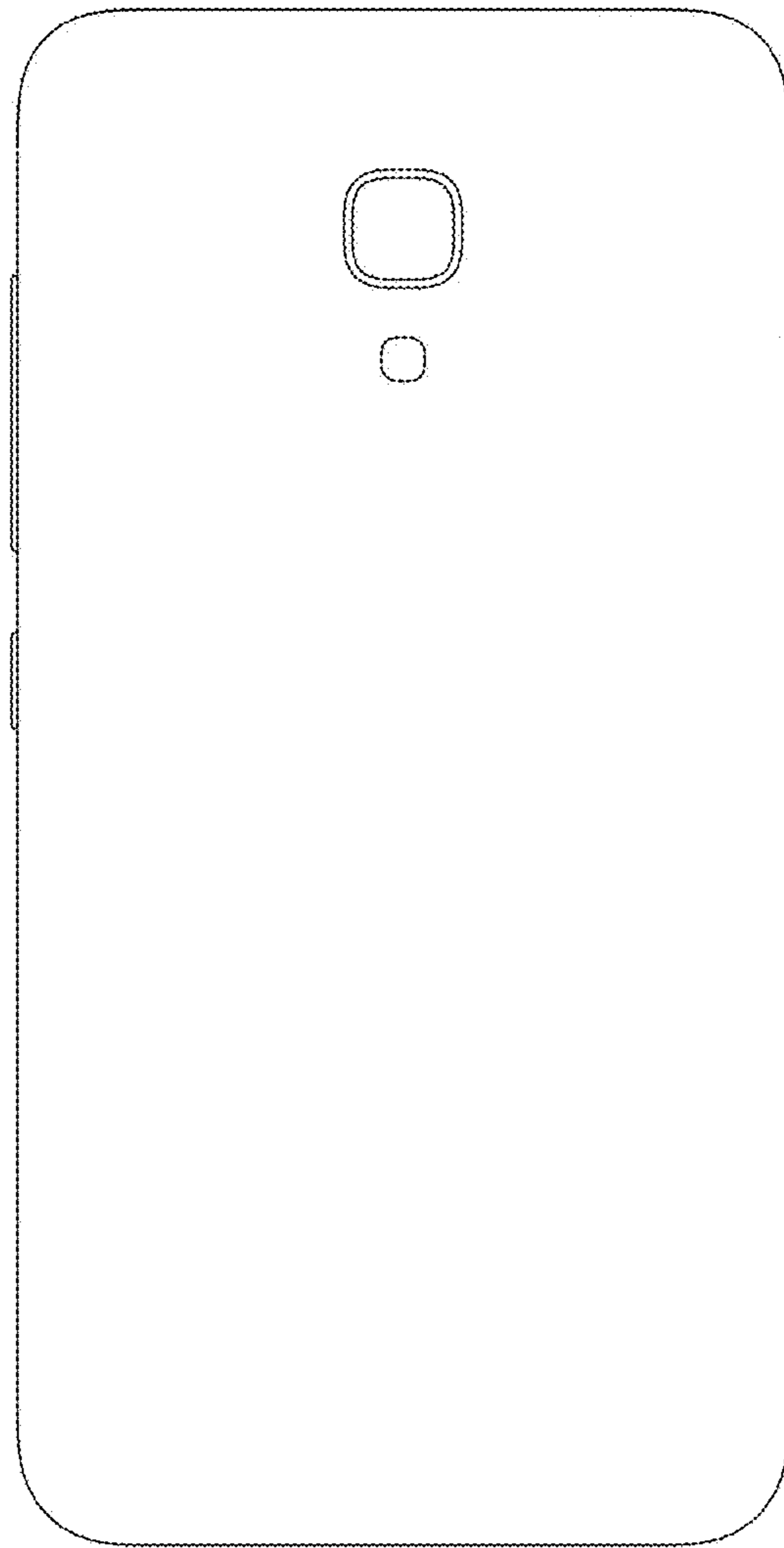

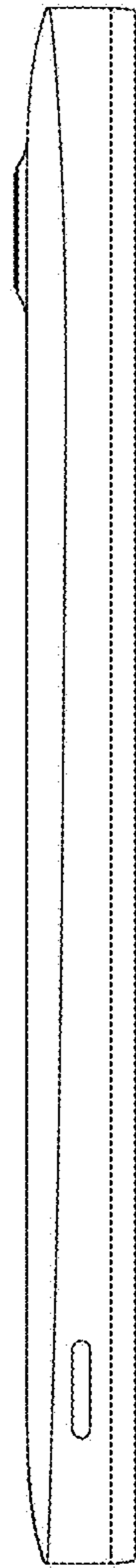

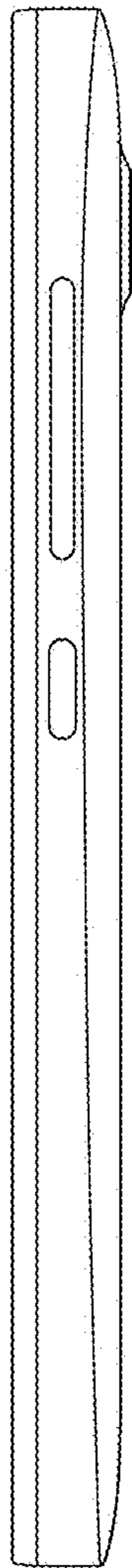

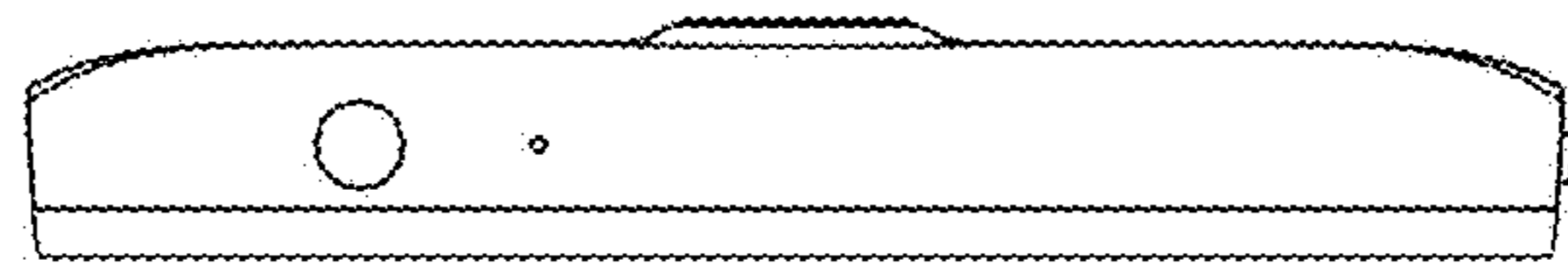

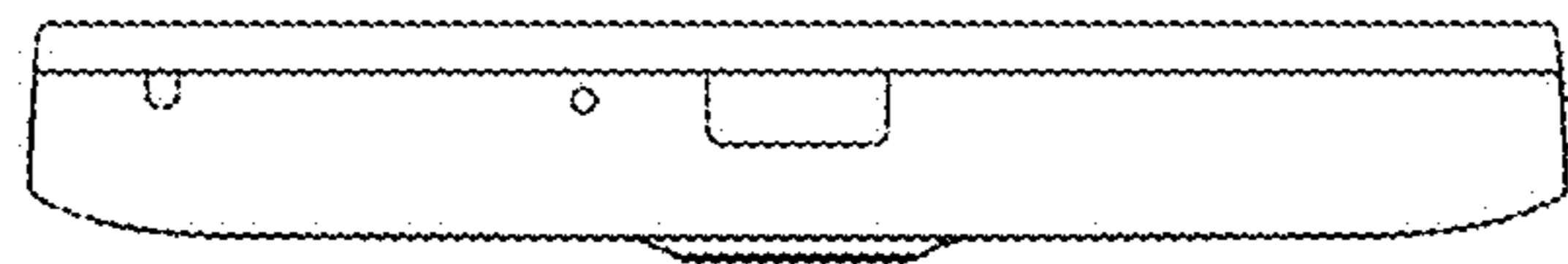

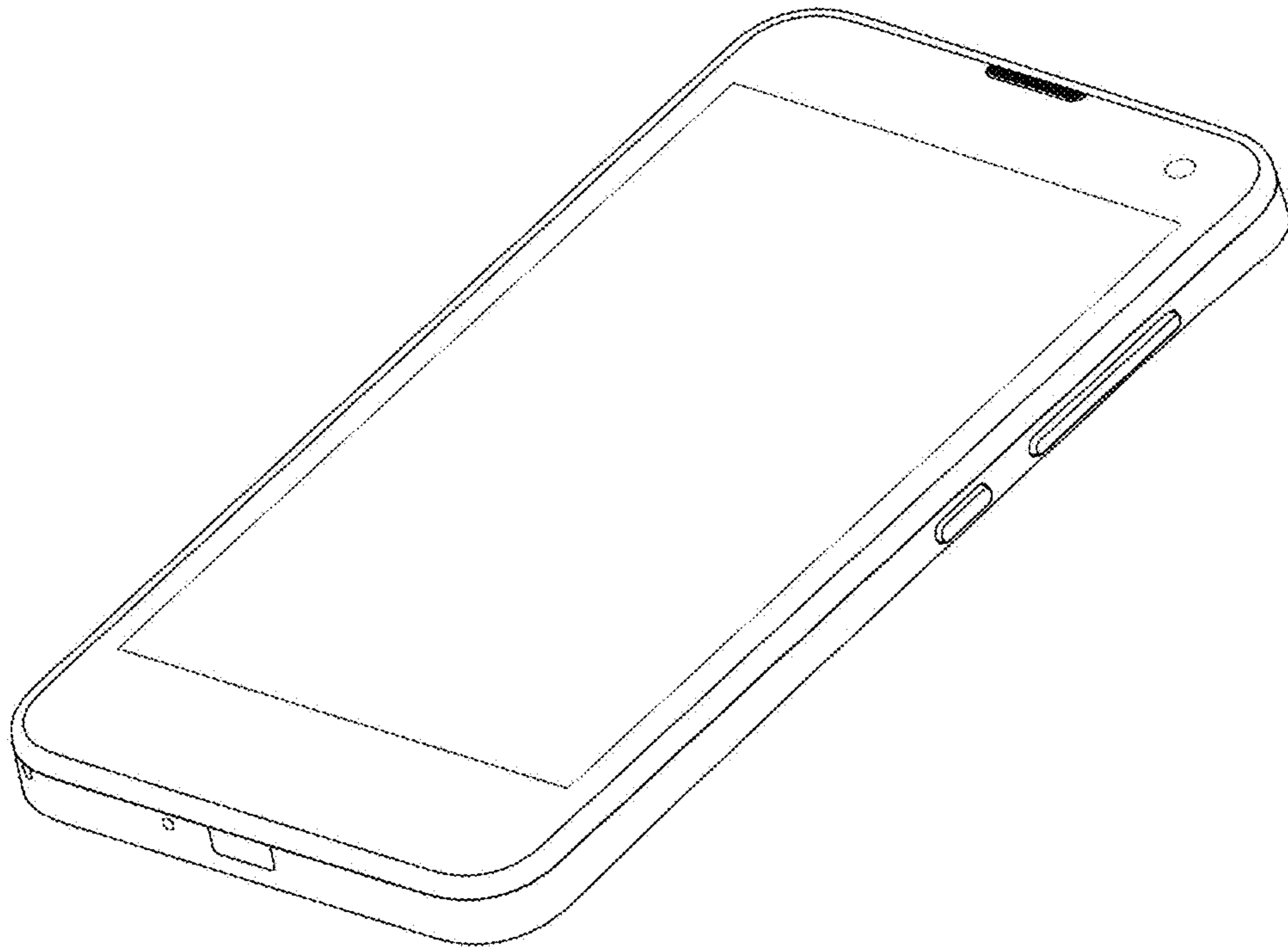

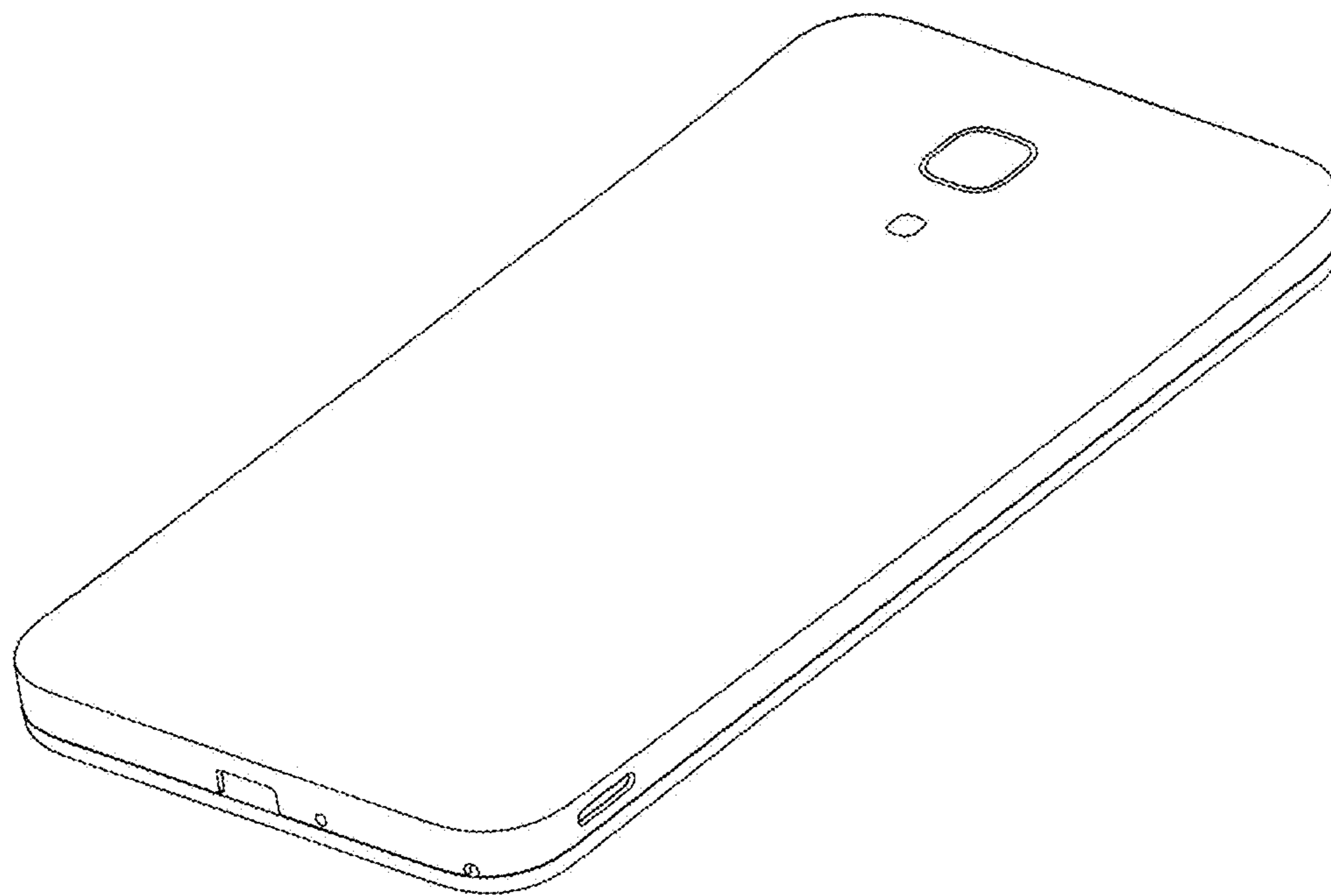
