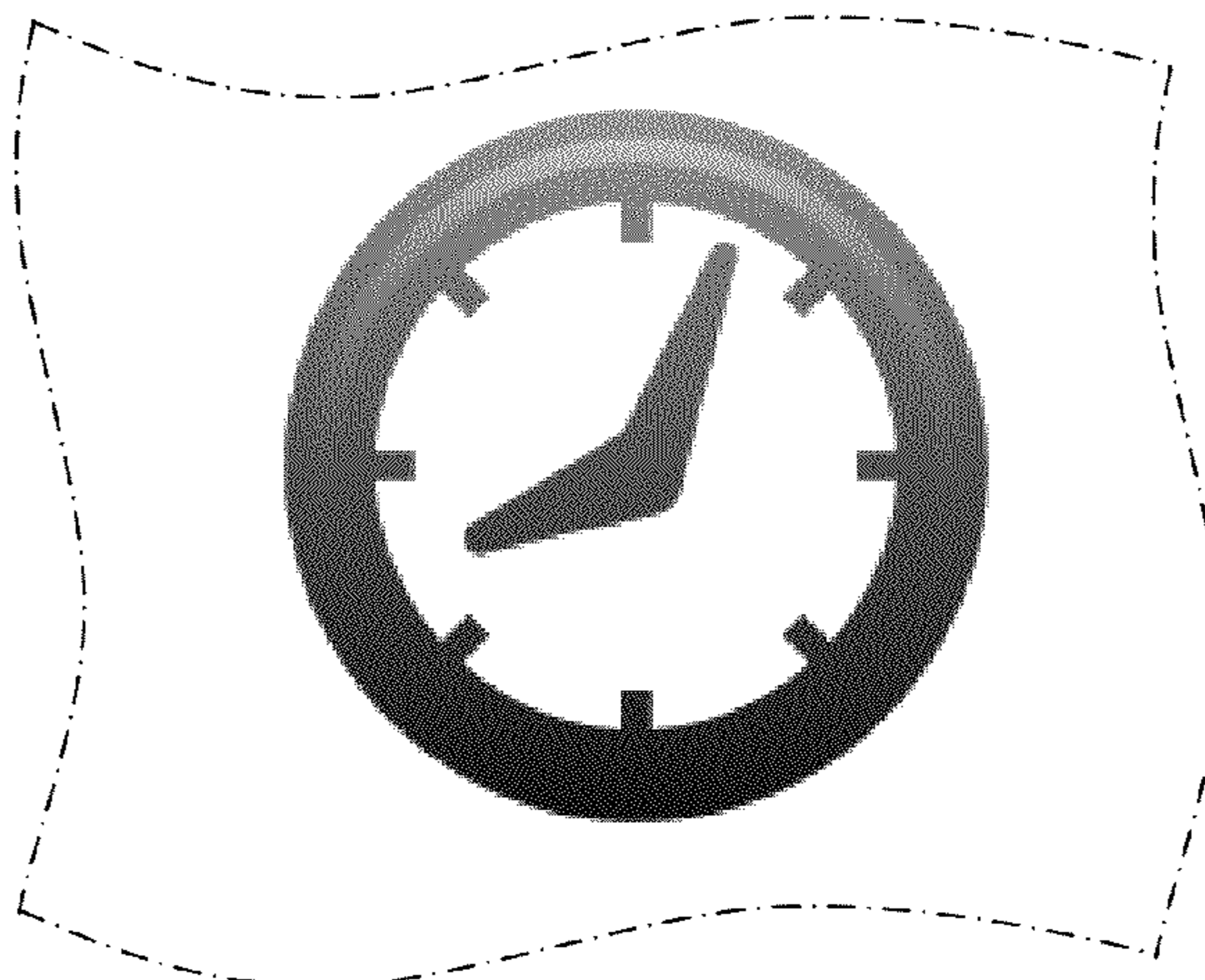
FIG. 1 is a front view of a display screen or portion thereof with icon showing our new design;

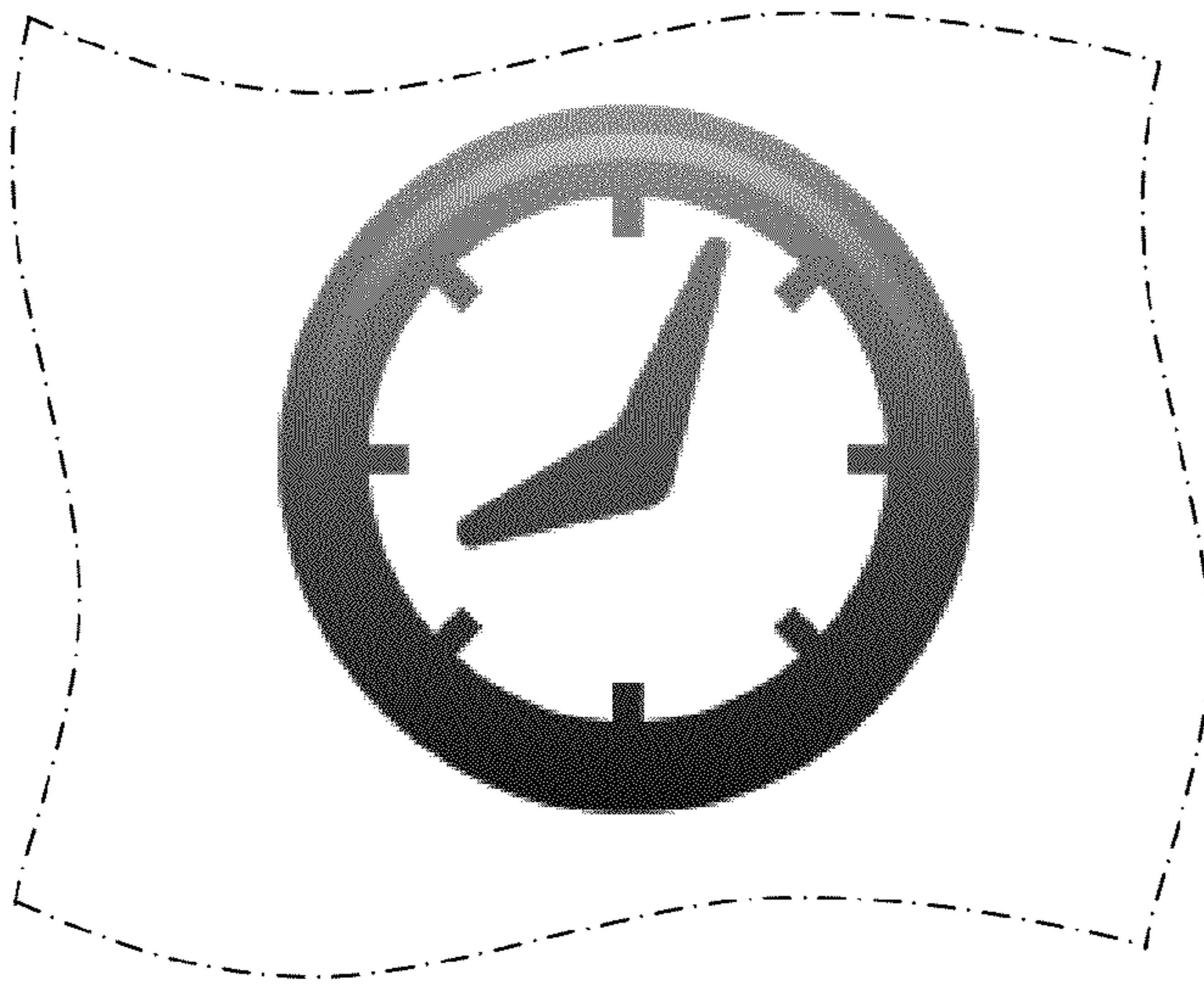

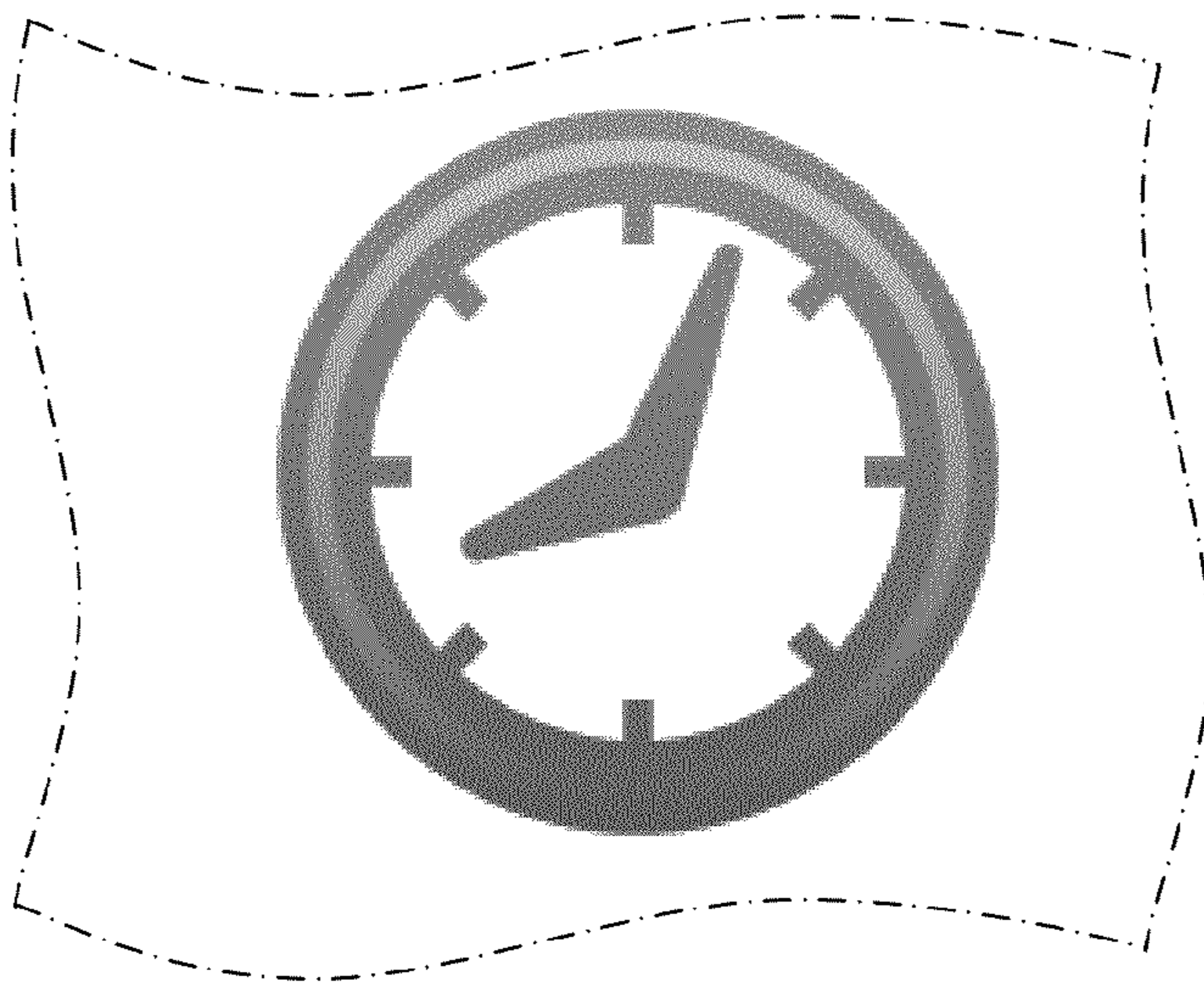

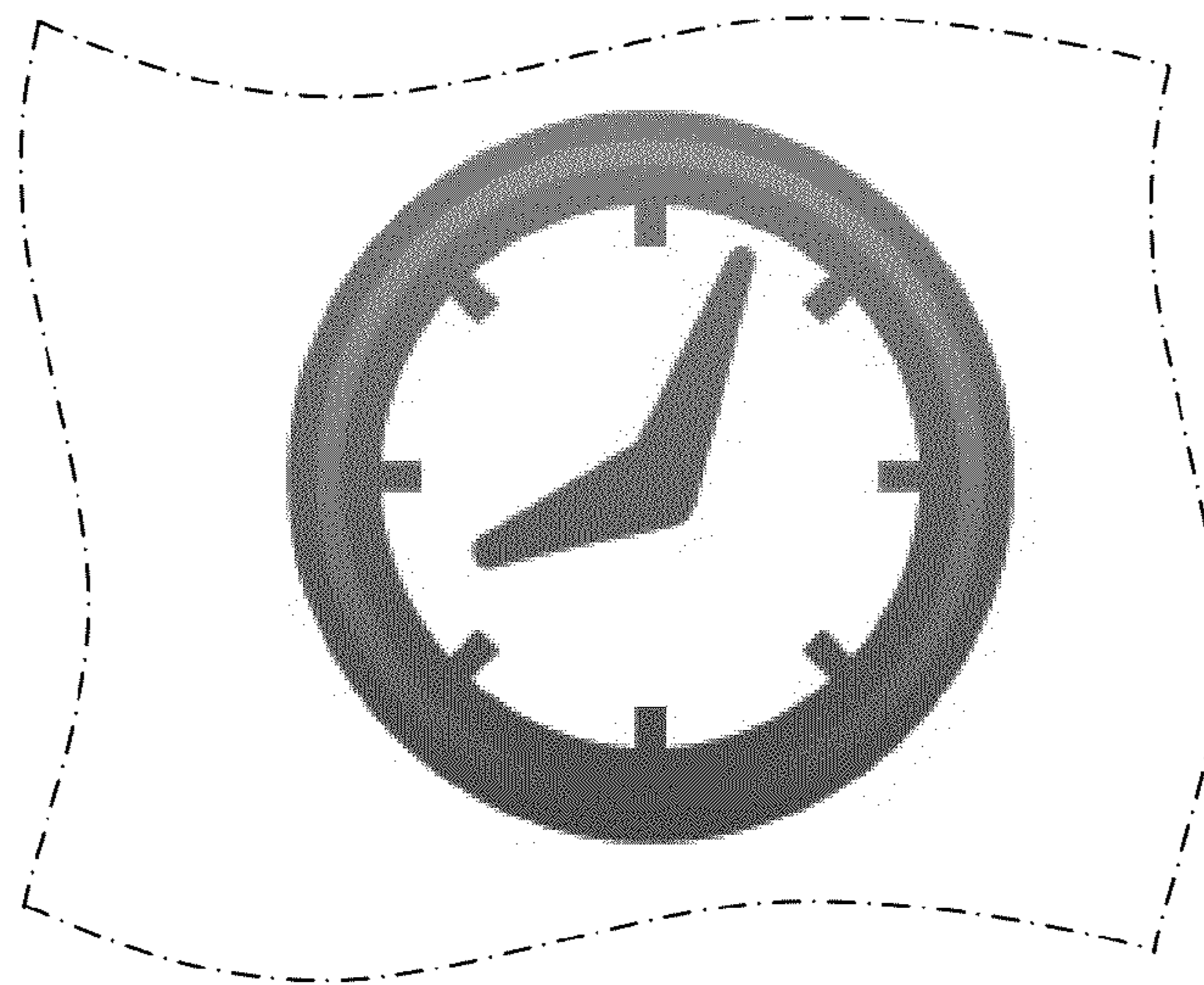
