(57) **CLAIM**

The ornamental design for a display screen or portion thereof with icon, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with icon, showing my new design;

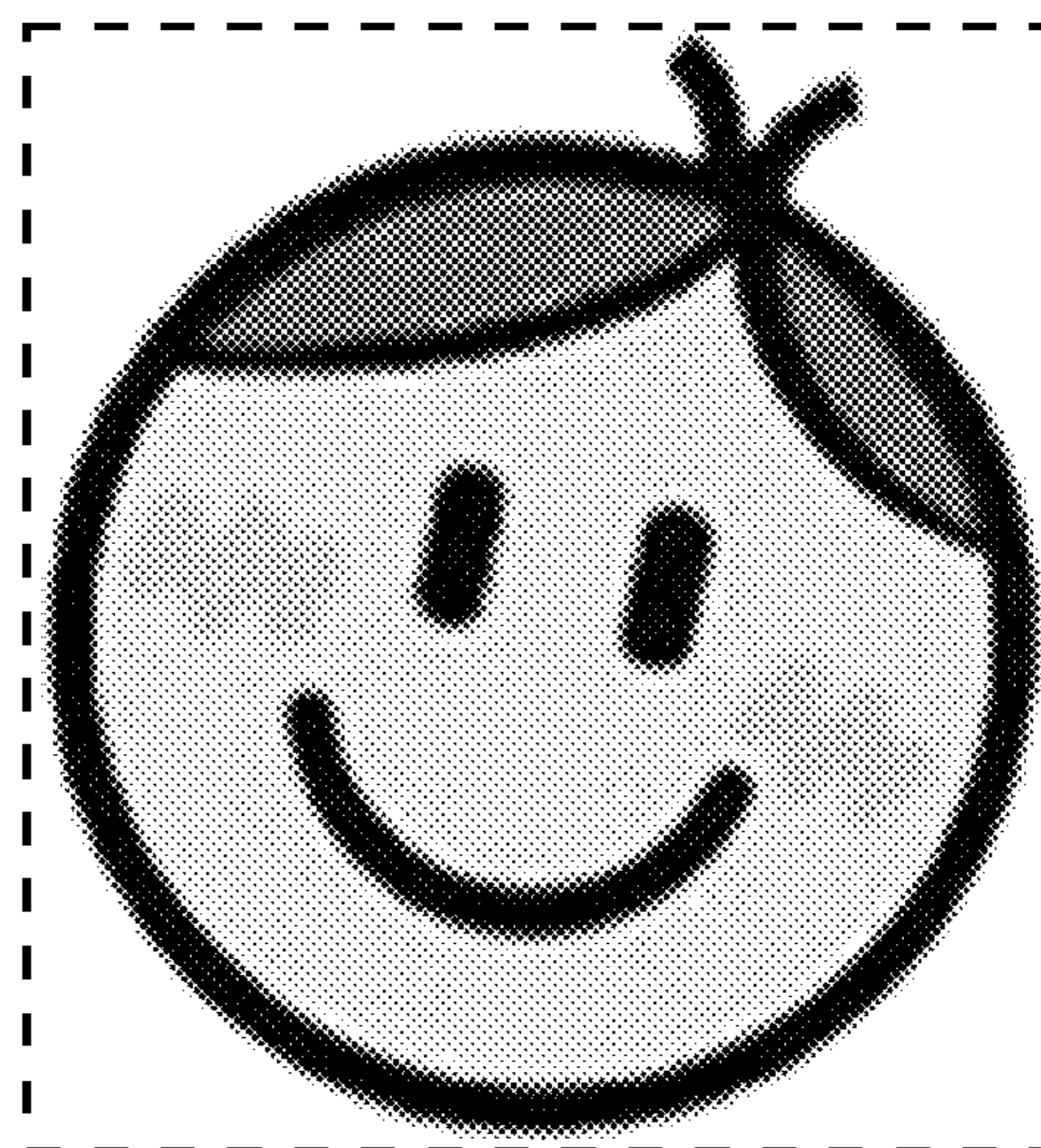
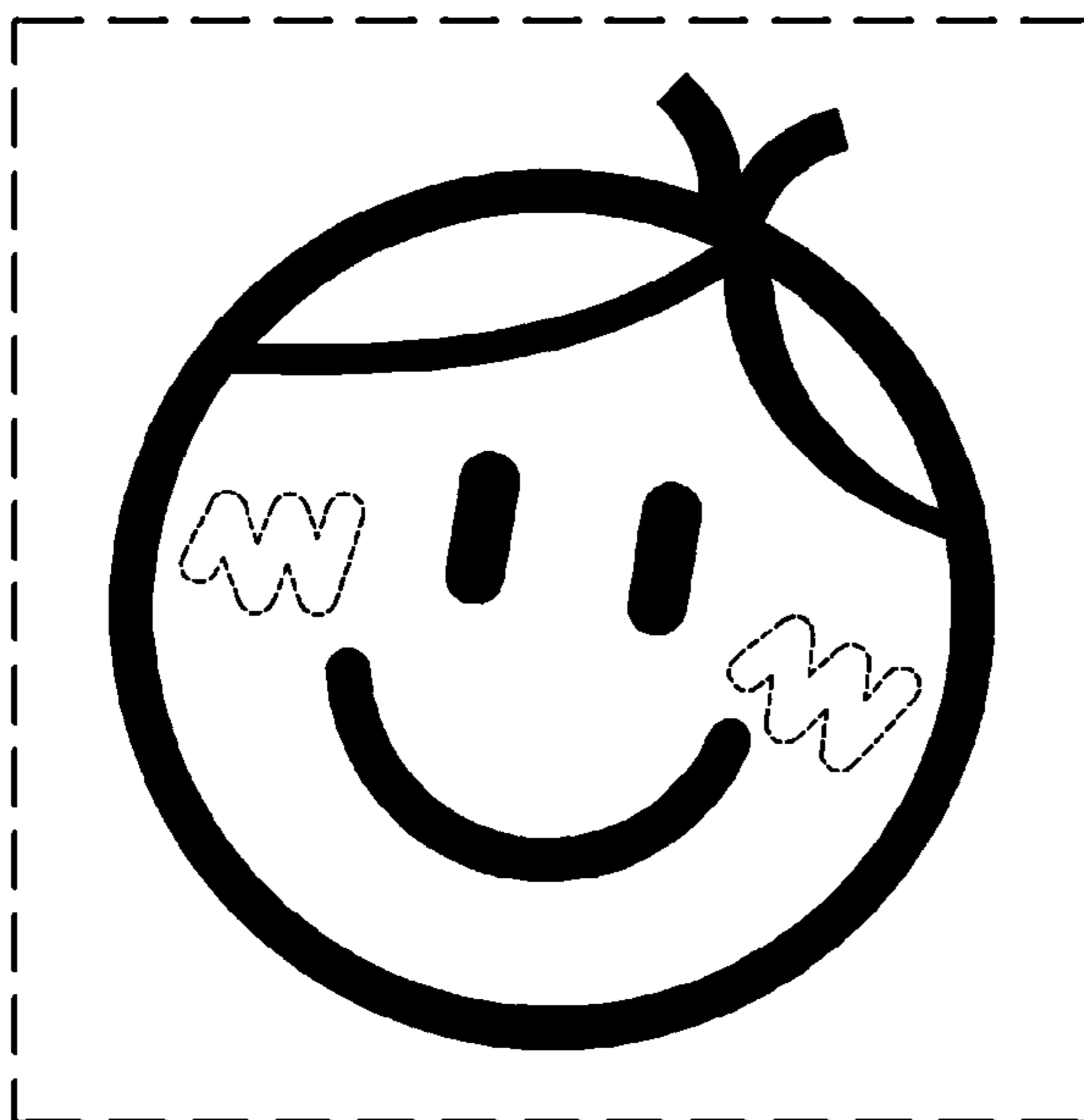

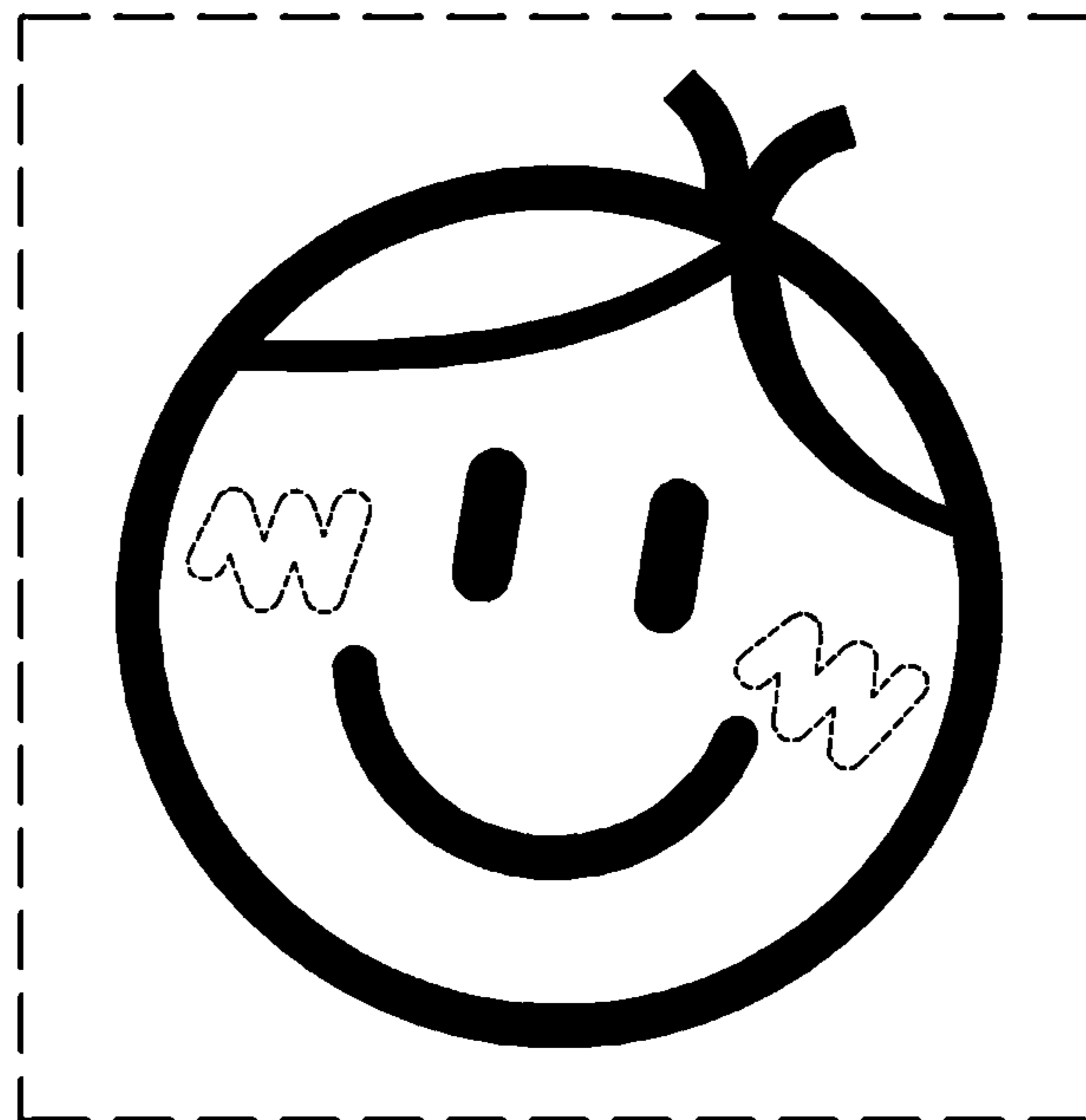

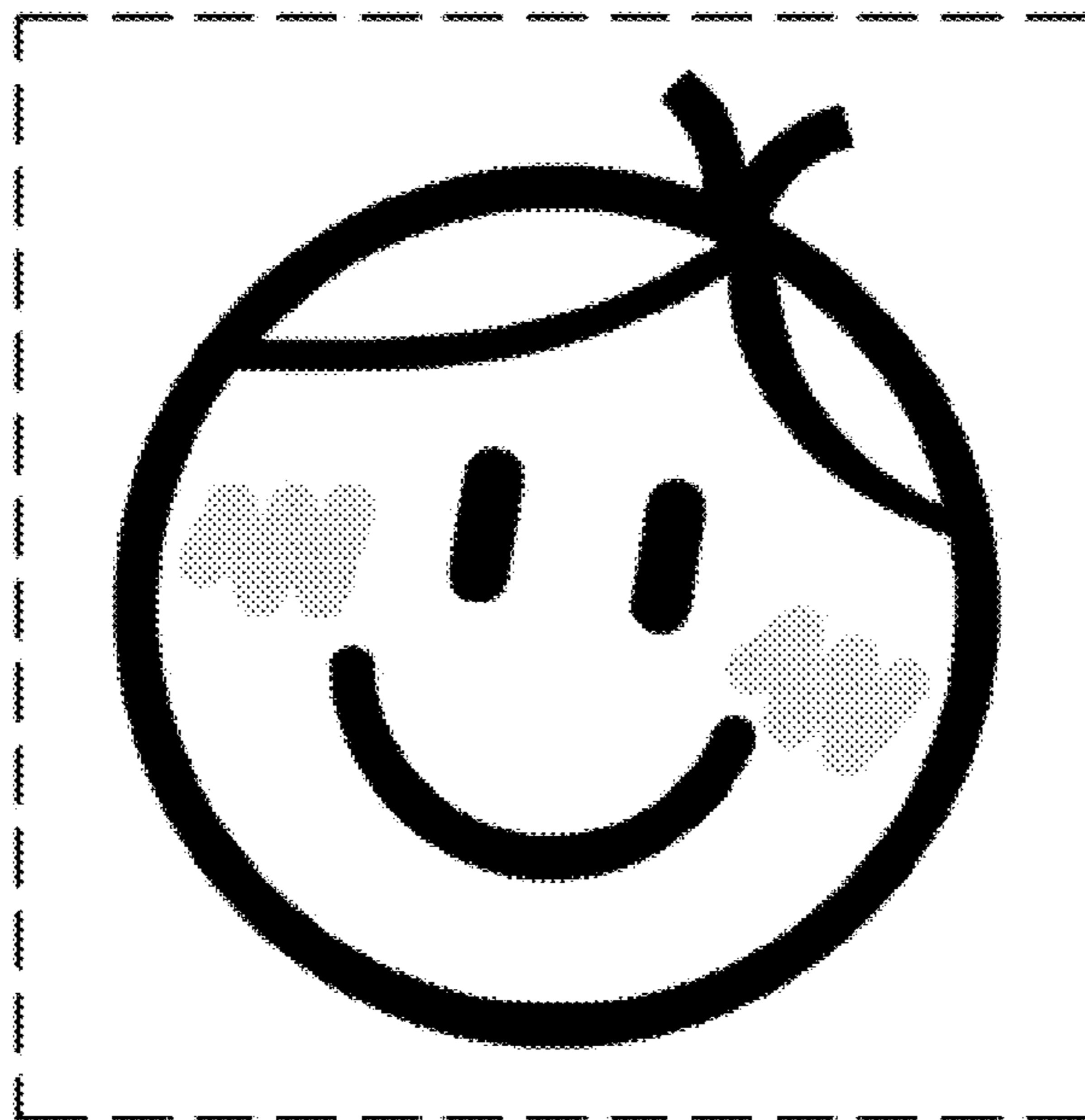
