(57) **CLAIM**

The ornamental design for a pocket folder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the first embodiment of a pocket folder.

FIG. 2 is a front plan thereof.

FIG. 3 is a back plan thereof.

FIG. 4 is a side view, the two sides being mirror images of each other with only one shown thereof.

FIG. 5 is a top plan thereof.

FIG. 6 is a bottom plan thereof.

FIG. 7 is an inside front plan view of the blank on which the folder is made before folding.

FIG. 8 is a perspective view of the second embodiment.

FIG. 9 is a front plan view of the second embodiment.

FIG. 10 is a back view of the second embodiment.

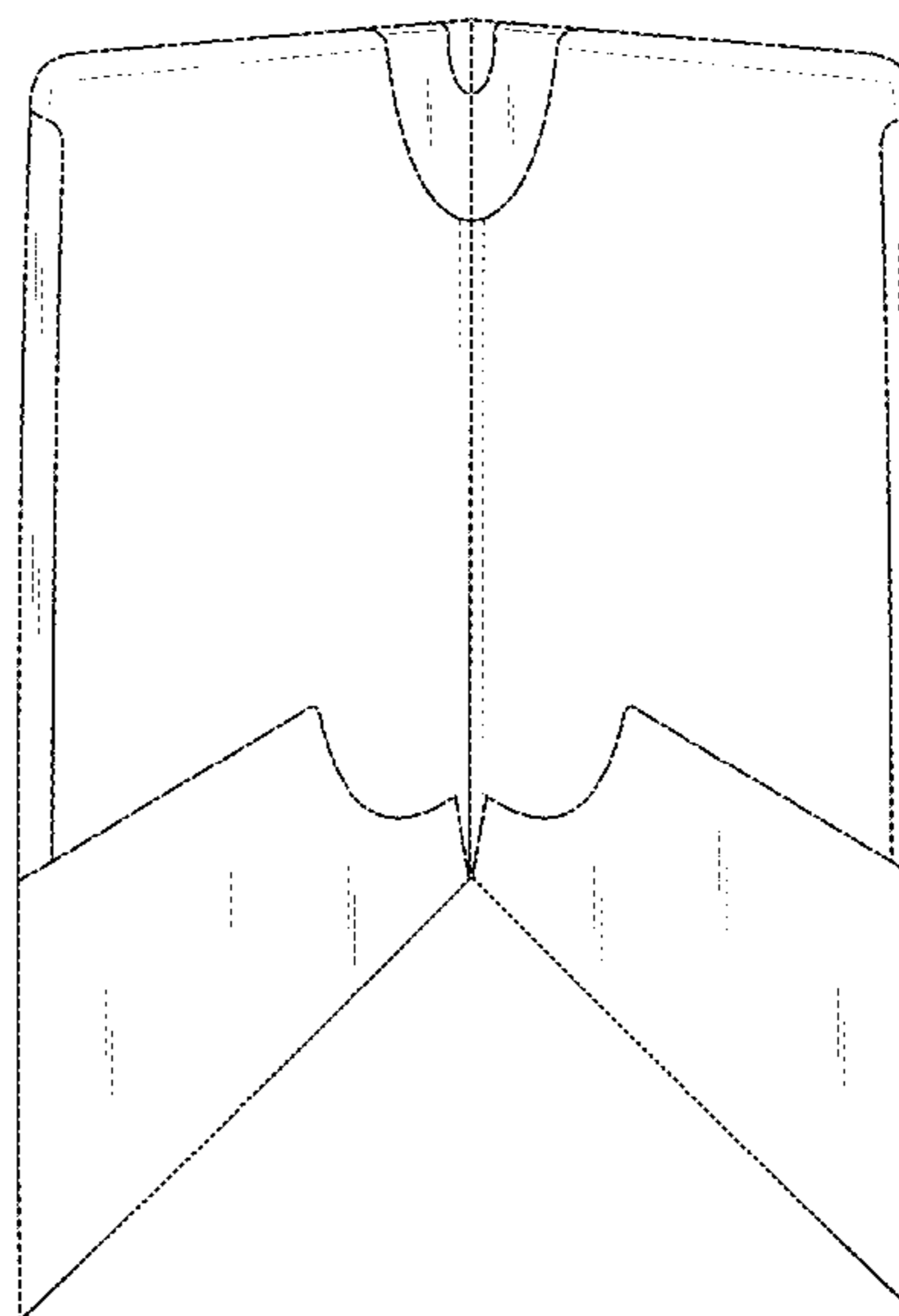
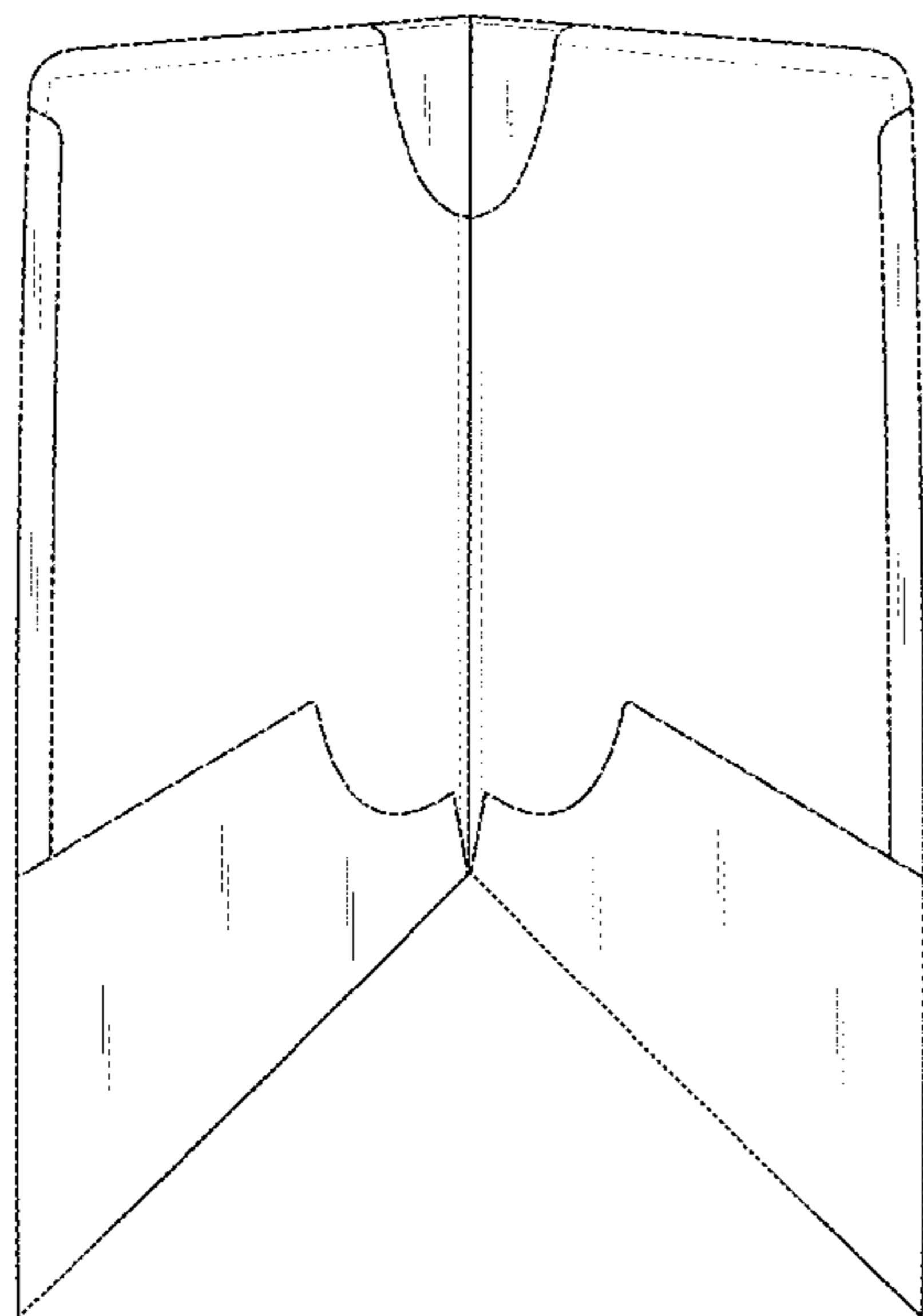
FIG. 11 is a side view like FIG. 4, the two sides being mirror images of each other with only one shown thereof.

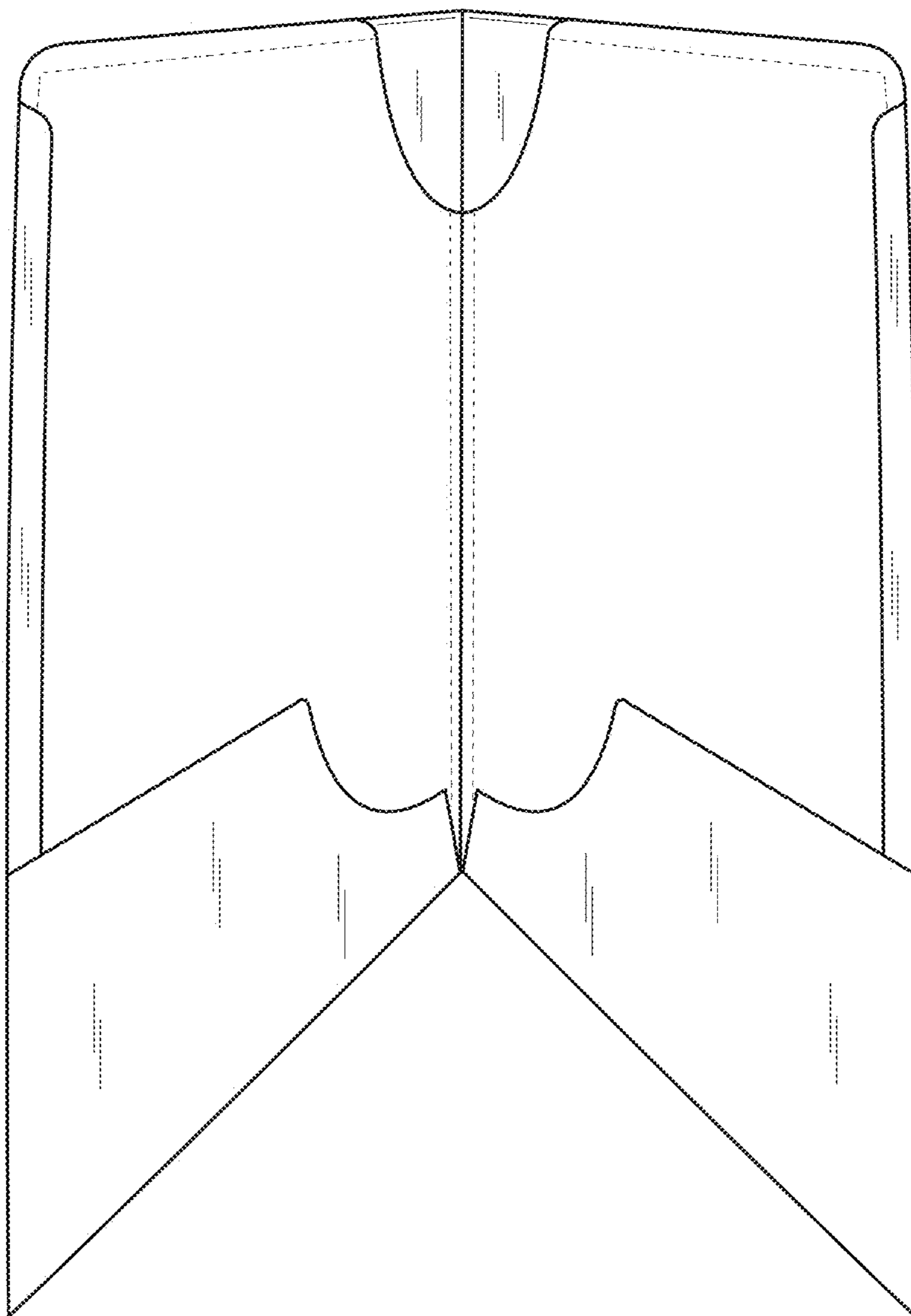

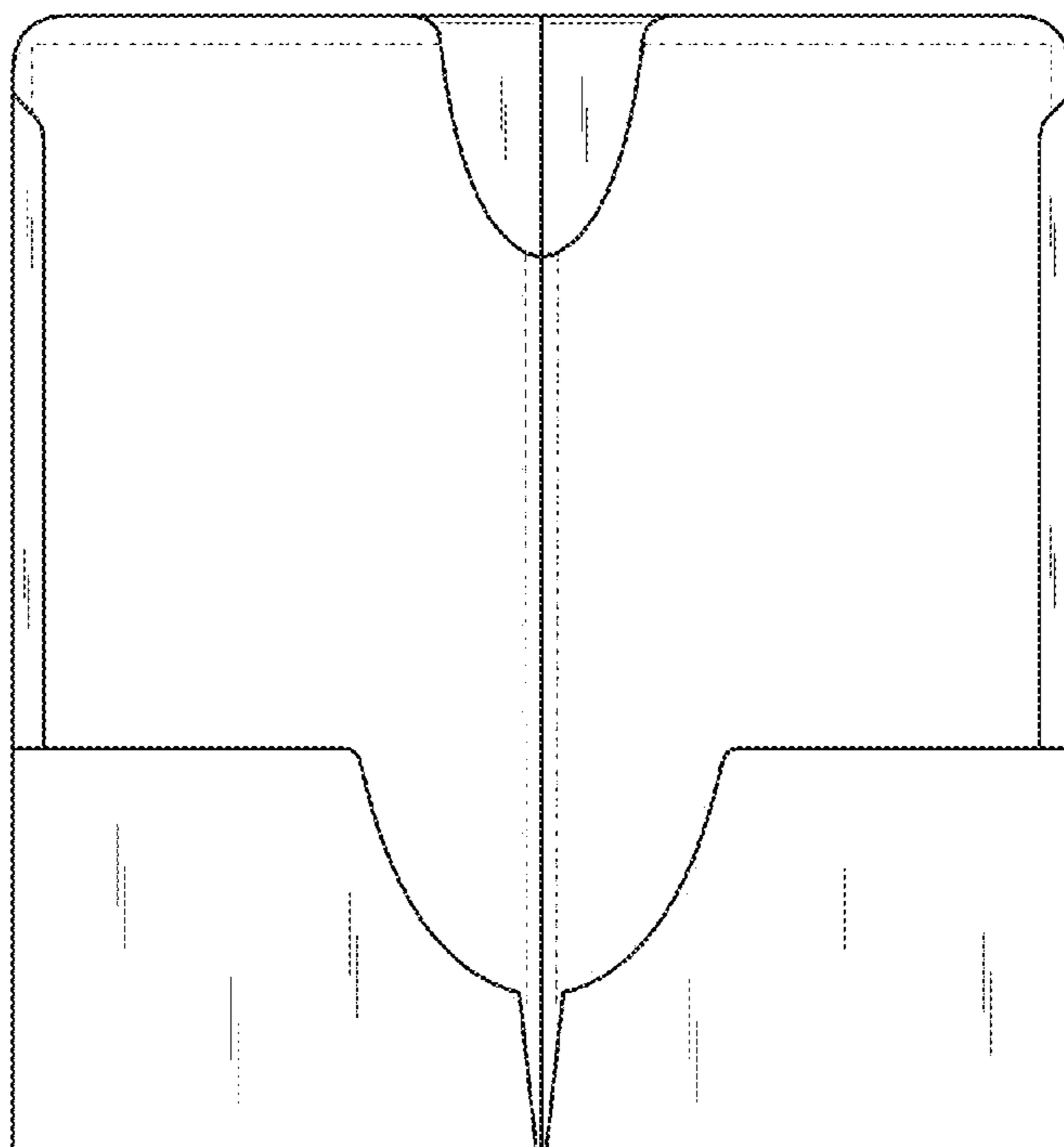

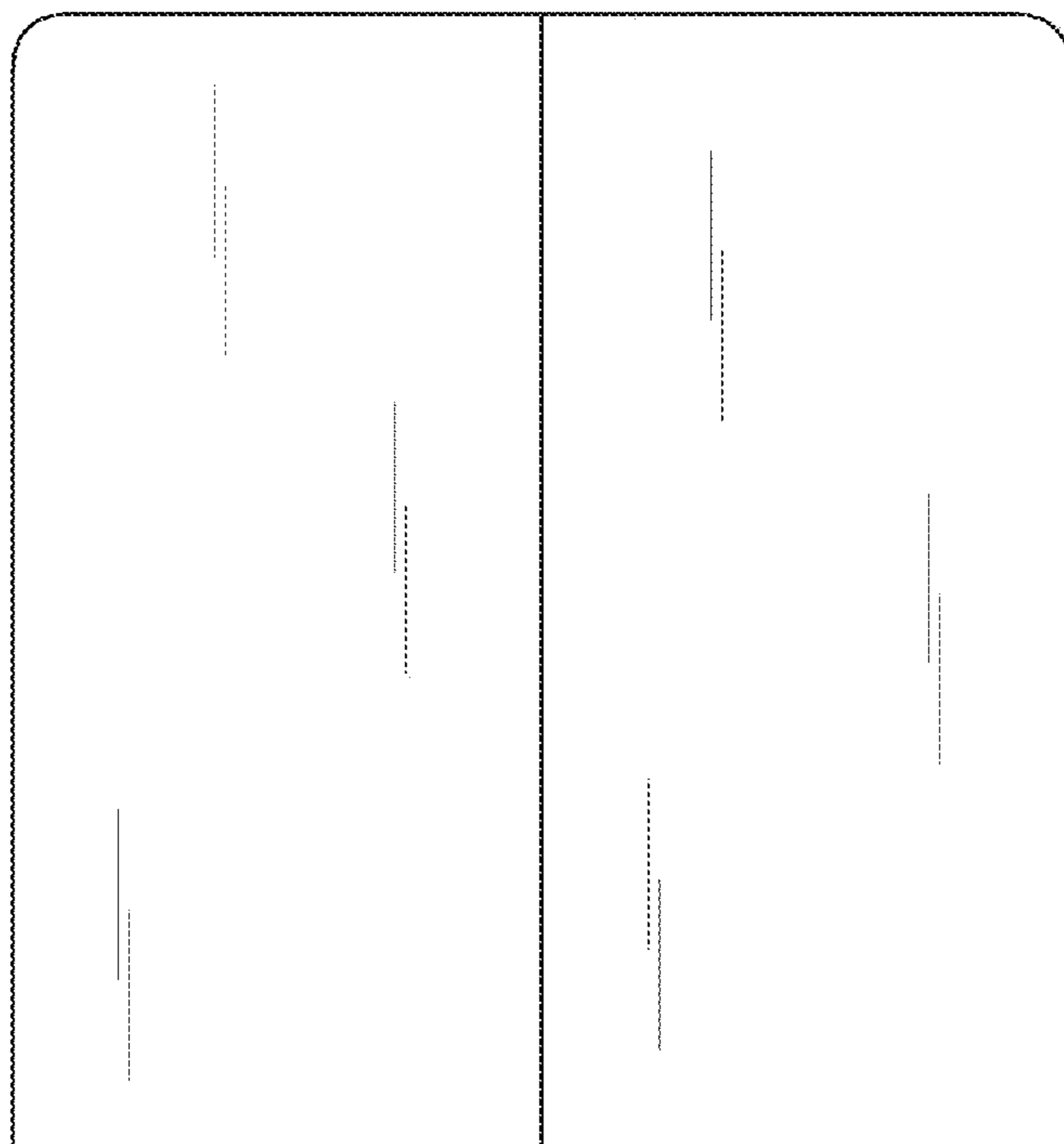

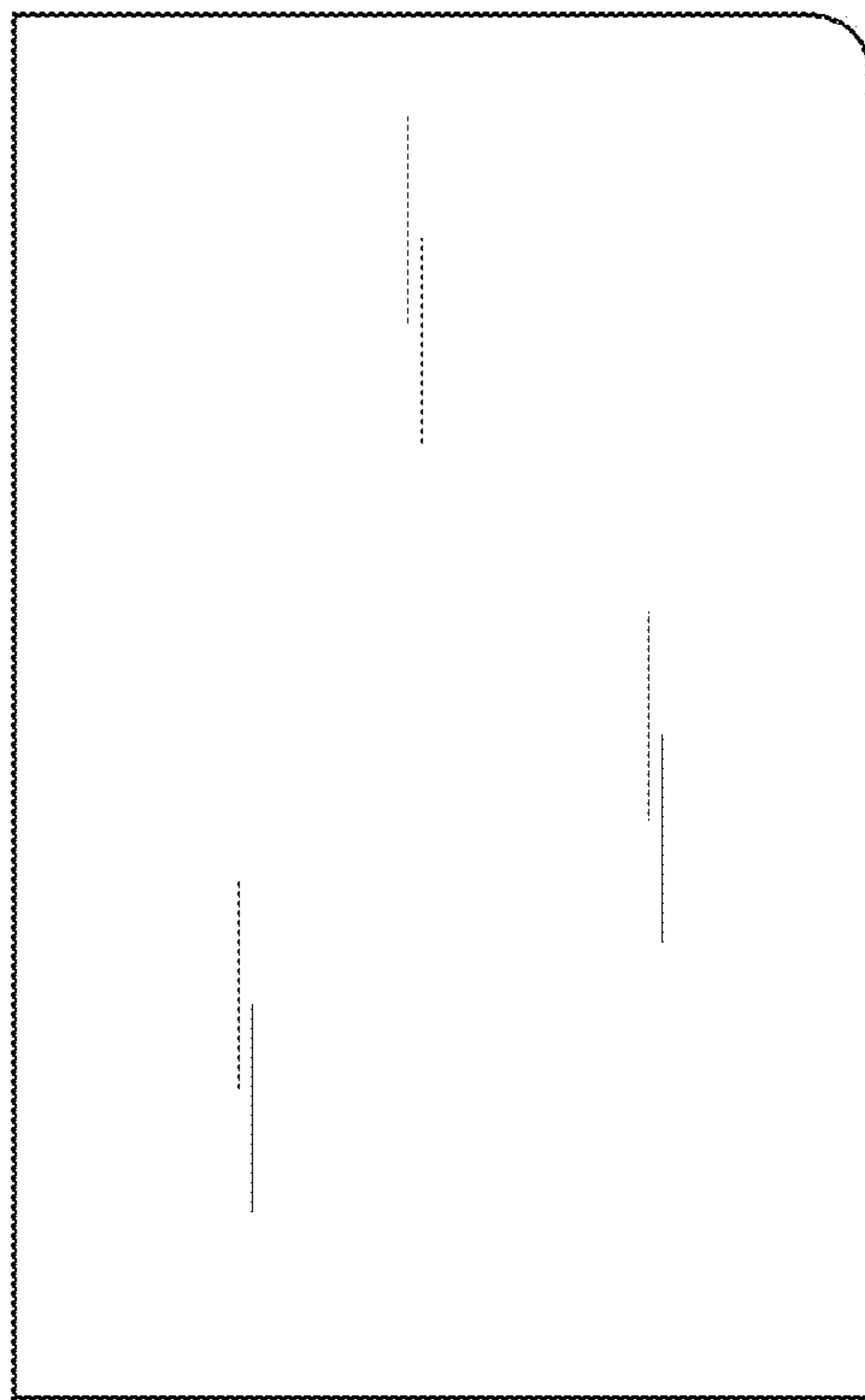

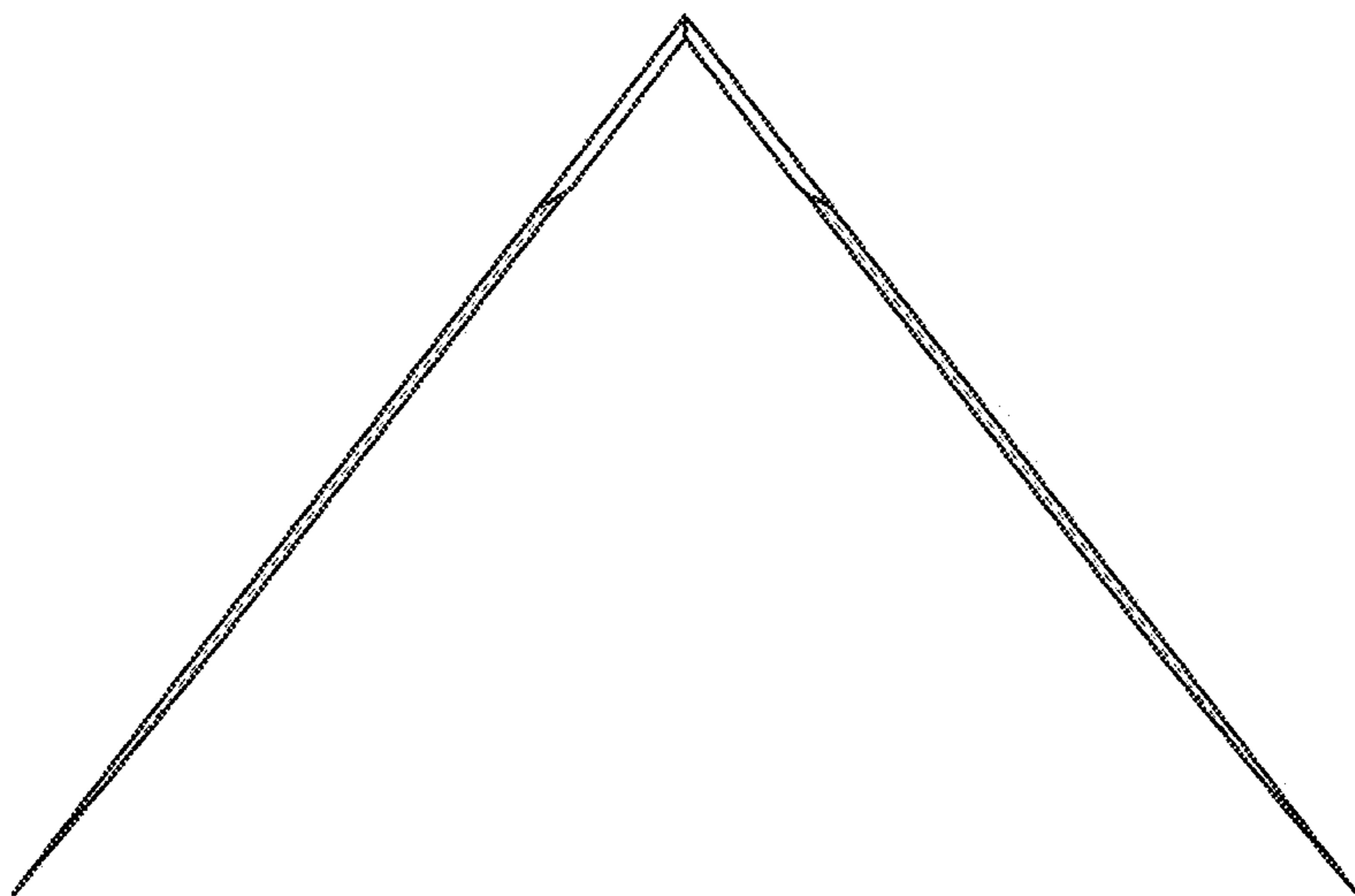

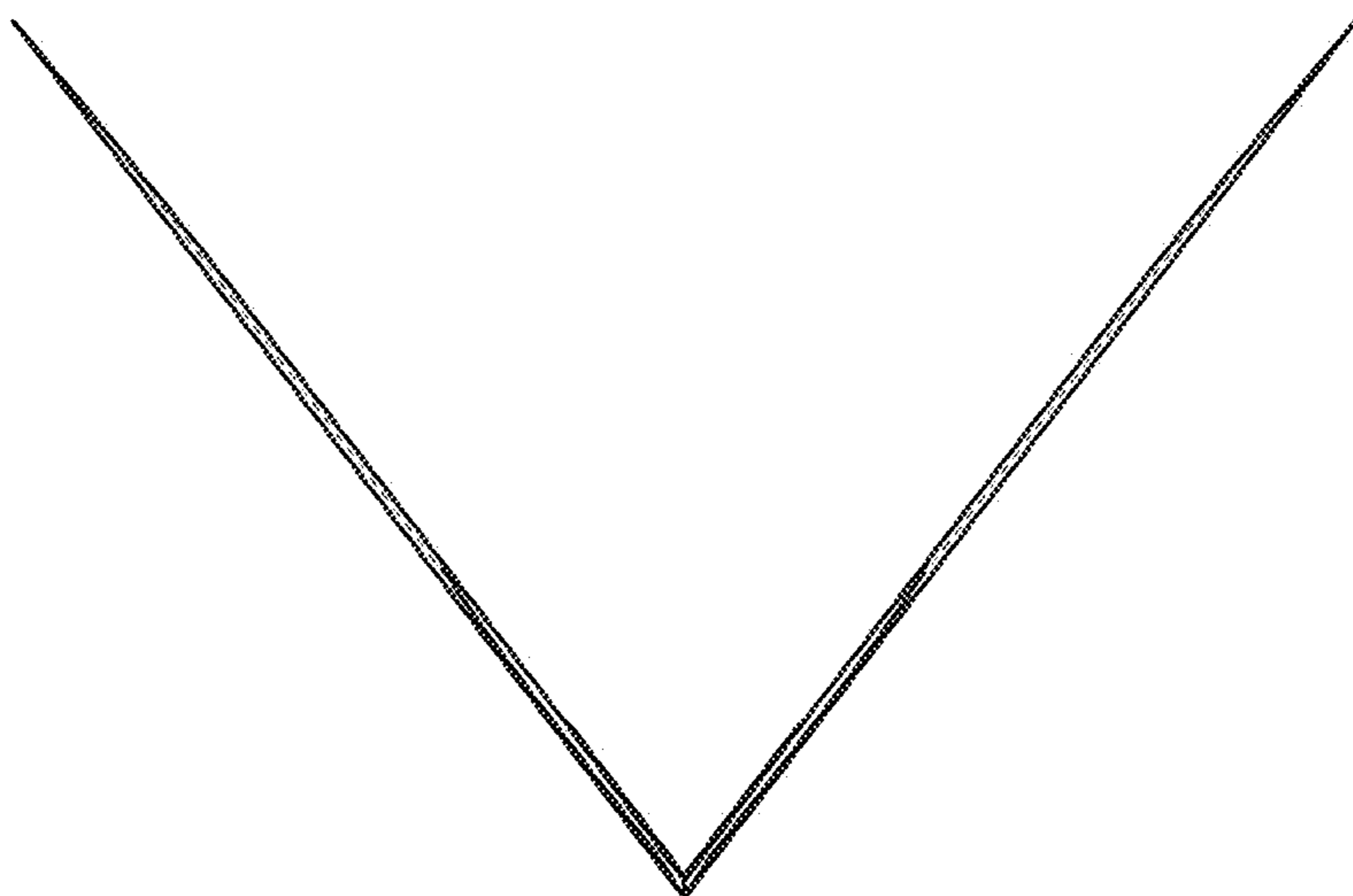

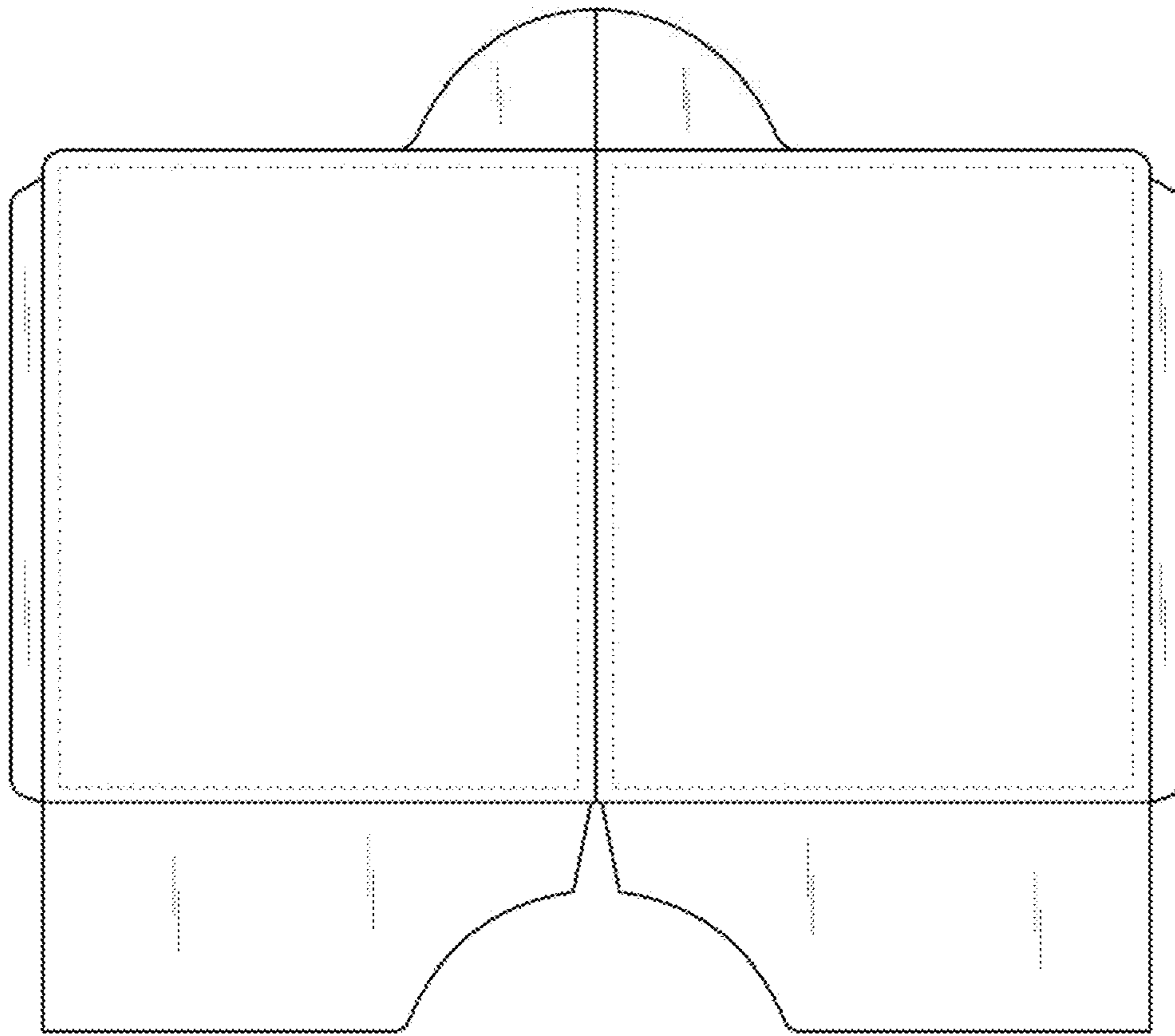

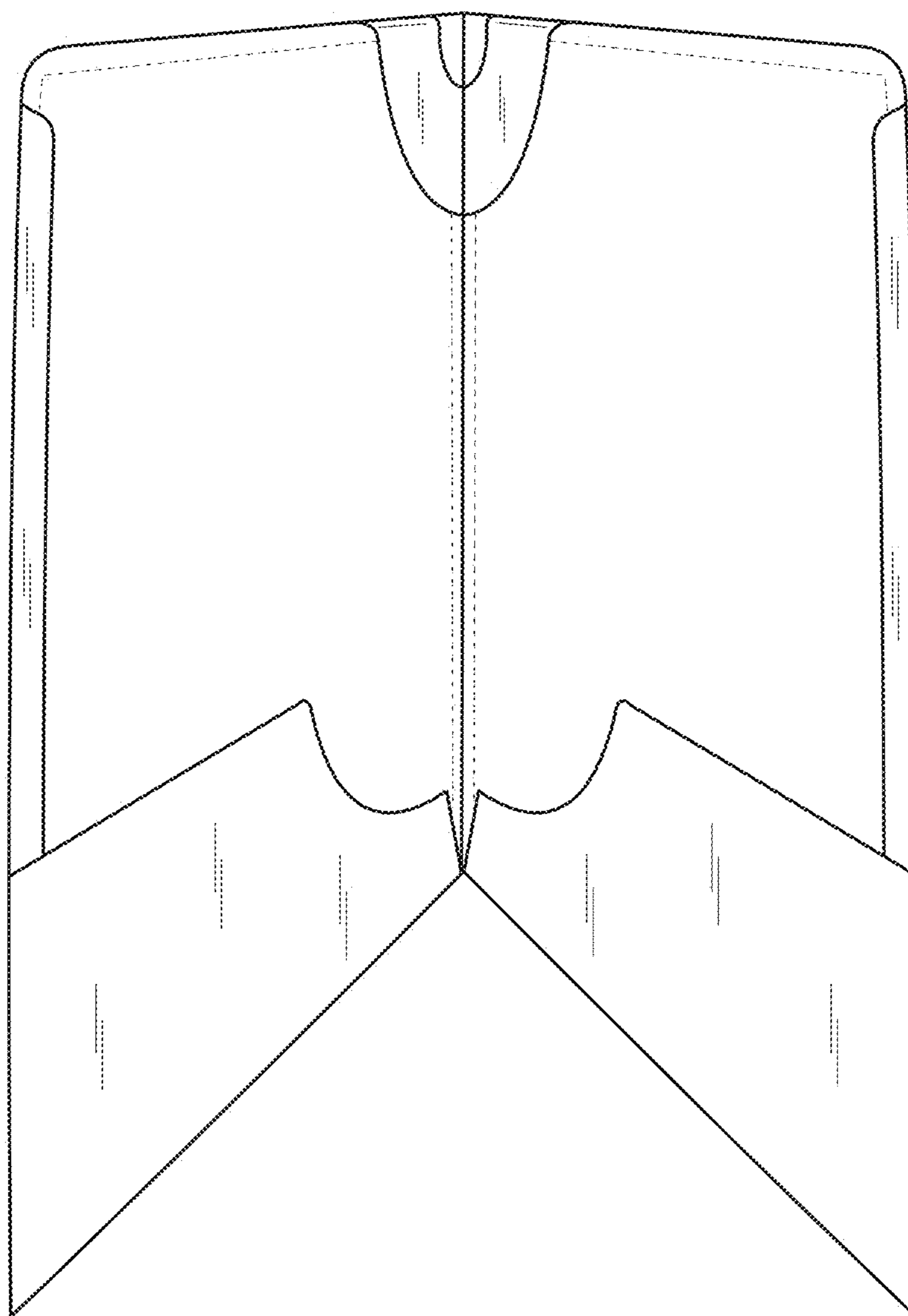

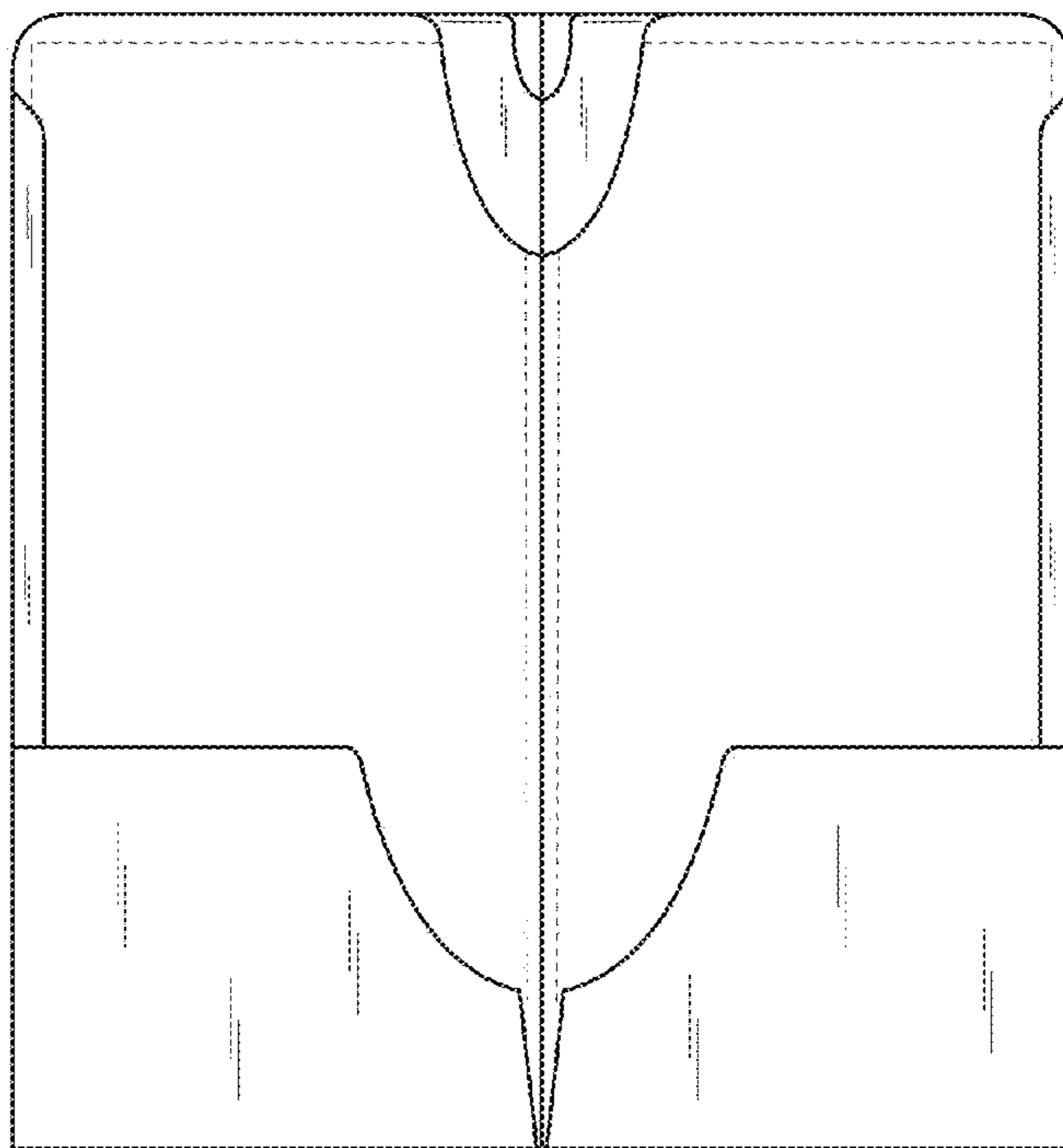

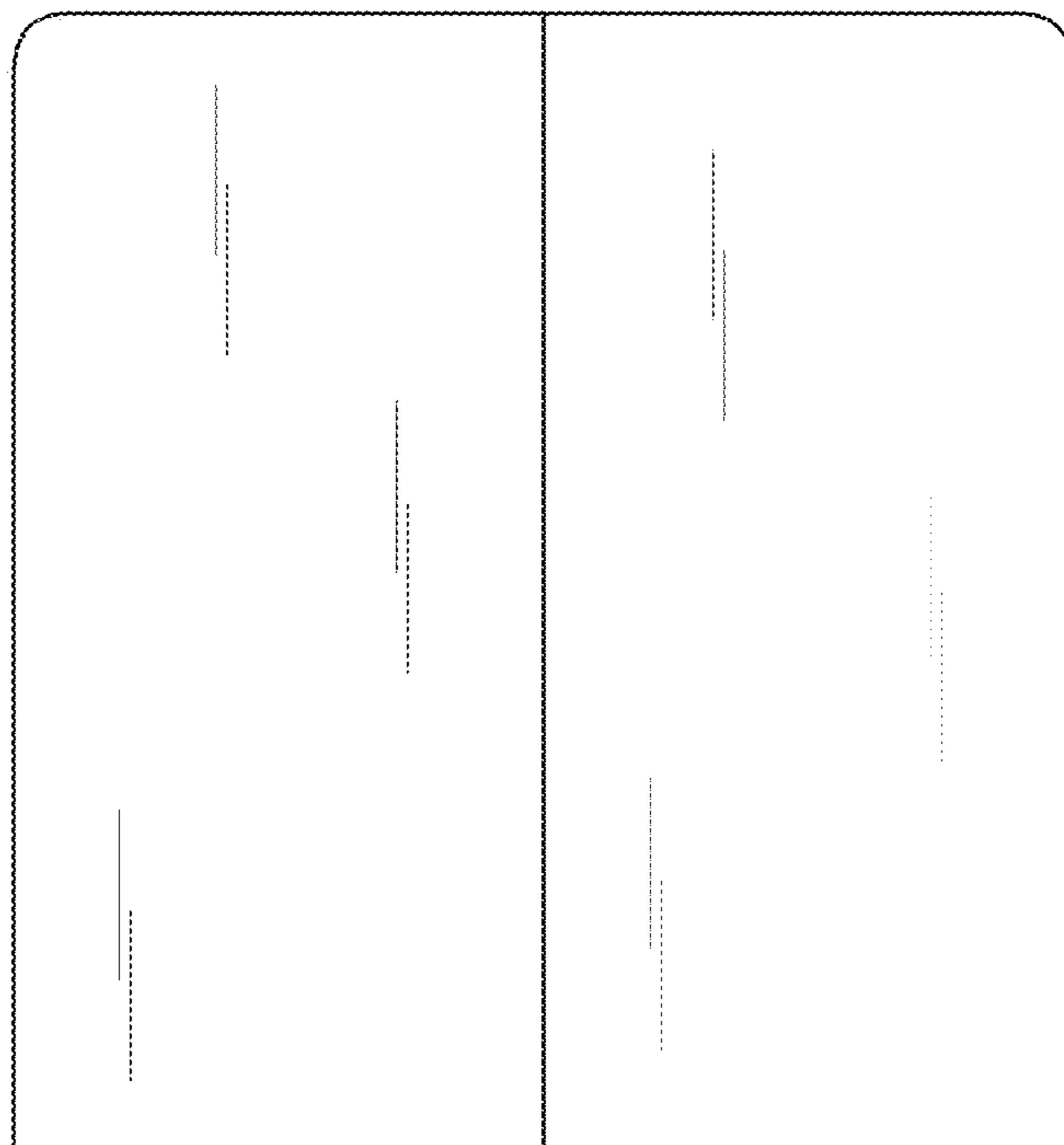

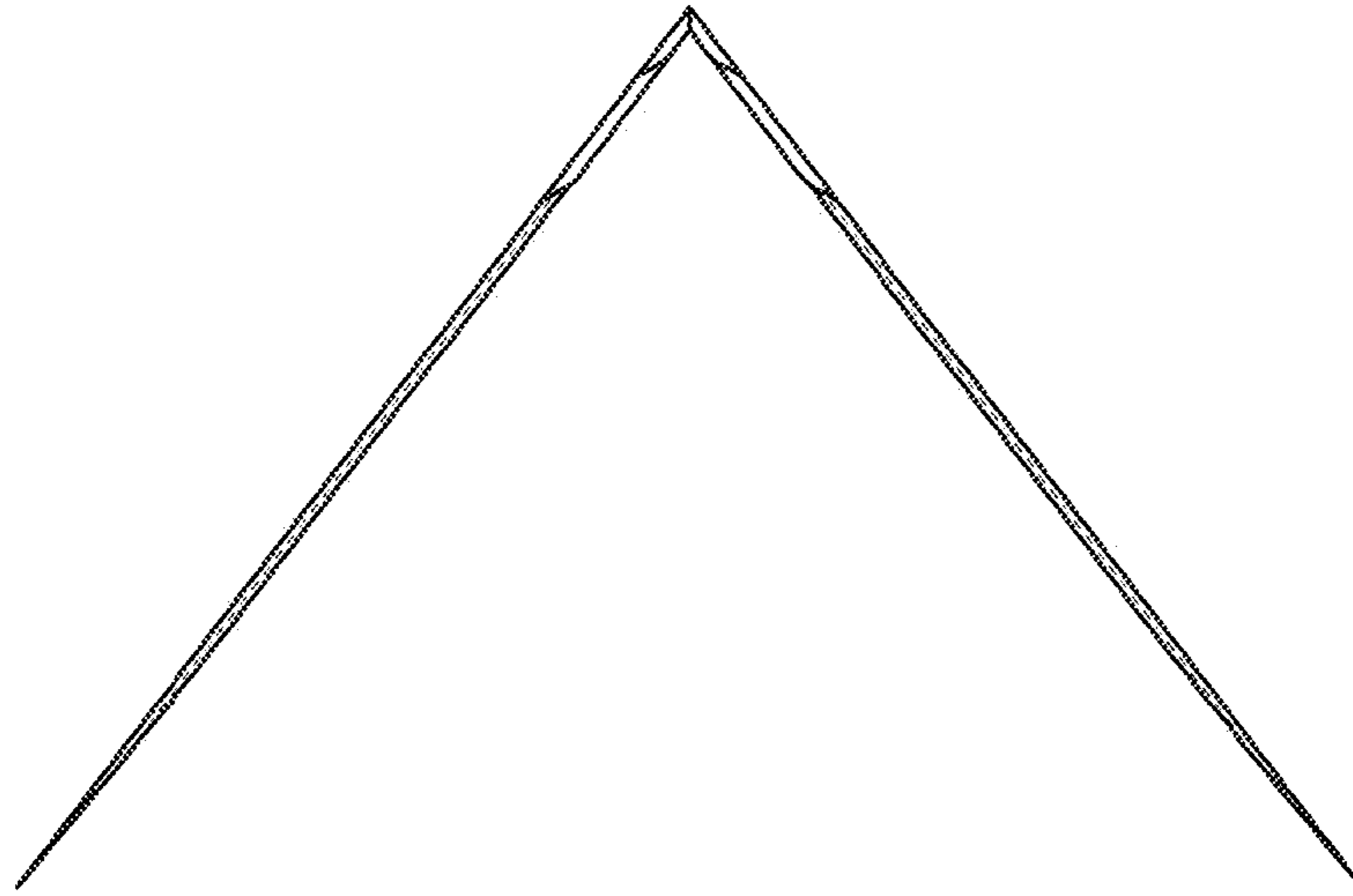

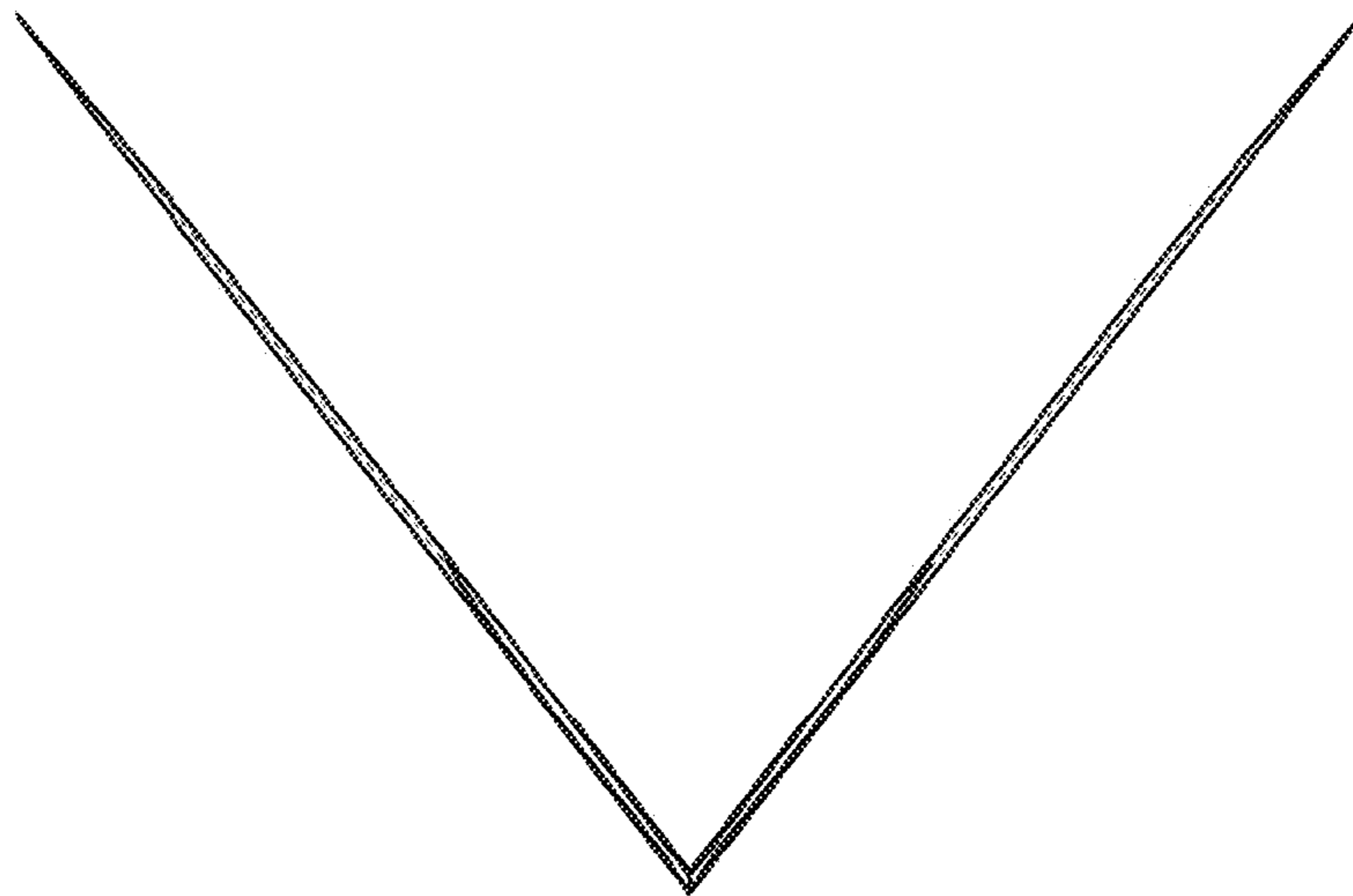

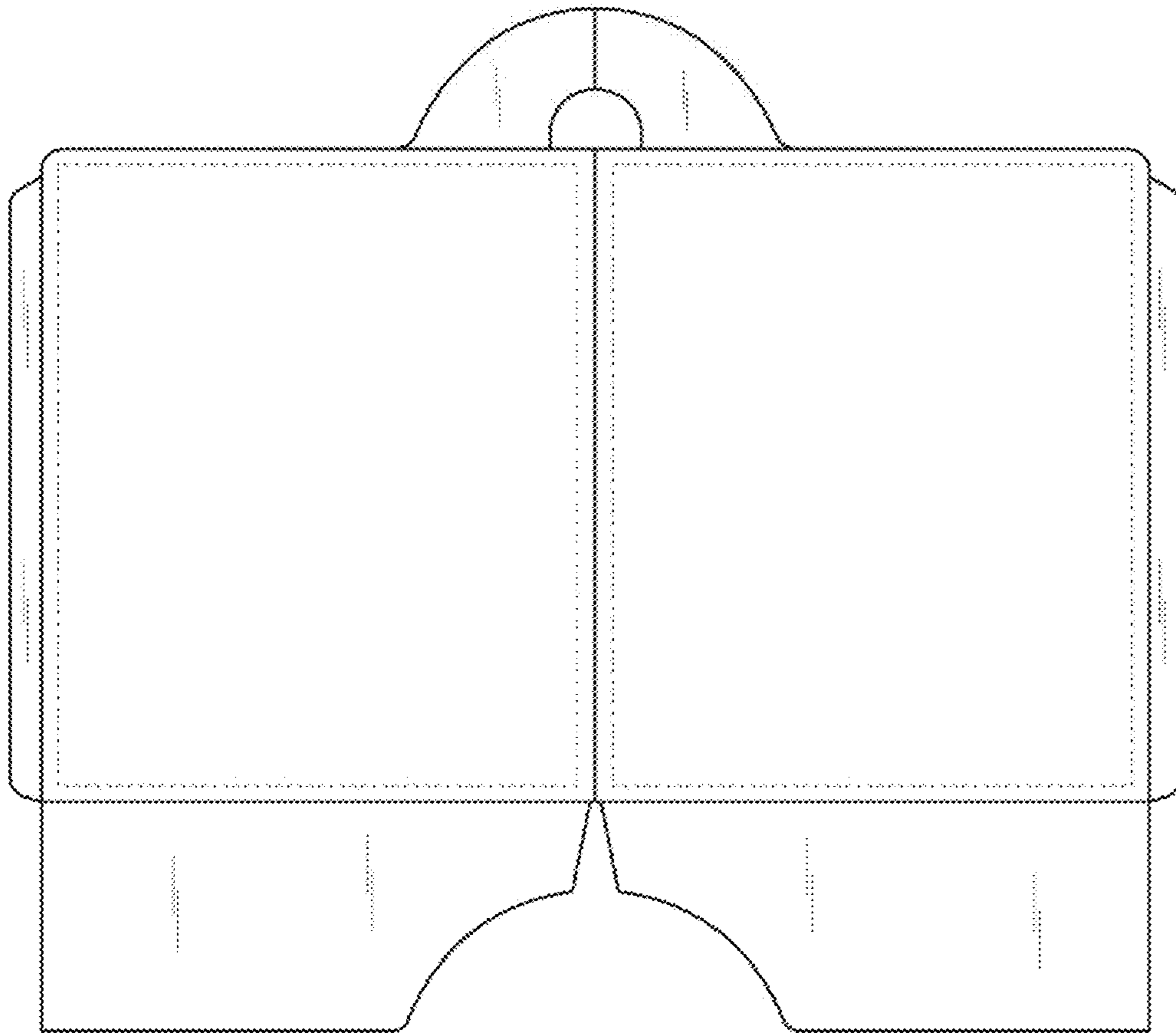
