**DESCRIPTION**

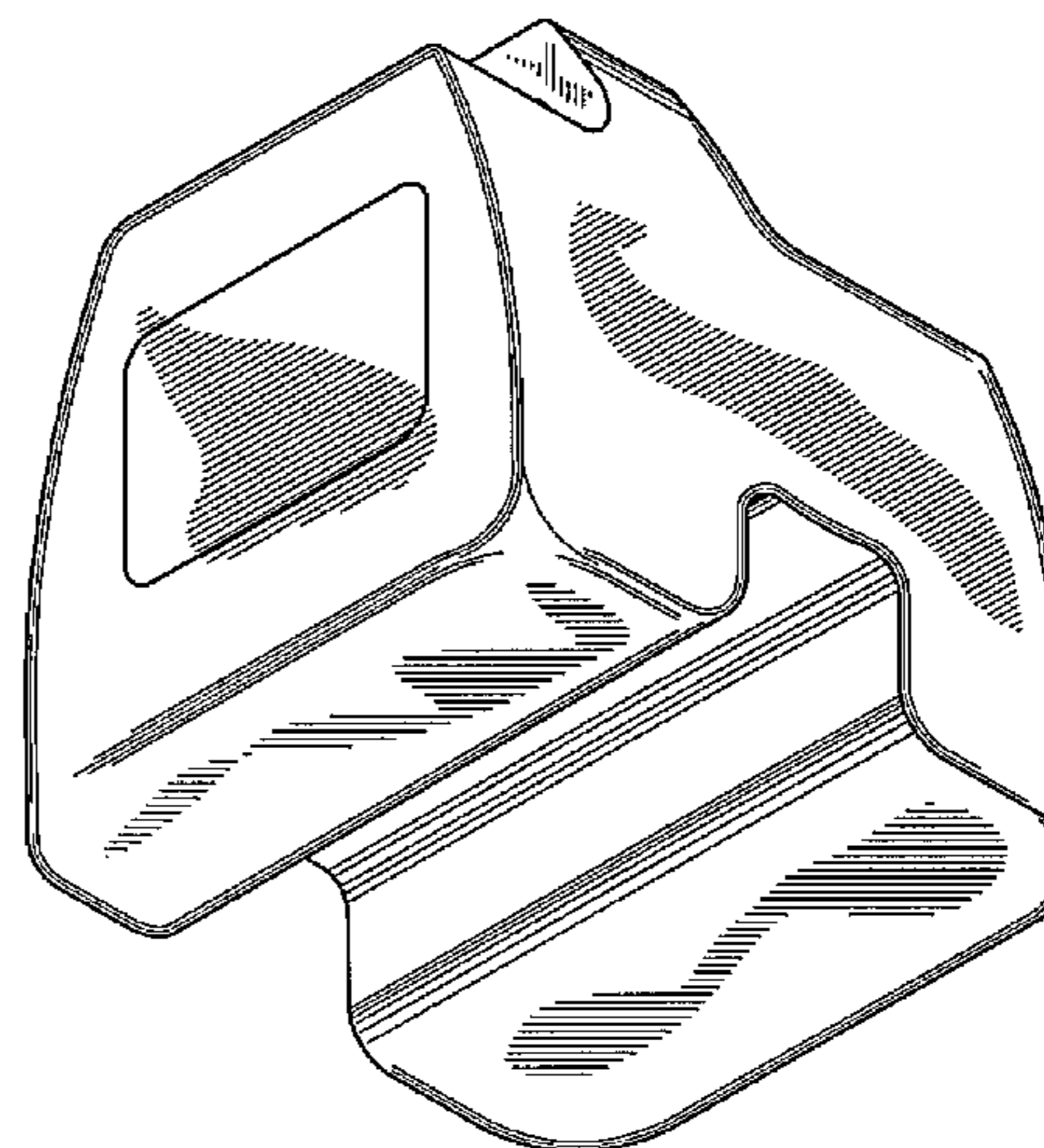
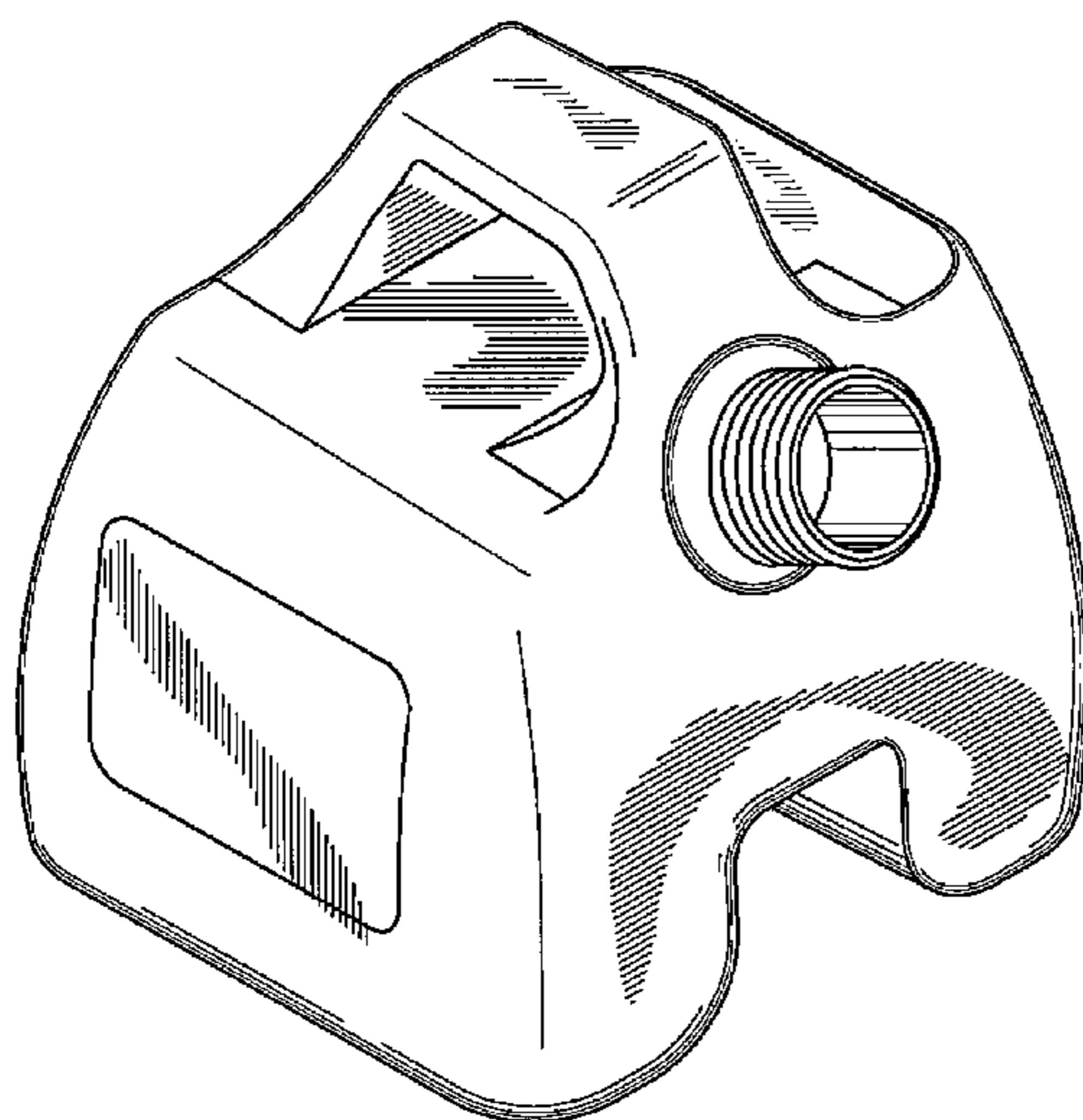

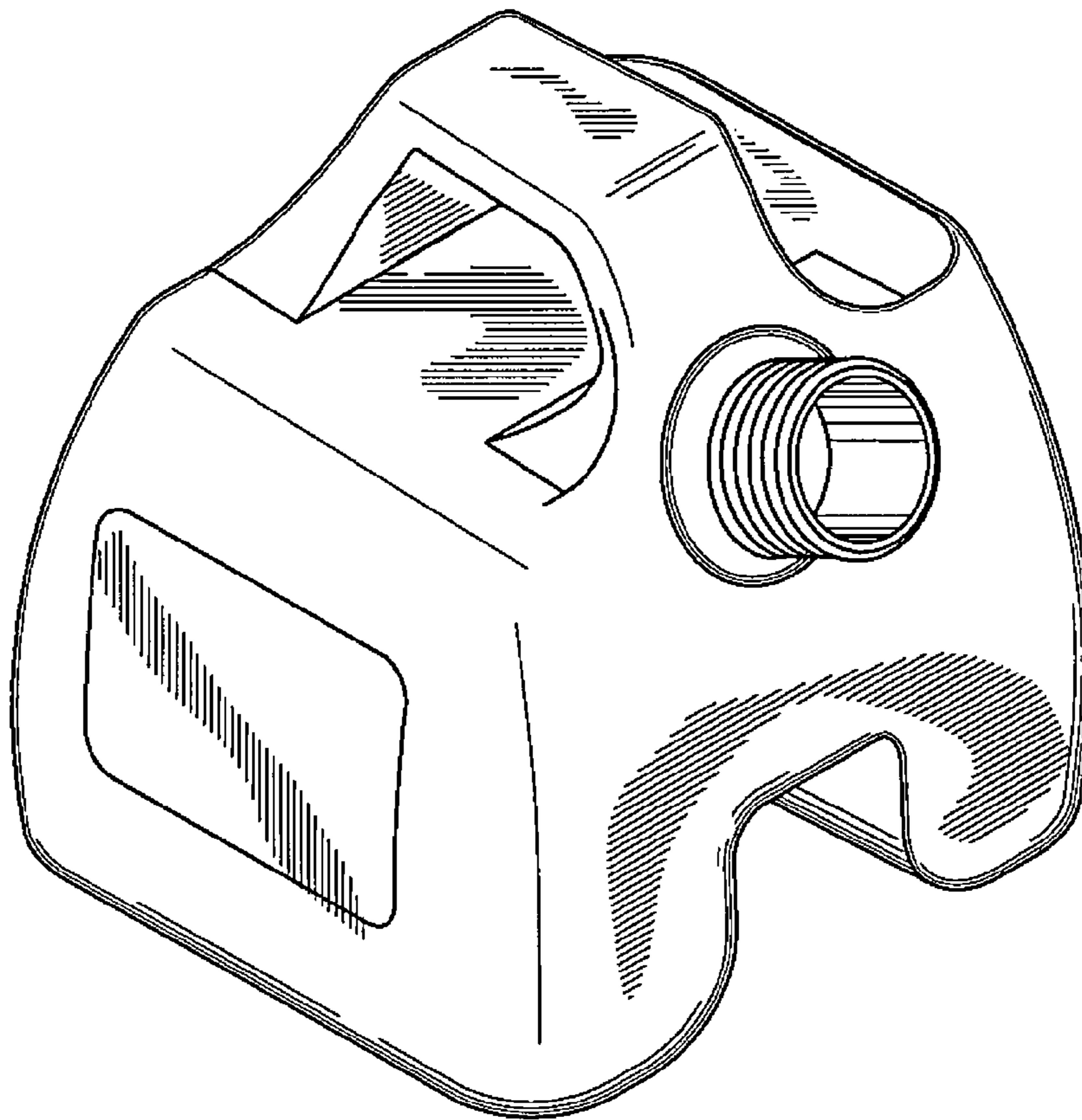
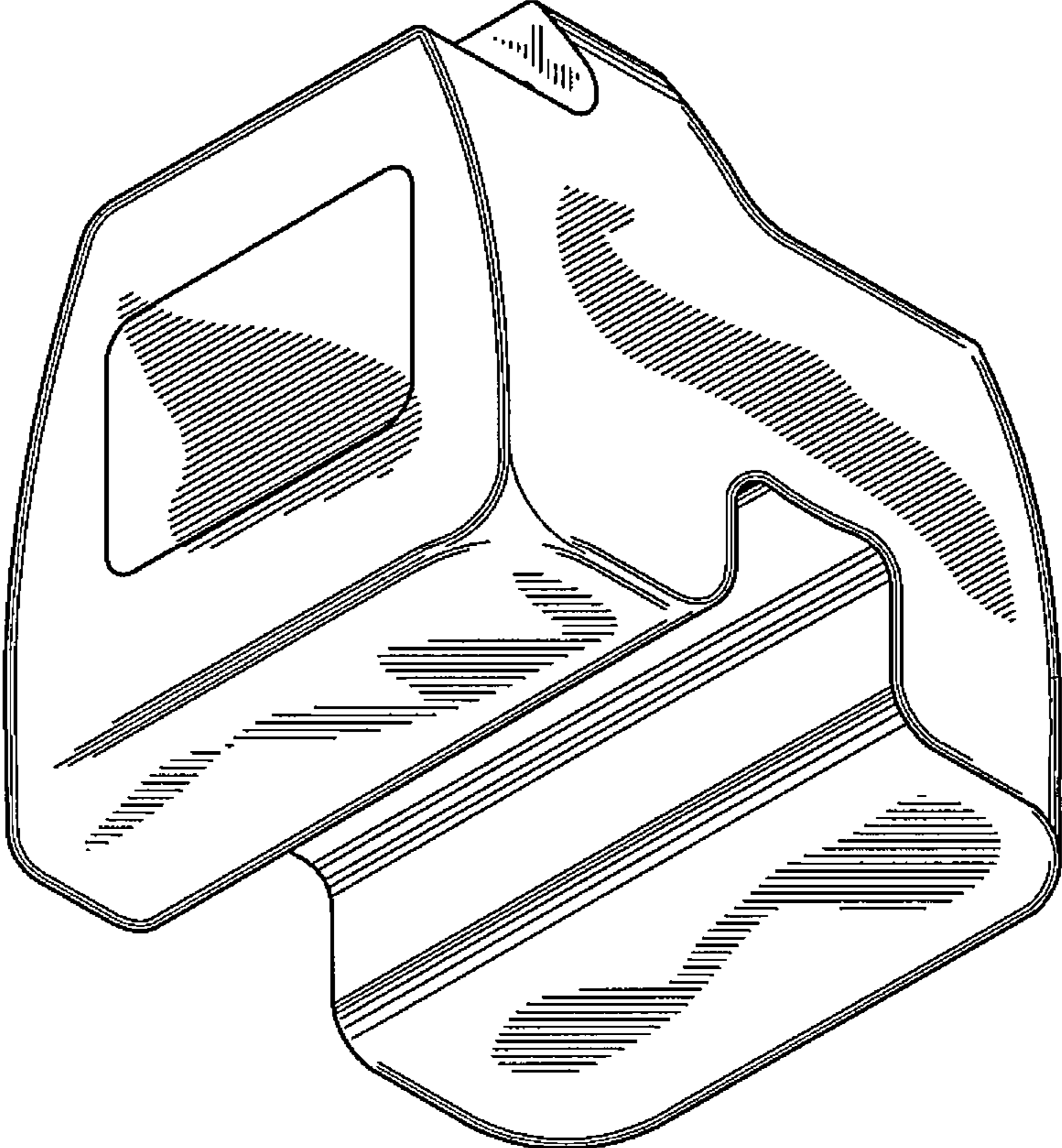

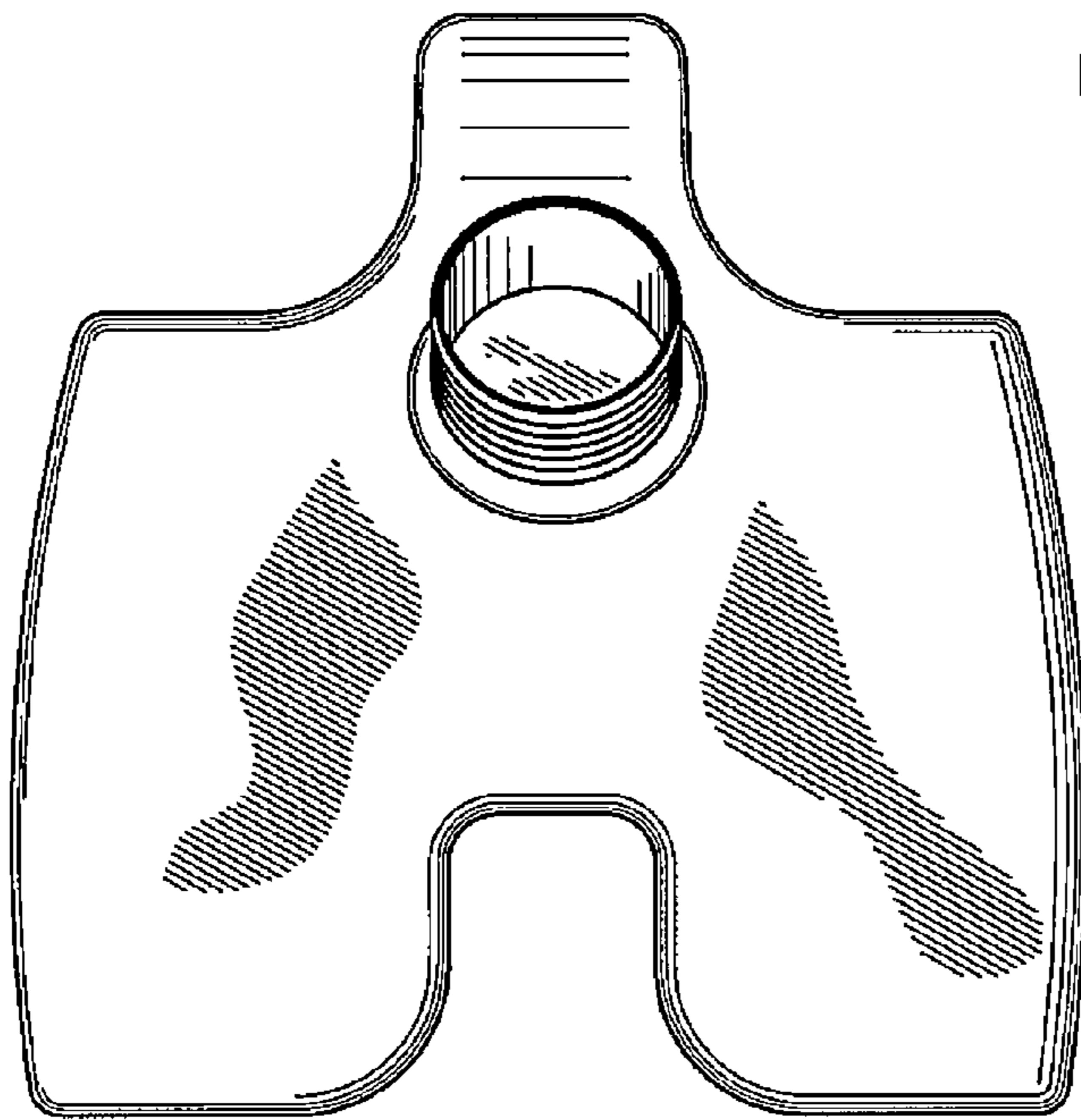
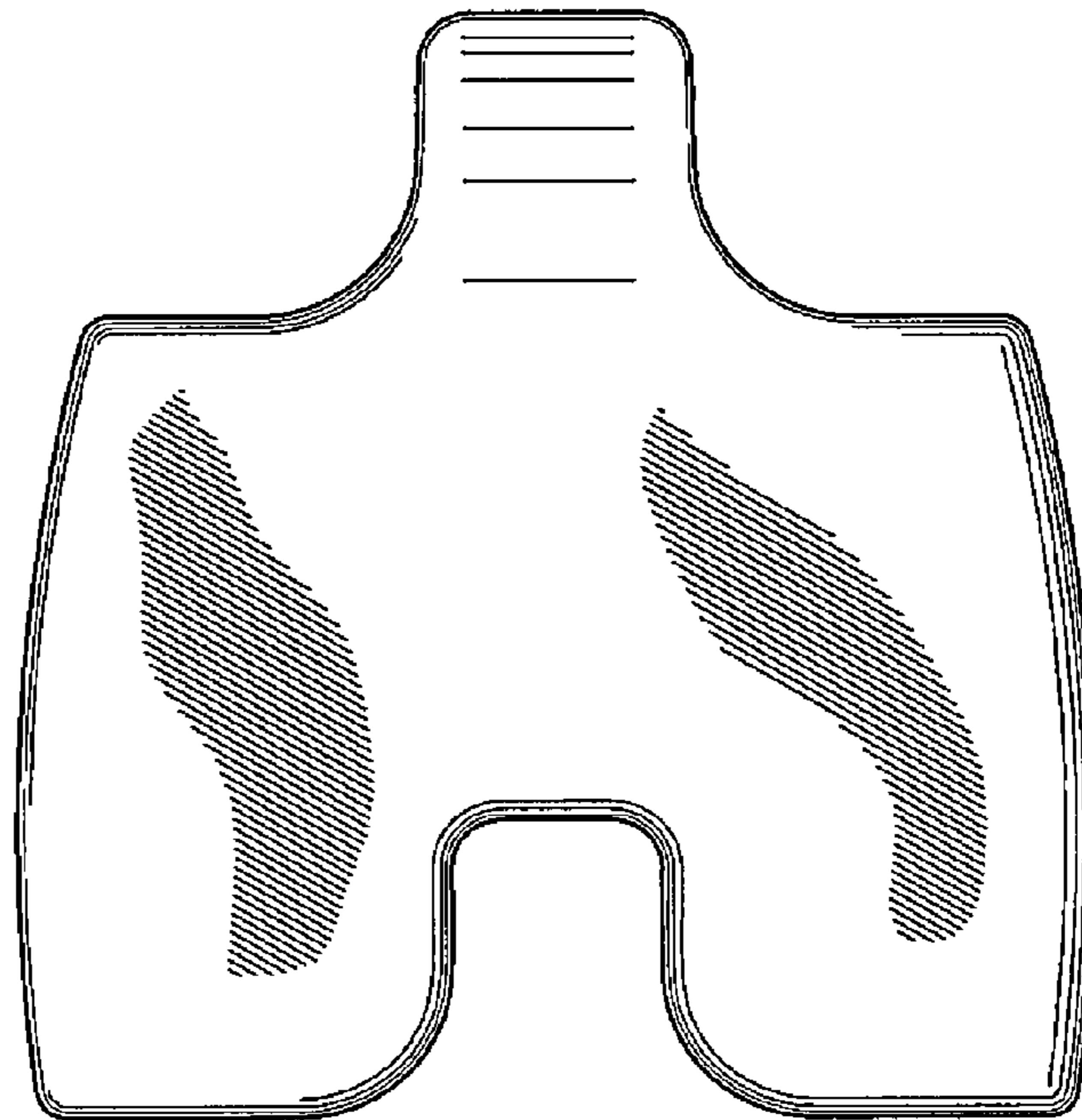

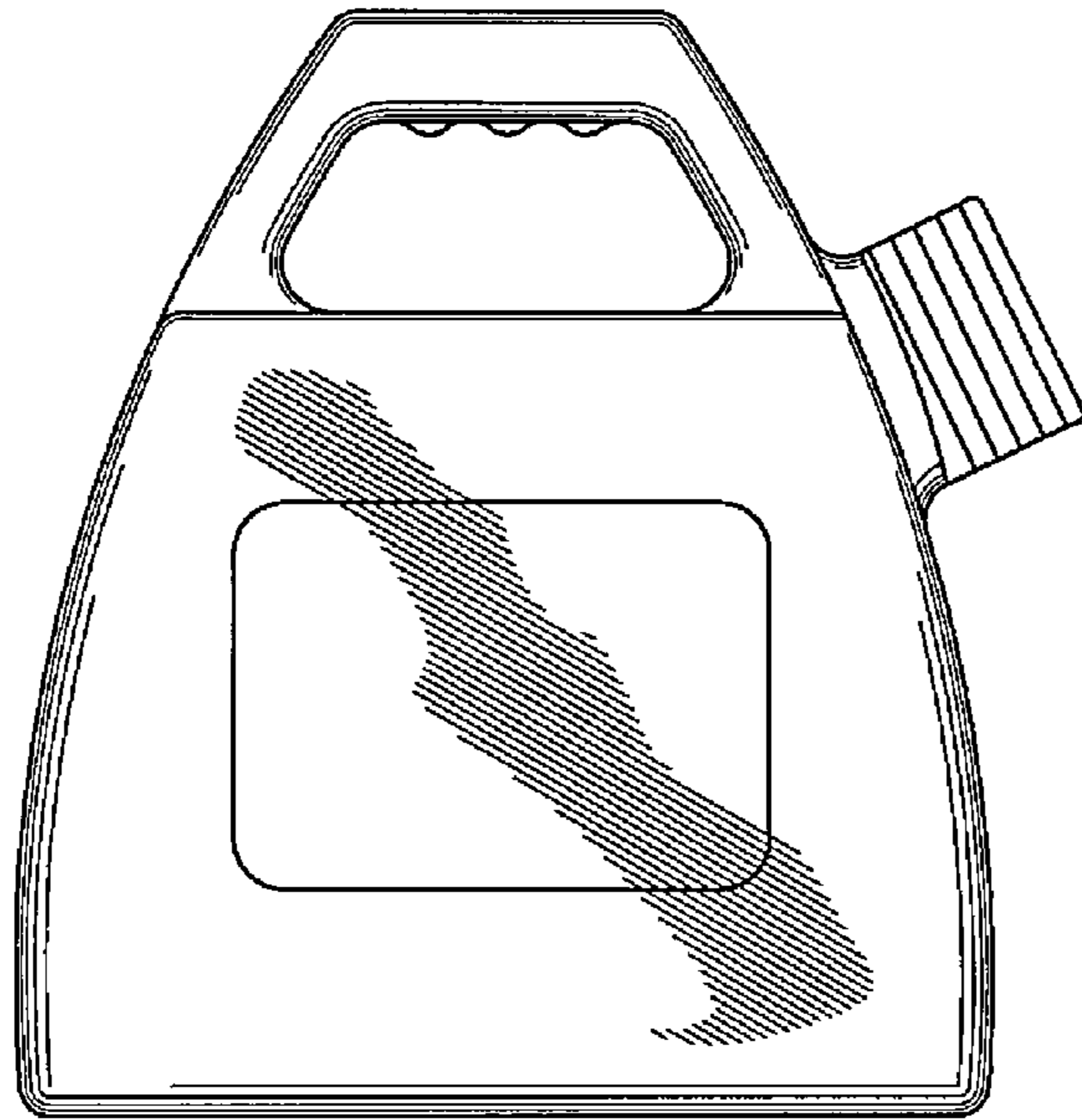

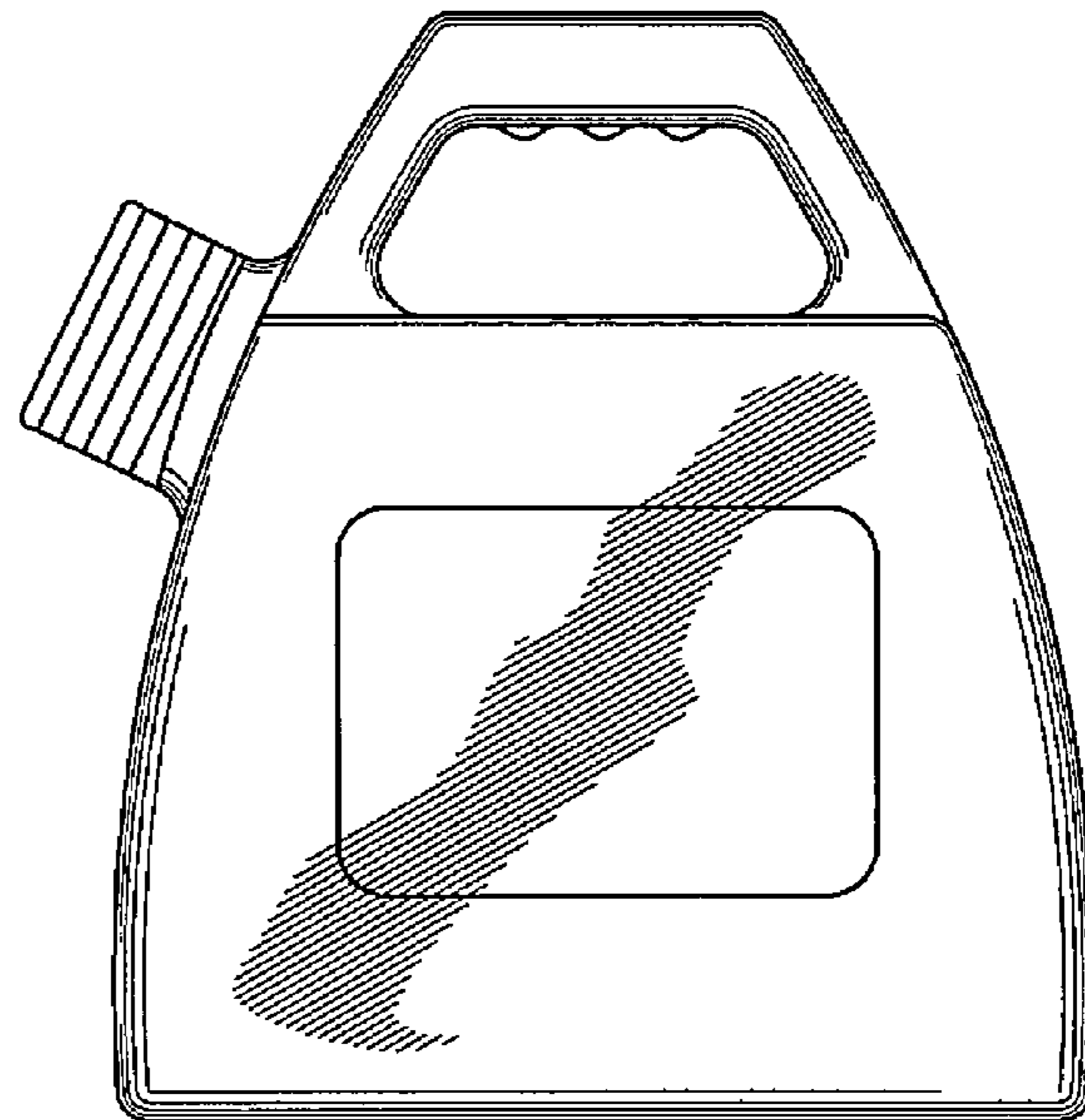

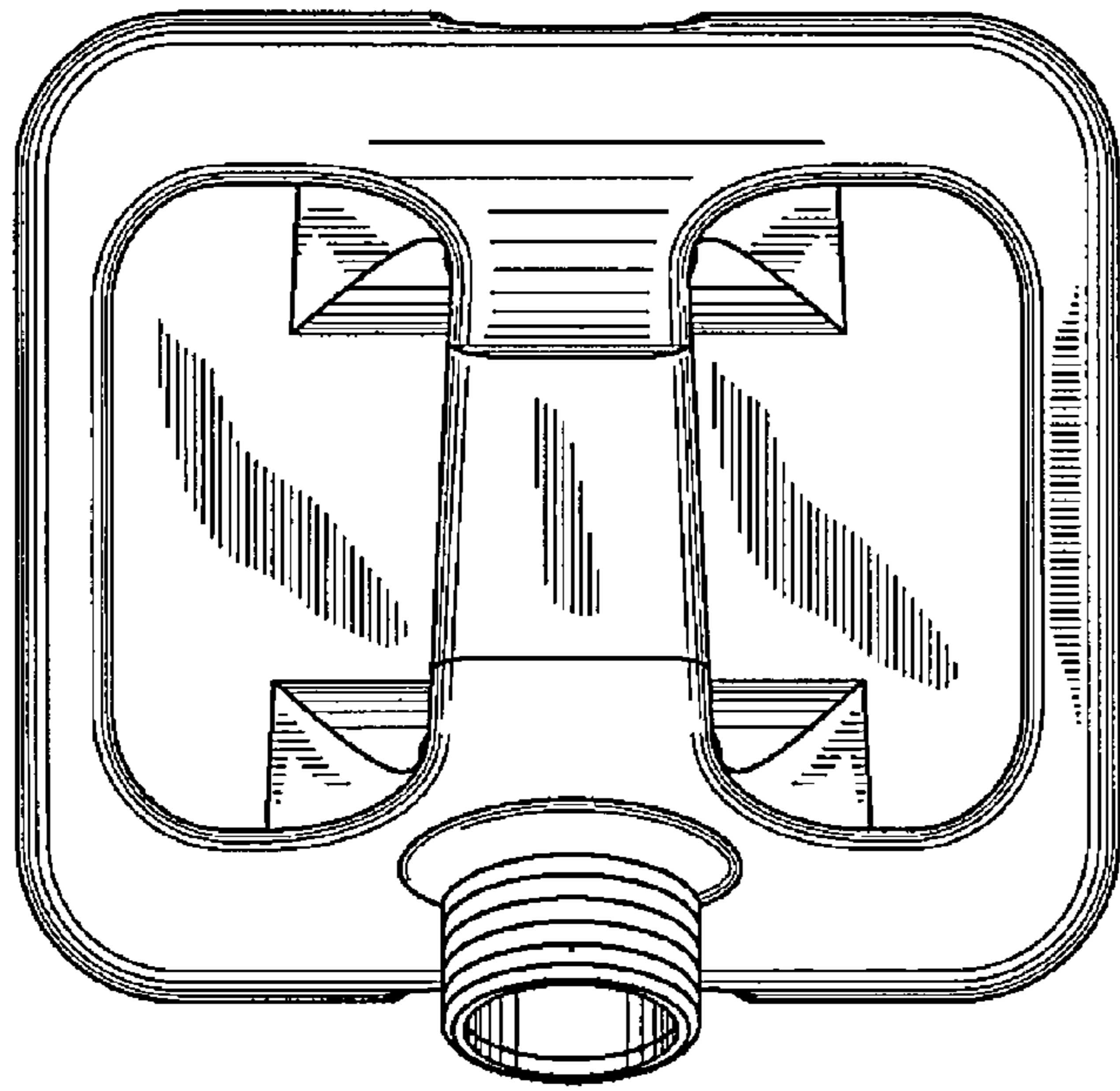

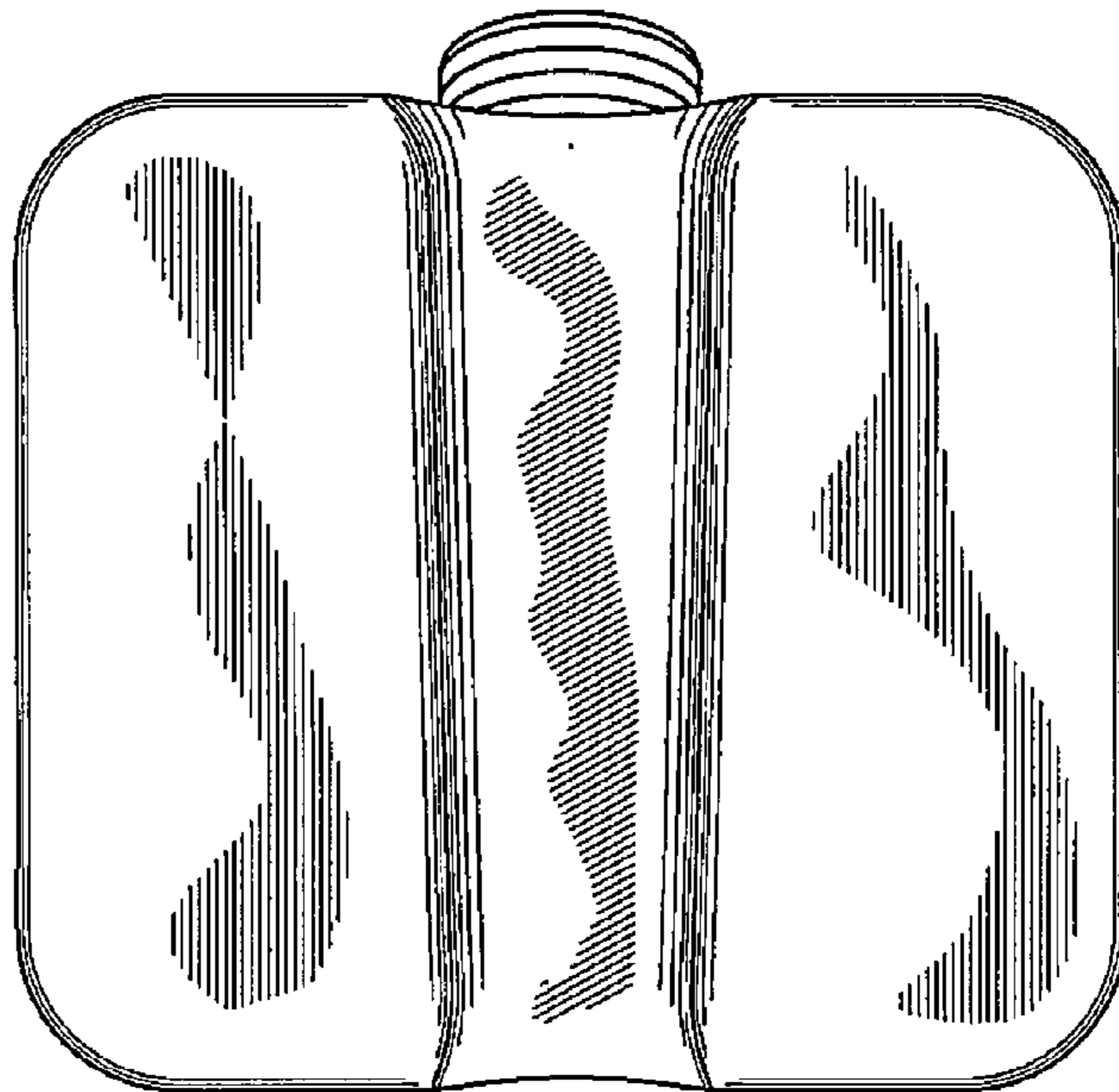
