DESCRIPTION

FIG. 1 is a front-top perspective view of a humidifier showing my new design;

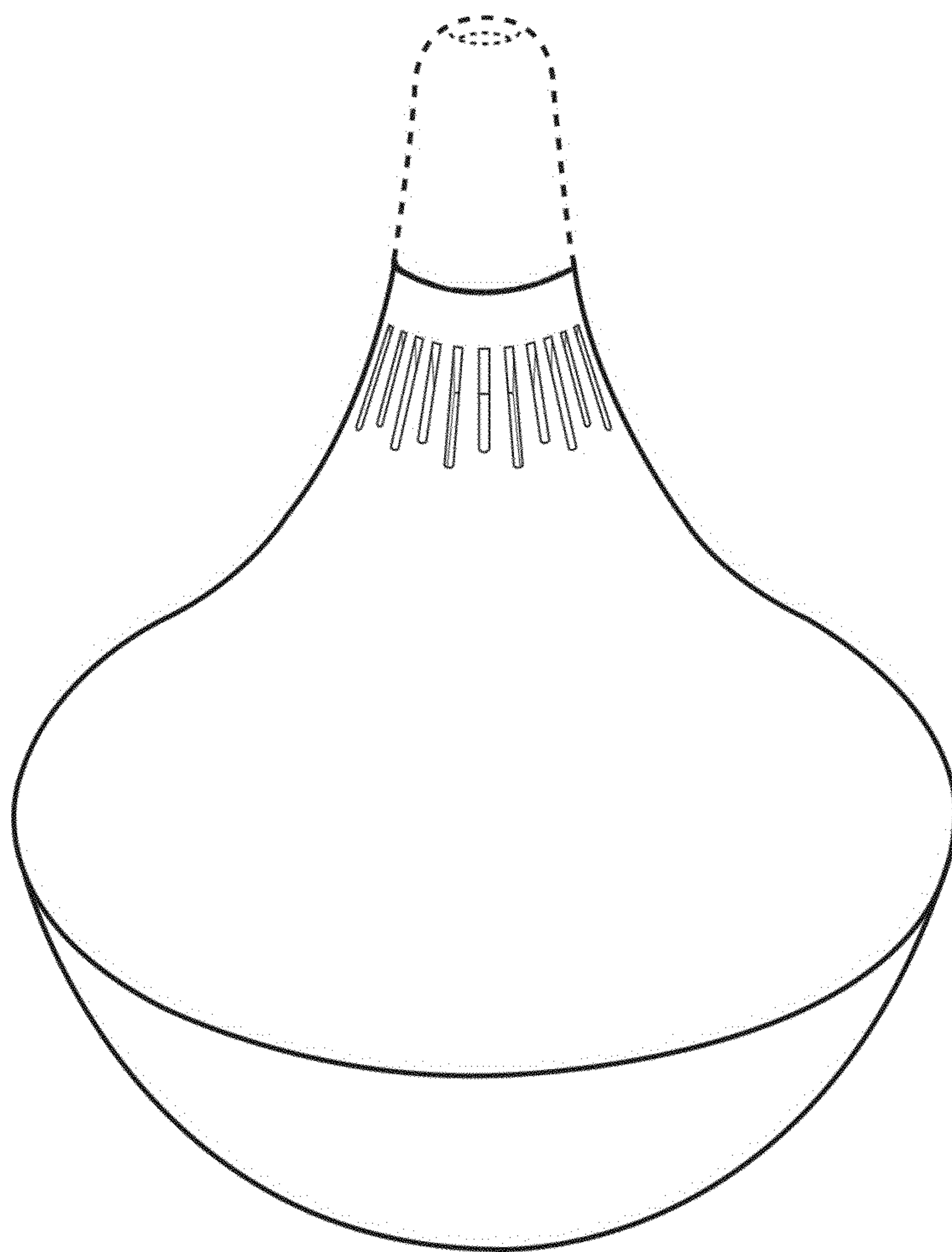

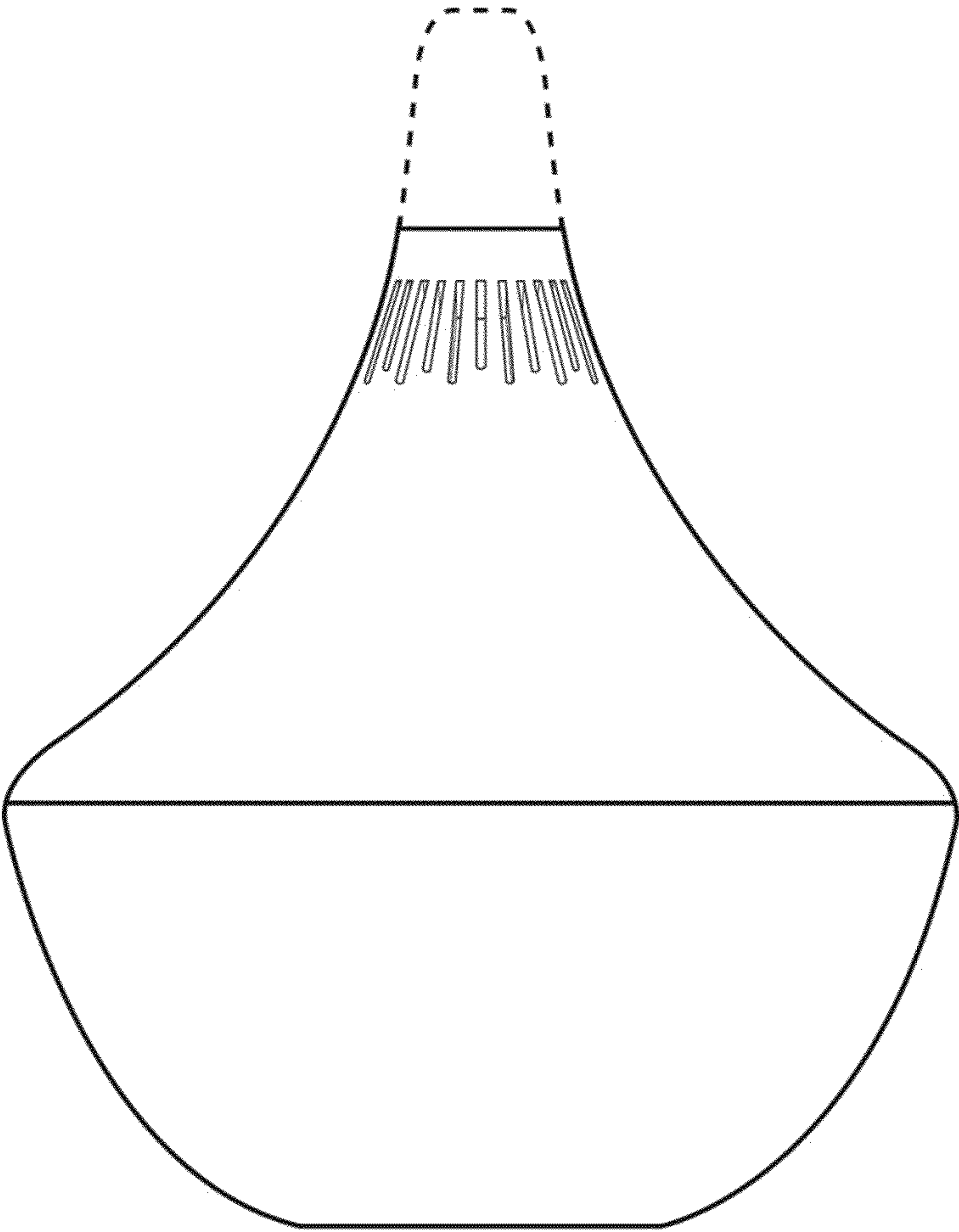

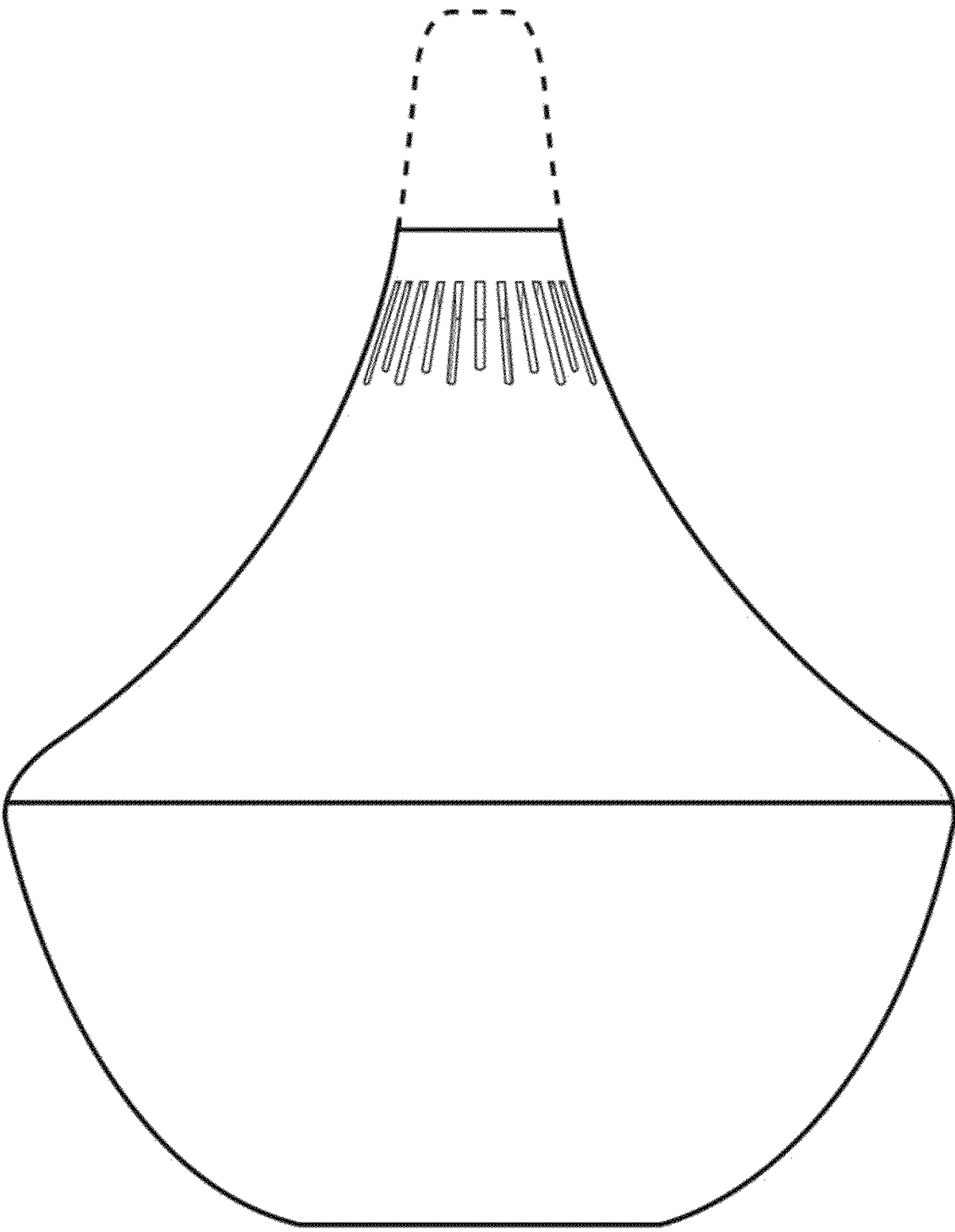

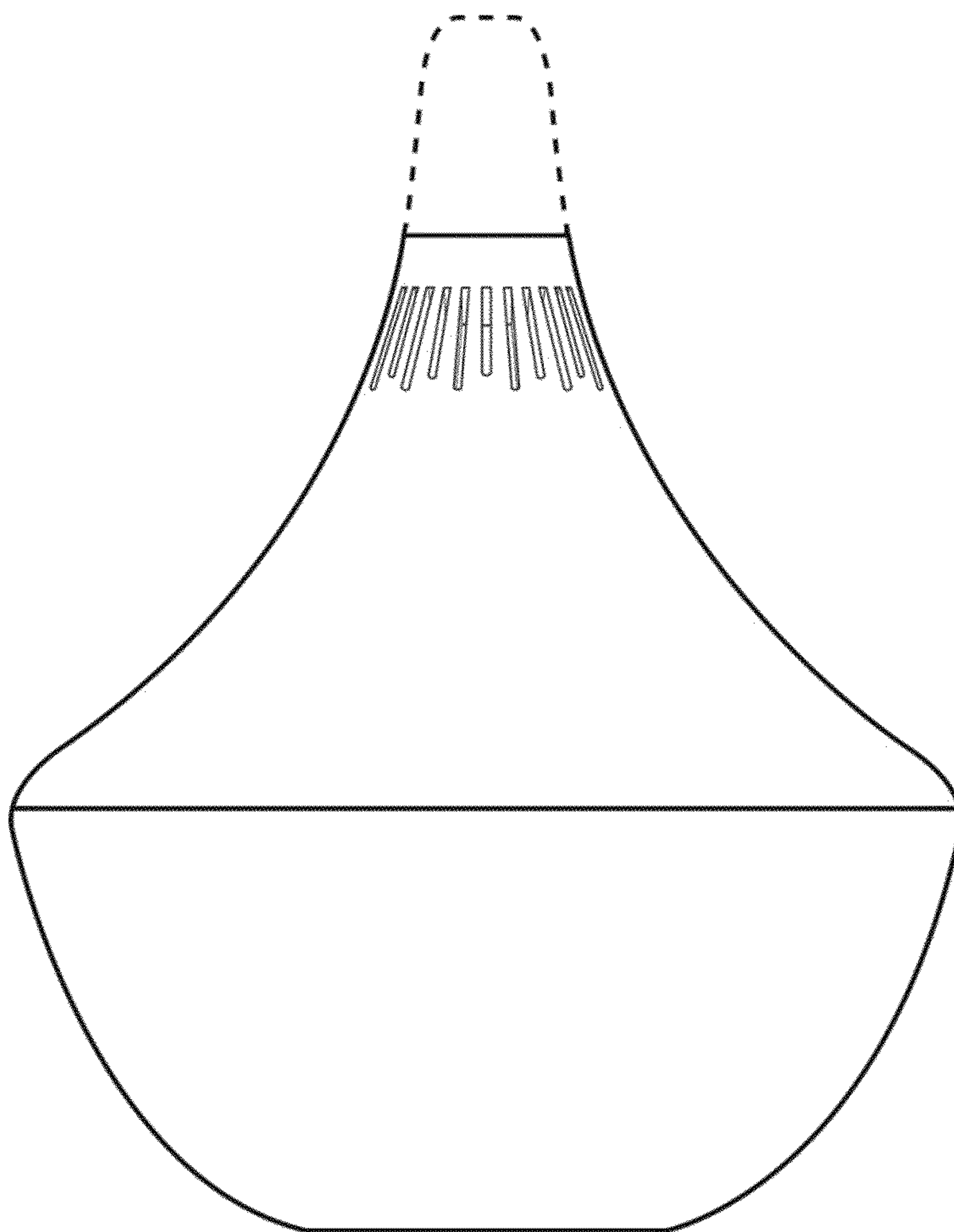

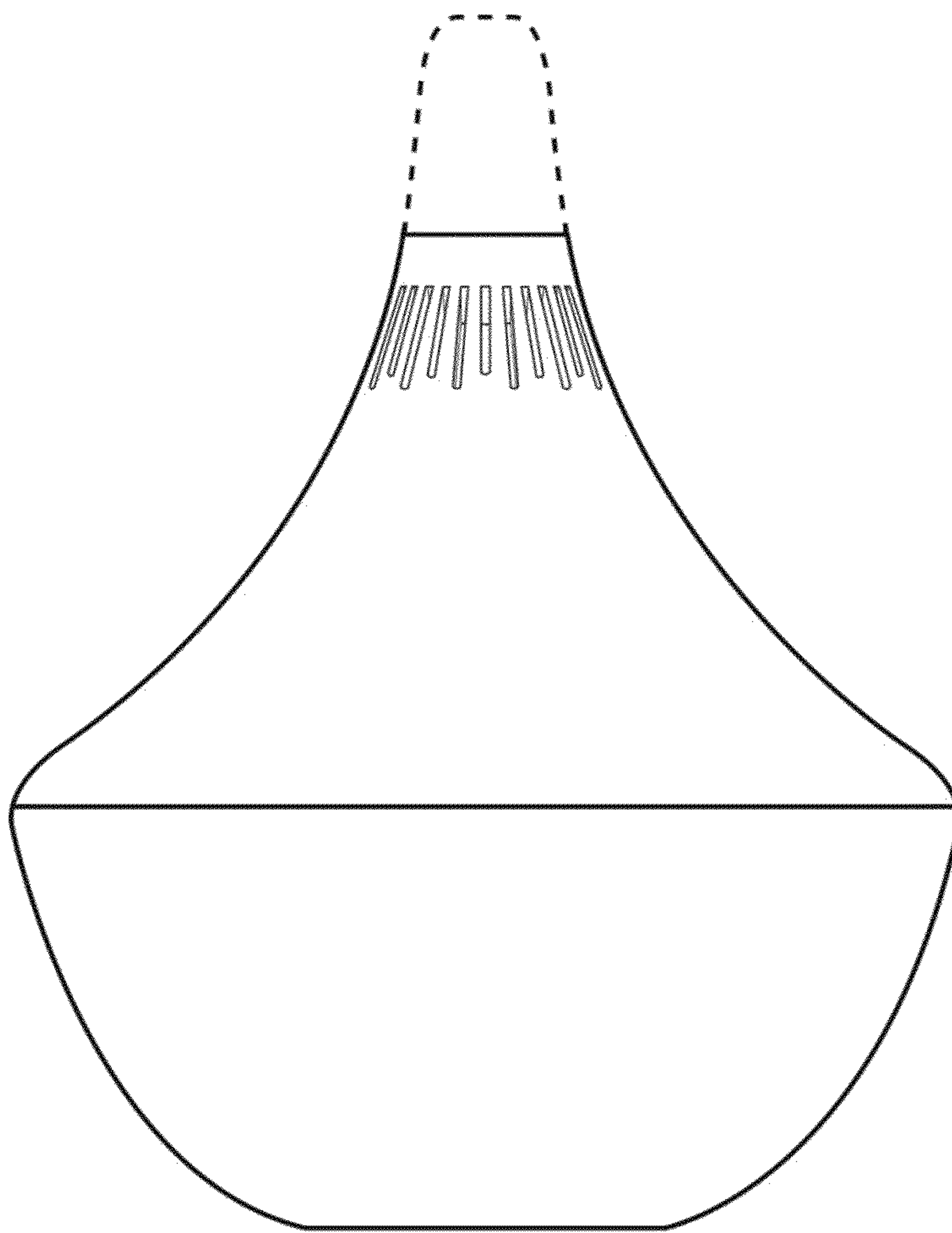

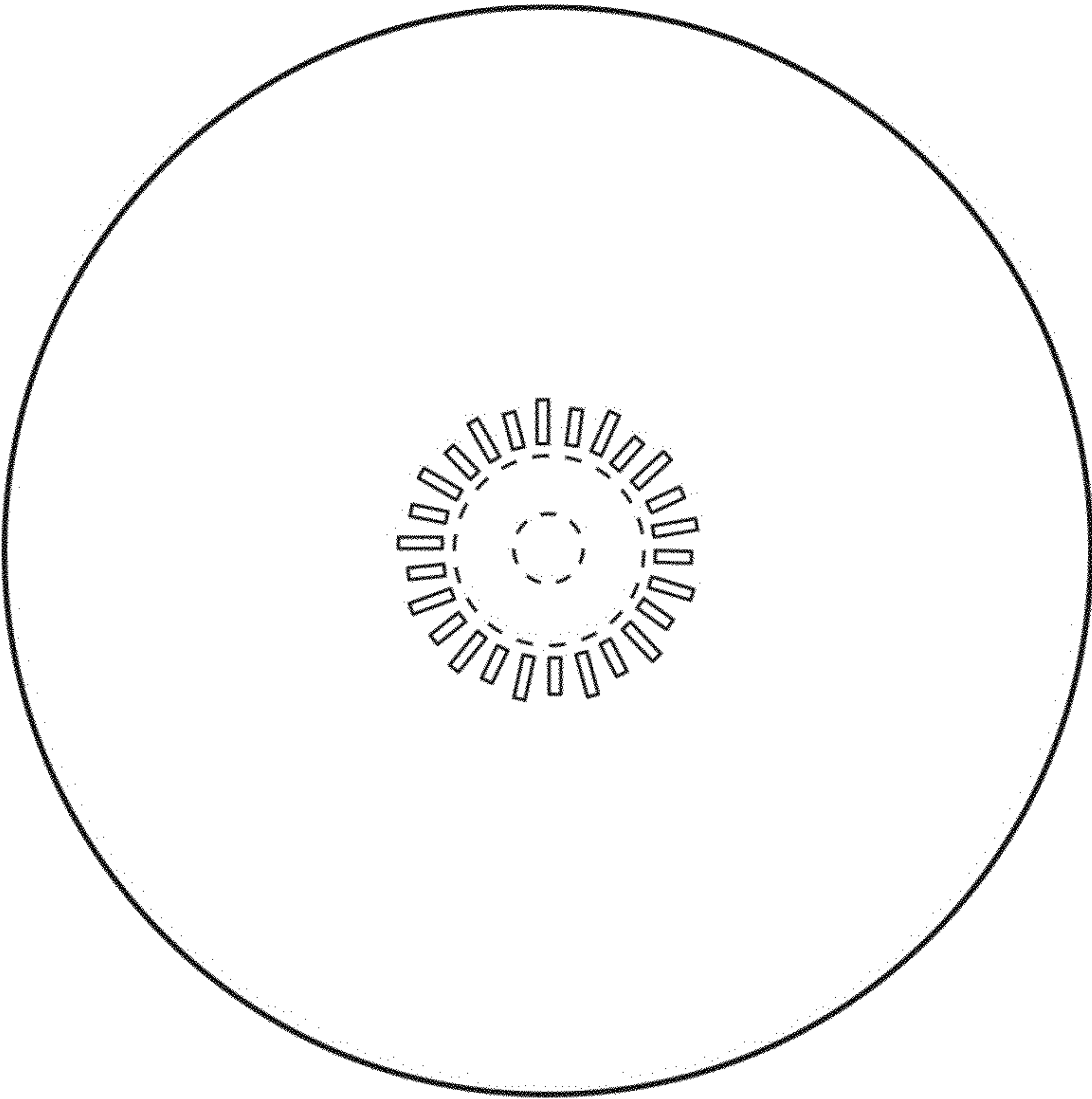

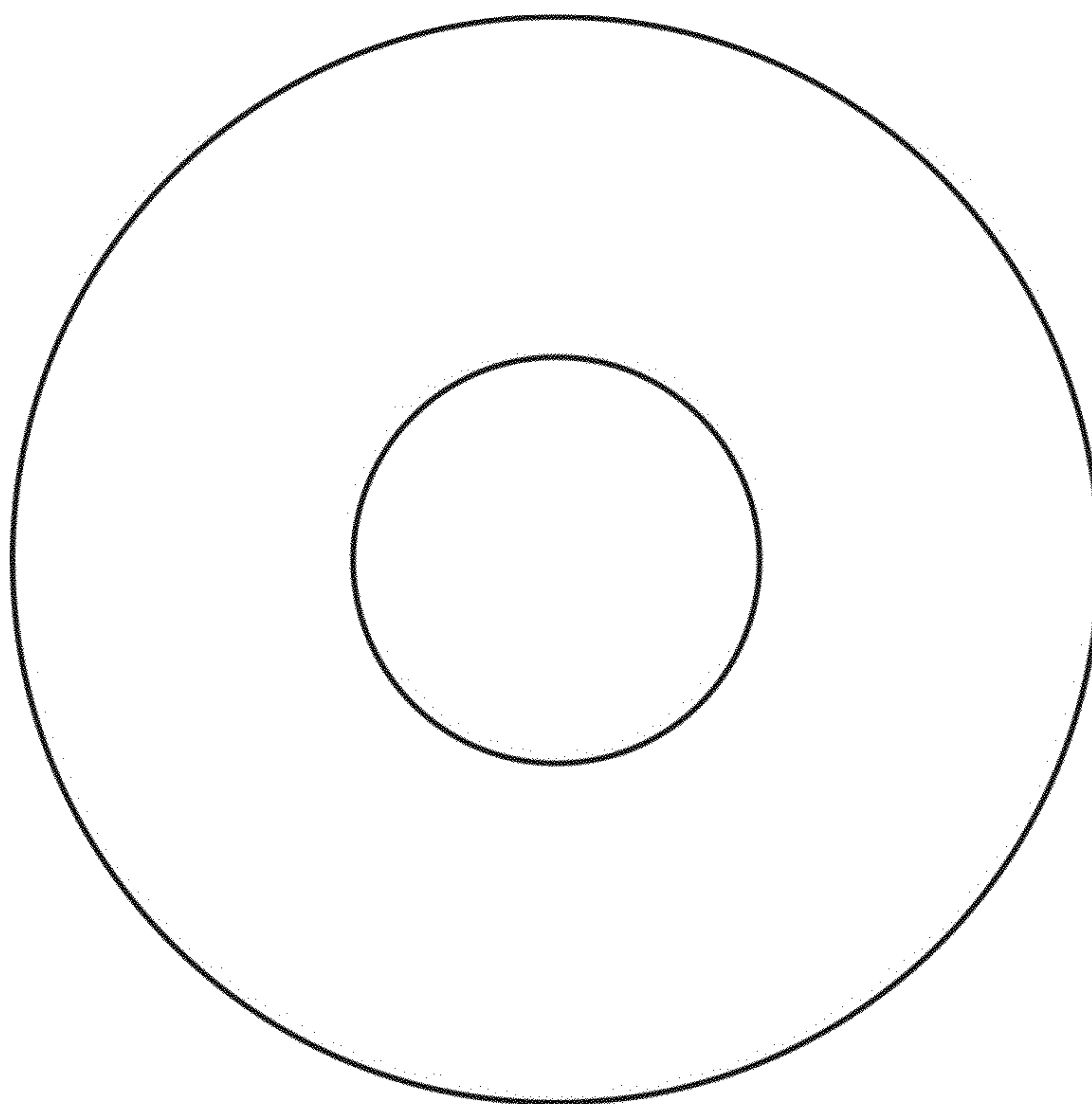
