DESCRIPTION

FIG. 1 is a perspective view of an tower air purifier with scent delivery, constructed in accordance with the present invention;

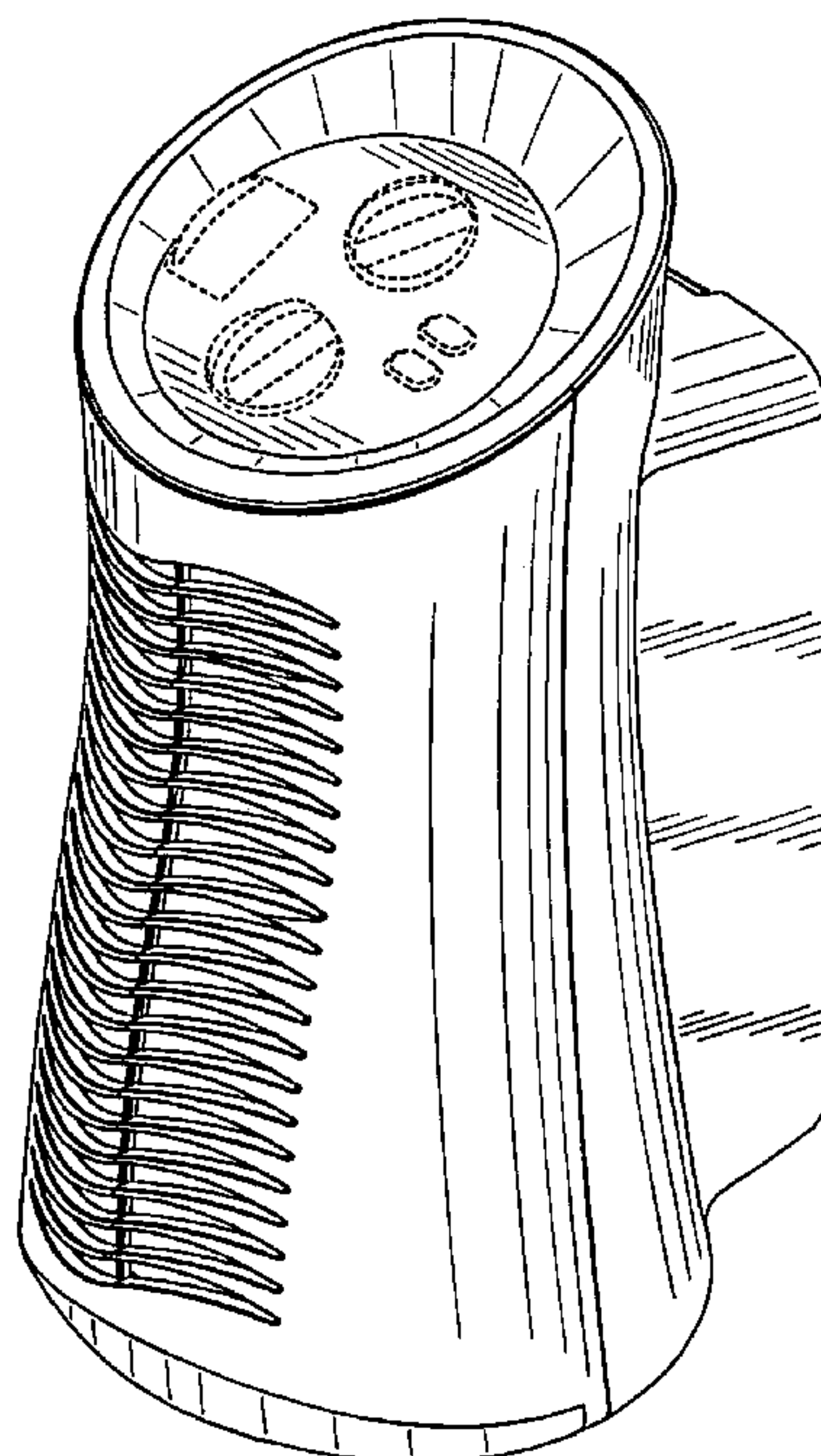

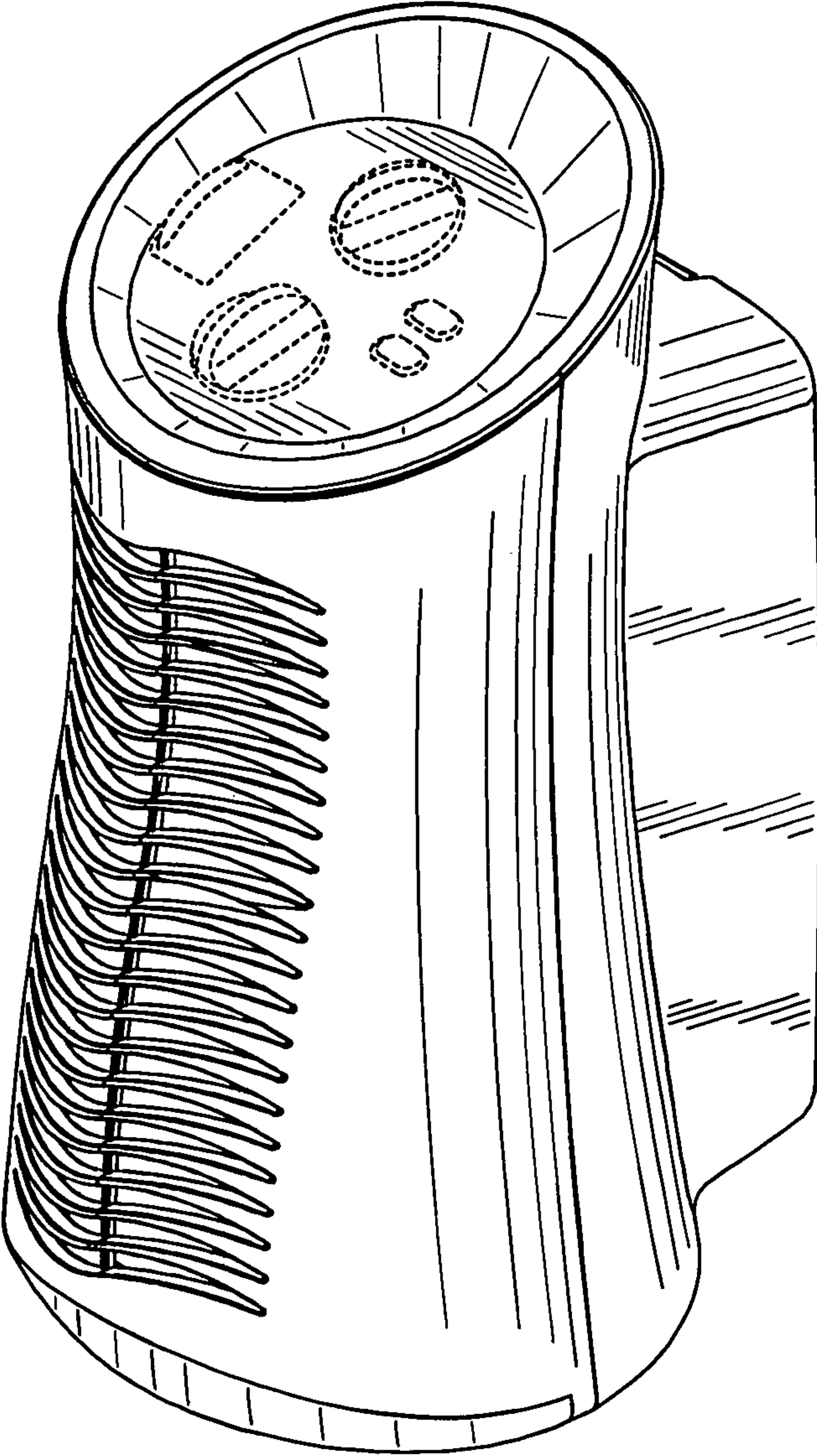

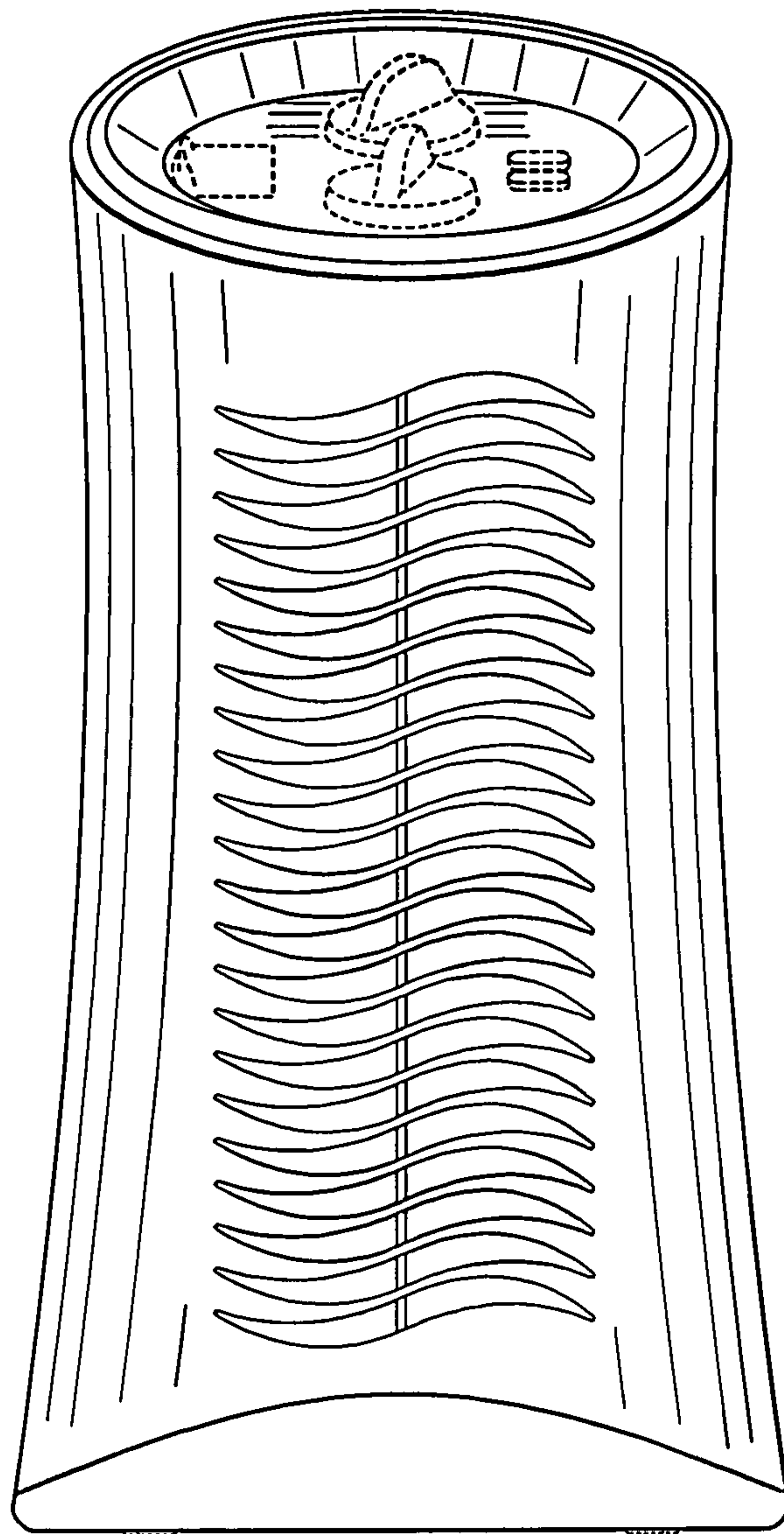

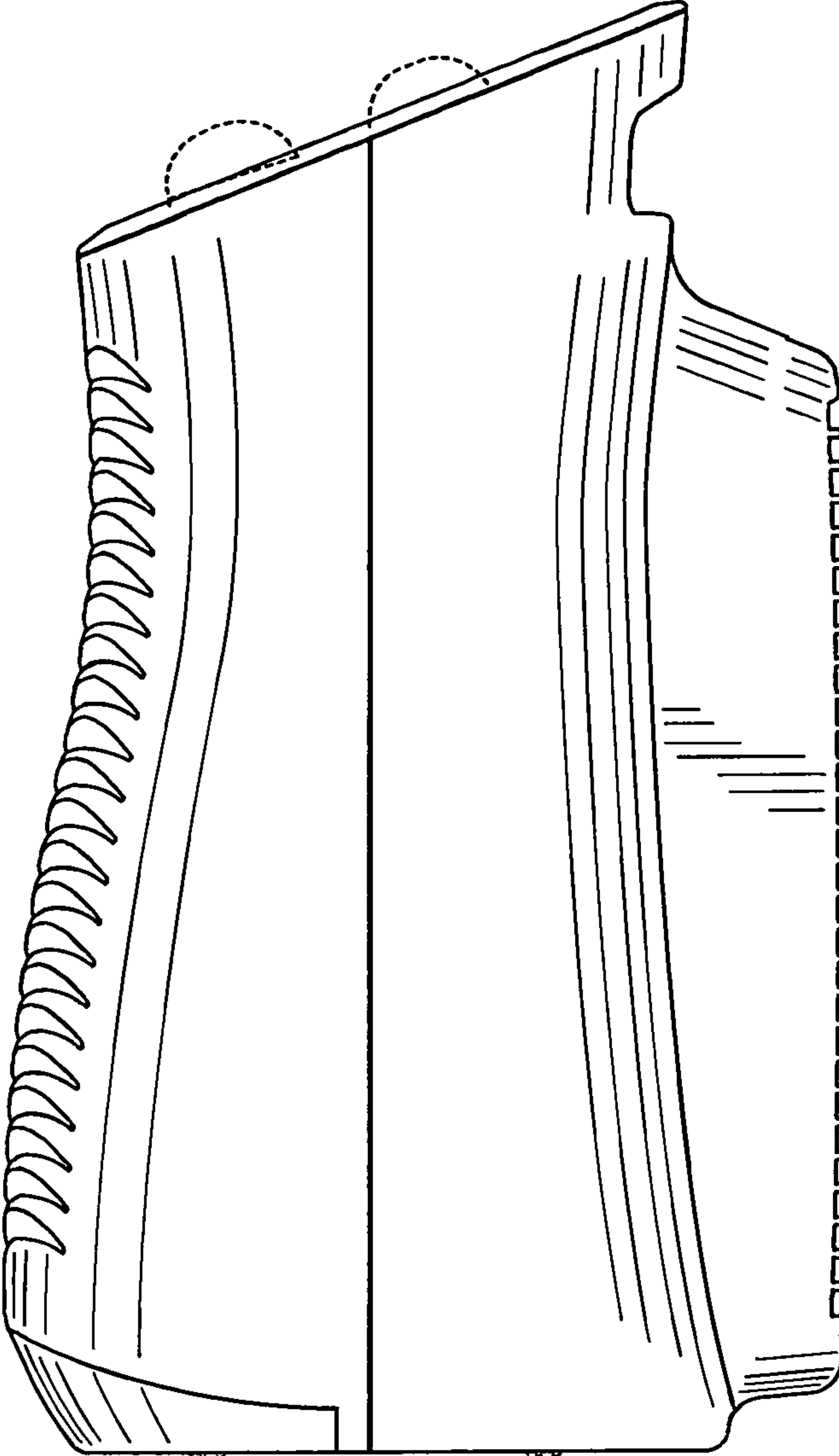

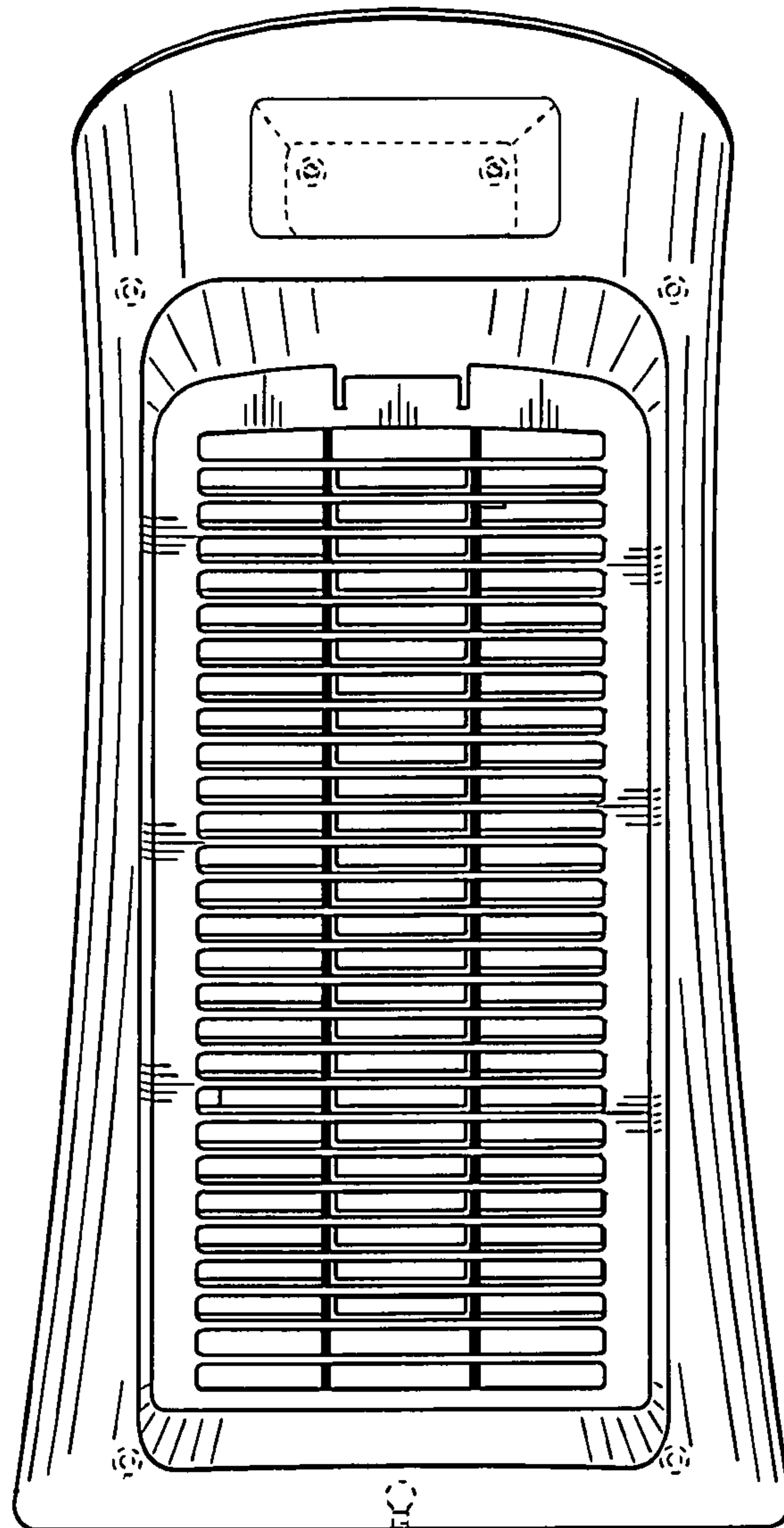

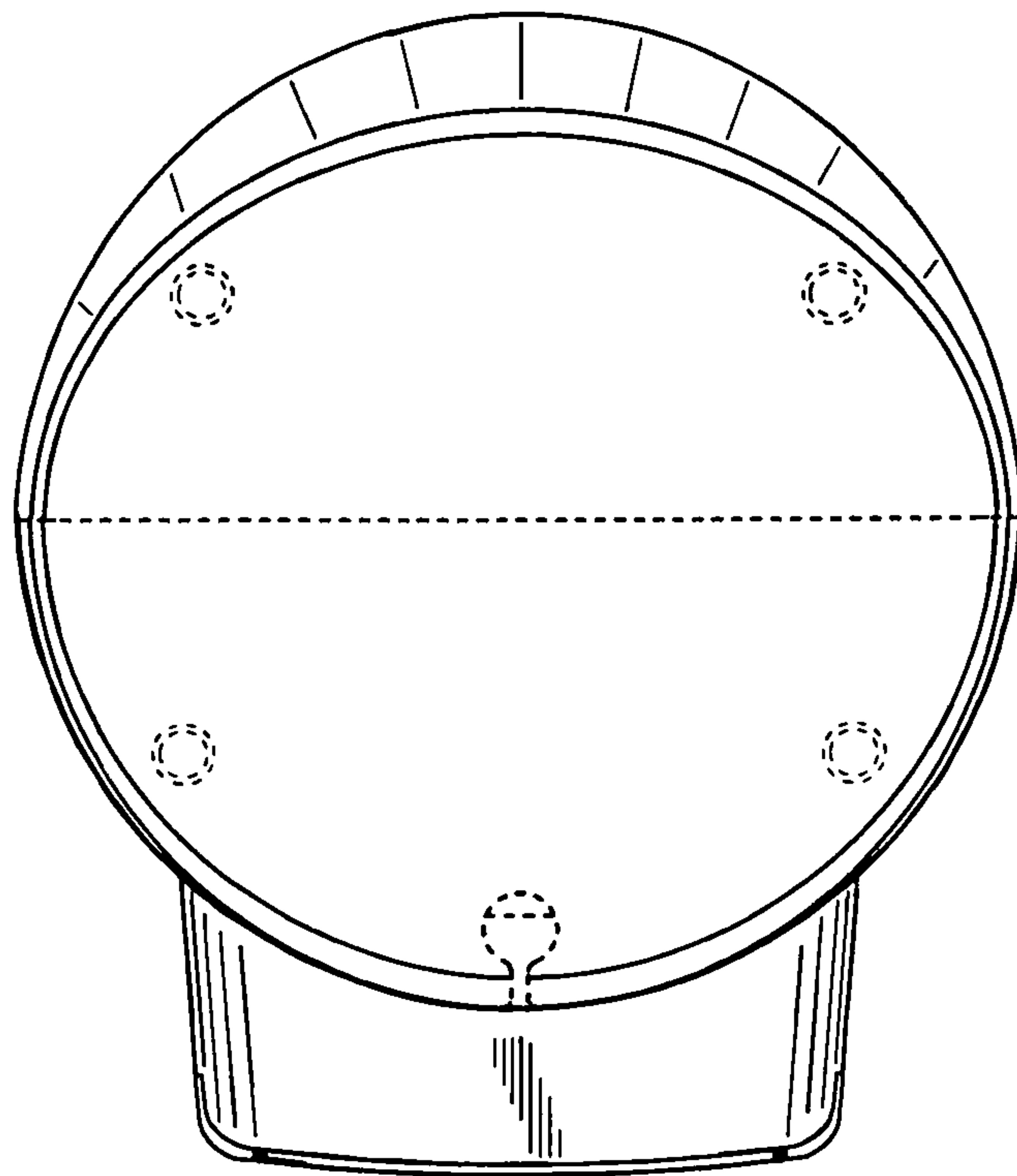

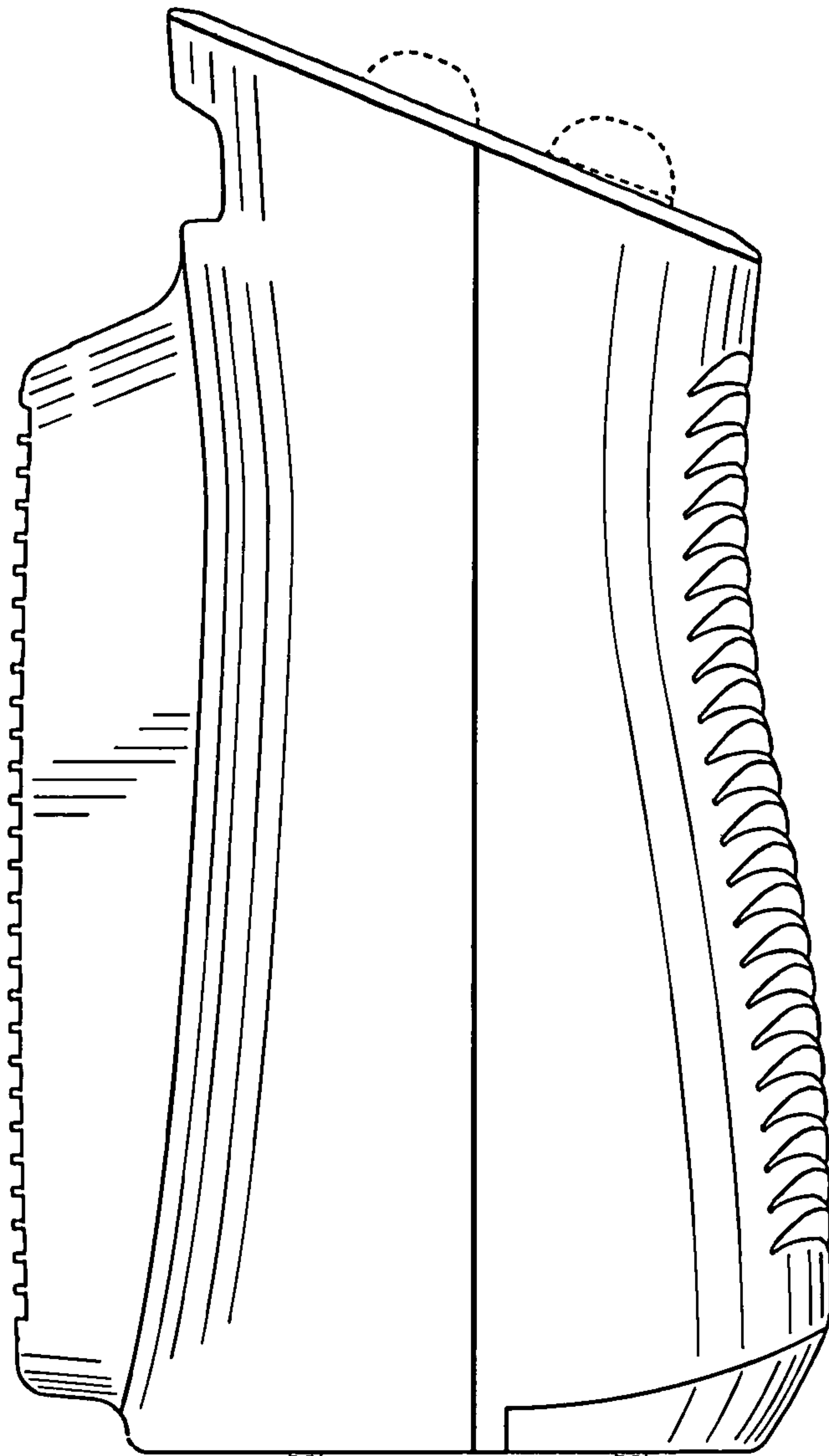
