The ornamental design for a blood glucose meter, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a blood glucose meter showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is another side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is another front view thereof, in which the information of blood glucose is displayed on a front portion of the blood glucose meter.

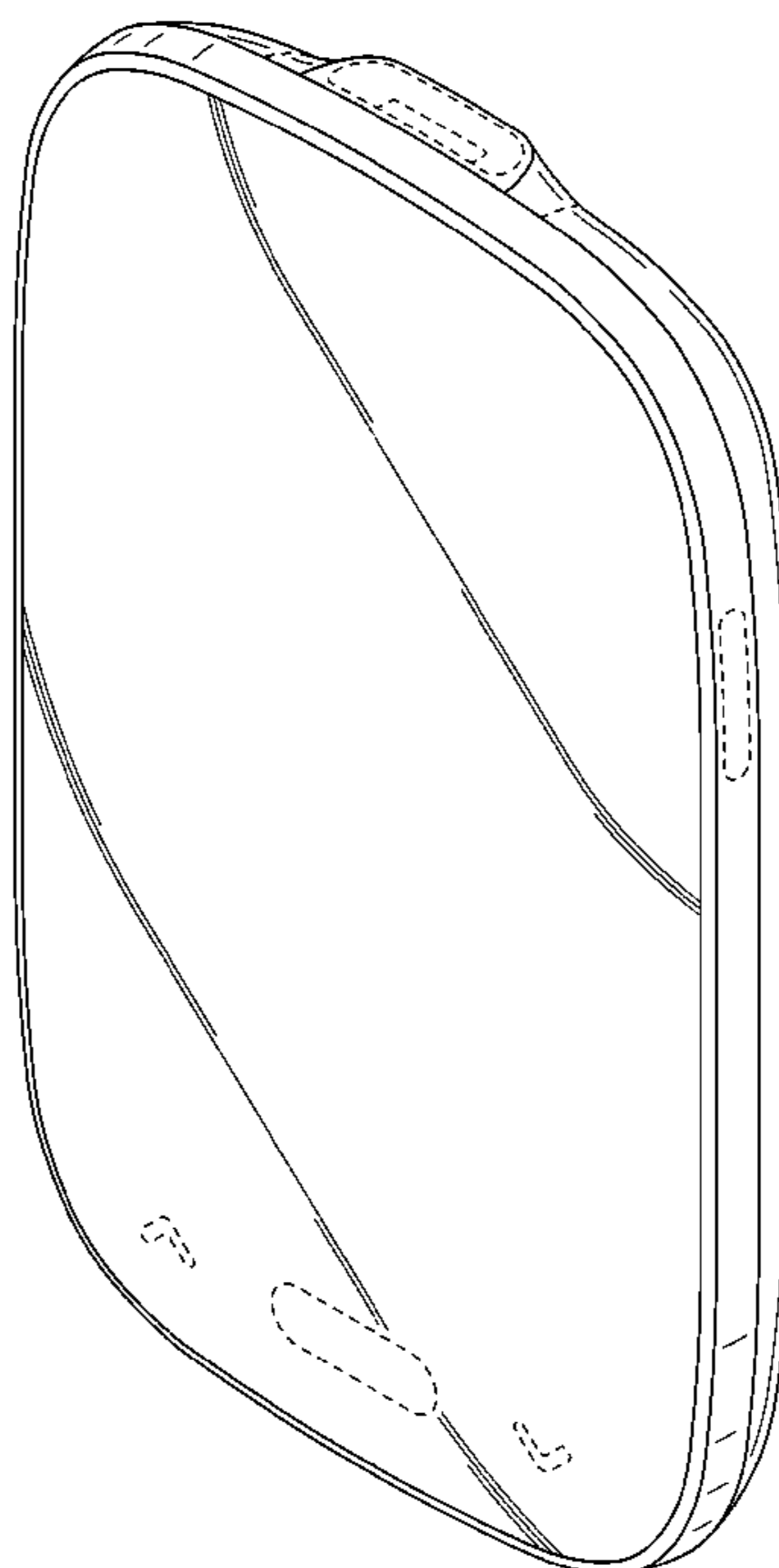

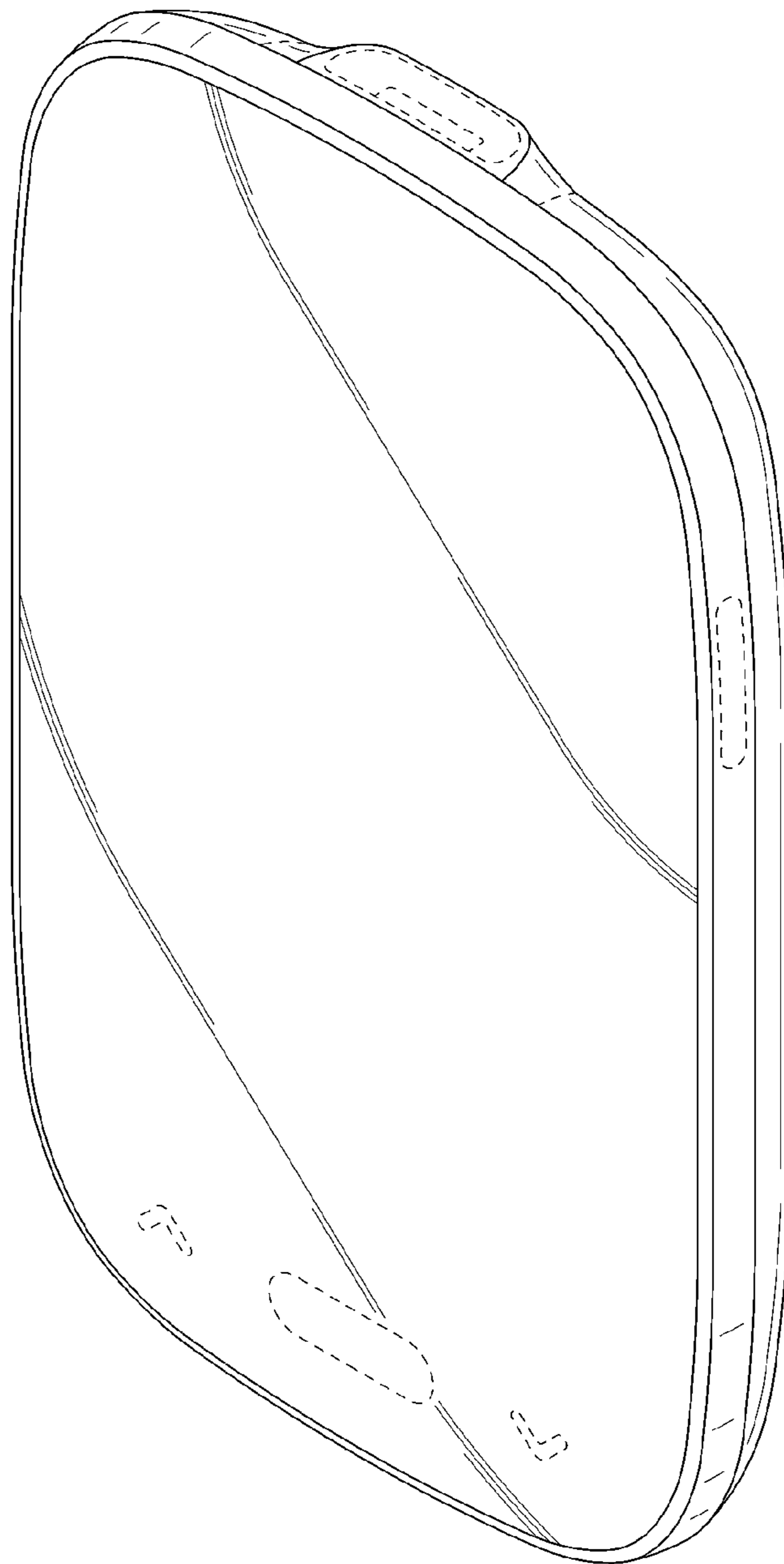

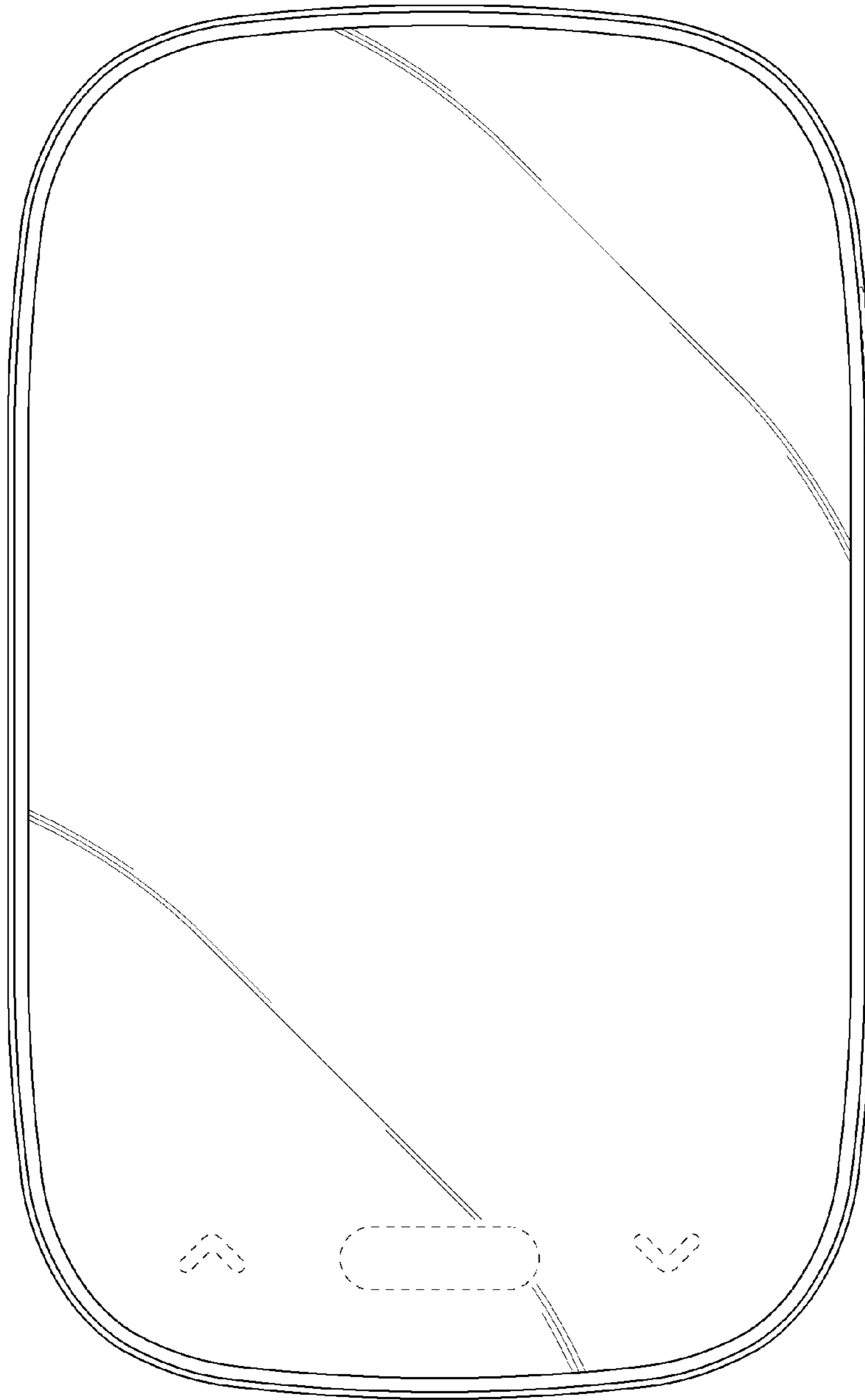

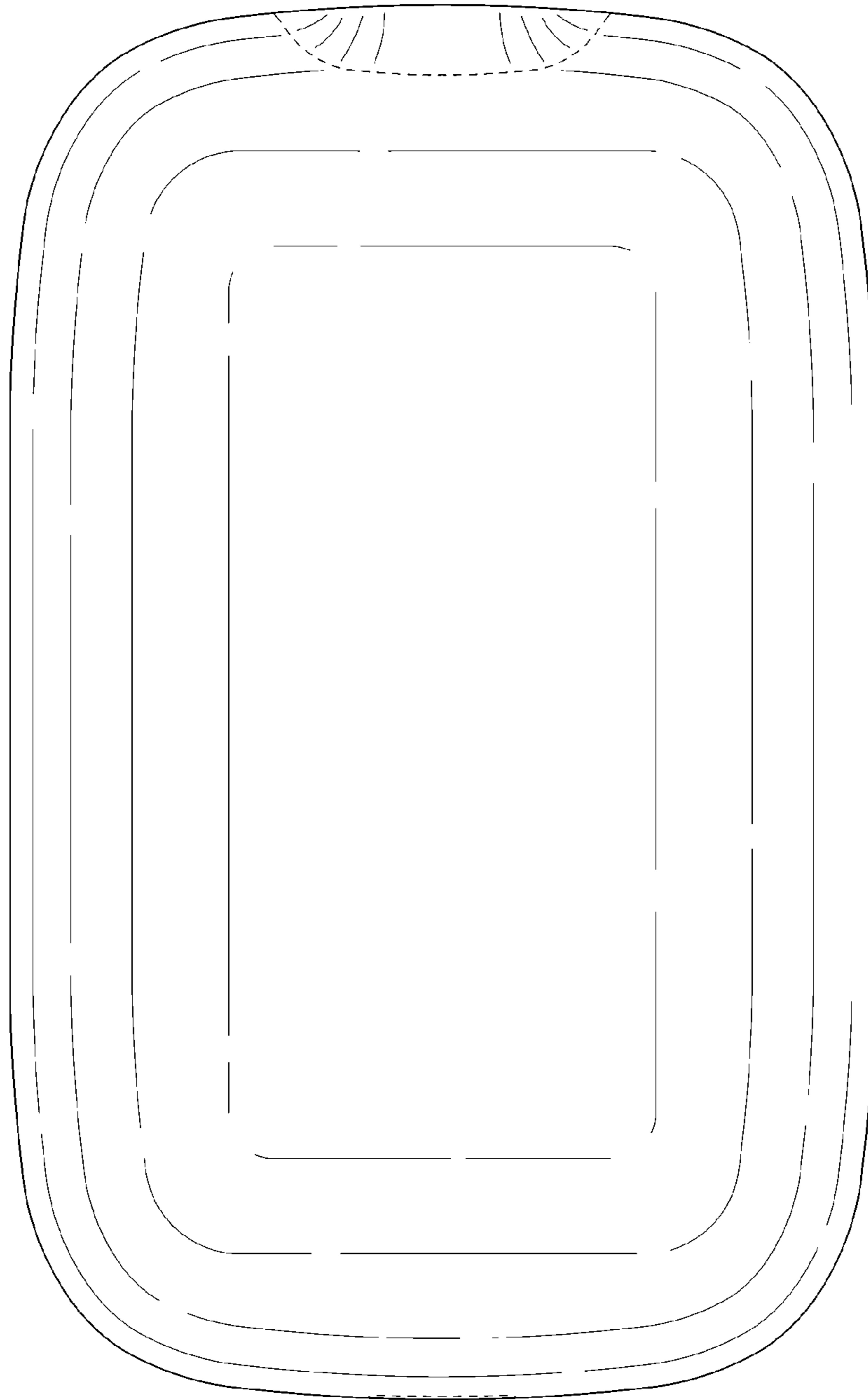

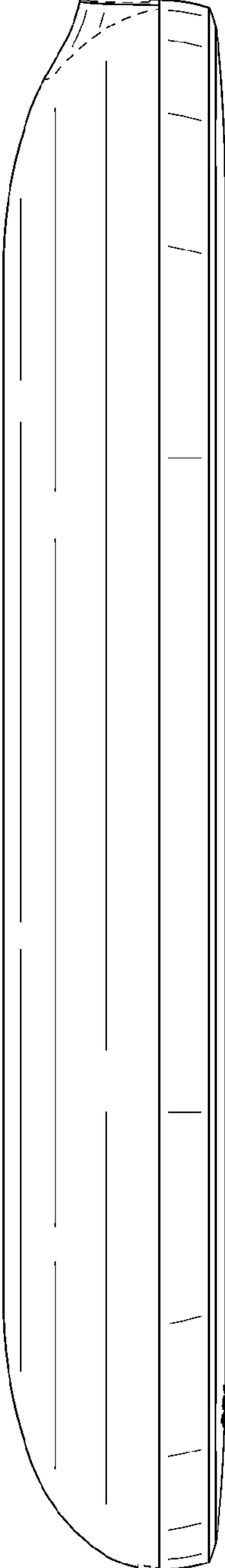

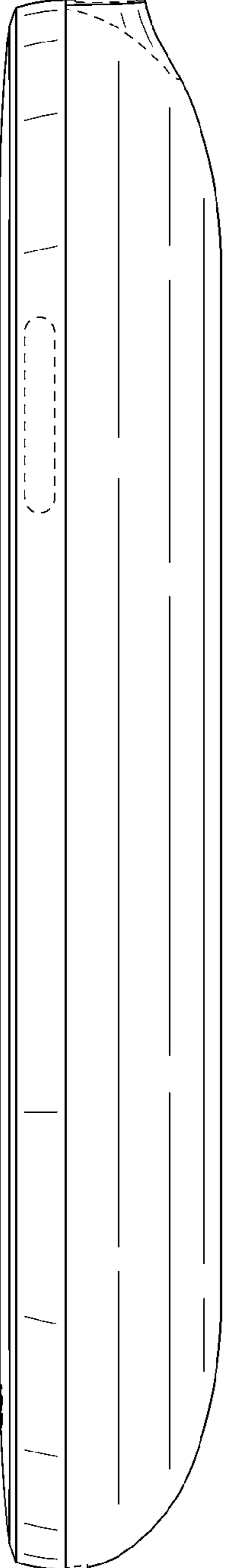

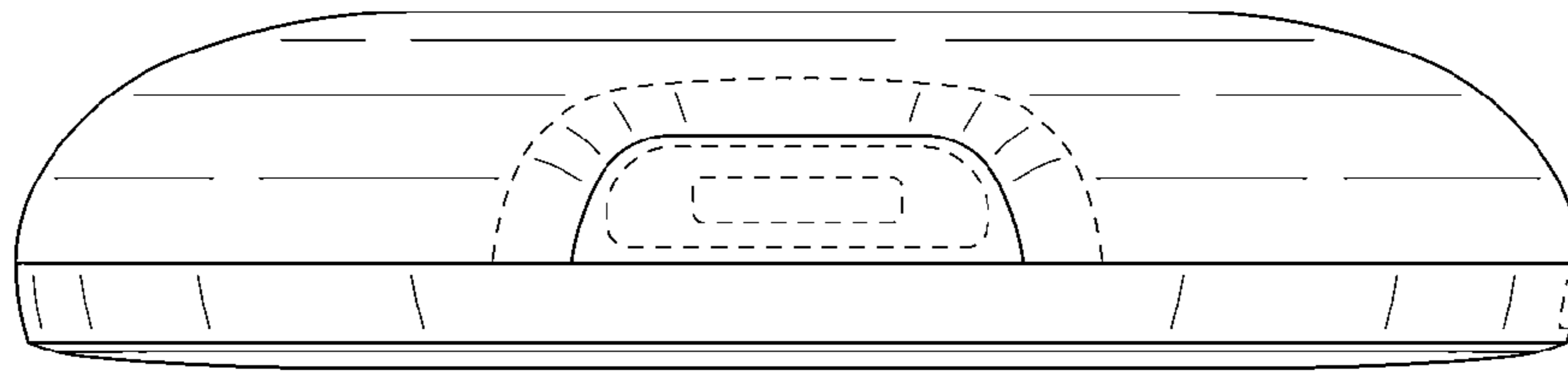

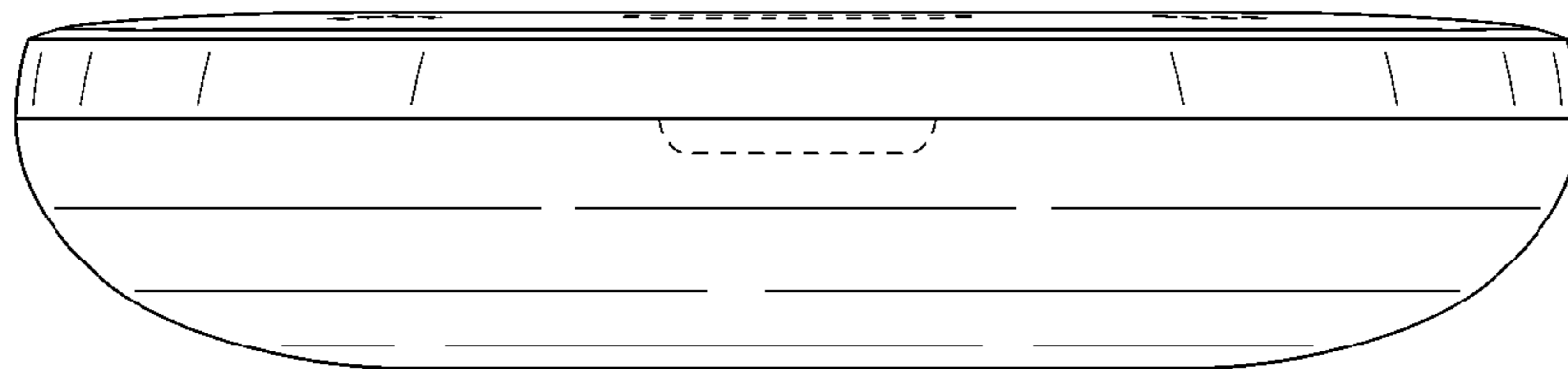
