FIG. 9 is a front elevational view of our new design together with athletic shoulder pads; and,

FIG. 10 is a rear elevational view of our new design together with athletic shoulder pads.

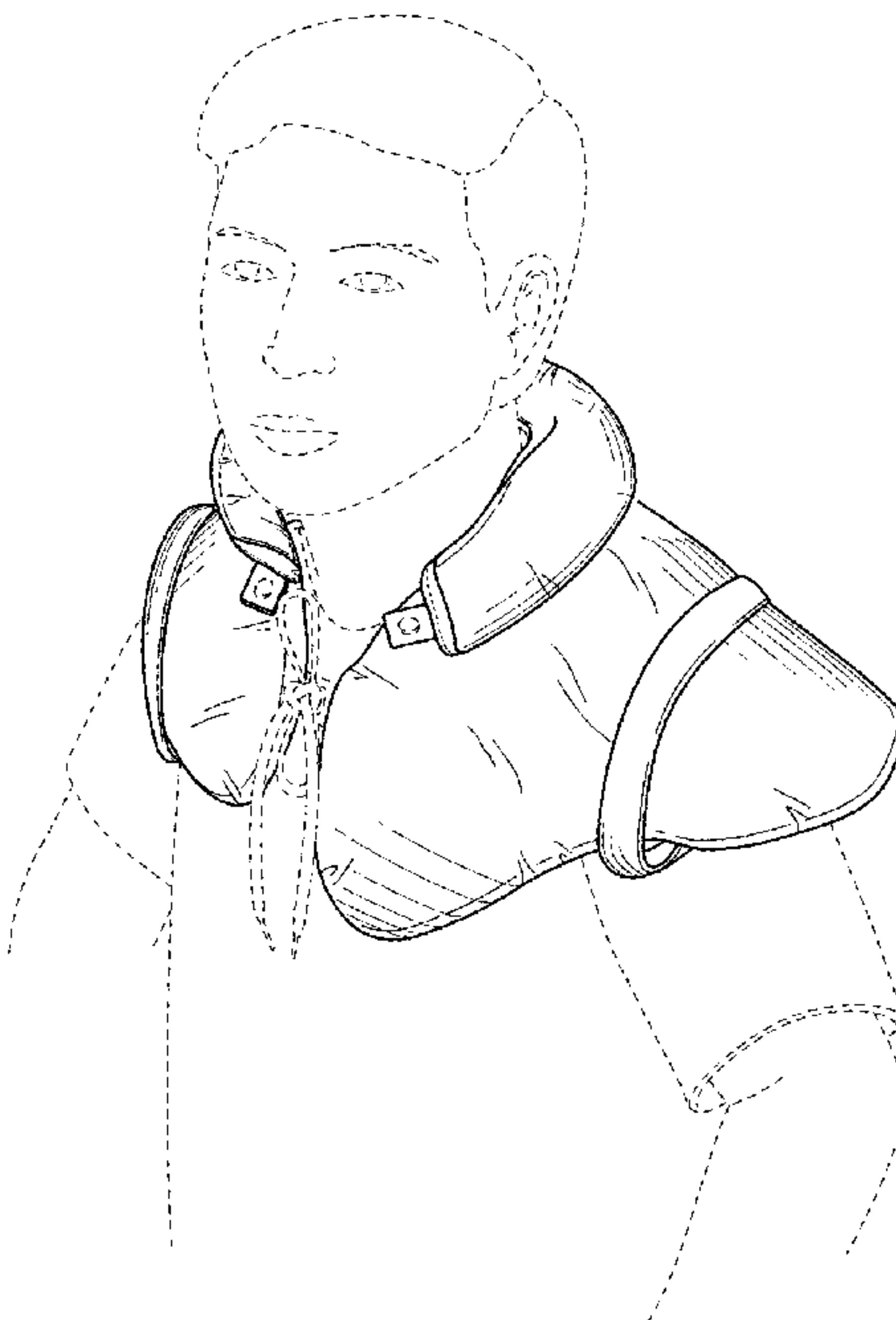

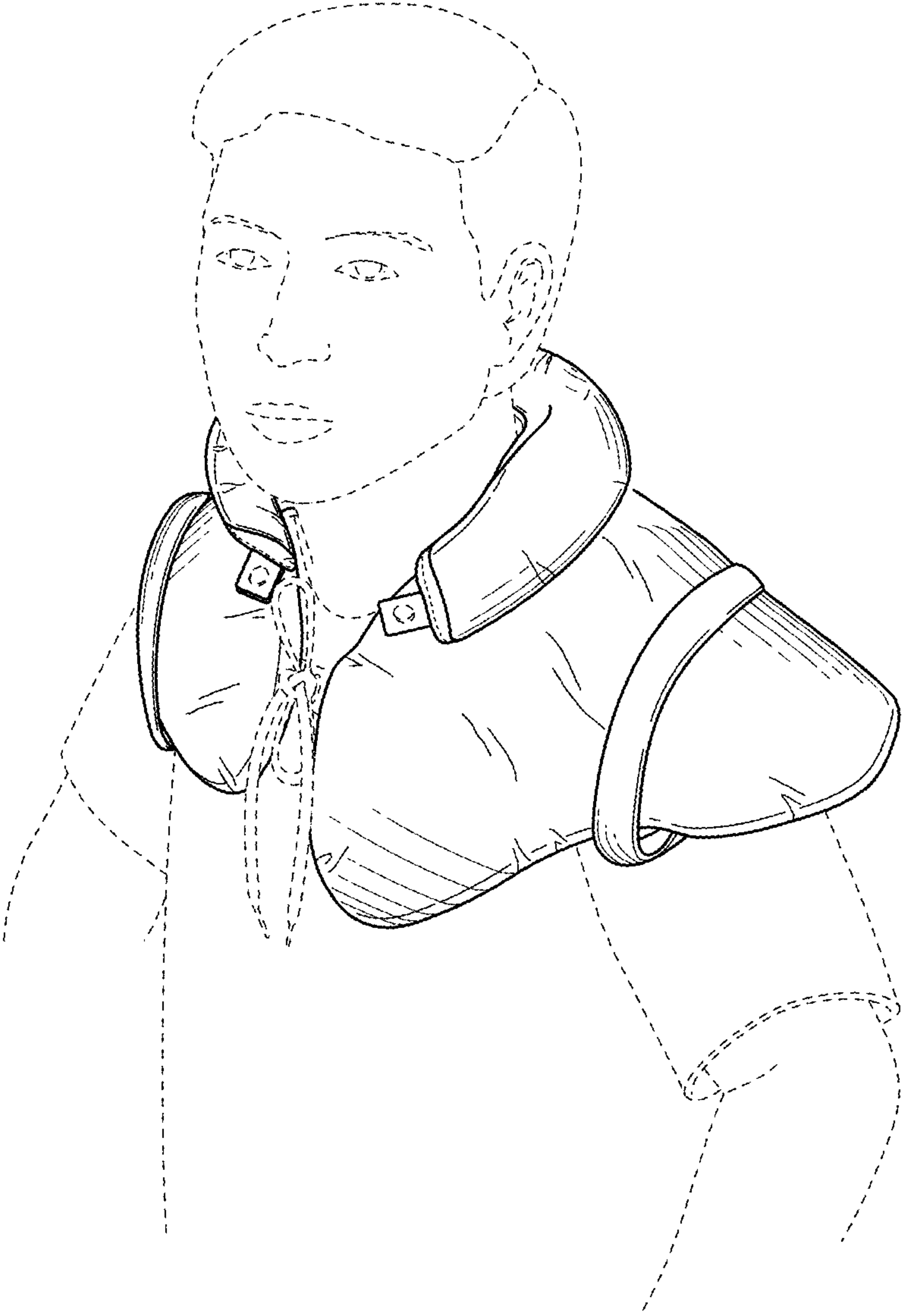

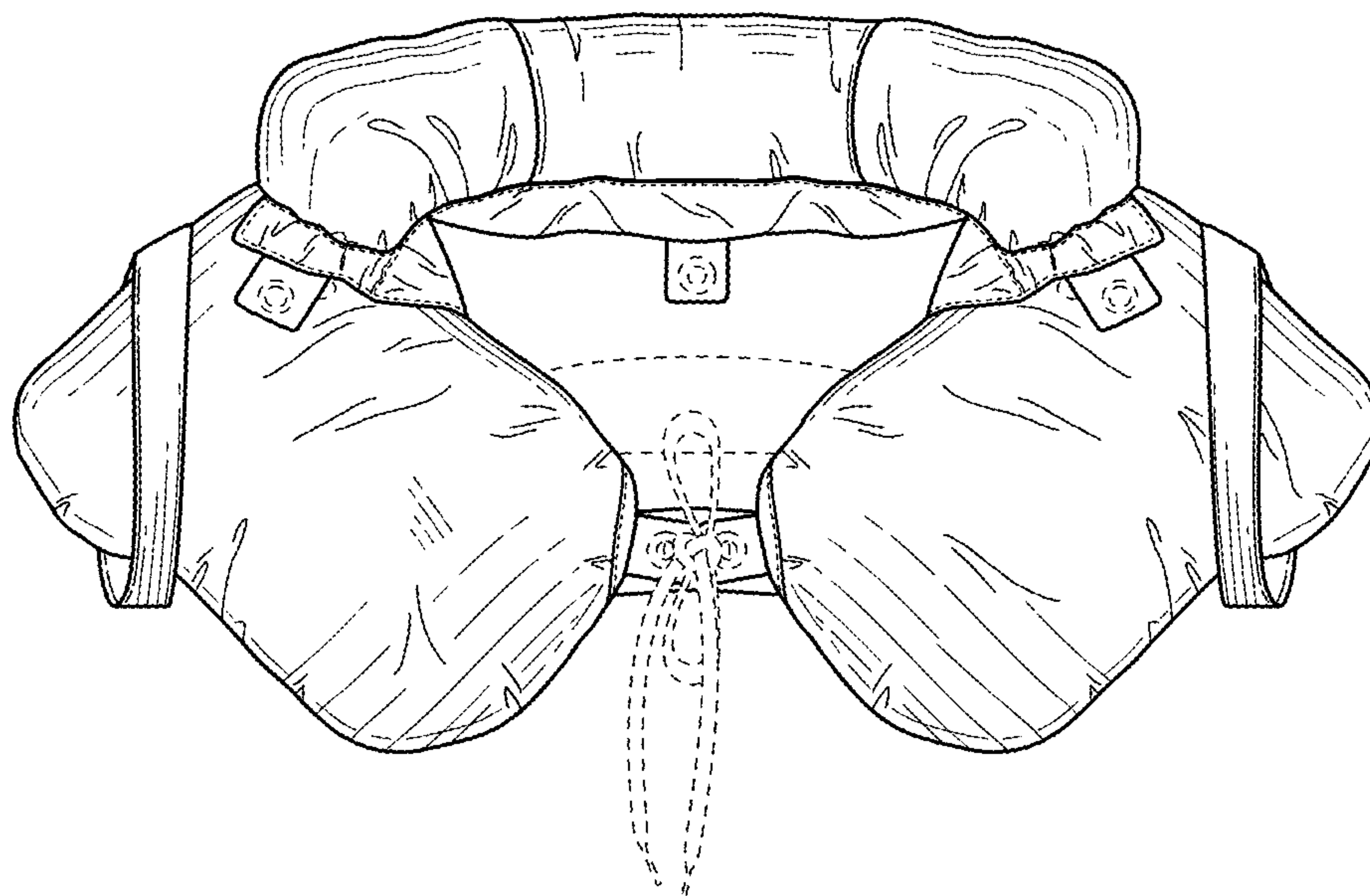

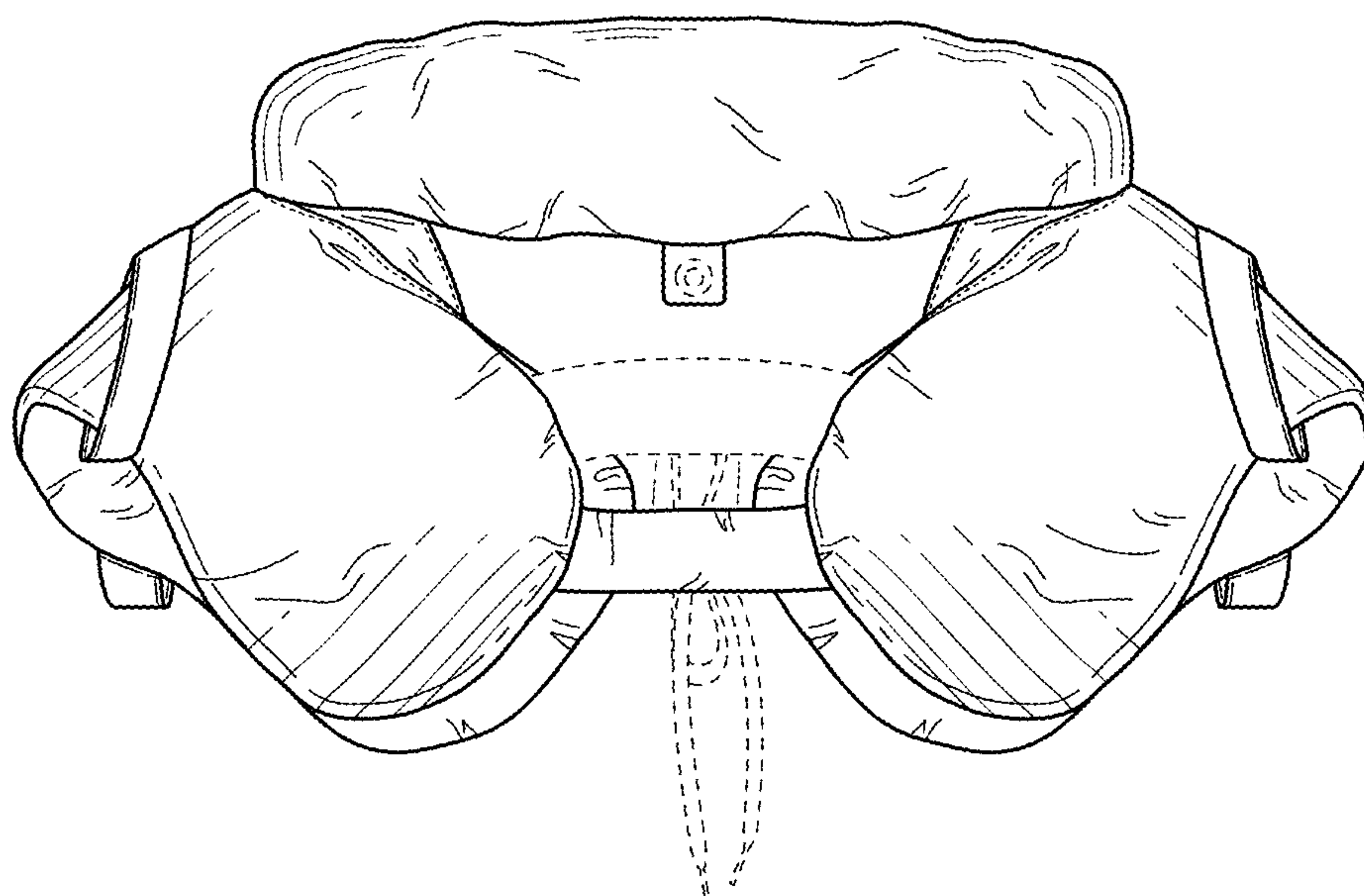

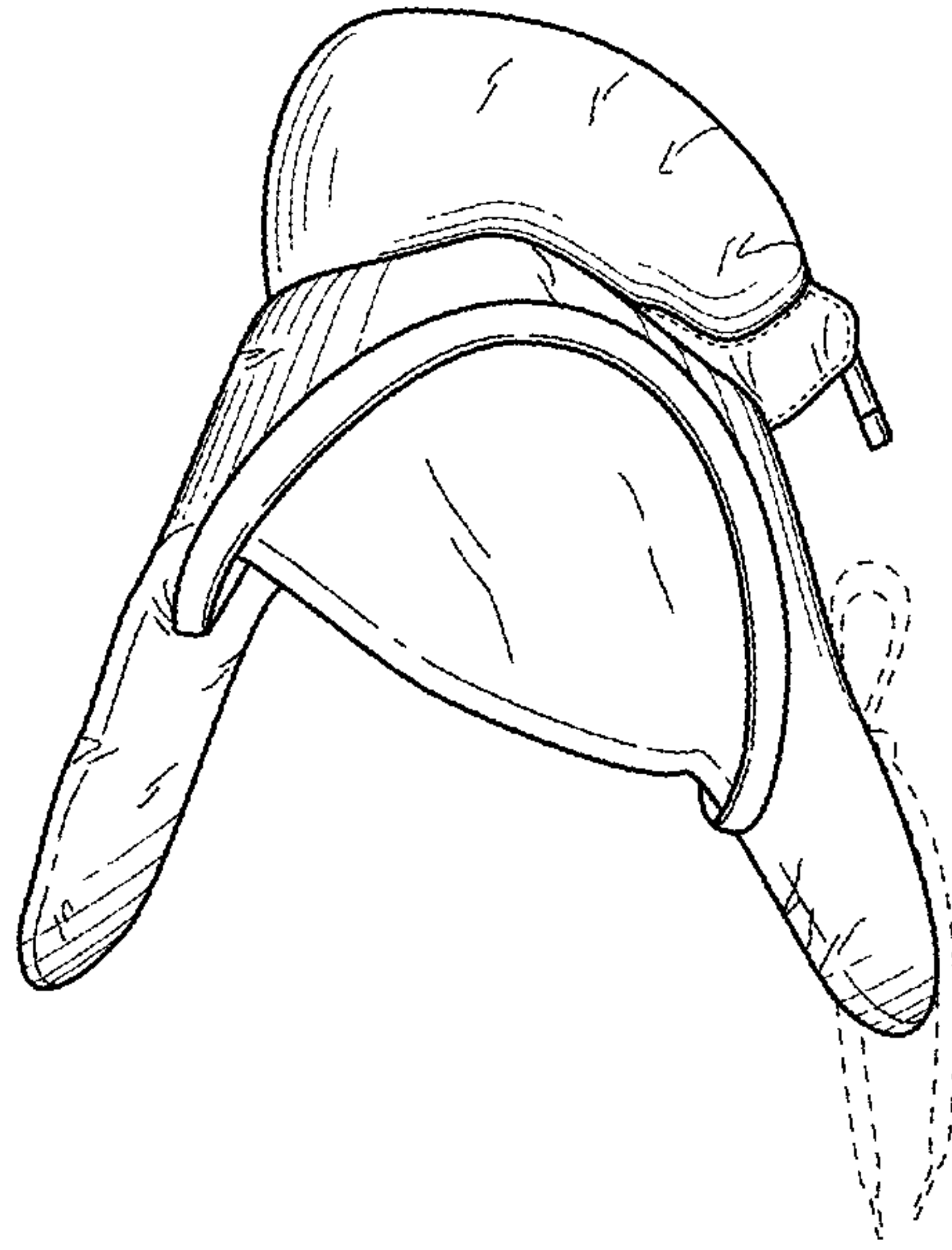

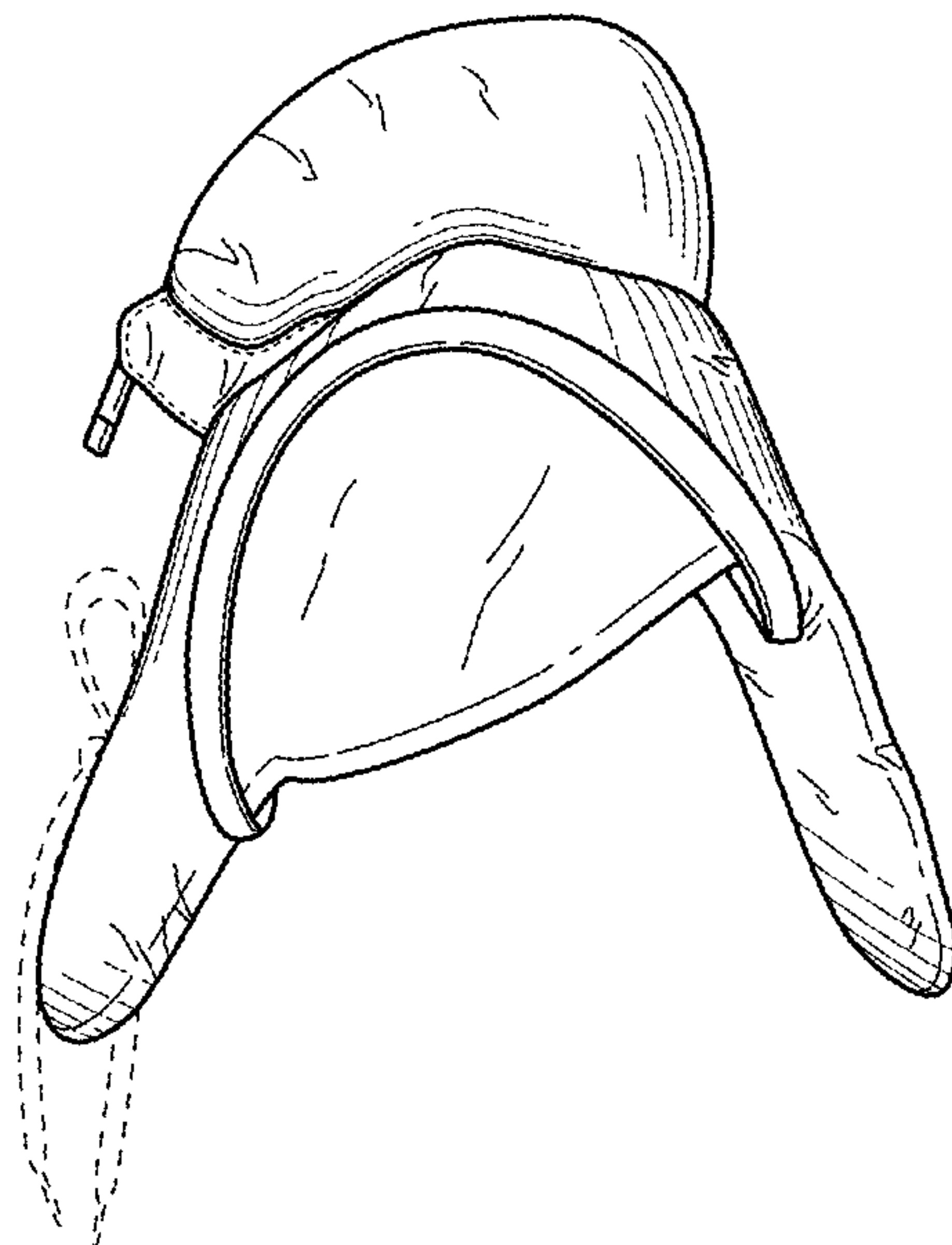

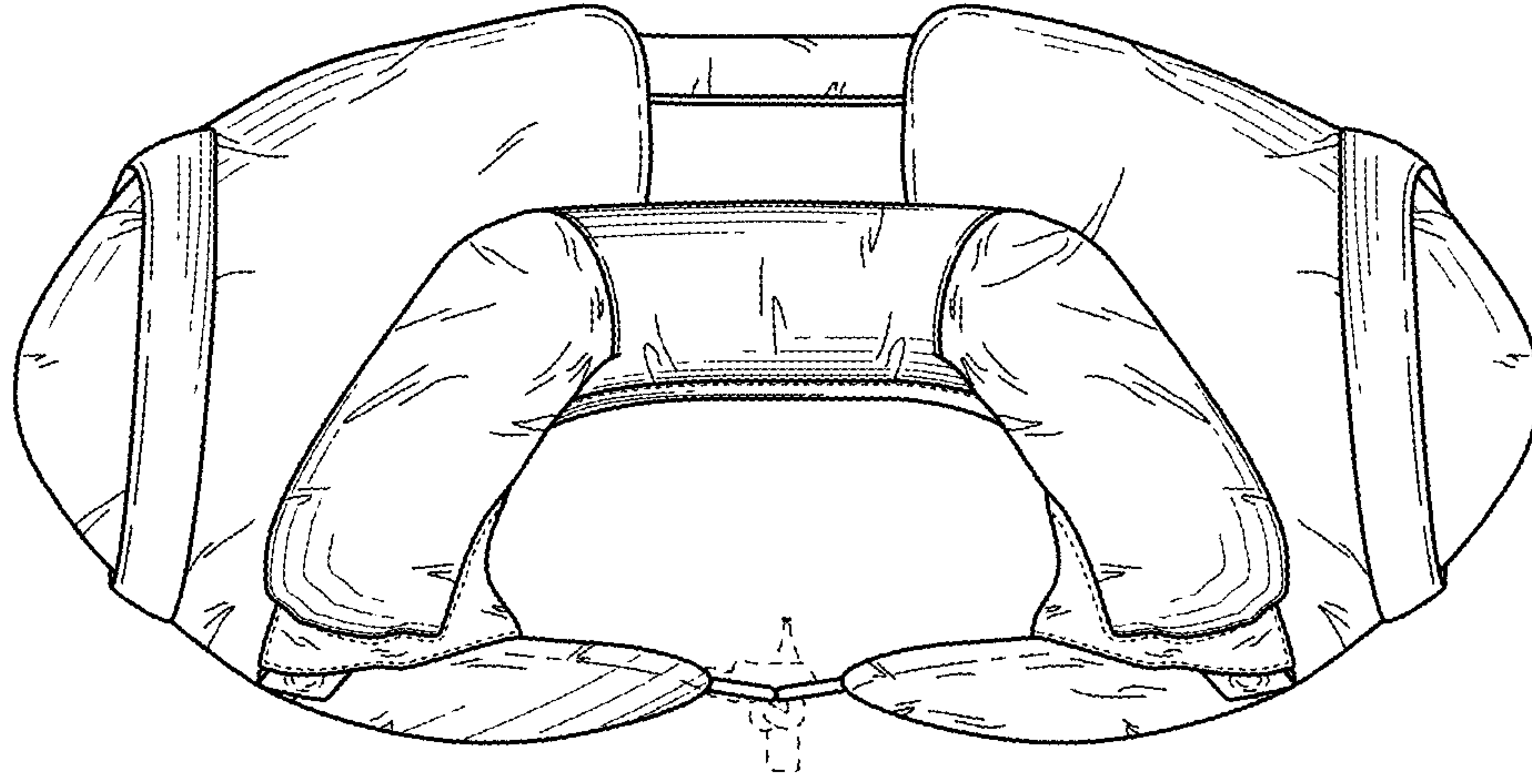

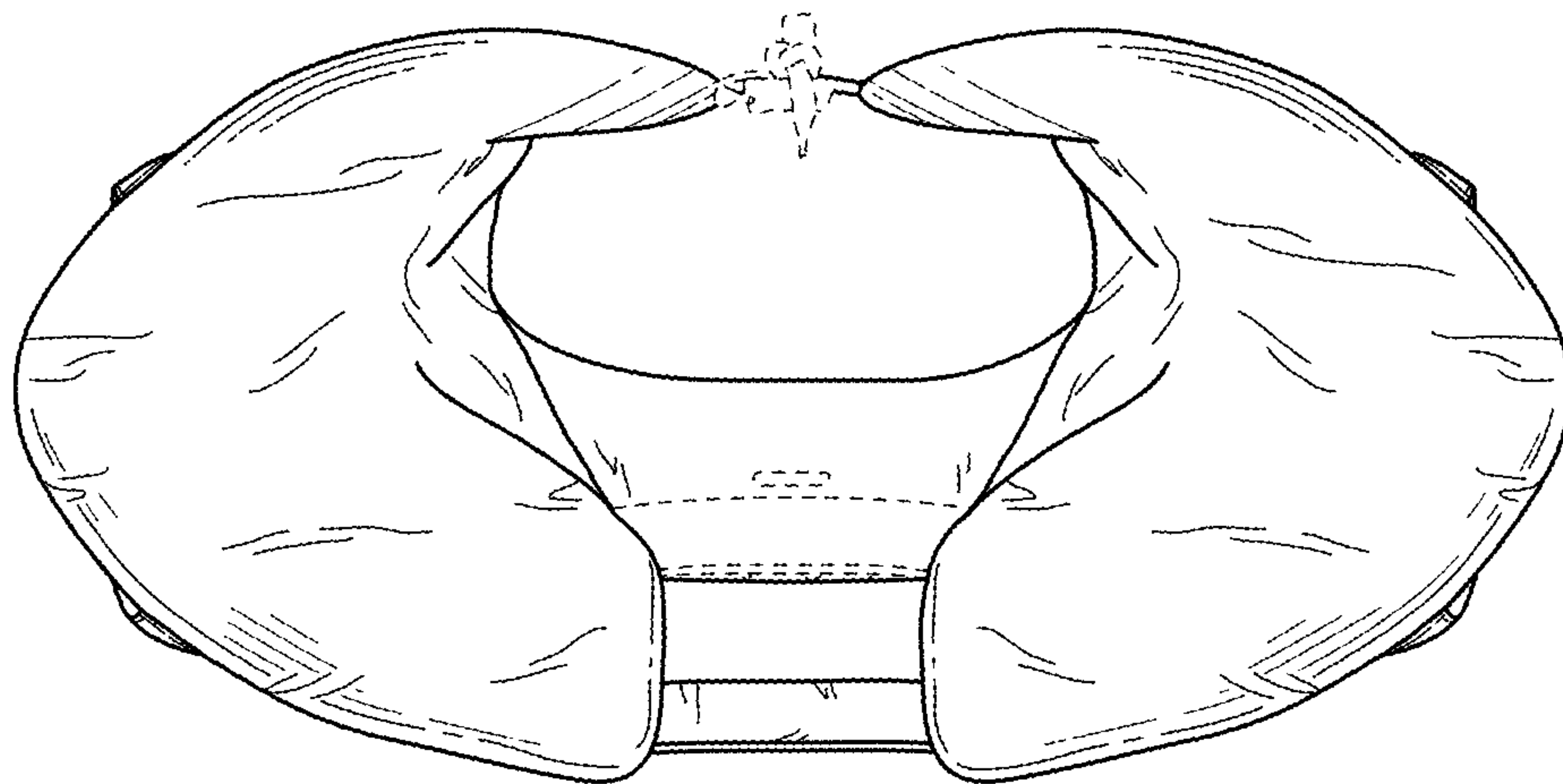

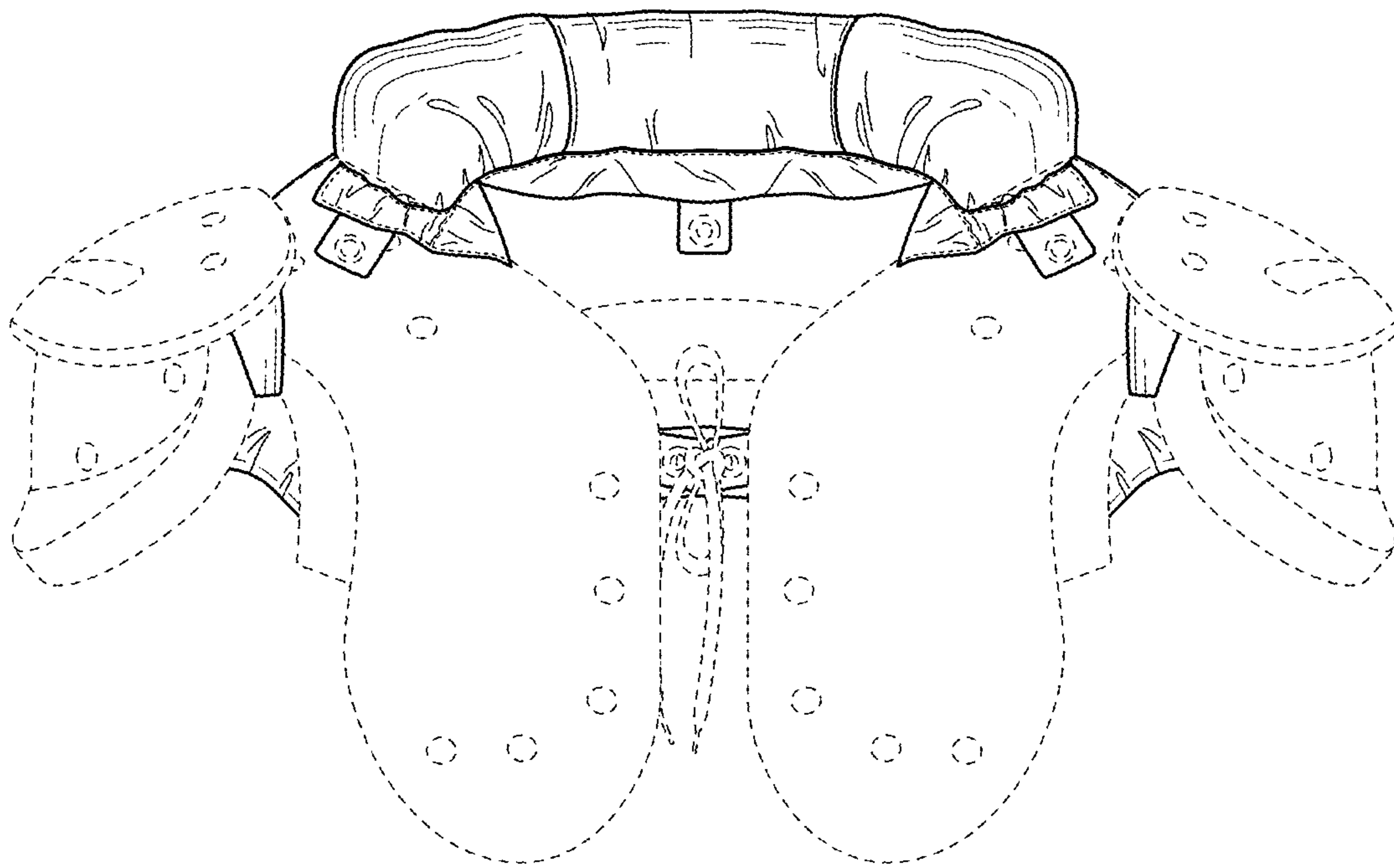

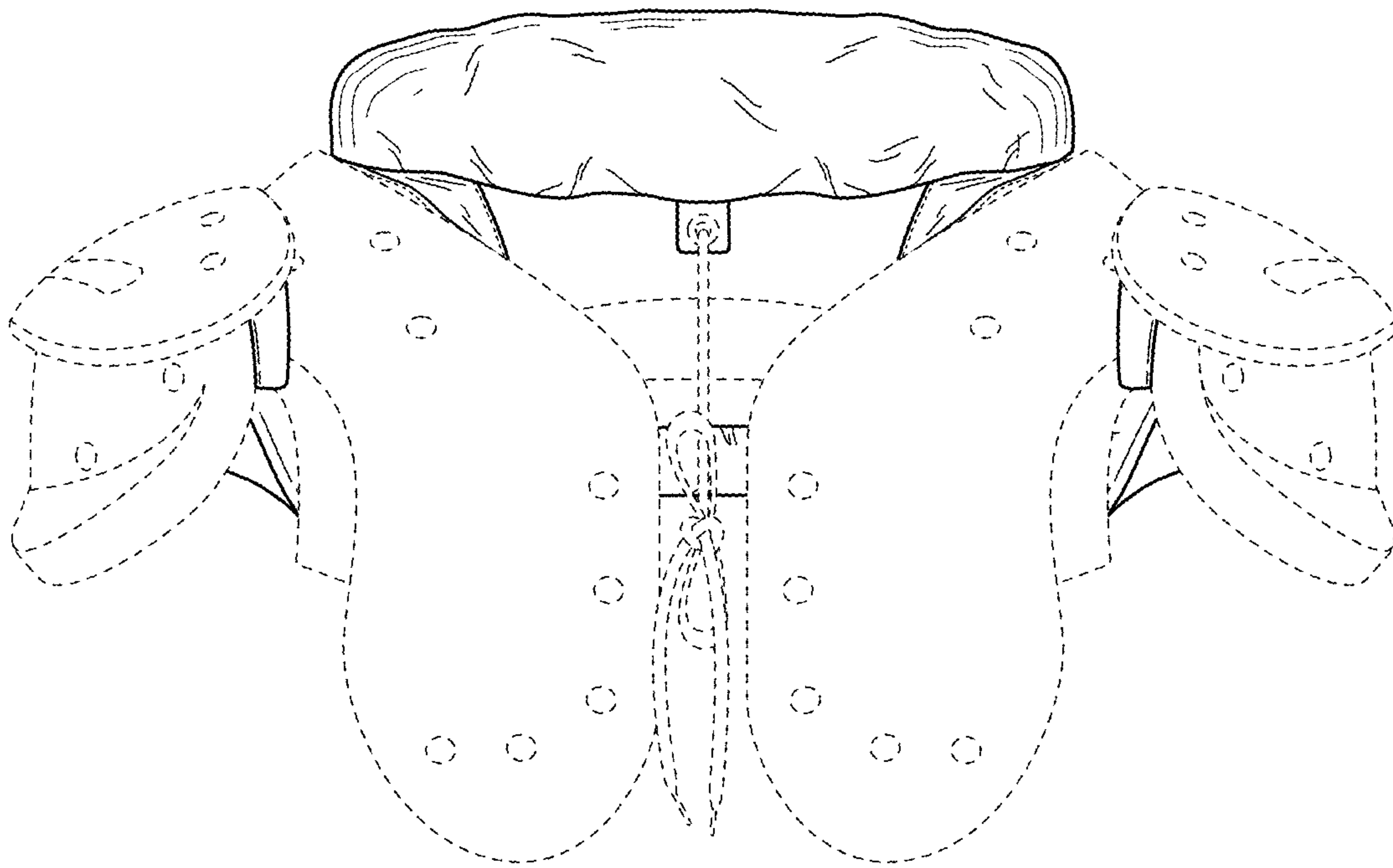
