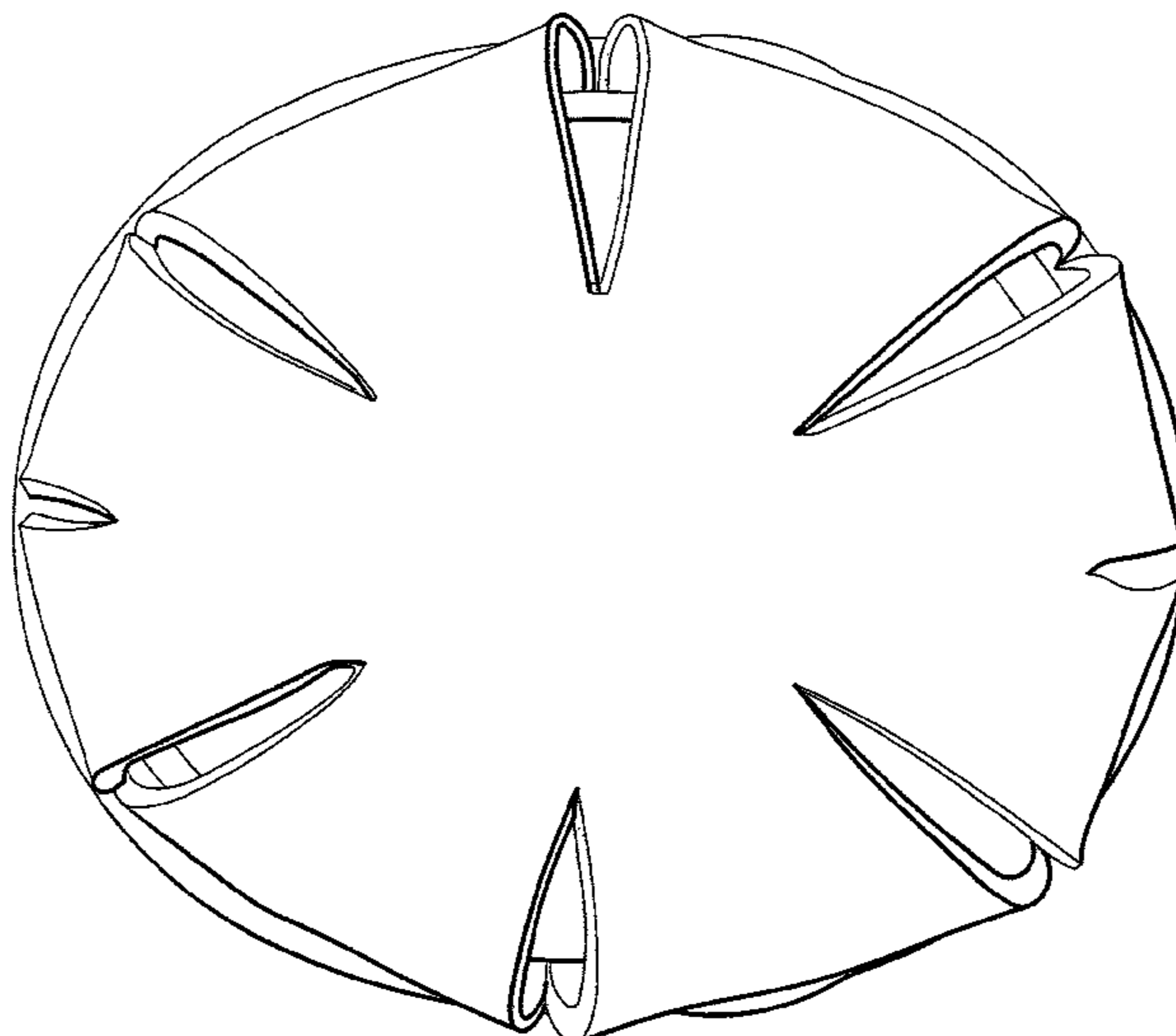
FIG. 4 is a right side perspective view thereof;

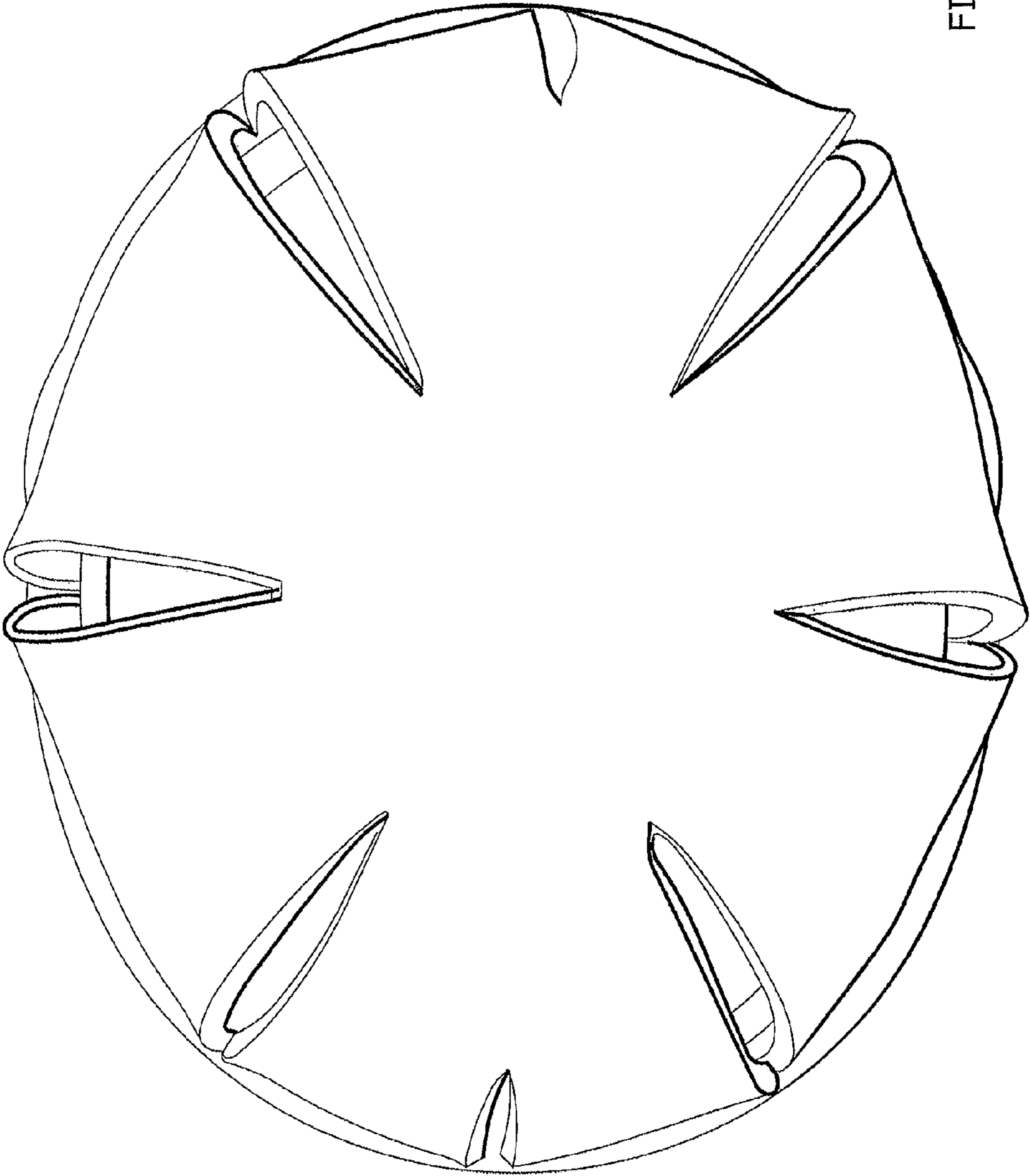

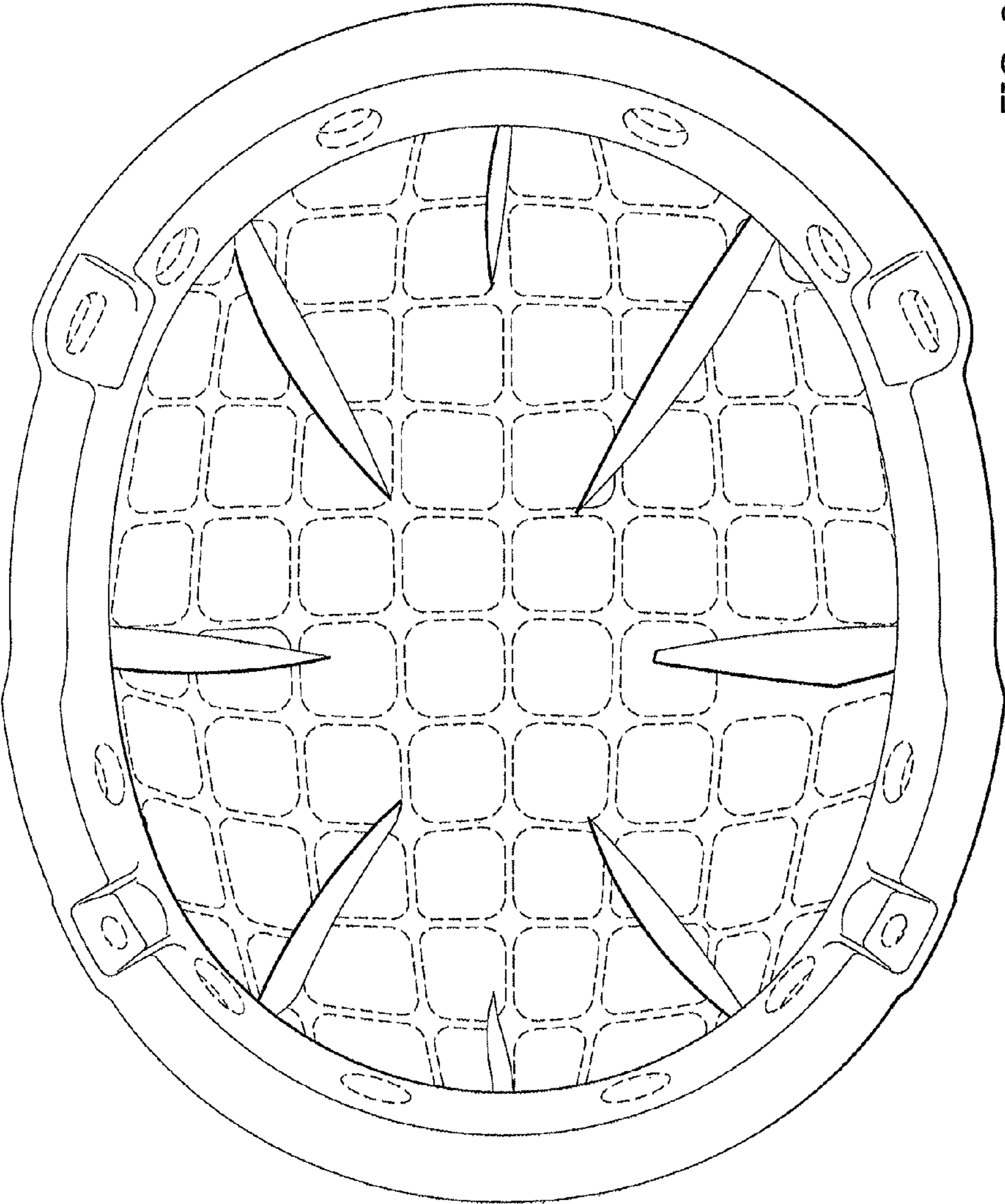

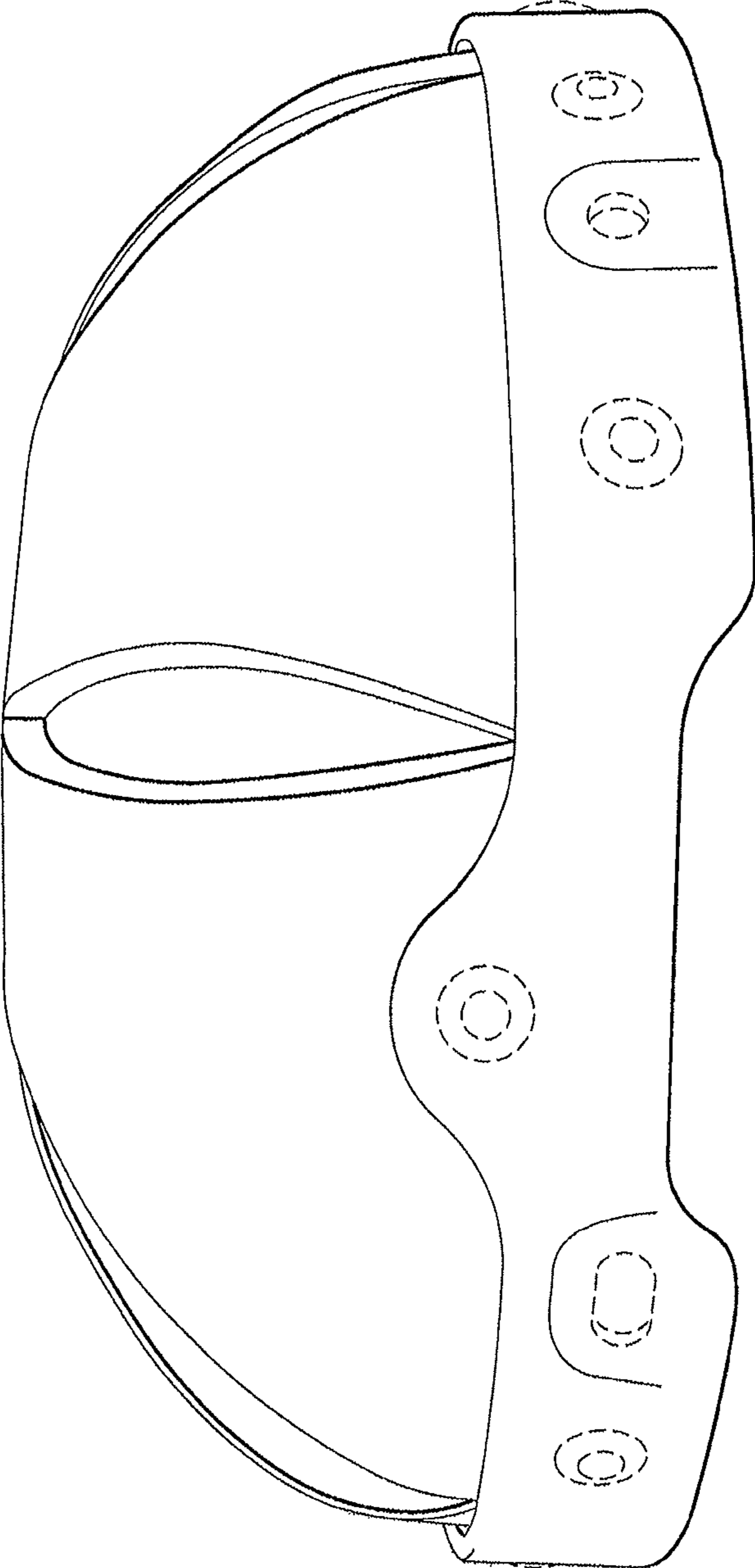

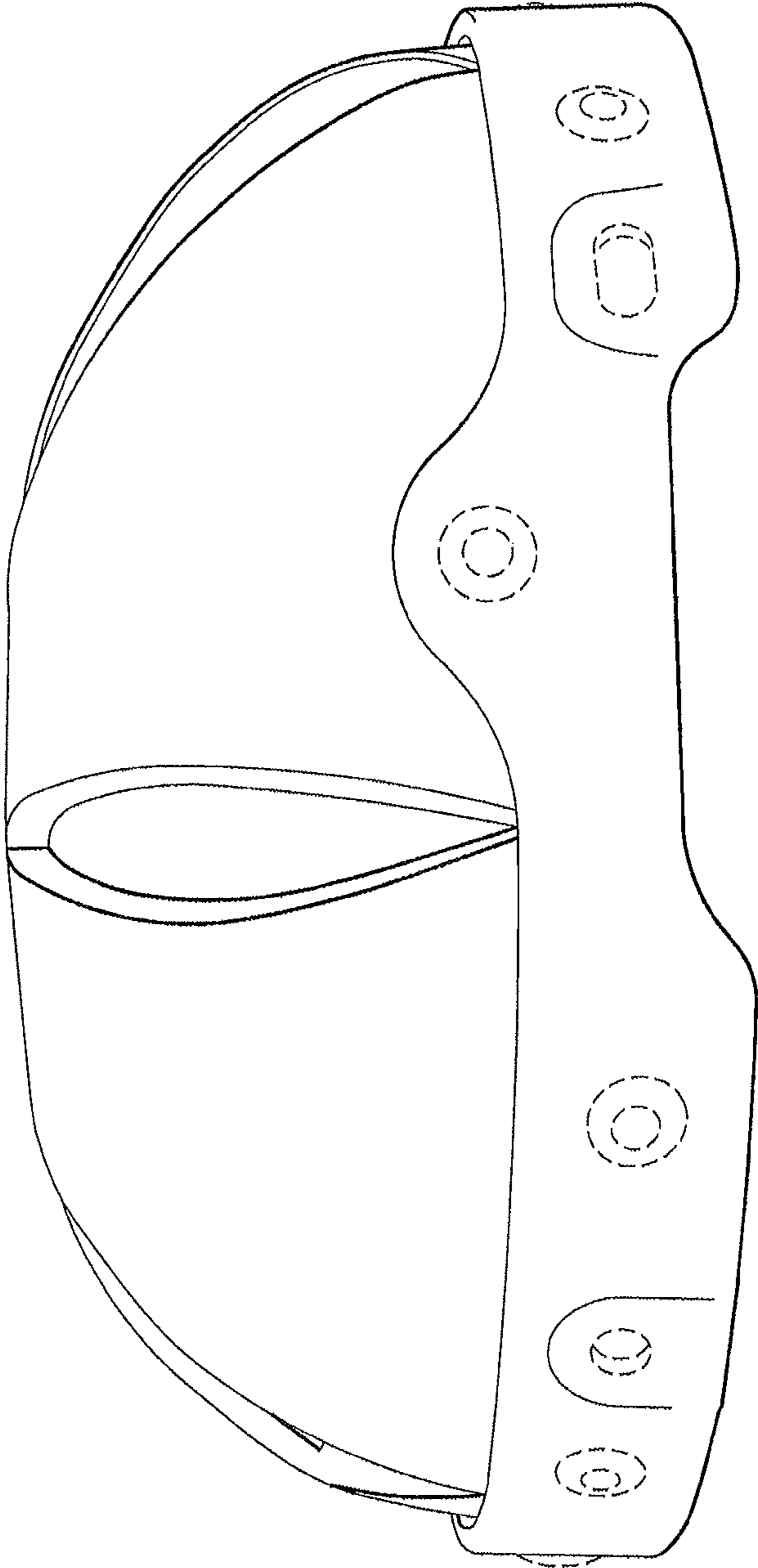

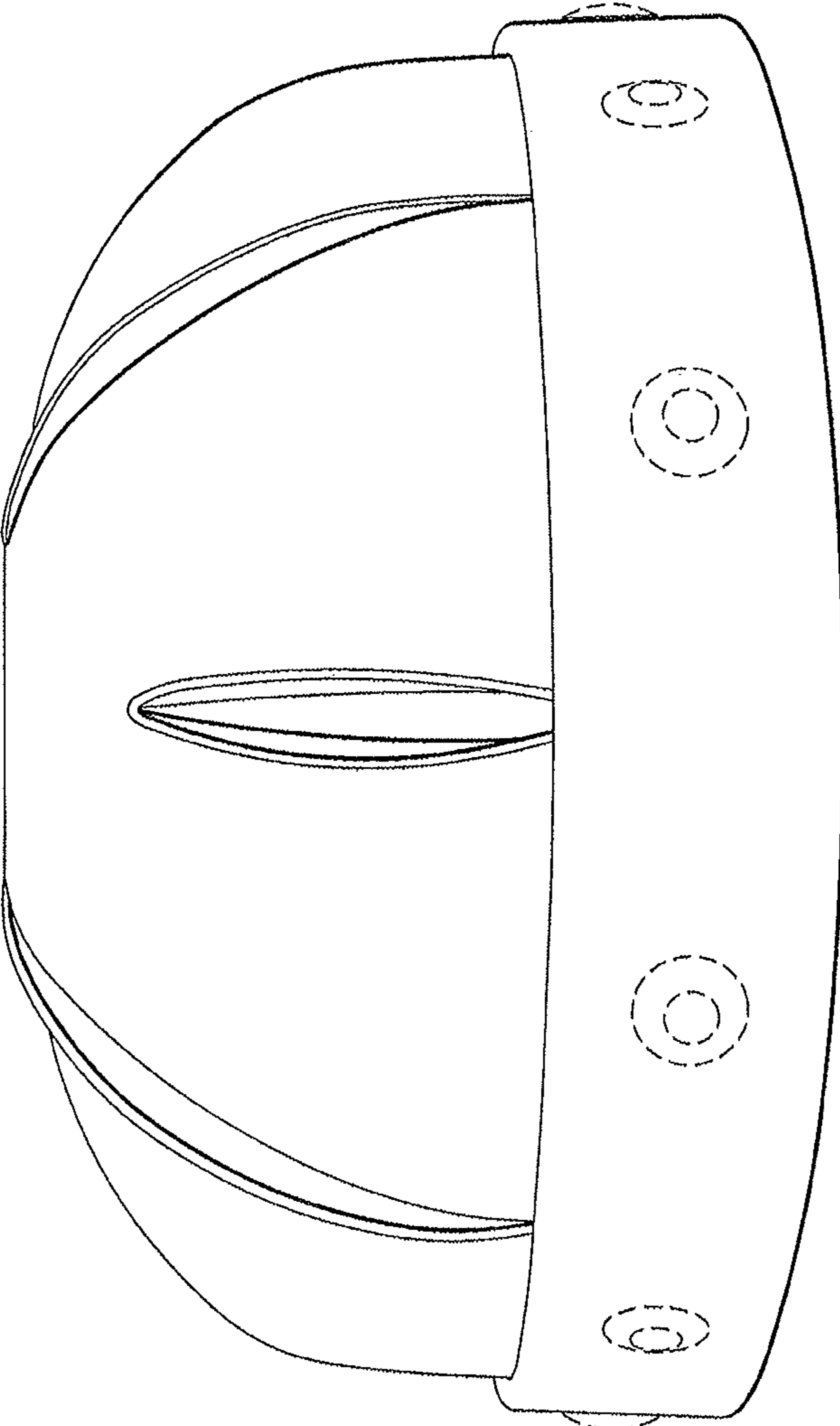

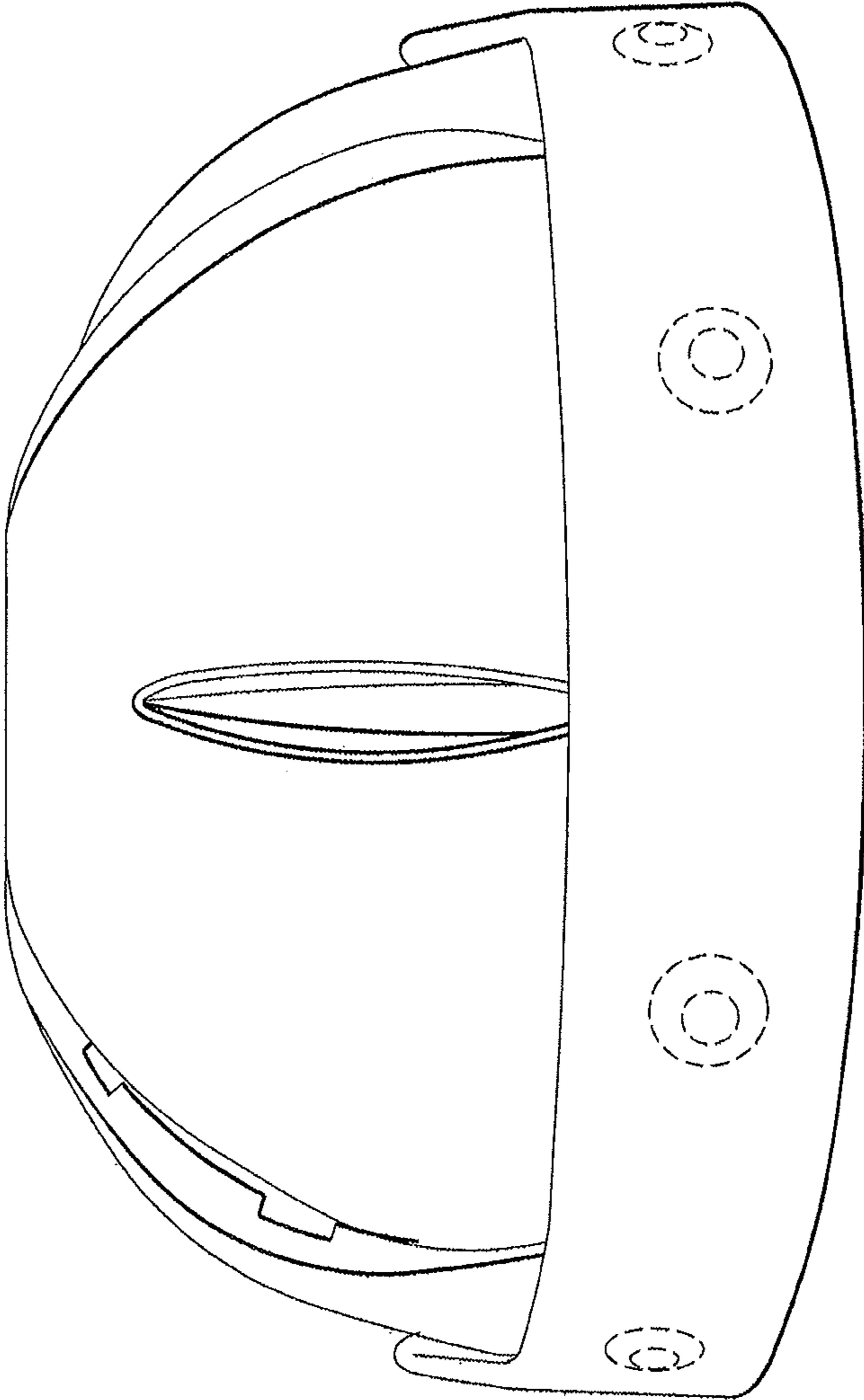
