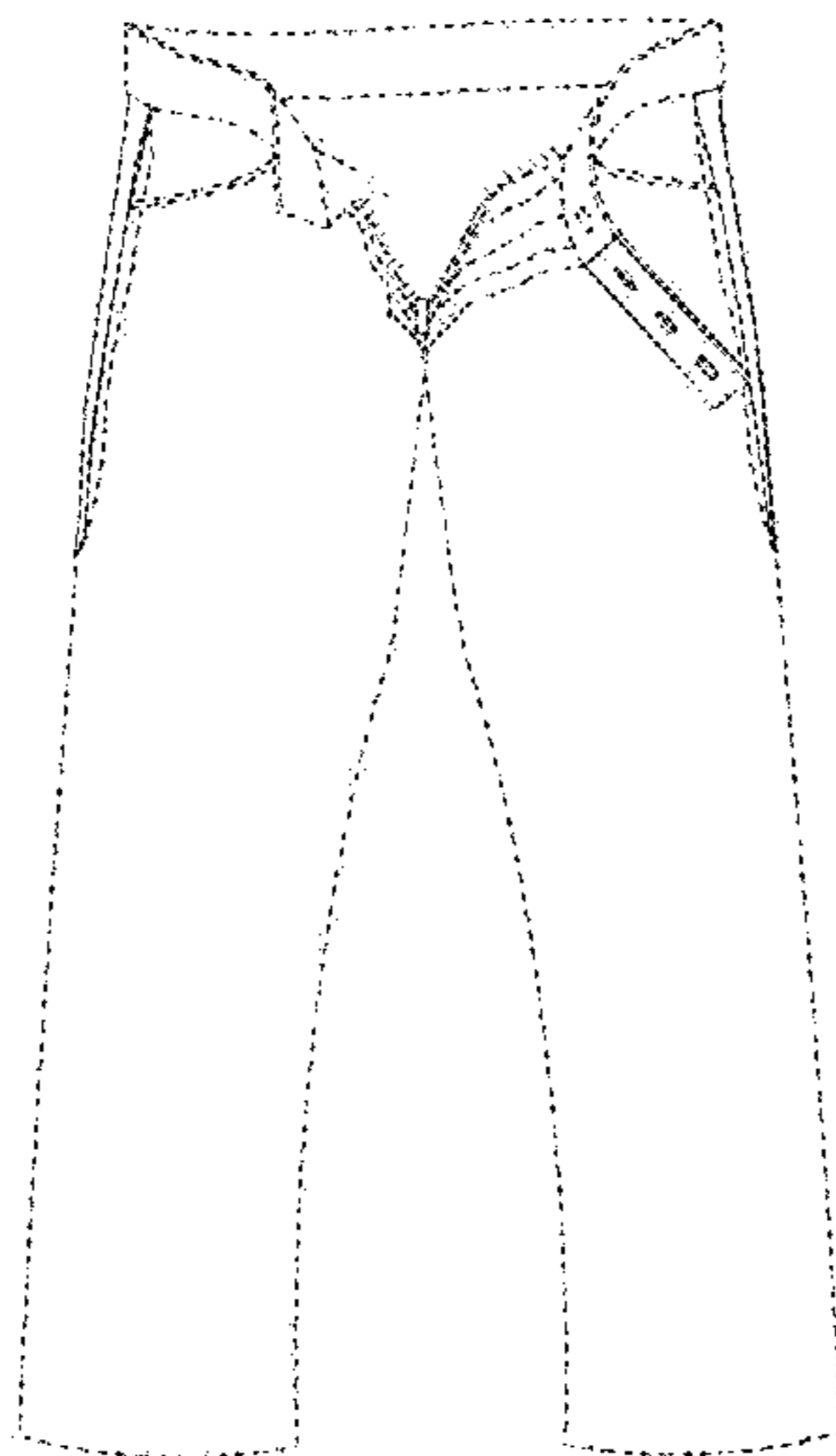
(57) **CLAIM**
I claim the ornamental design for jeans, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the jeans.
FIG. 2 is a rear view of the jeans.
FIG. 3 is a side view of the jeans.
FIG. 4 is a second side view of the jeans.
FIG. 5 is a top-down view of the jeans.
FIG. 6 is a bottom-up view of the jeans; and,
FIG. 7 is a side view of the inseam portion of the jeans.
The broken line showing of the jeans is for the purpose of illustrating portions of the article and forms no part of the claimed design.

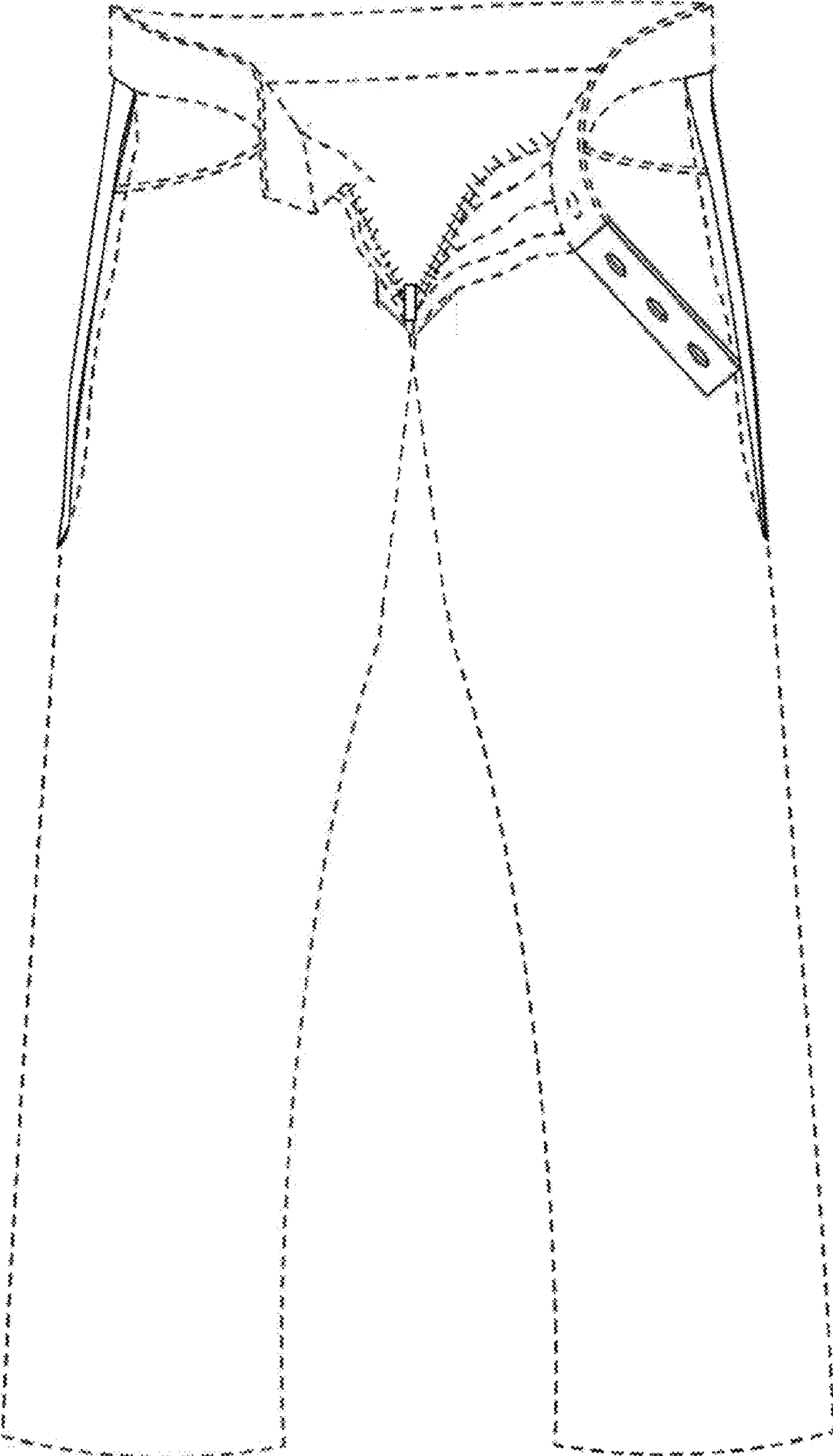

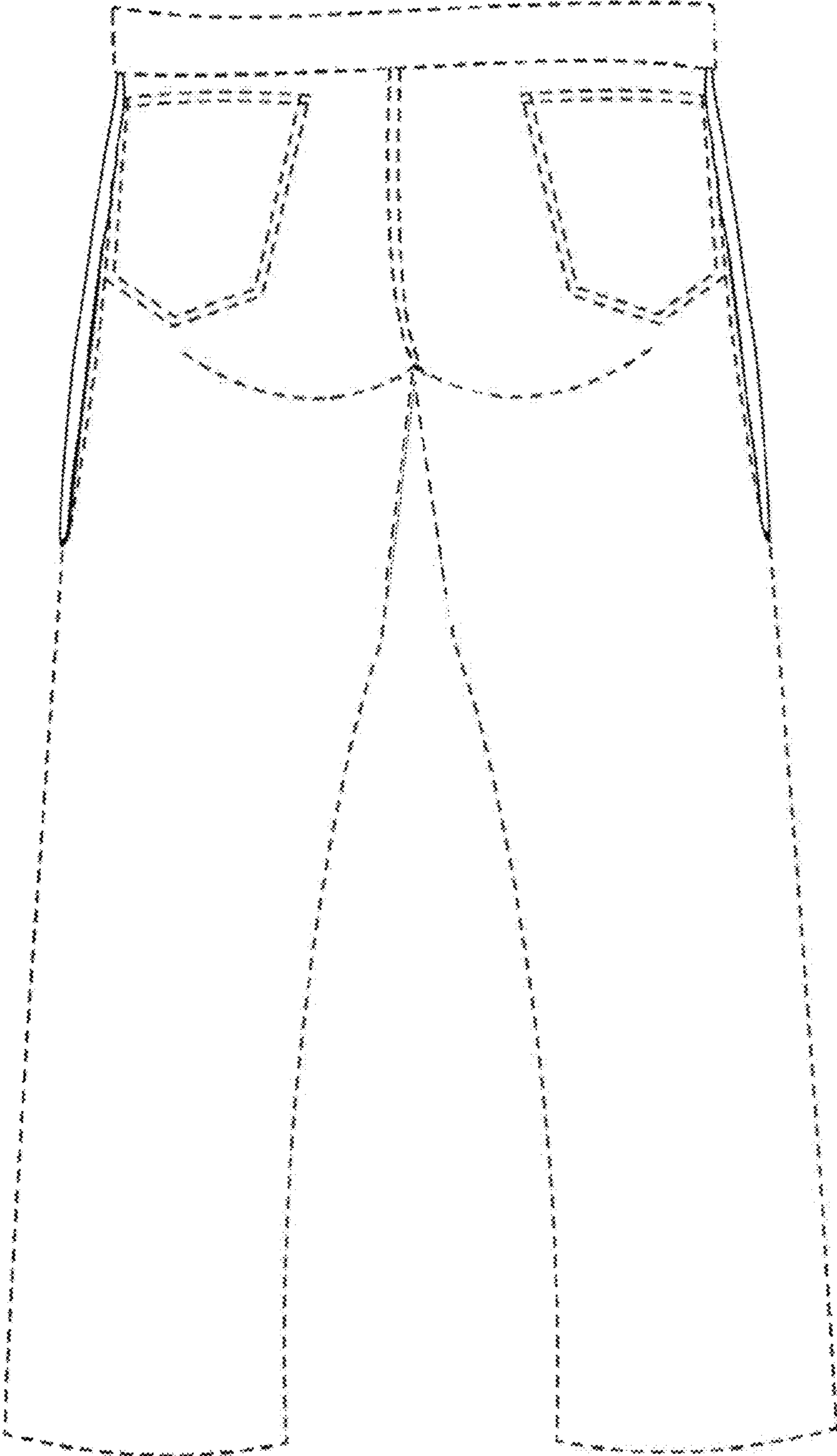

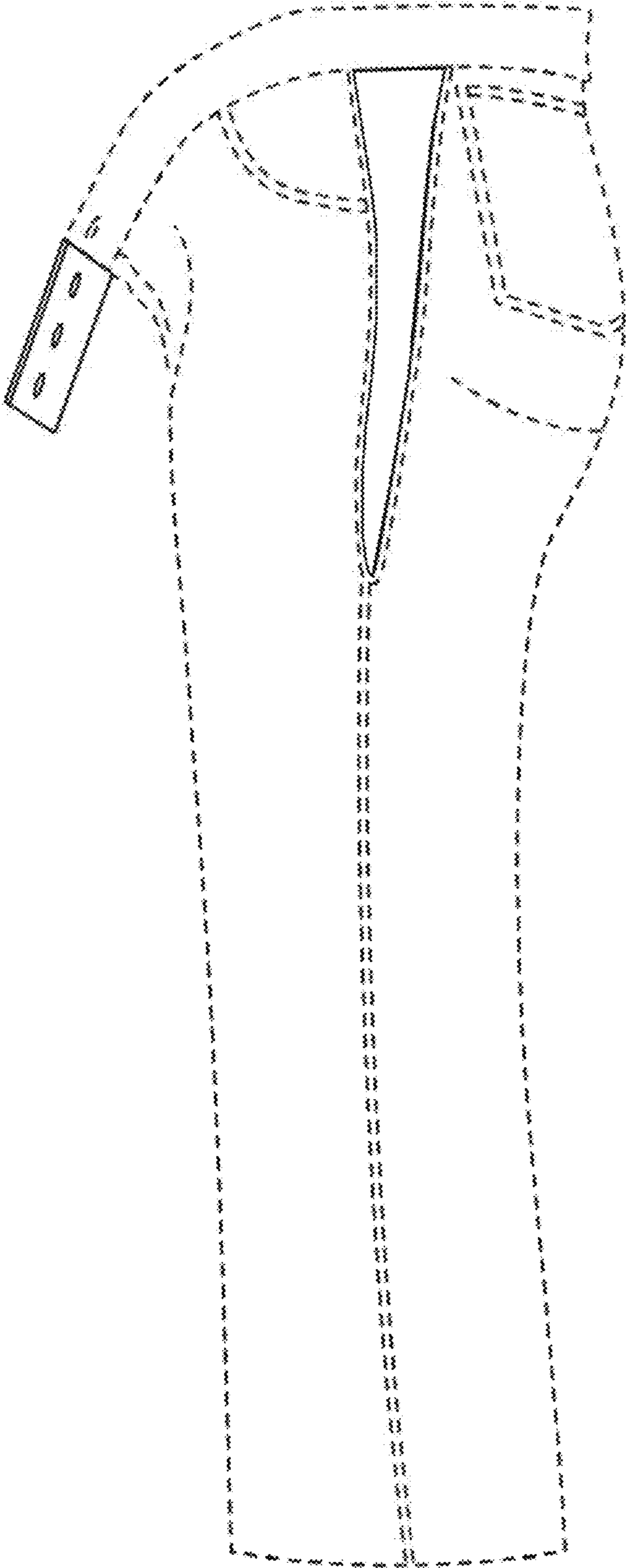

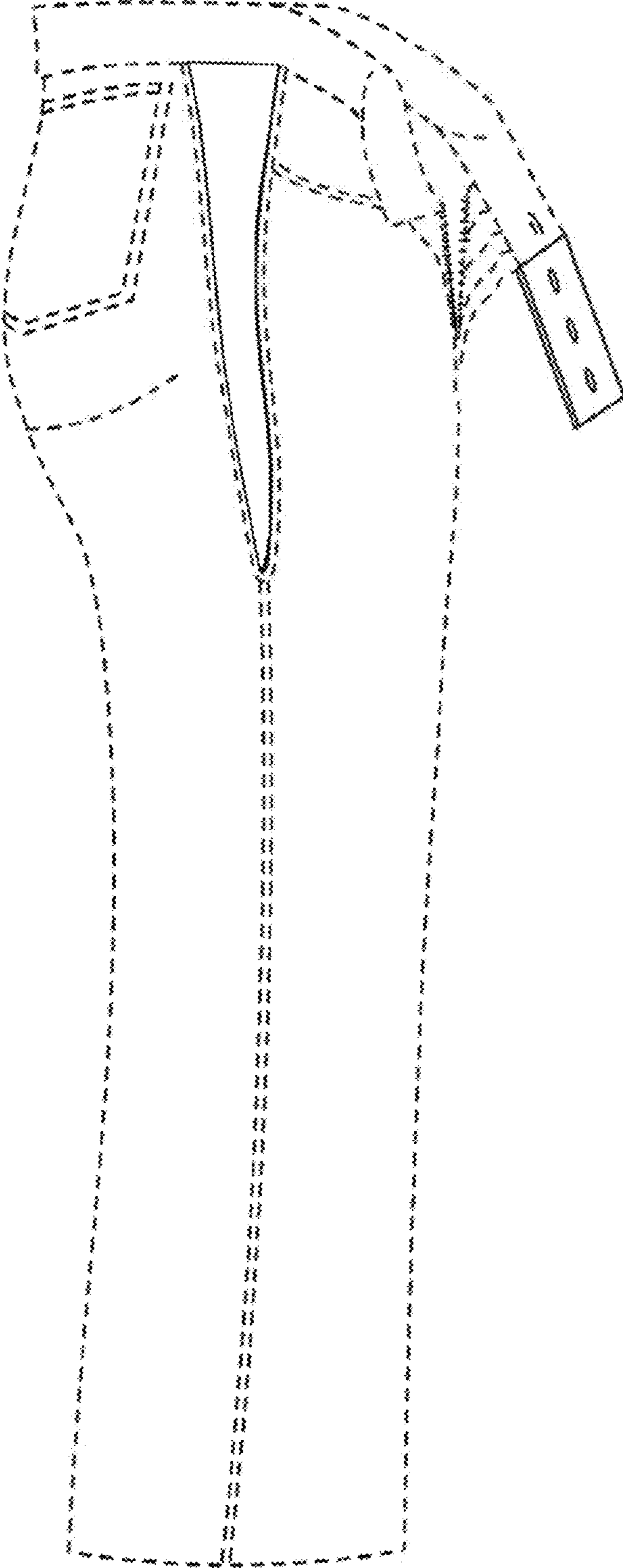

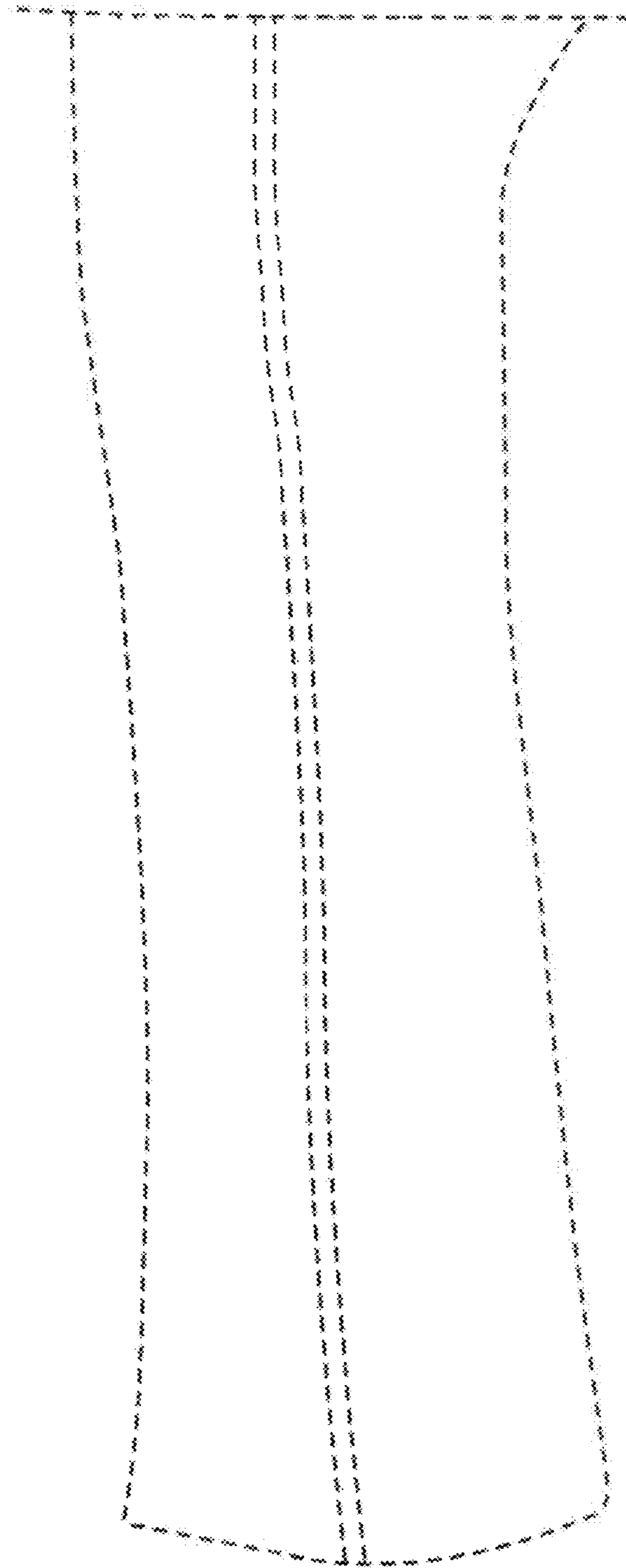
