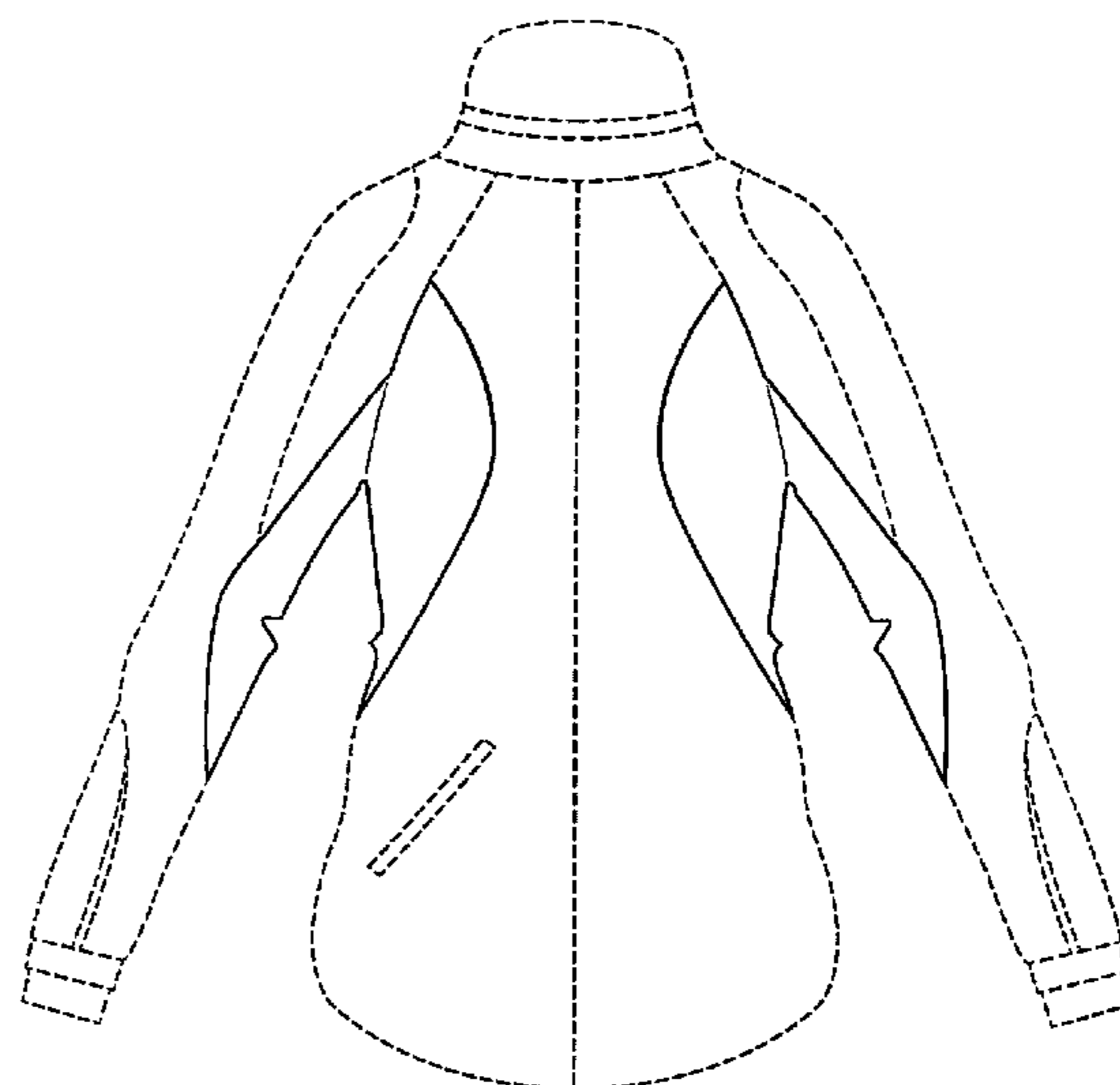
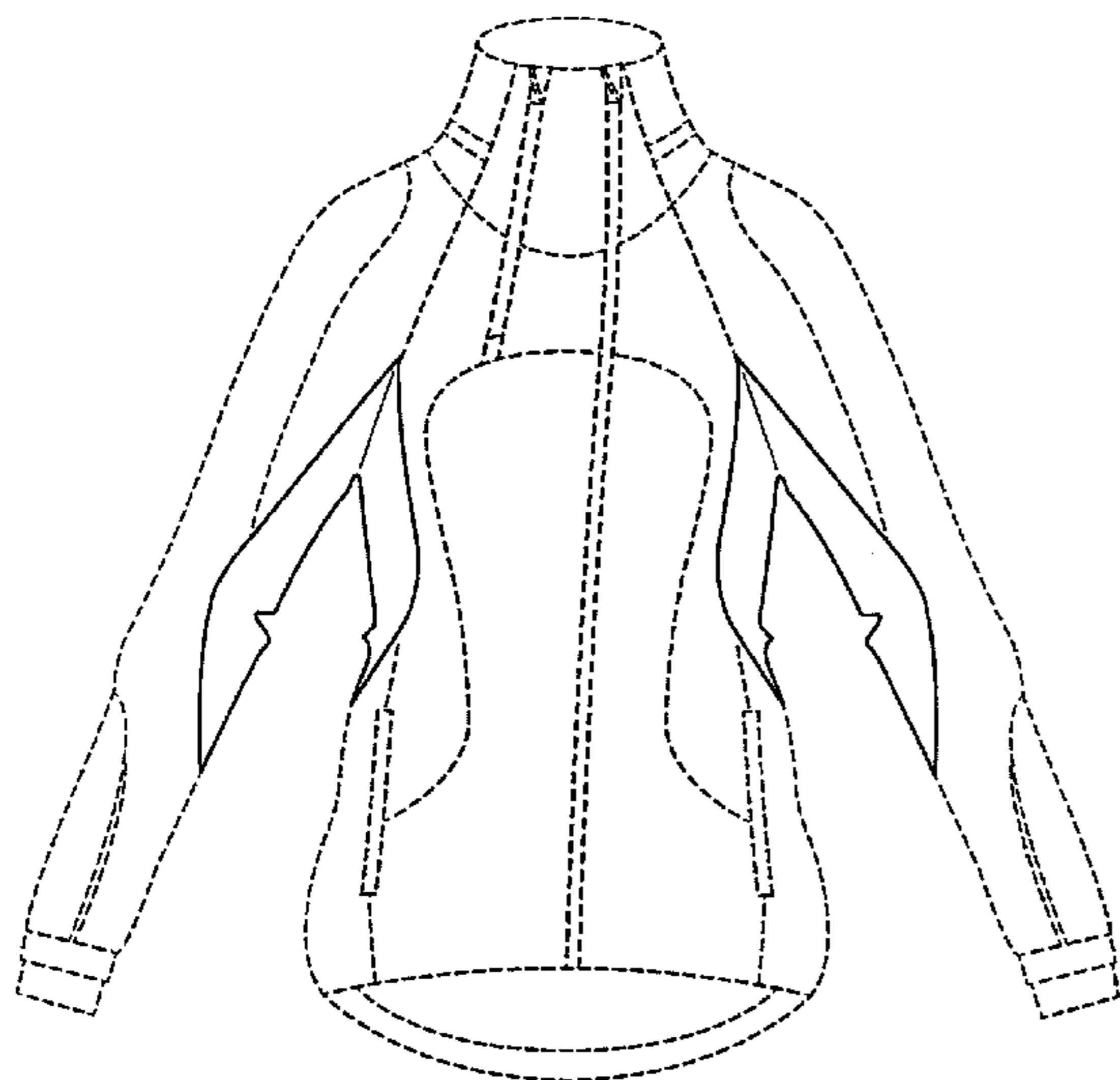
(57) **CLAIM**

The ornamental design for a jacket with panels, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a sleeve portion to an upper garment to the embodiment of the design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a right side elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a front perspective view thereof.

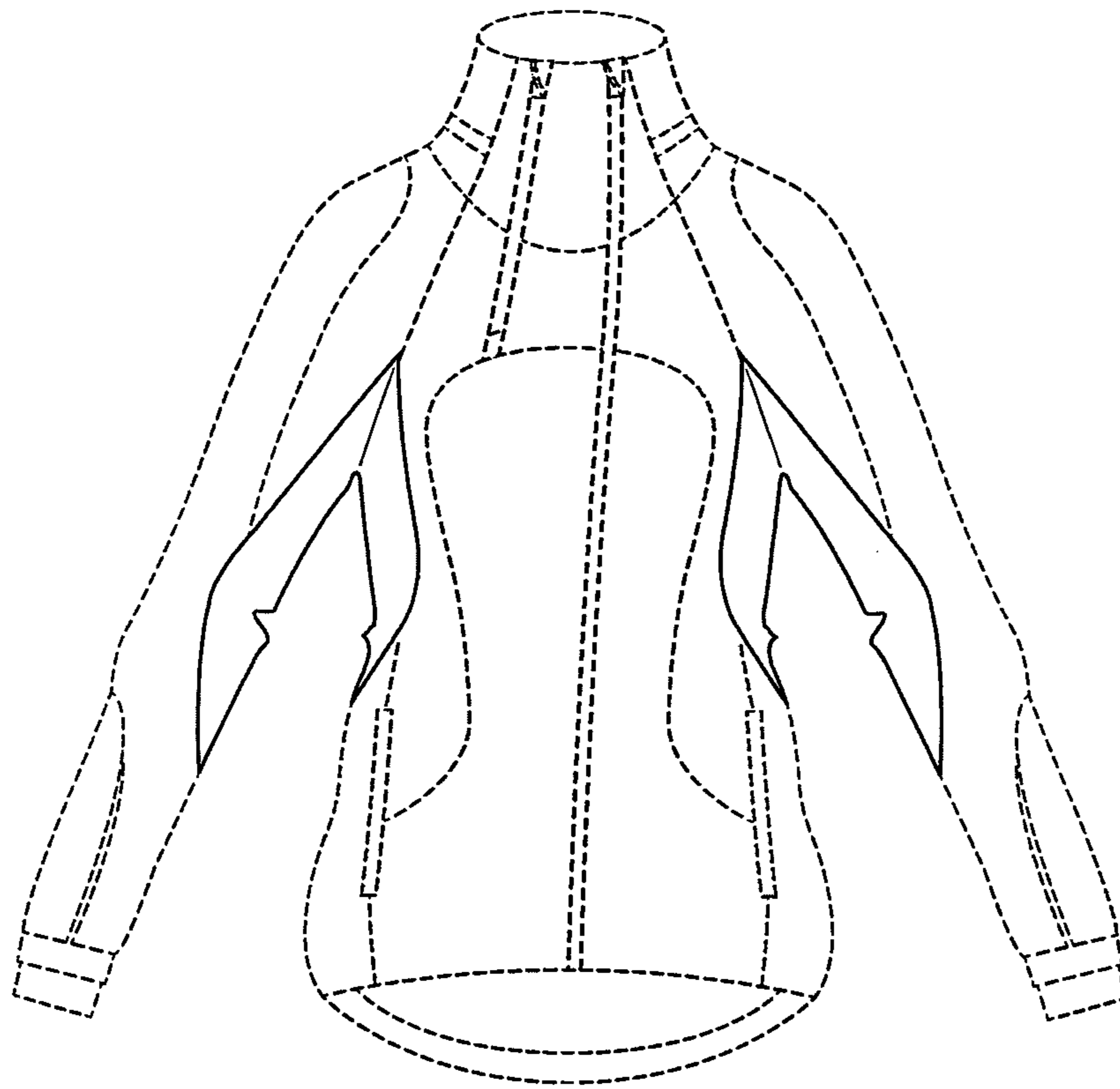

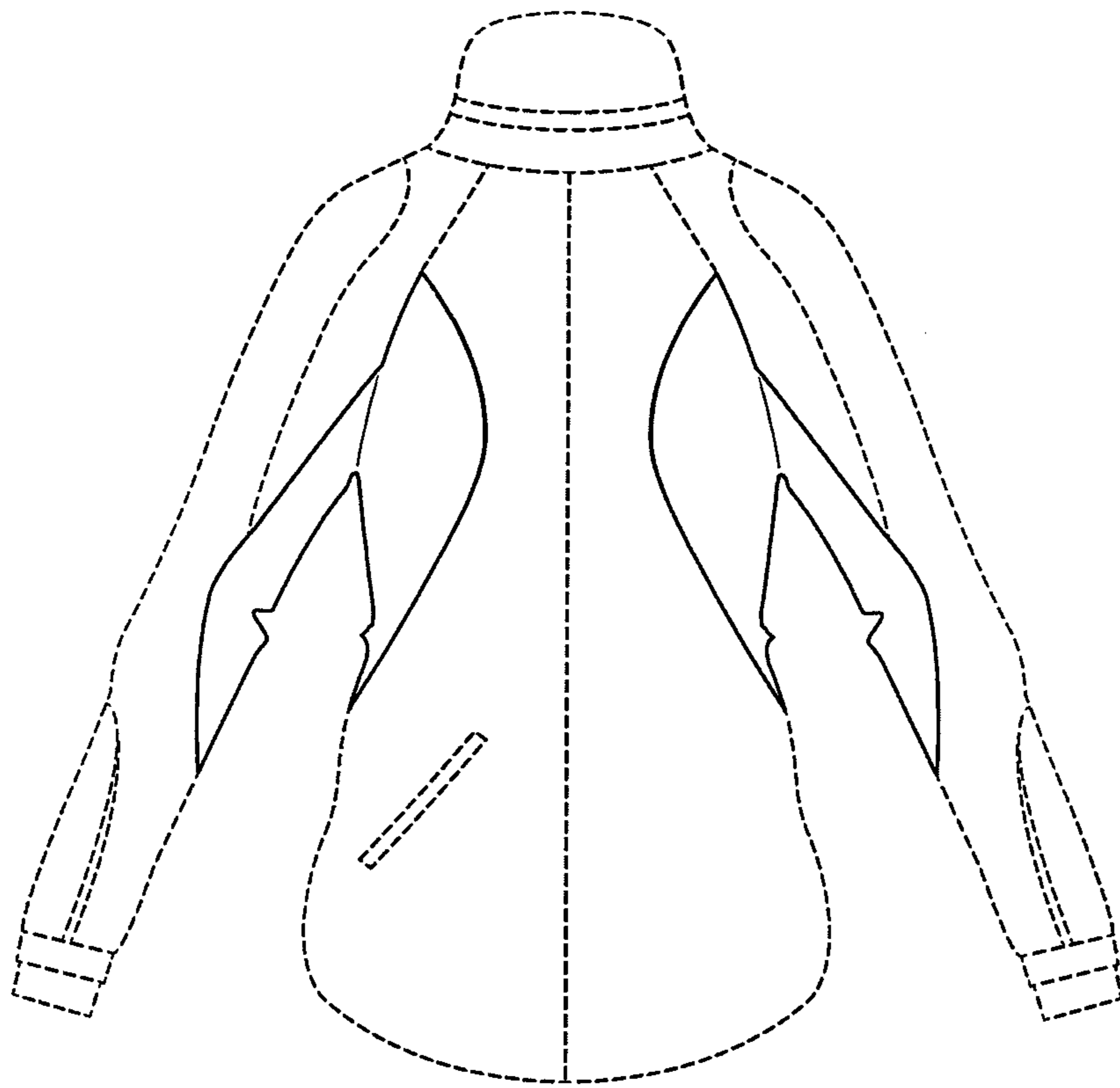

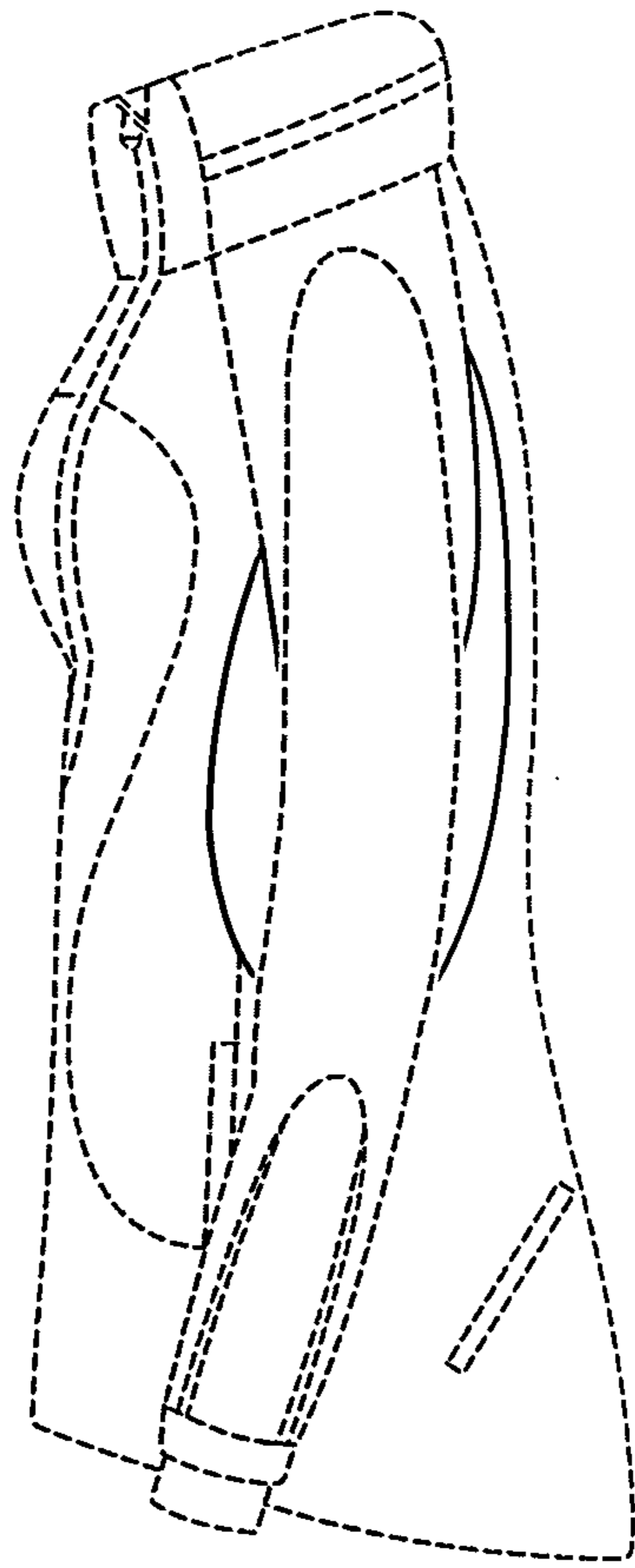

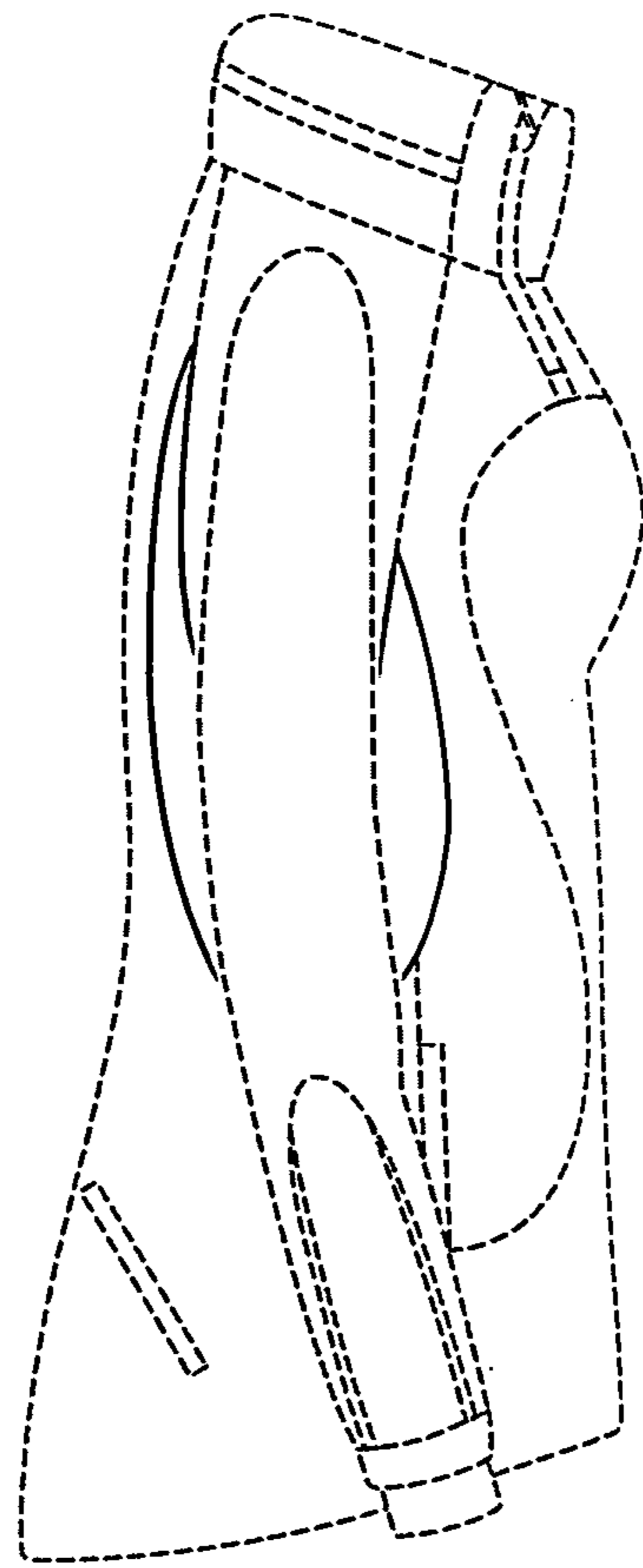

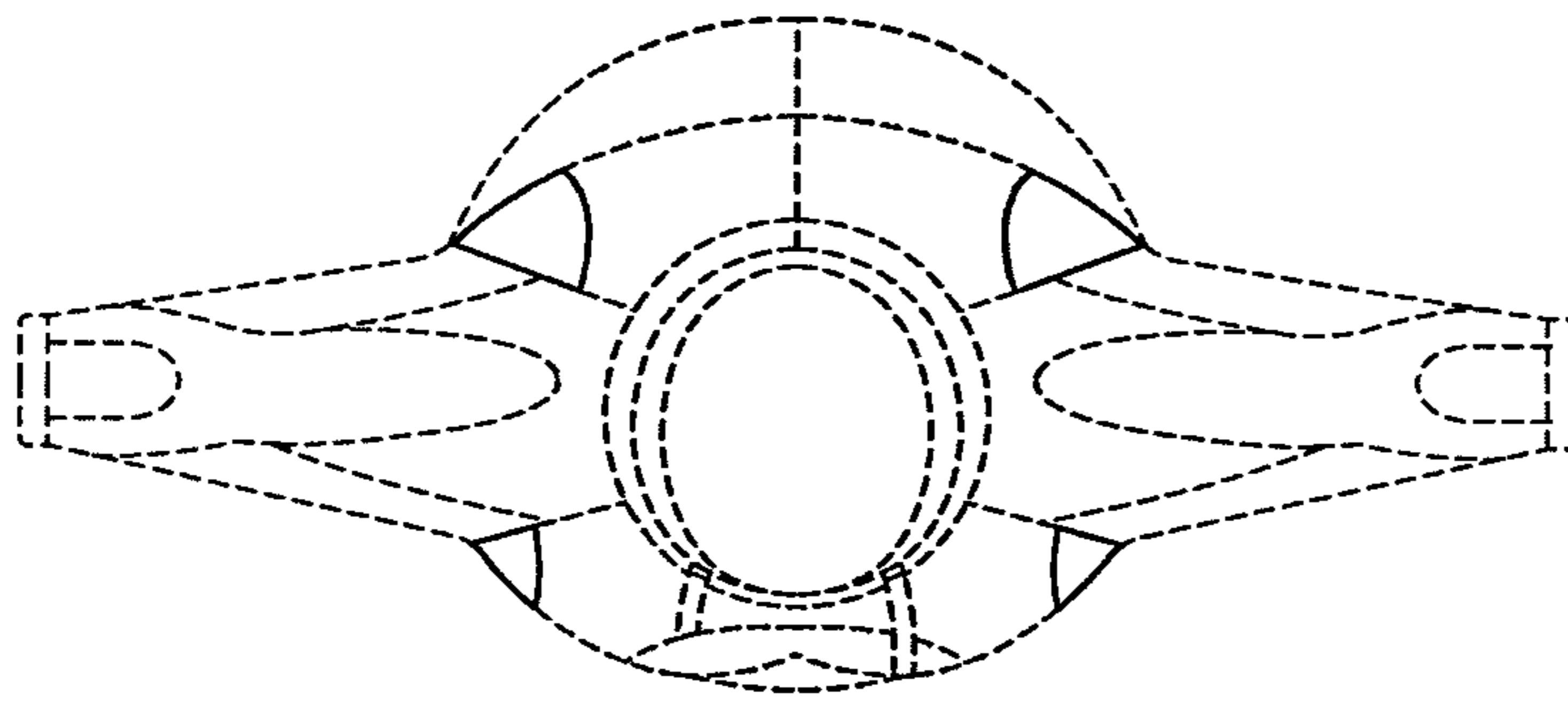

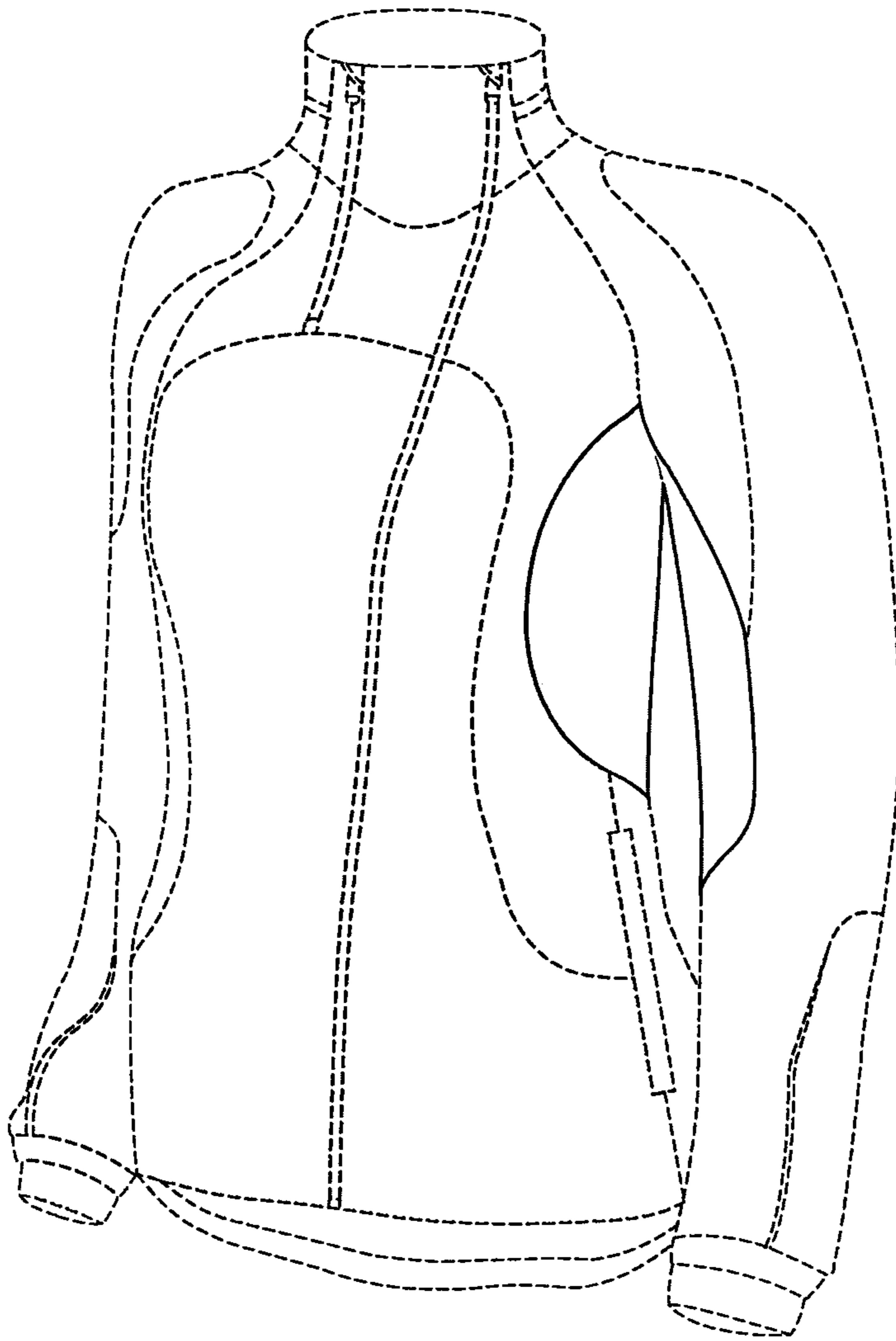
