**DESCRIPTION**

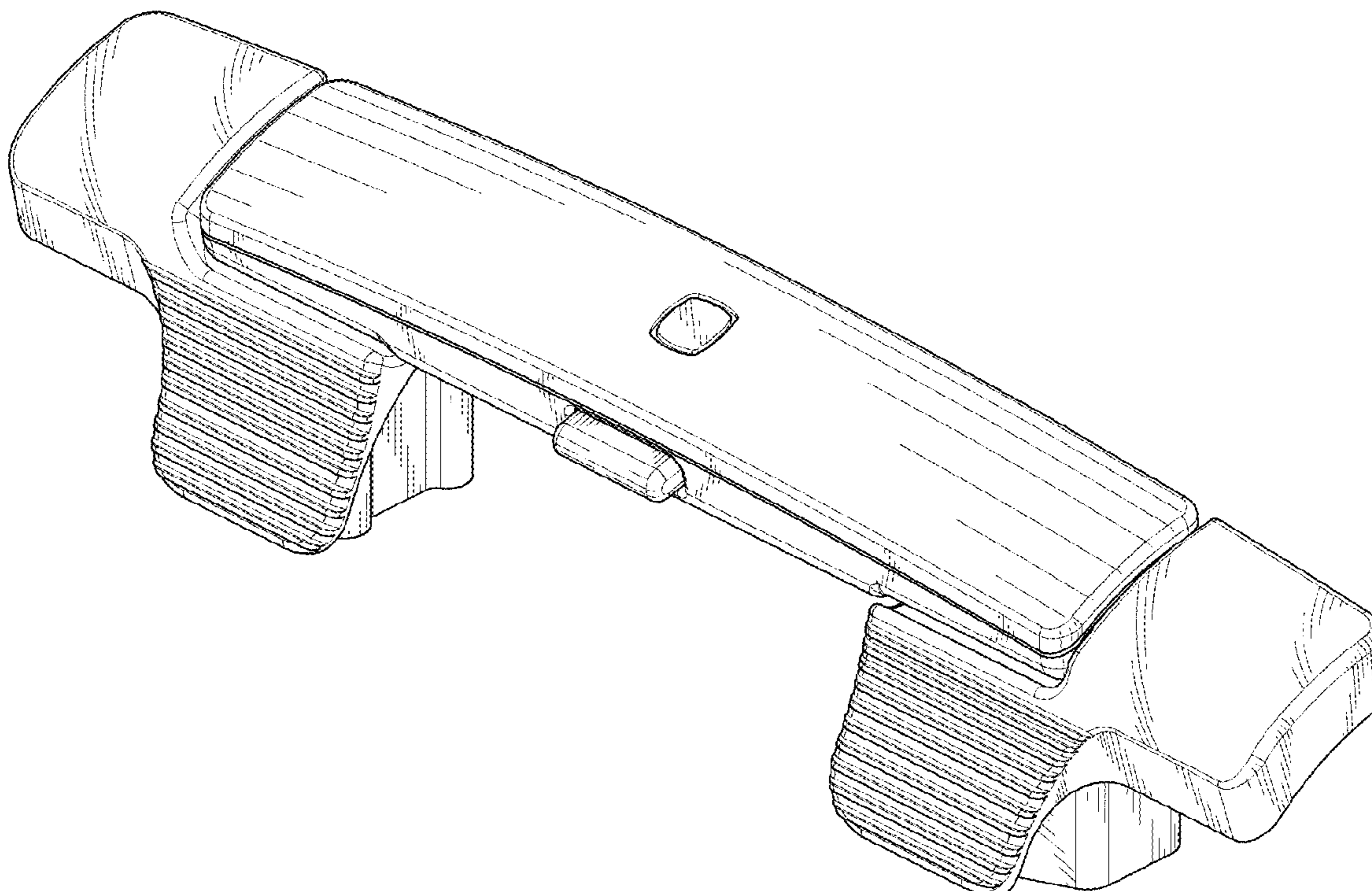
FIG. 1 is a right side perspective view of a luggage handle pull bar, showing my new design;

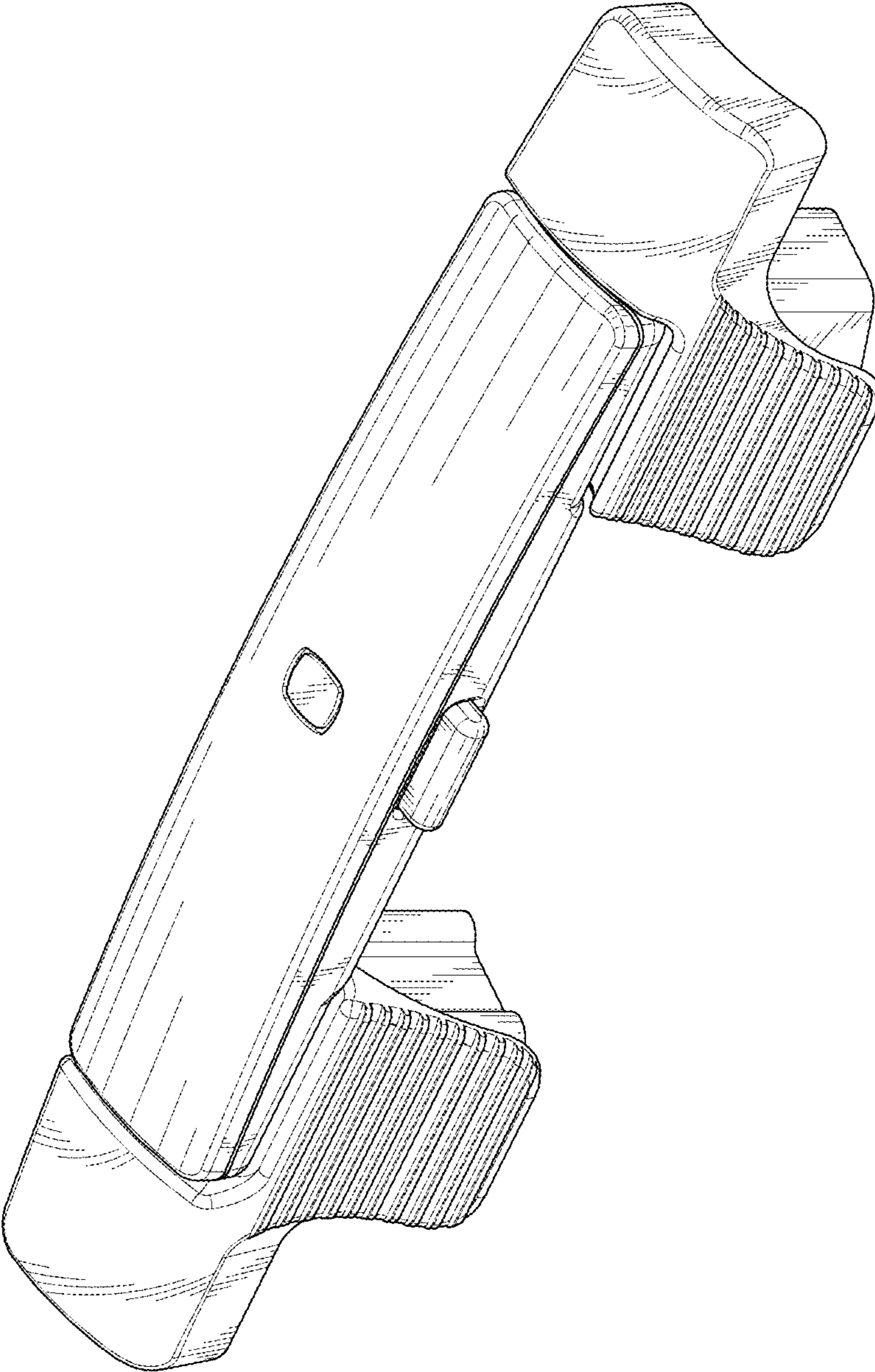

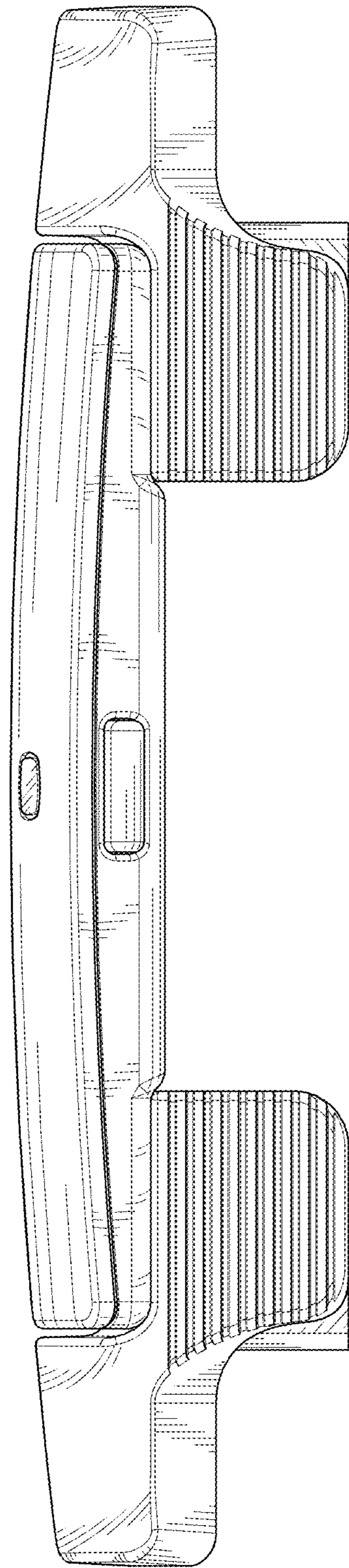

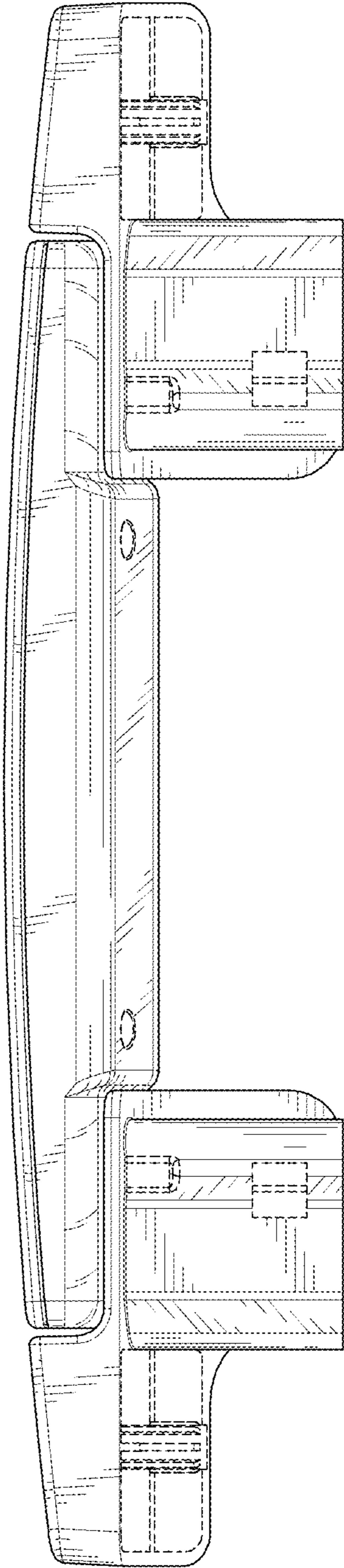

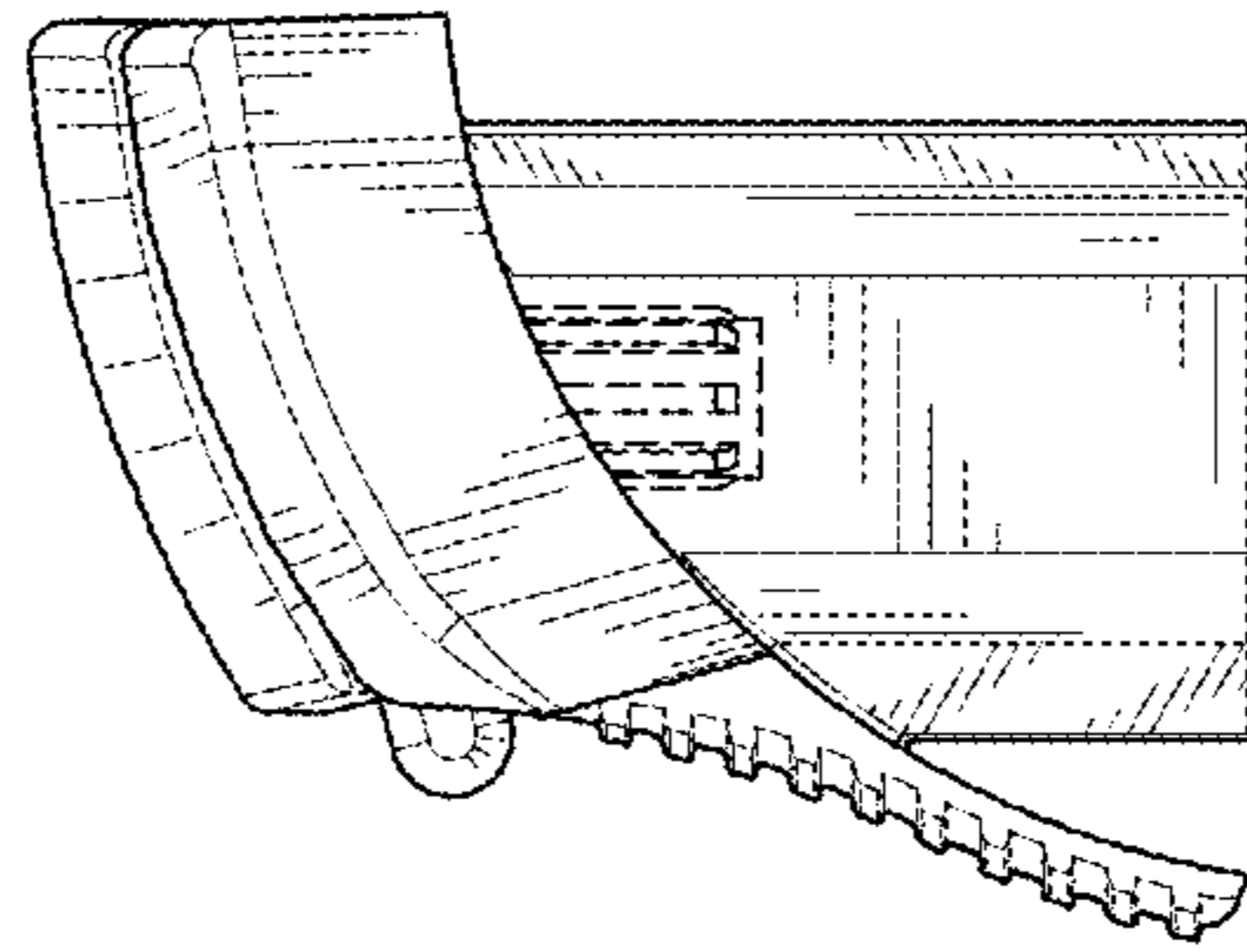

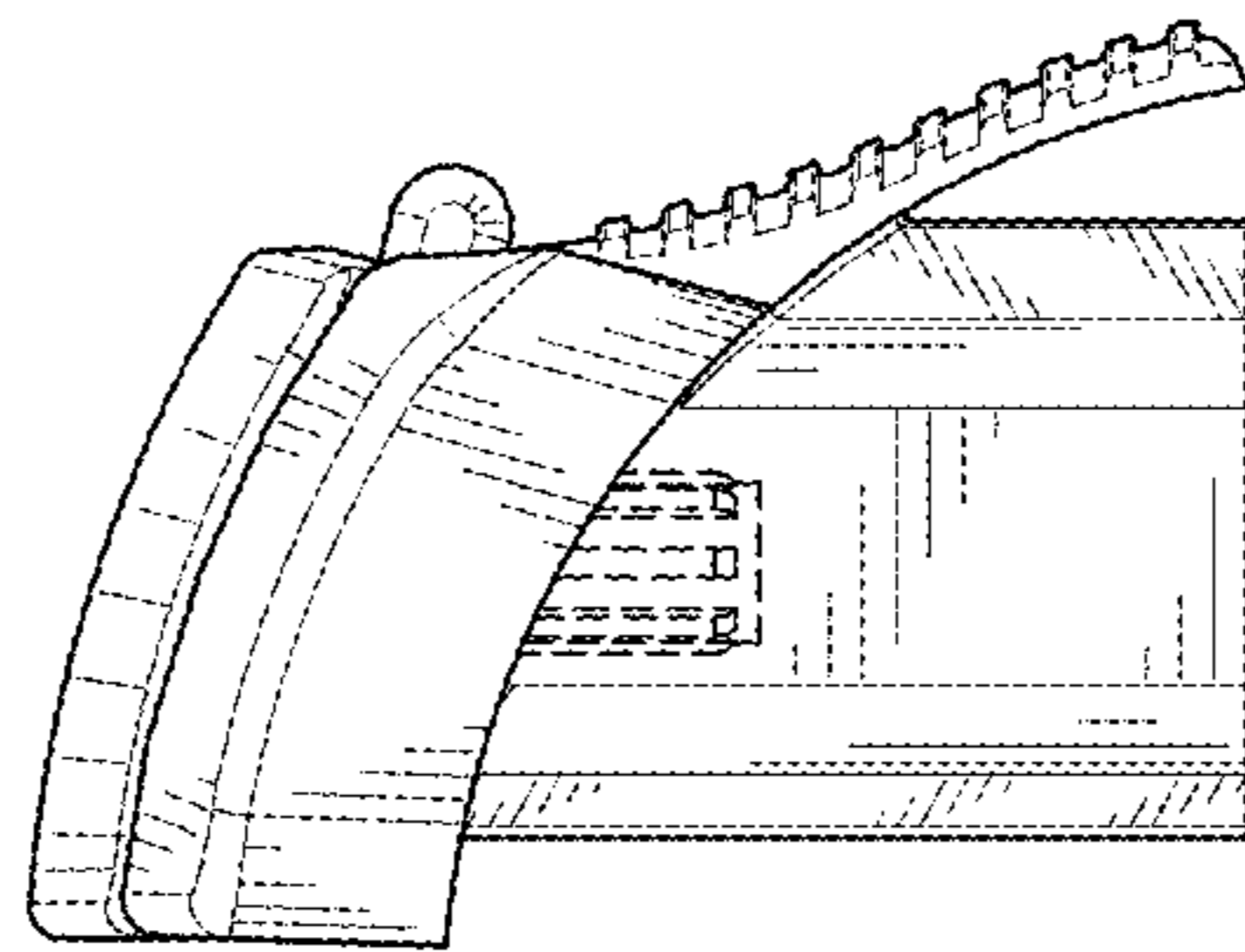

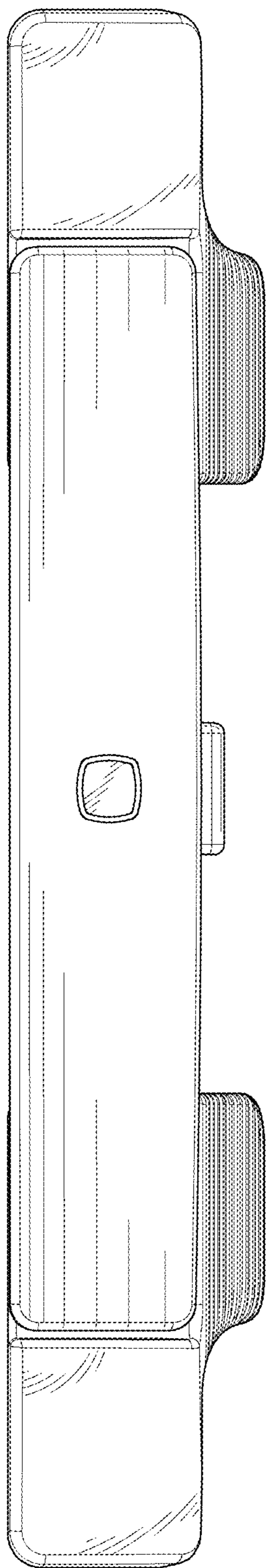

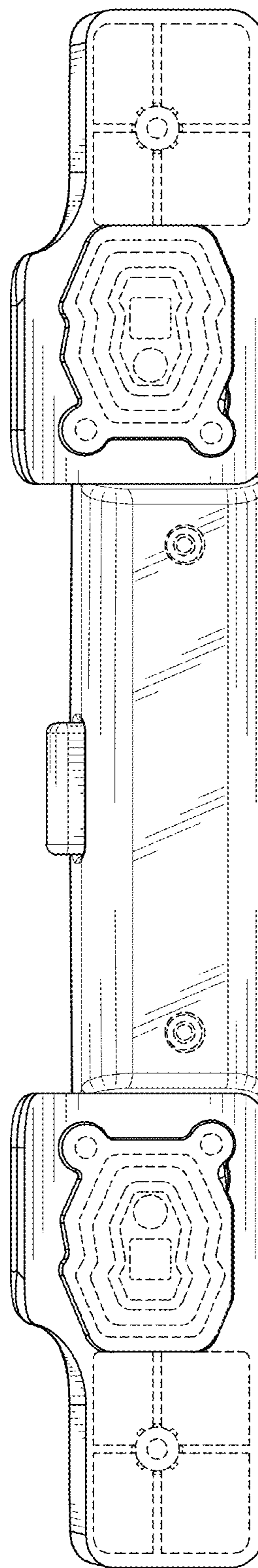
