(57) **CLAIM**

The ornamental design for a sofa with reversible cushions, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side perspective view of a first embodiment of a sofa with reversible cushions shown in a first position in accordance with the present design;

FIG. 2 is a front side perspective view of the first embodiment of a sofa with reversible cushions of FIG. 1 shown in a second position in accordance with the present design;

FIG. 3 is a front elevational view of FIG. 1;

FIG. 4 is a front elevational view of FIG. 2;

FIG. 5 is a top plan view of FIG. 1;

FIG. 6 is a top plan view of FIG. 2;

FIG. 7 is a rear elevation view of FIG. 1;

FIG. 8 is a rear elevation view of FIG. 2;

FIG. 9 is a front side perspective view of a second embodiment of a sofa with reversible cushions shown in a first position in accordance with the present design;

FIG. 10 is a front side perspective view of the first embodiment of a sofa with reversible cushions of FIG. 9 shown in a second position in accordance with the present design;

FIG. 11 is a front elevational view of FIG. 9;

FIG. 12 is a front elevational view of FIG. 10;

FIG. 13 is a top plan view of FIG. 9;

FIG. 14 is a top plan view of FIG. 10;

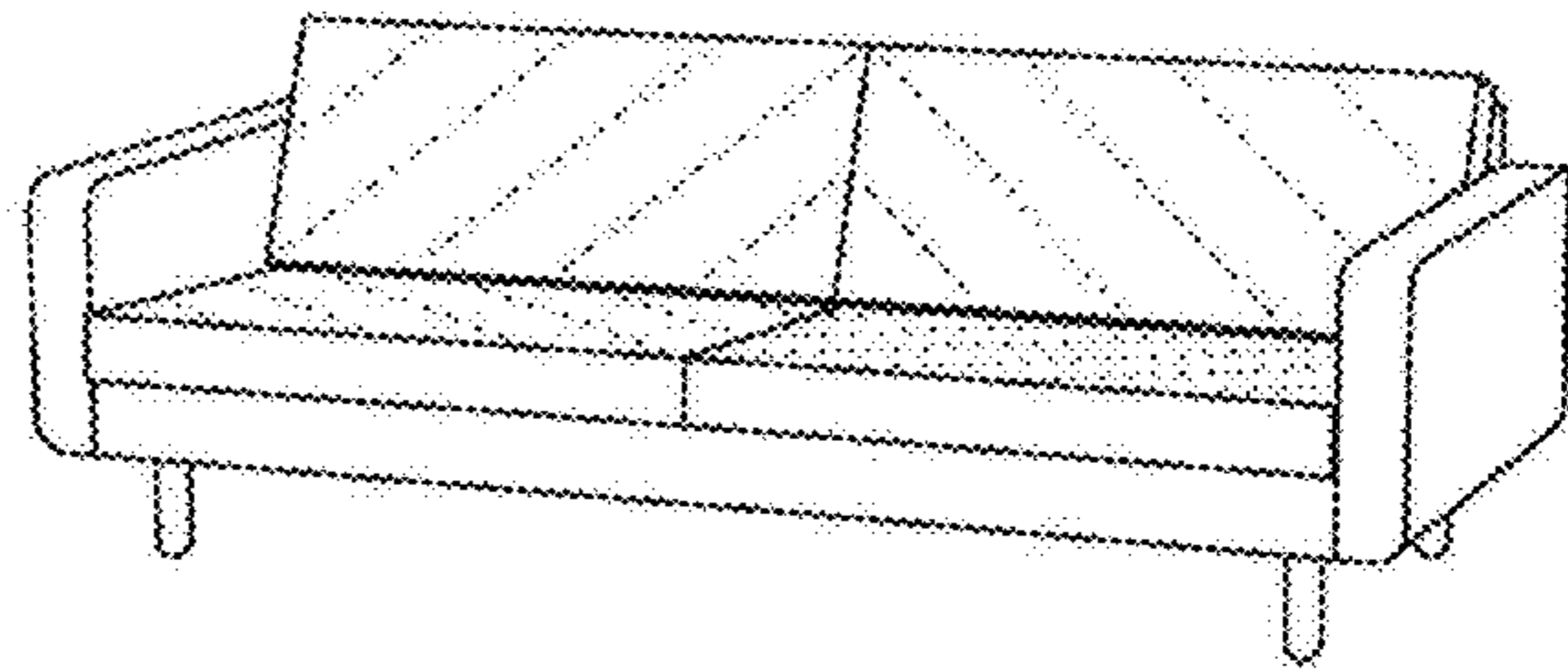
FIG. 15 is a rear elevation view of FIG. 9;

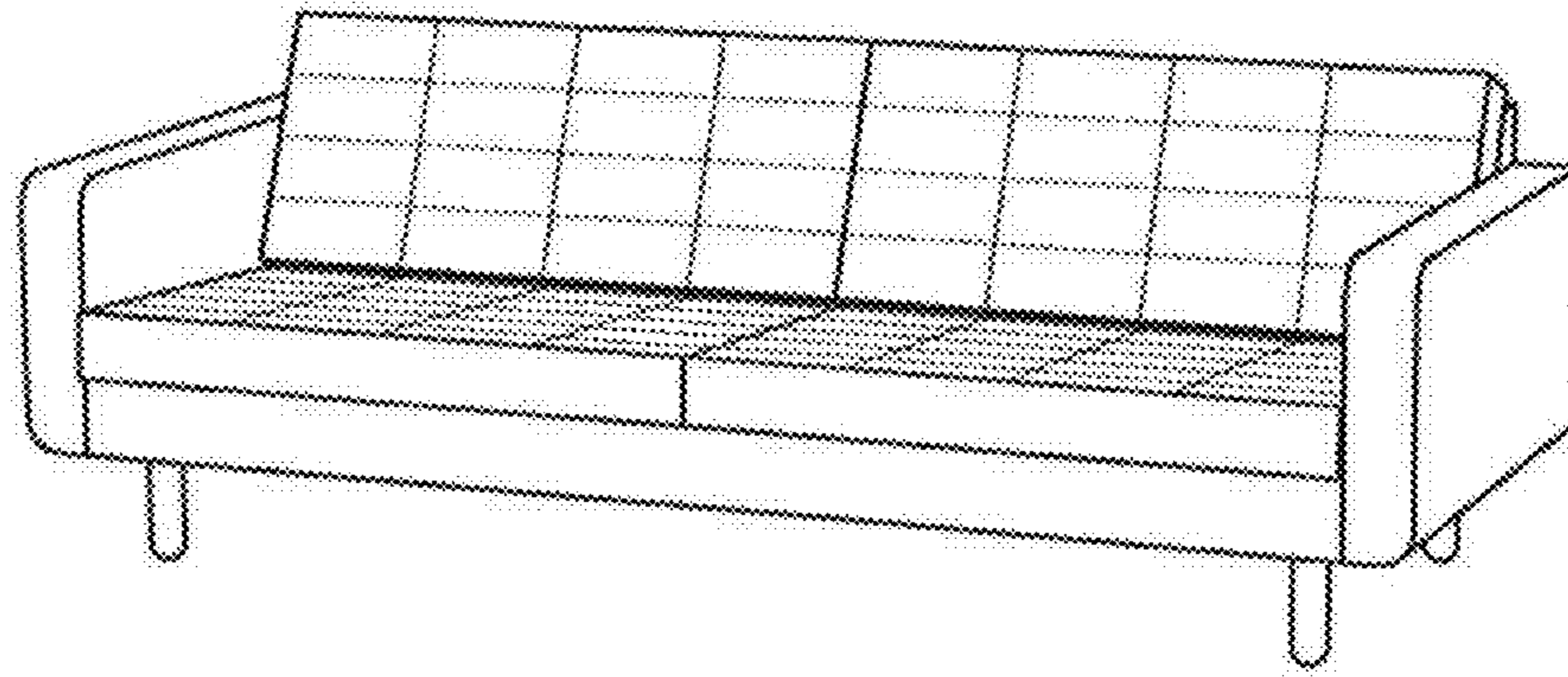

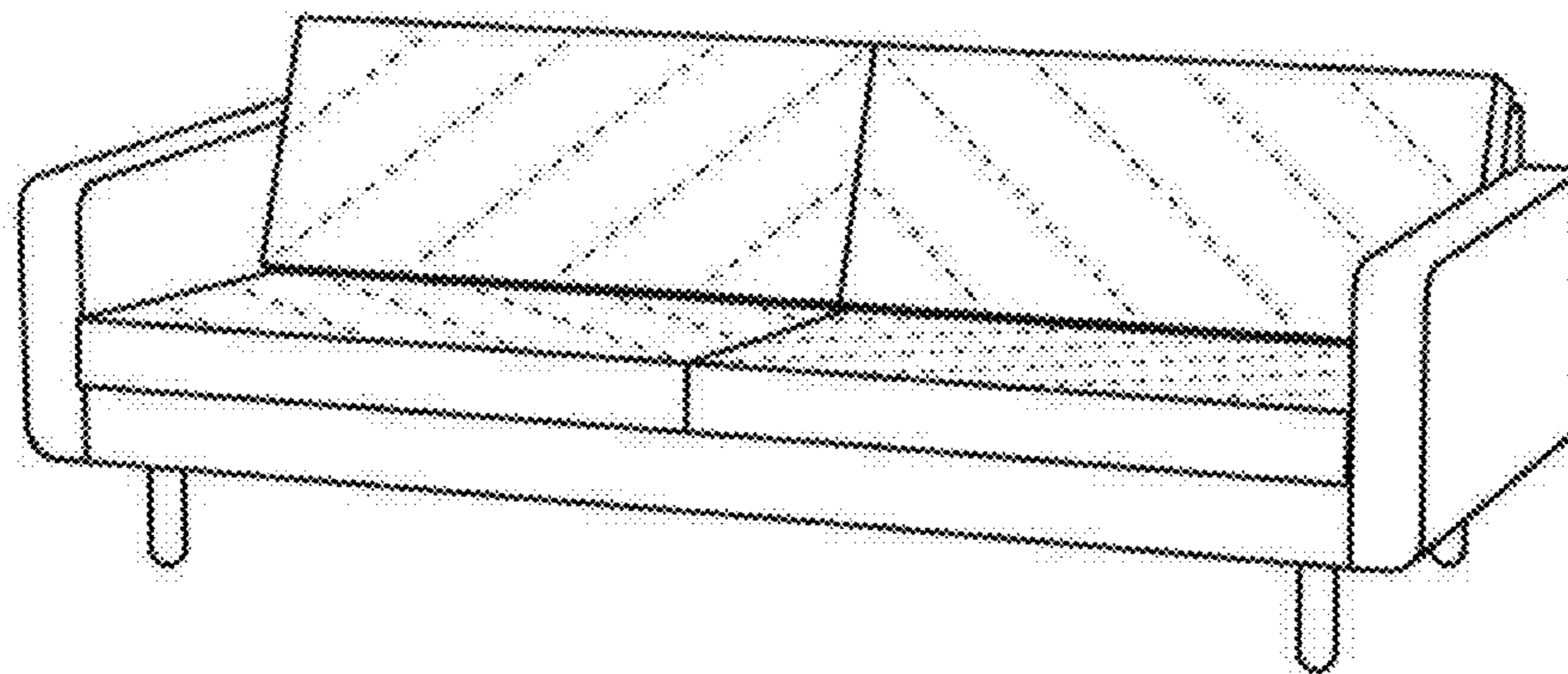

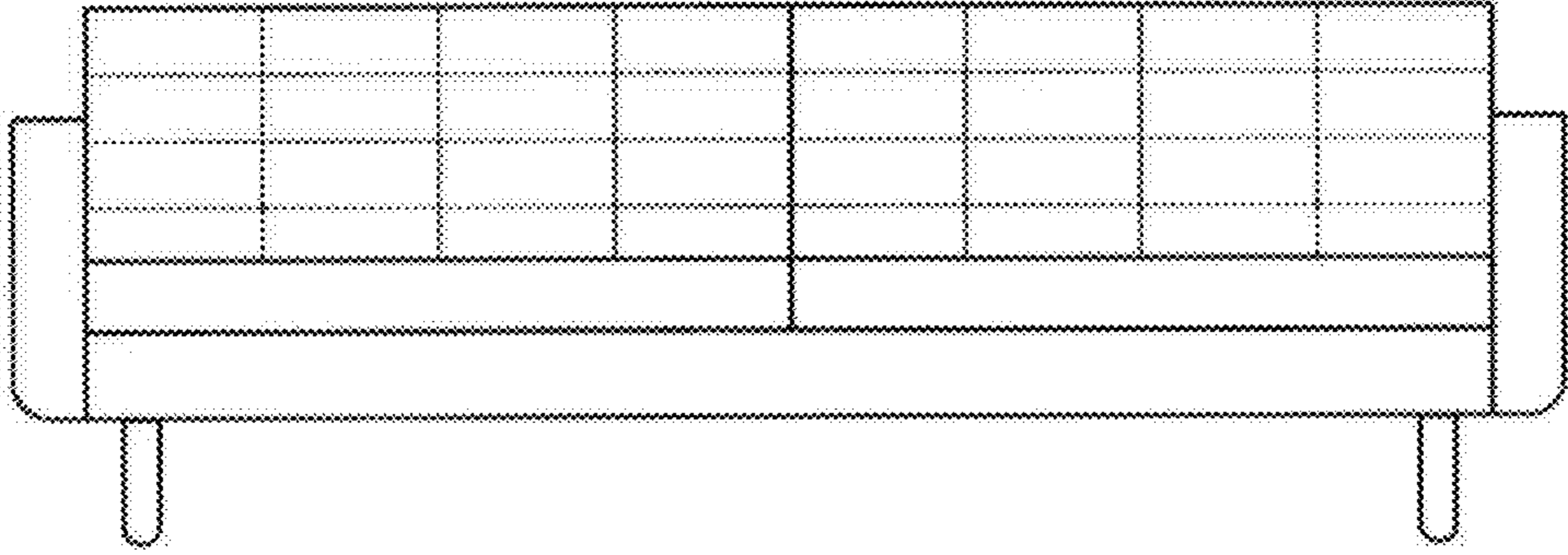

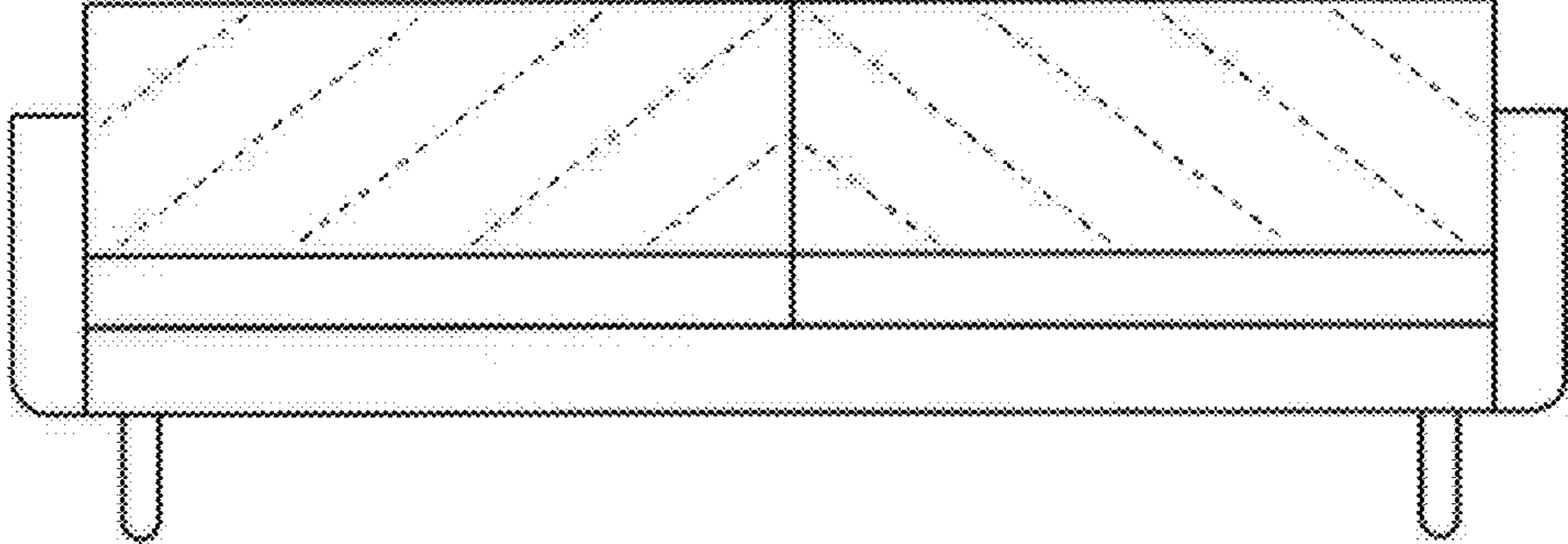

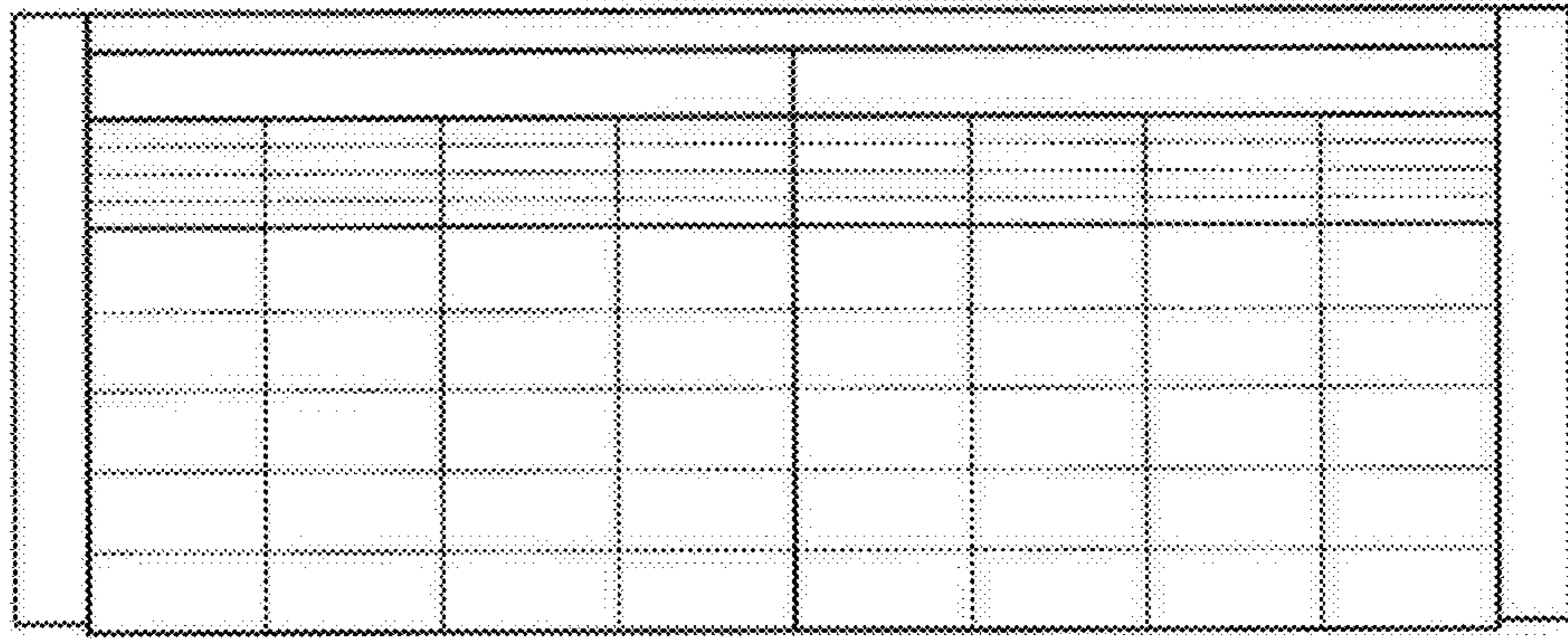

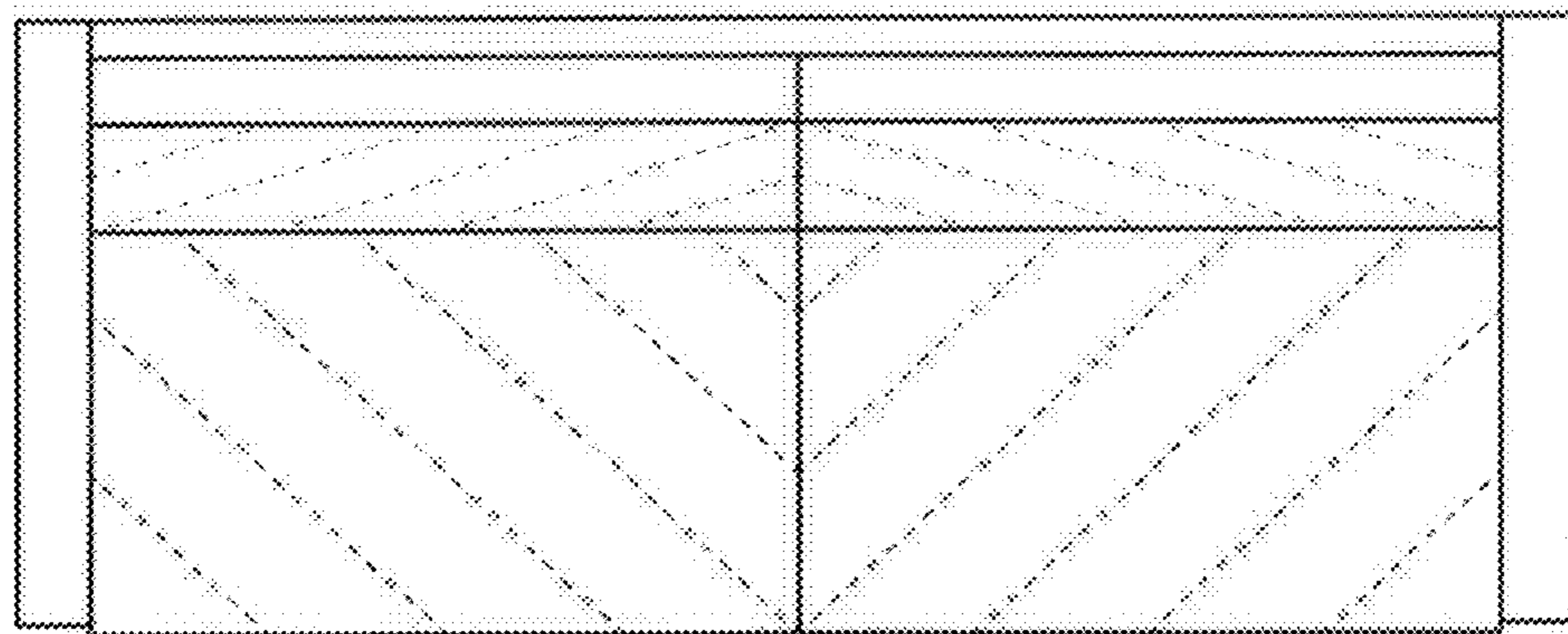

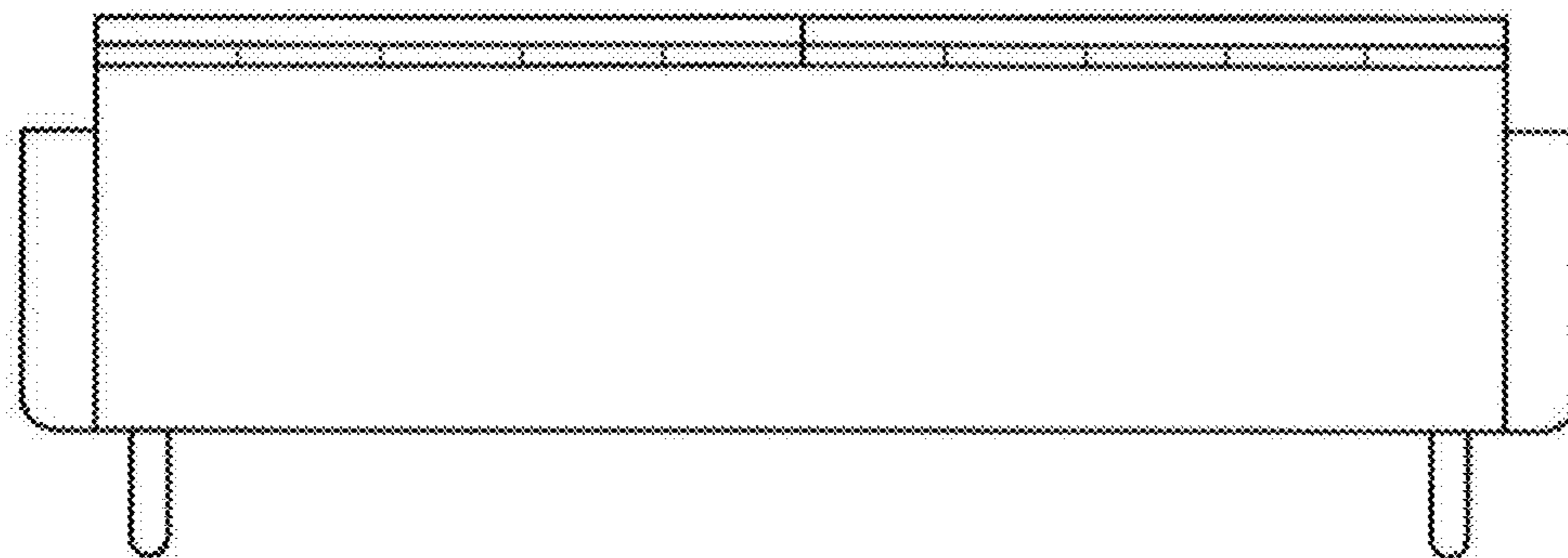

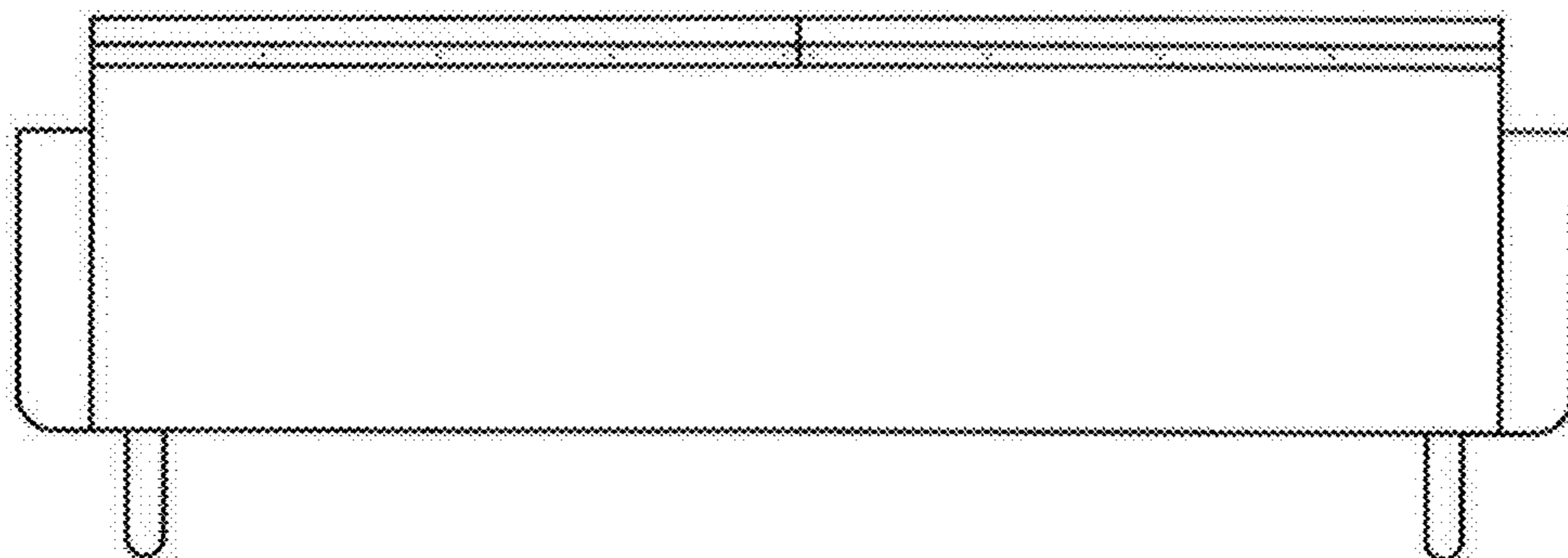

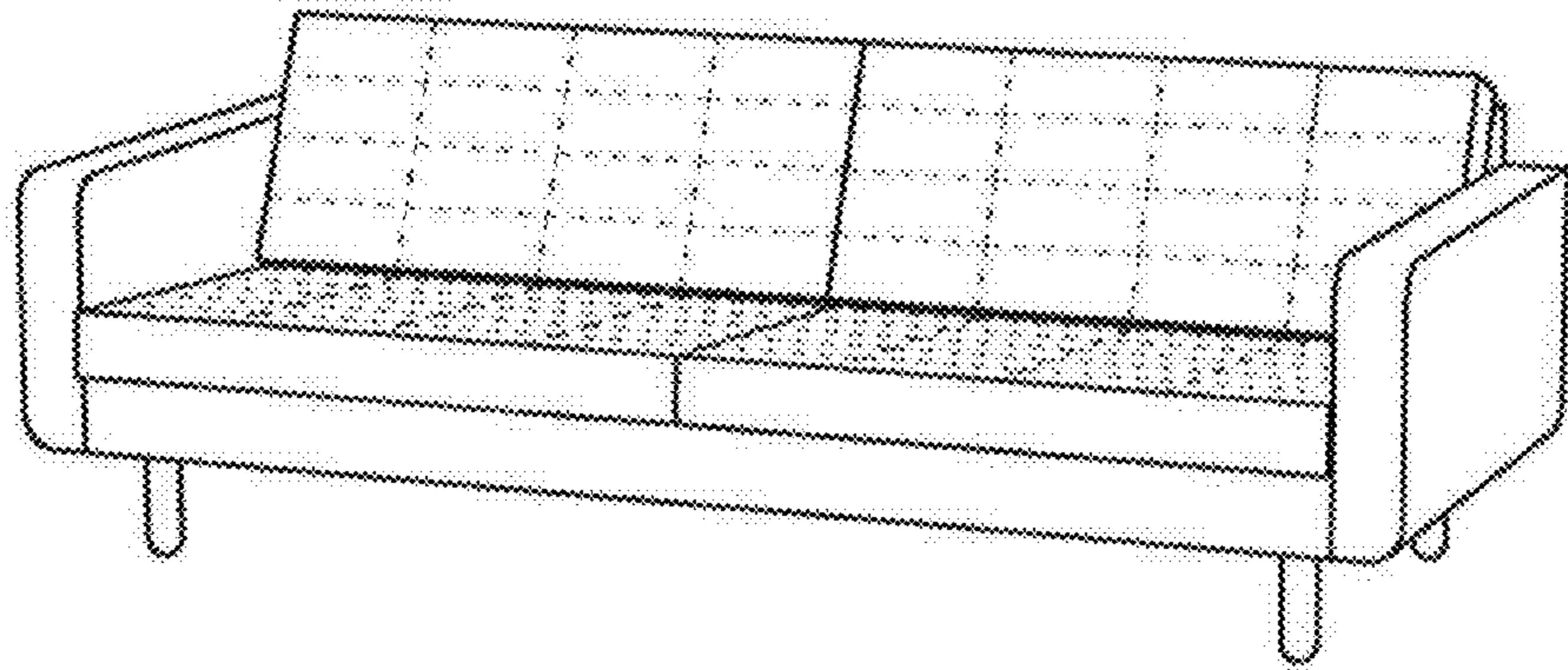

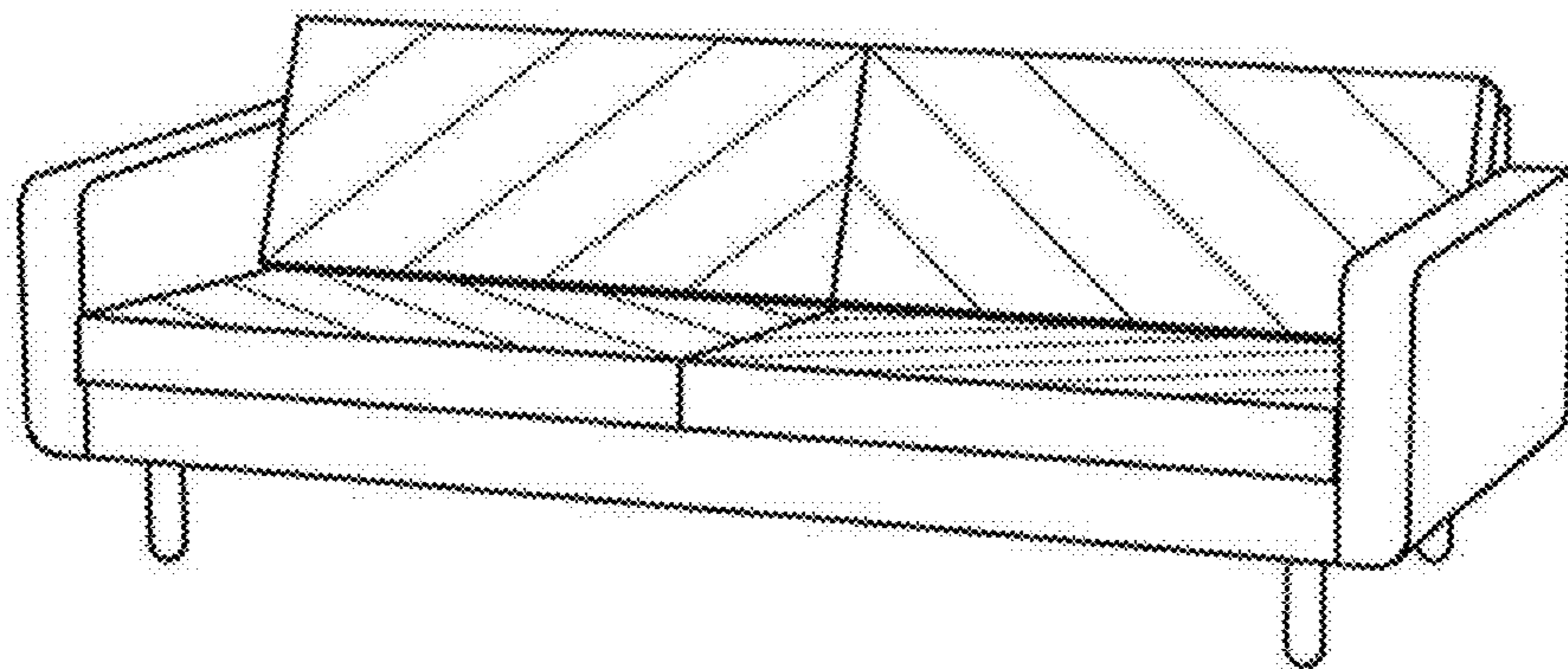

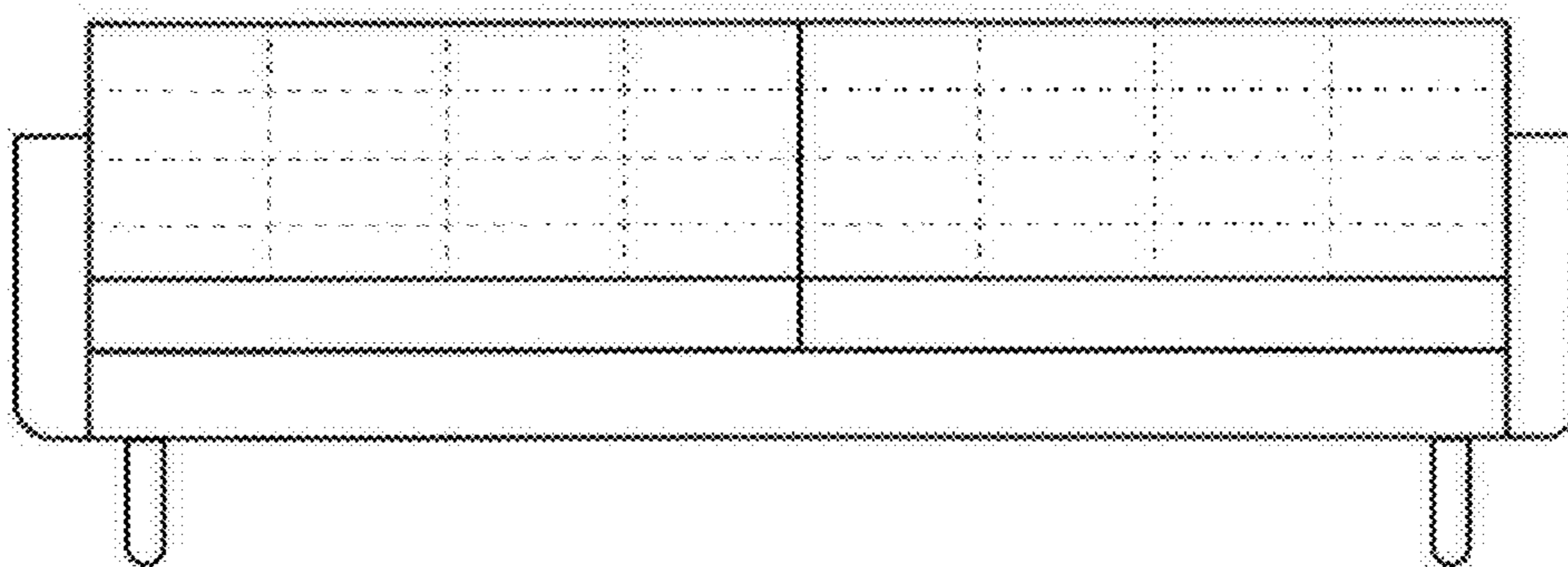

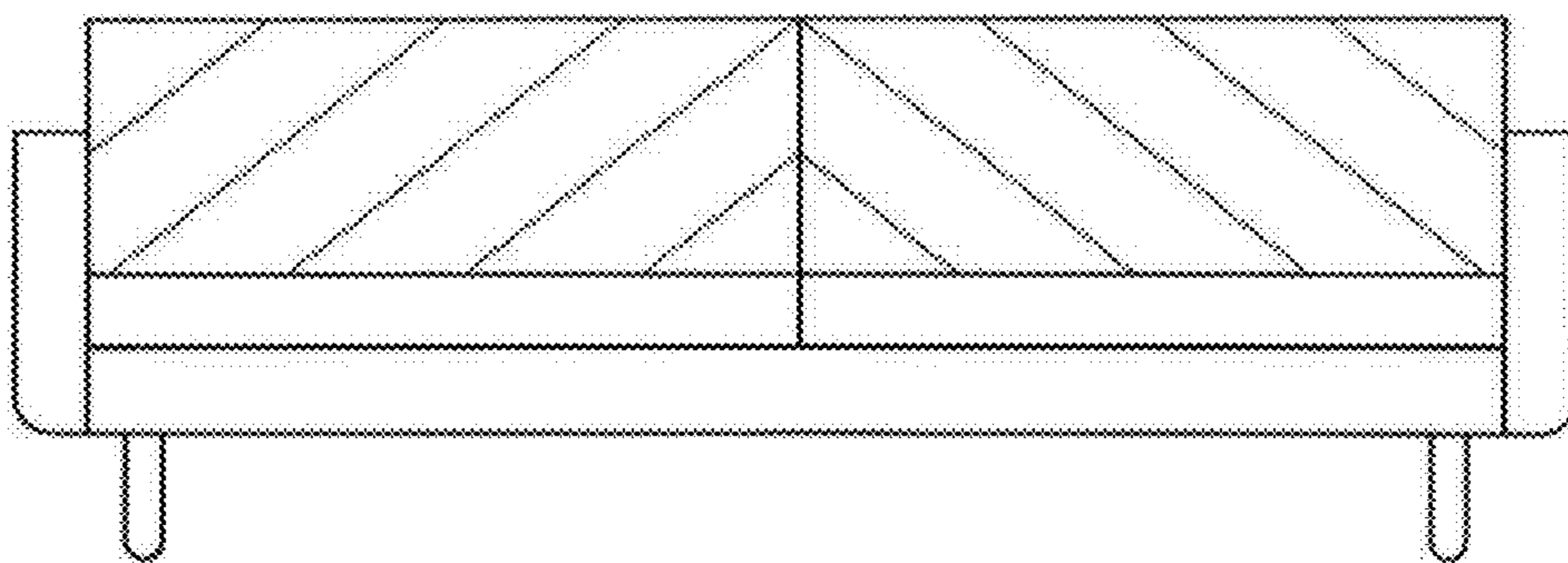

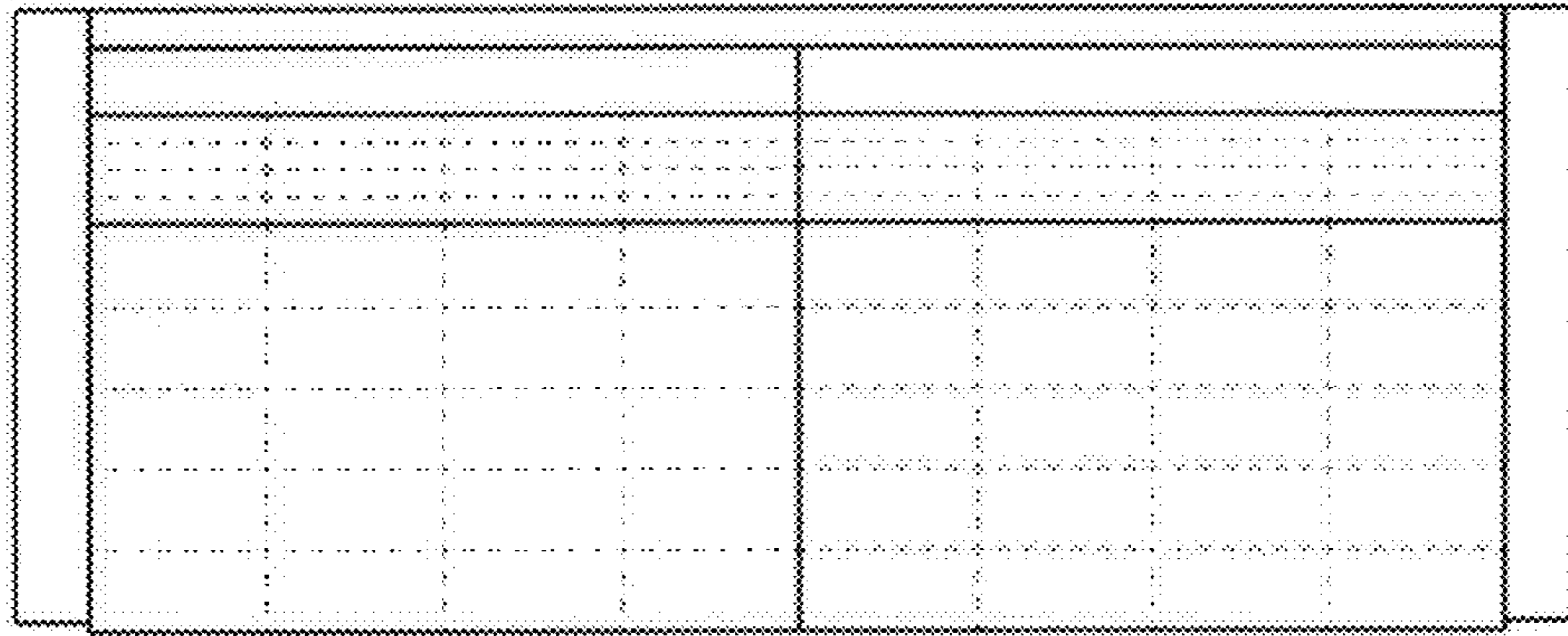

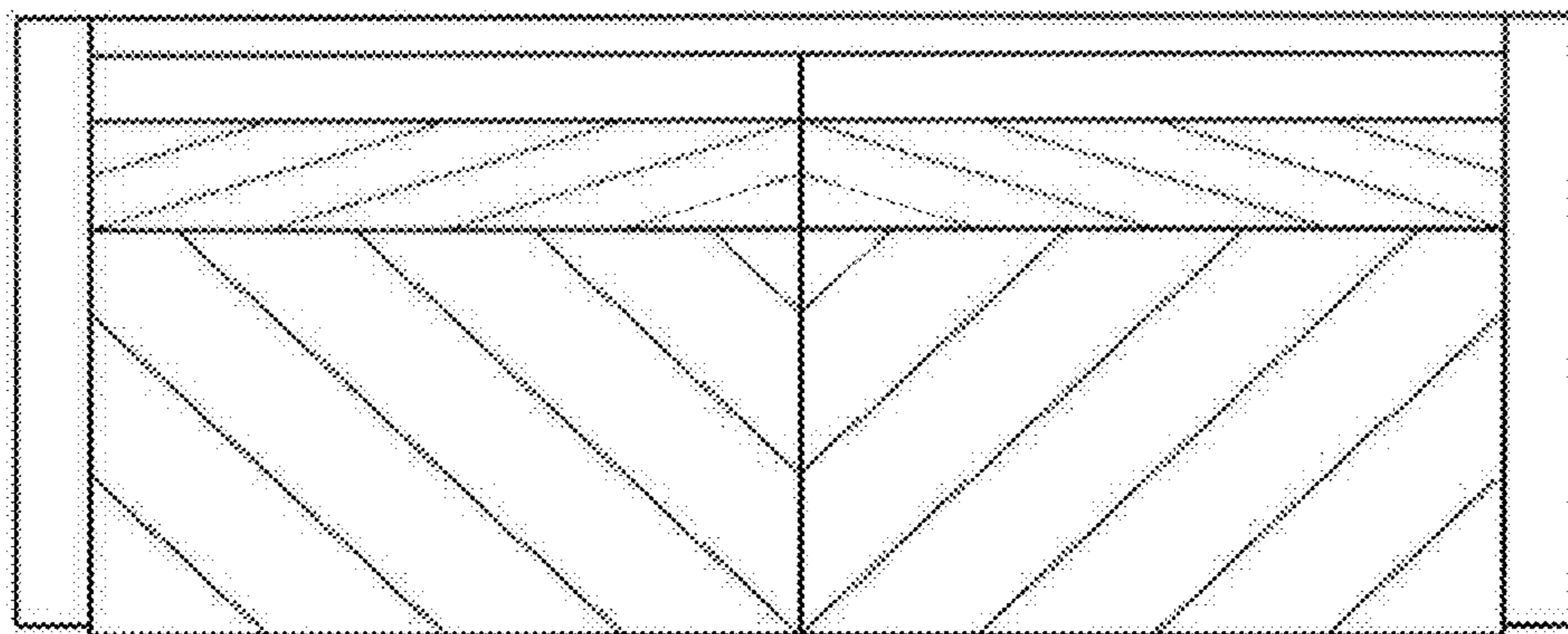

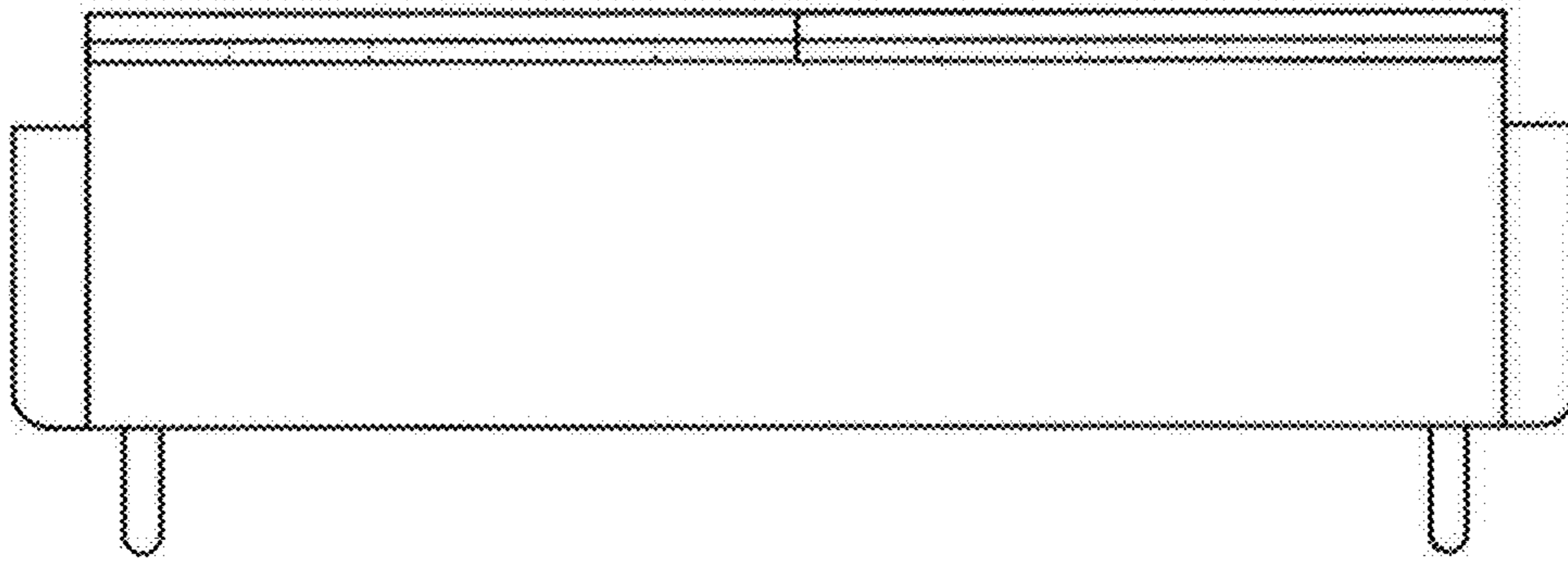

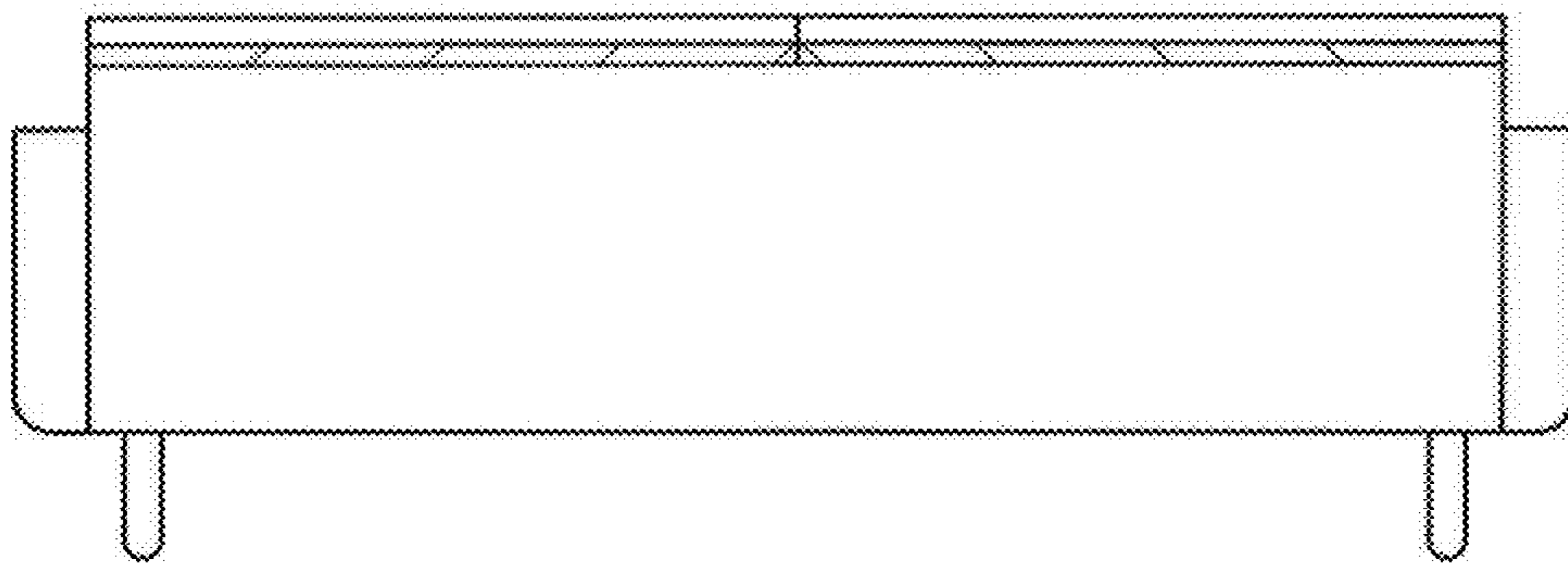

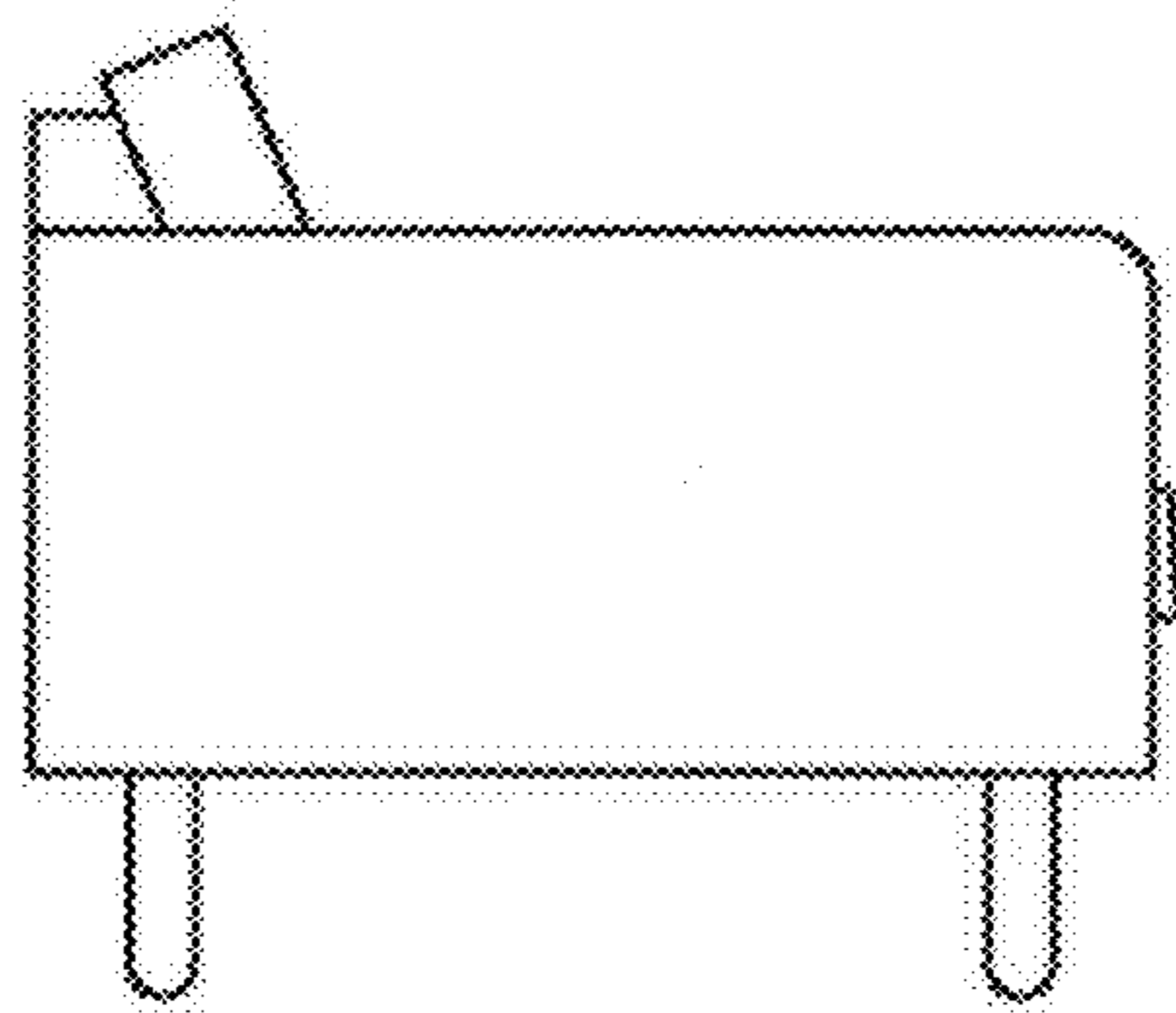
