(57) **CLAIM**

The ornamental design for a blind fabric, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a blind fabric showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top elevational view thereof;
FIG. 7 is a bottom elevational view thereof; and,
FIG. 8 is a perspective view of the blind fabric shown retracted and in a position of use.
The broken lines in FIG. 8 depict environmental subject matter that forms no part of the claimed design.
The claimed blind fabric is installed on a blind frame and used to blocks out the sunlight coming through a window.

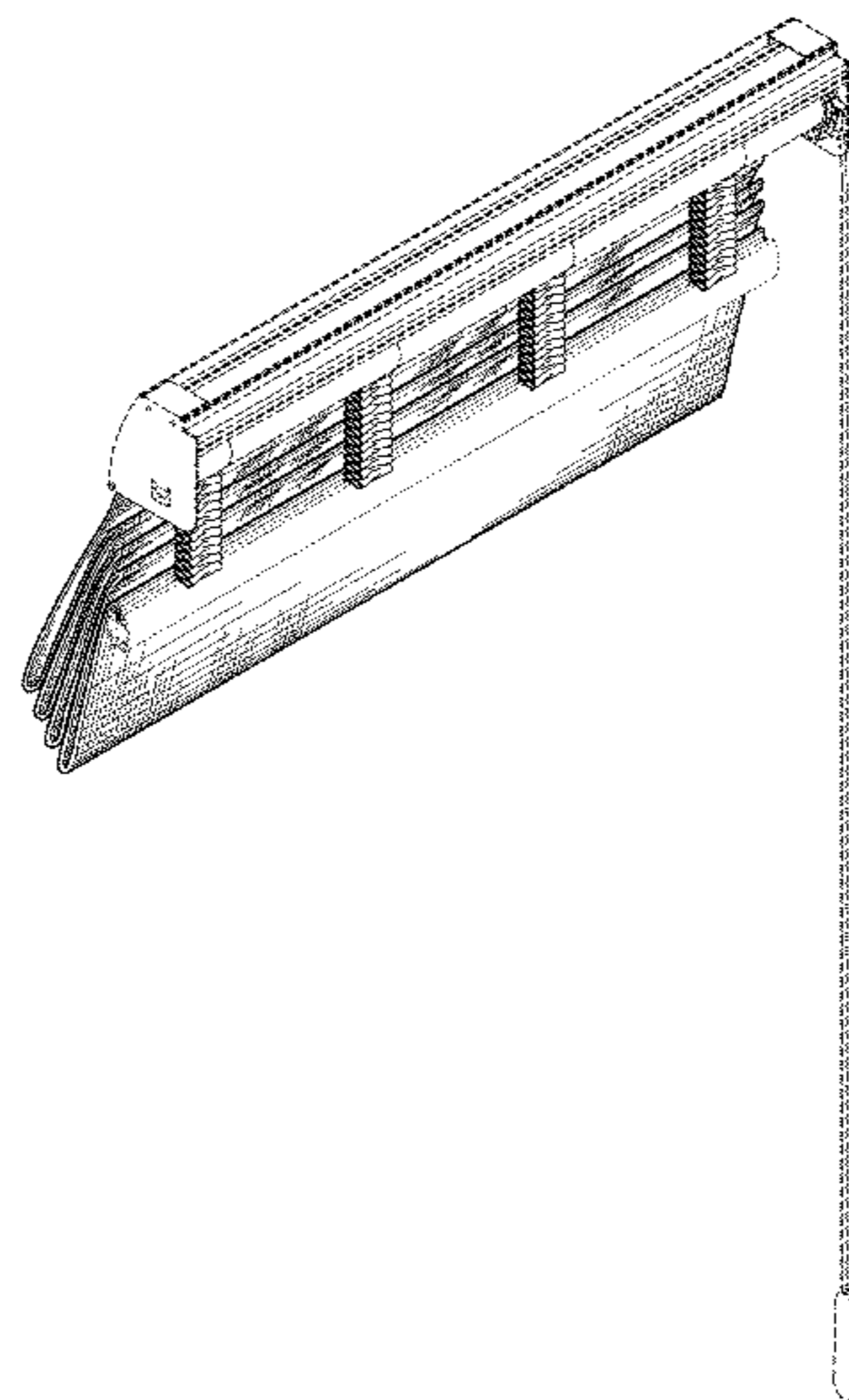
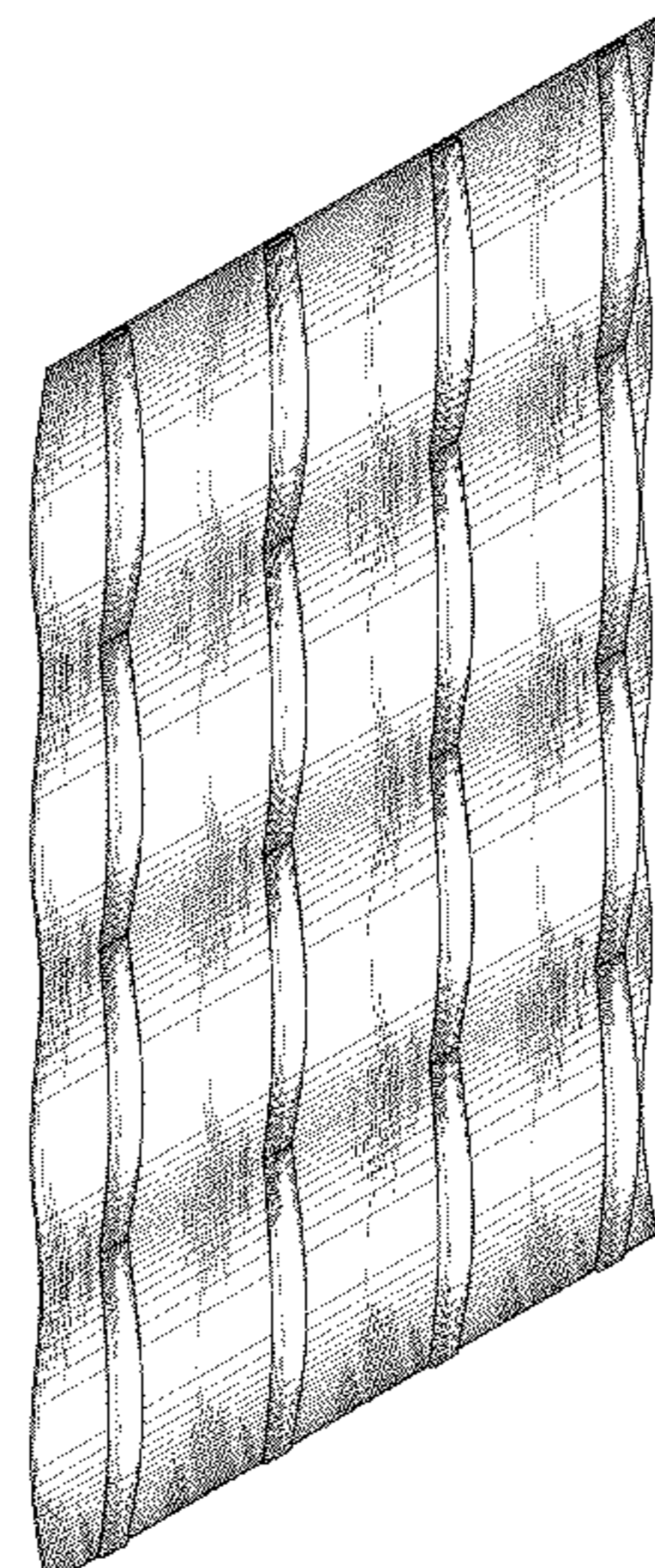

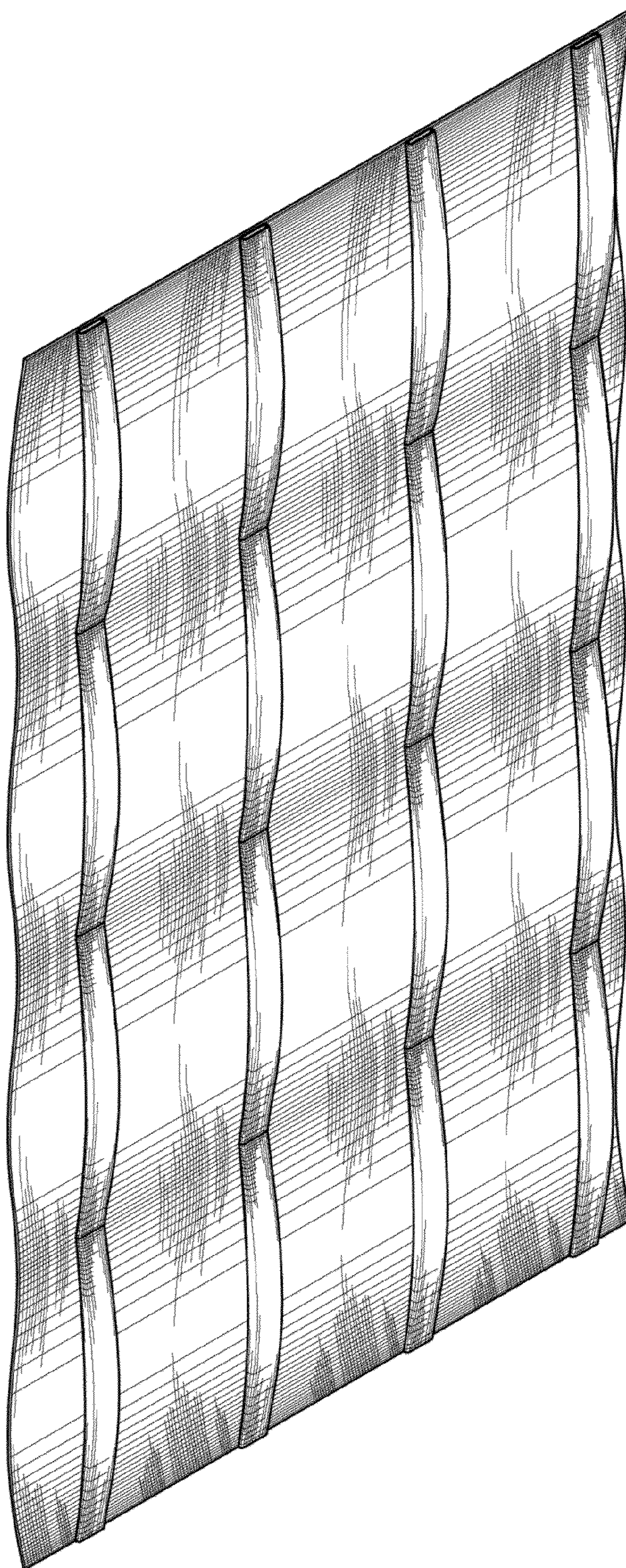

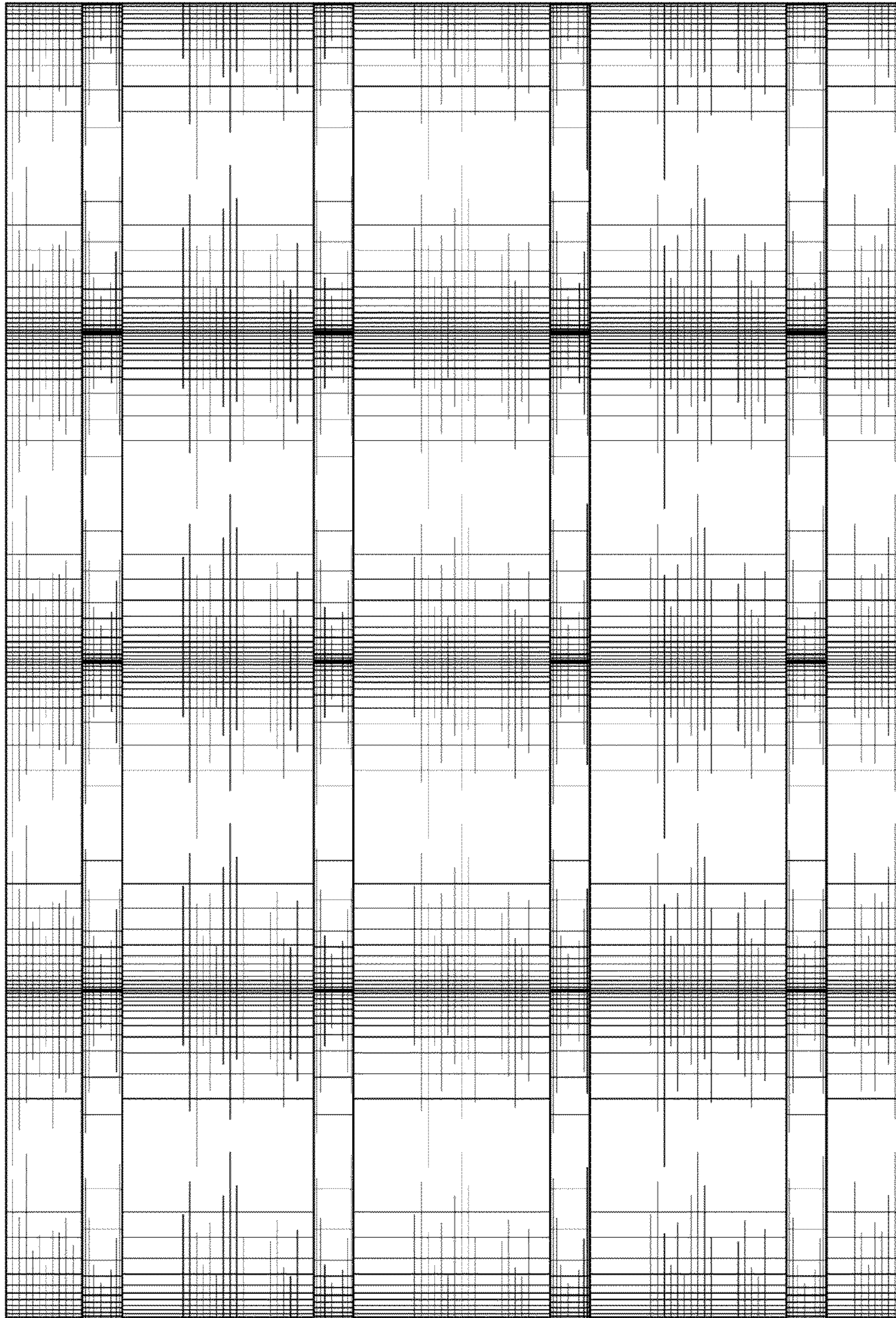

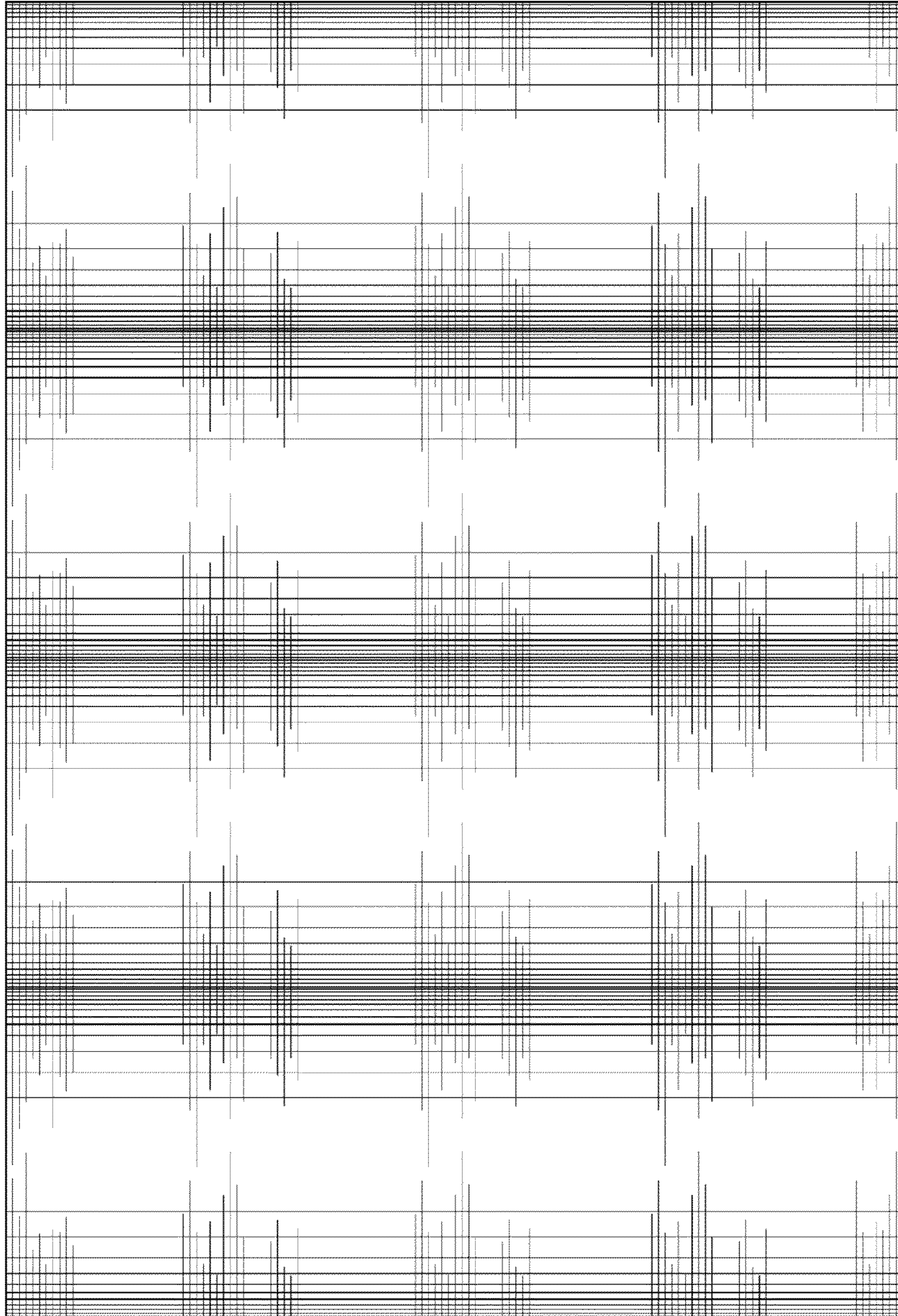

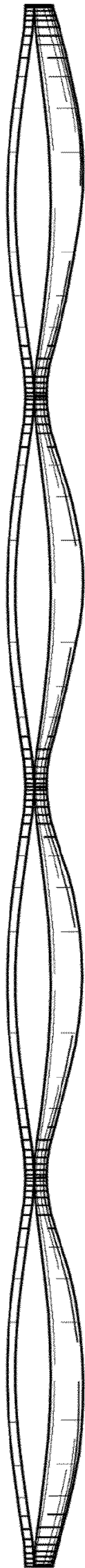

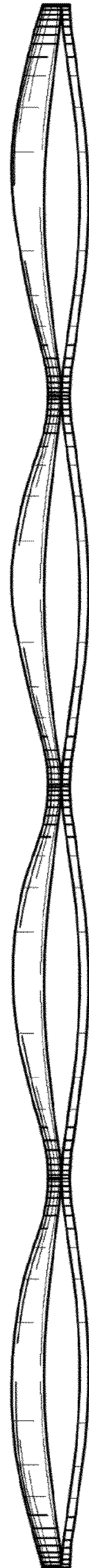

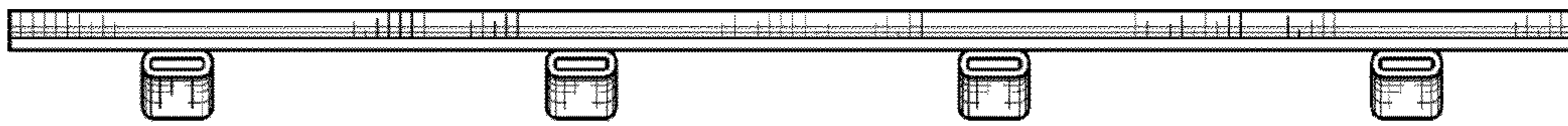
