(57) **CLAIM**

The ornamental design for a reclining chair cover, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a reclining chair cover in accordance with a preferred embodiment of my design, shown in a condition on a reclining chair;

FIG. 2 is a front view of the reclining chair cover of FIG. 1;

FIG. 3 is a rear view of the reclining chair cover of FIG. 1;

FIG. 4 is a right side view of the reclining chair cover of FIG. 1;

FIG. 5 is a top side view of the reclining chair cover of FIG. 1;

FIG. 6 is a top view of the reclining chair cover of FIG. 1, shown in a flat condition, off of a chair;

FIG. 7 is a bottom view of the reclining chair cover of FIG. 1, shown in a flat condition, off of a chair;

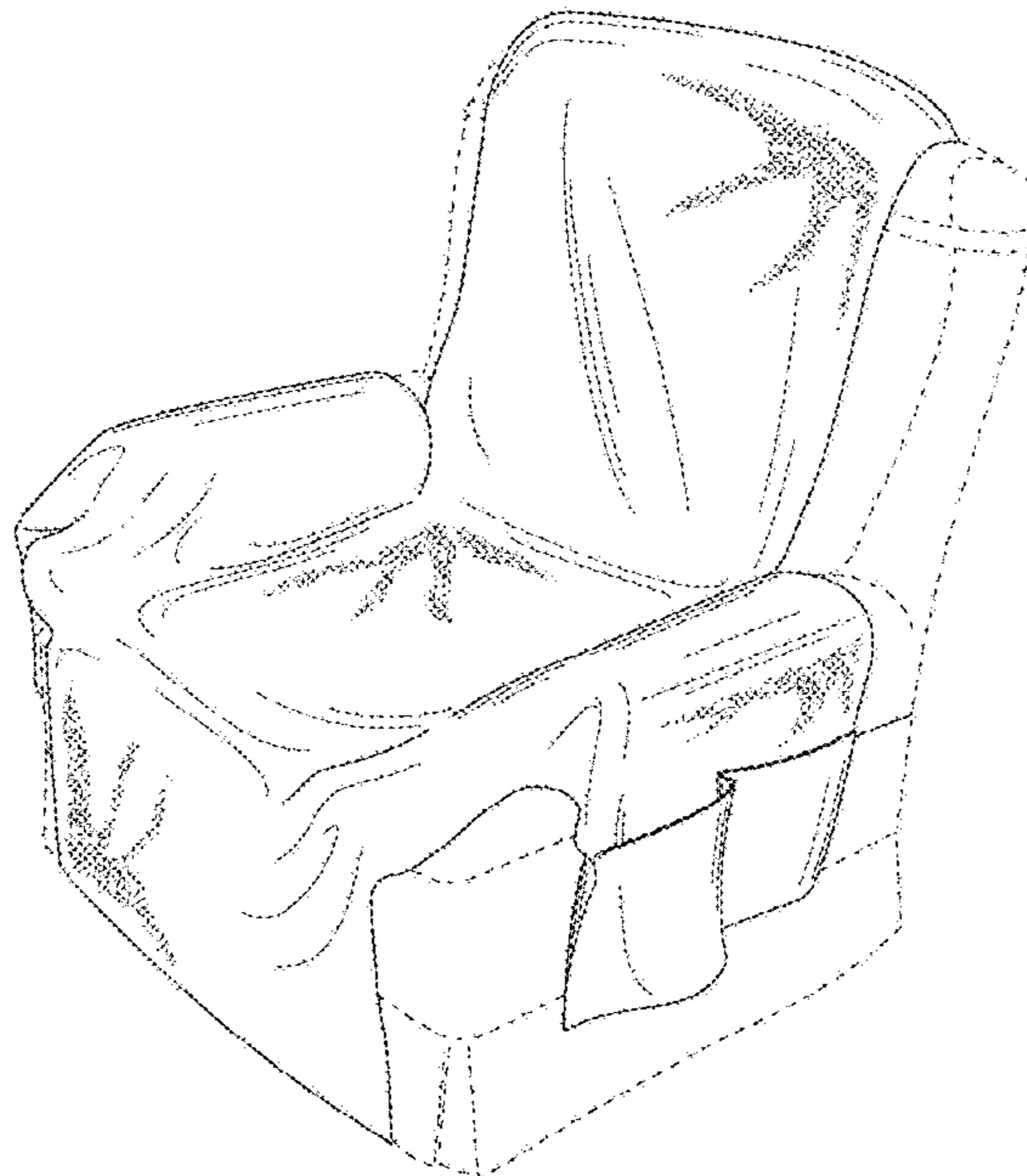
FIG. 8 is a left side view of the reclining chair cover of FIG. 1, shown in a flat condition, off of a chair, the right side view being a mirror image thereof;

FIG. 9 is a front view of the reclining chair cover of FIG. 1, shown in a flat condition, off of a chair; and,

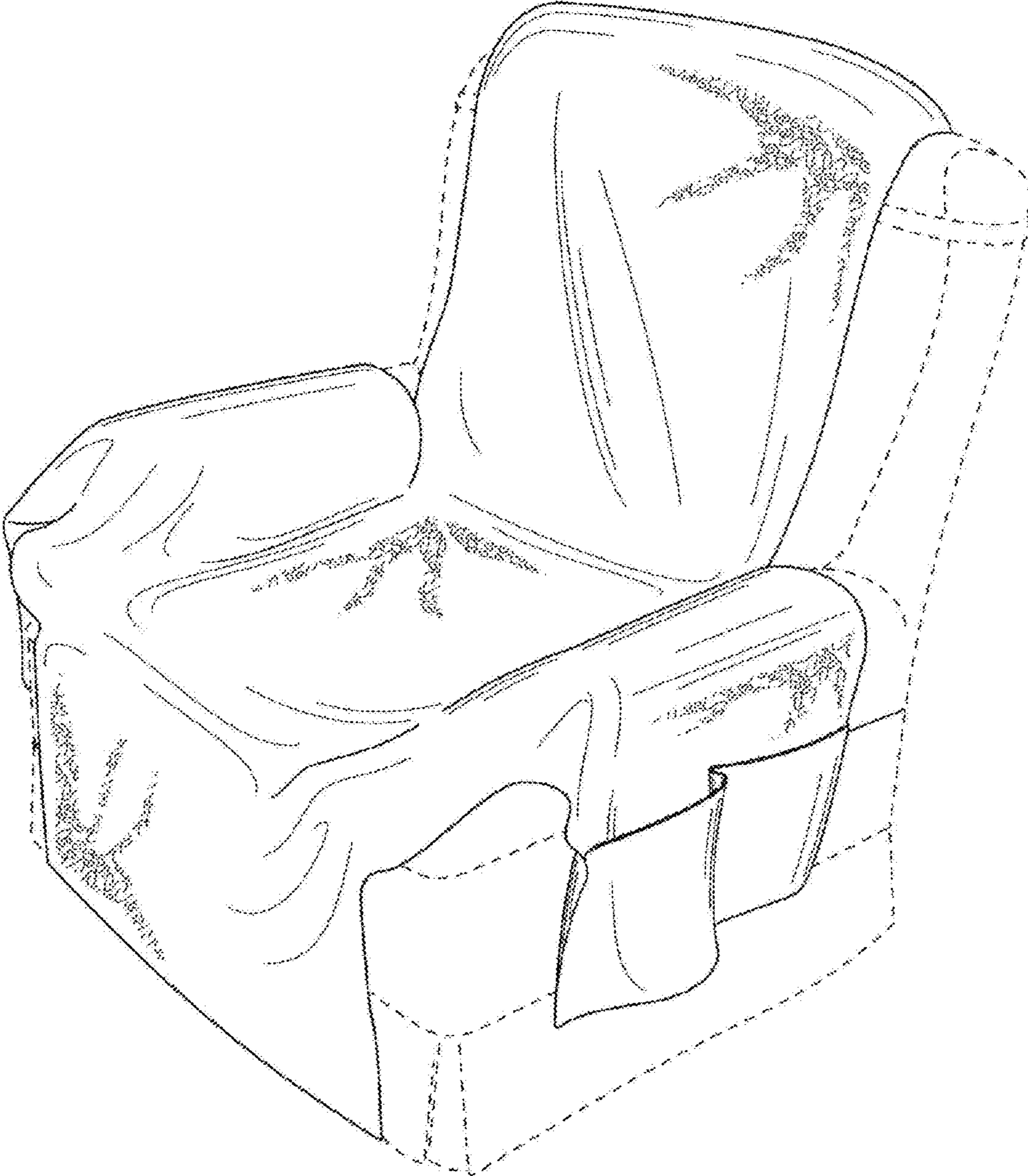

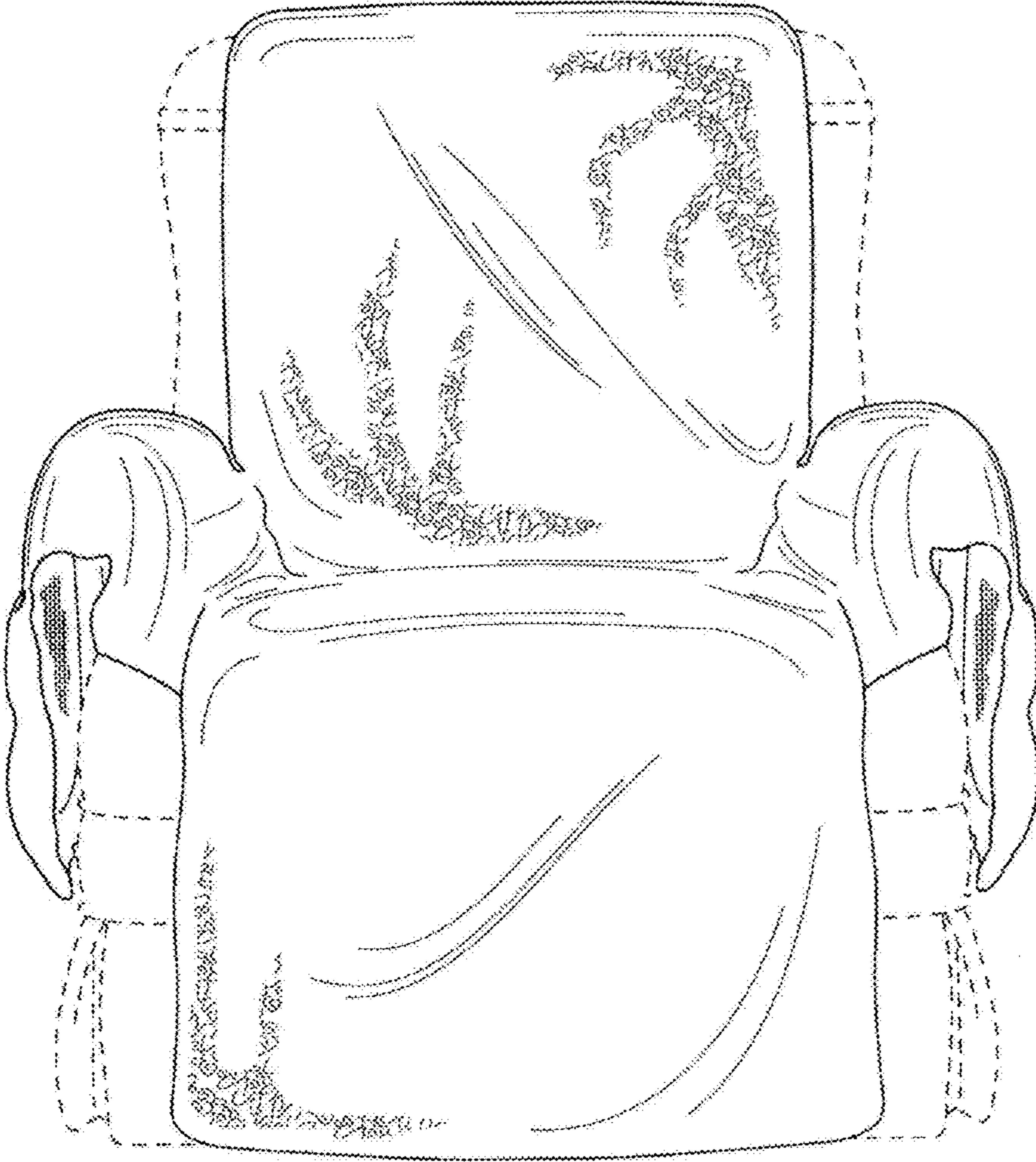

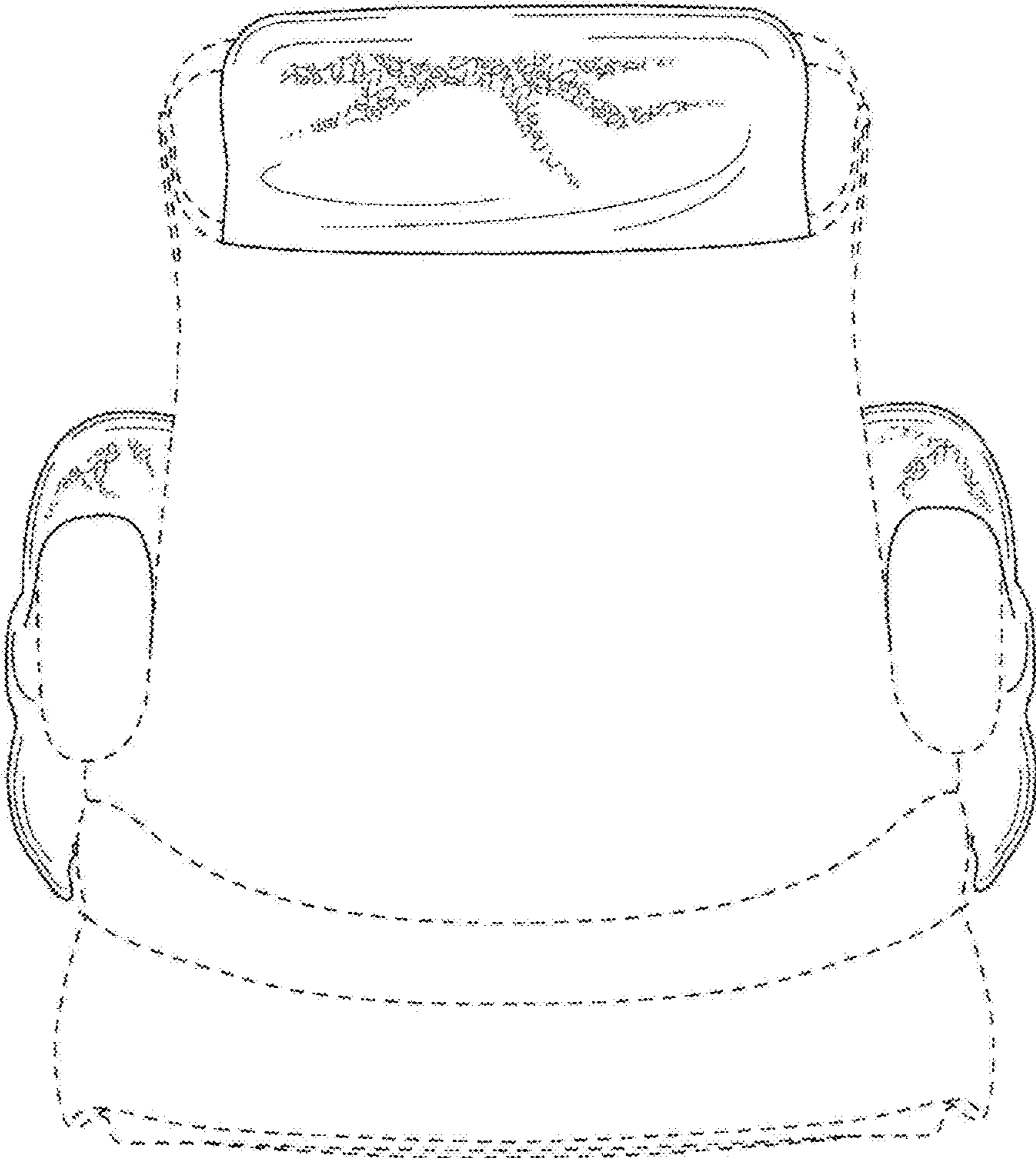

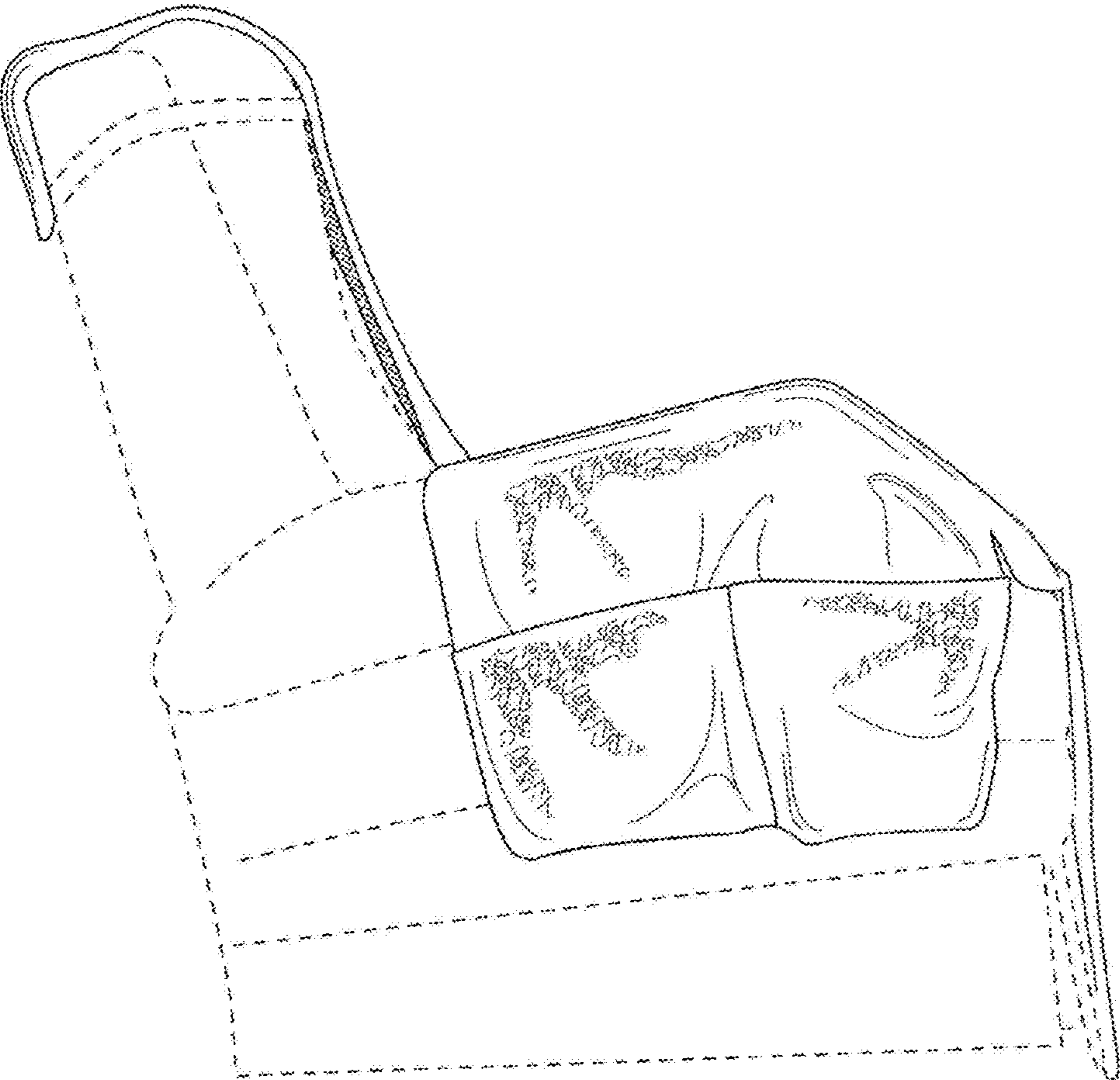

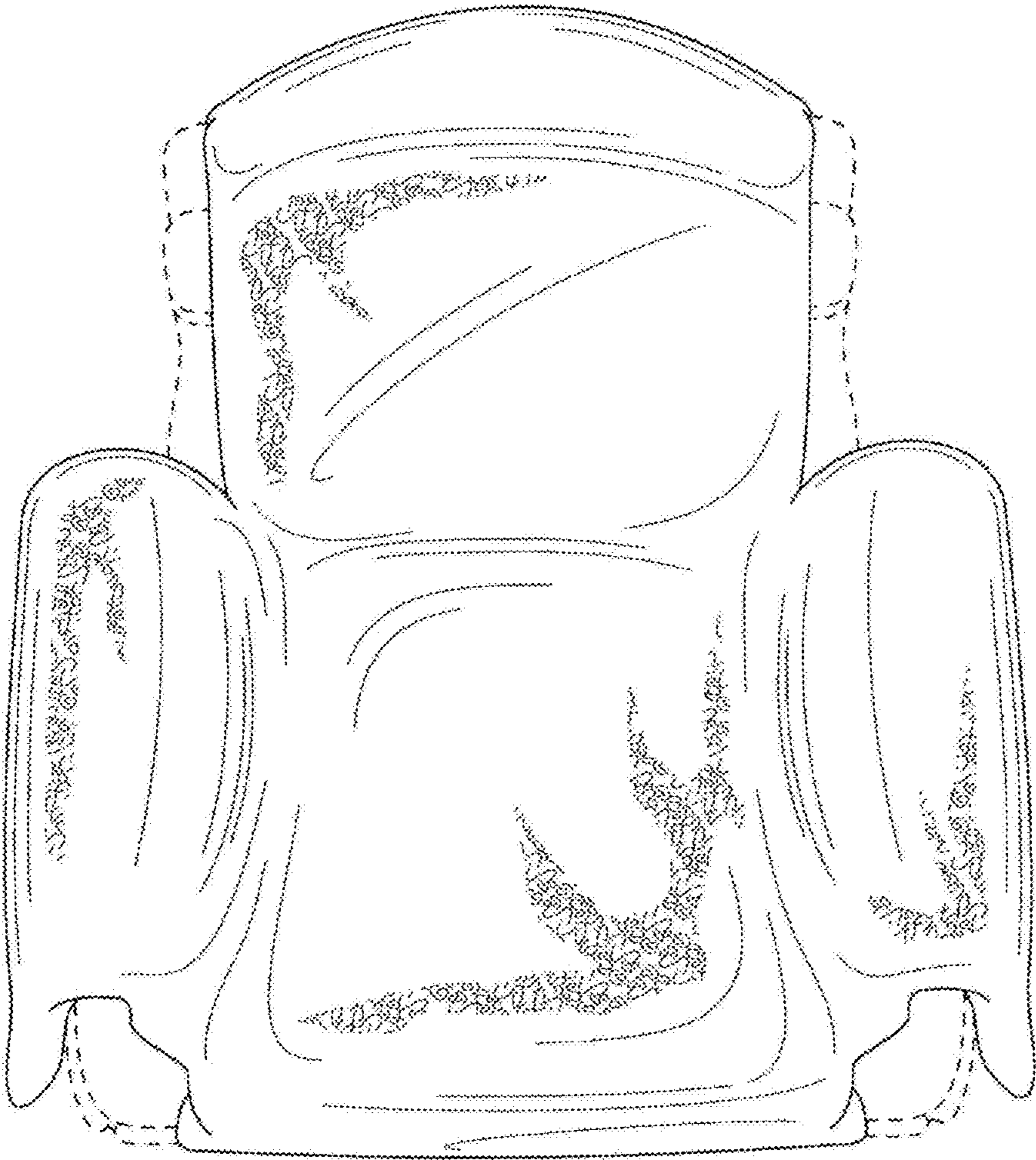

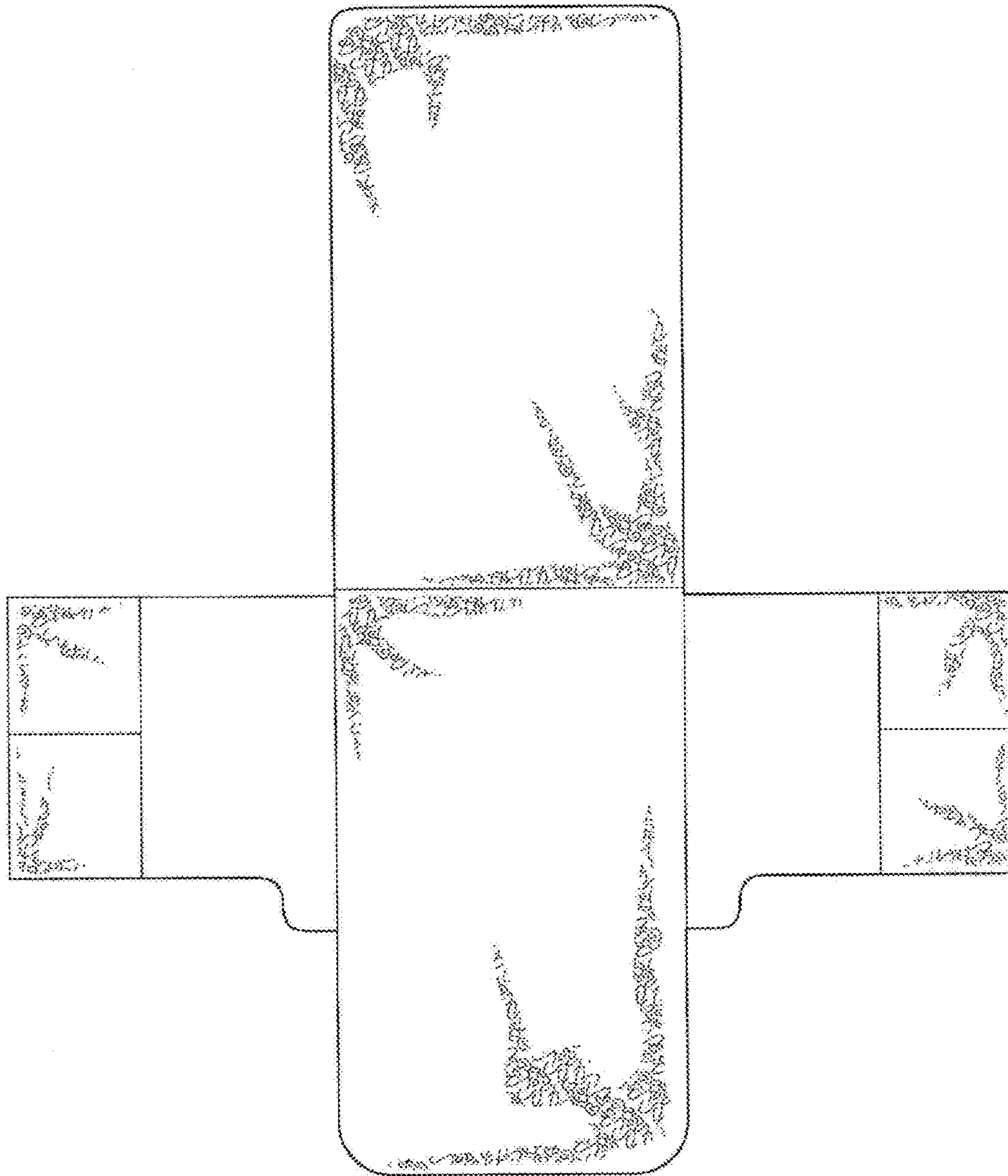

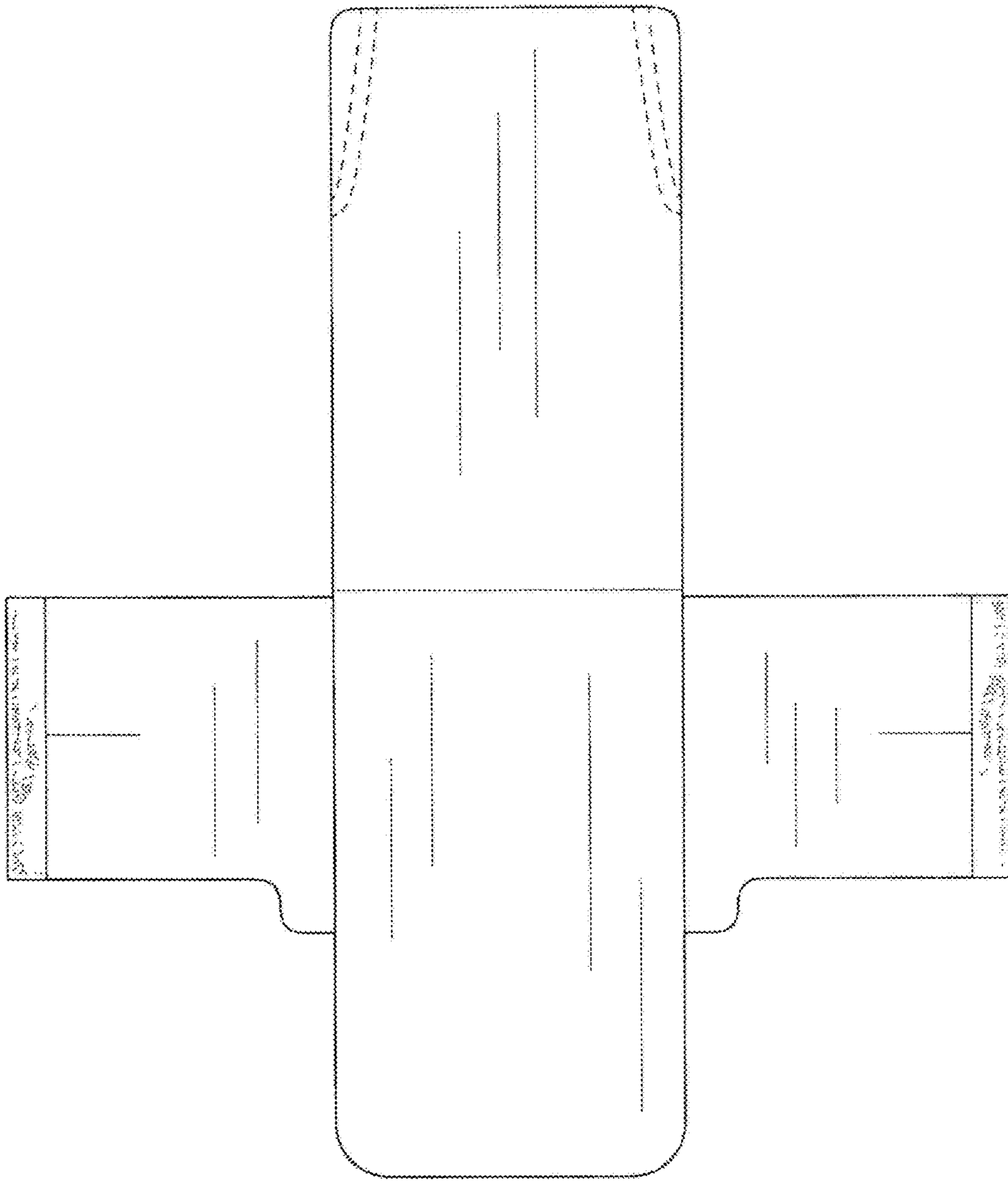

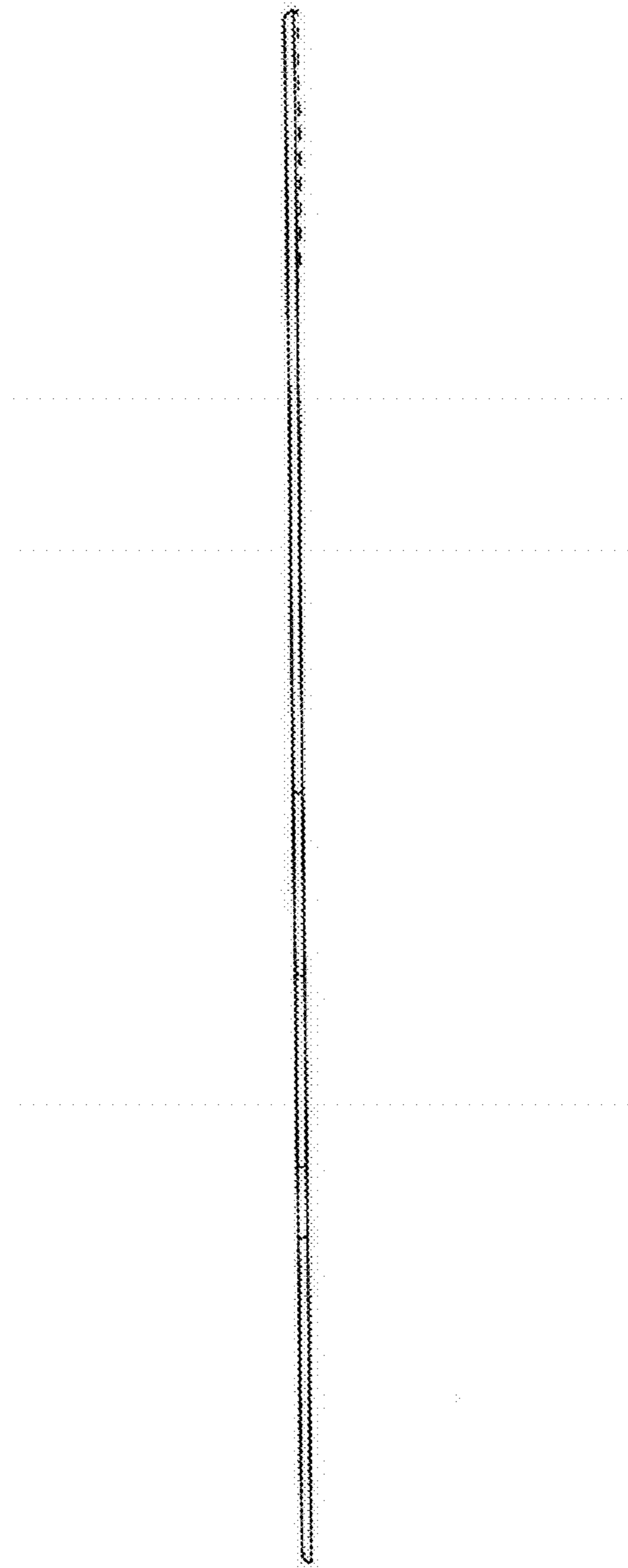

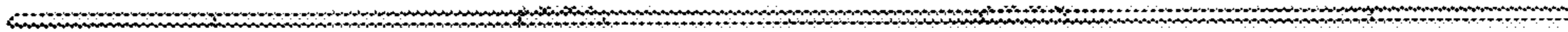

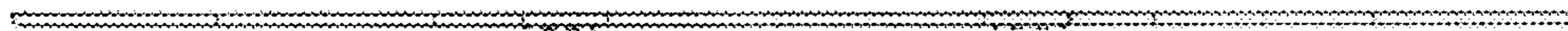
