**DESCRIPTION**

FIG. 1 is a perspective view of the cup with handle and lid.

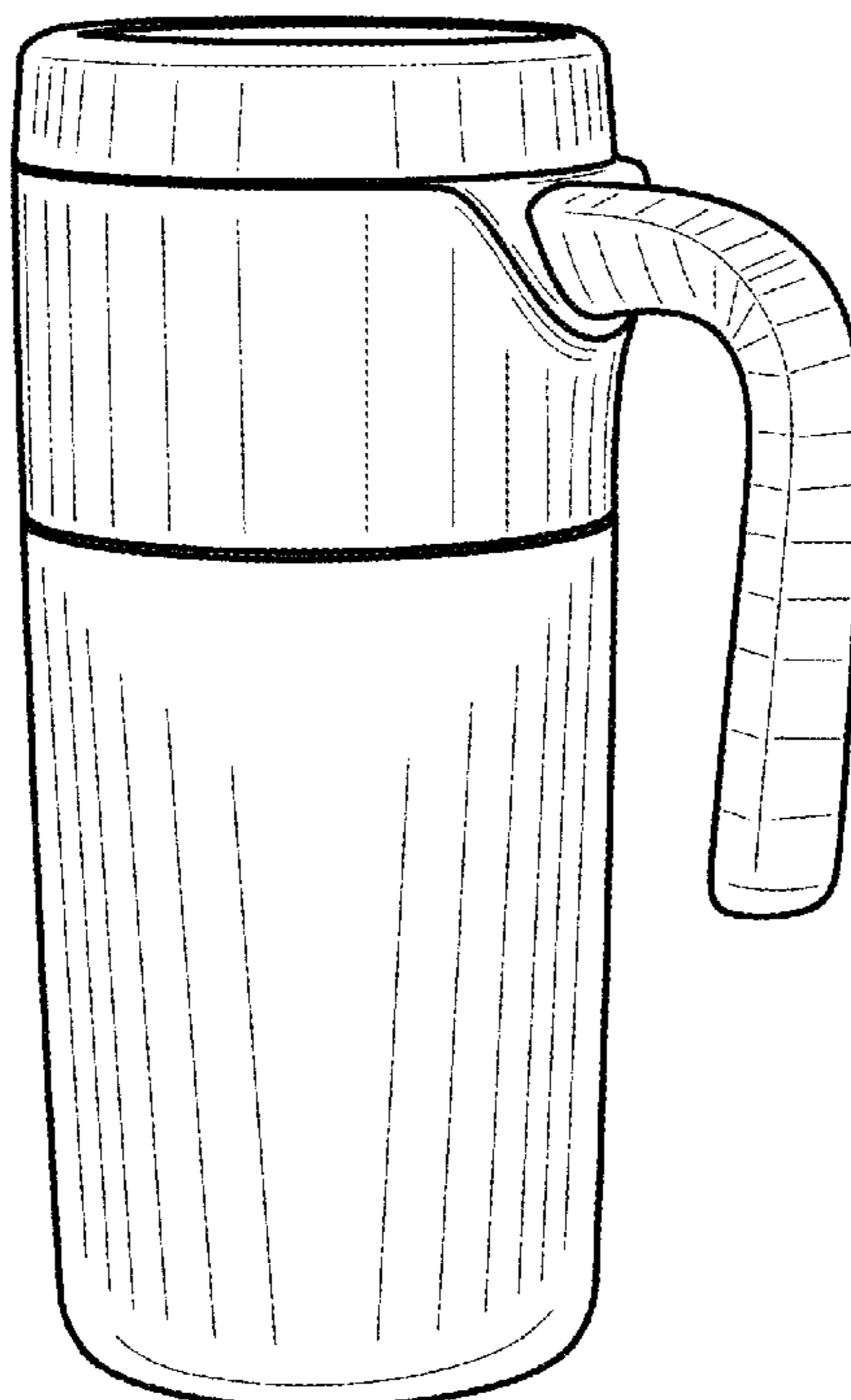

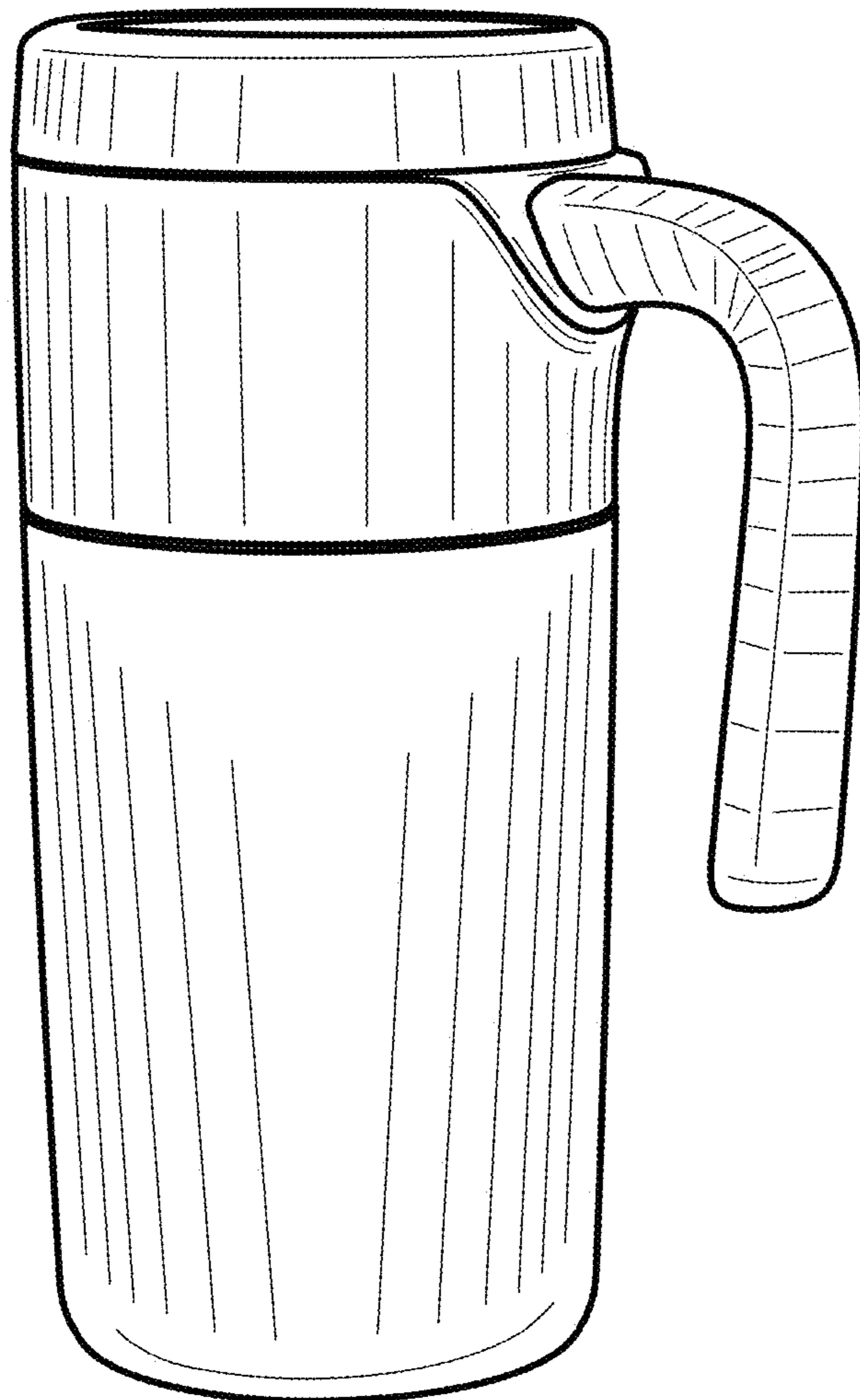

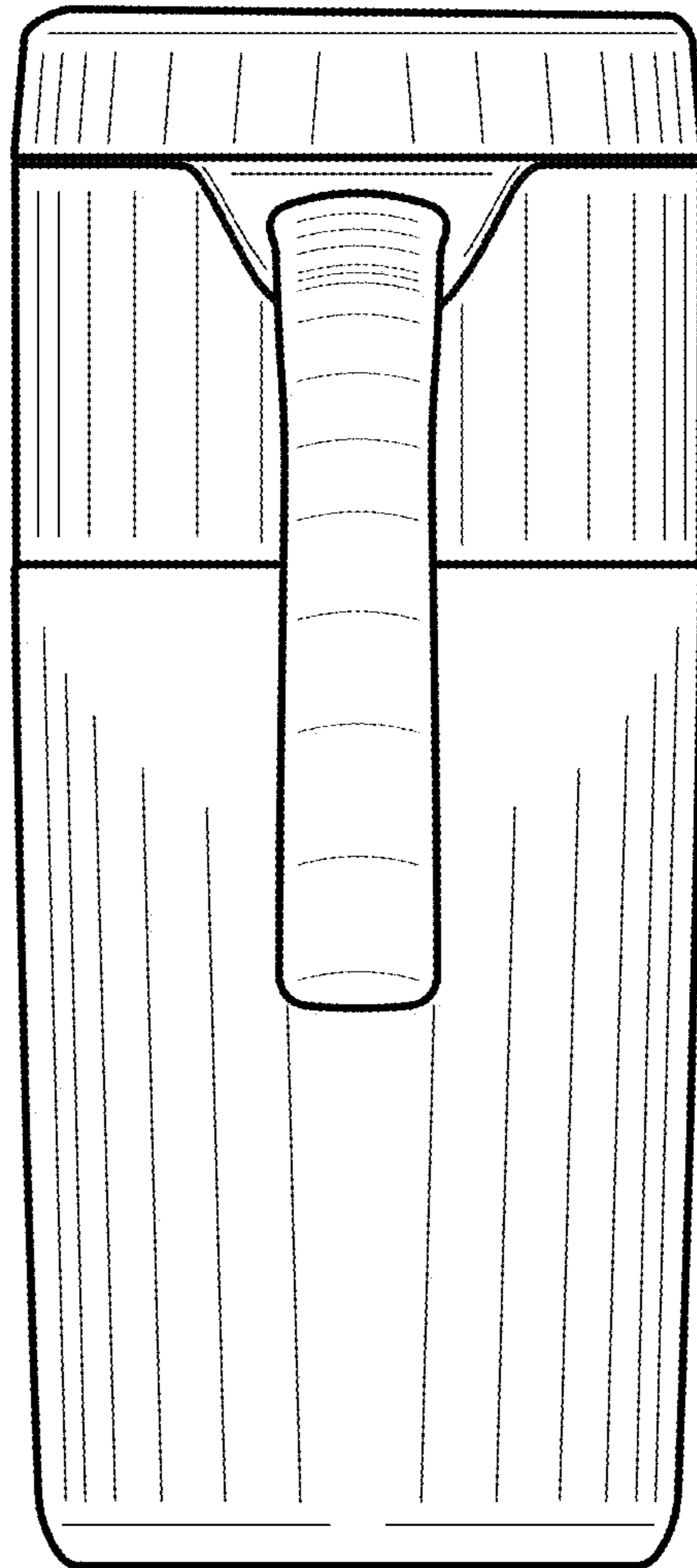

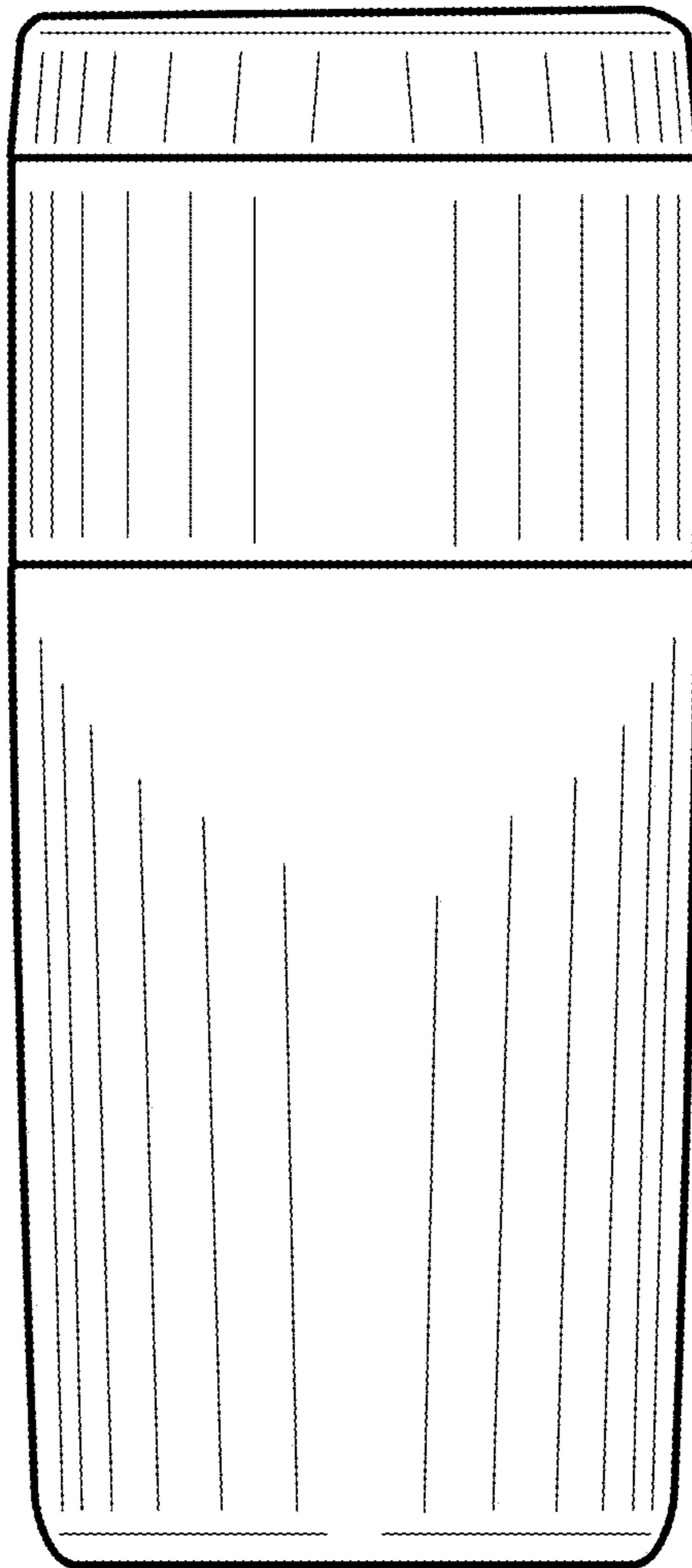

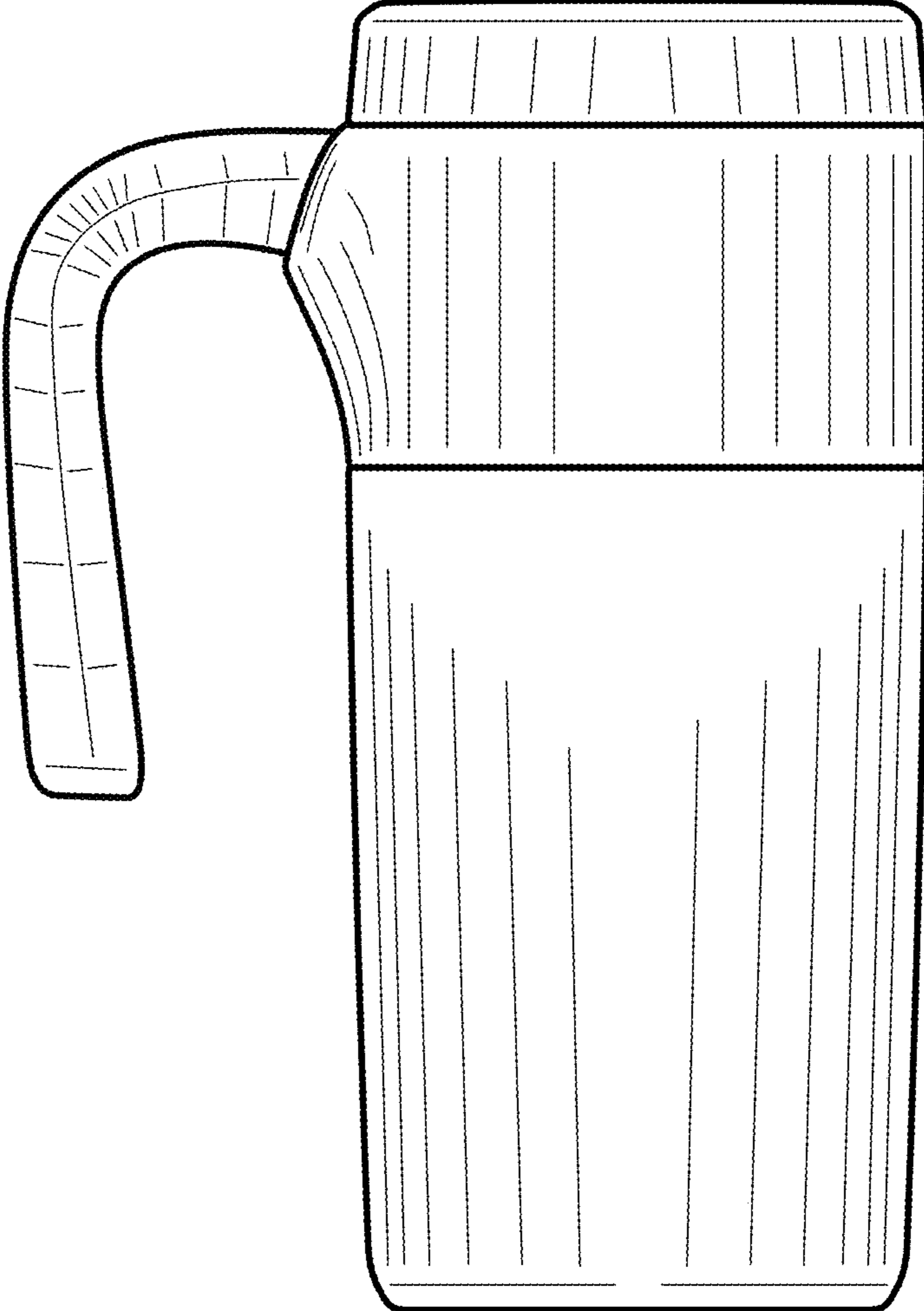

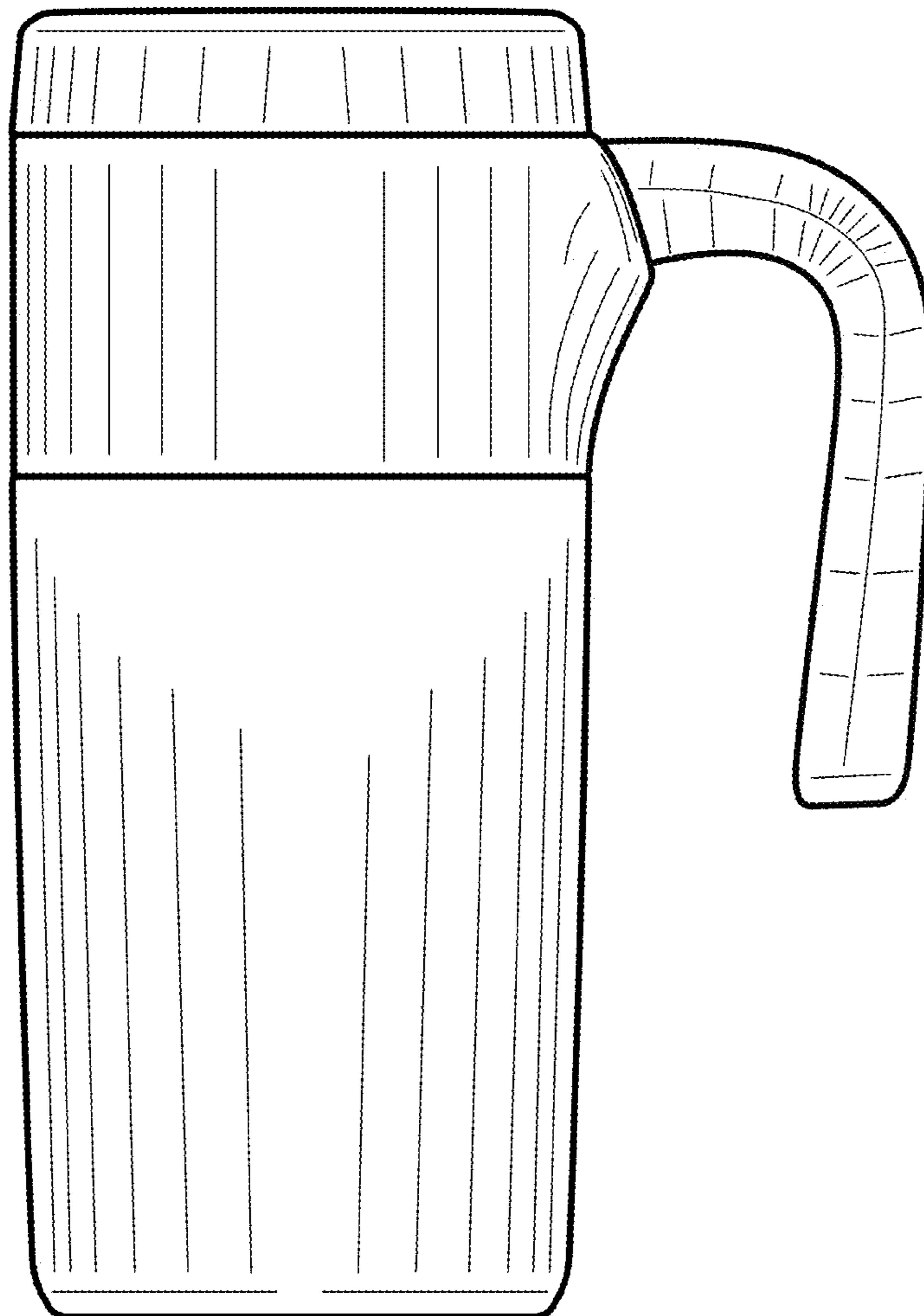

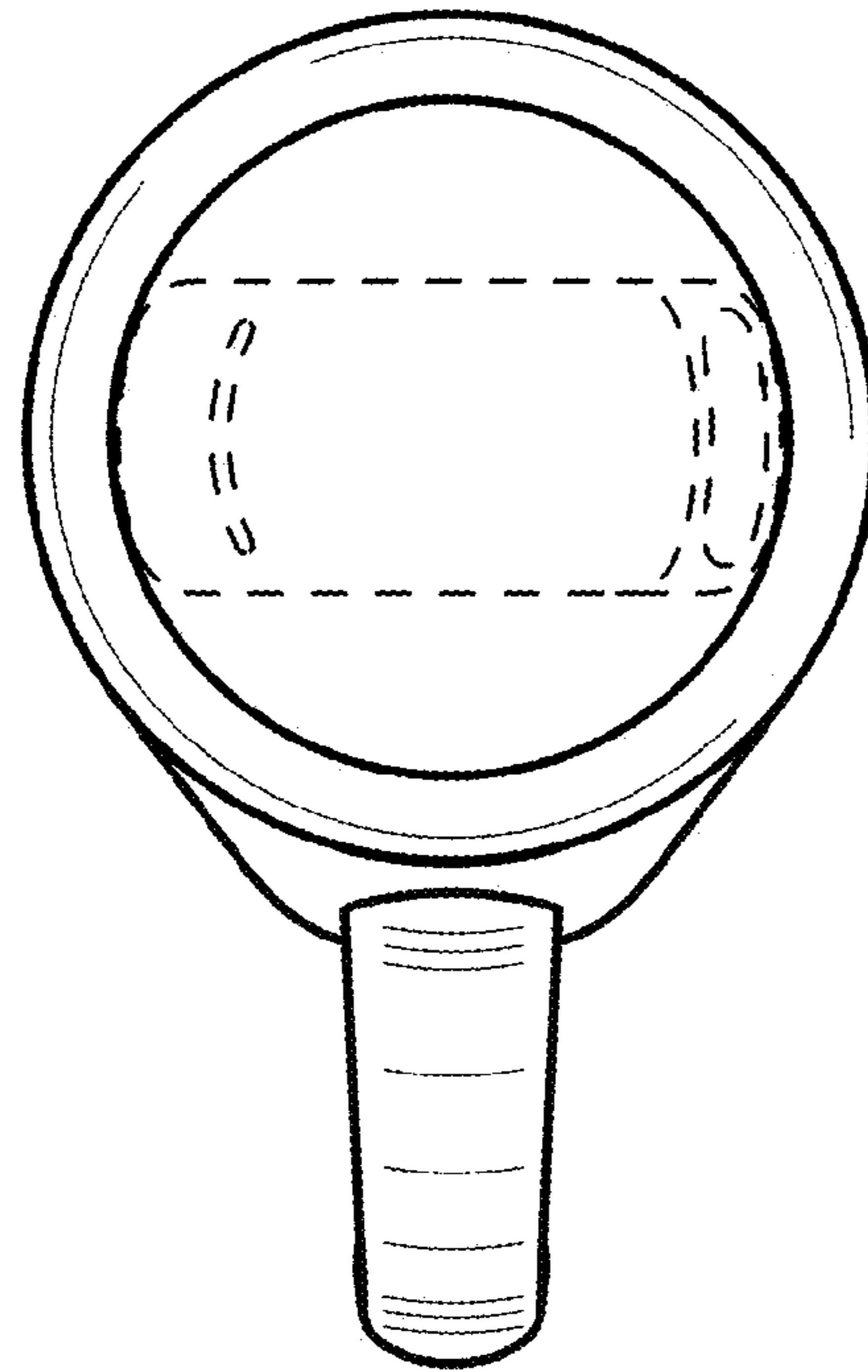
