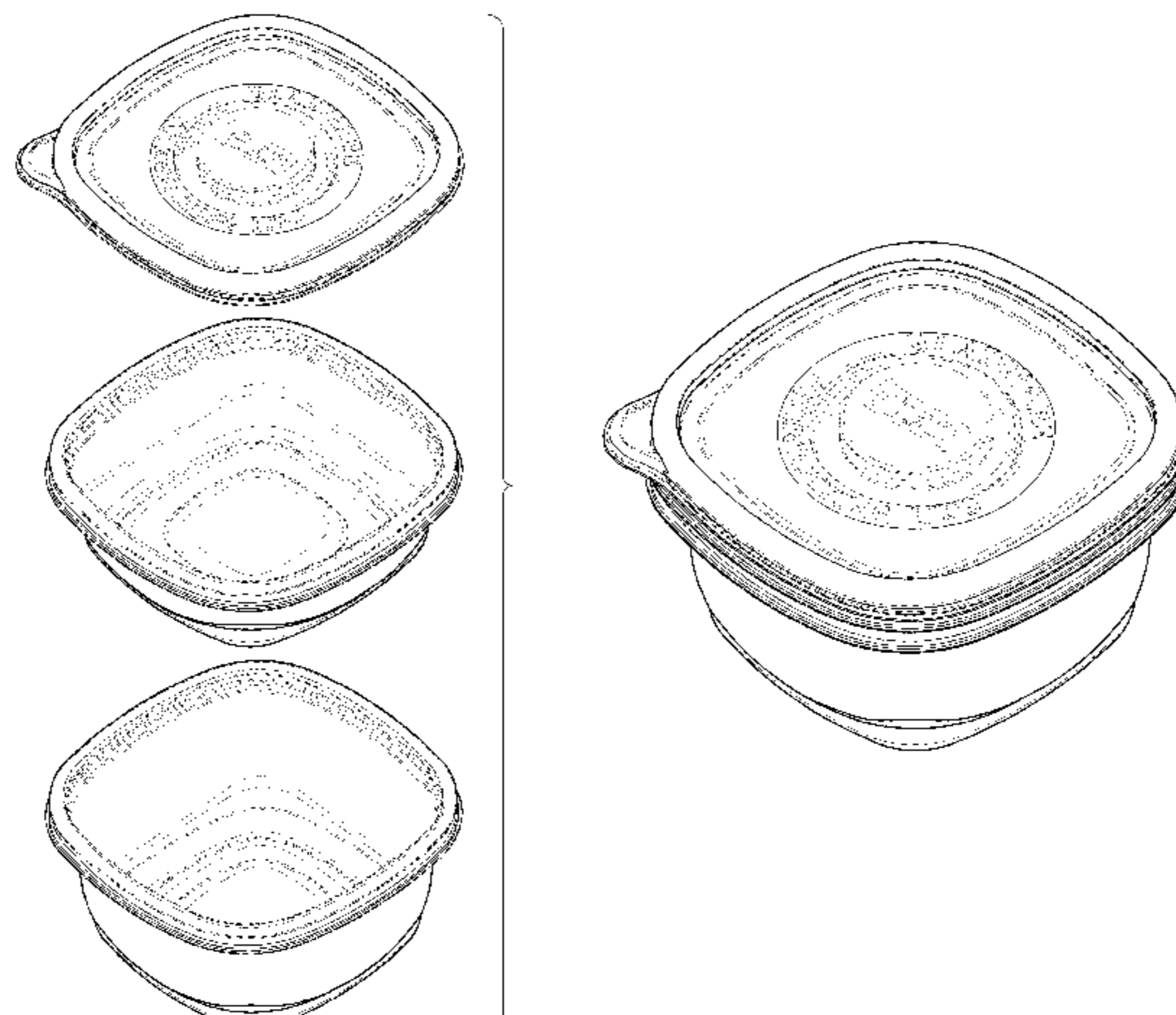
(57) **CLAIM**

The ornamental design for a stackable food container, as shown and described.

DESCRIPTION

FIG. 1 is an exploded rear perspective view of a stackable food container showing our new design;
FIG. 2 is a rear perspective view of a stackable food container showing our new design;
FIG. 3 is a front side elevational view of FIG. 2;
FIG. 4 is a rear side elevational view of FIG. 2;
FIG. 5 is a left side elevational view of FIG. 2;
FIG. 6 is a right side elevational view of FIG. 2;
FIG. 7 is a top plan view of FIG. 2; and,
FIG. 8 is an exploded left side elevational view of a stackable food container showing our new design.
The broken lines showing a manufacturer's logo and indicia on the surface of the lid in FIGS. 1, 2 and 7; pattern on sides in FIG. 8; and environmental structure in FIGS. 1, 2 and 7 of the stackable food container are for the purpose of illustrating environment, and form no part of the claimed design.

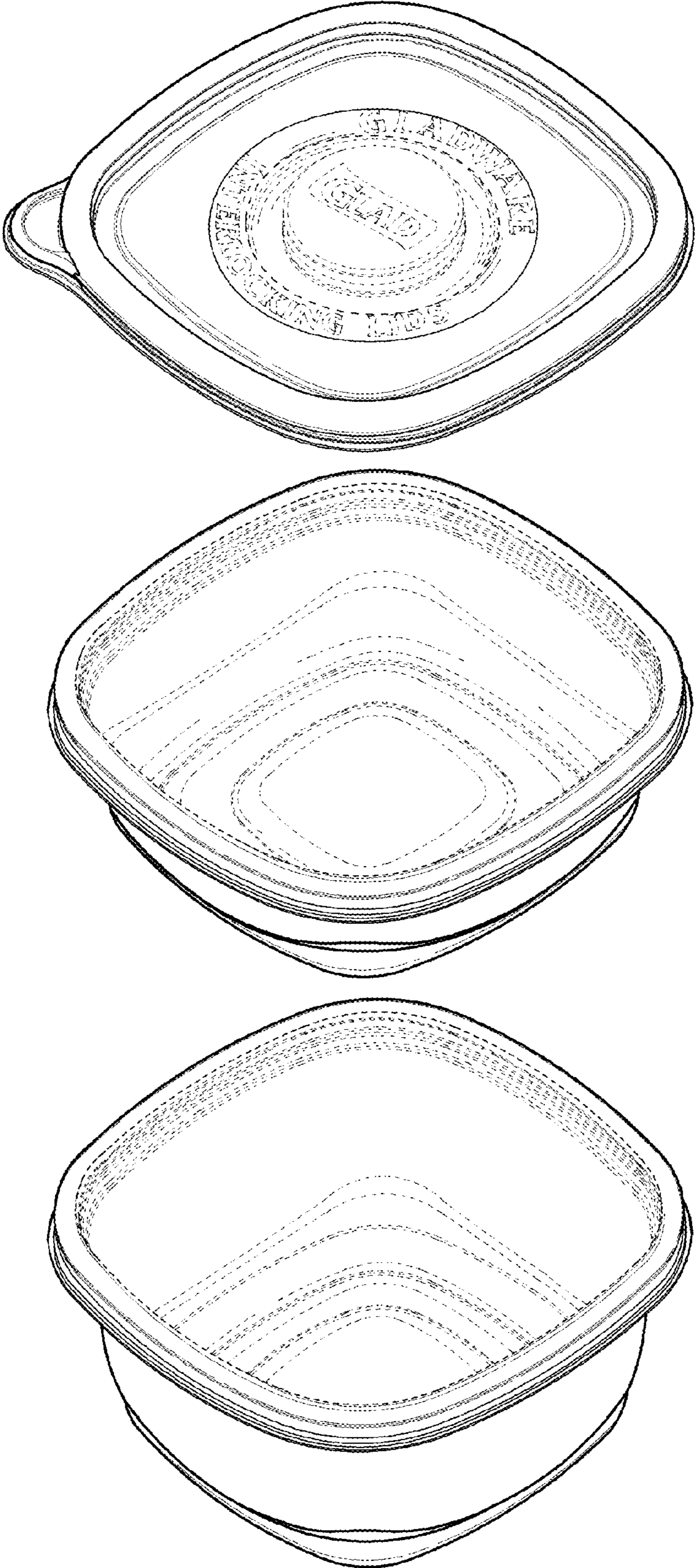

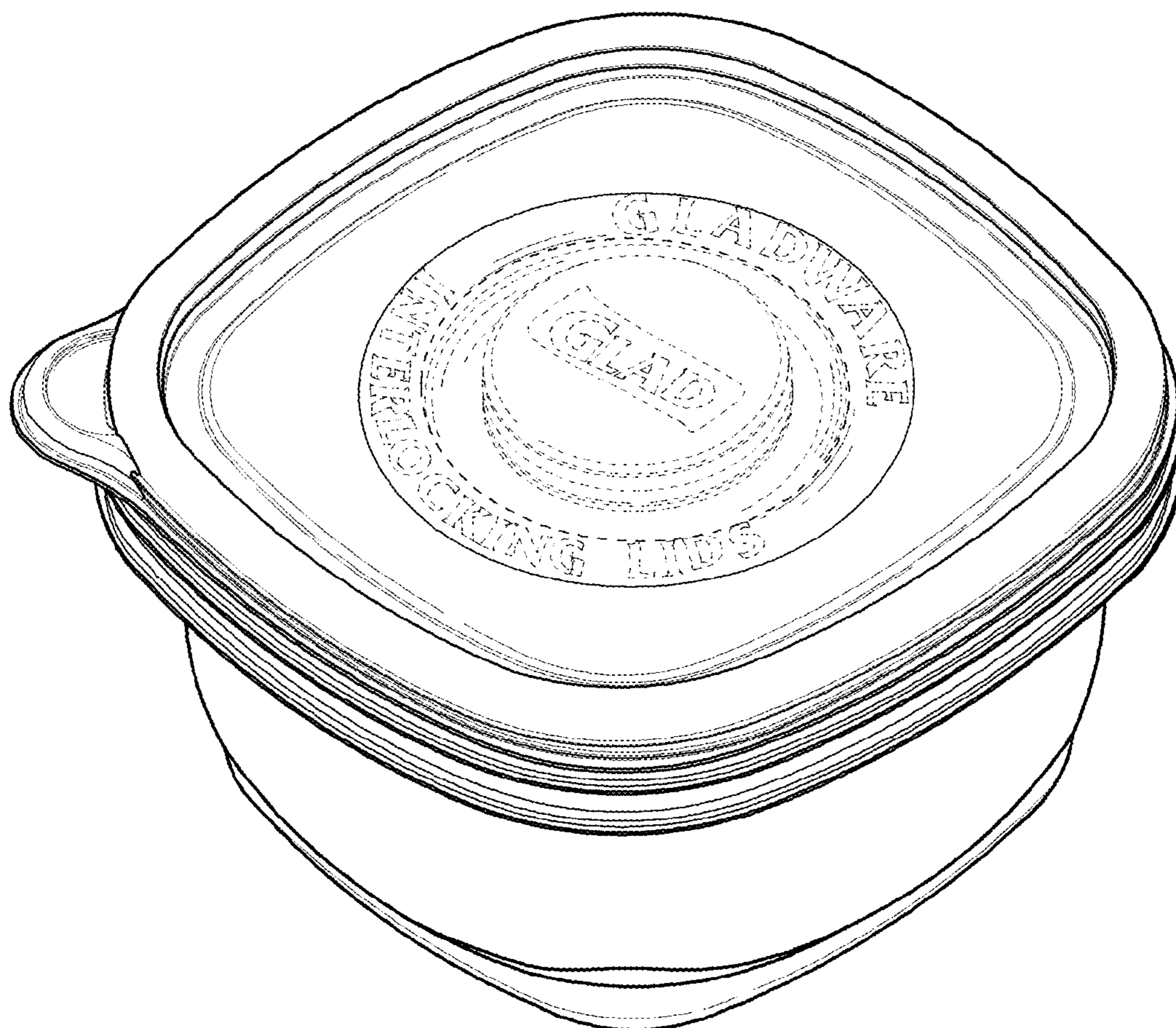

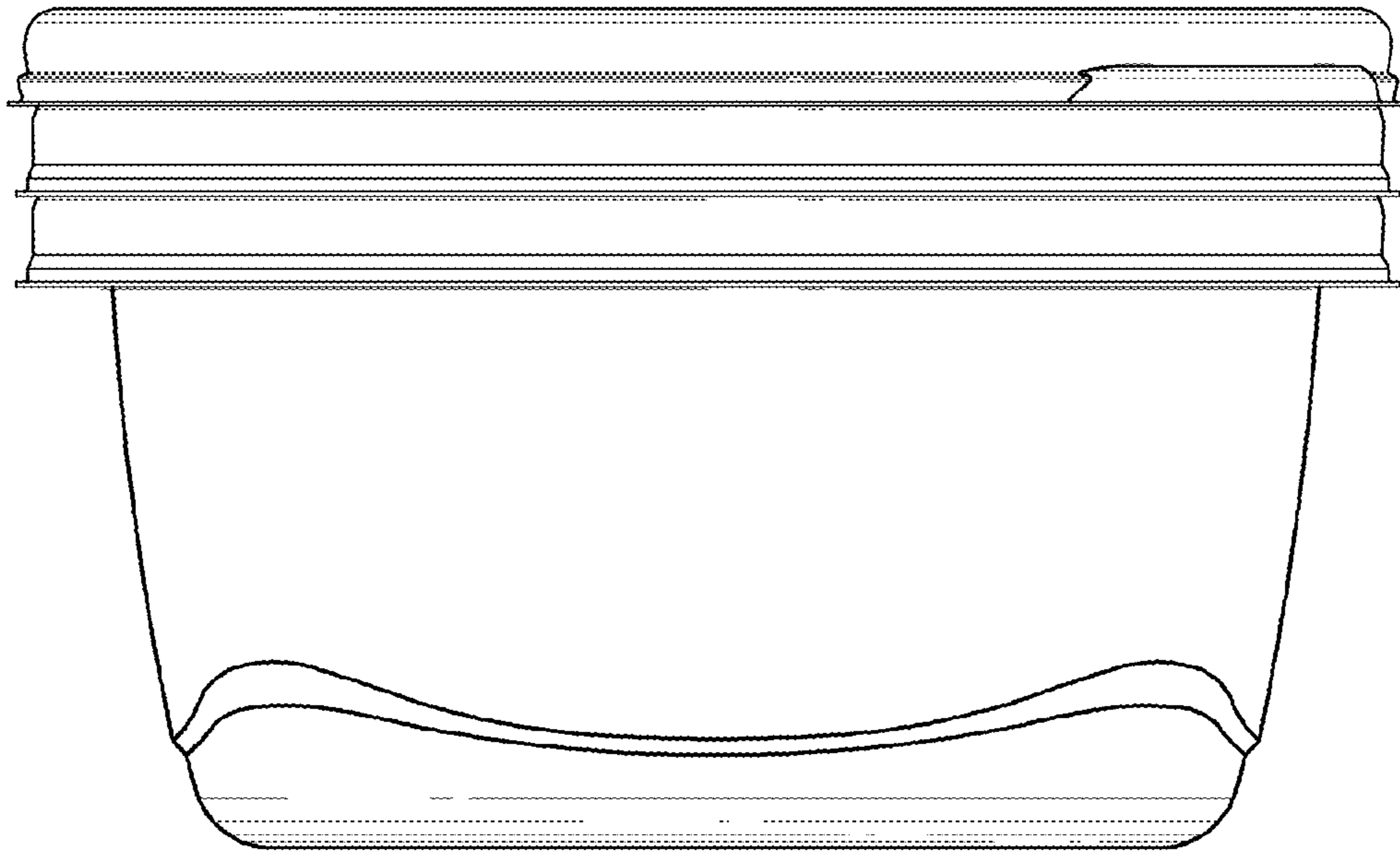

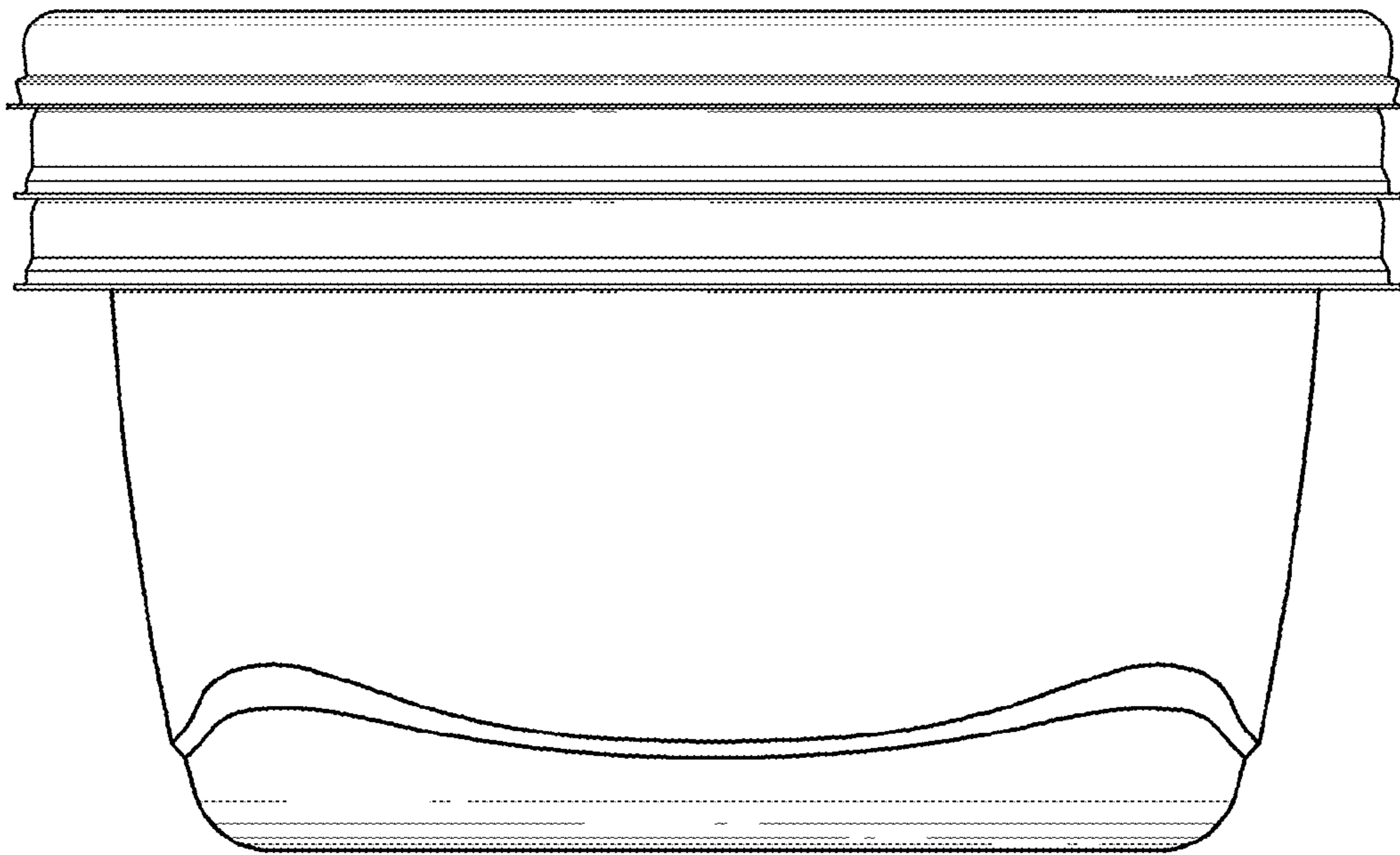

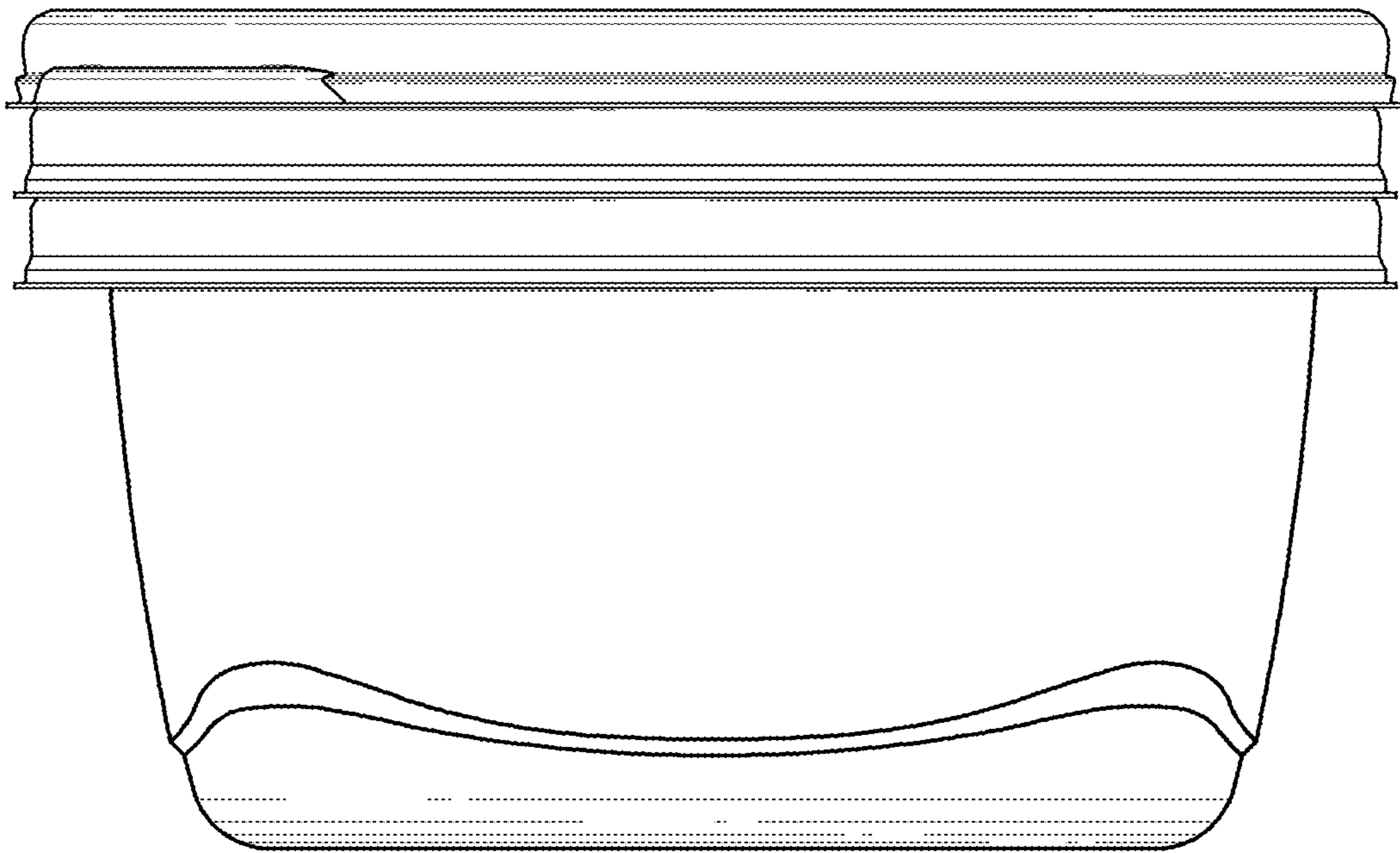

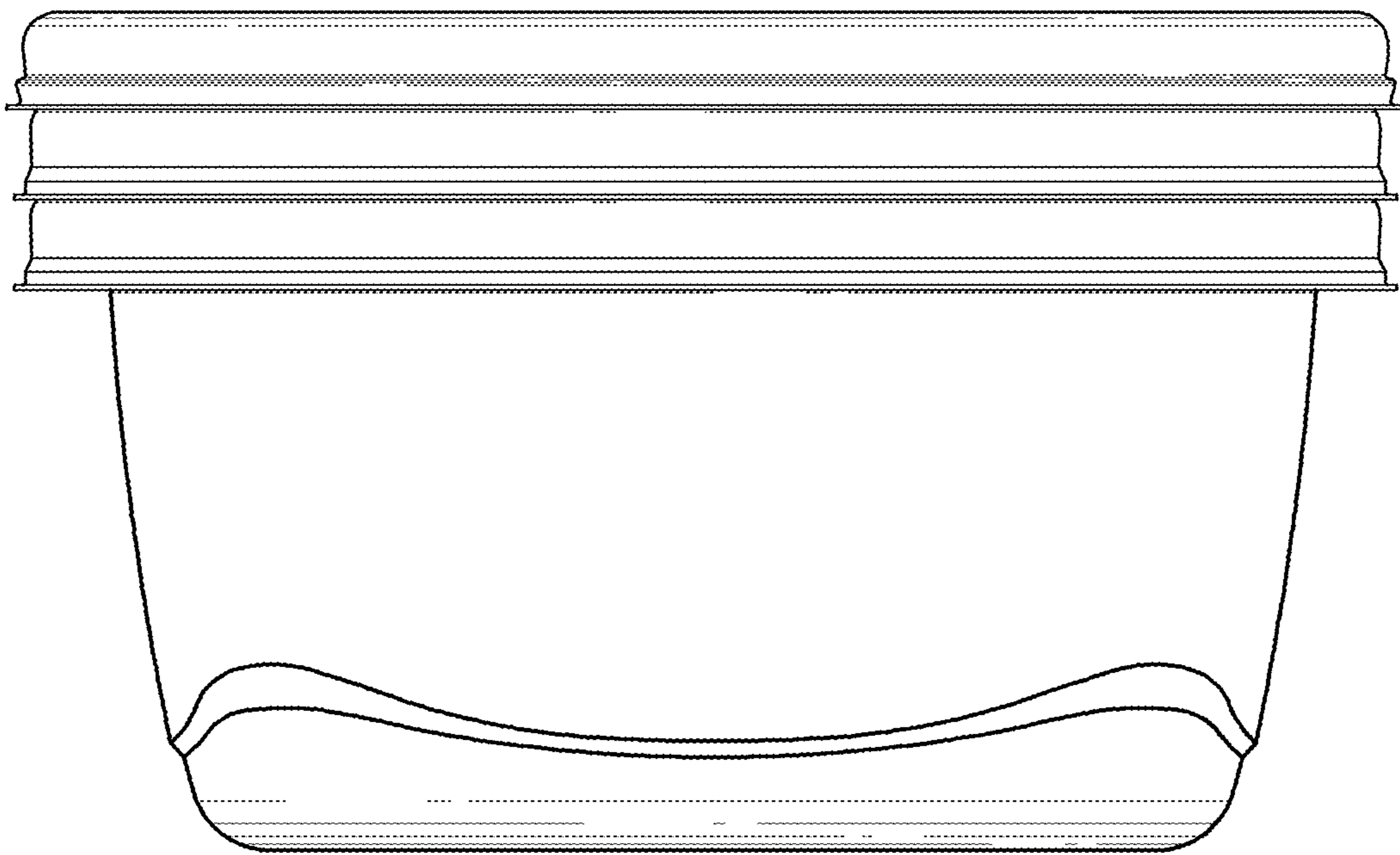

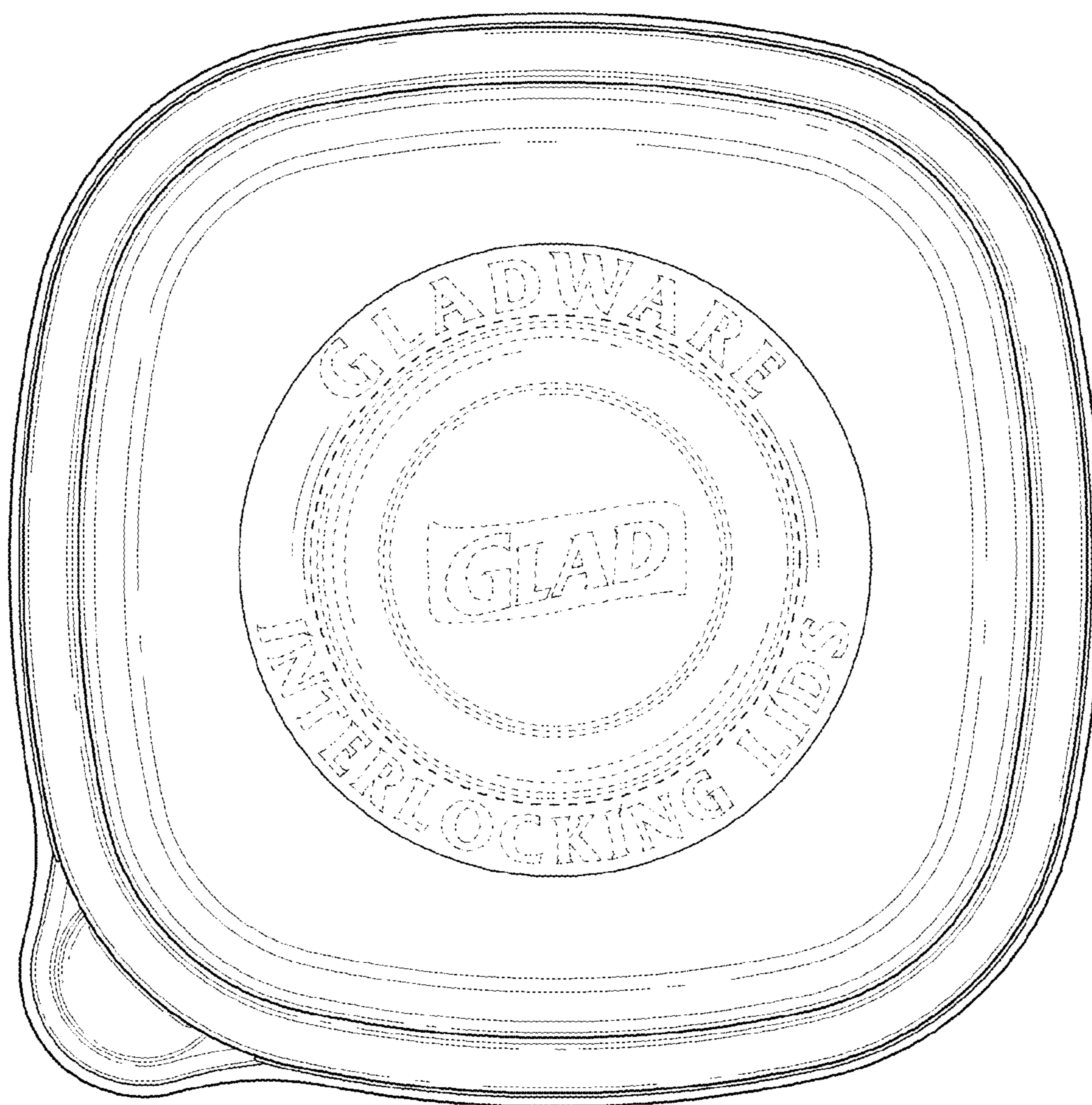

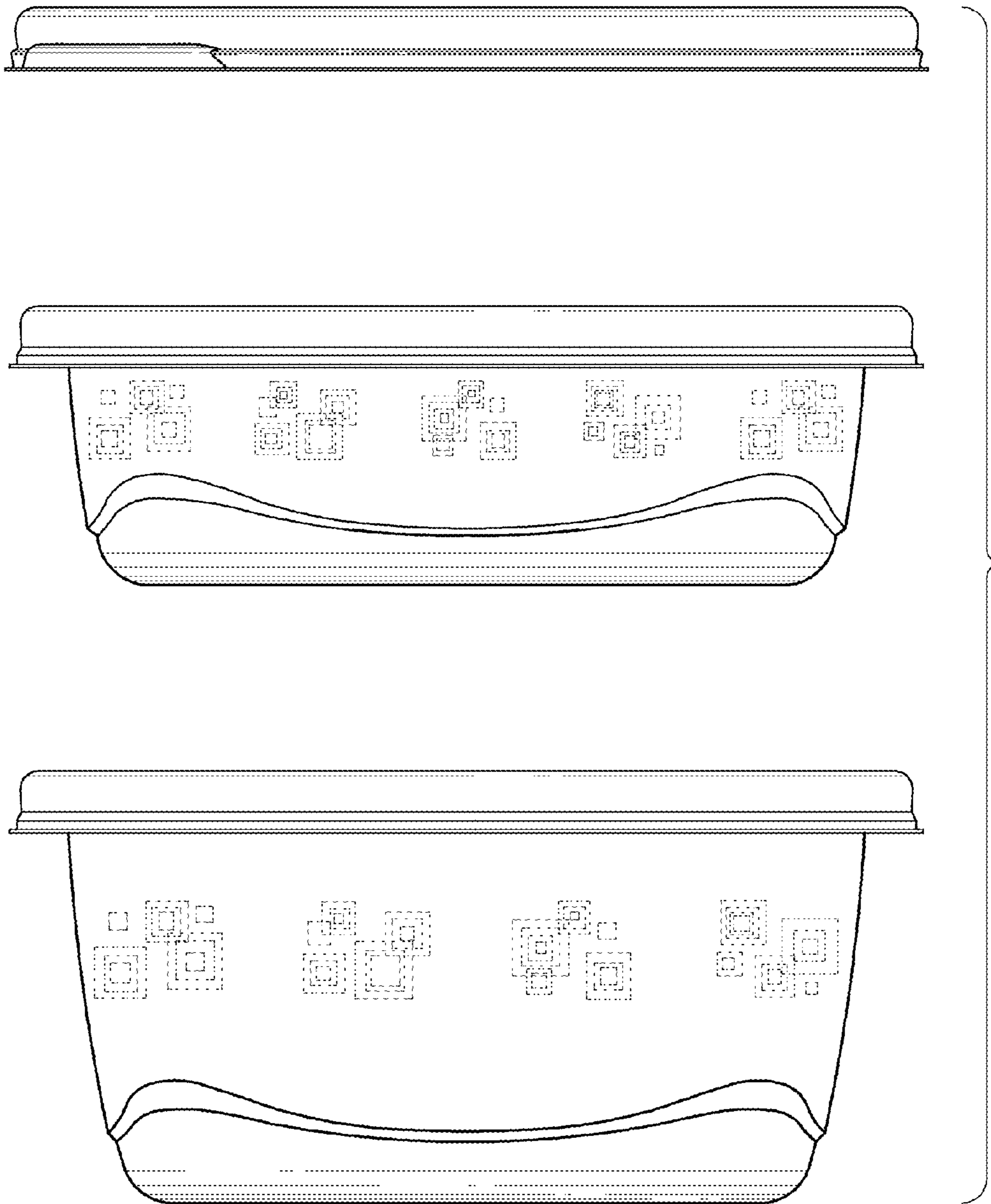
