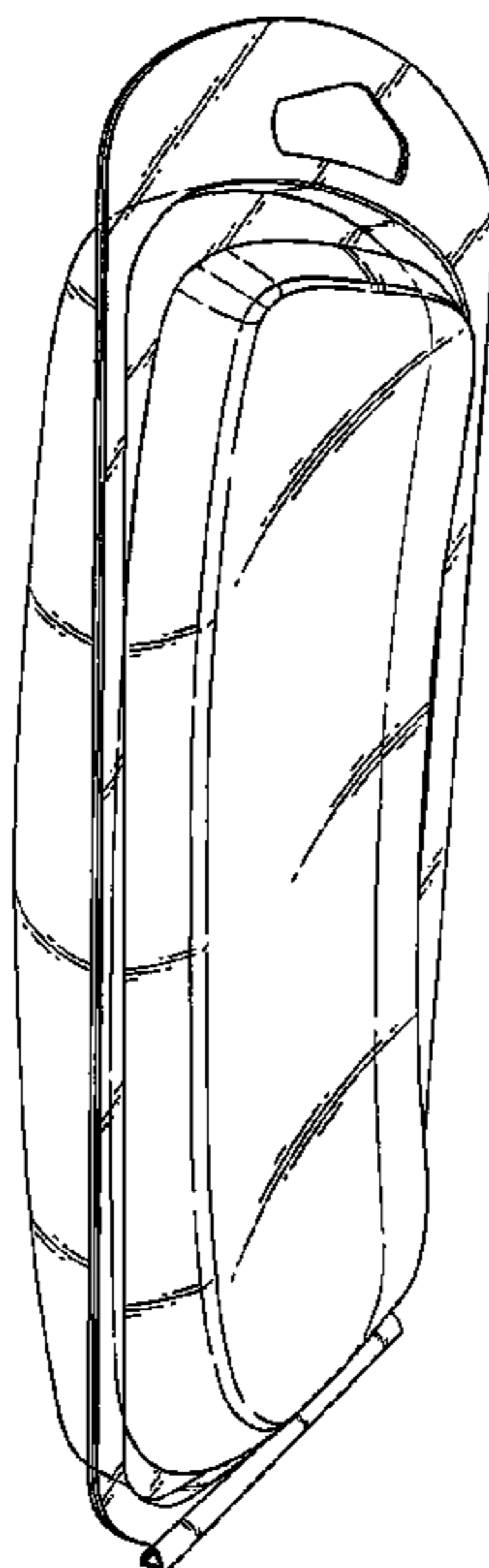
(57) **CLAIM**

The ornamental design for a blister pack, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the blister pack, showing the new design;  
FIG. 2 is a rear view thereof;  
FIG. 3 is left-side view thereof;  
FIG. 4 is a right-side view thereof;  
FIG. 5 is a bottom view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a rear, left side, and top perspective view thereof.  
The blister pack is symmetrical about a vertical axis, such that FIG. 4 is a mirror image of FIG. 3.

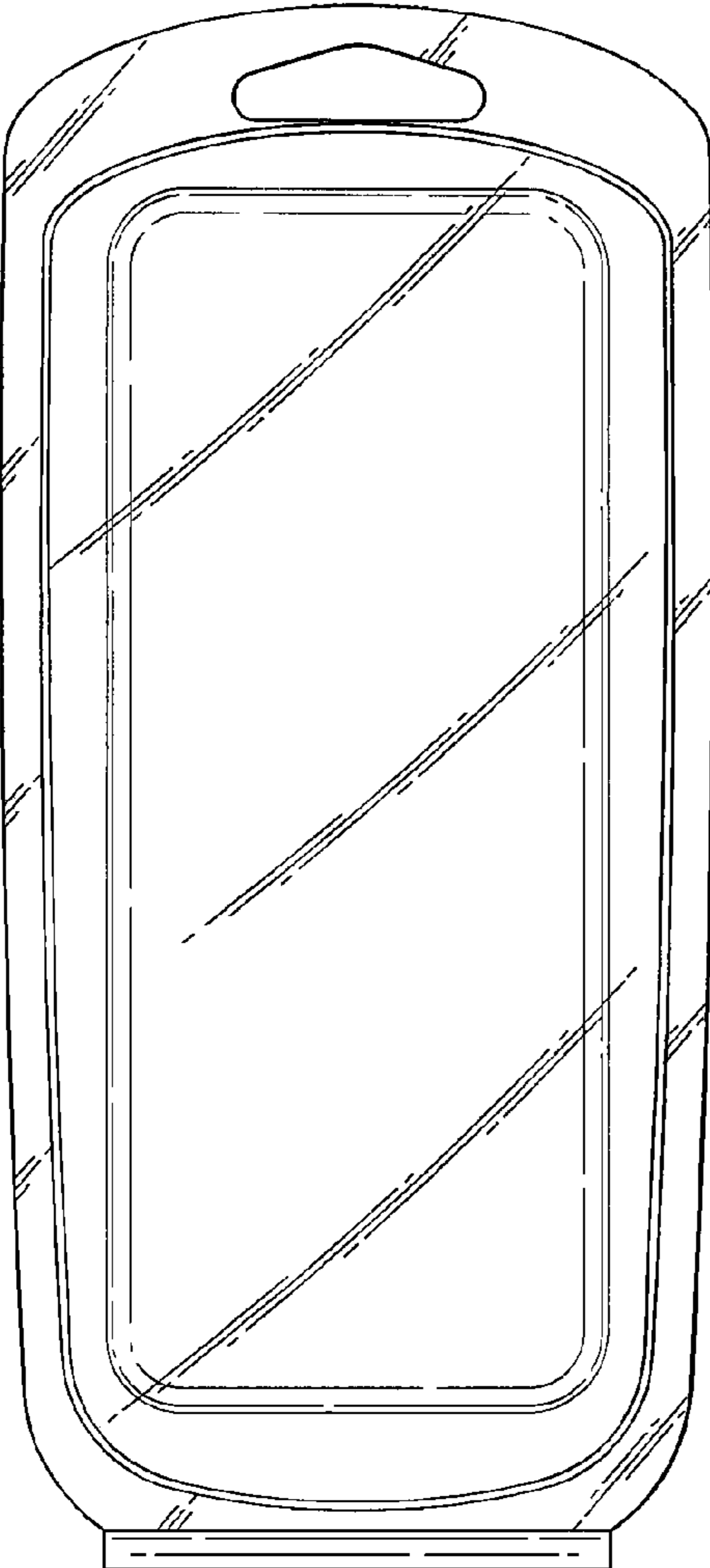

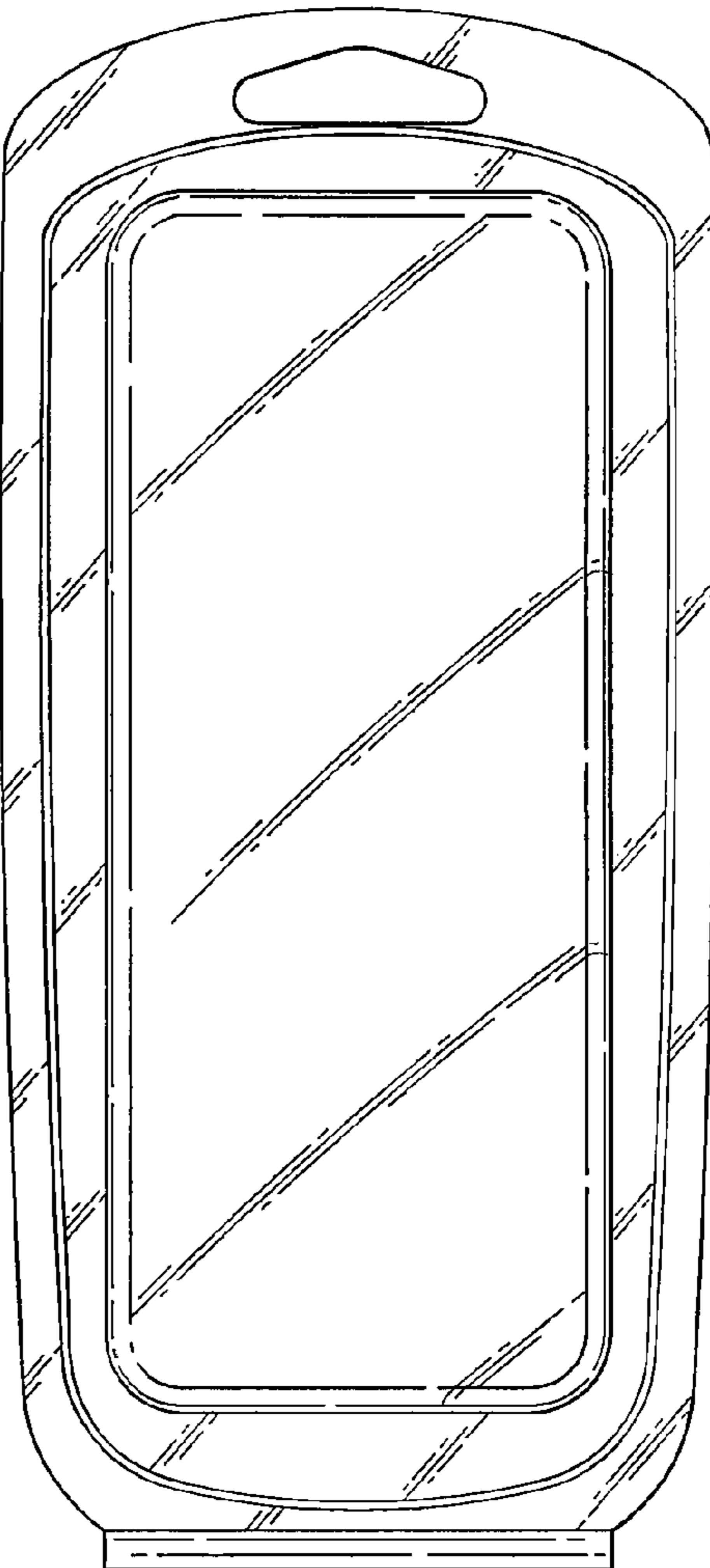

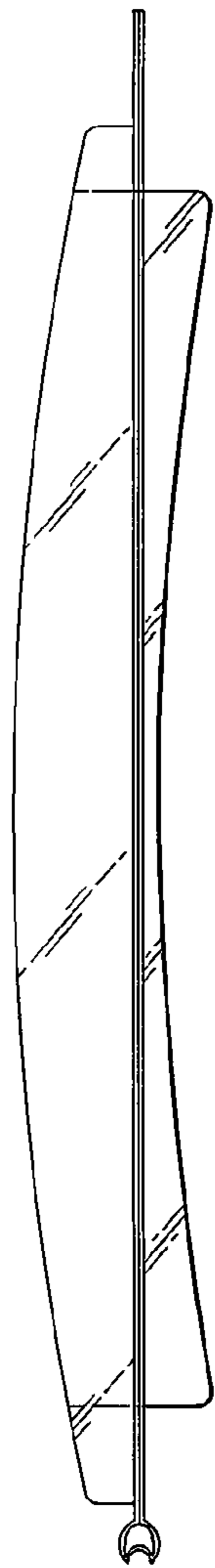

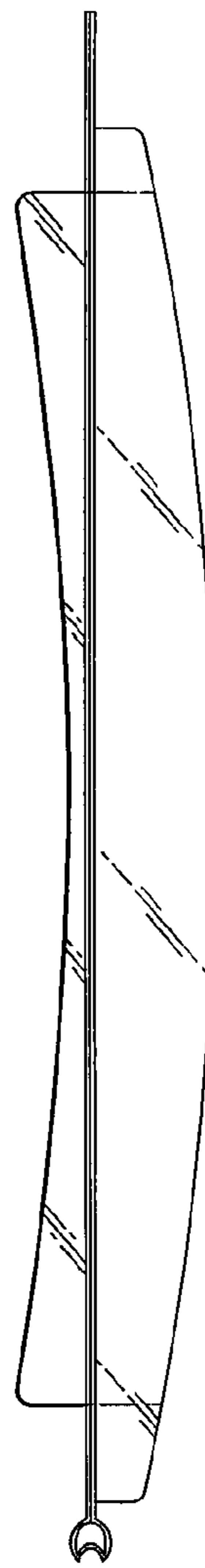

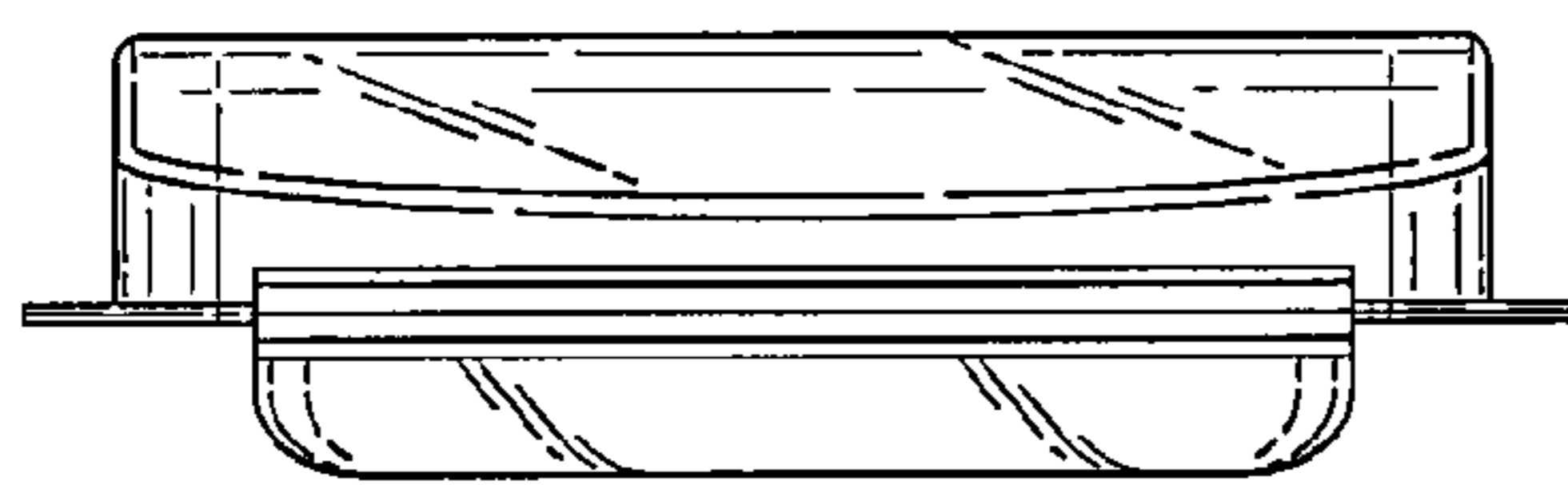

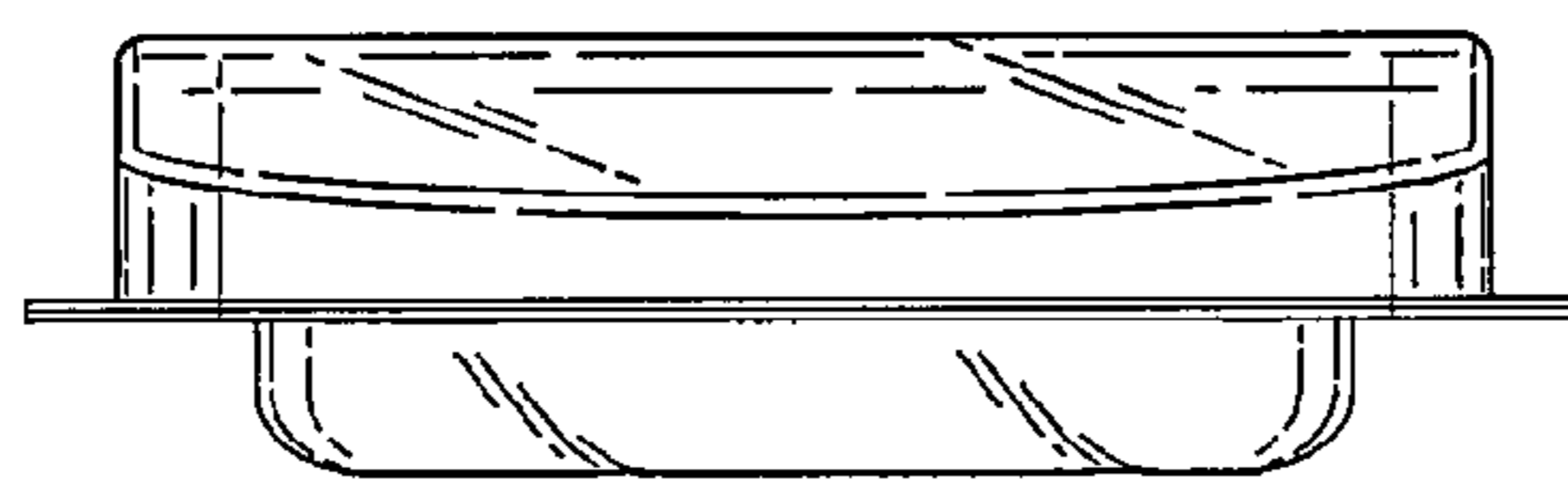

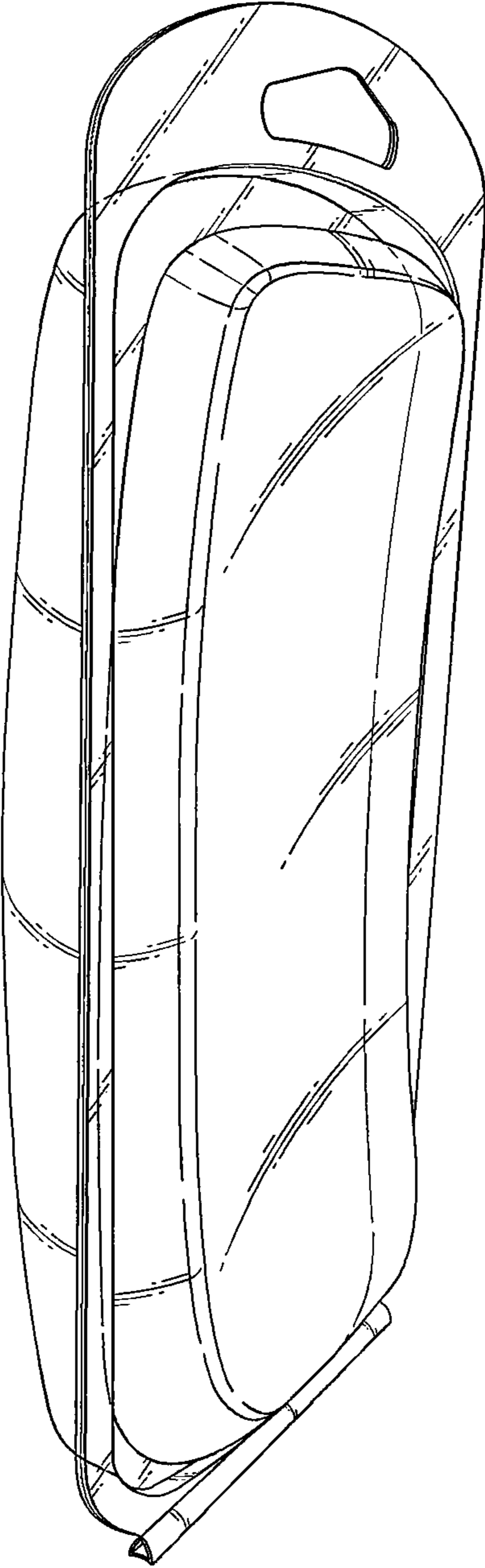
