FIG. 3 is a first side view thereof;

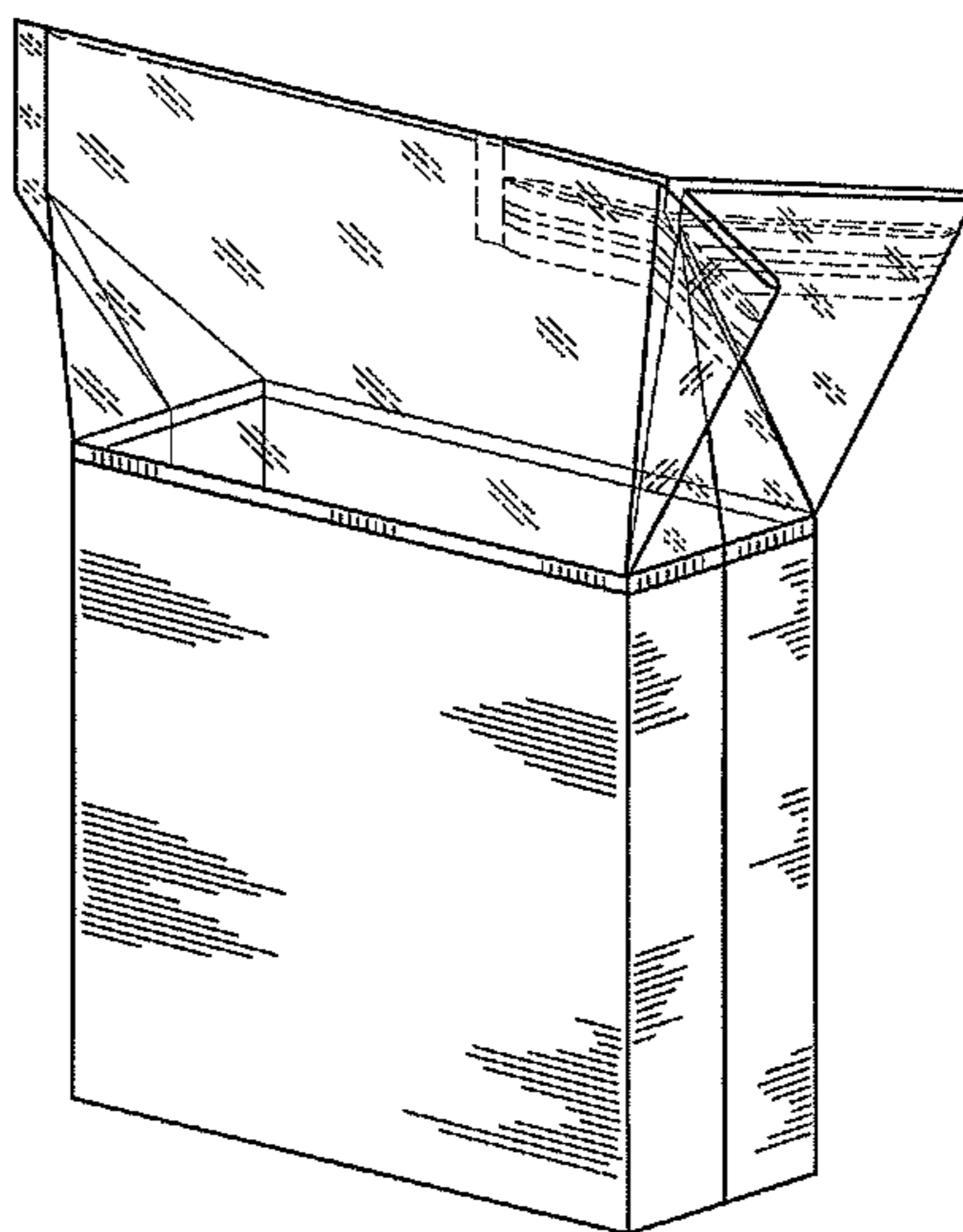
FIG. 4 is a second side view thereof;

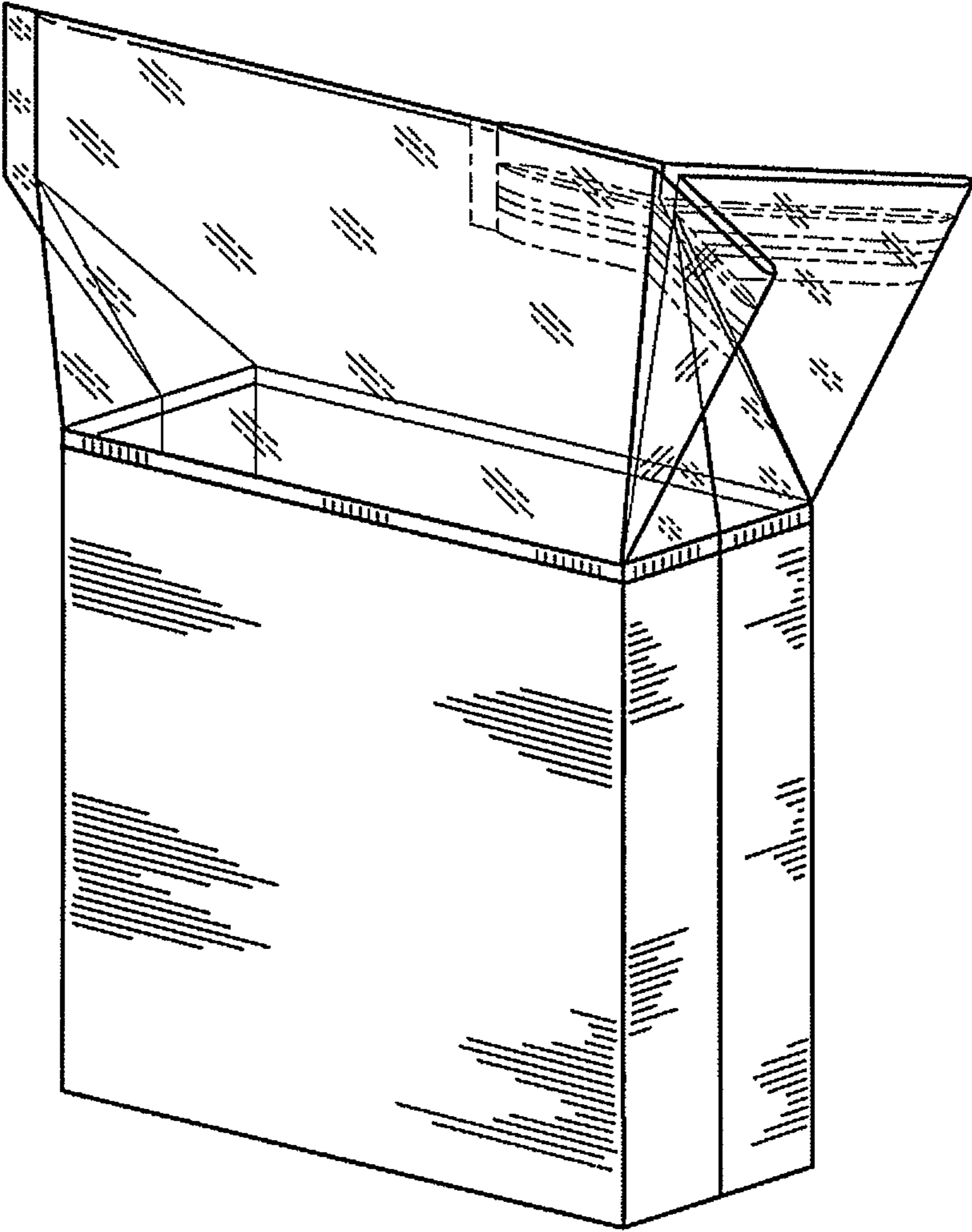

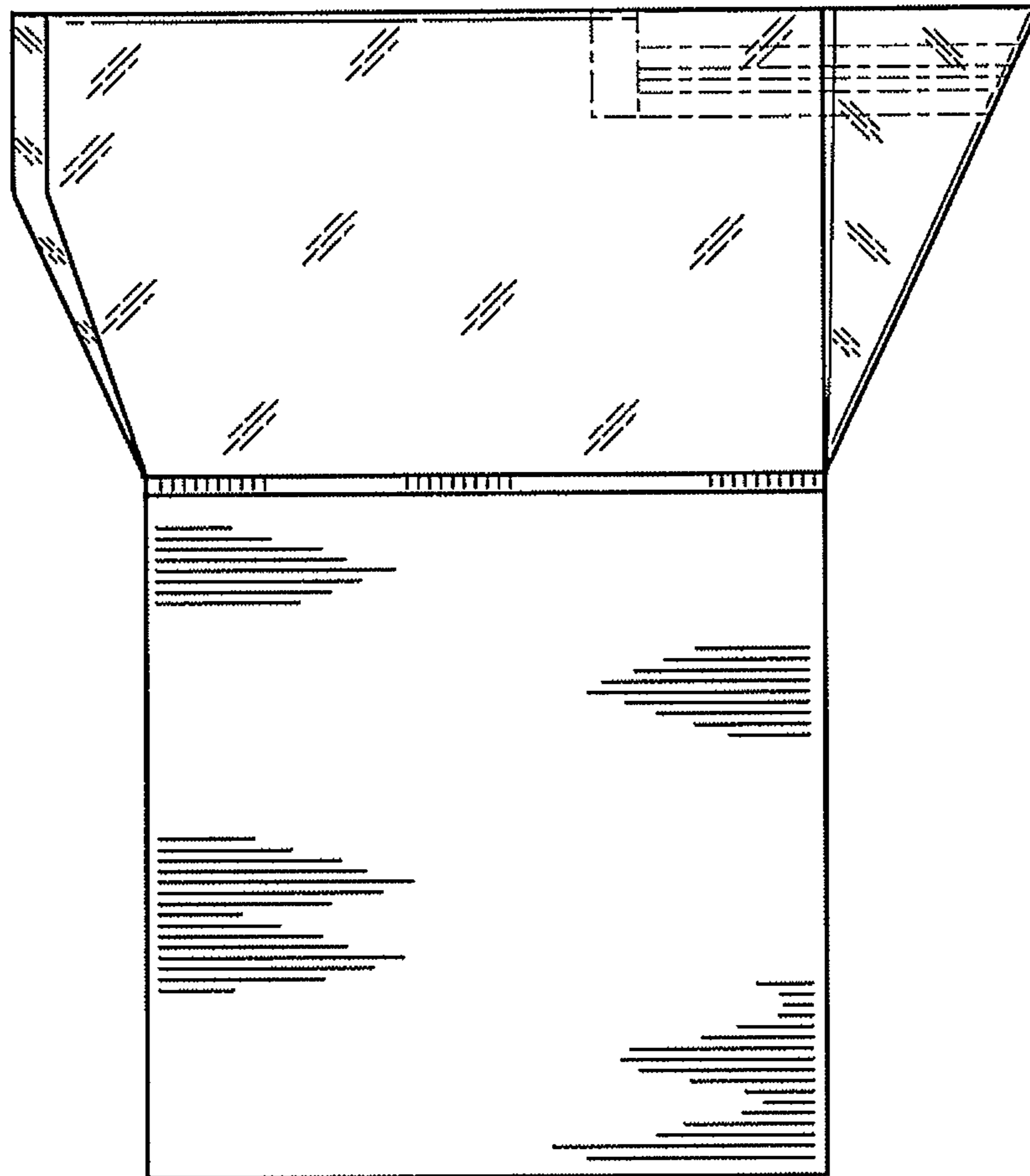

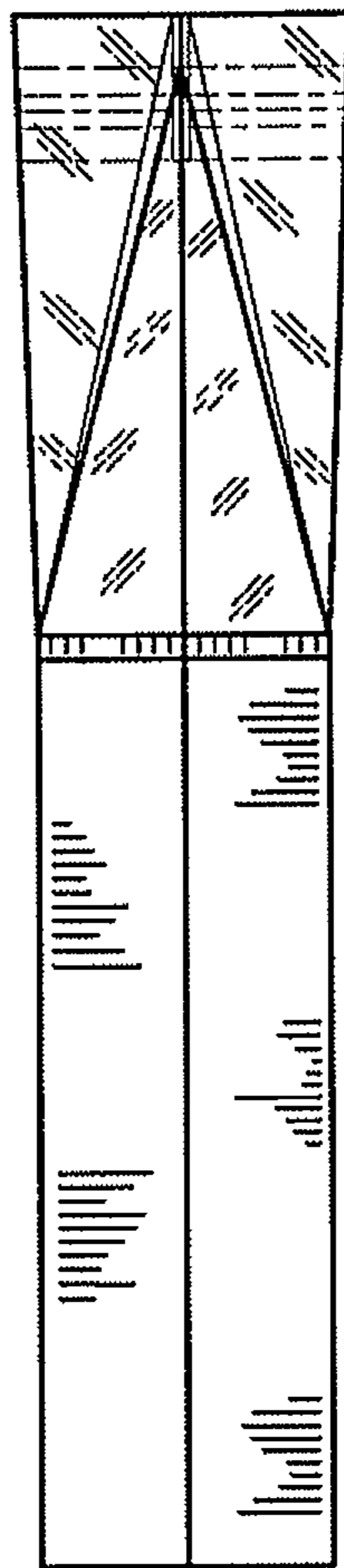

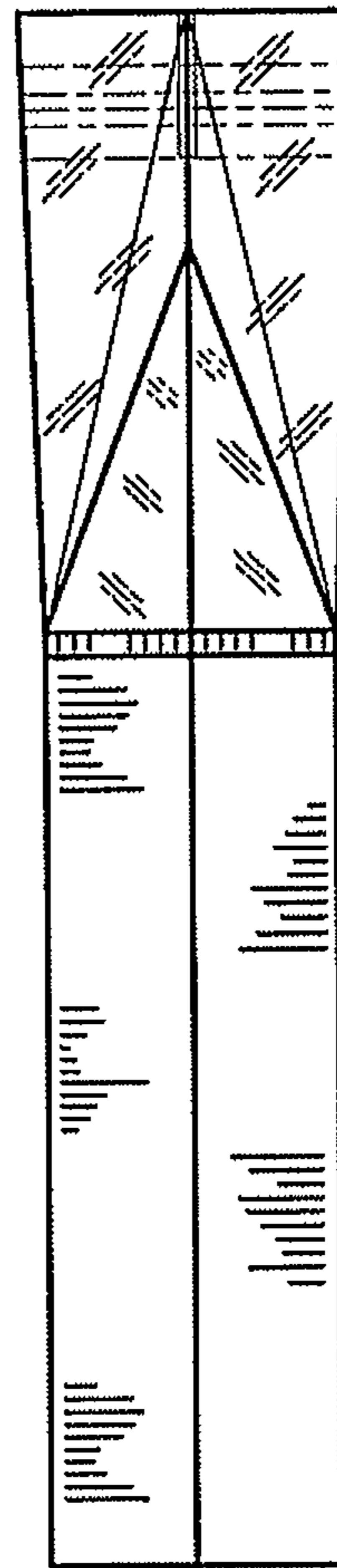

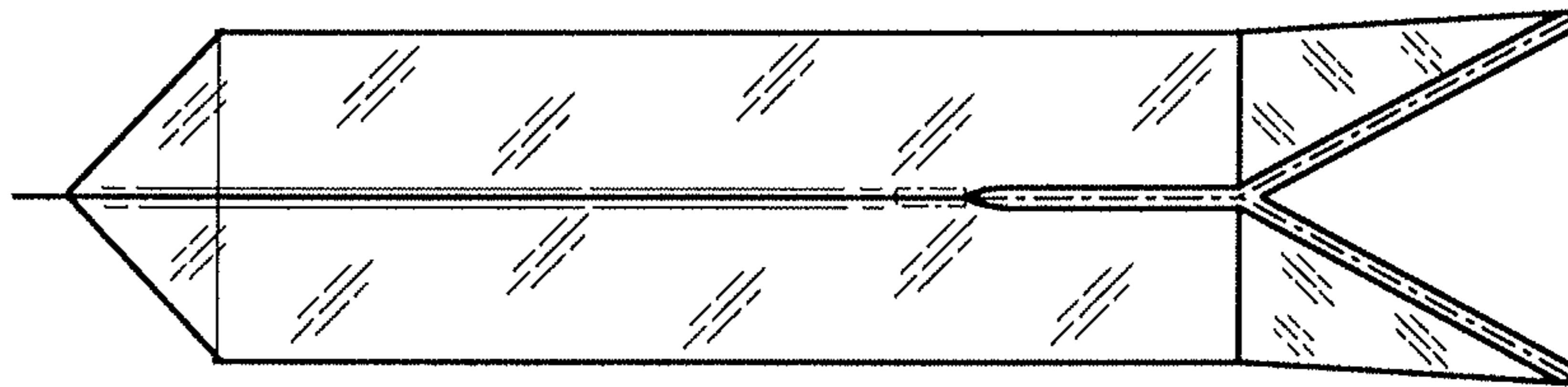

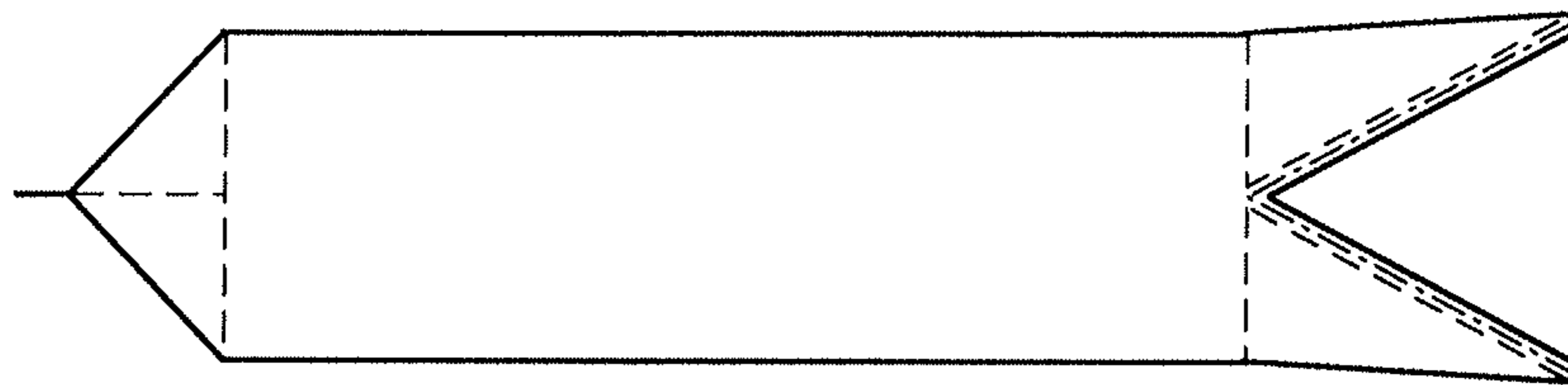
