DESCRIPTION

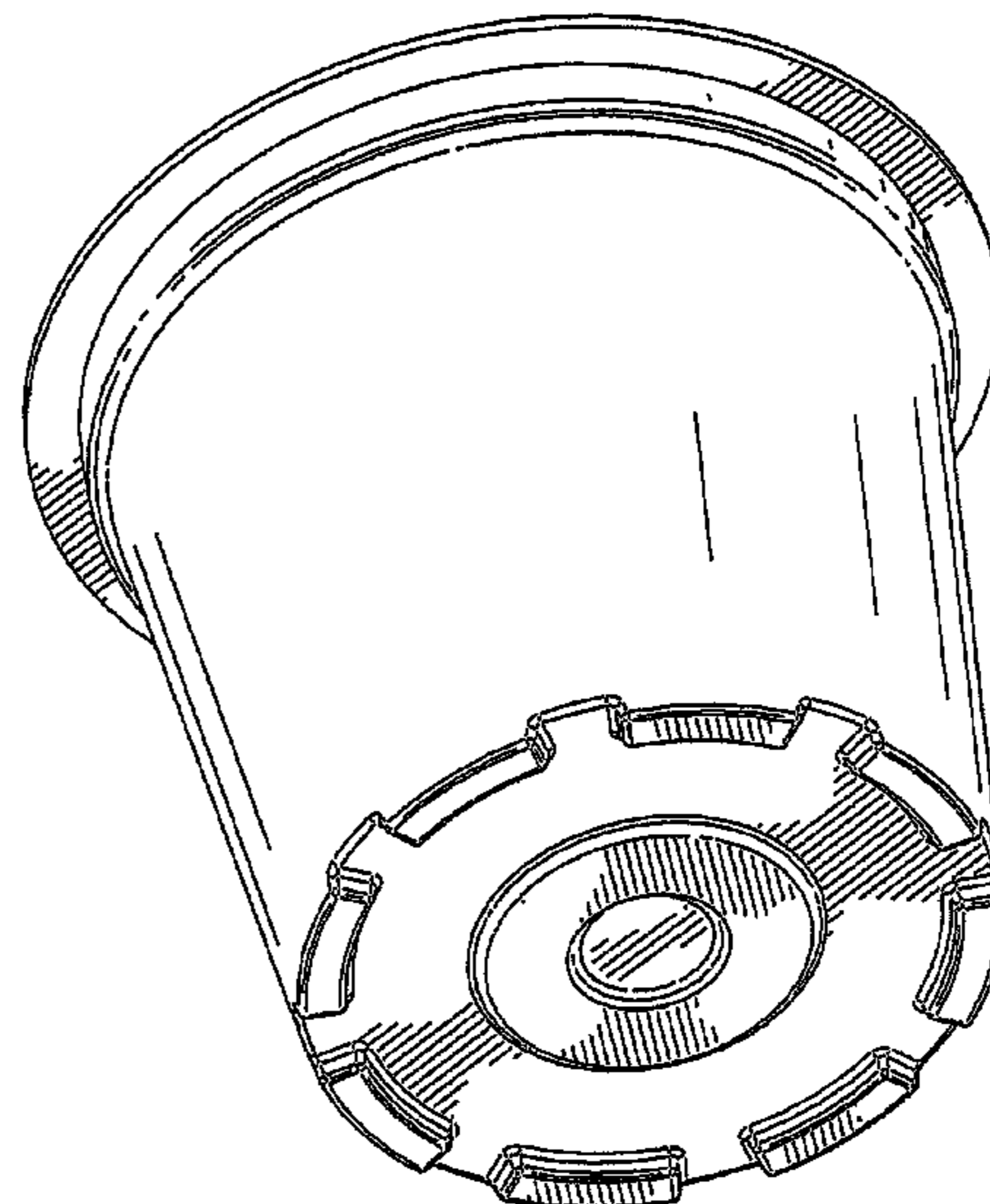
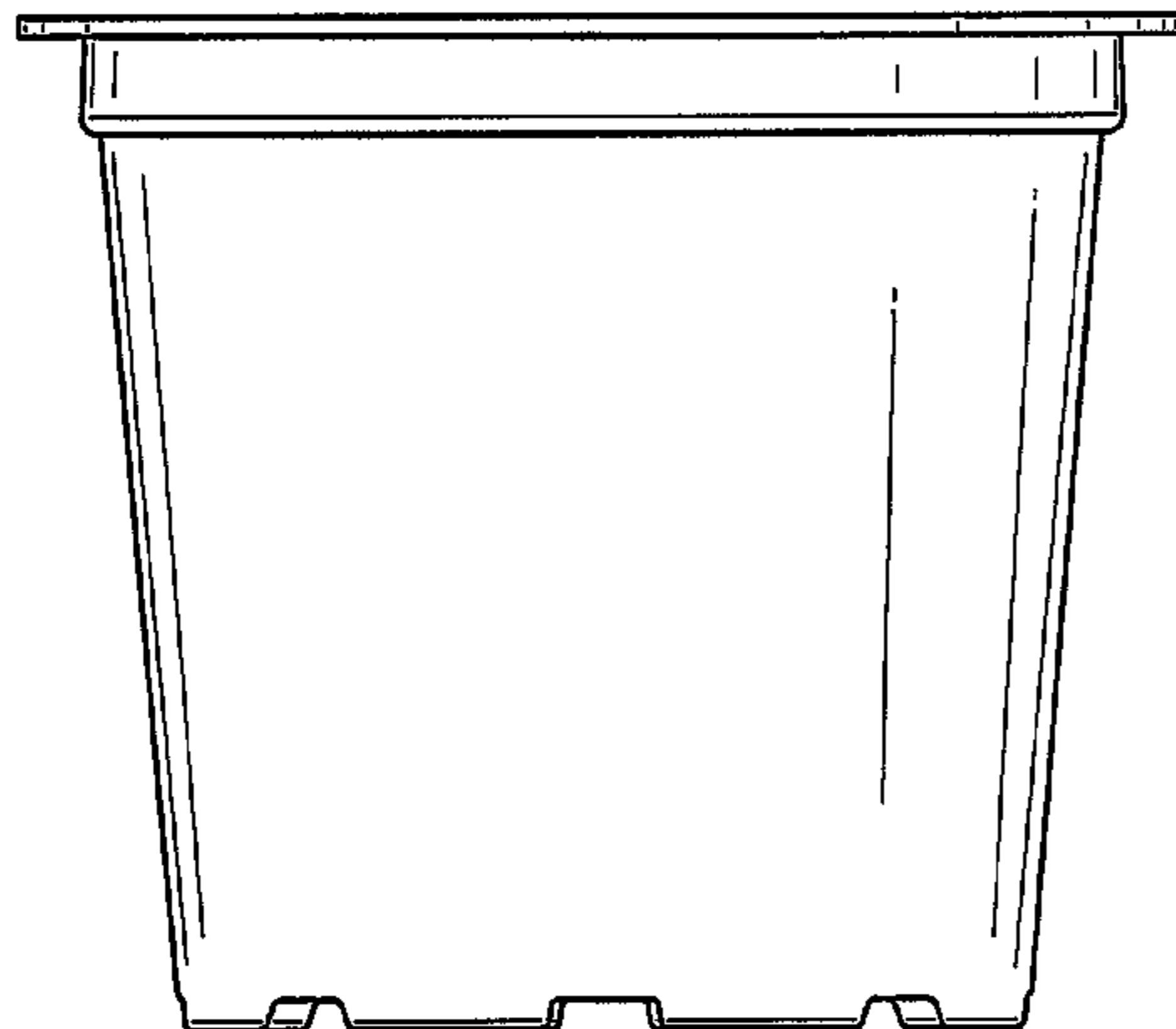
FIG. 1 is a side view of a container with castle shaped base of my new design;

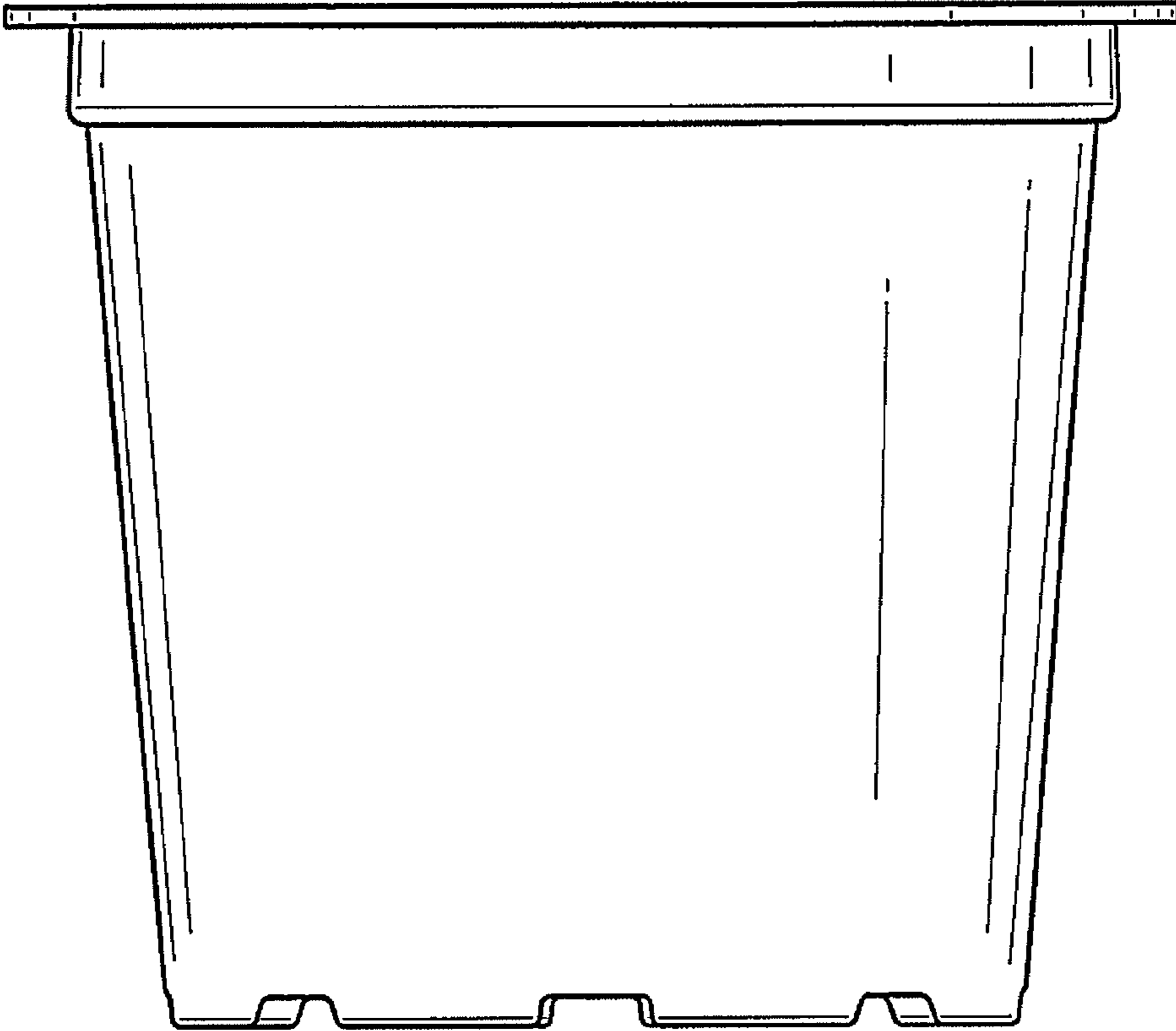

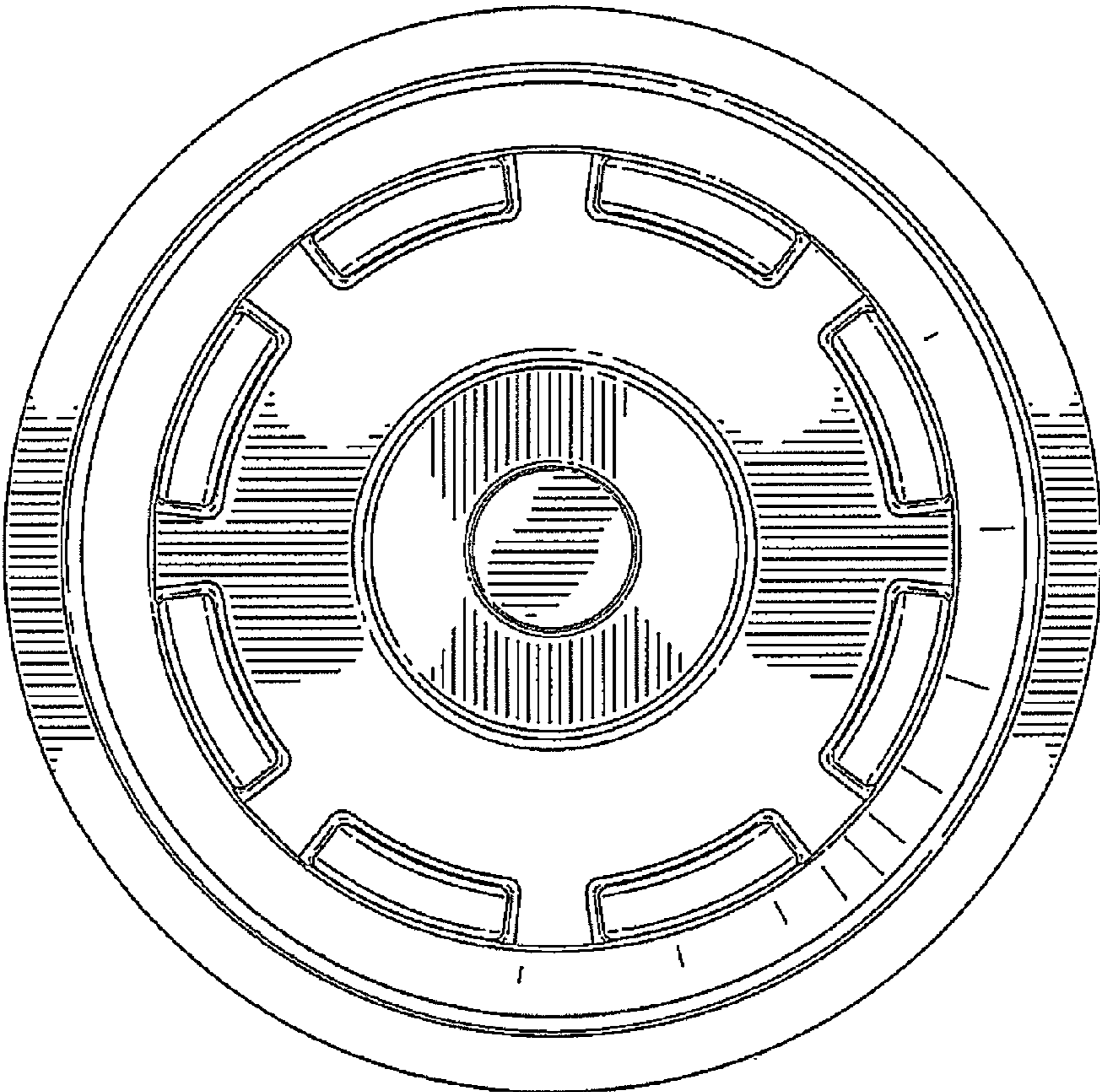

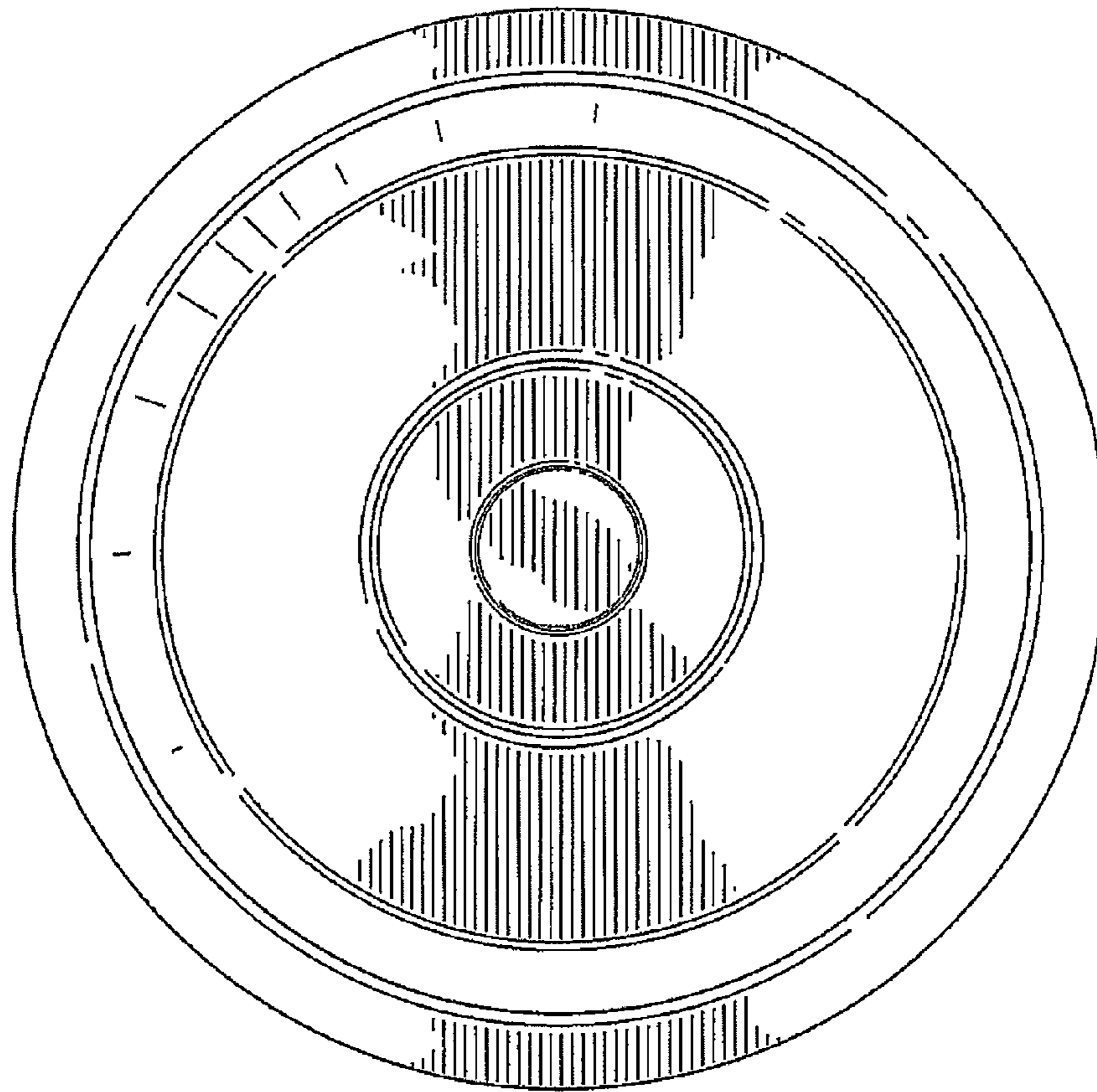

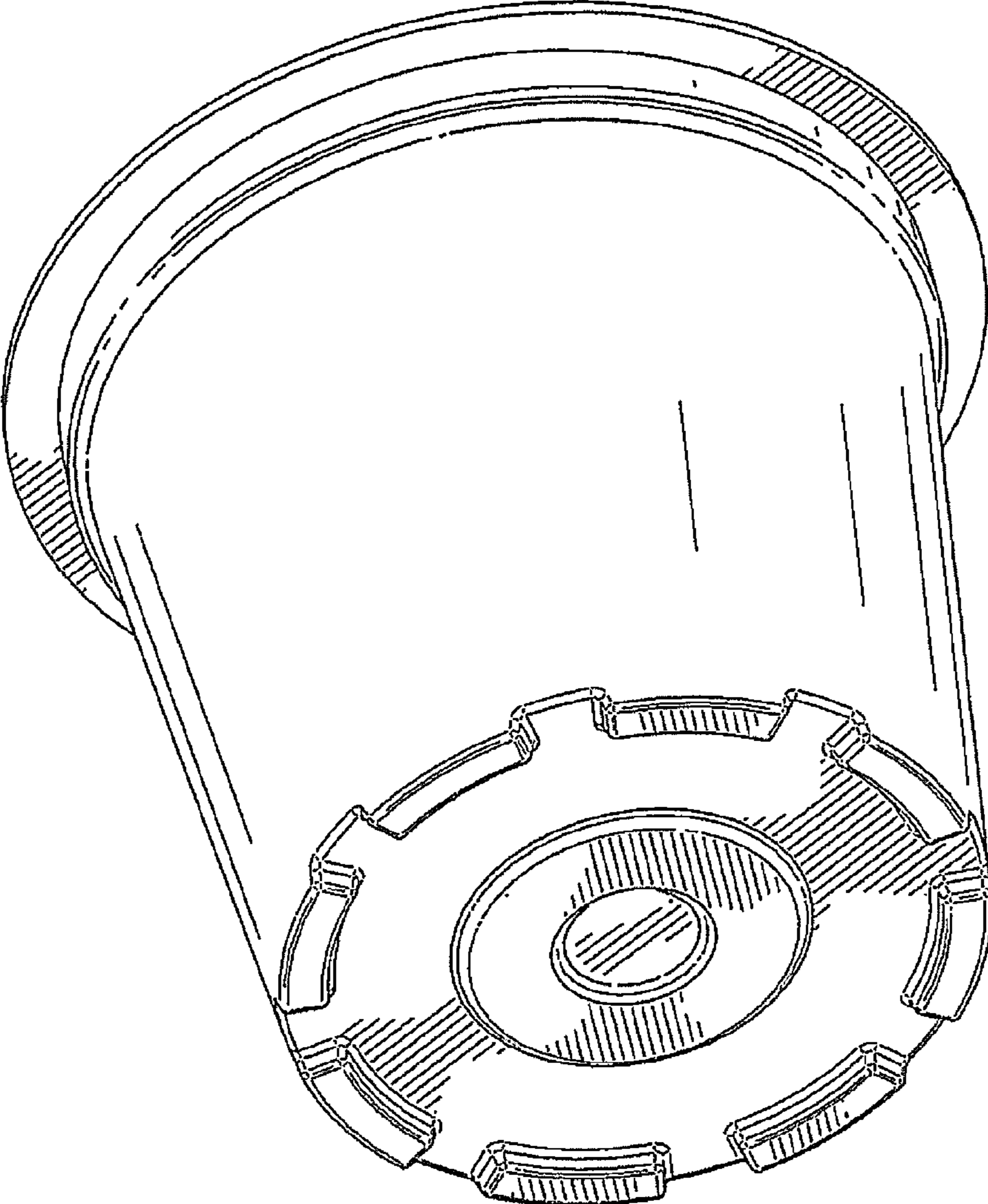
