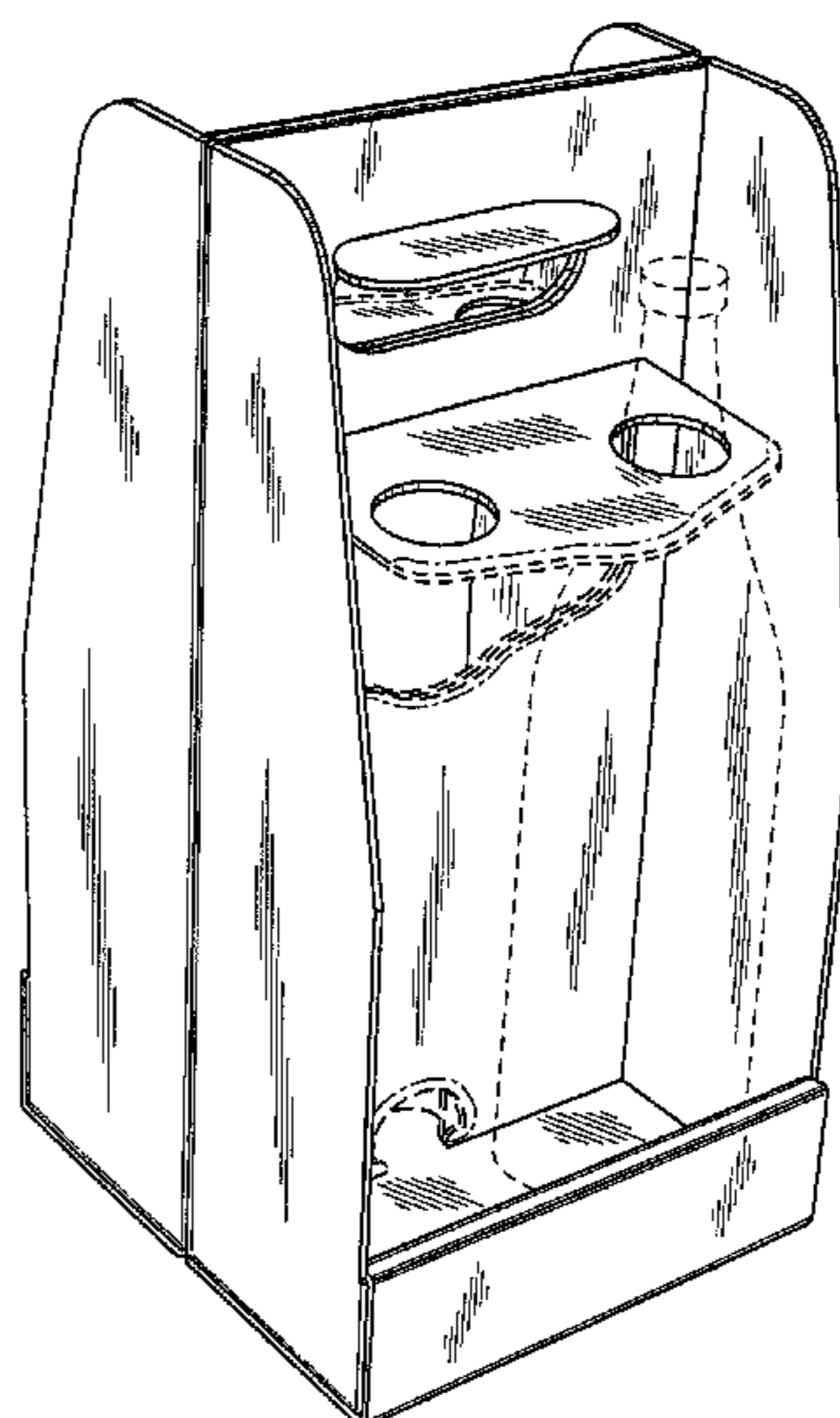

(57) **CLAIM**
We claim the ornamental design for a carrier for beer bottles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a carrier for beer bottles showing our new design.
FIG. 2 is an end elevational view thereof.
FIG. 3 is a front elevational view thereof.
FIG. 4 is a rear elevational view thereof.
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

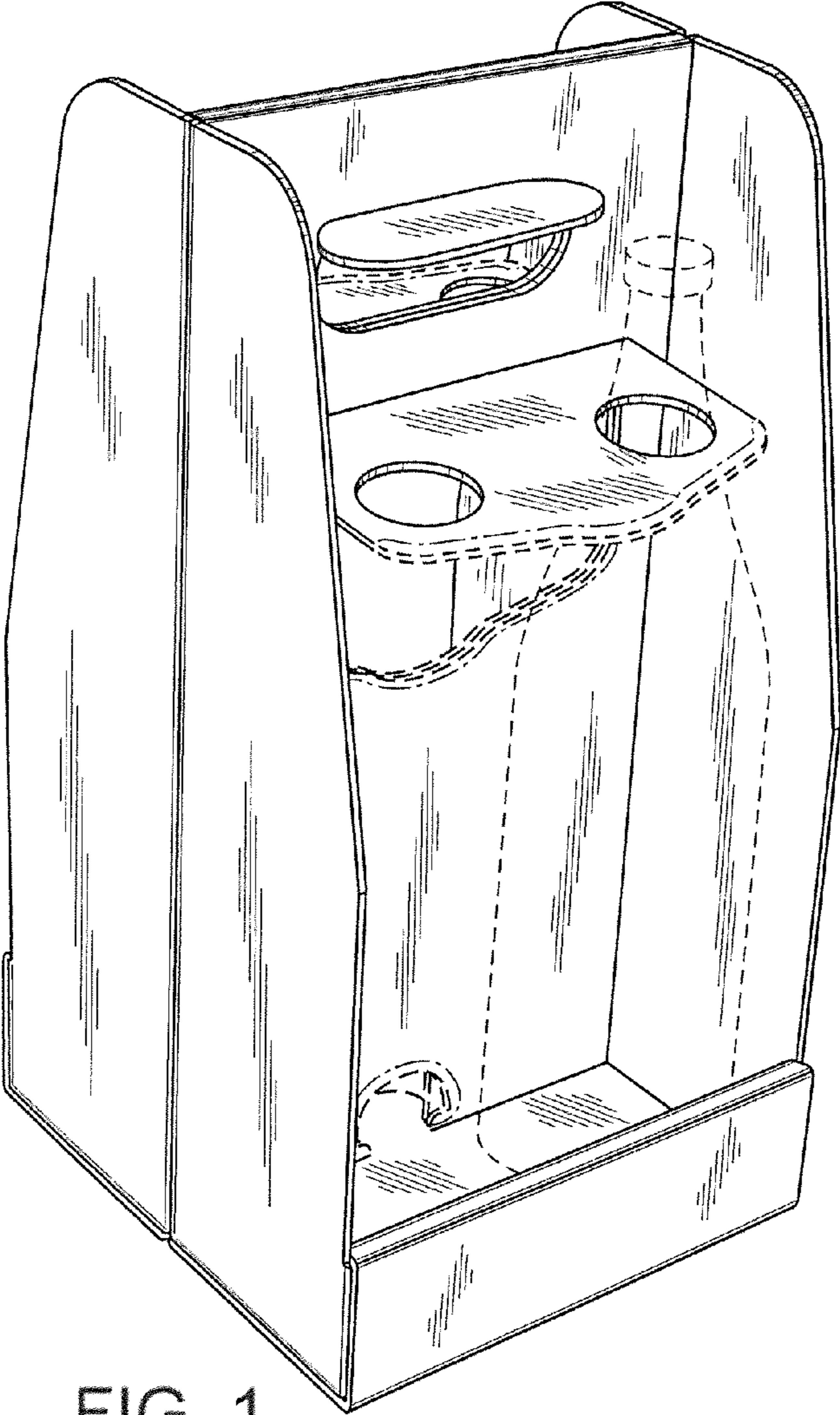

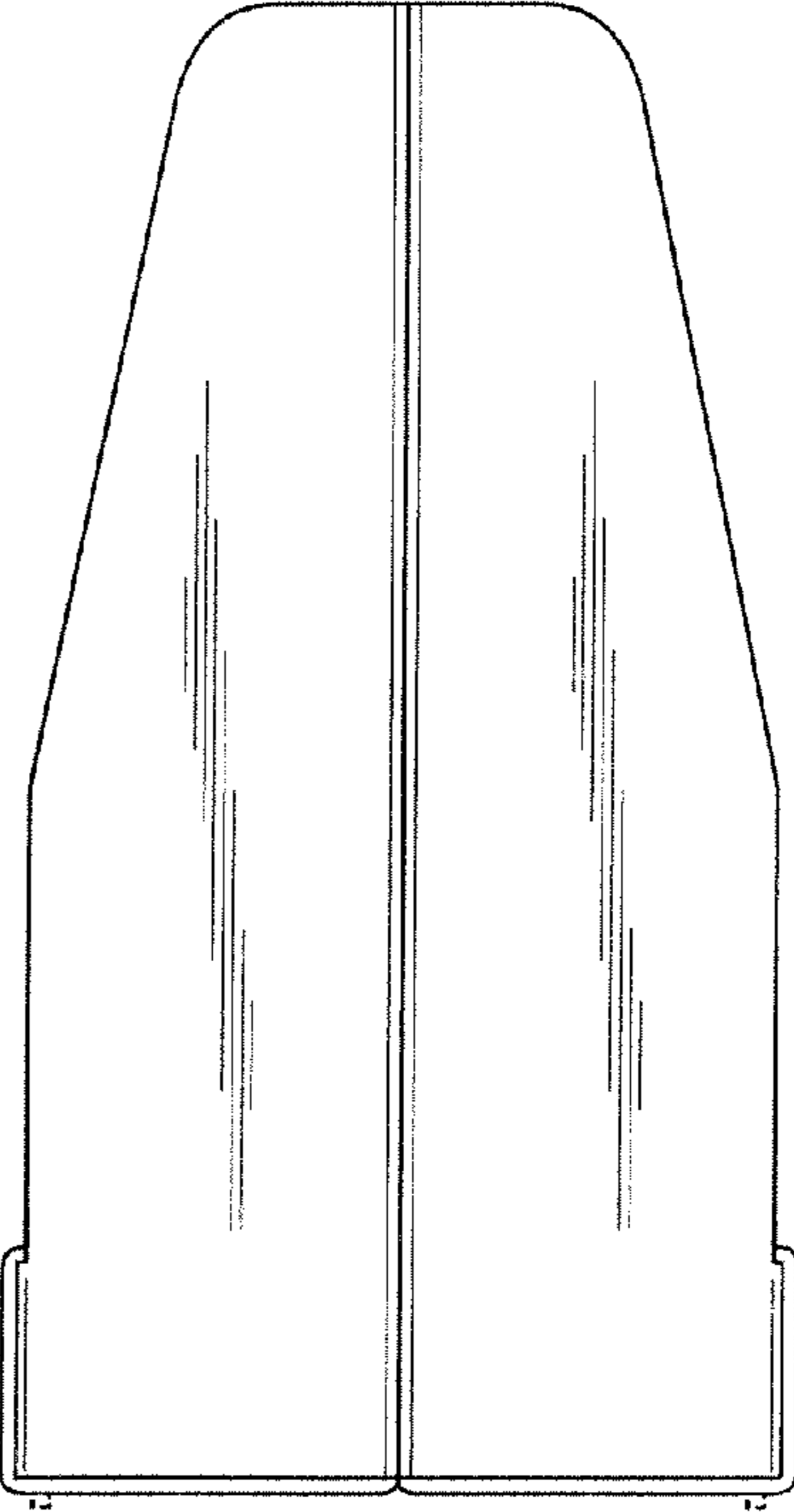

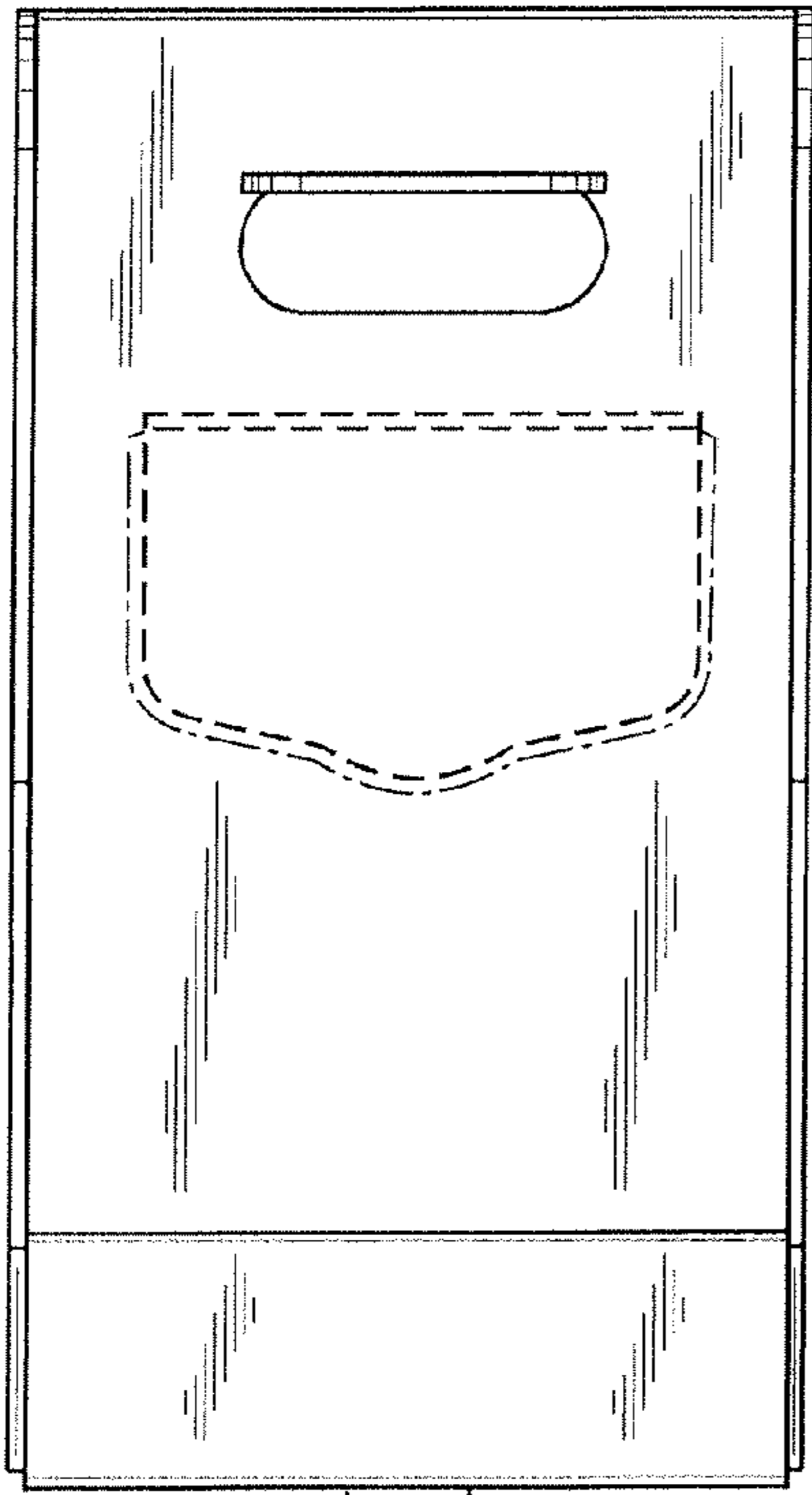

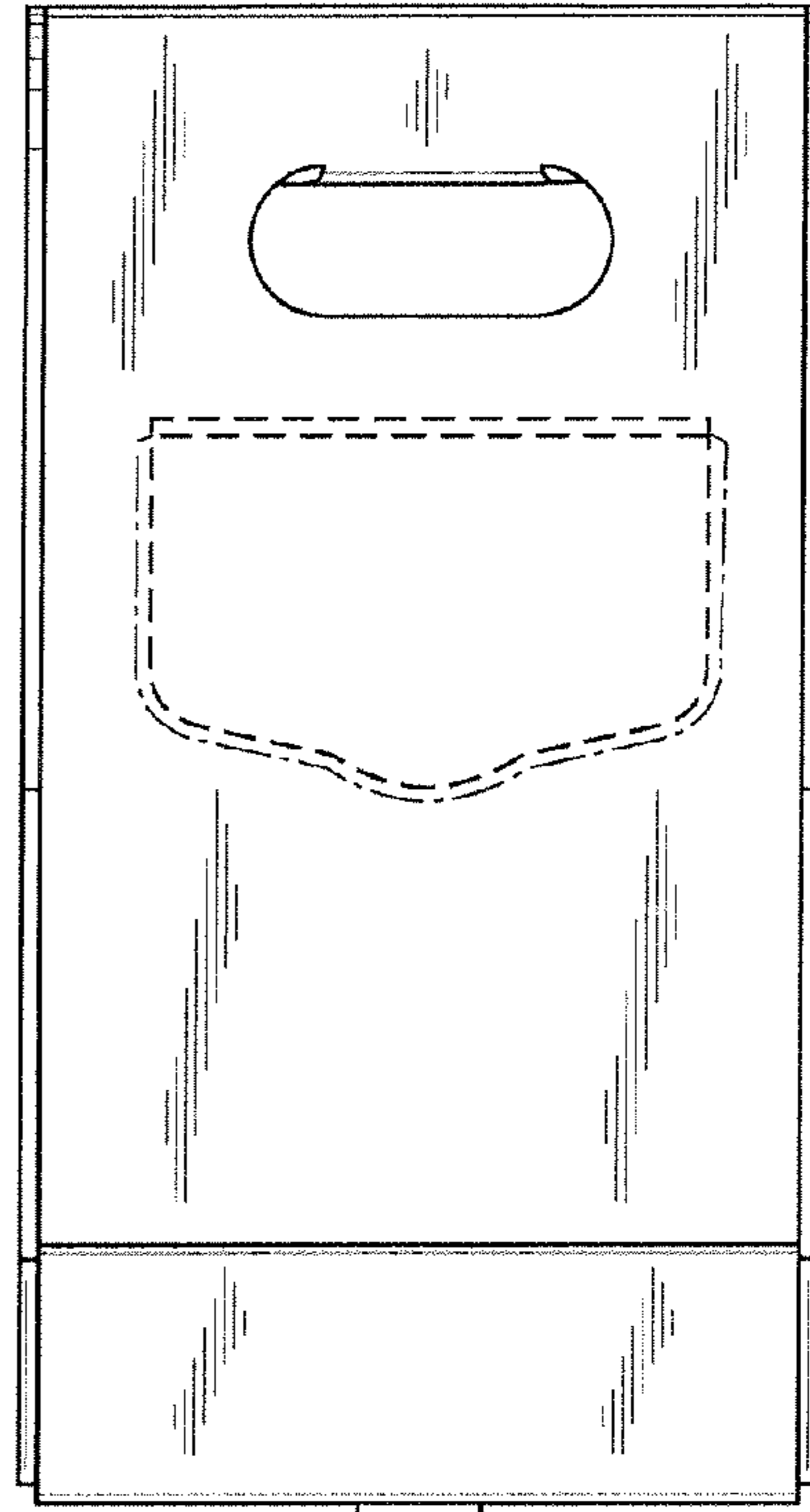

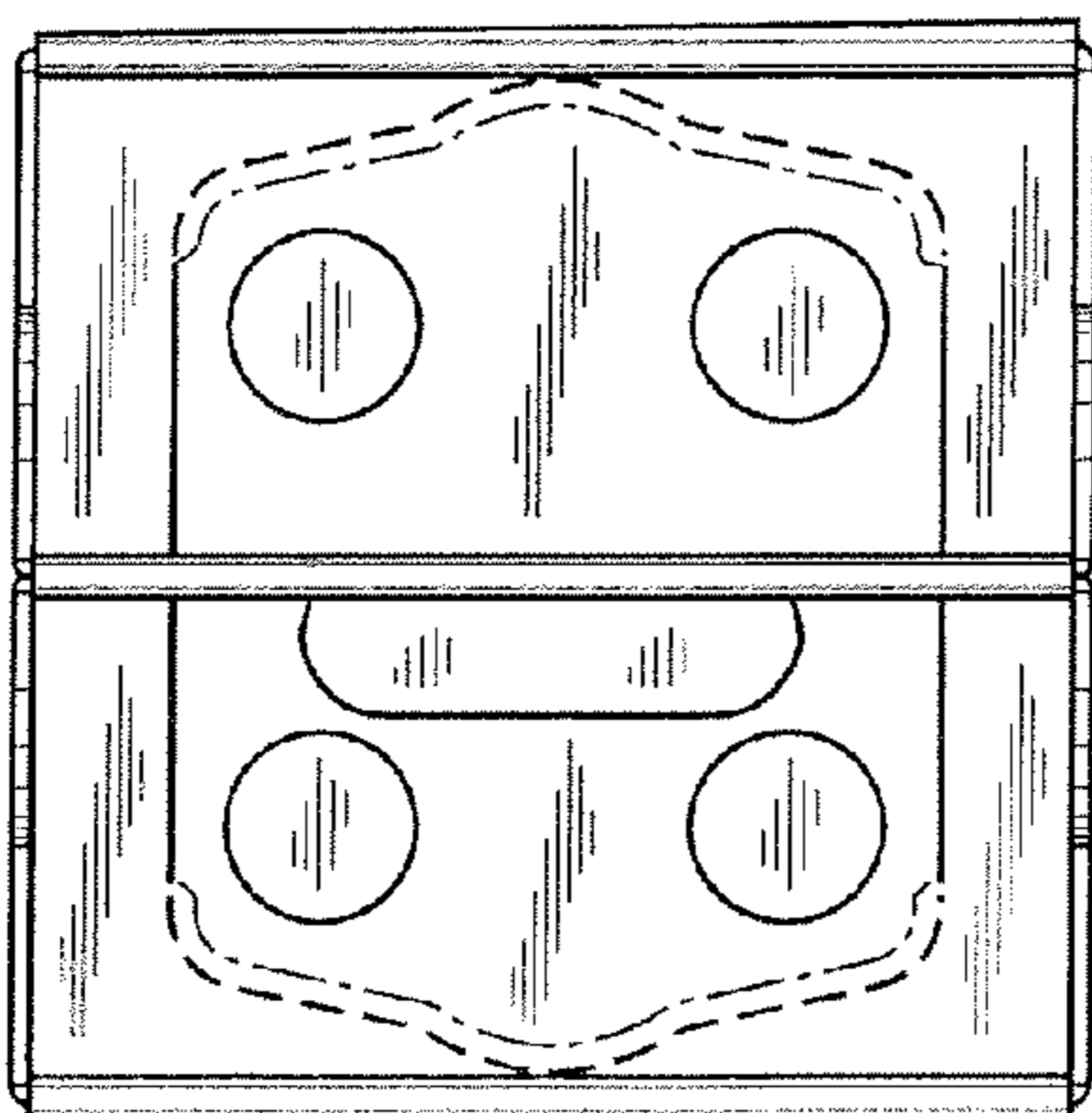

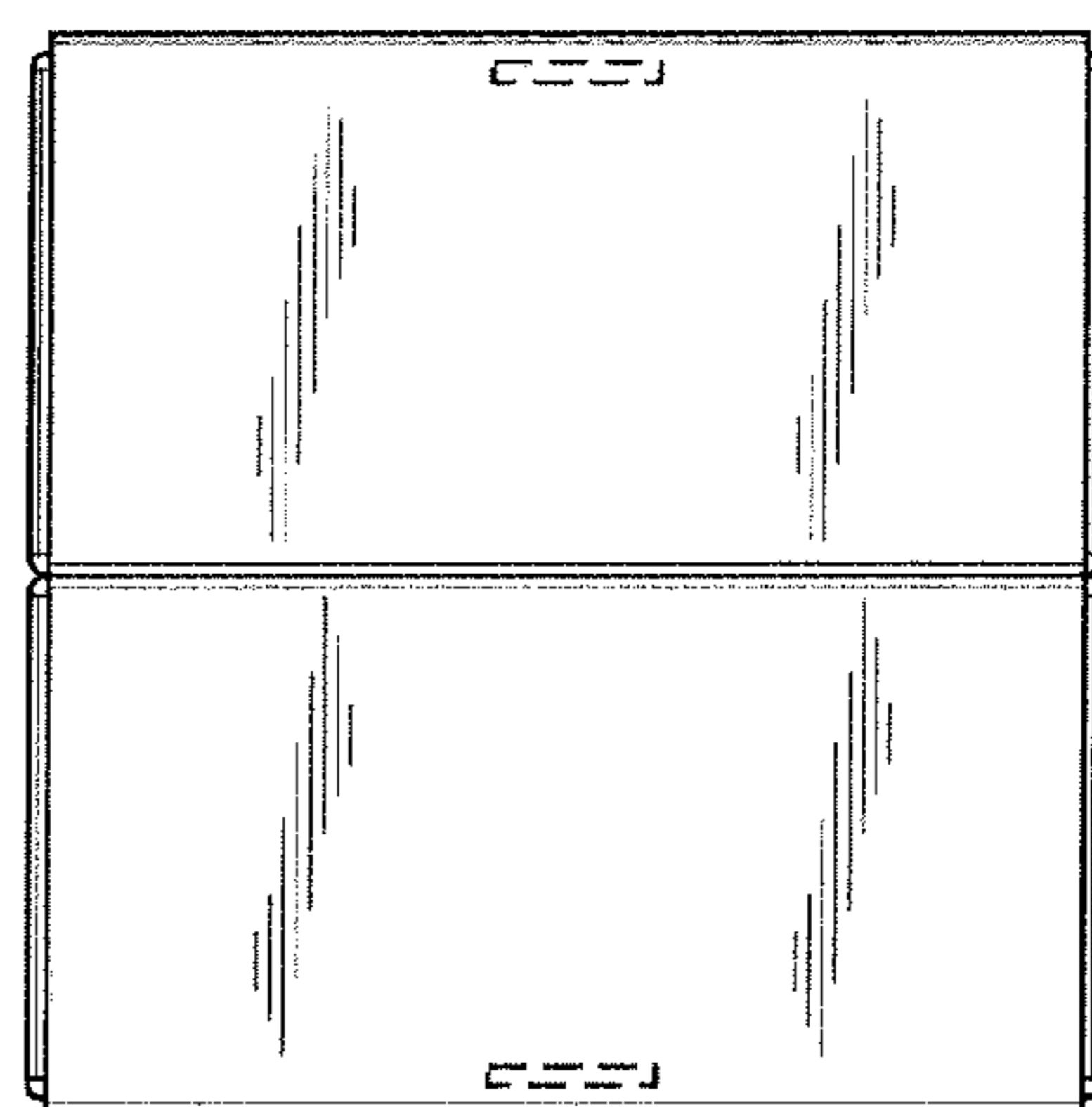
