(57) **CLAIM**

The ornamental design for a thermometer with cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a thermometer with cover constructed in accordance with an embodiment of the present invention;

FIG. 2 is a back perspective view of the thermometer with cover of FIG. 1;

FIG. 3 is a front view of the thermometer with cover of FIG. 1;

FIG. 4 is a back view of the thermometer with cover of FIG. 1;

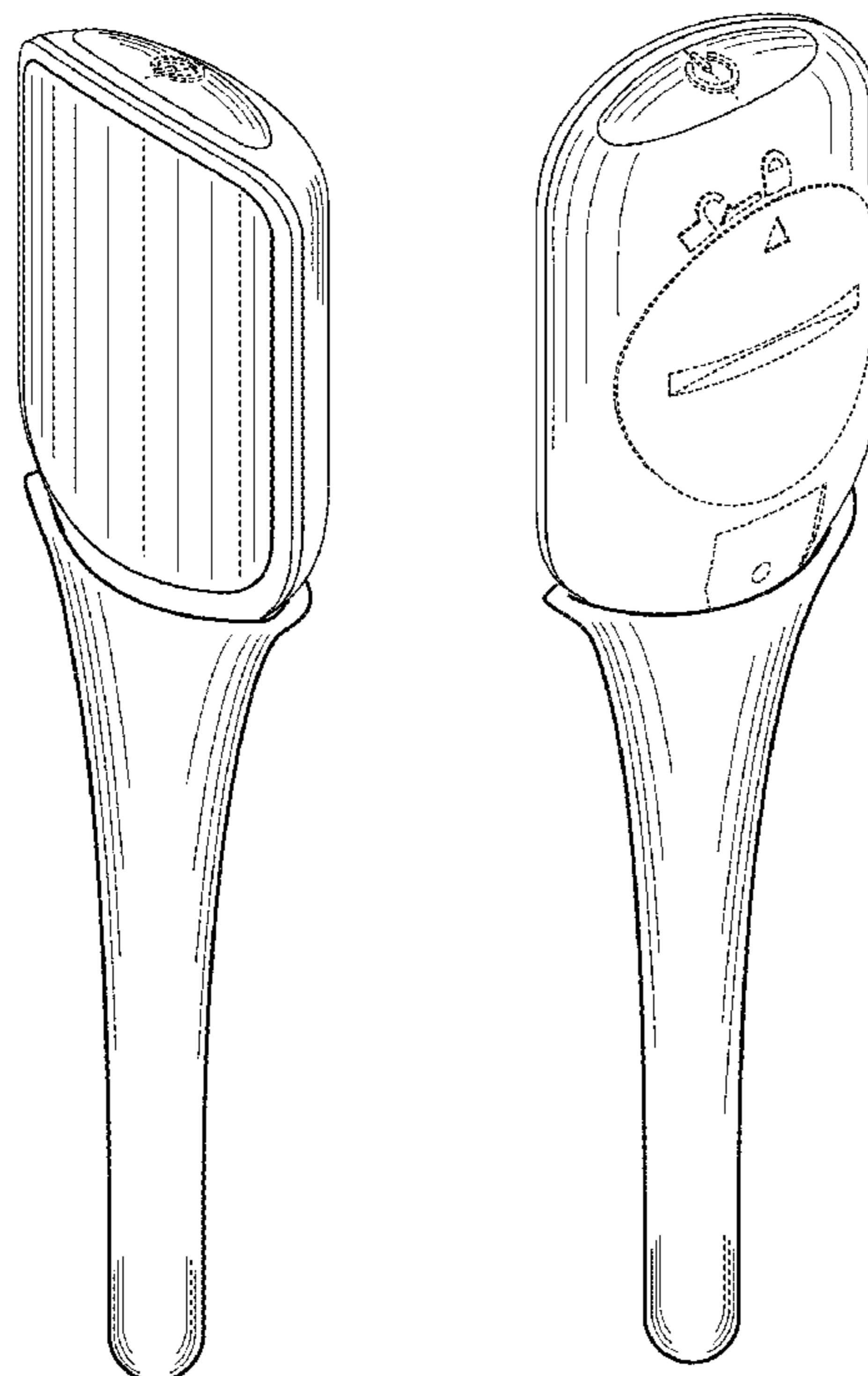
FIG. 5 is a top view of the thermometer with cover of FIG. 1; FIG. 6 is a left side view of the thermometer with cover of FIG. 1;

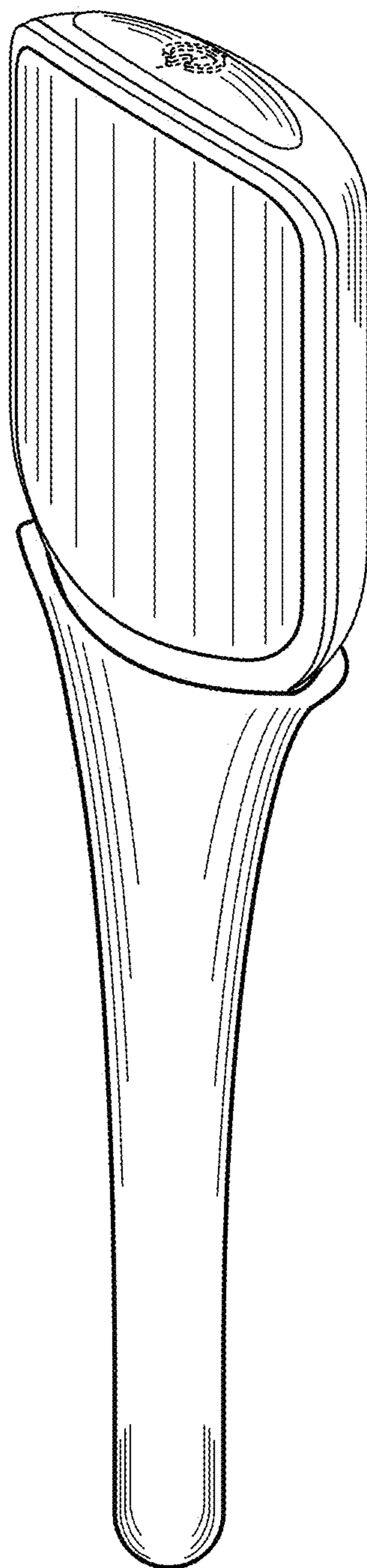

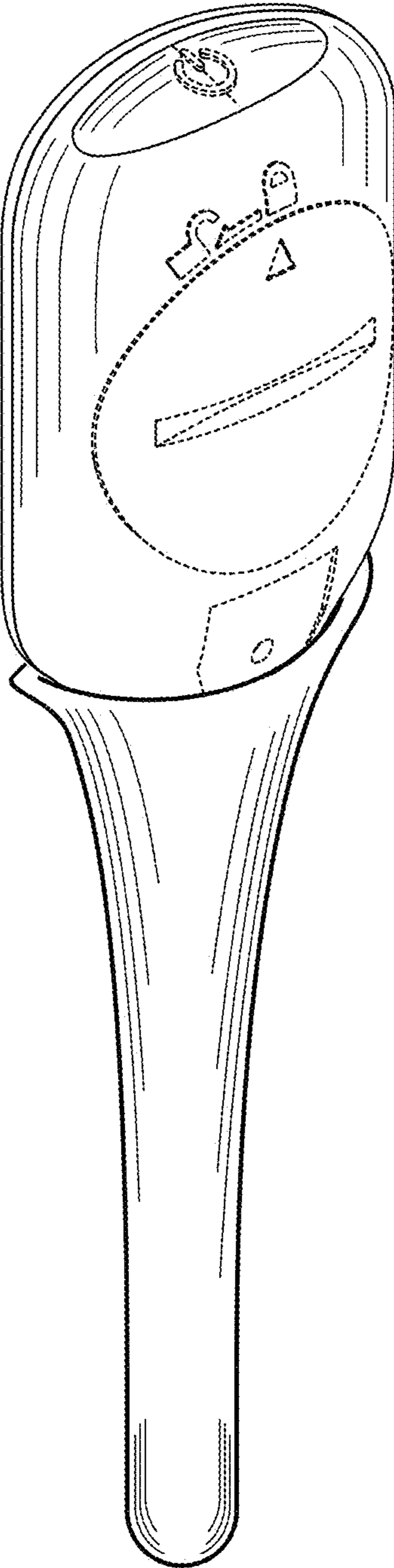

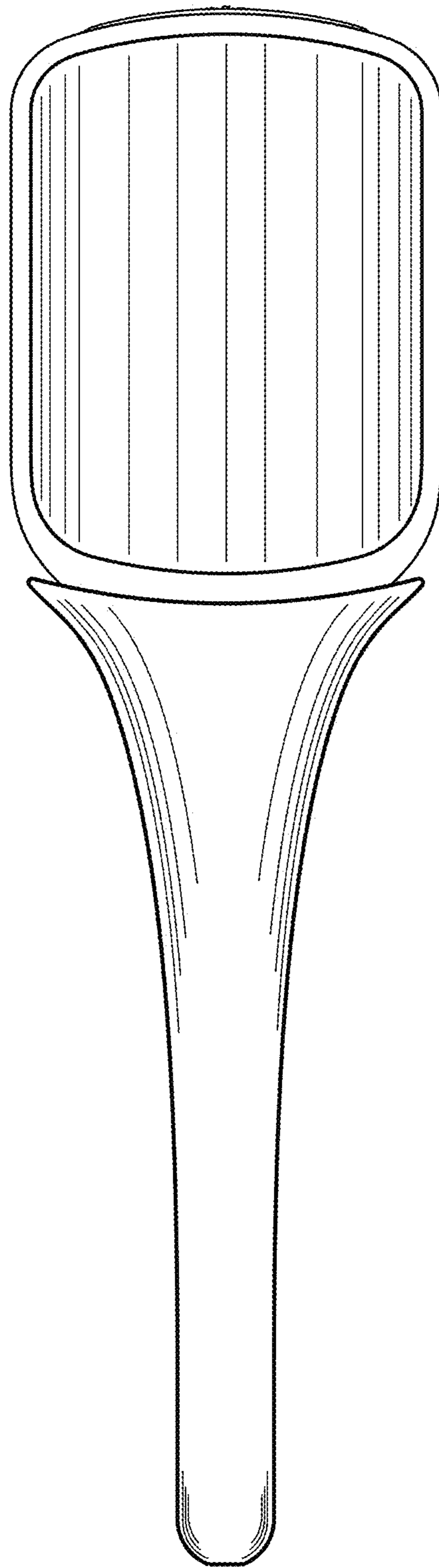

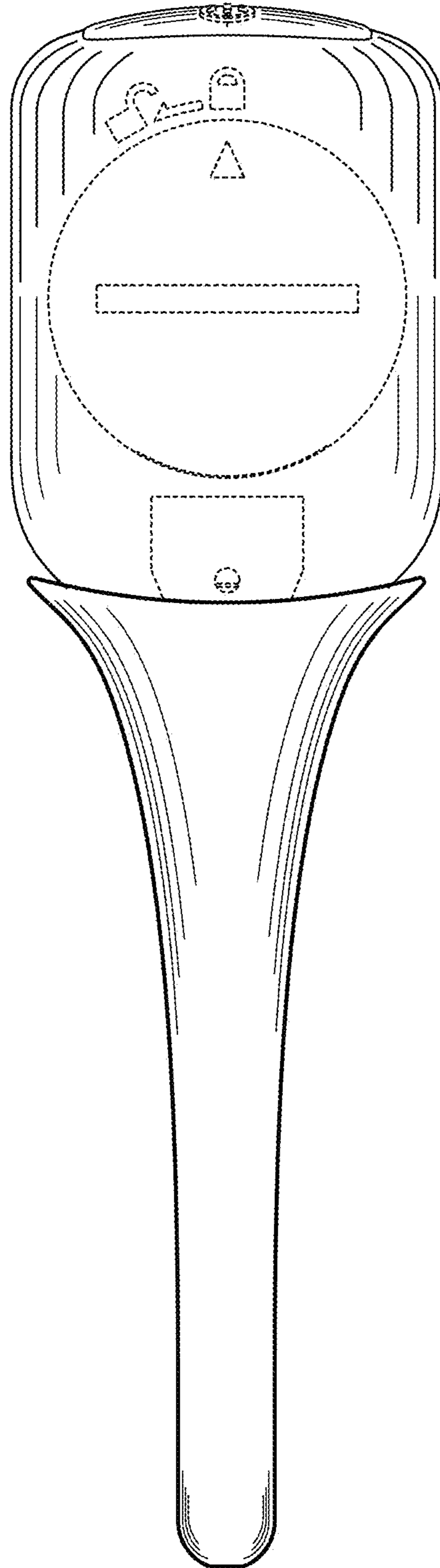

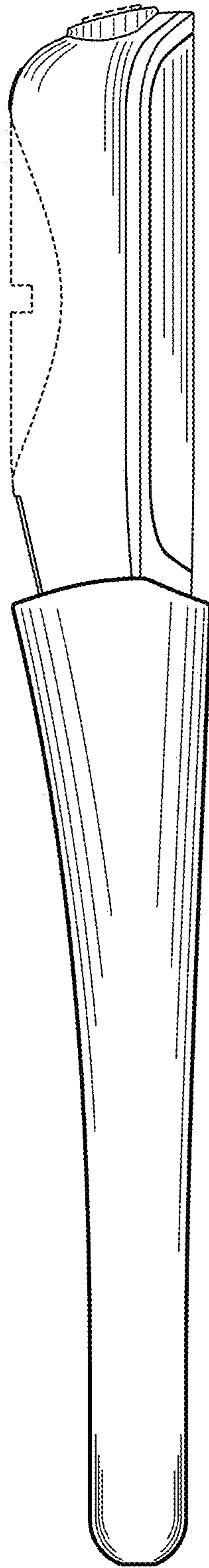

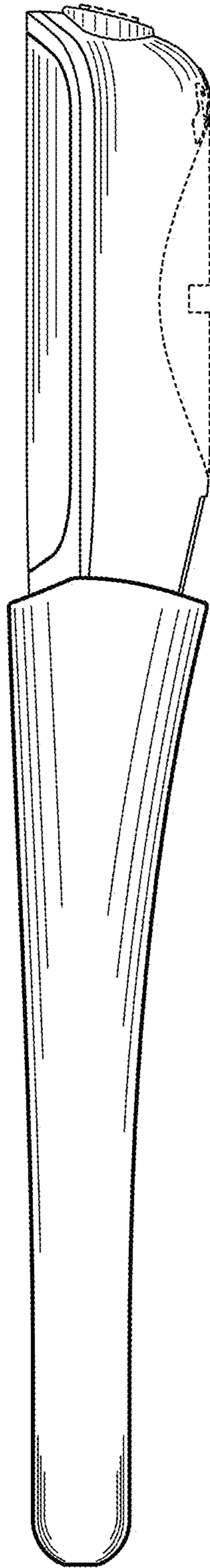

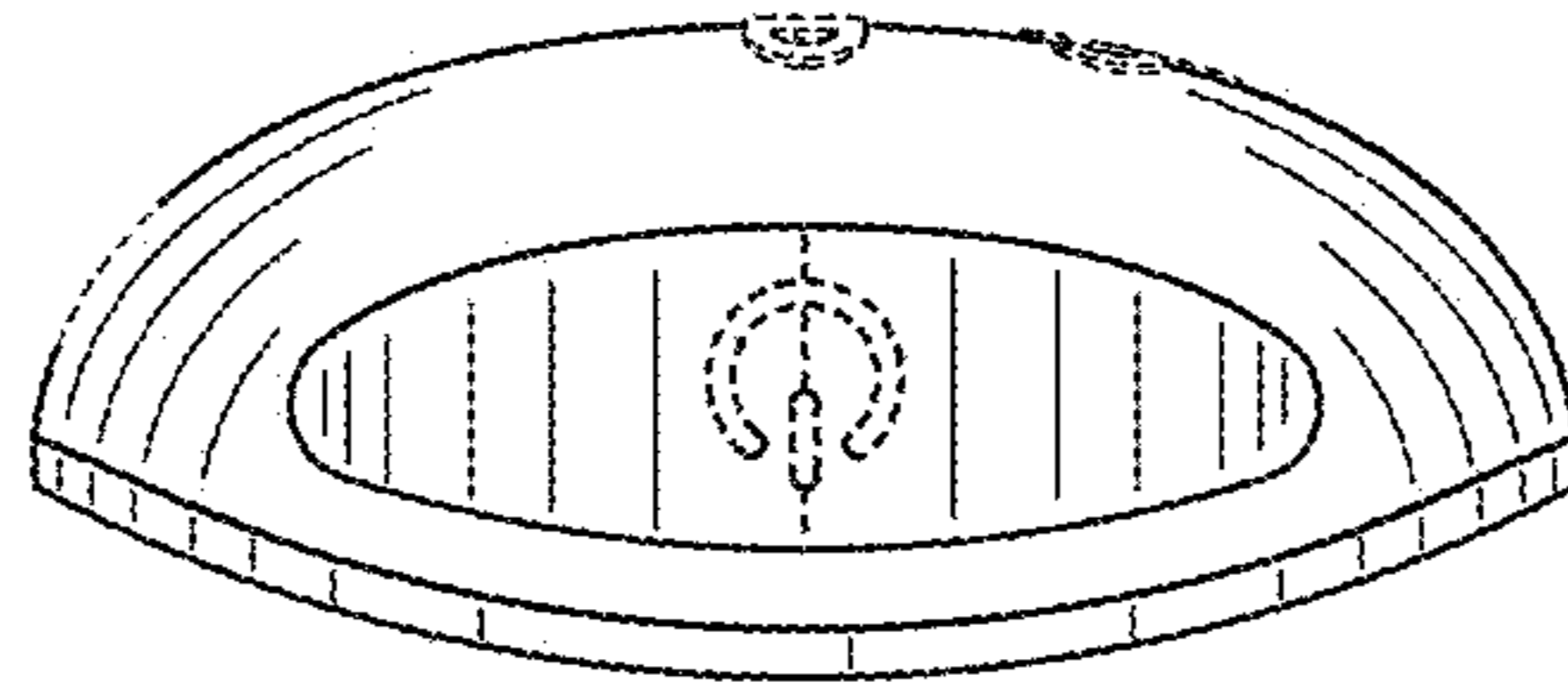

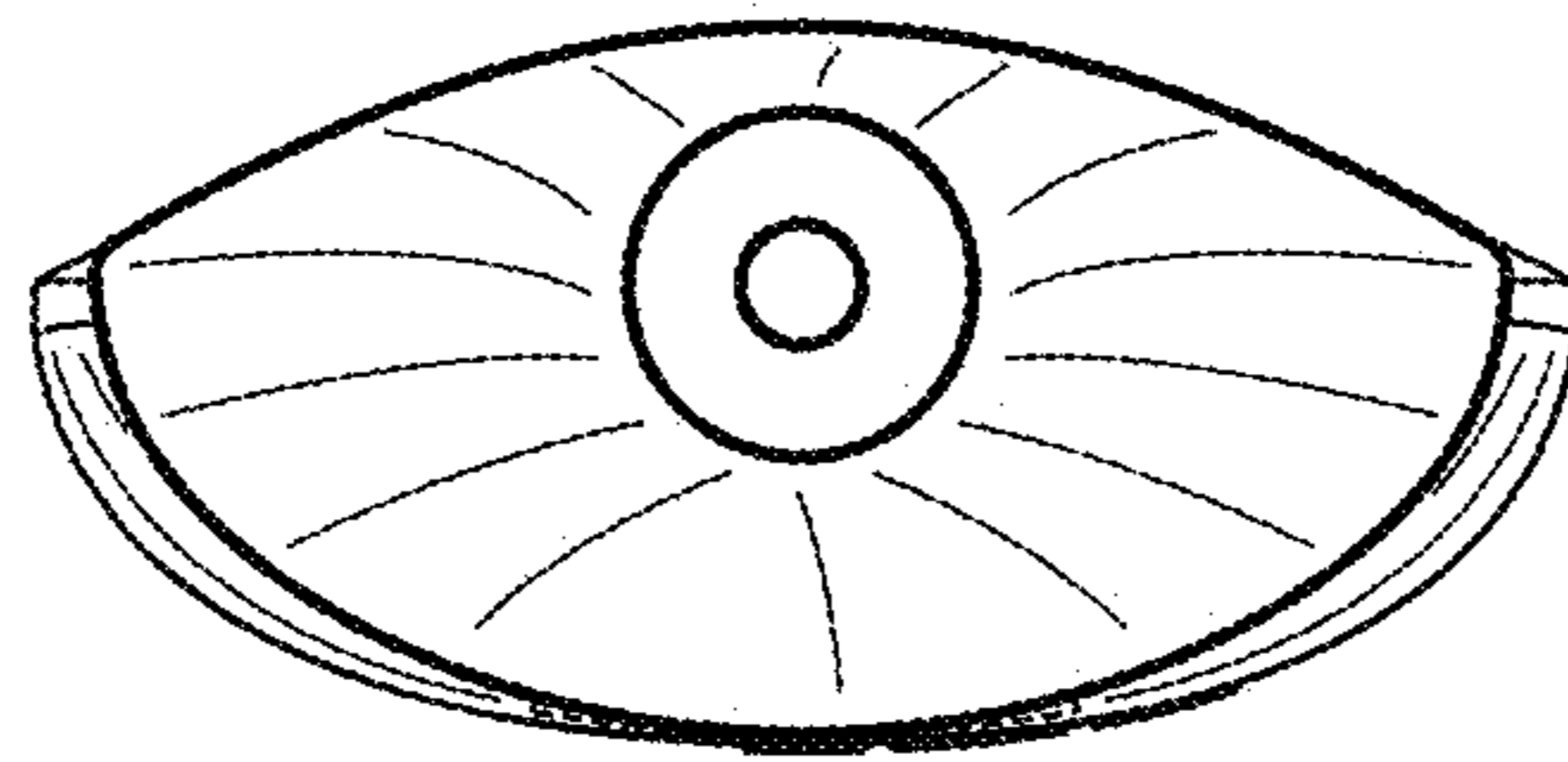
