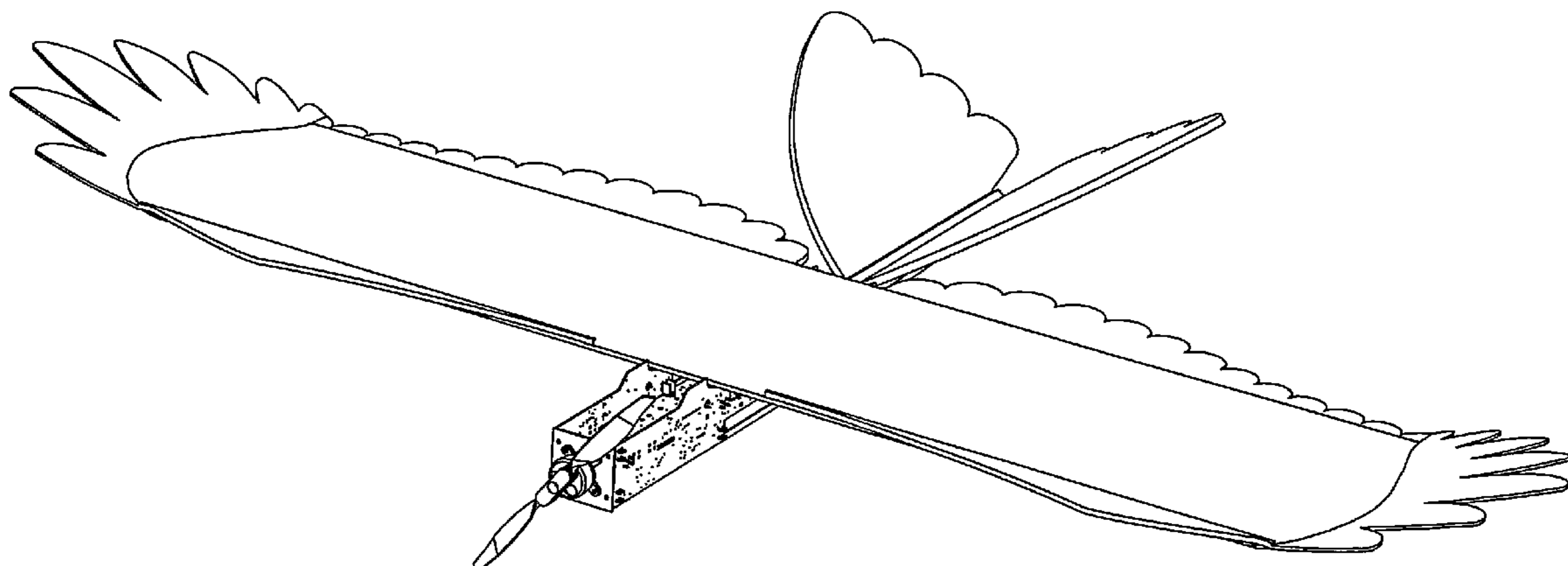

The ornamental design for an unmanned aerial vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an unmanned aerial vehicle according to the design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a right side view thereof drawn to an enlarged scale;  
FIG. 5 is a left side view thereof drawn to an enlarged scale;  
FIG. 6 is a top view of FIG. 1; and,  
FIG. 7 is a bottom view of FIG. 1.  
The portions shown in broken lines in FIGS. 3 and 7 do not form part of the claimed design.

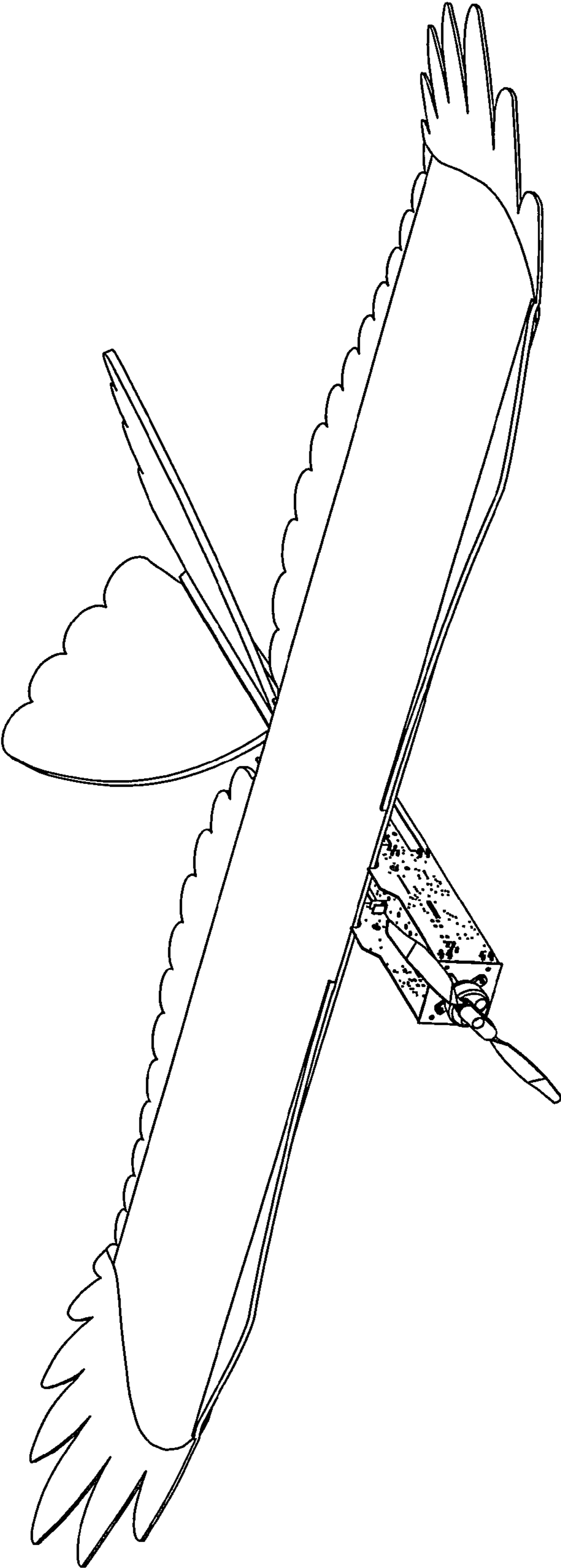

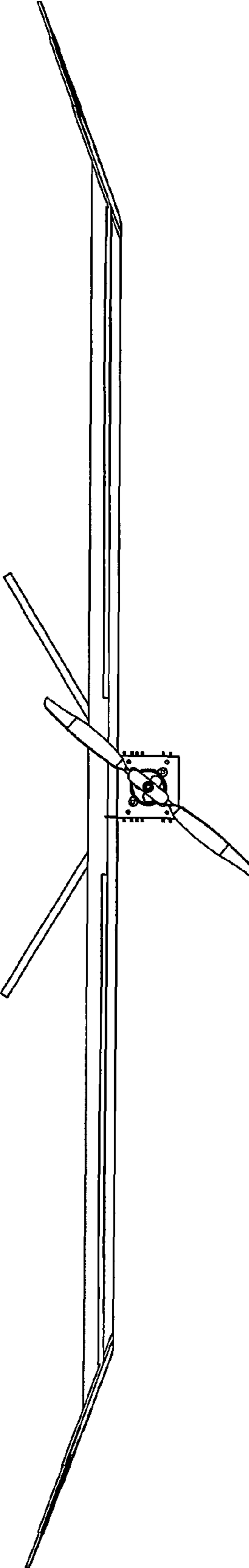

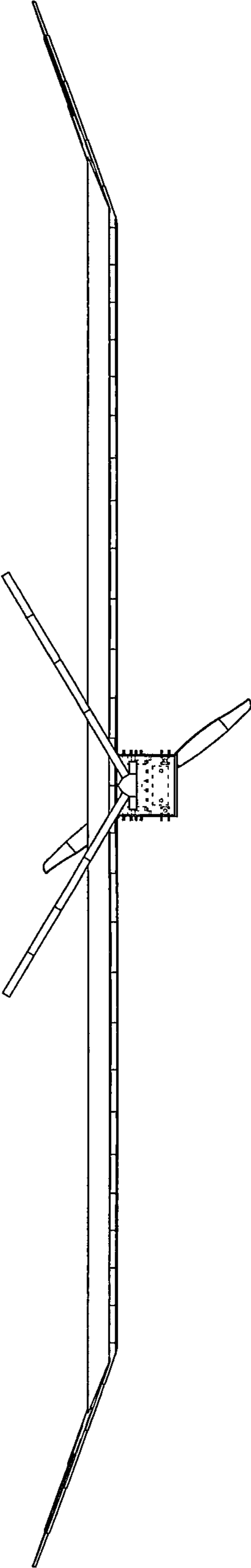

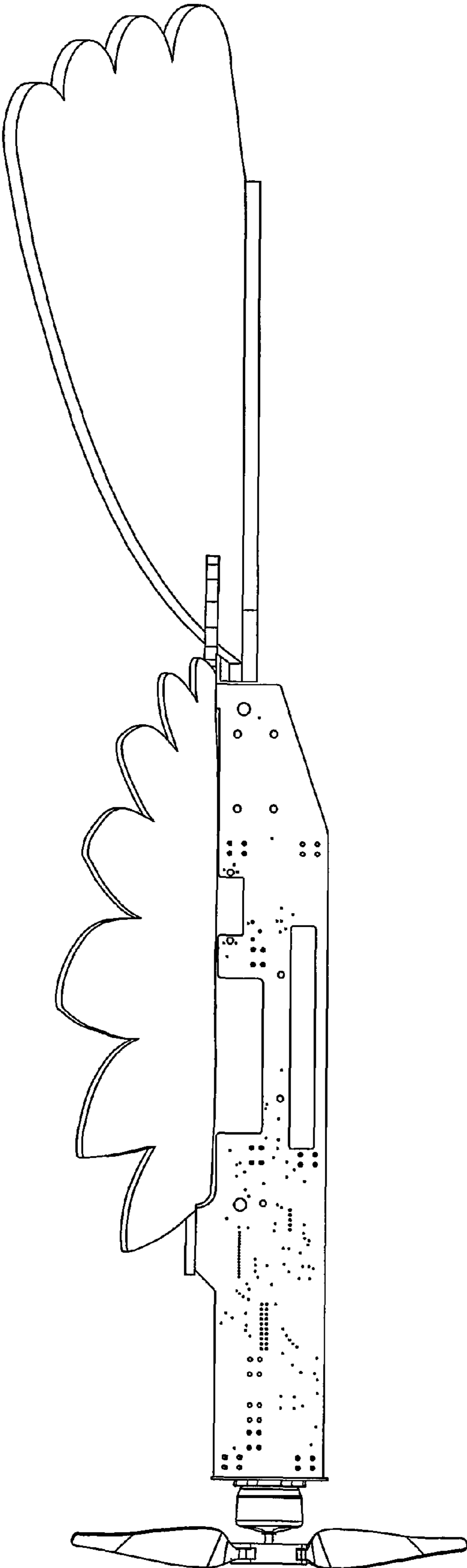

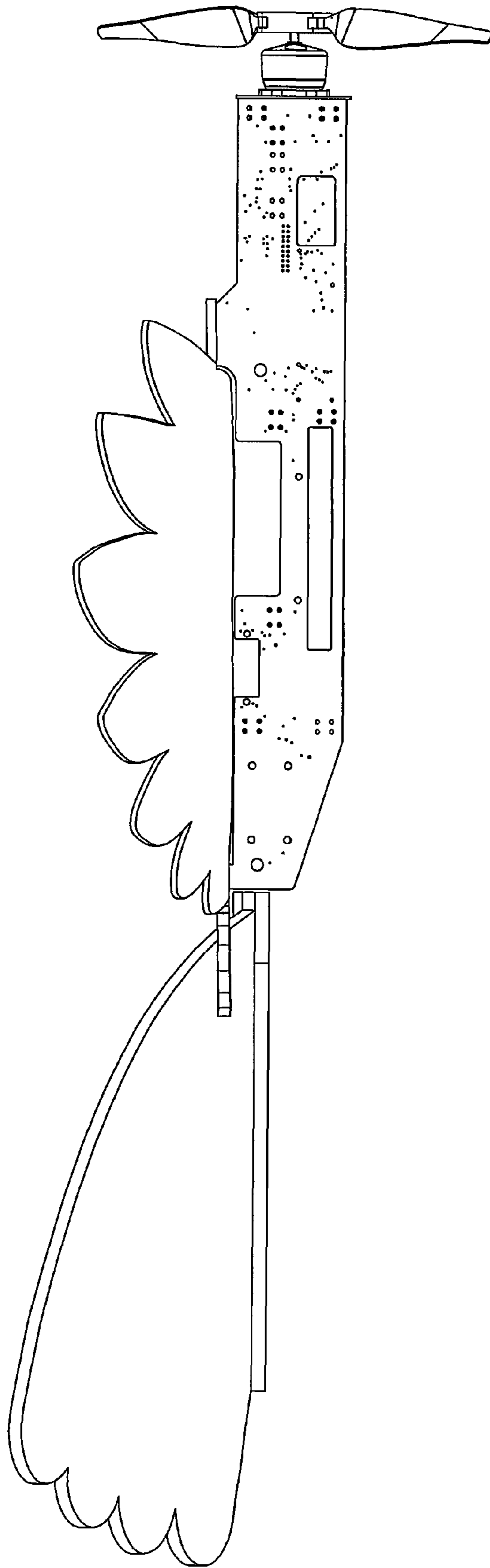

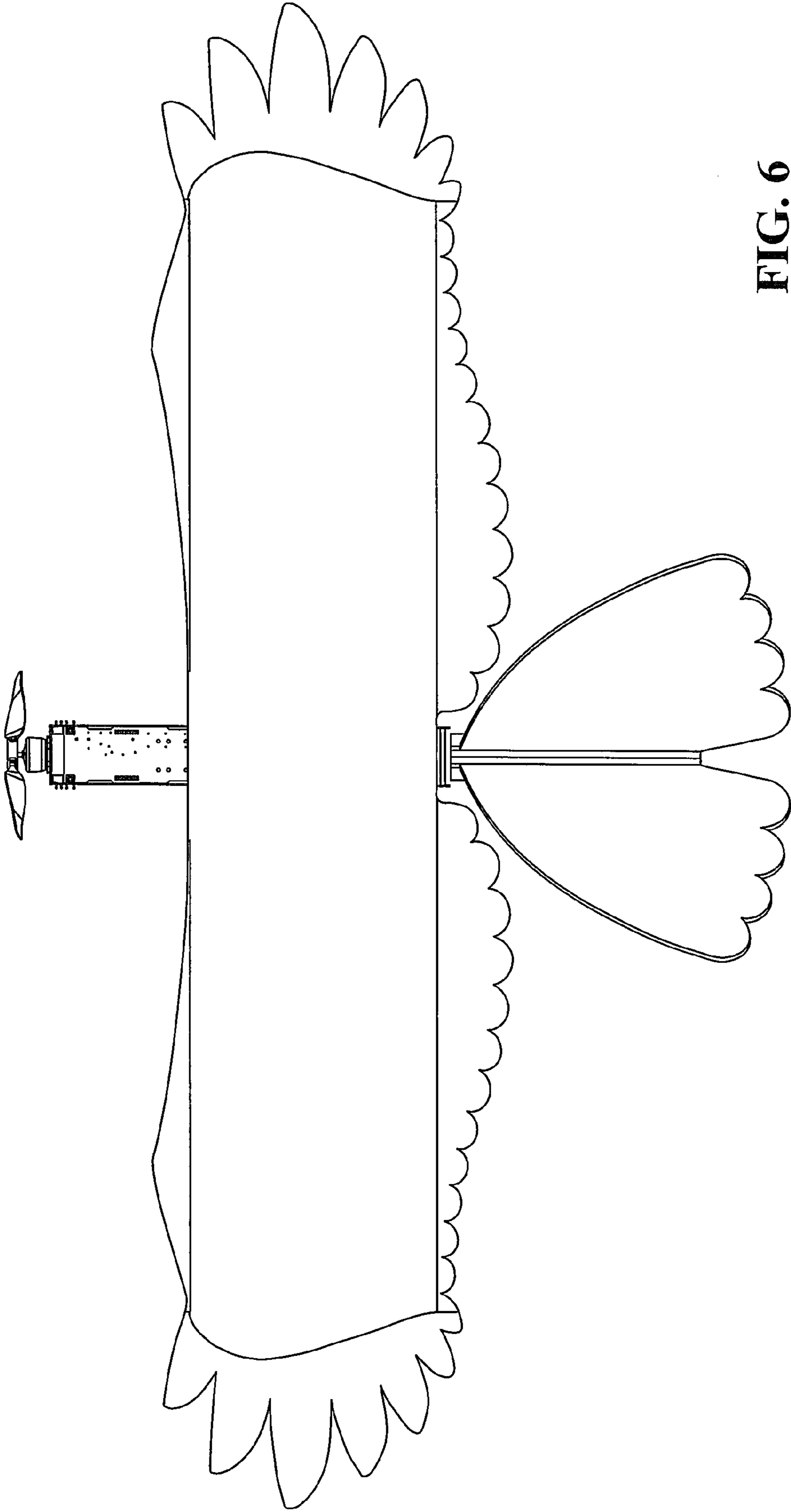

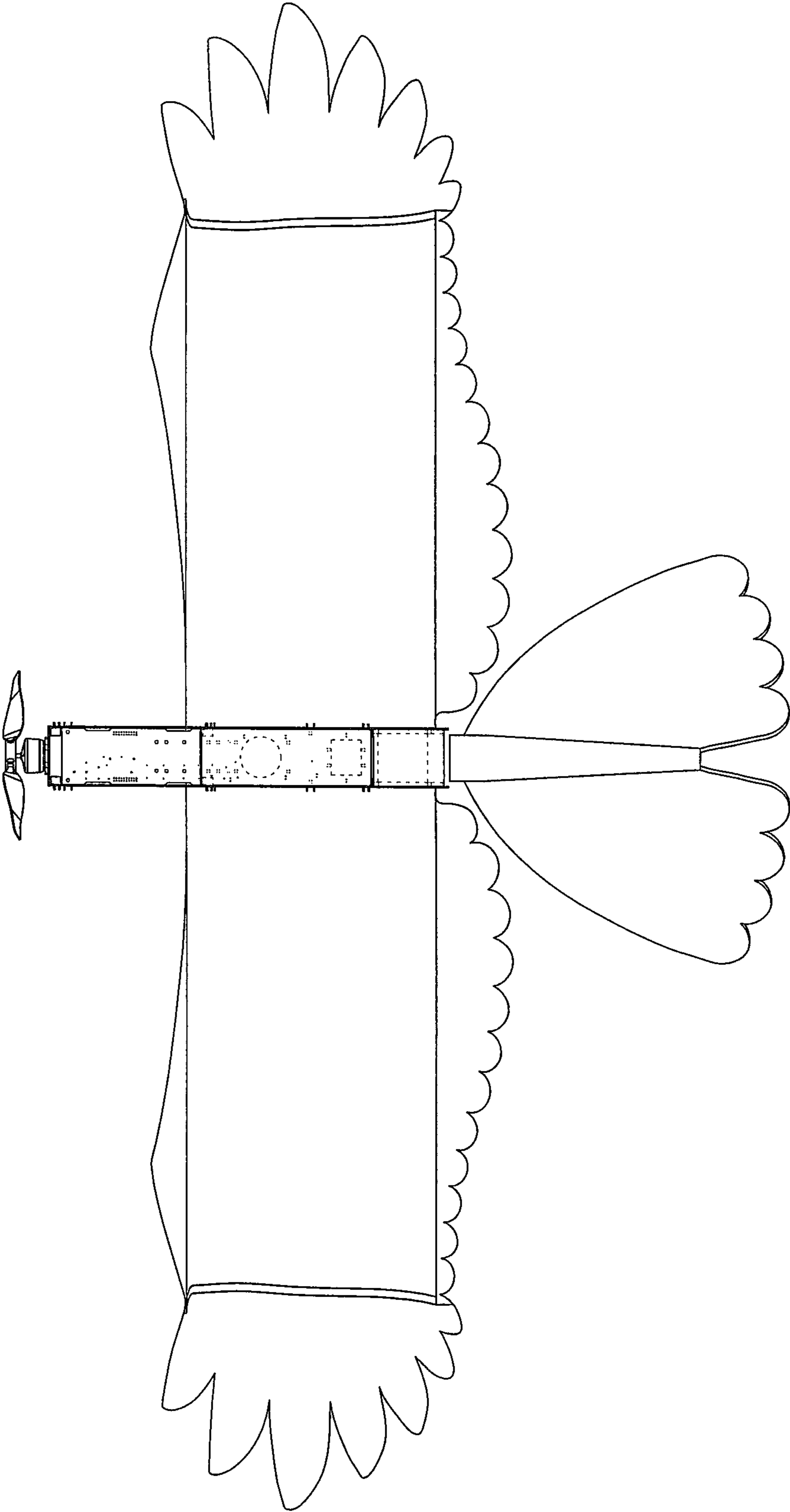
