(57) **CLAIM**

The ornamental design for a front portion of a vehicle, toy, and/or replicas thereof, as shown and described.

FIG. 3 is a left side view thereof;

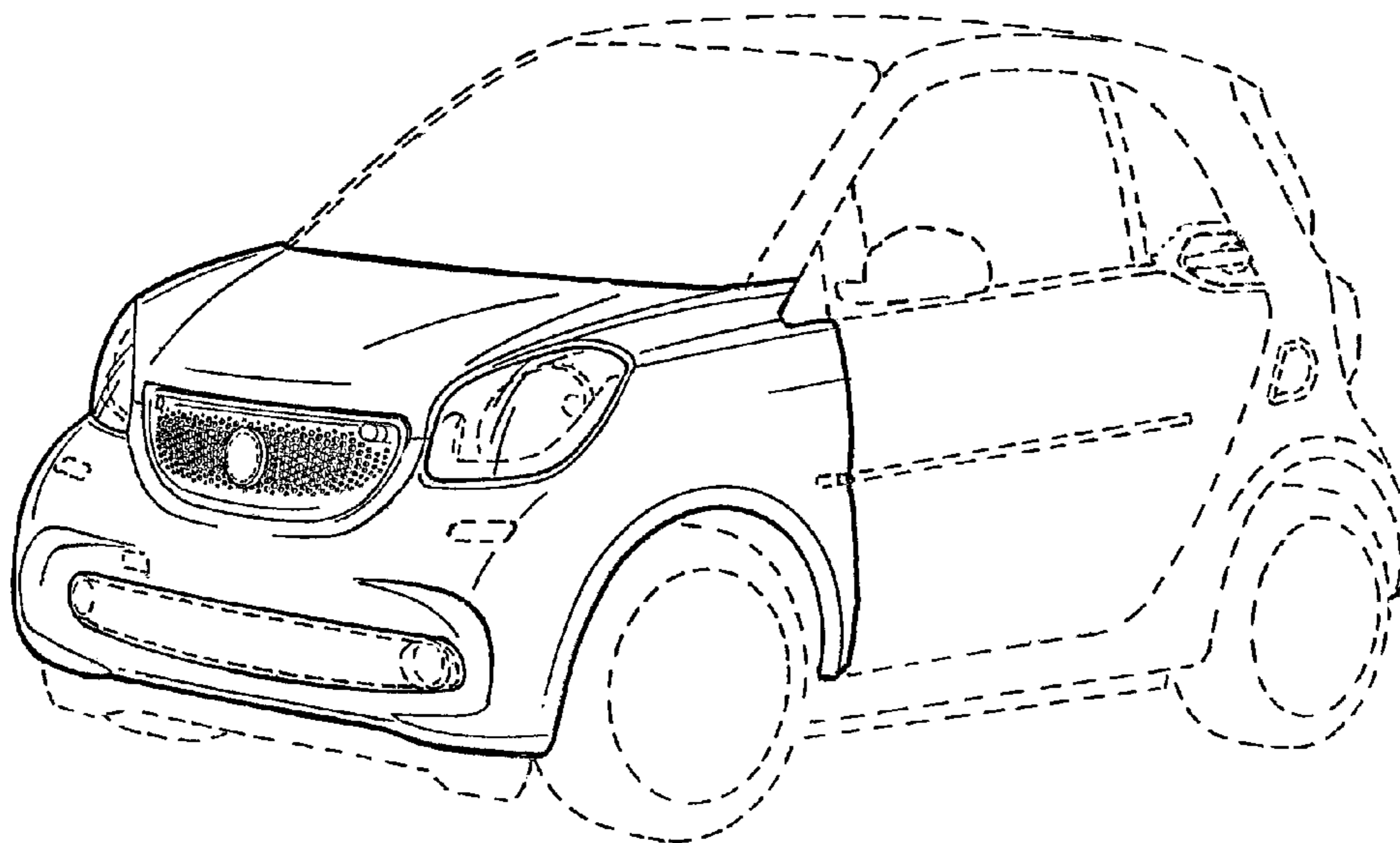
FIG. 4 is a right side view thereof;

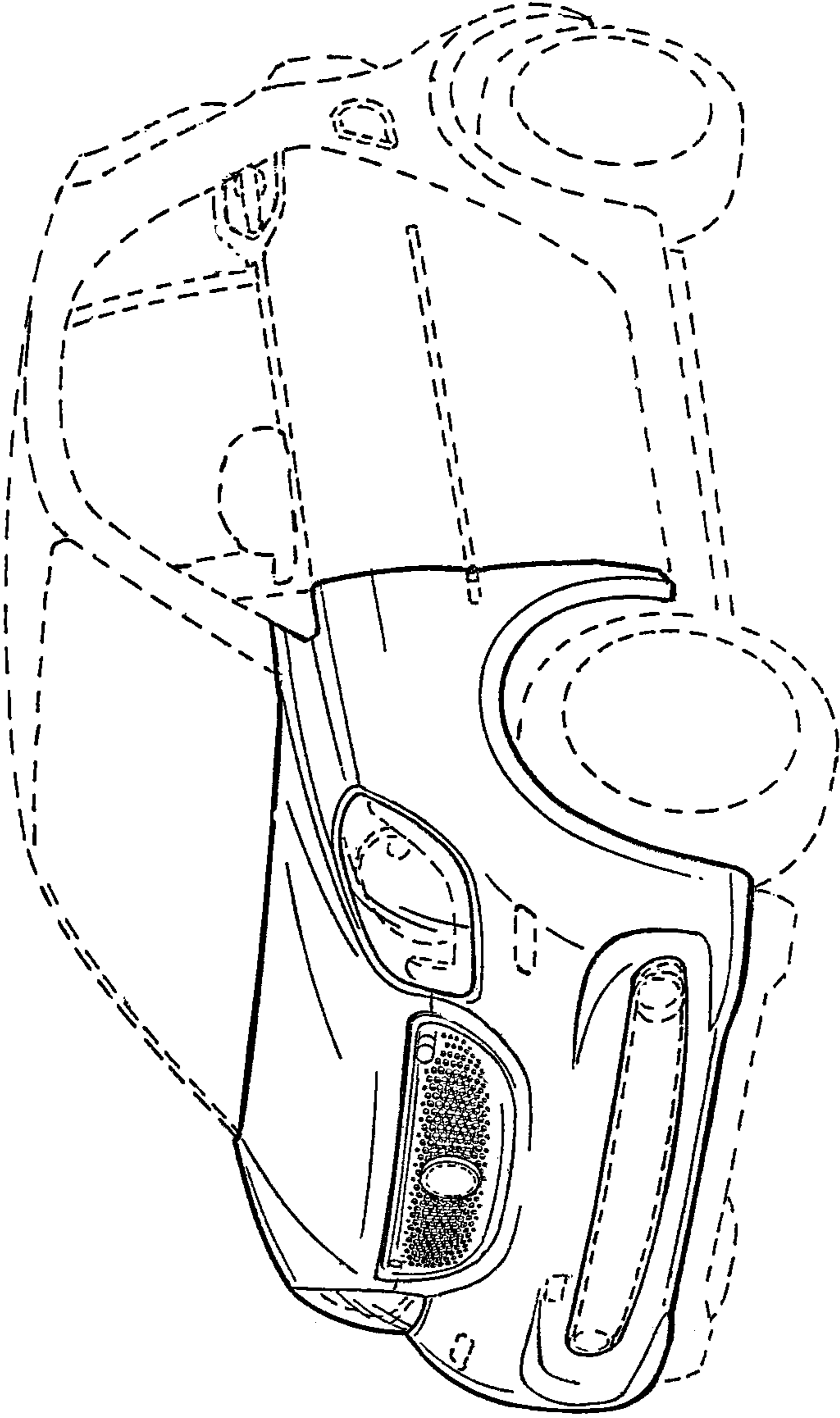

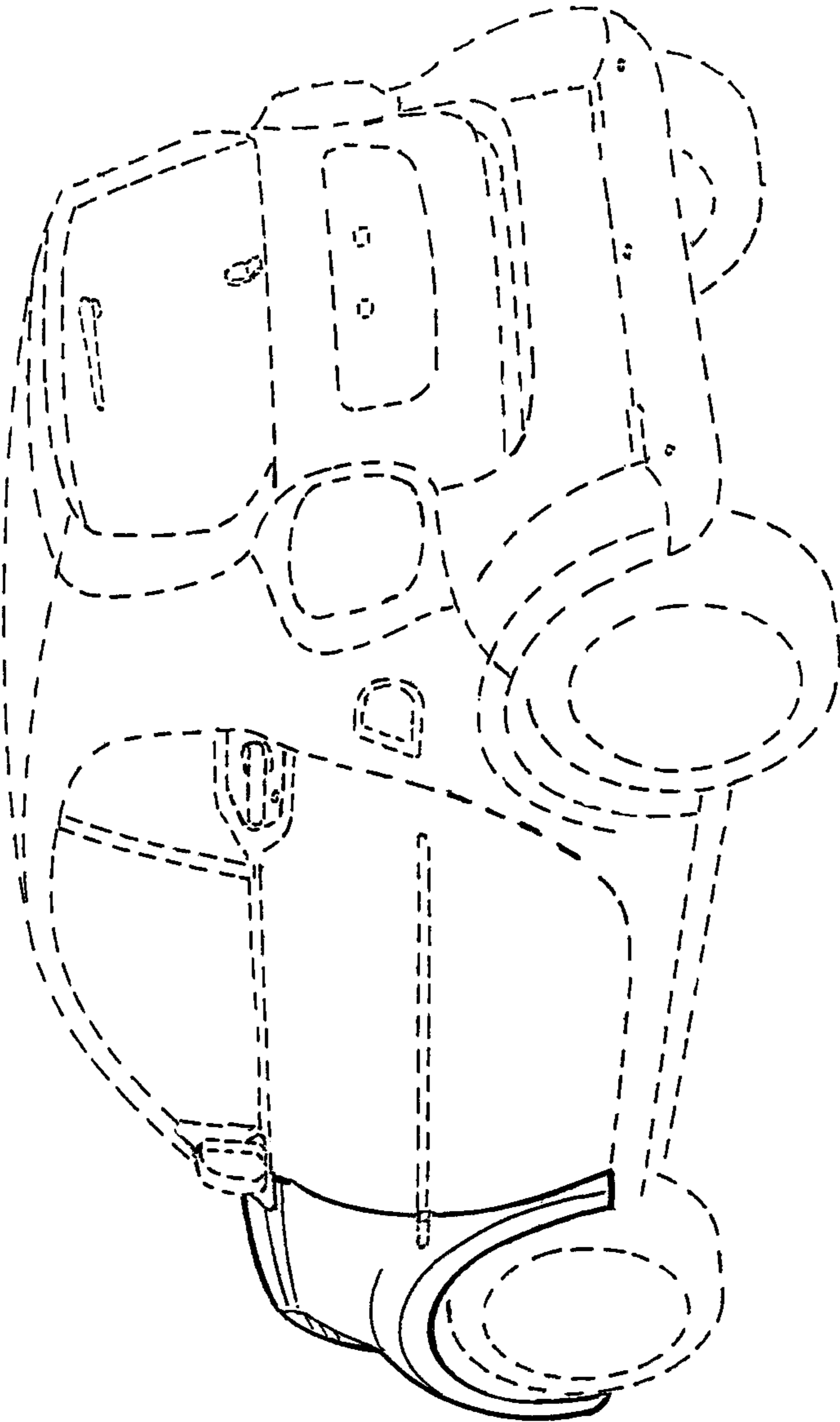

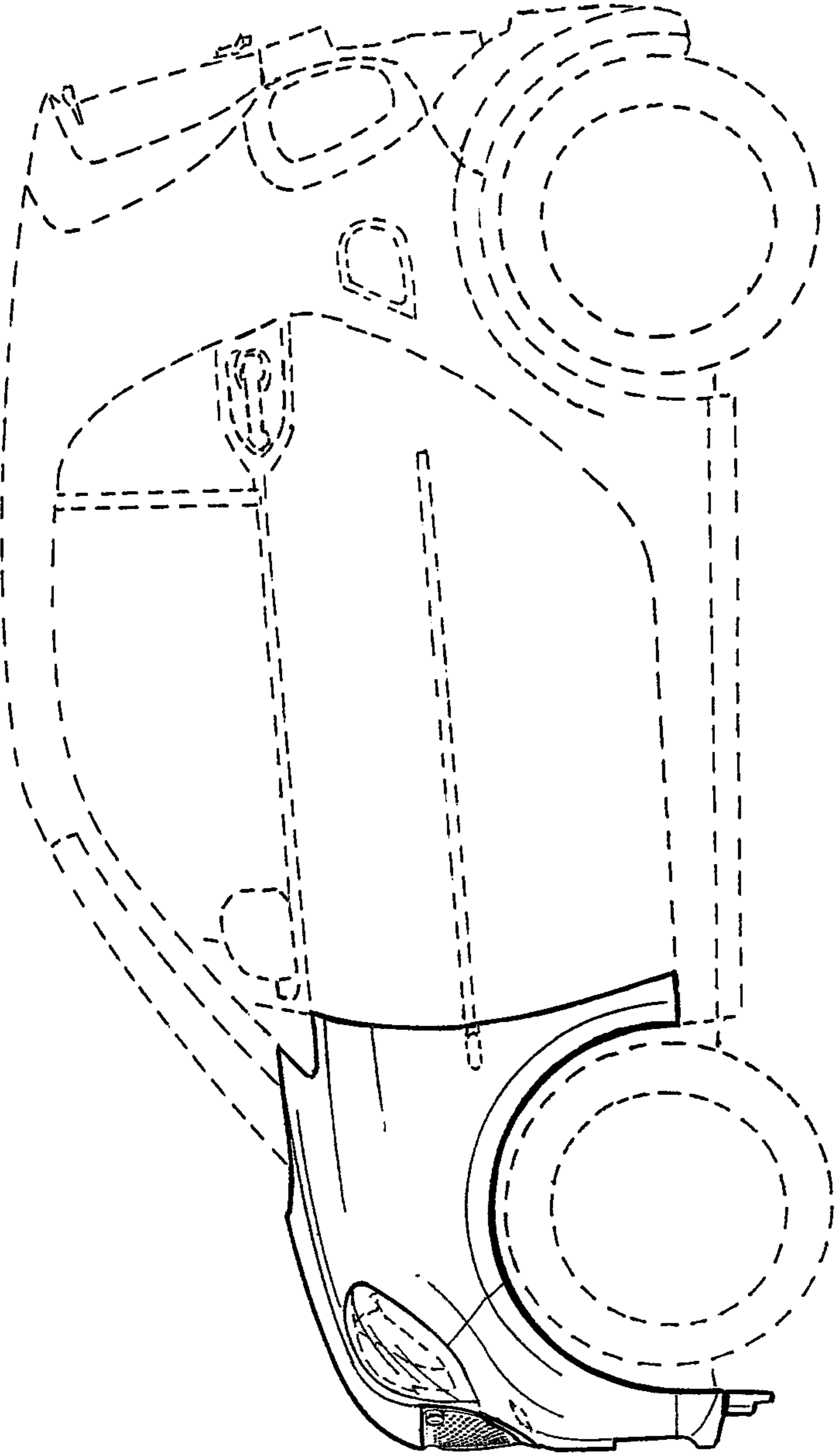

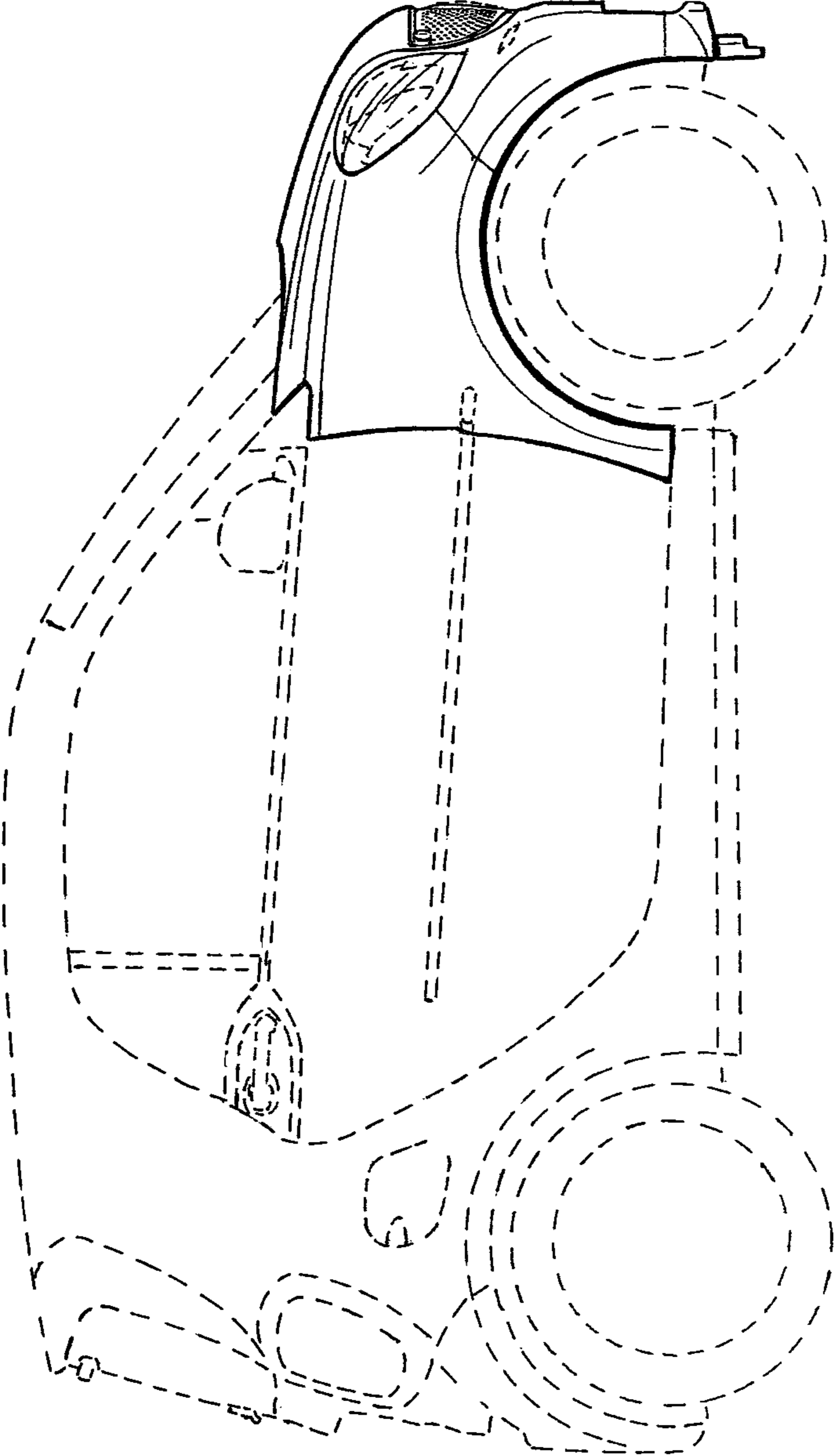

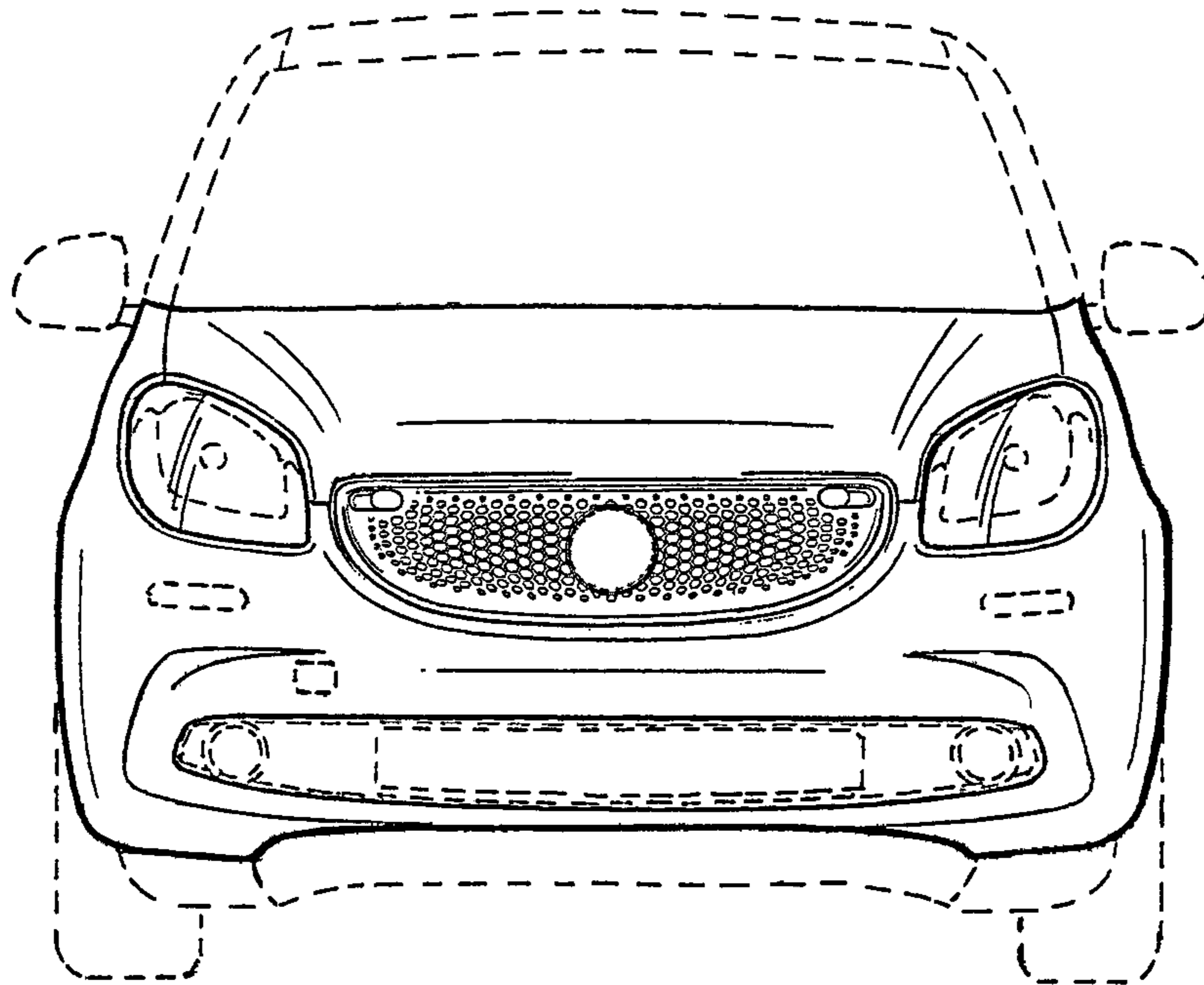

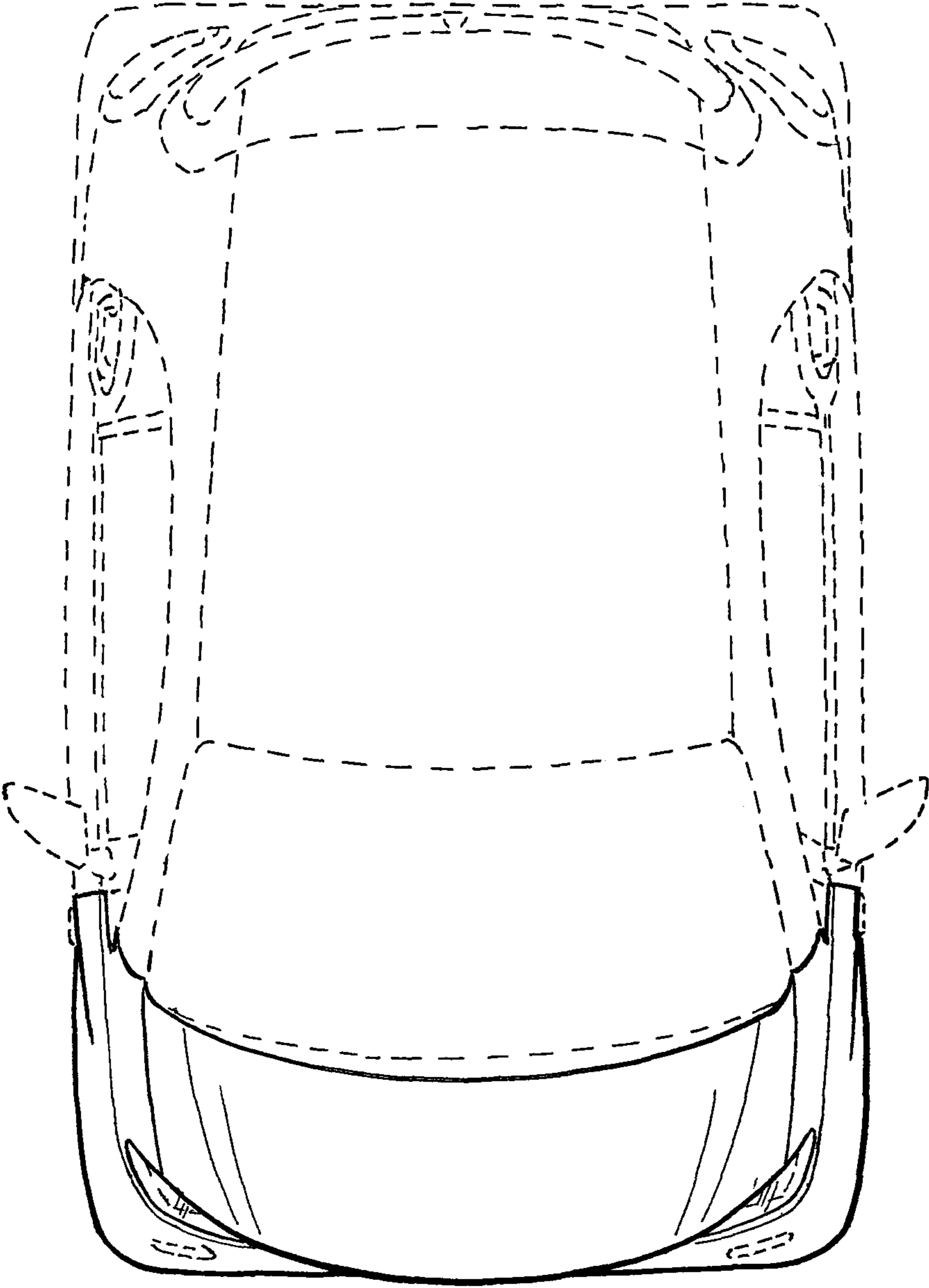
