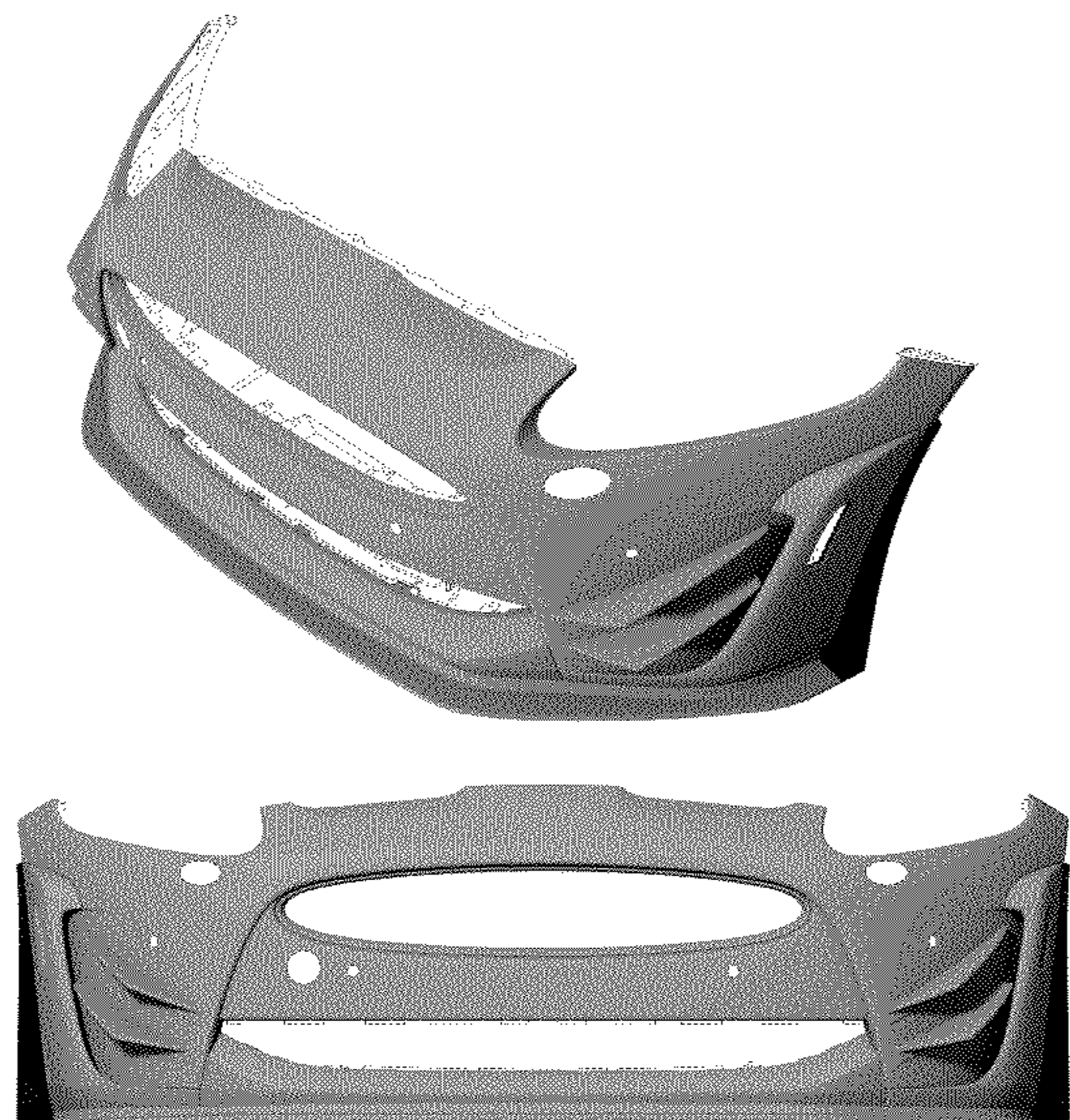
(57) **CLAIM**

The ornamental design for a vehicle component, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front perspective view of a vehicle component; FIG. 2 is a right front perspective view of a vehicle component; FIG. 3 is a top view of a vehicle component; FIG. 4 is a left side view of a vehicle component; FIG. 5 is a right side view of a vehicle component; FIG. 6 is a front view of a vehicle component; and, FIG. 7 is a rear view of a vehicle component. 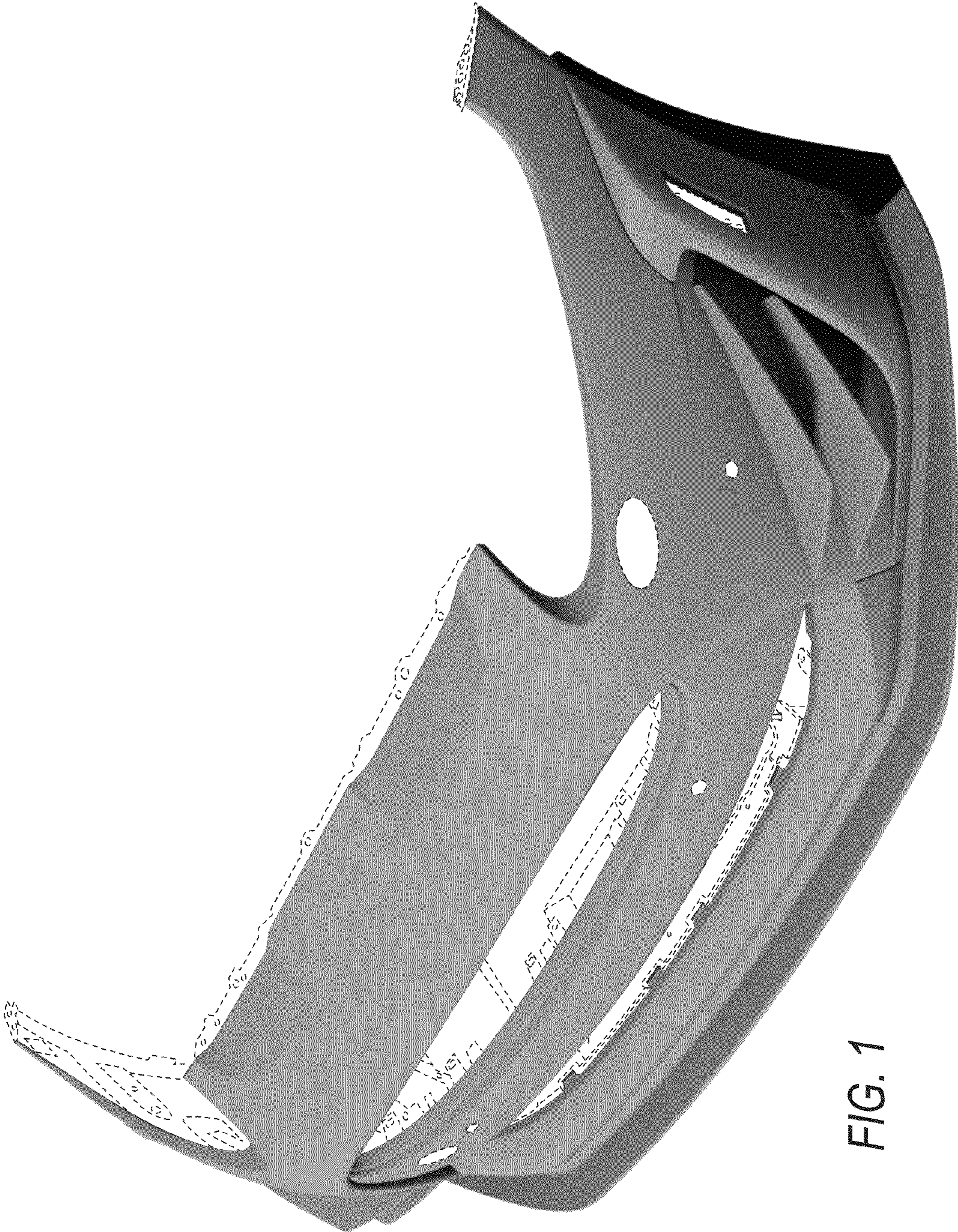

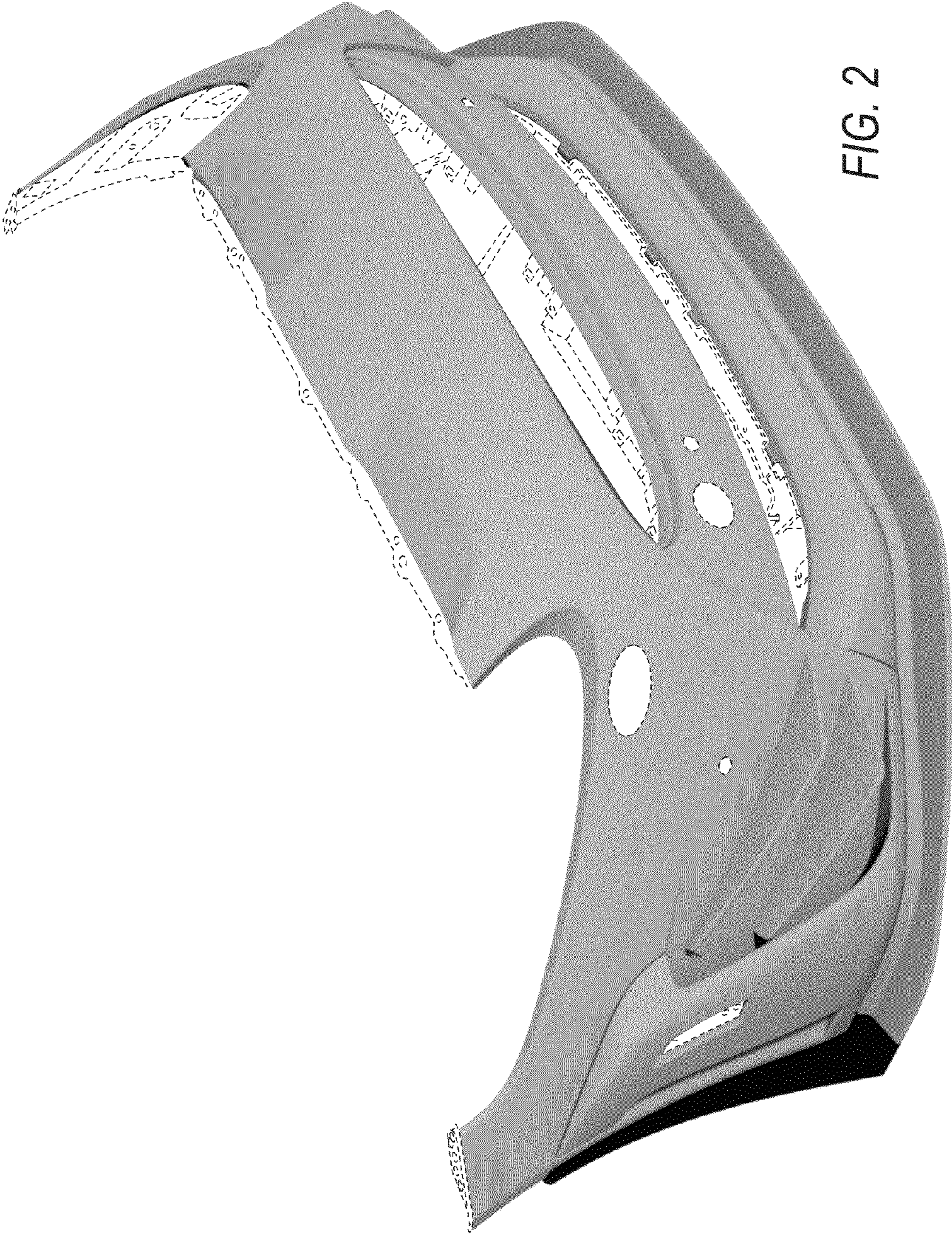

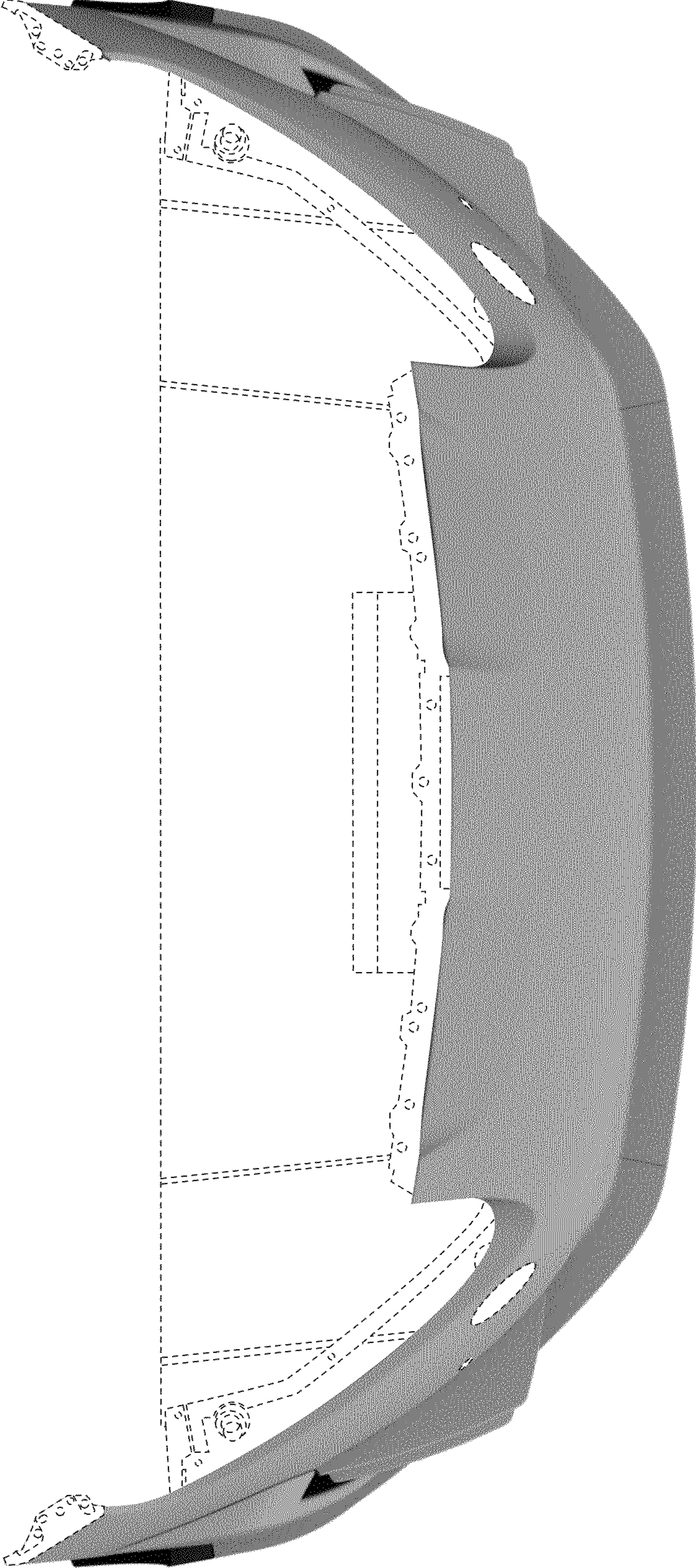

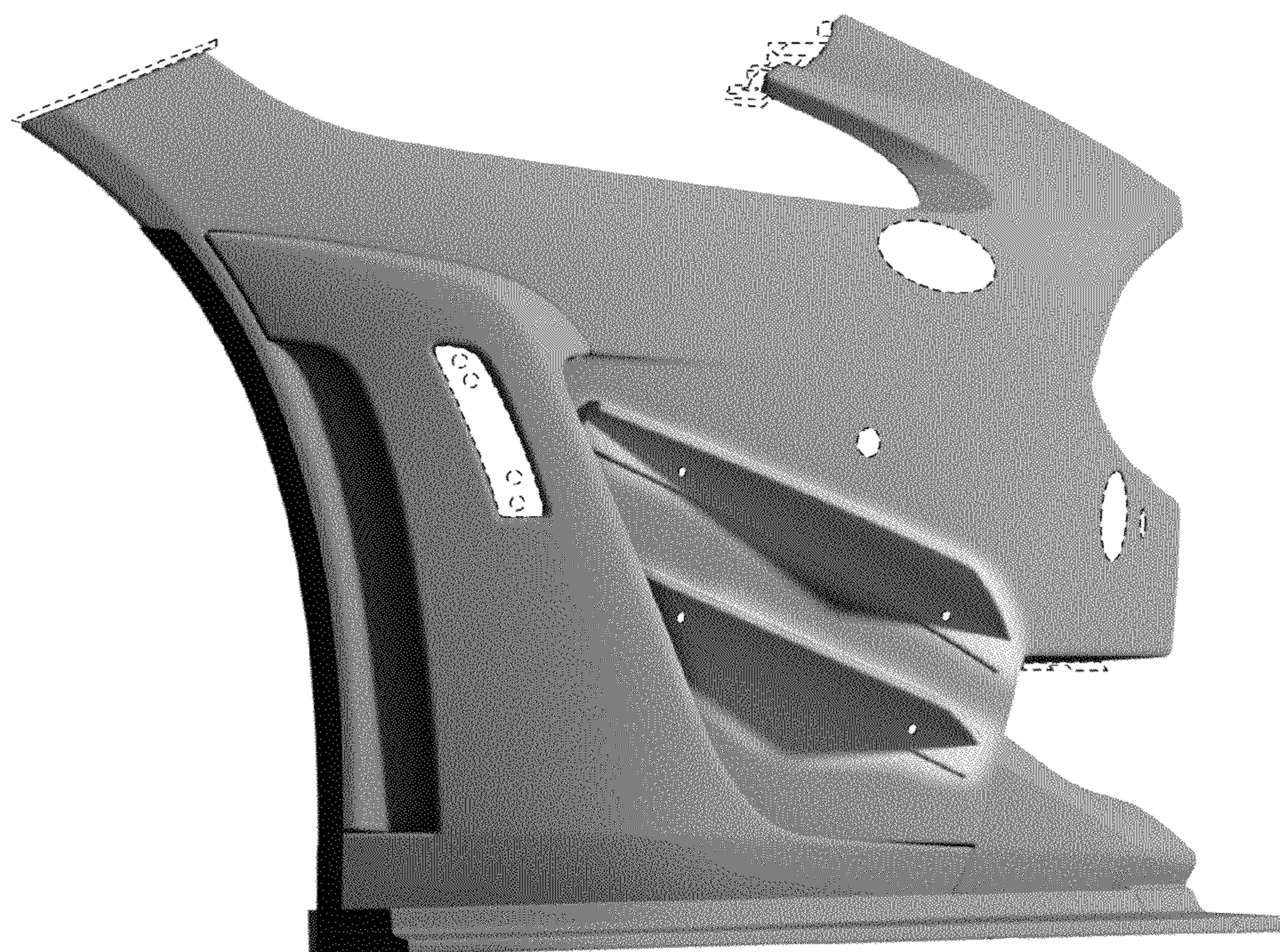

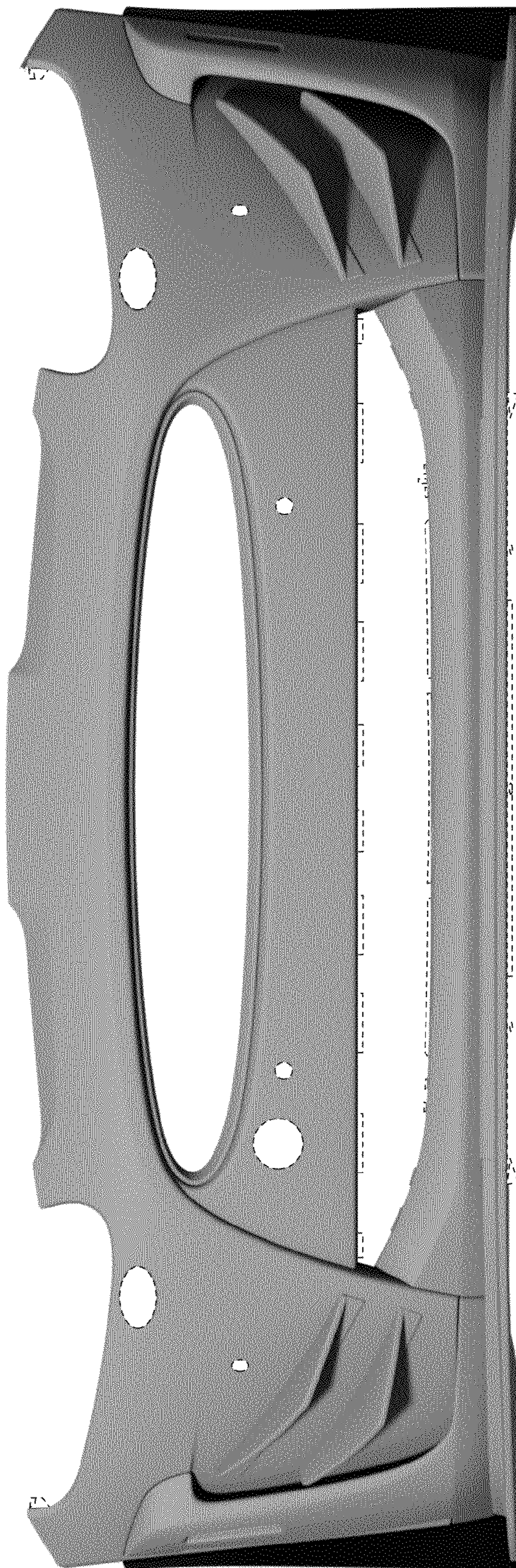

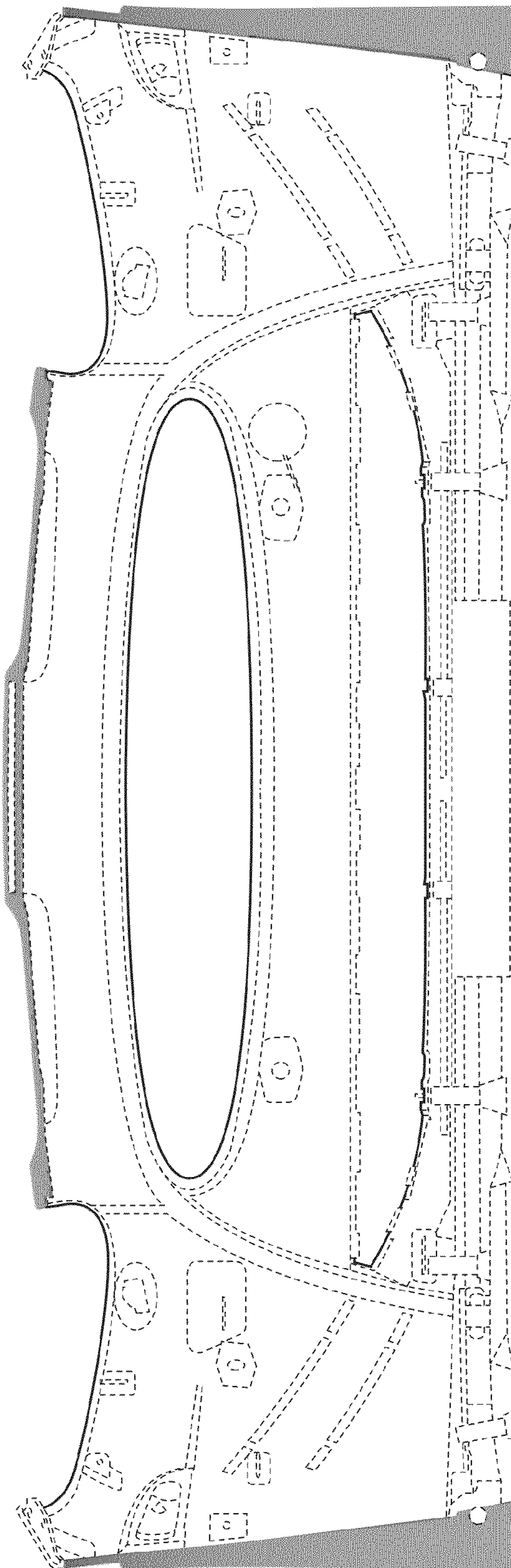
