module.

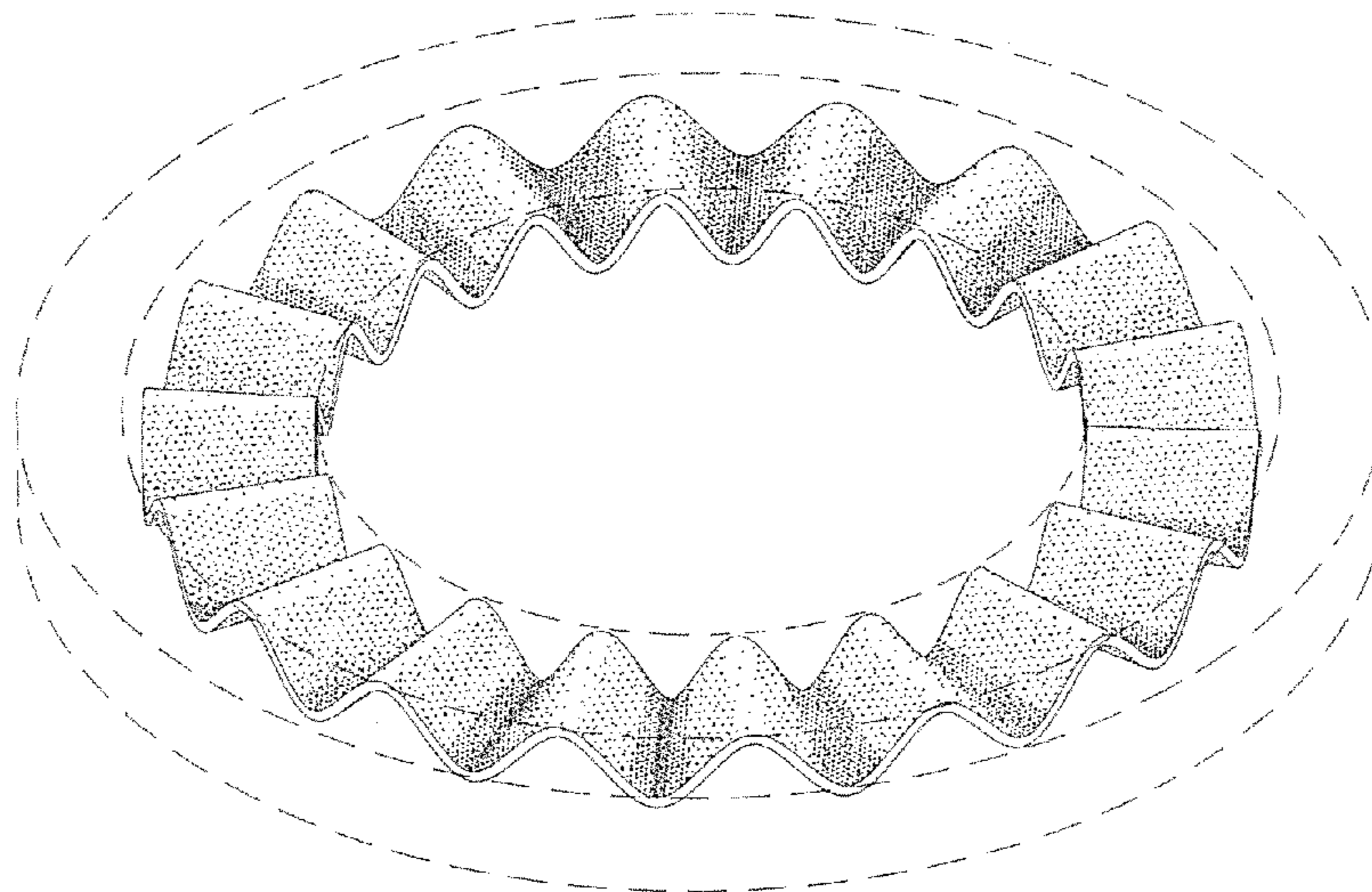
FIG. 5 is a rear view of the suspension for the acoustic mod-

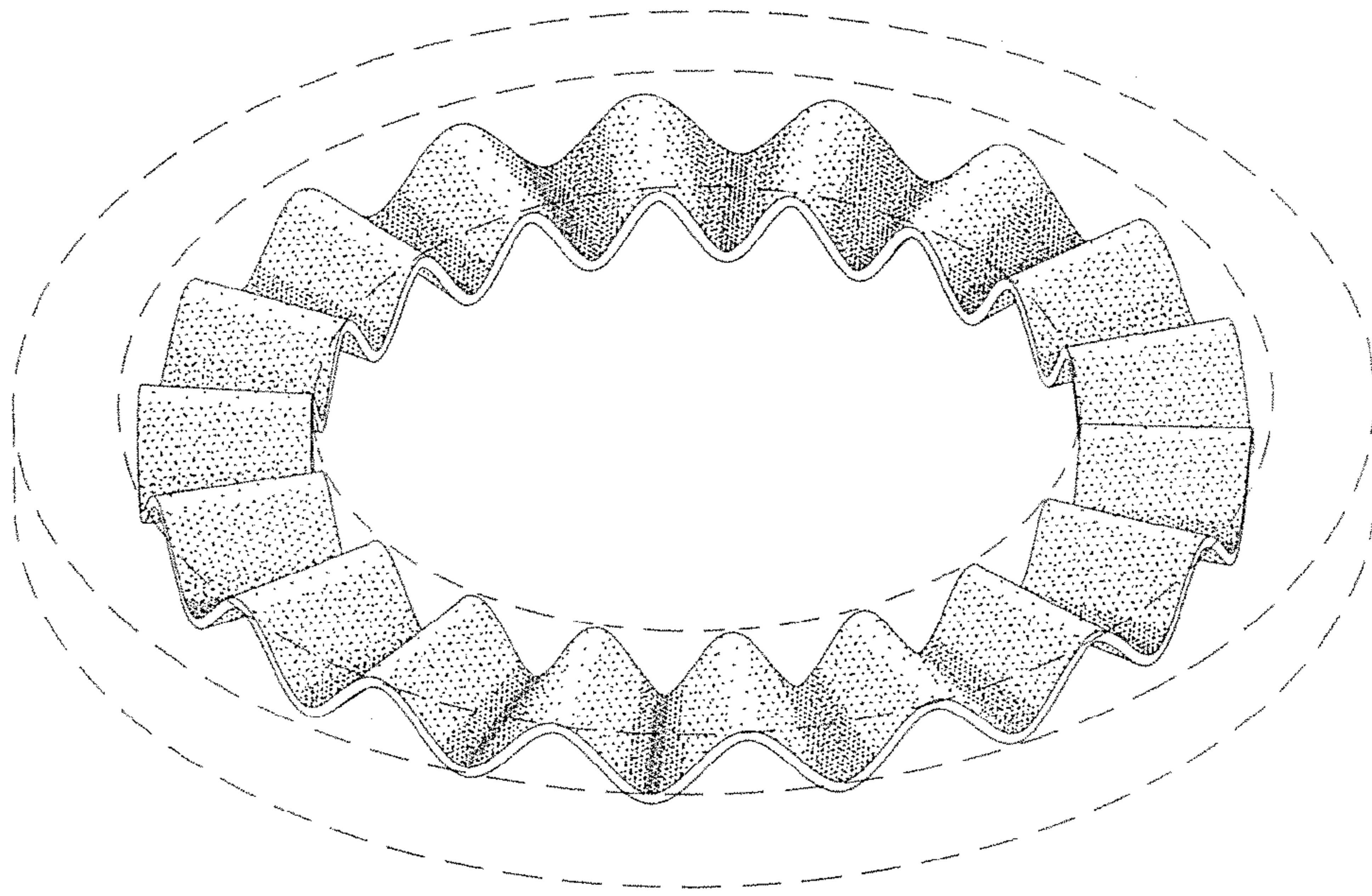

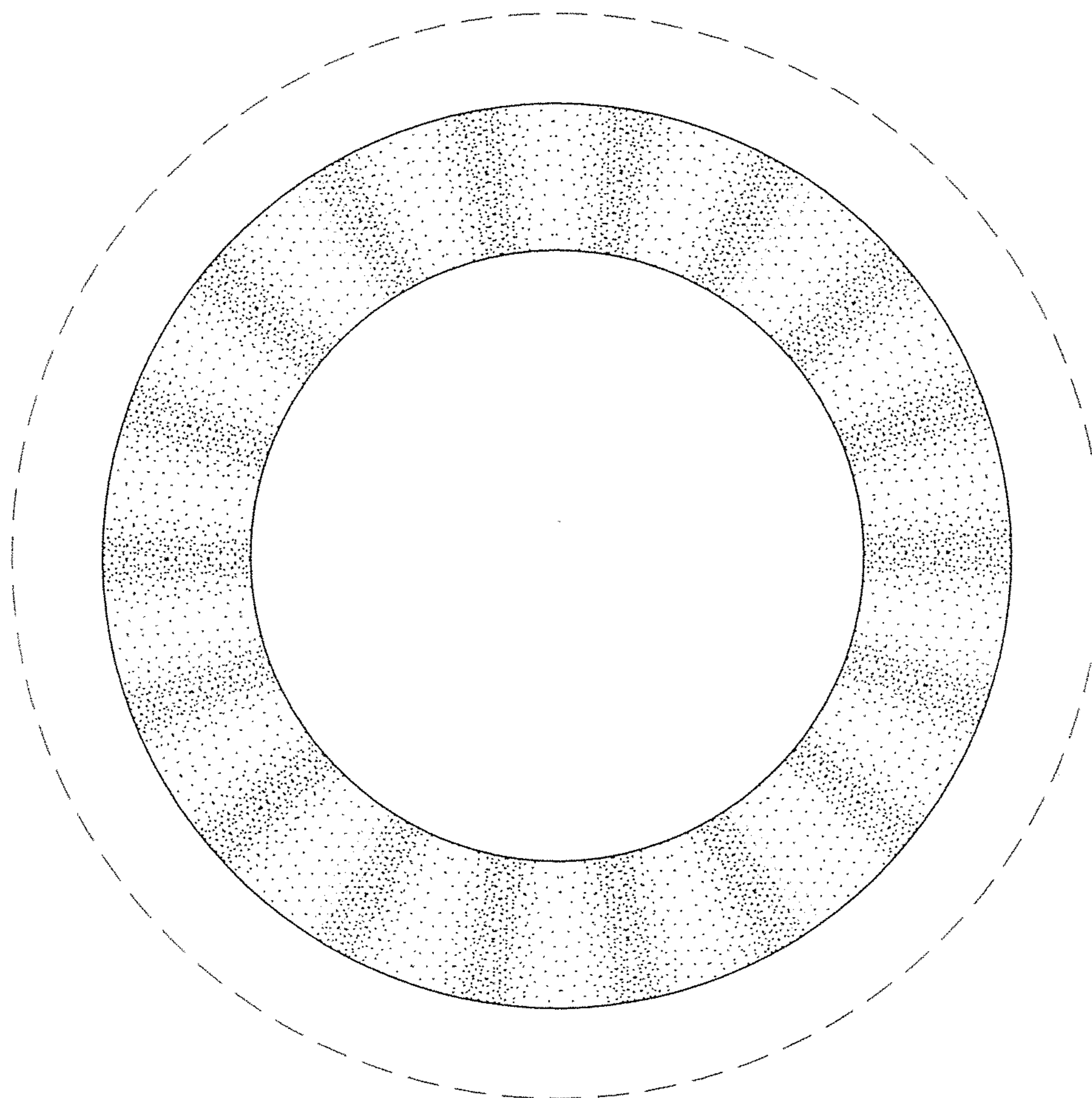

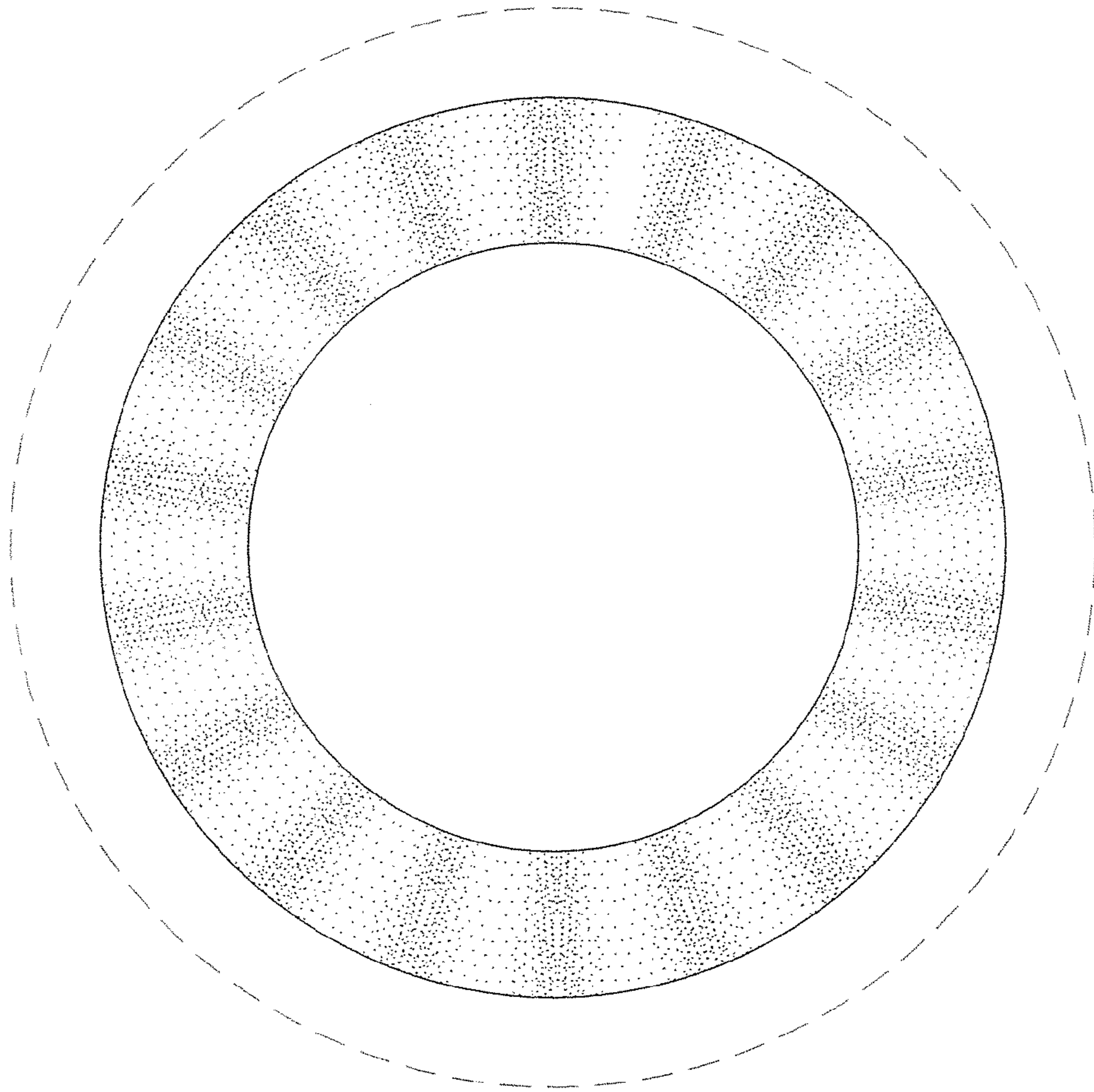

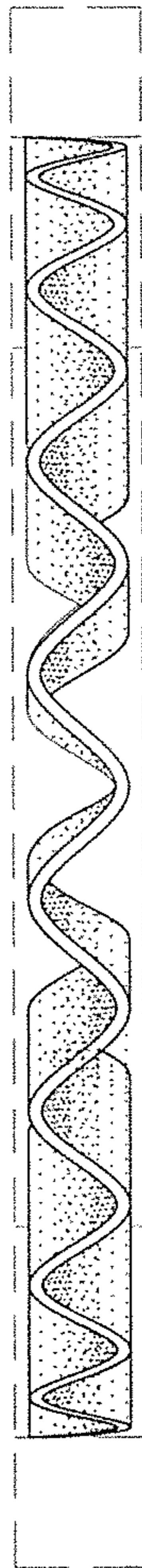

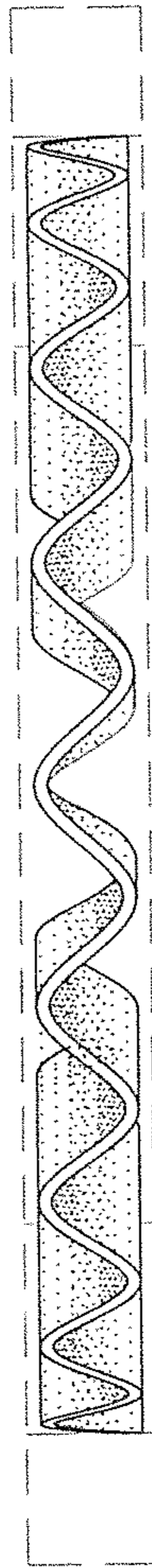

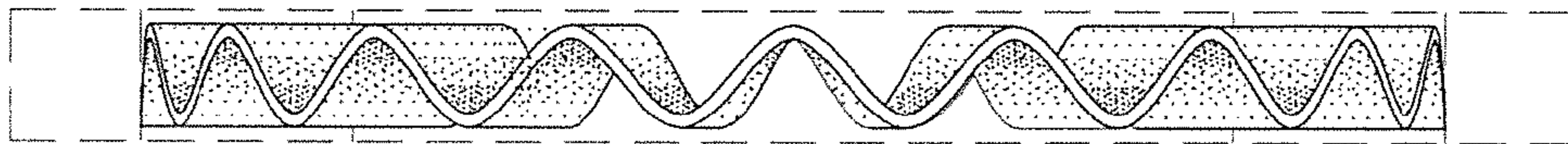

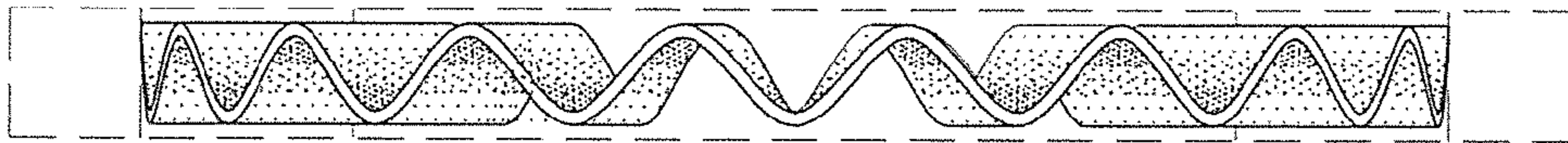
