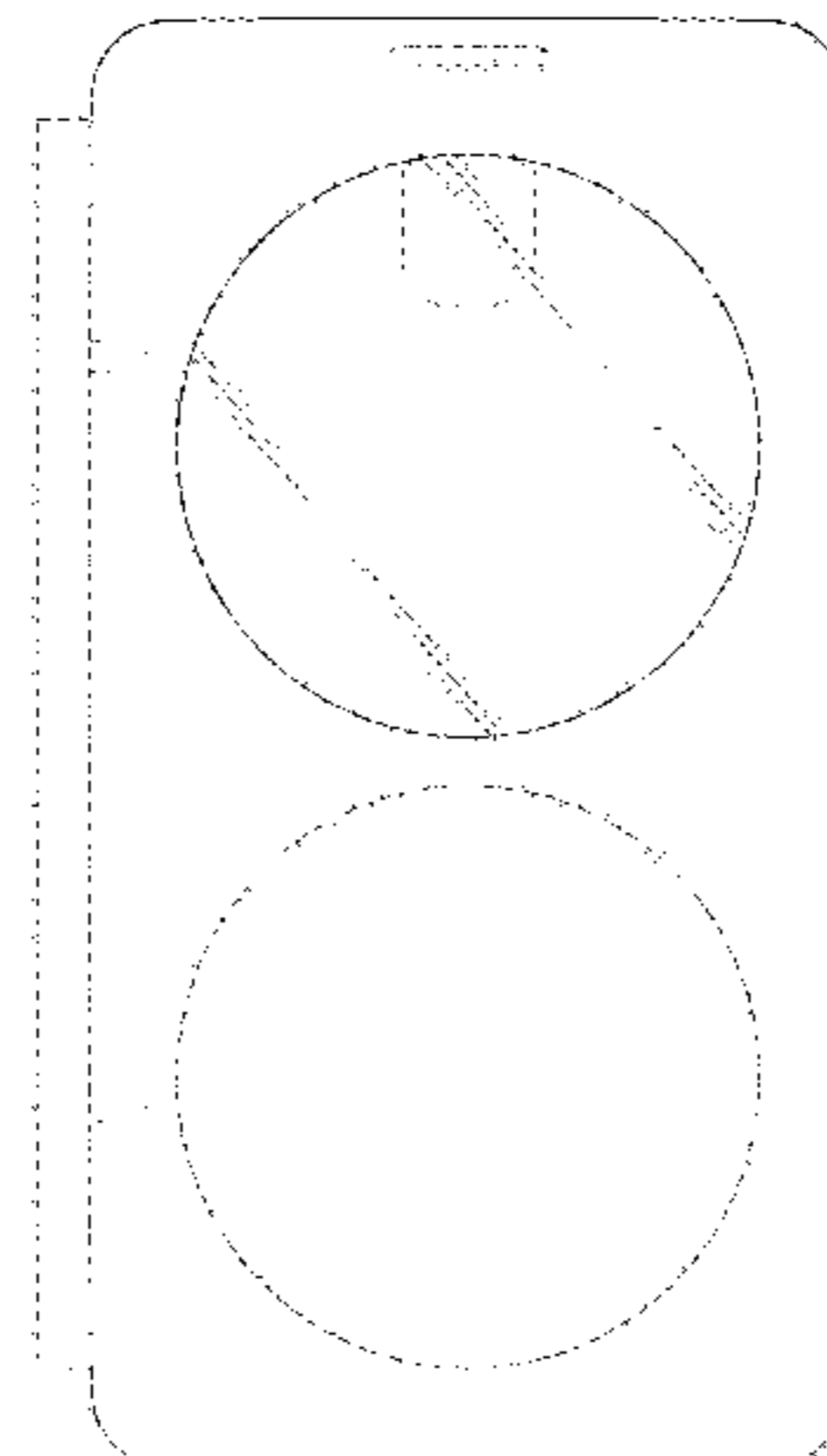
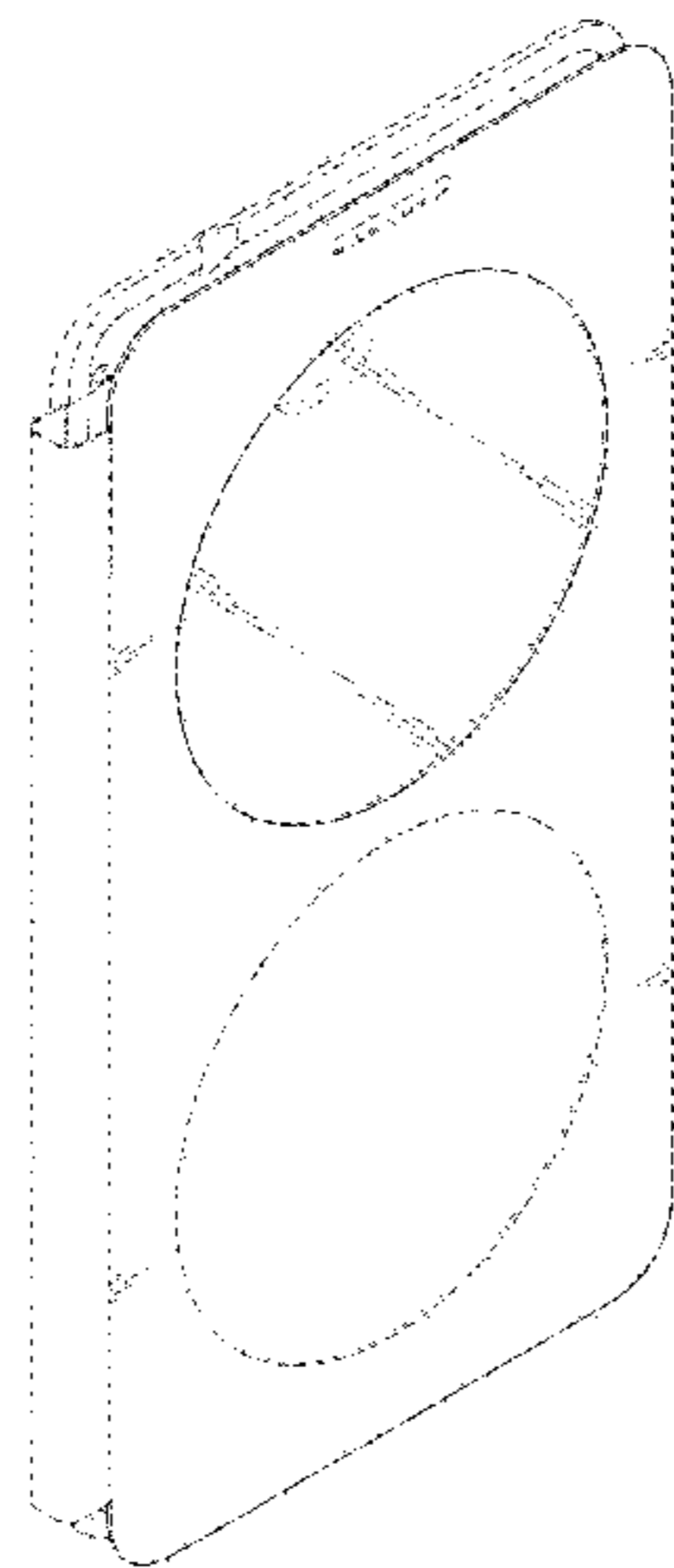
The ornamental design for a cover for mobile phone, as shown and described.

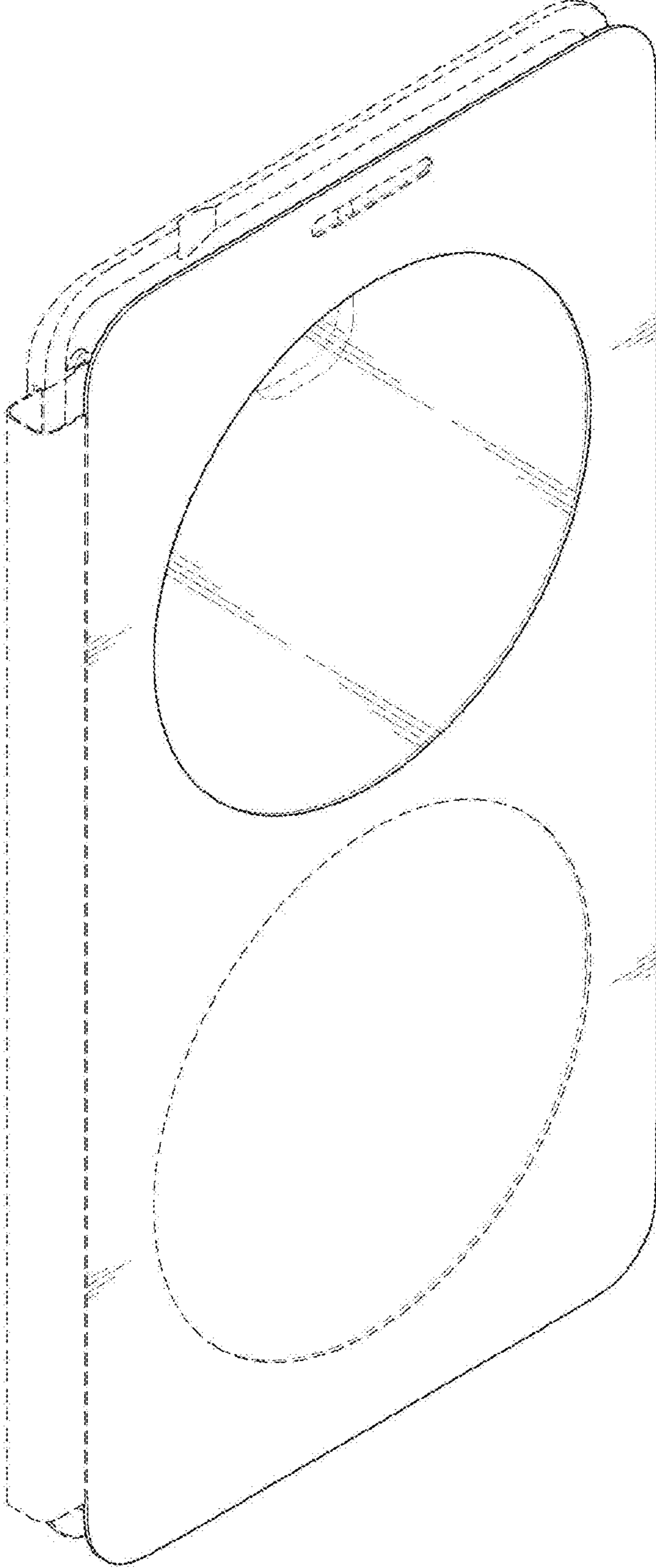

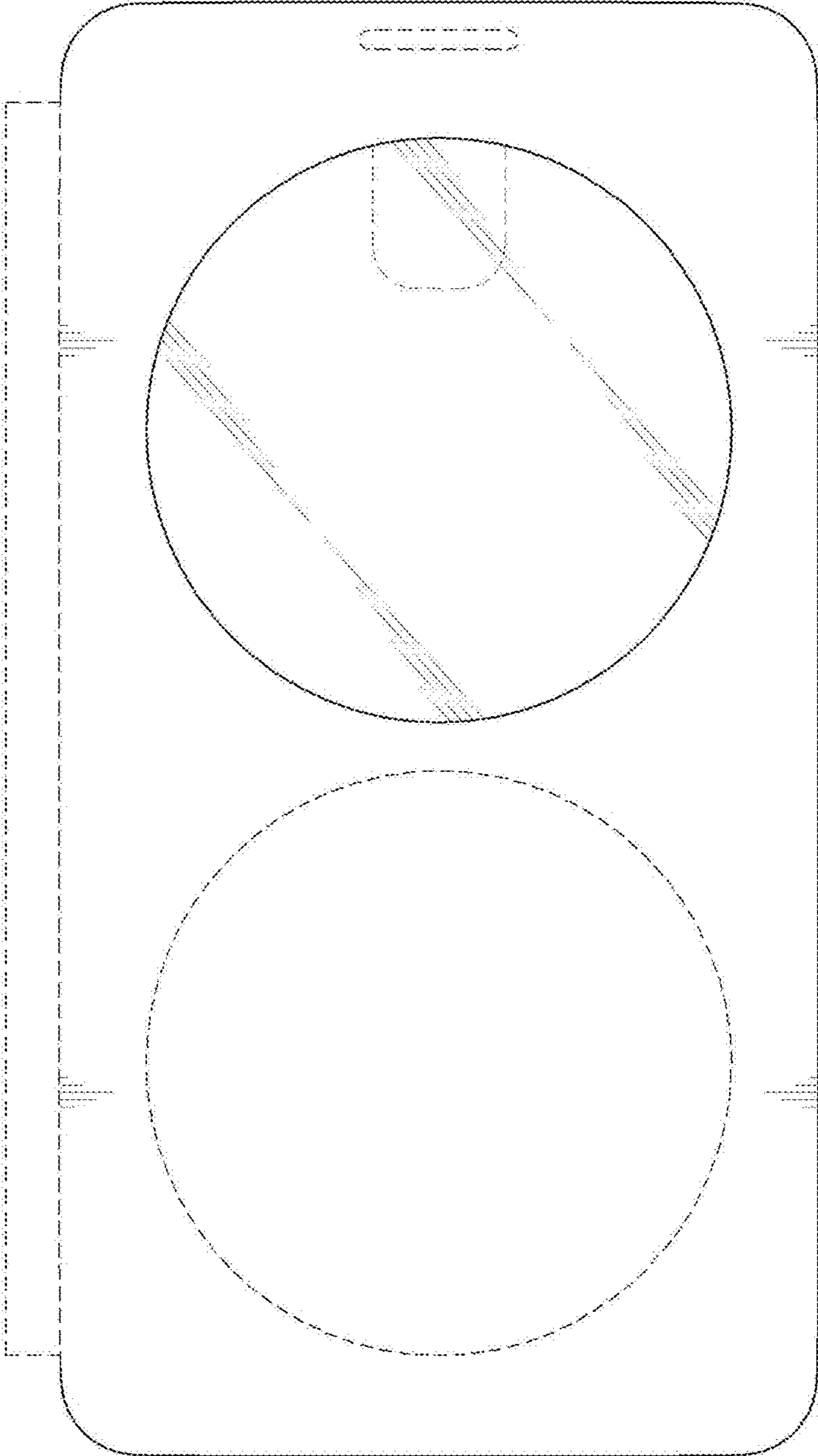

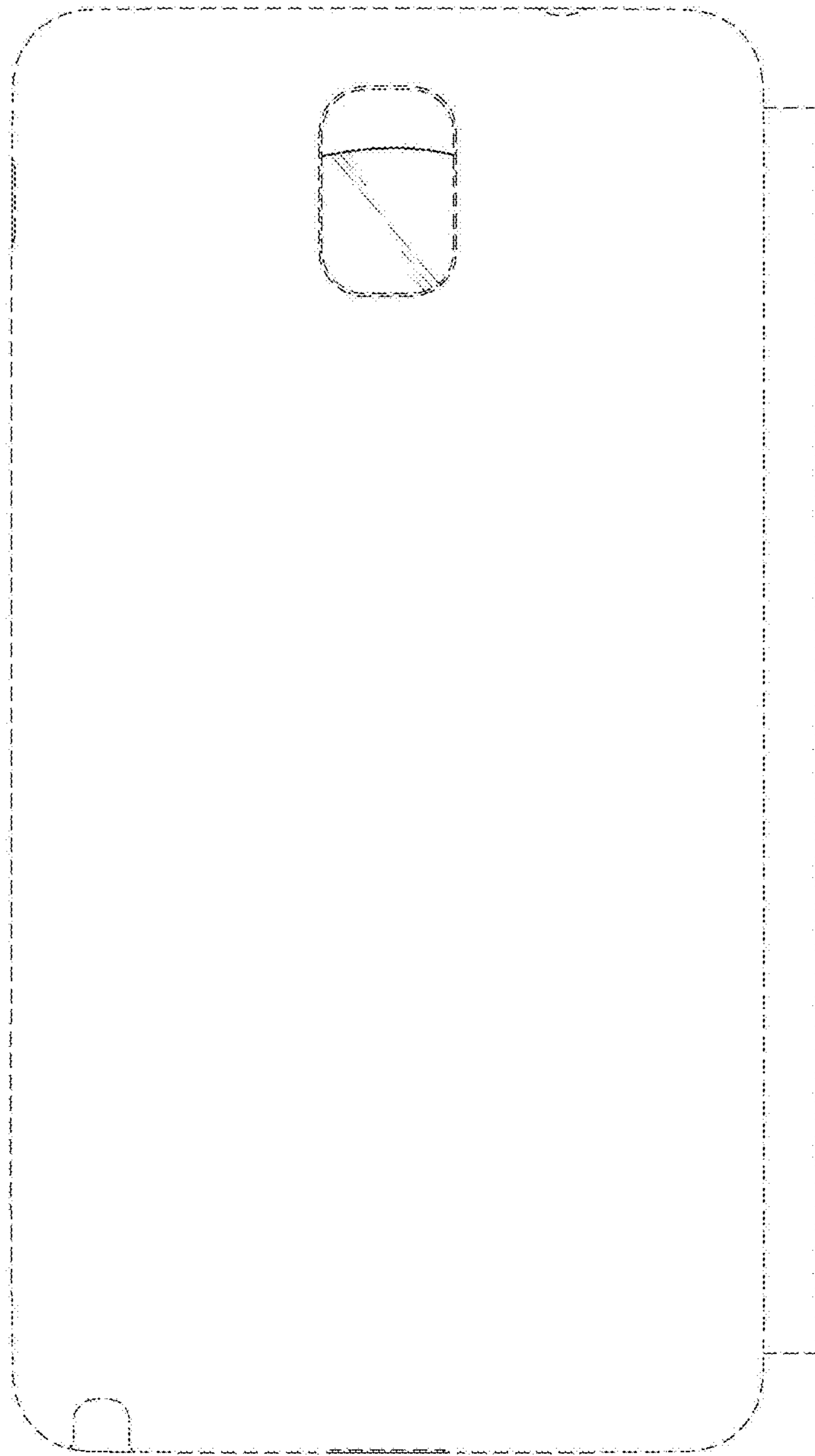

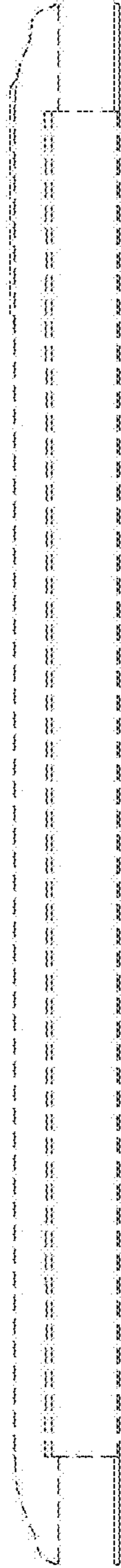

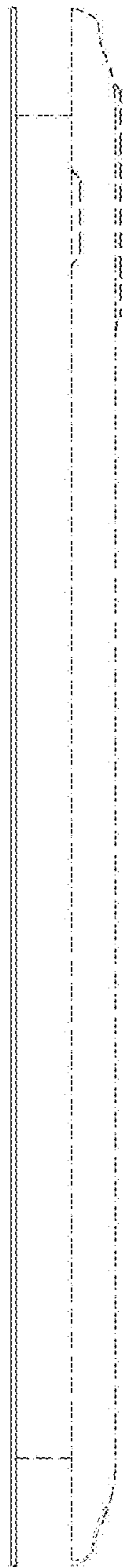

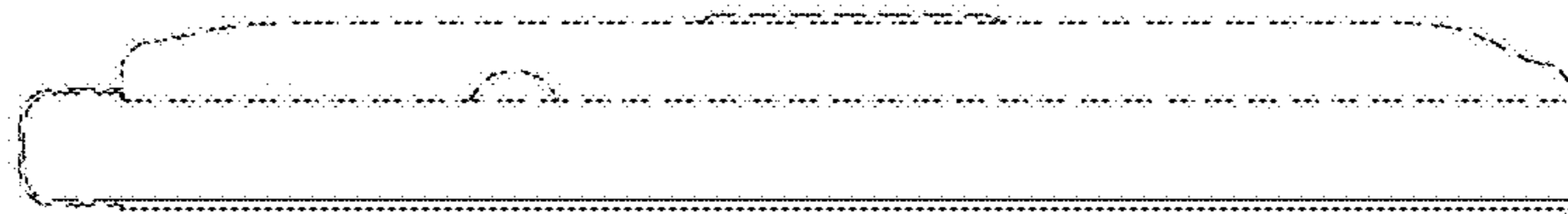
