DESCRIPTION

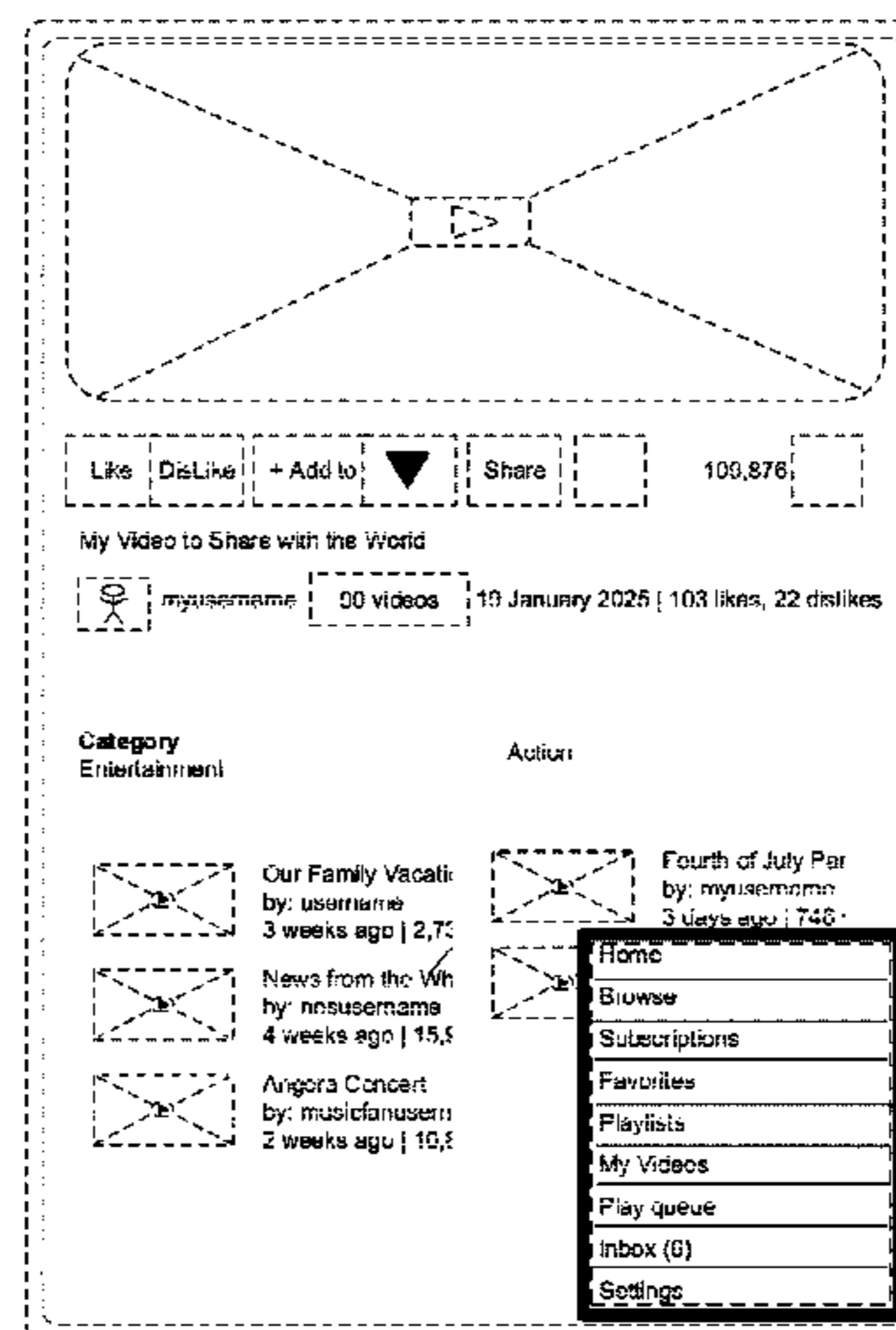
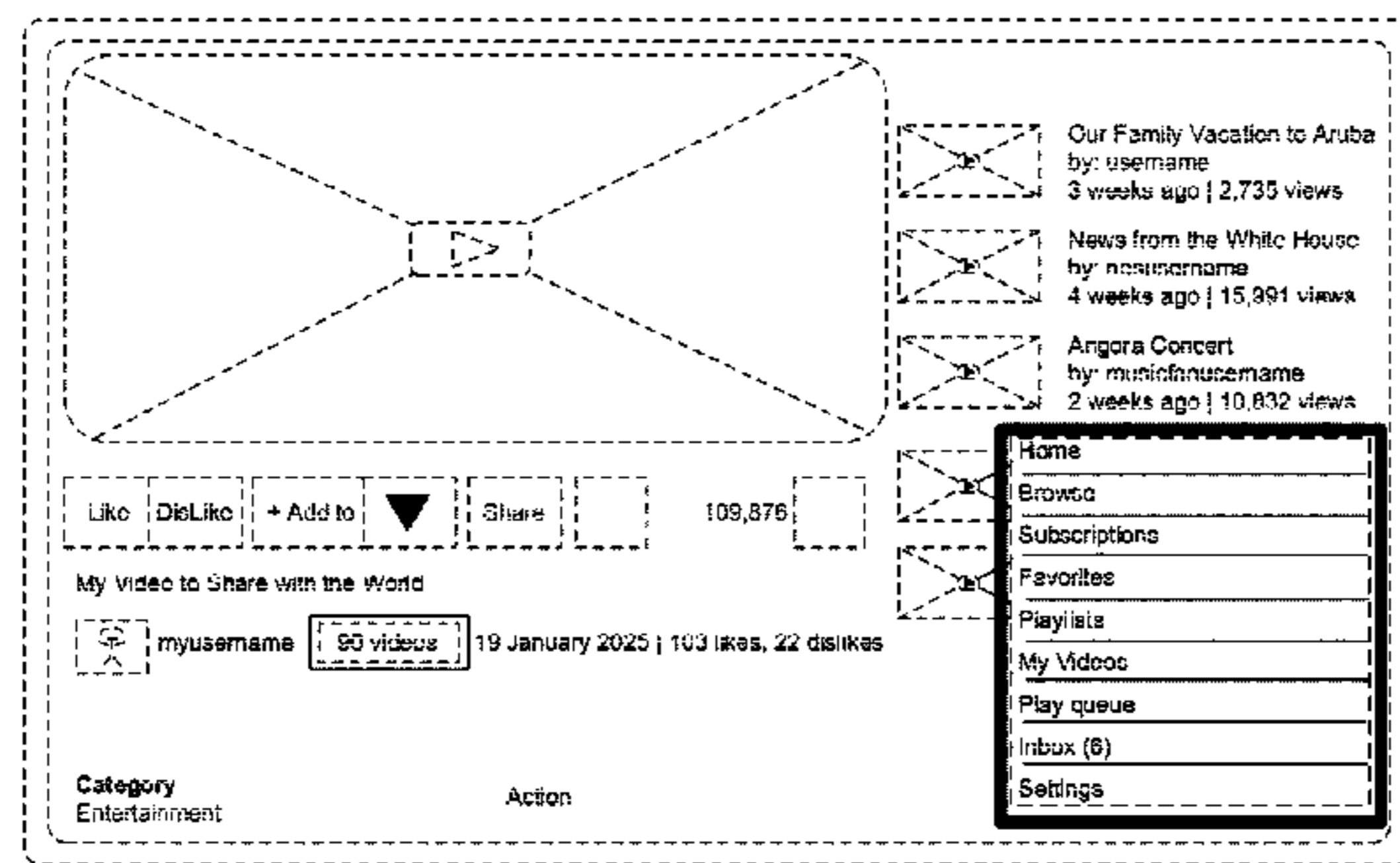
FIG. 1 is a front view of a display screen of a communication terminal with a graphical user interface;

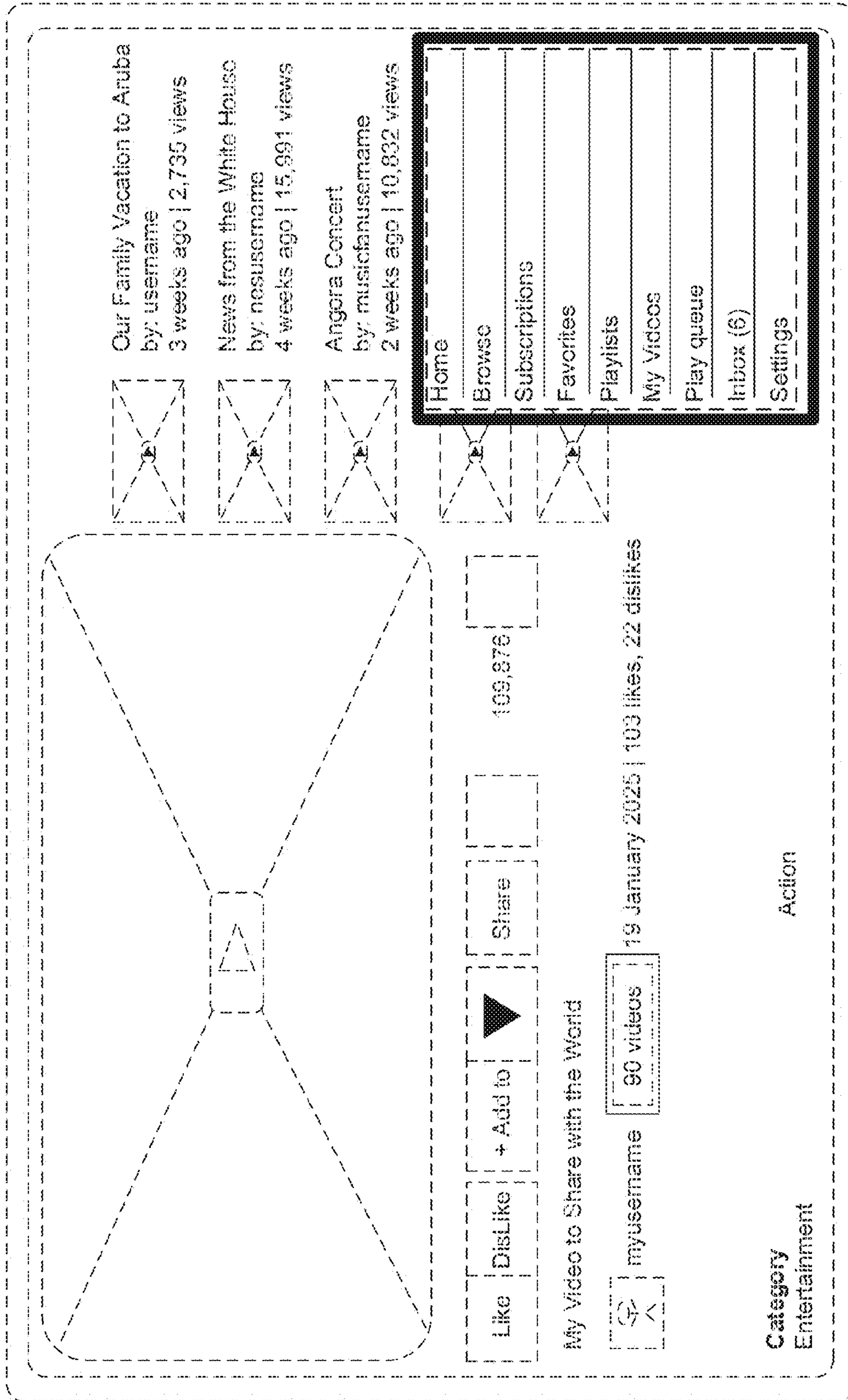

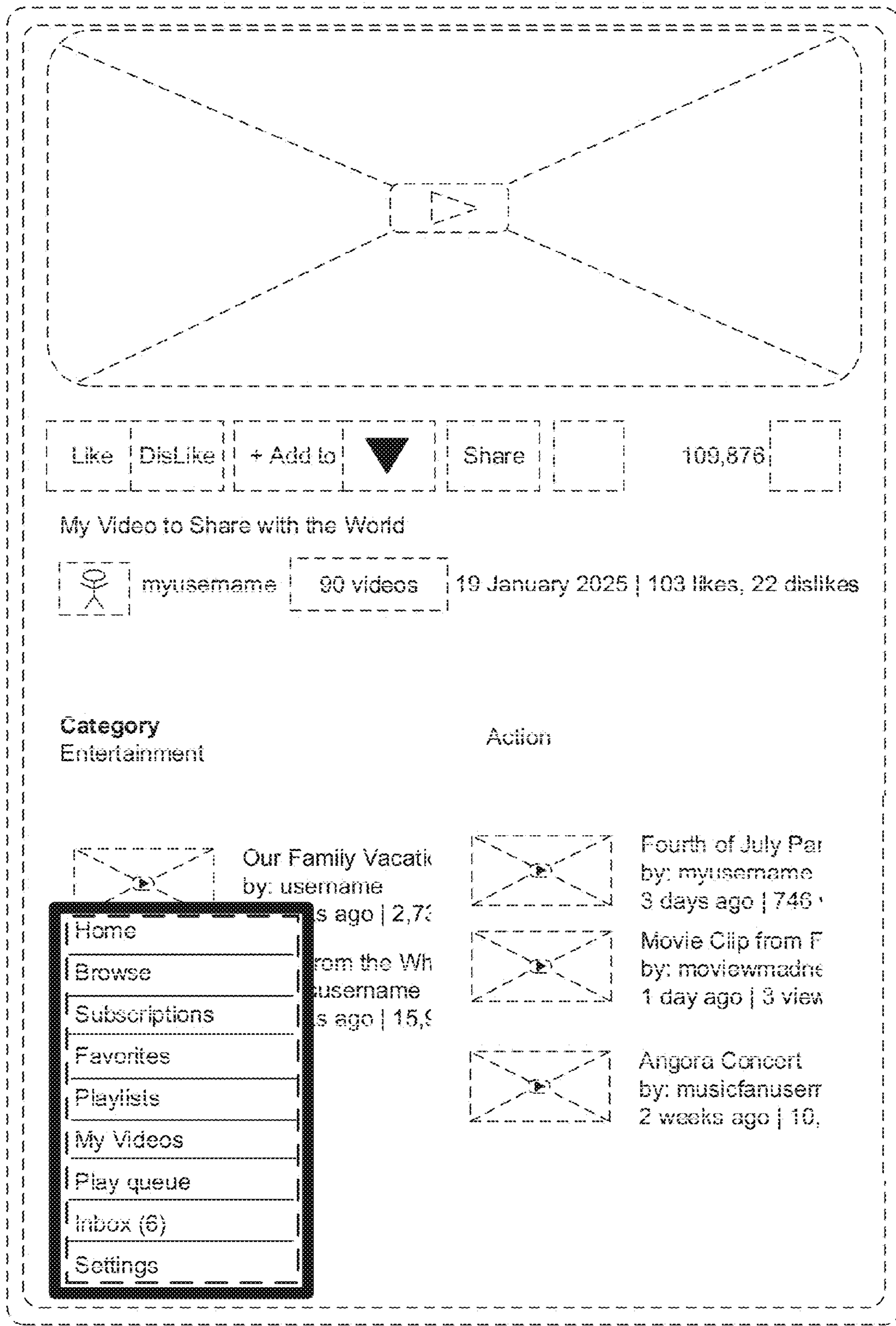

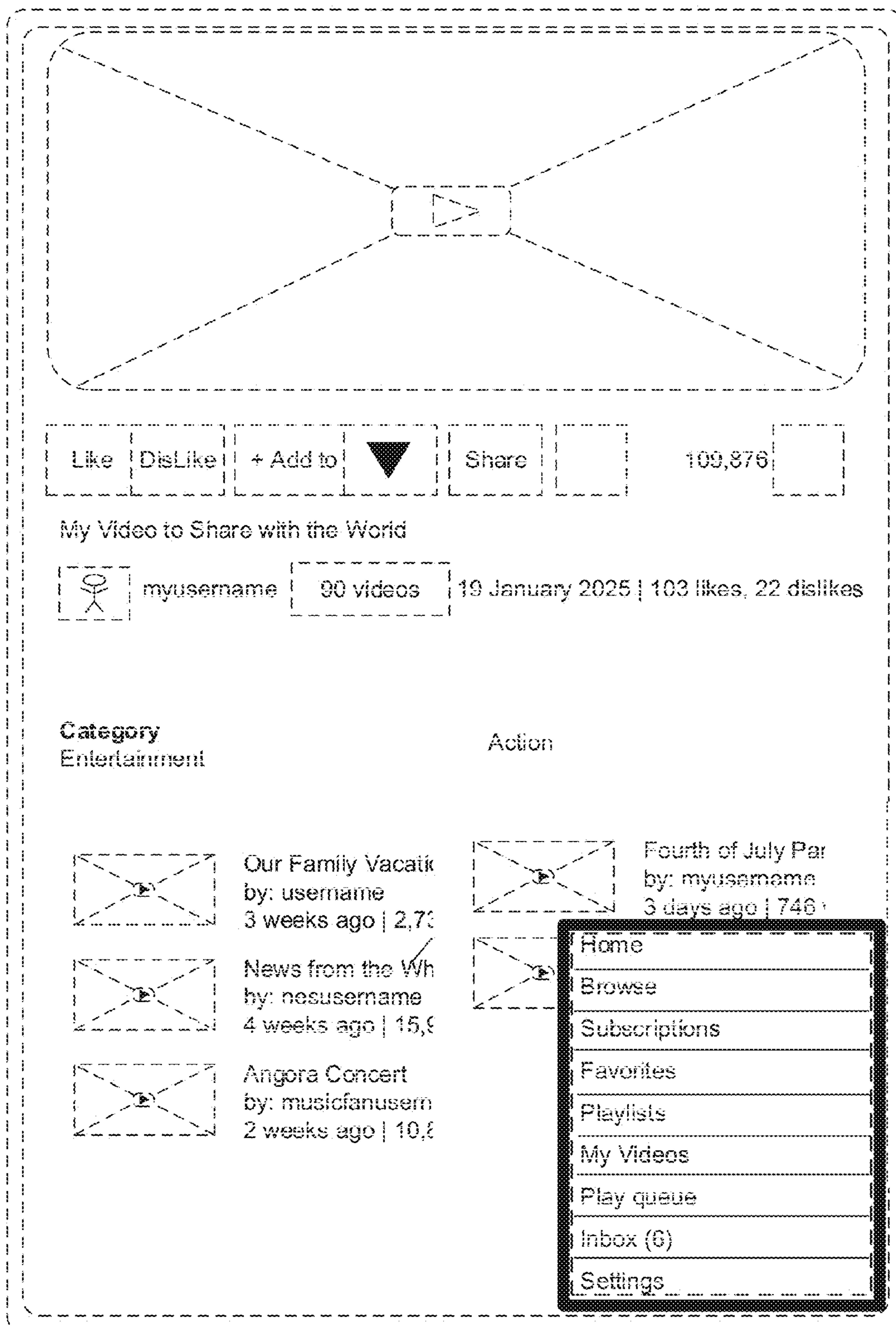
