(57) **CLAIM**

I claim the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing my new design; and, FIG. 2 is a front view thereof, in which a mobile terminal in broken lines is provided to illustrate an example environment. The broken line drawing of the mobile terminal, and the text/words, numbers, symbols, and otherwise images shown in broken lines in the graphical user interface of FIGS. 1 and 2 are for illustrative purposes only and form no part of the claimed design.

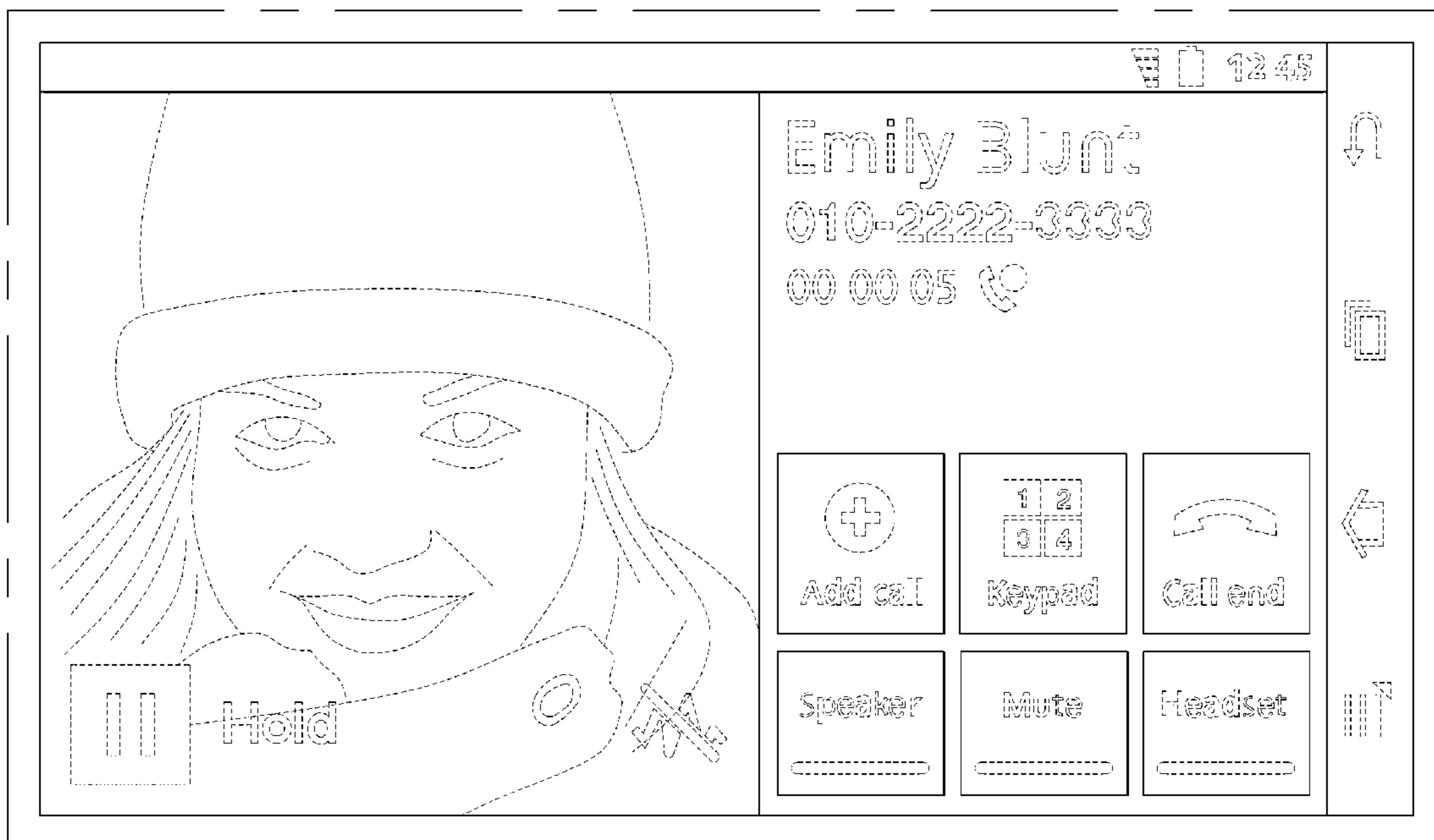

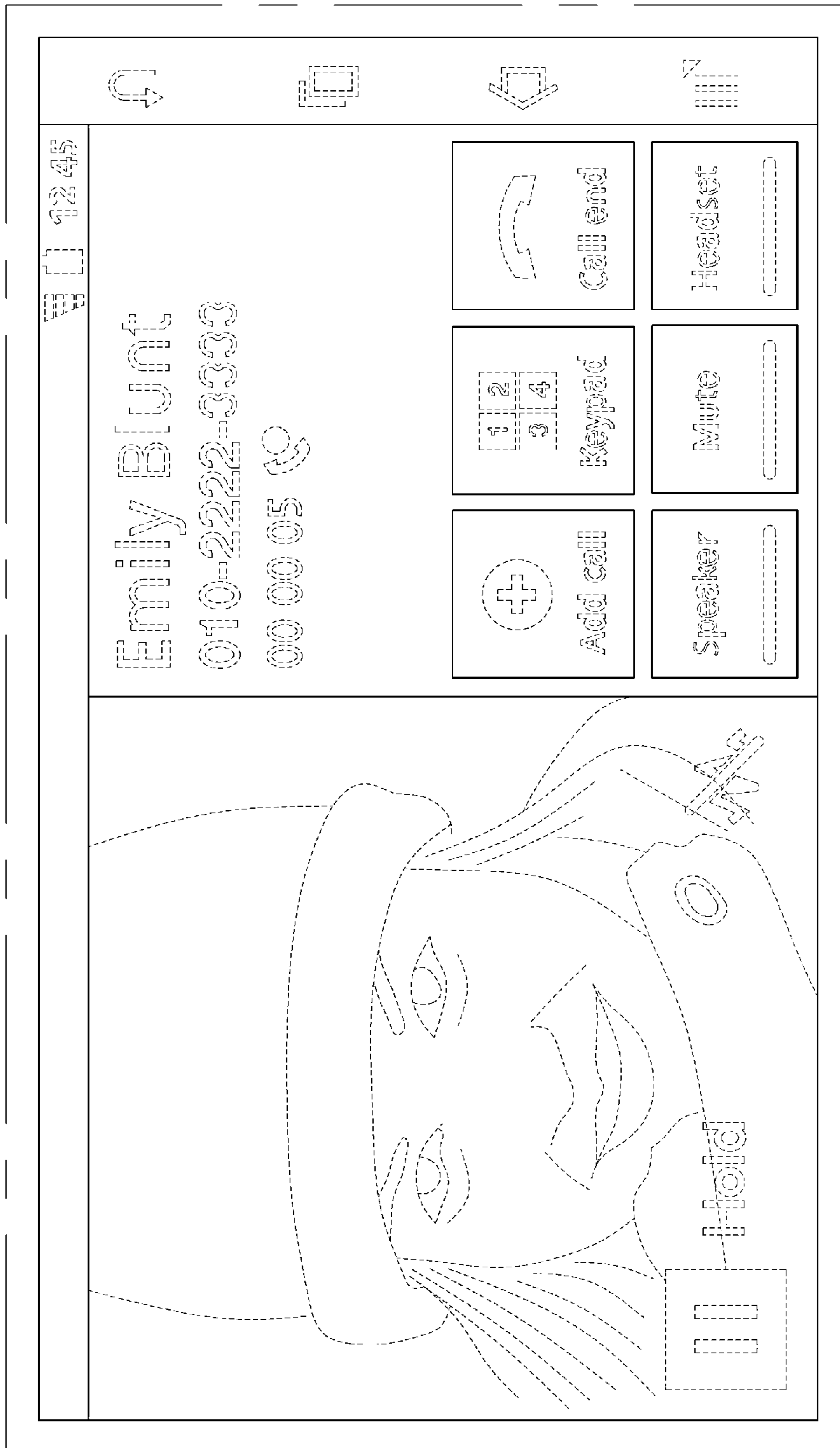
