FIG. 1 is a front view of a display screen with icon showing the new design;

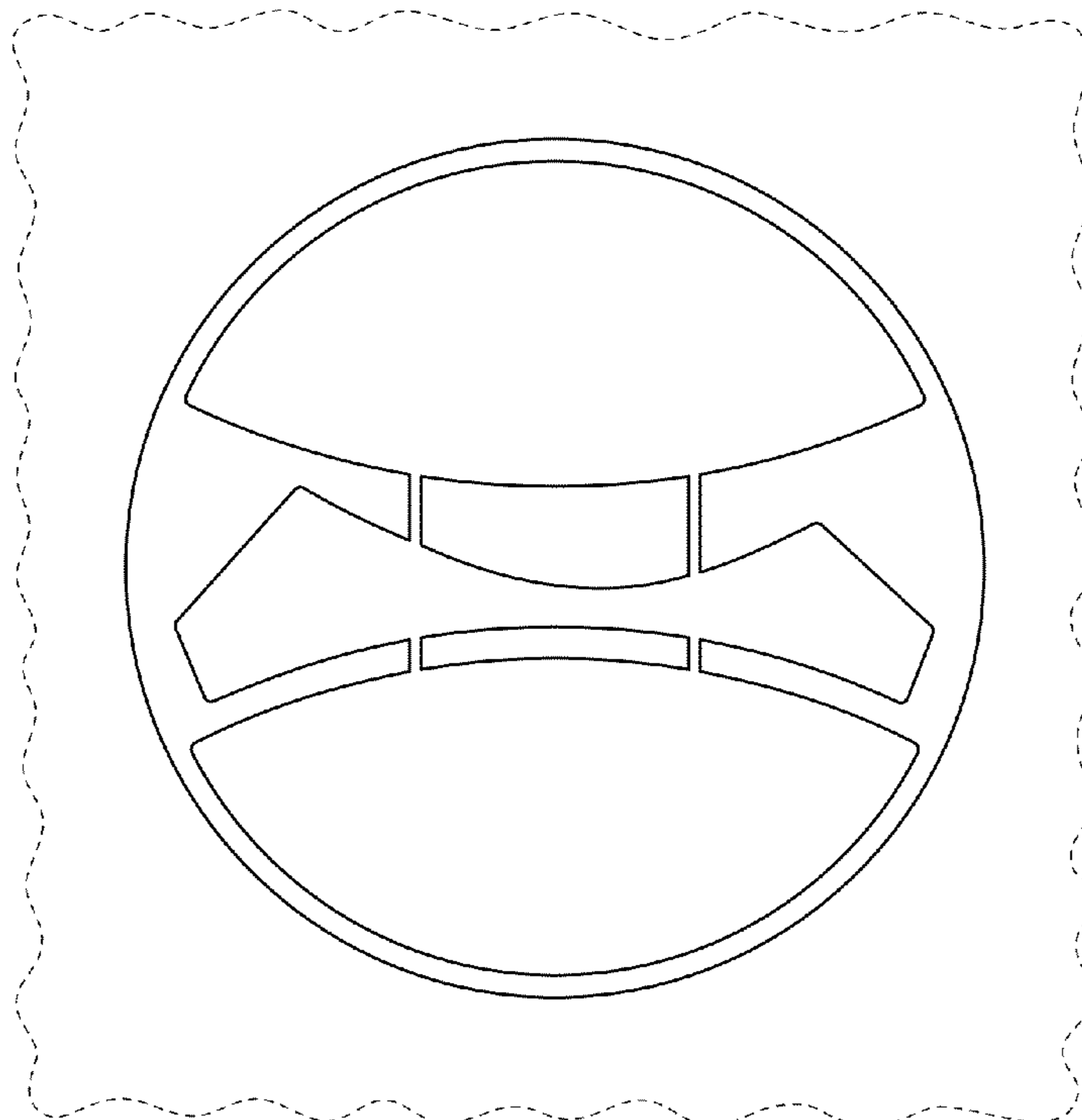
FIG. 2 is a front view of a display screen with icon showing an alternative embodiment of the new design; and,

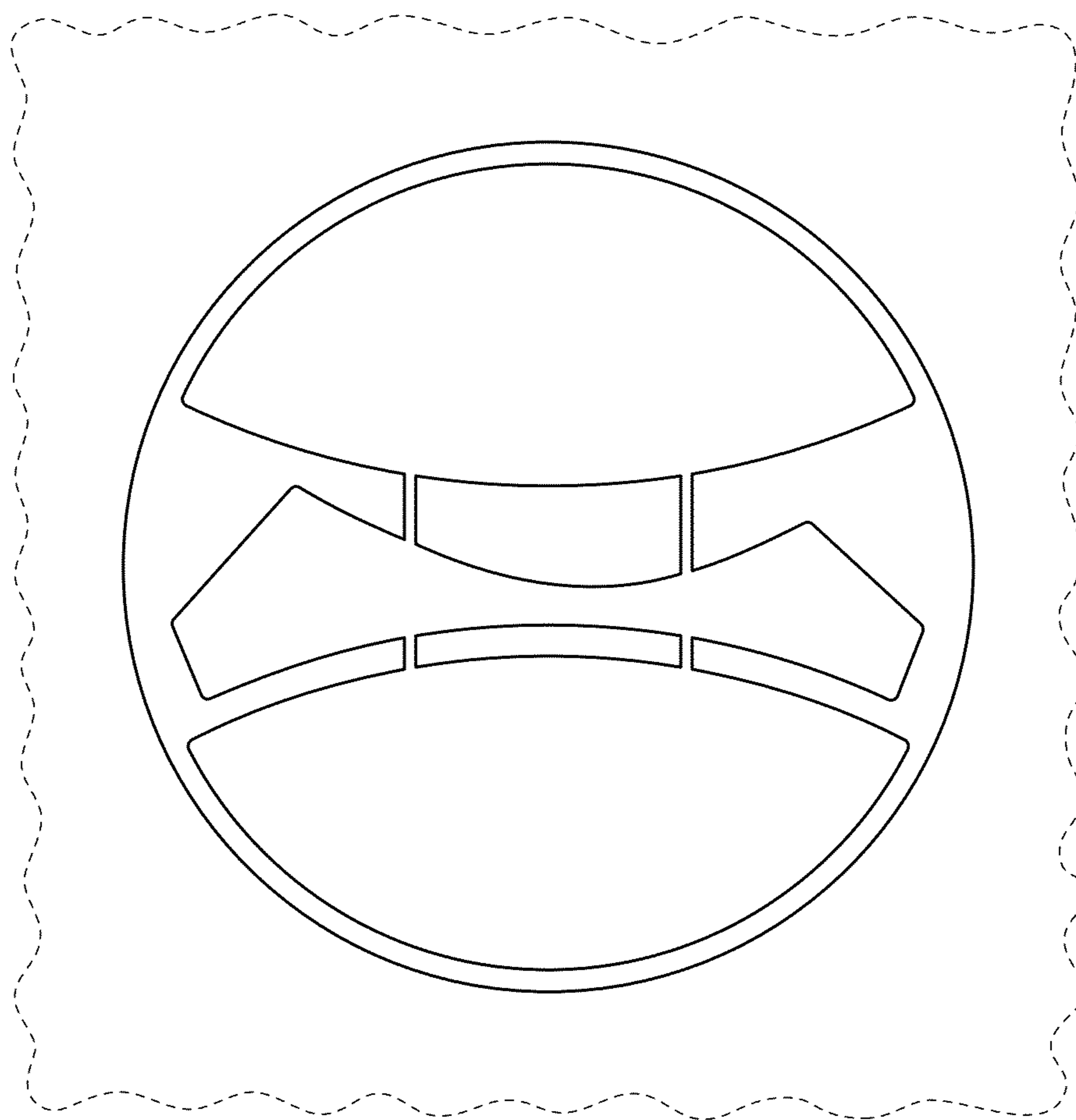

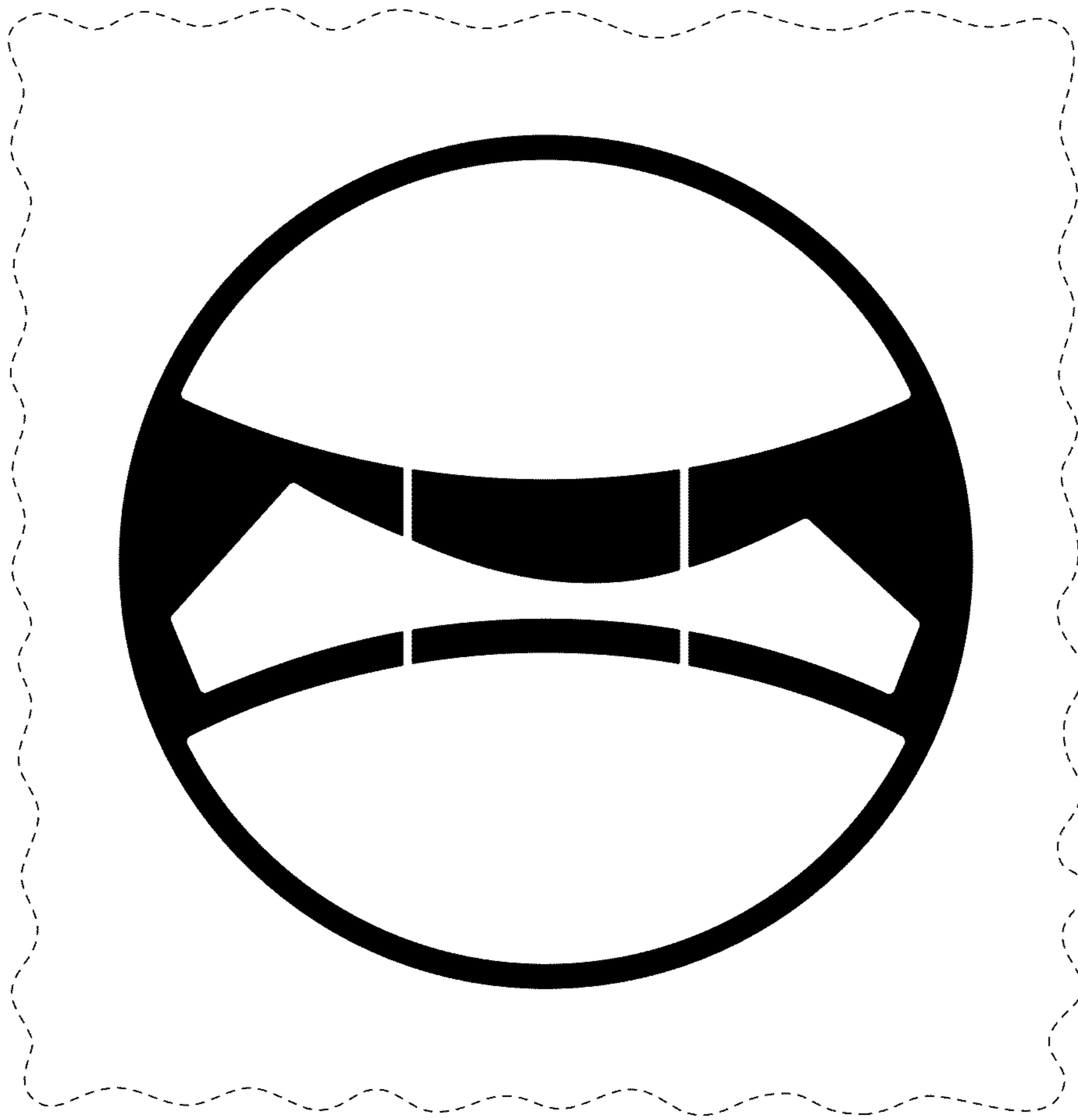

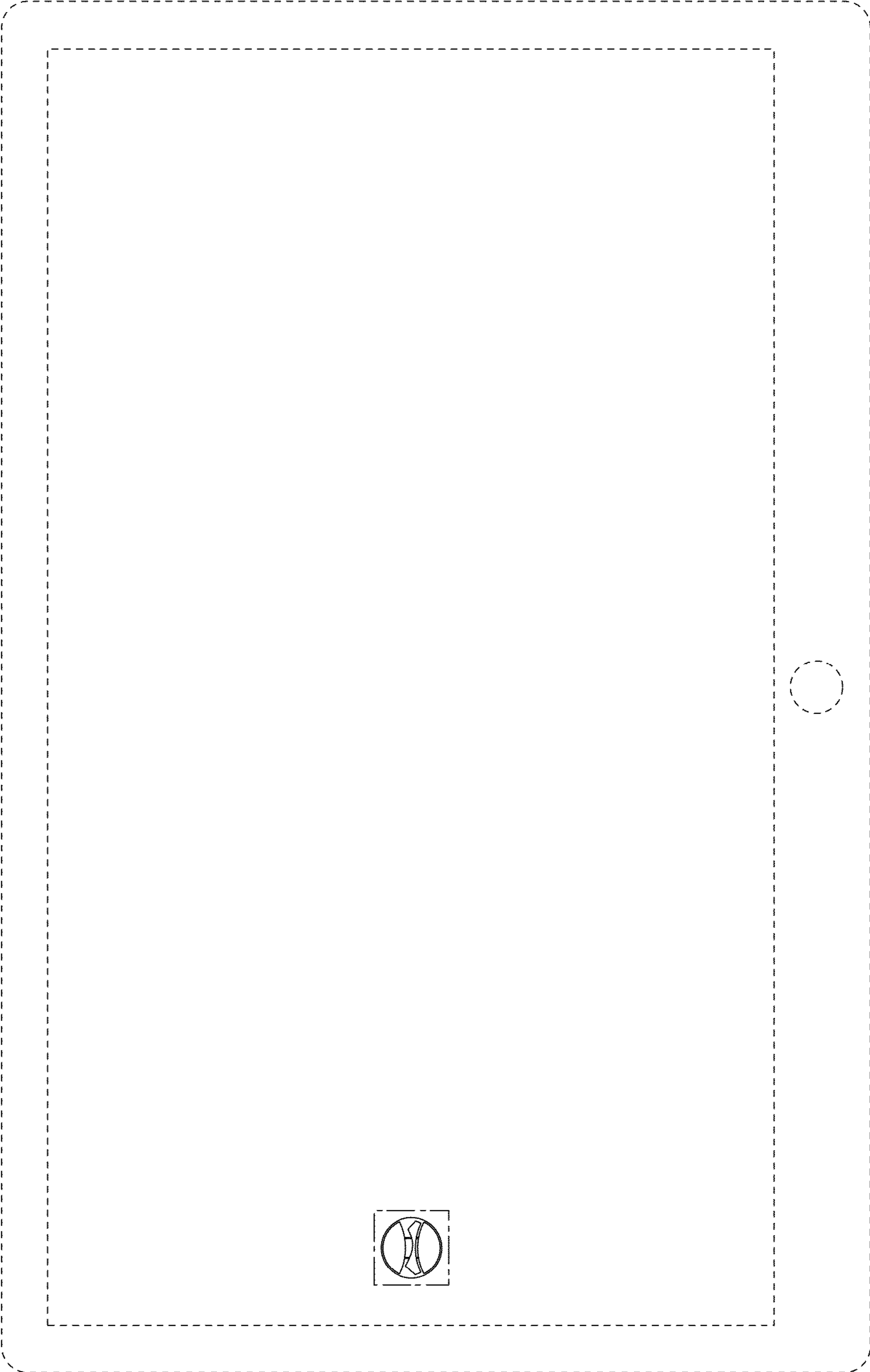
