The broken line representation of the display screen or portion thereof forms no part of the claimed design.

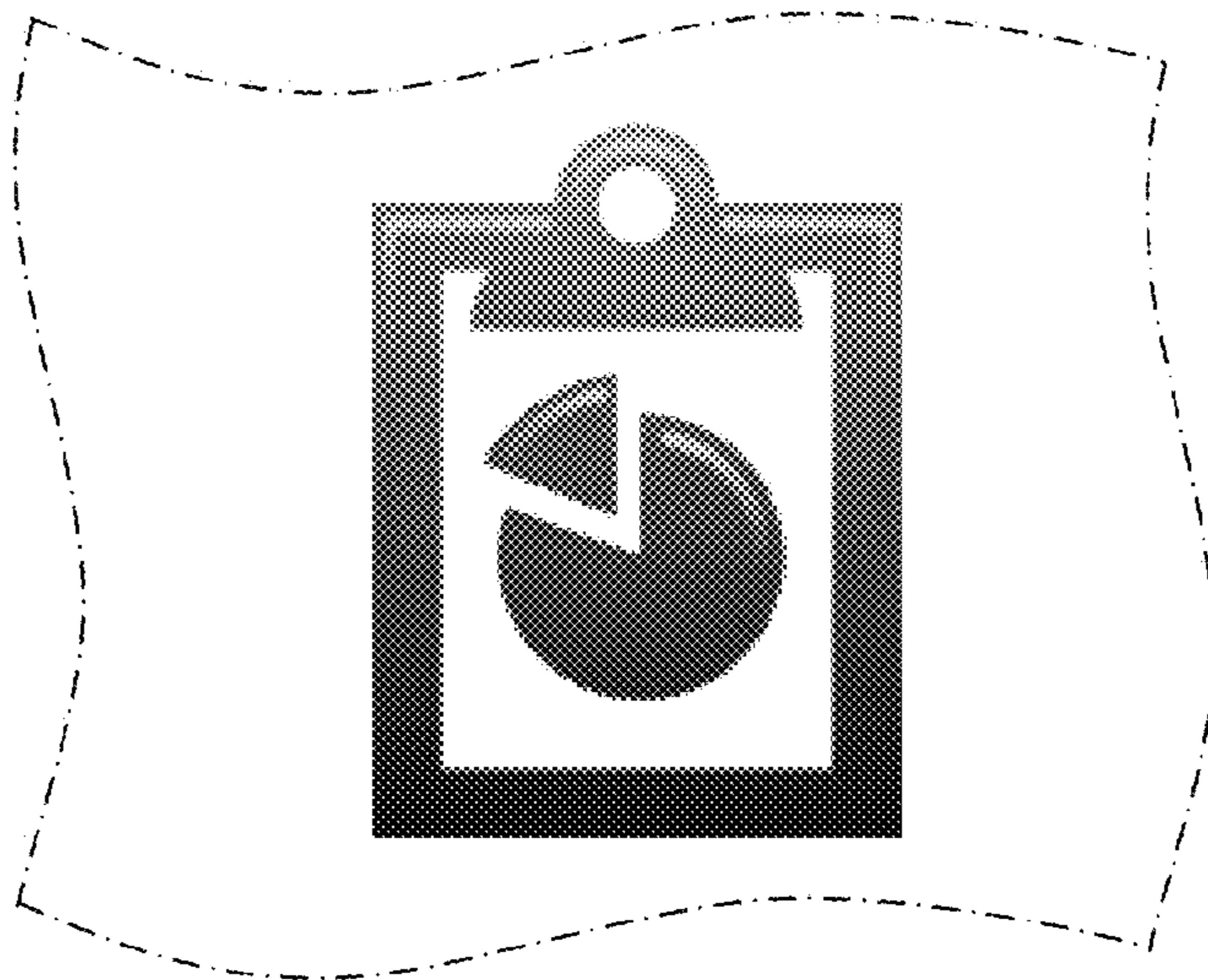

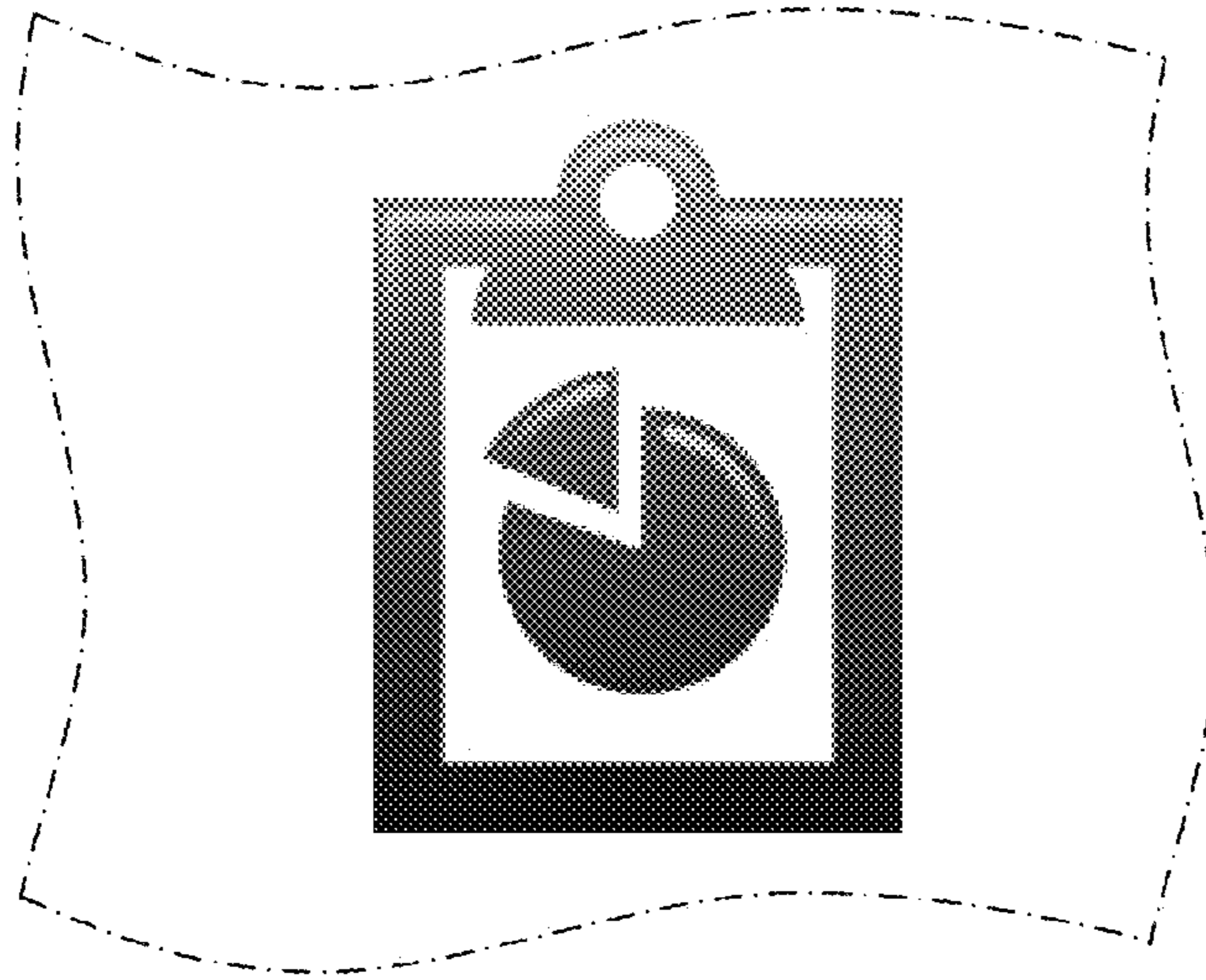

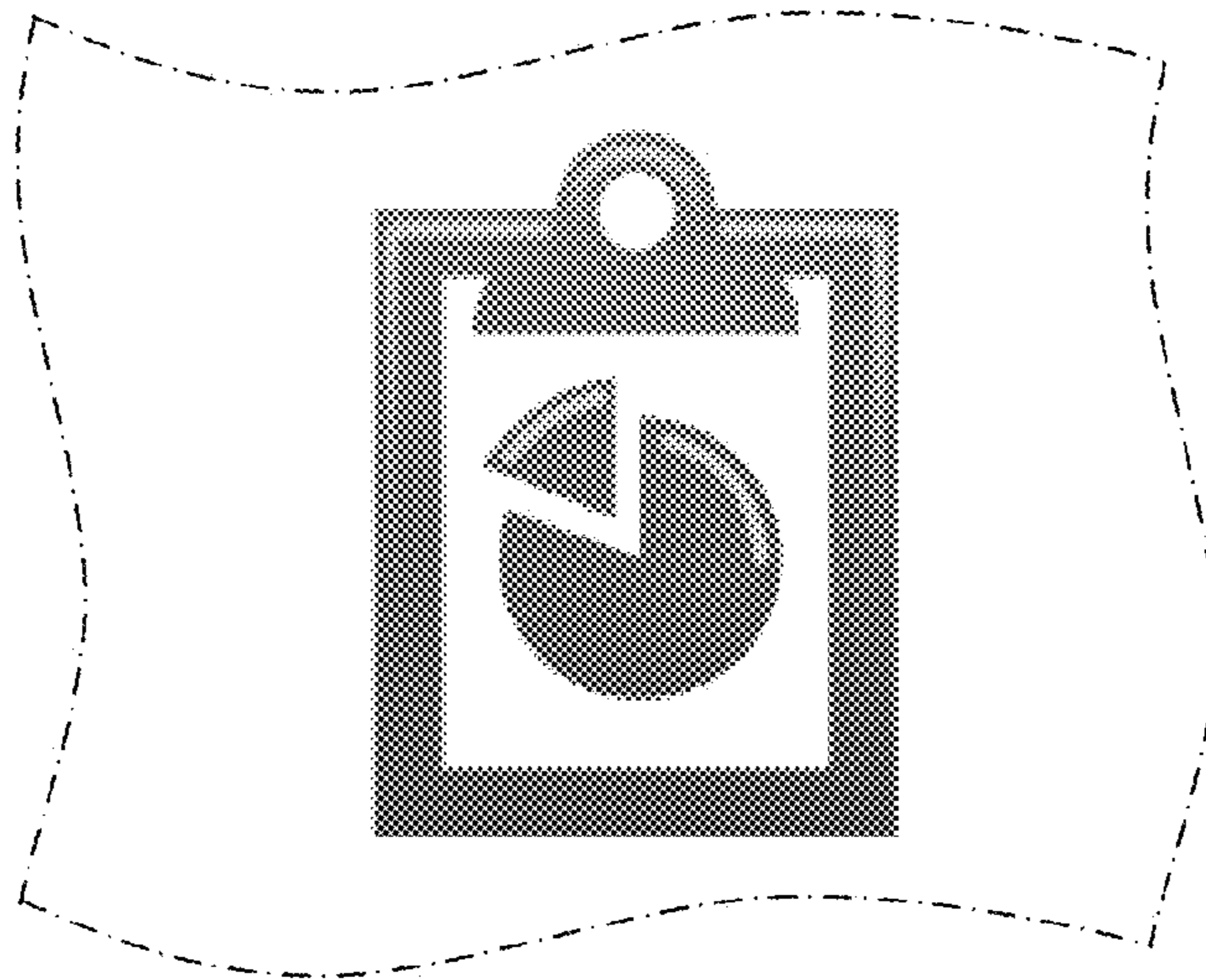

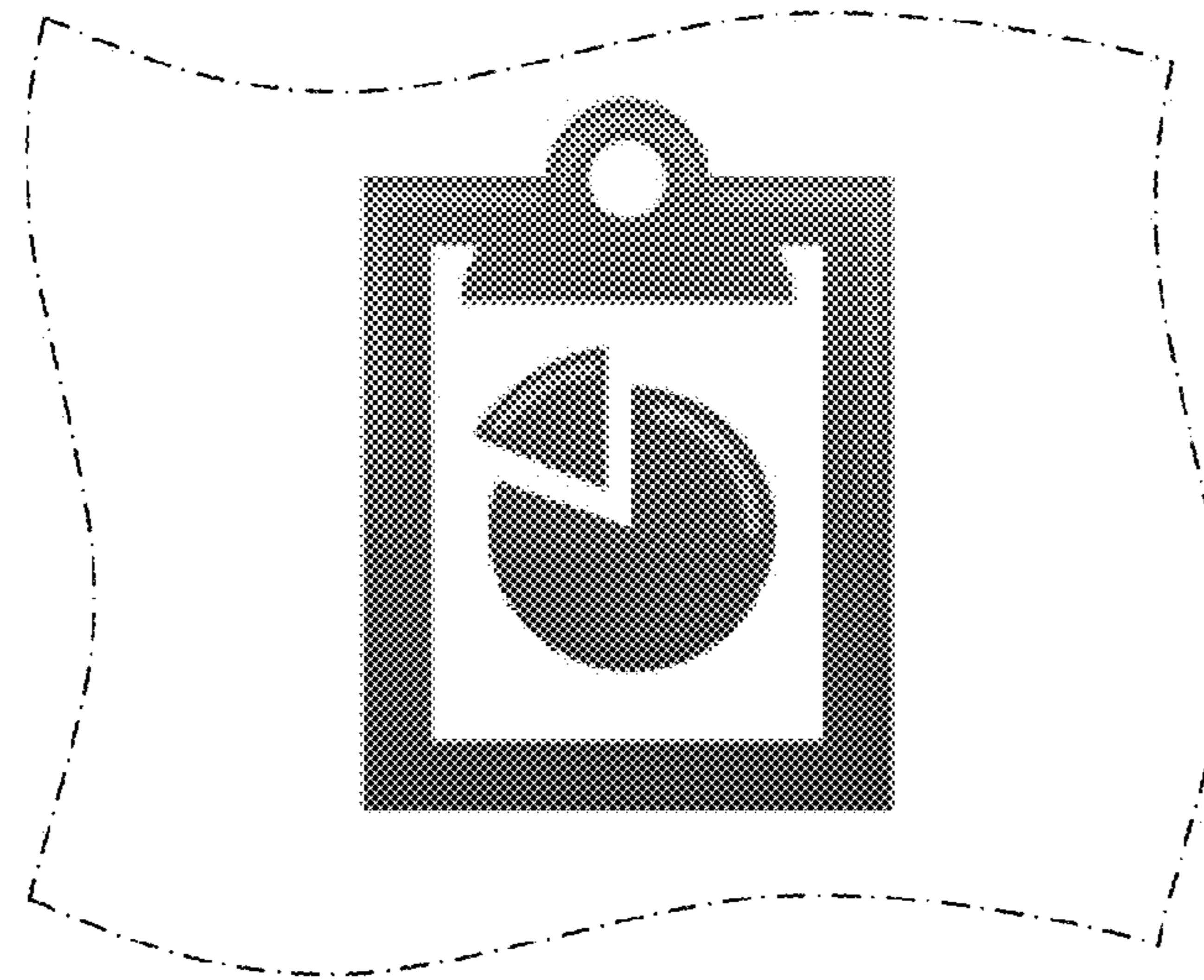
