(57) **CLAIM**

The ornamental design for a combined decorative composition book and planner, as shown and described.

**DESCRIPTION**

FIG. 14 is a perspective view of the combined decorative composition book and planner, showing its seventh open position configuration thereof.

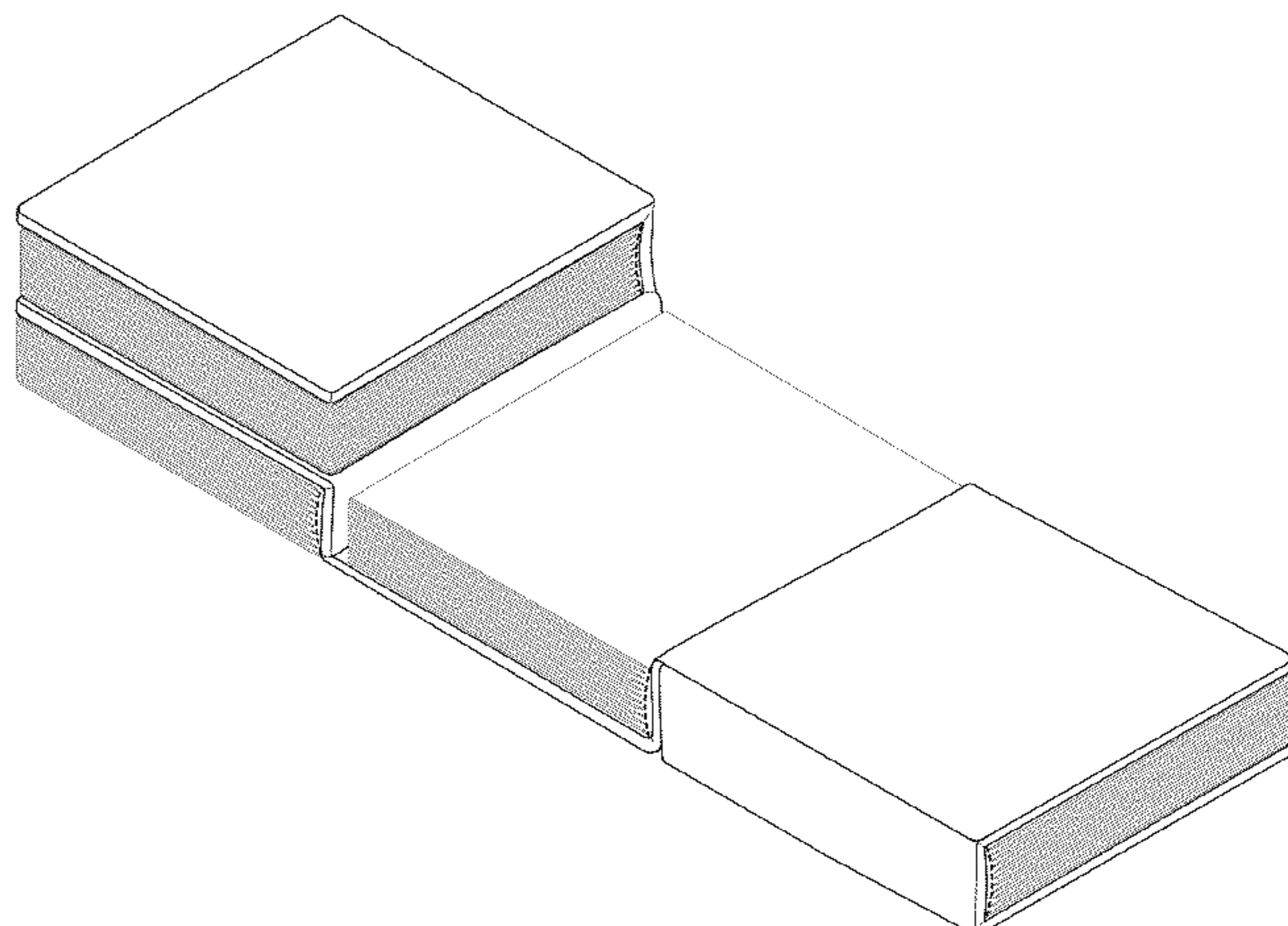
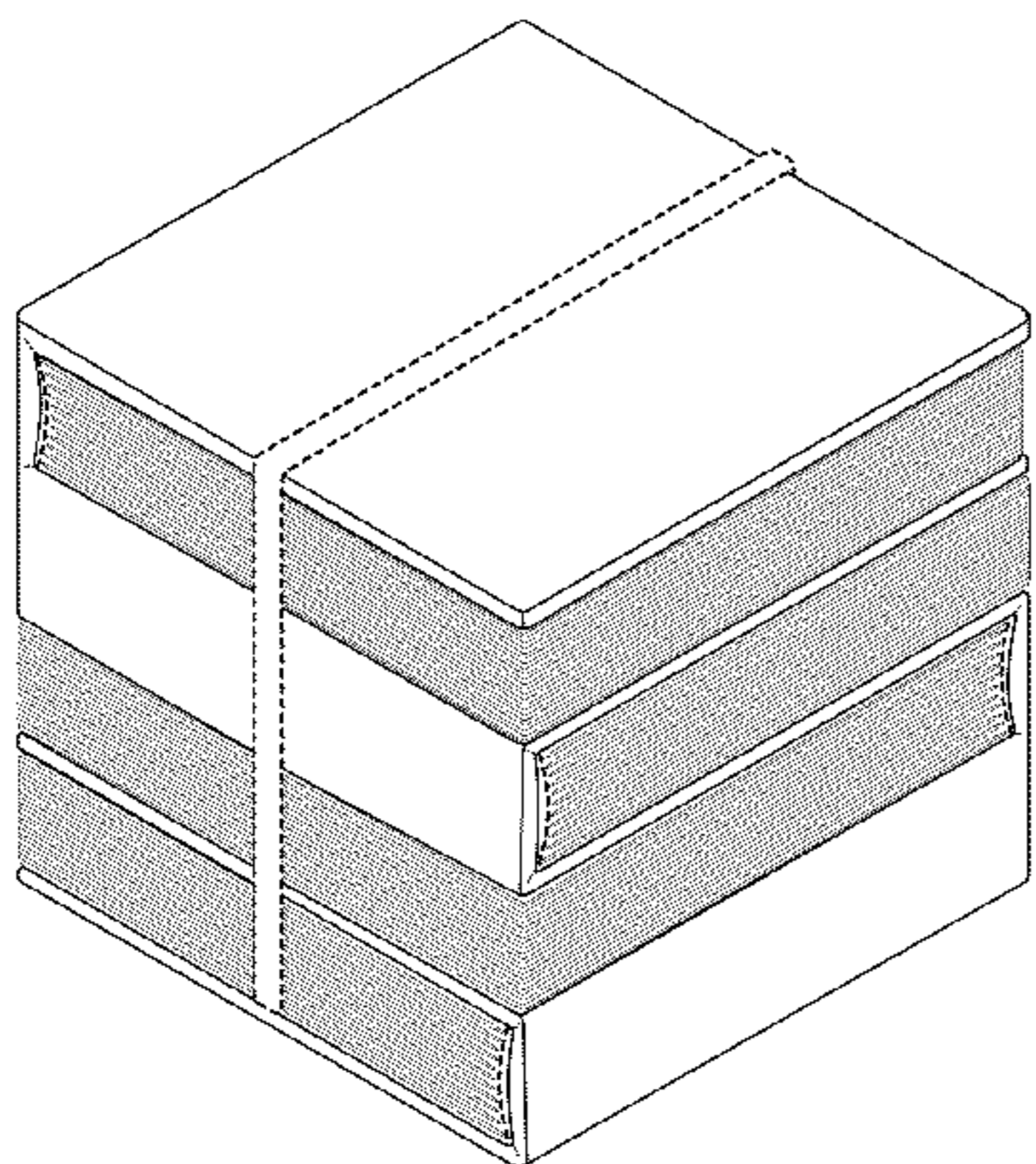
FIG. 15 is a perspective view of the combined decorative composition book and planner, showing its eighth open position configuration thereof.

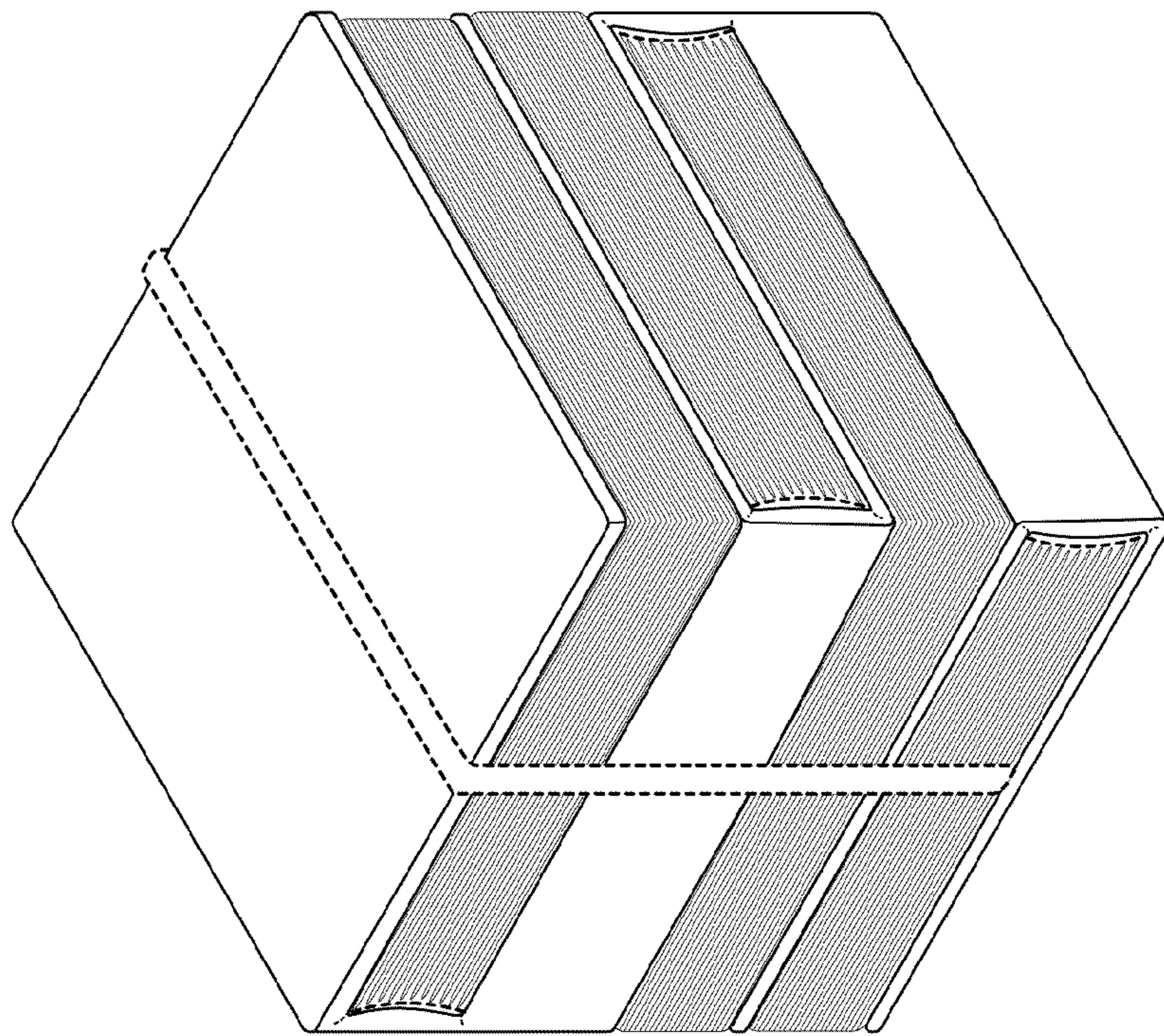

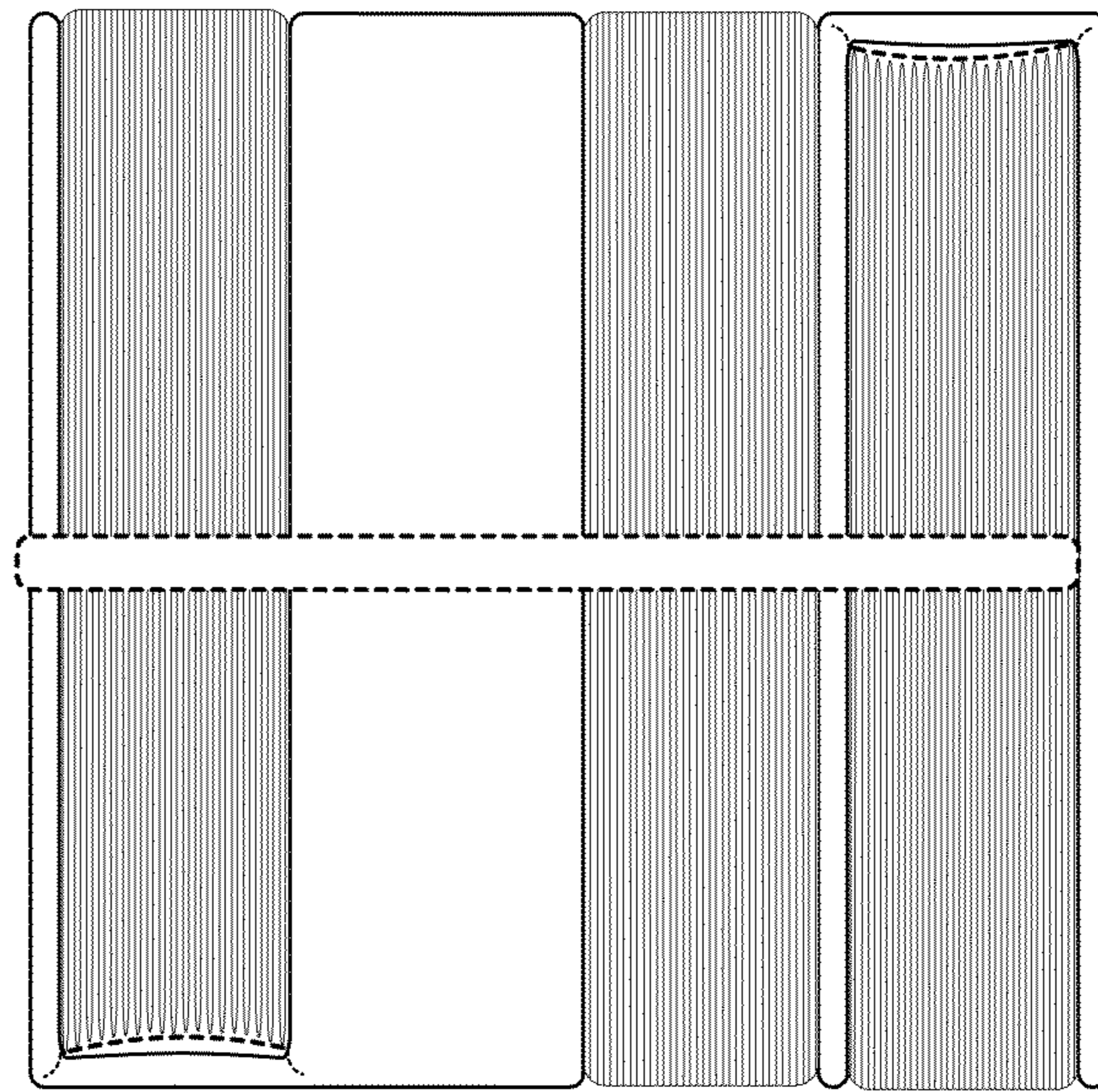

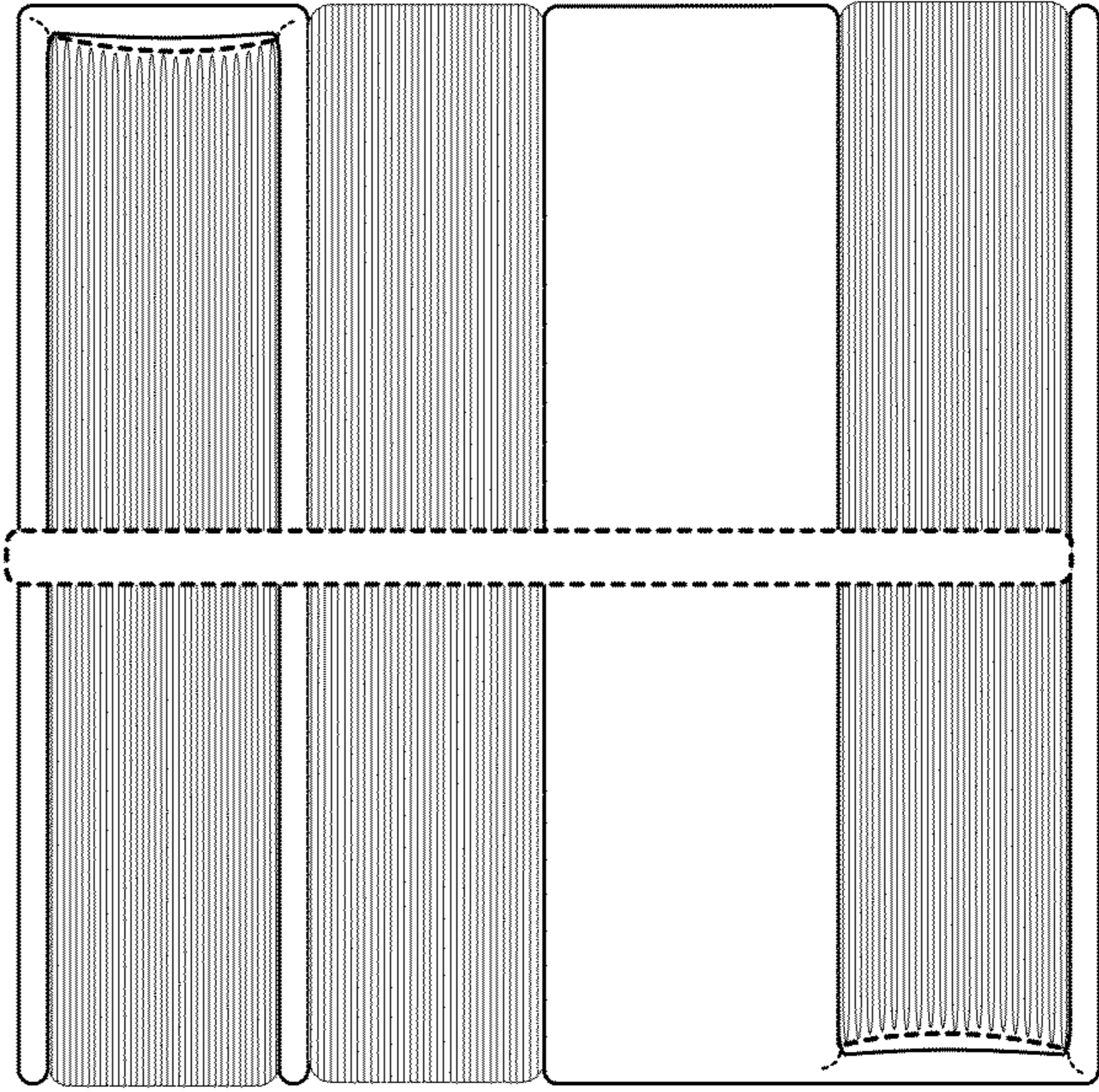

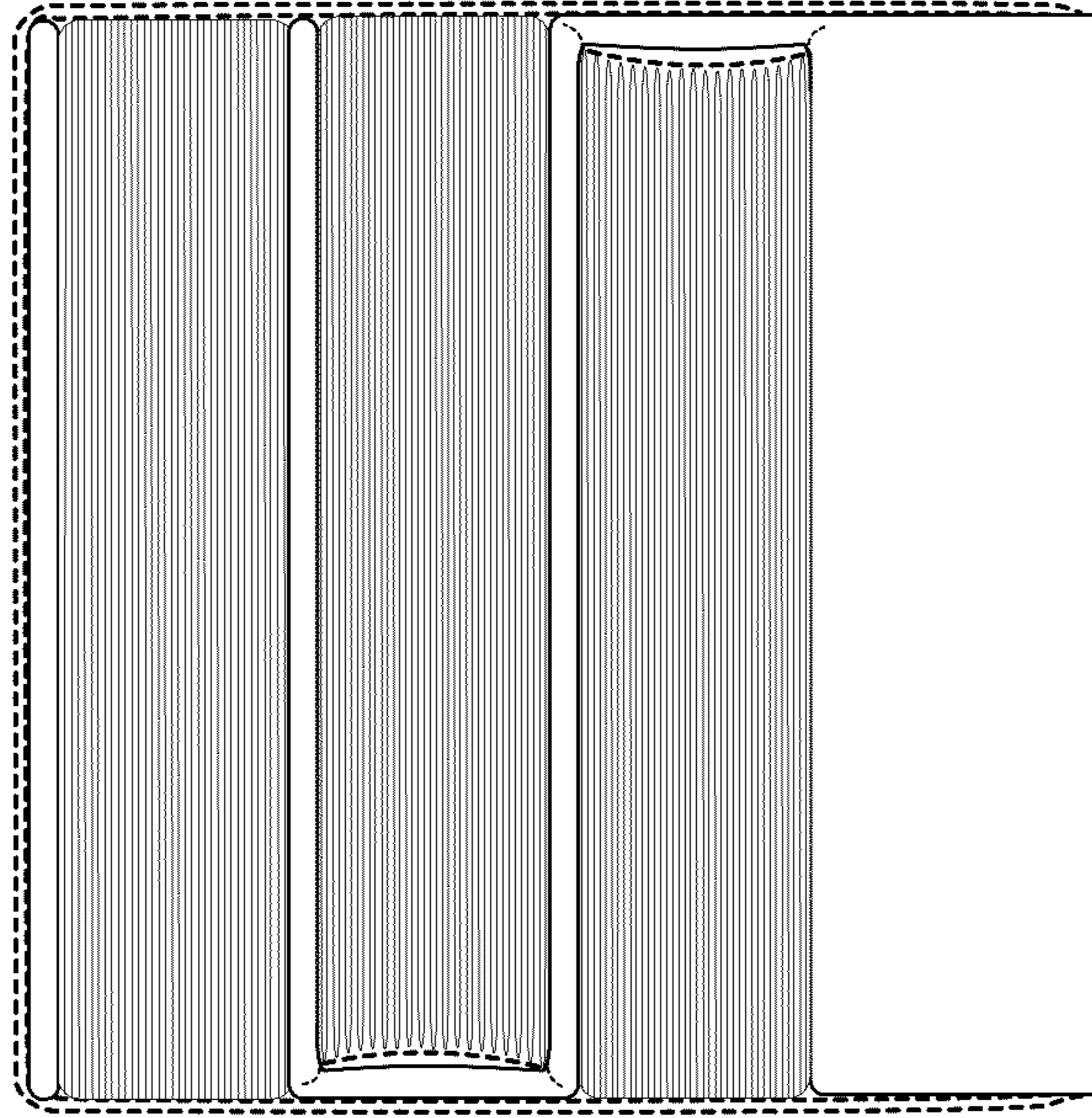

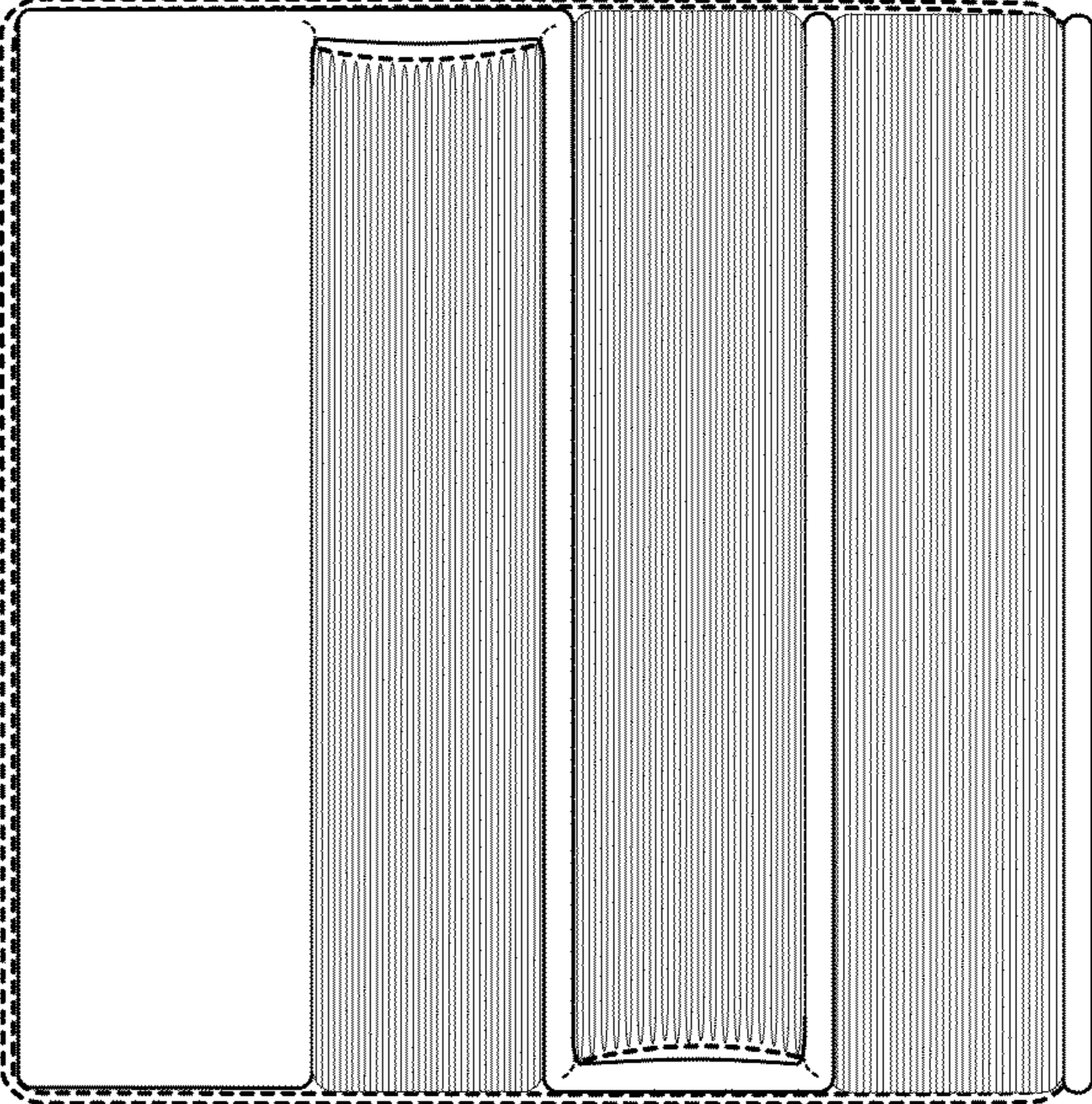

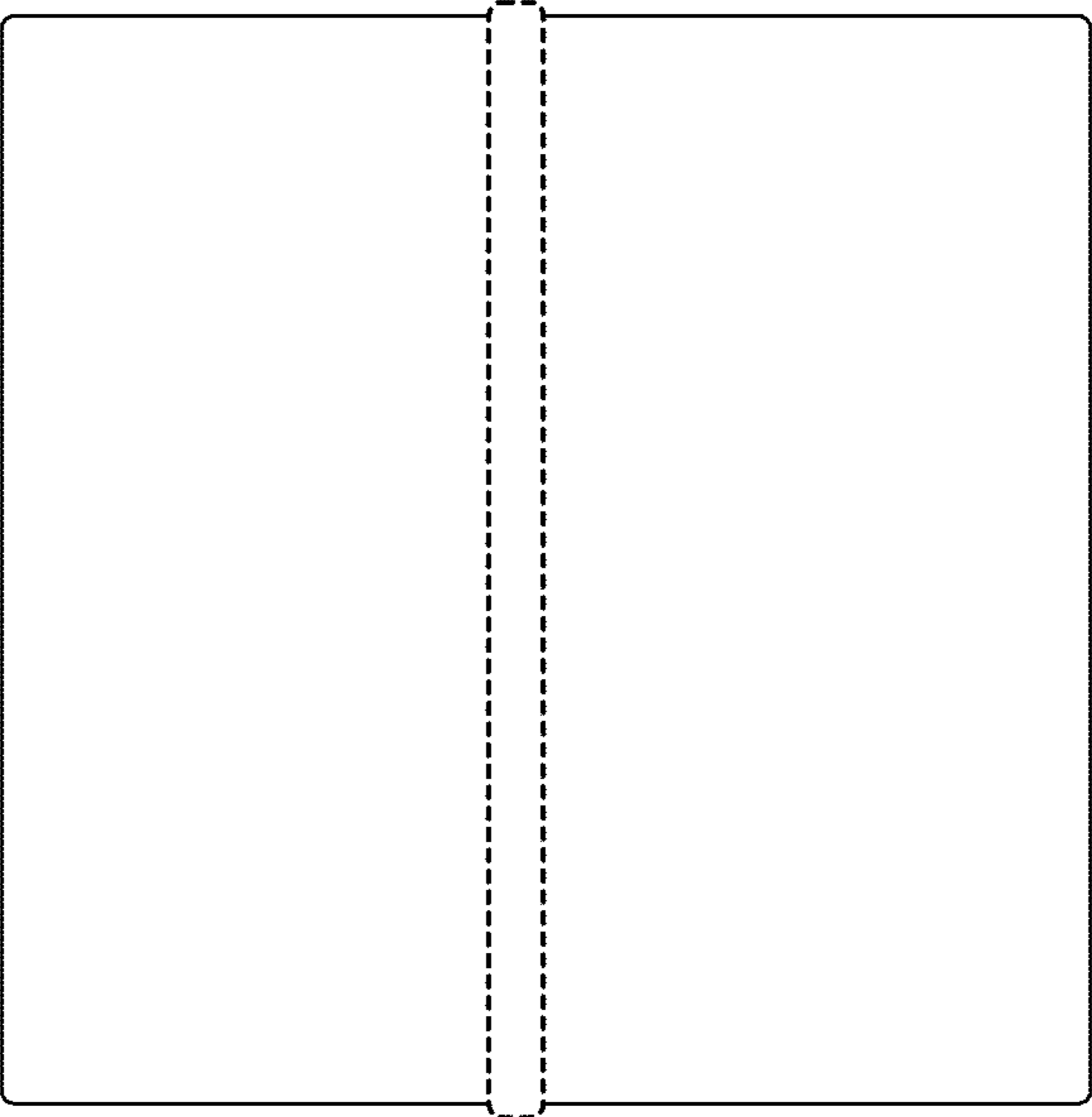

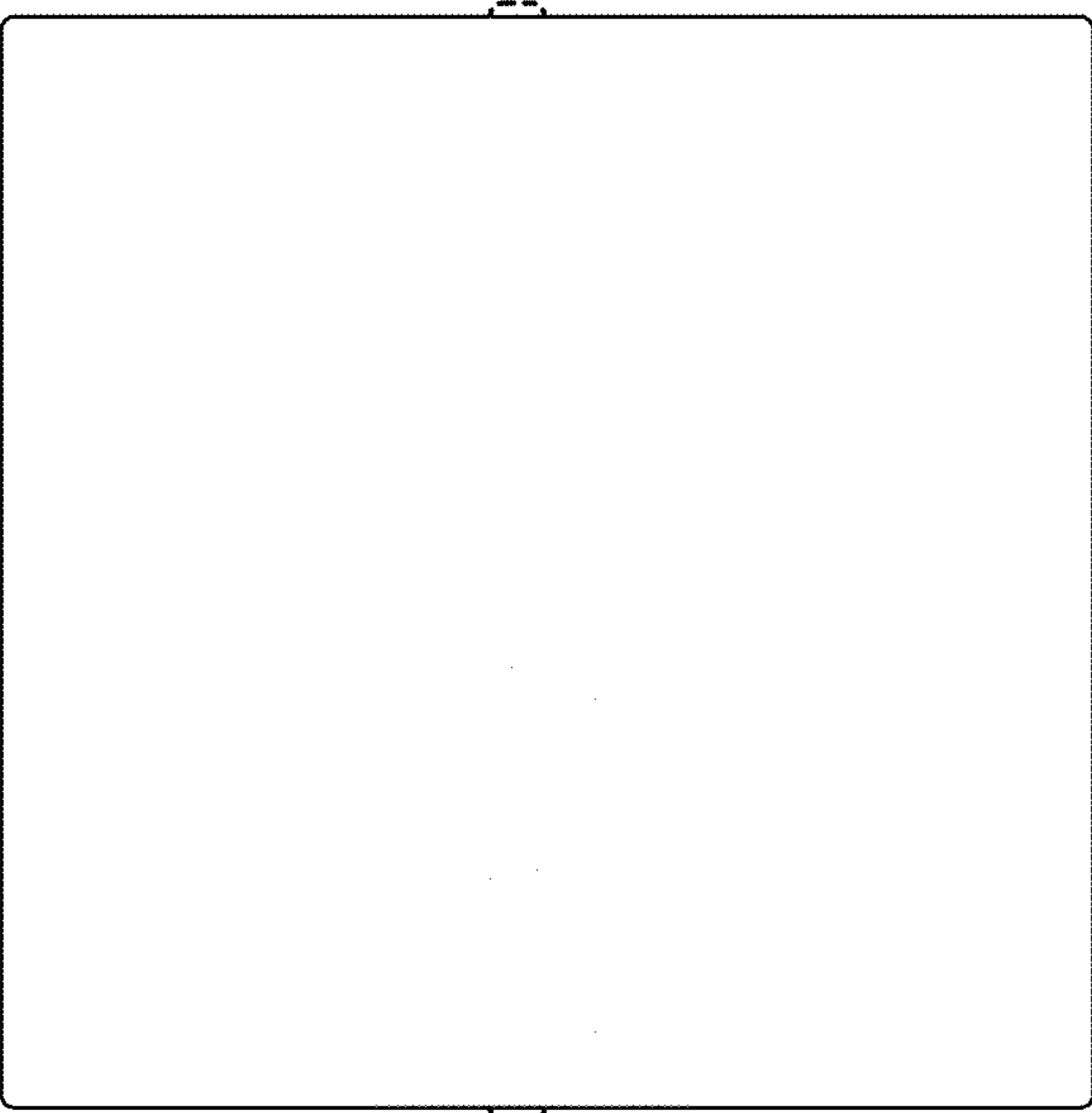

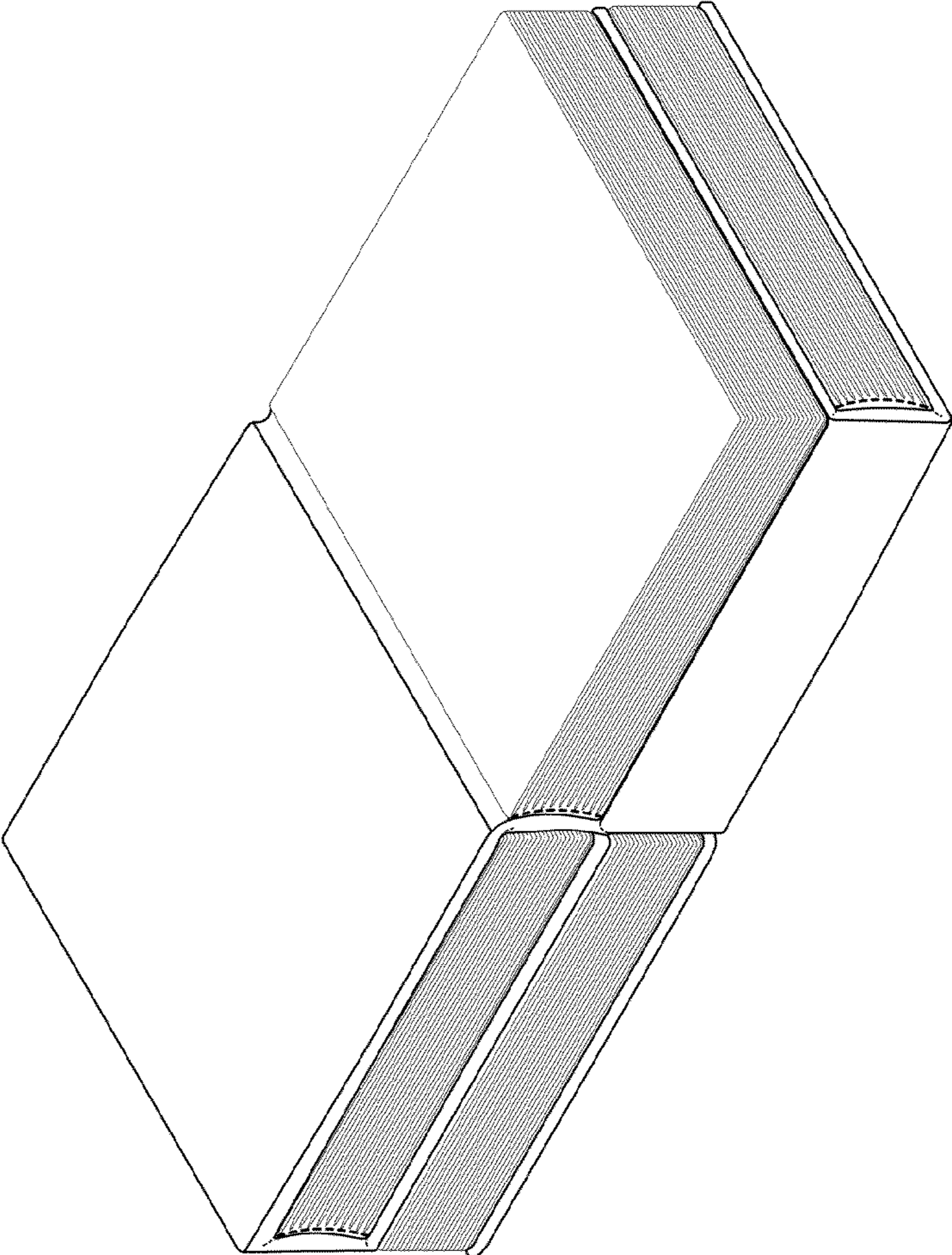

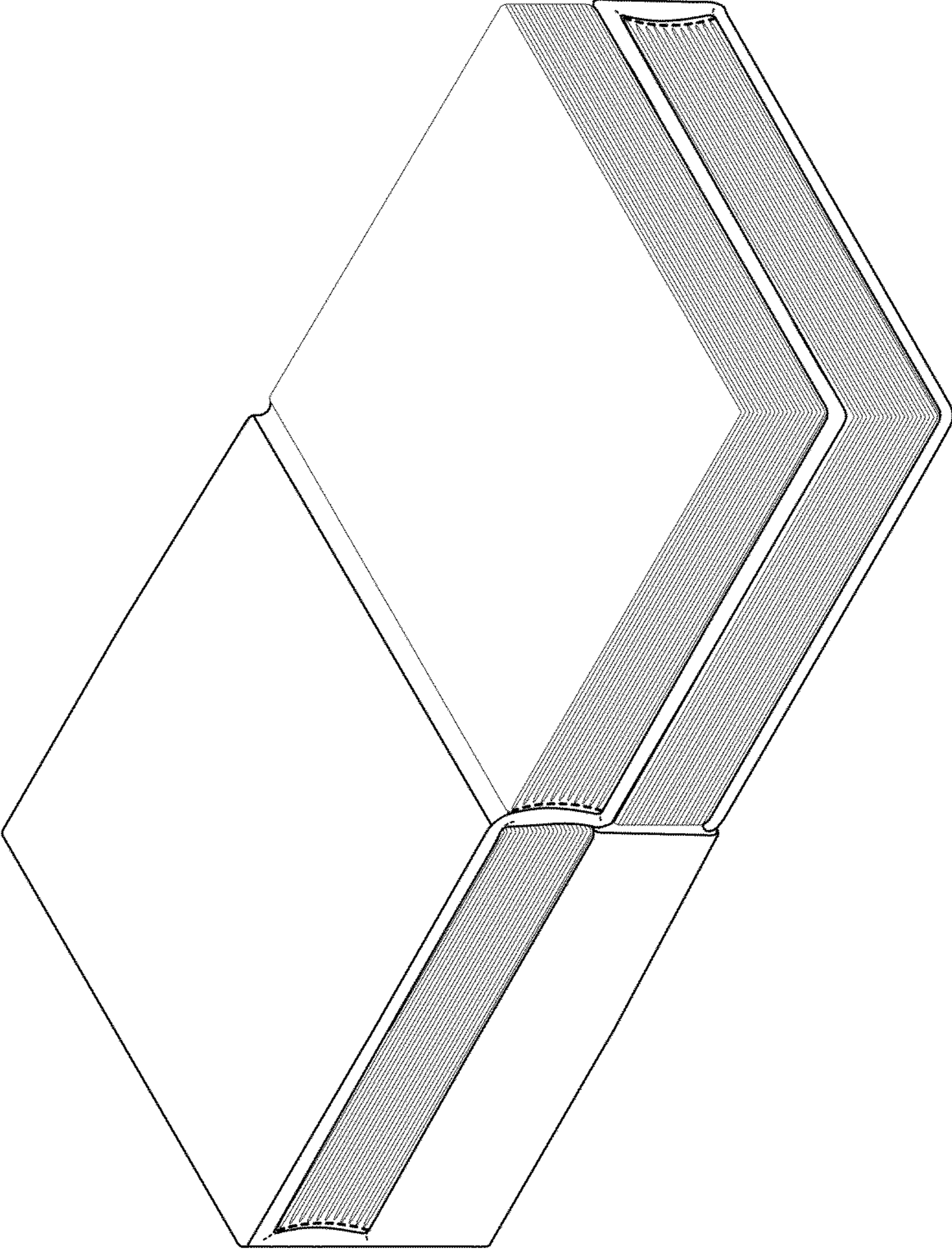

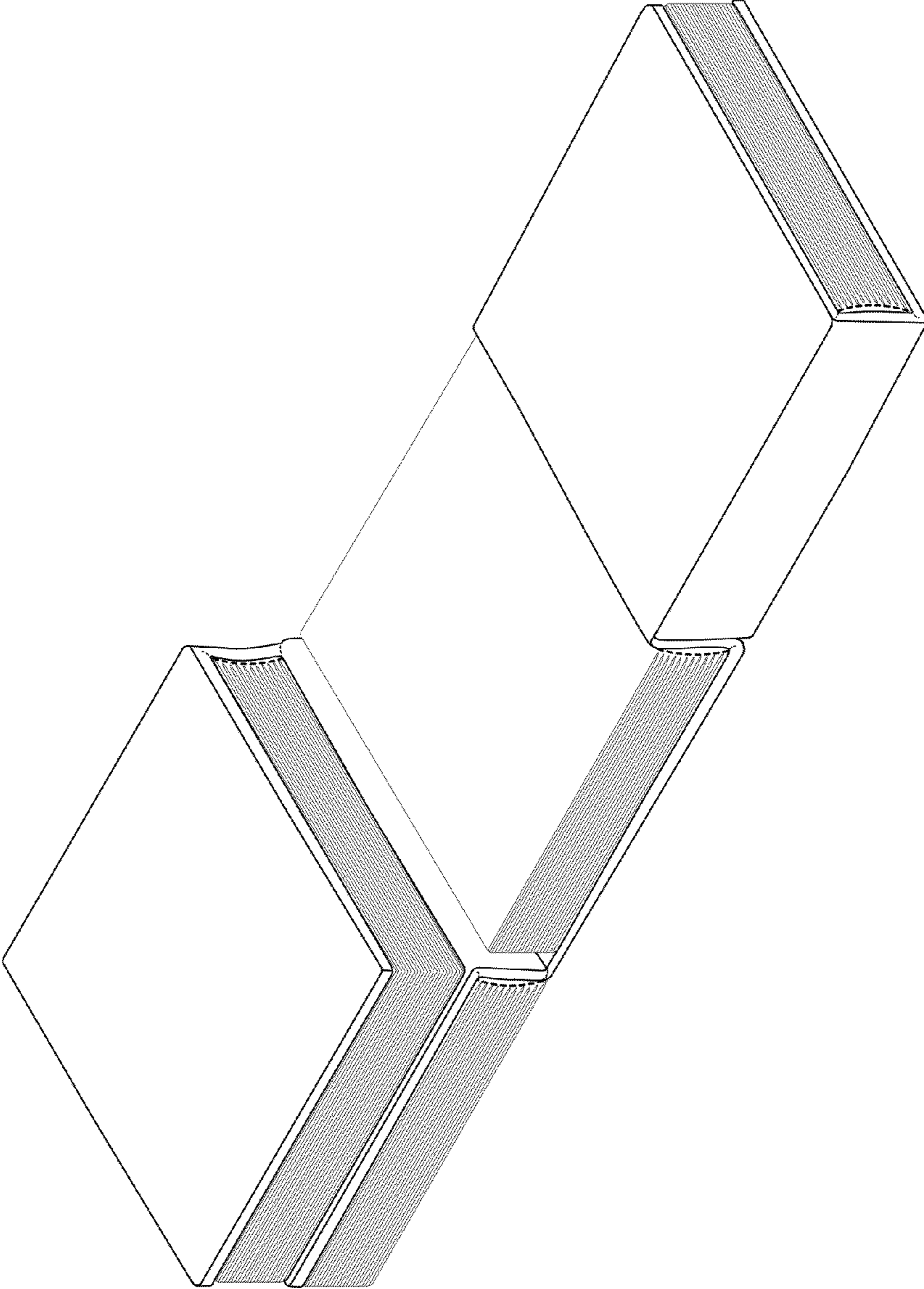

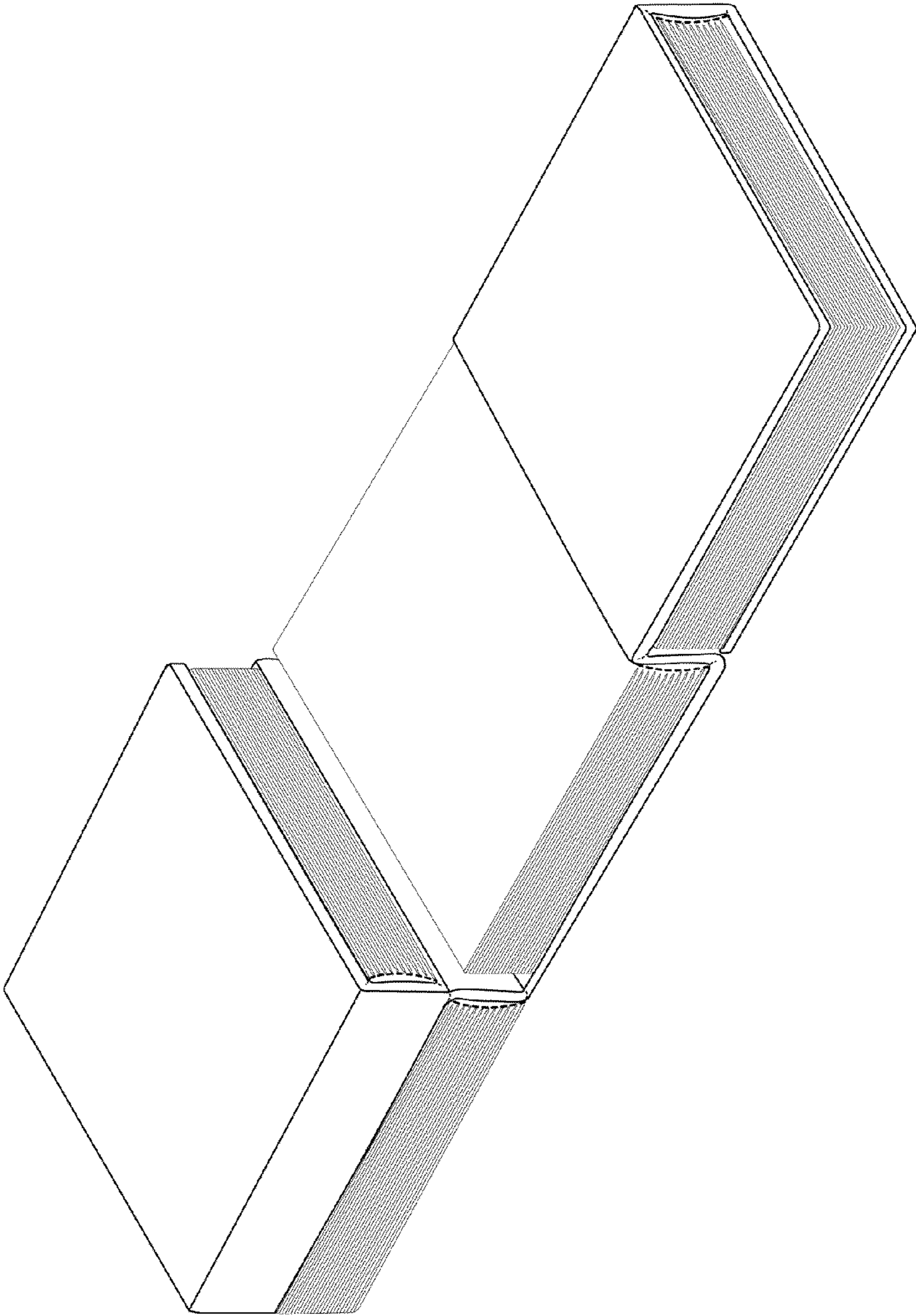

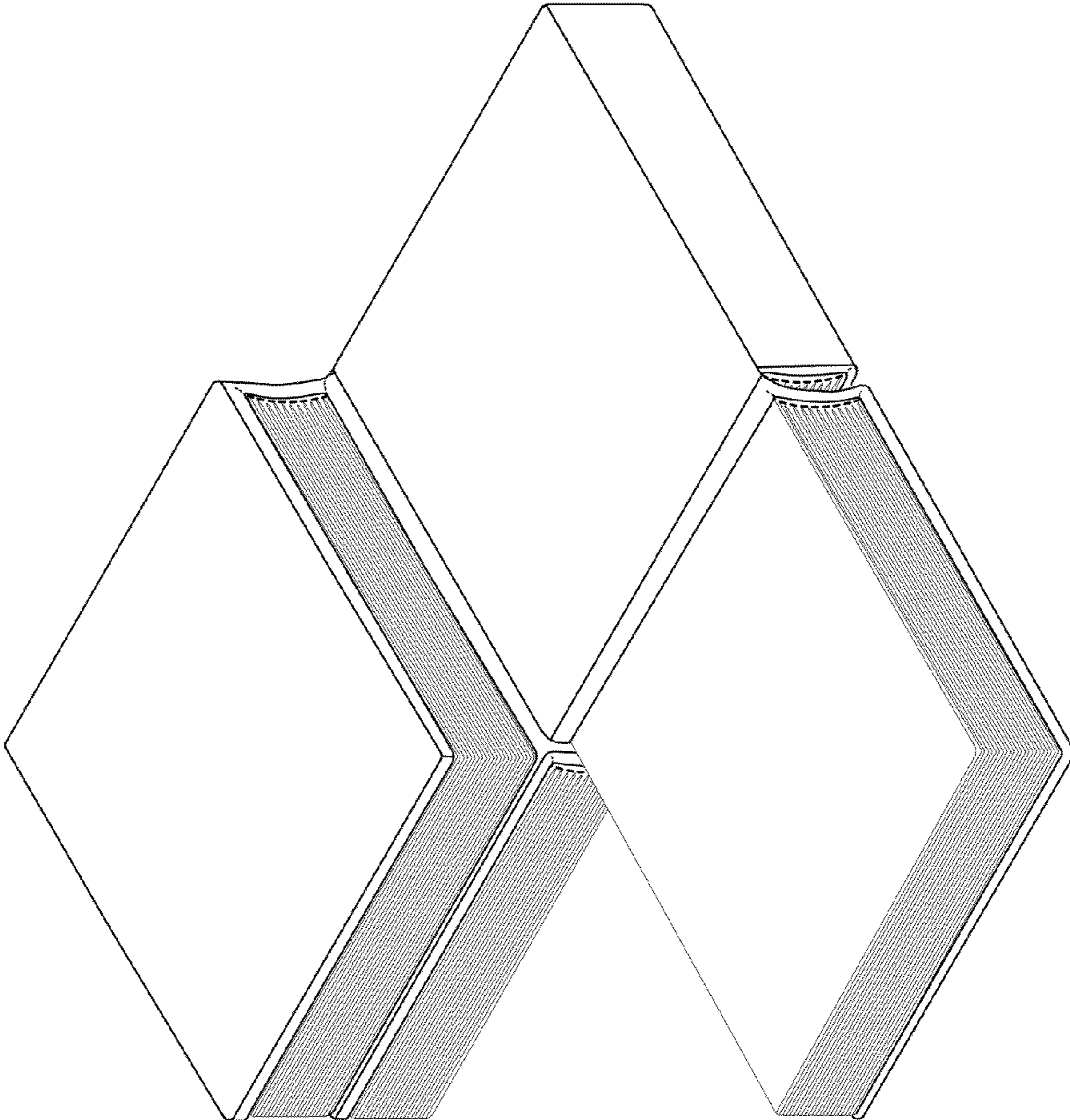

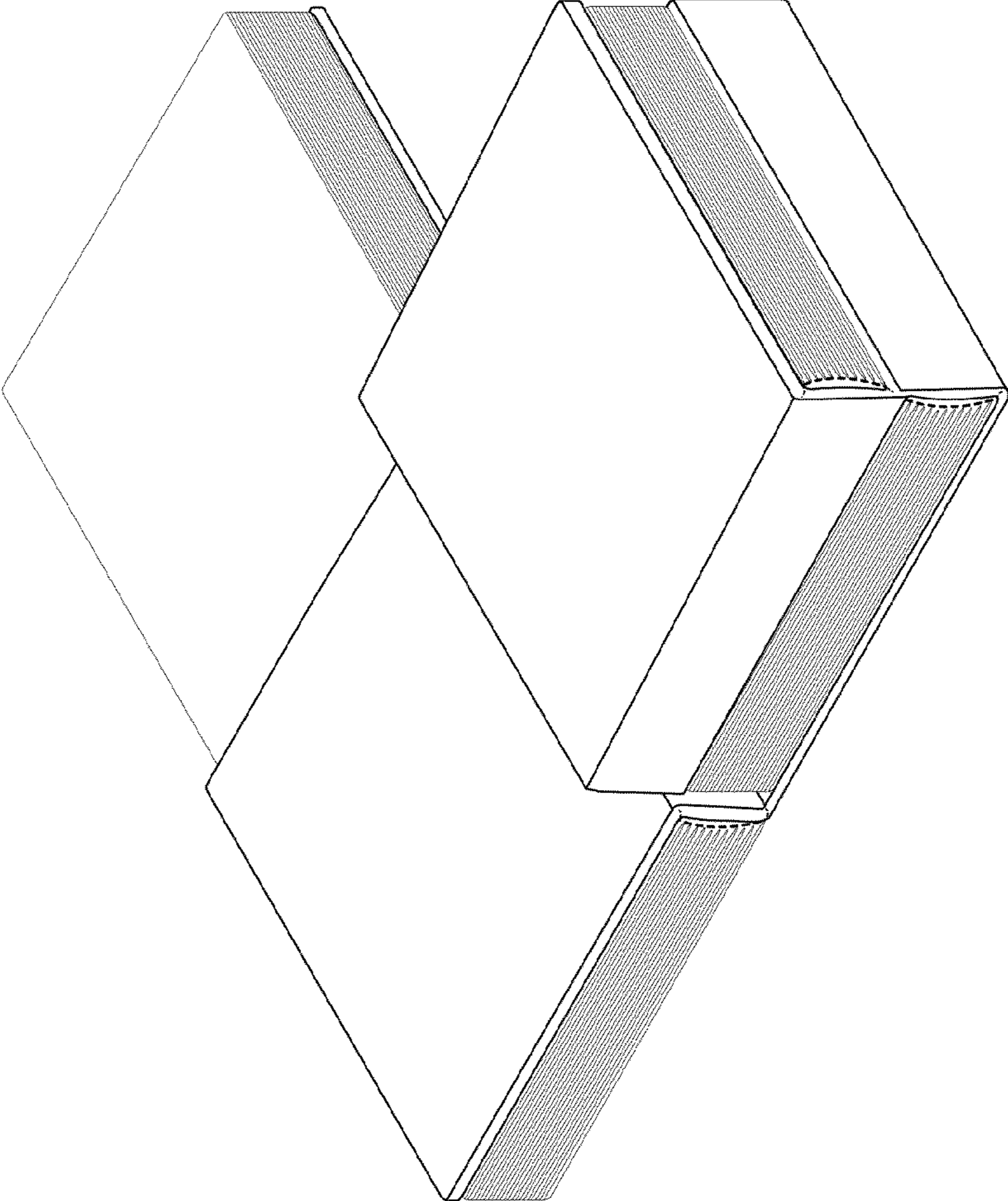

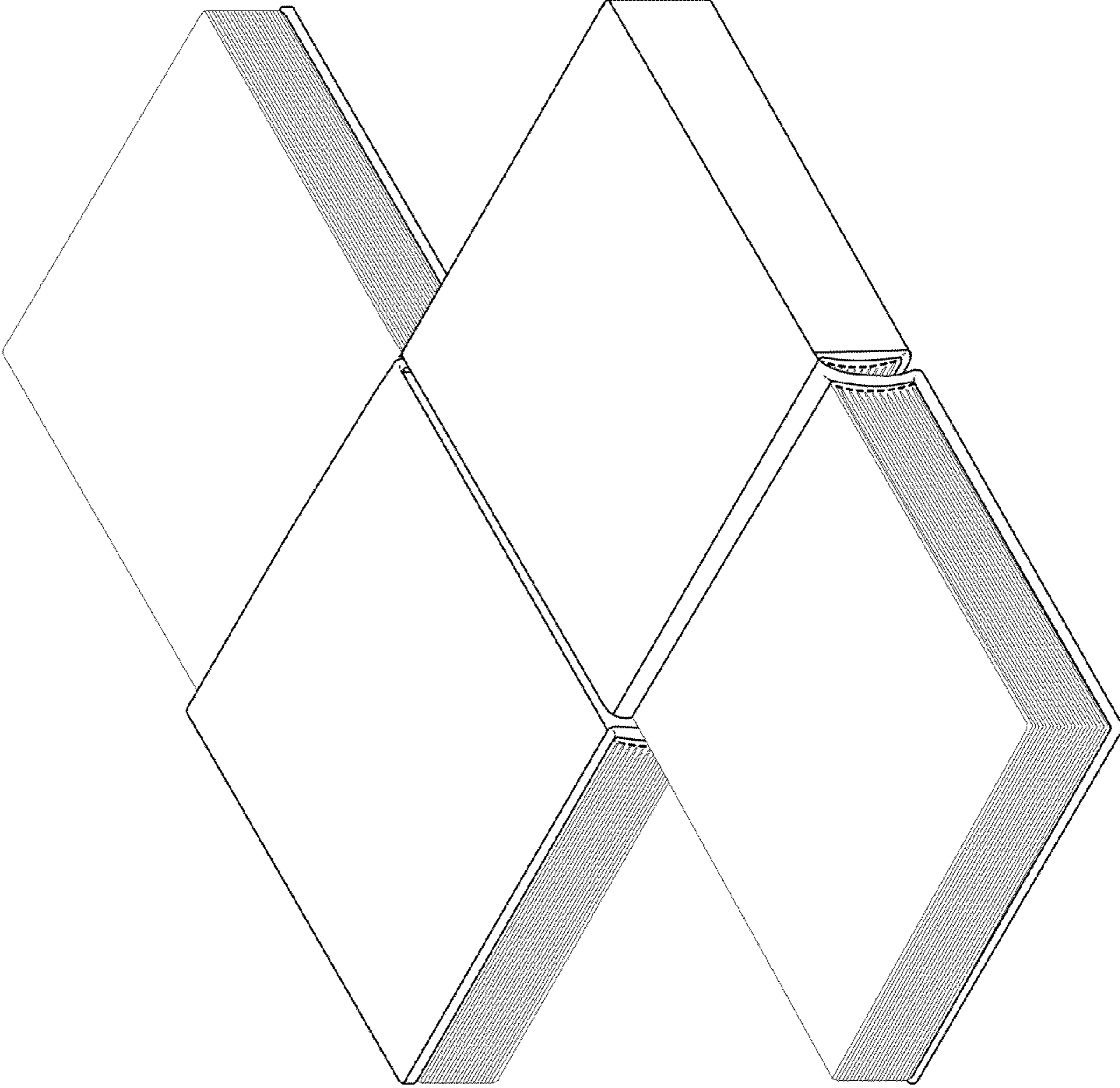

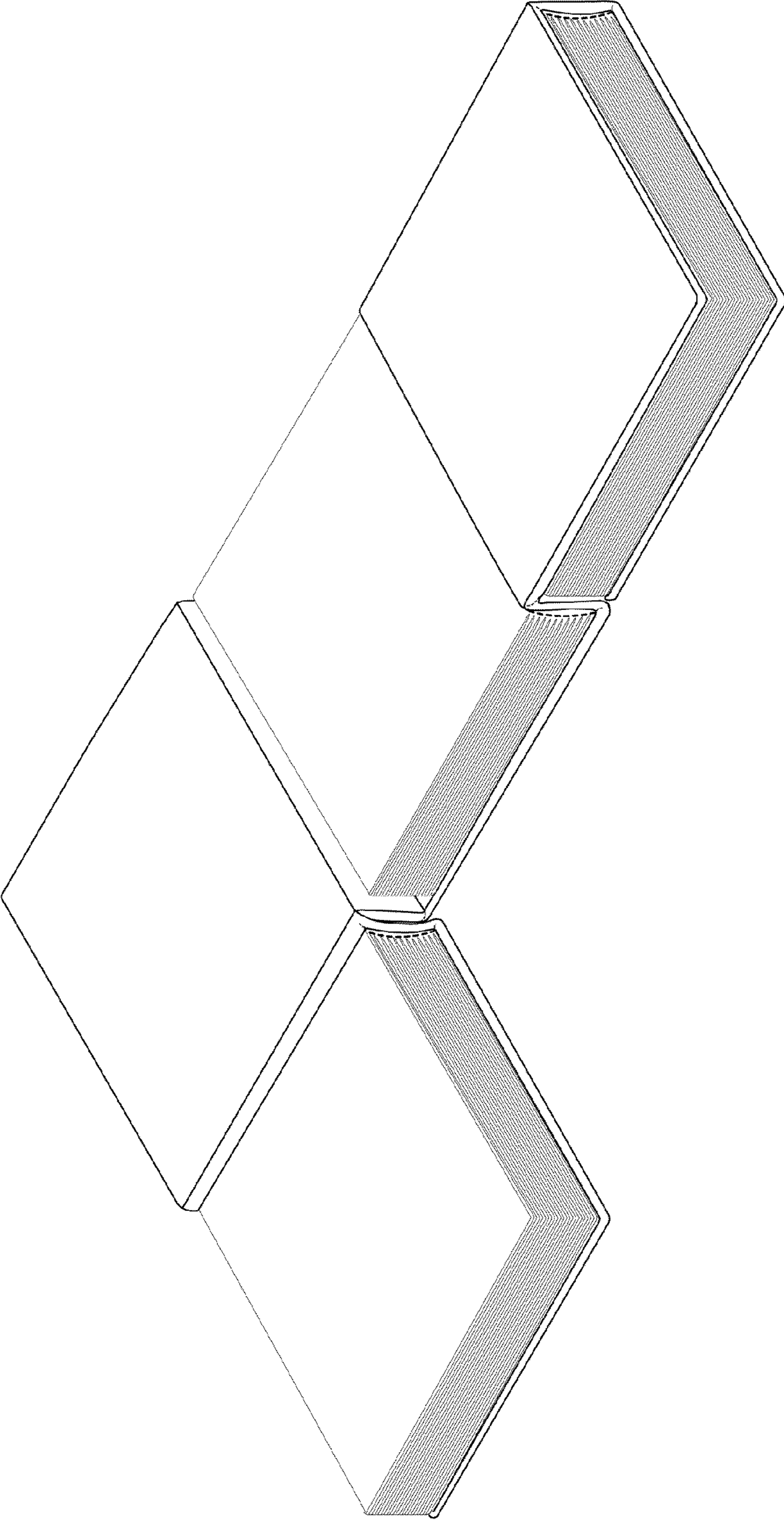

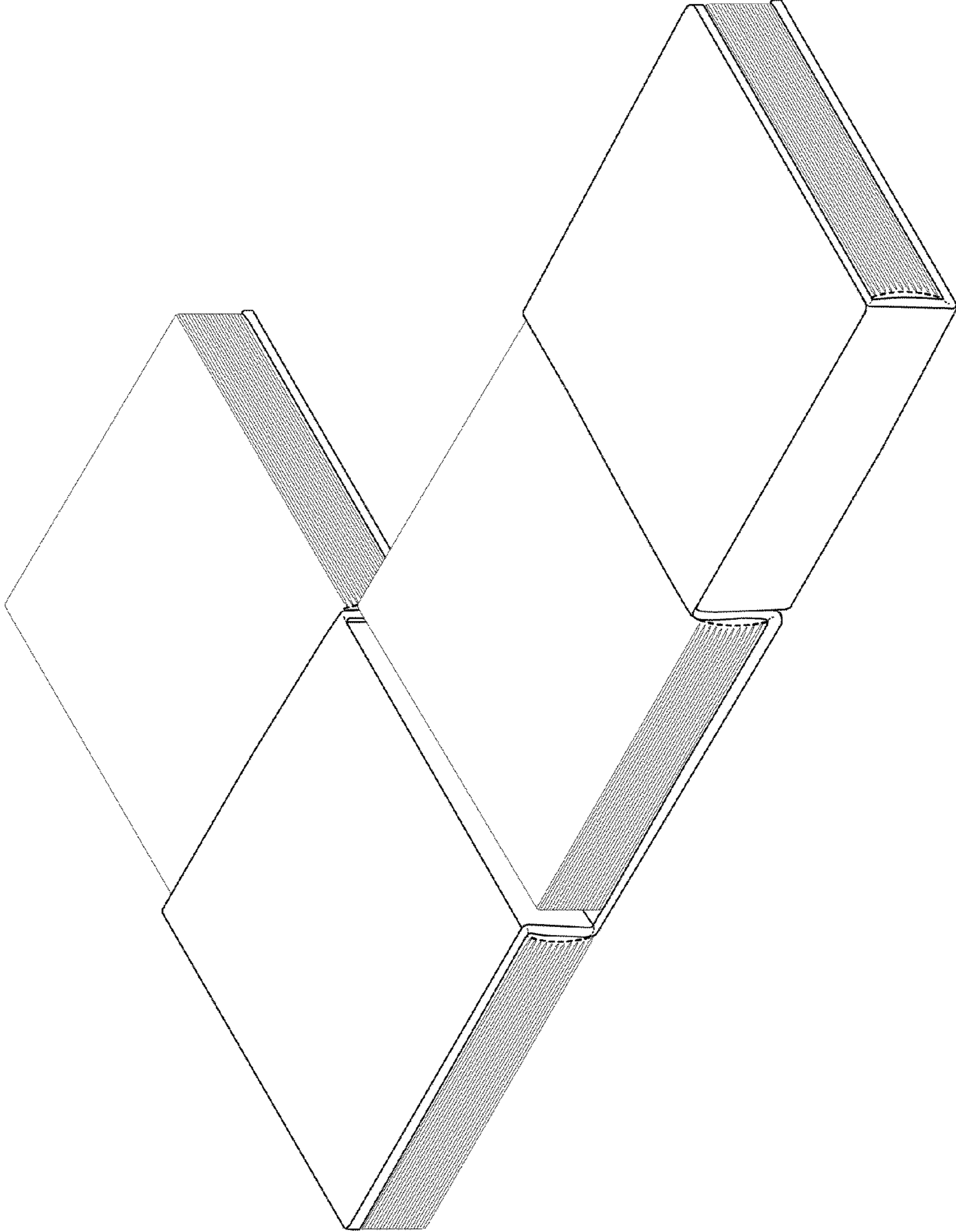

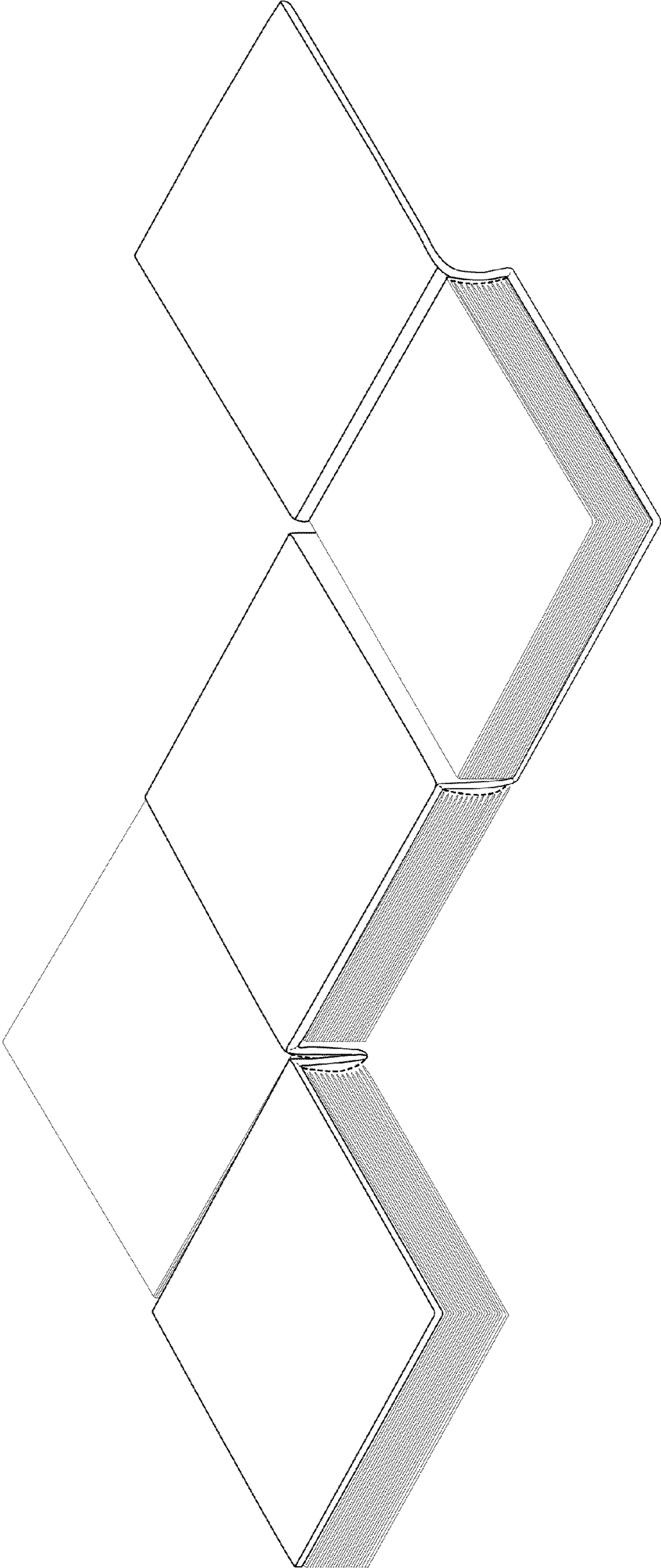
