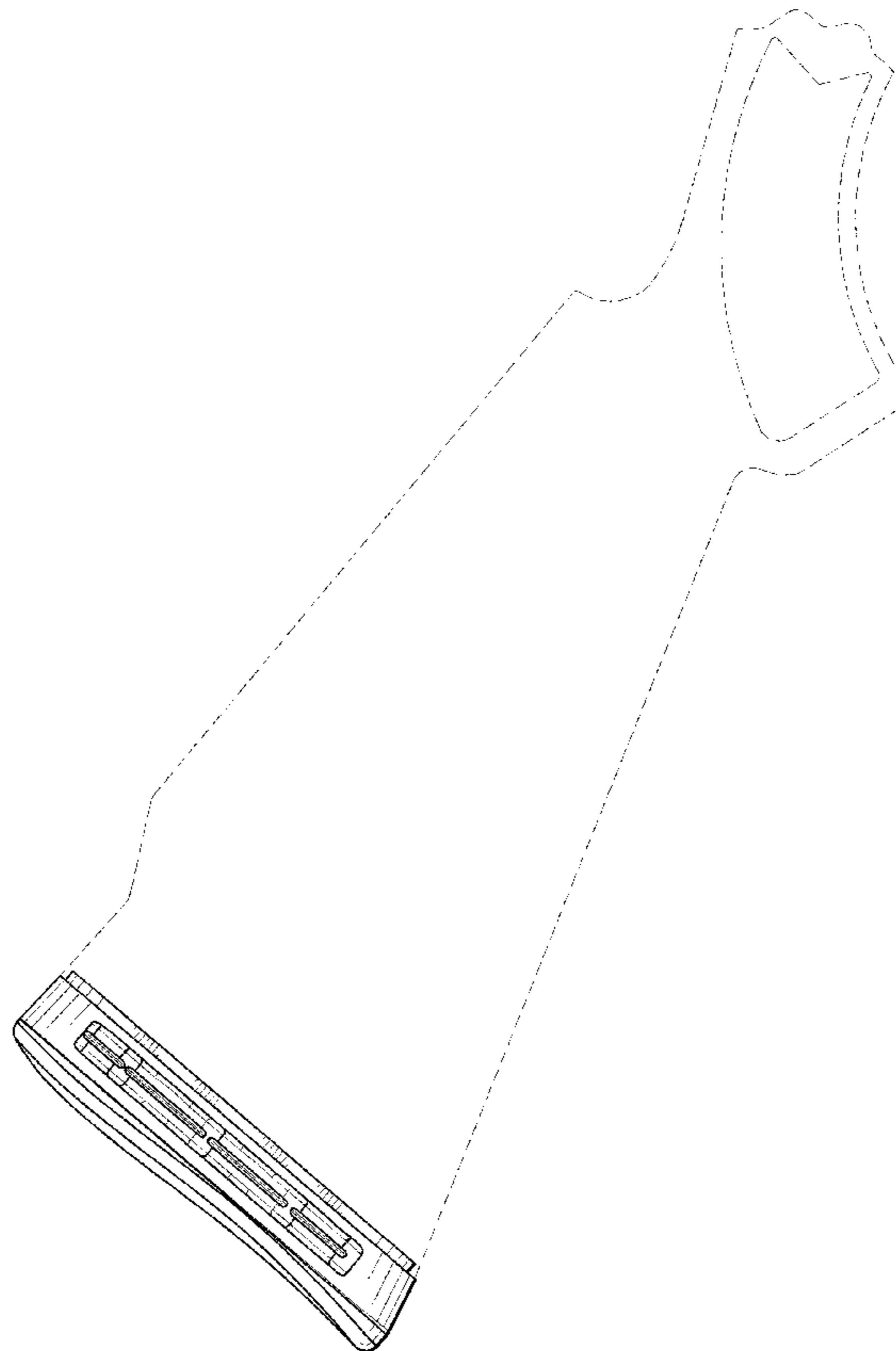

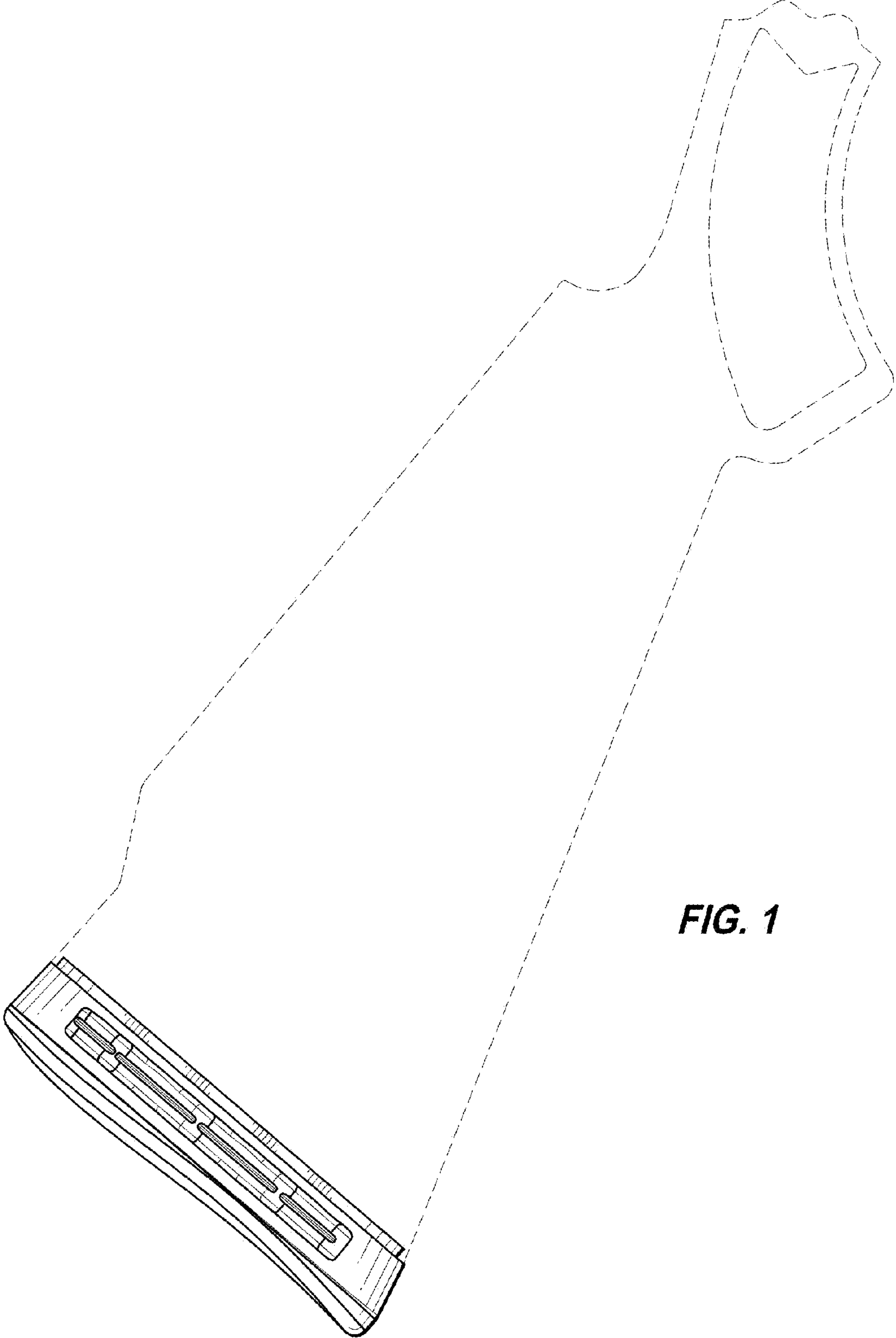
I claim the ornamental design for a recoil pad, as shown and described.

**DESCRIPTION**

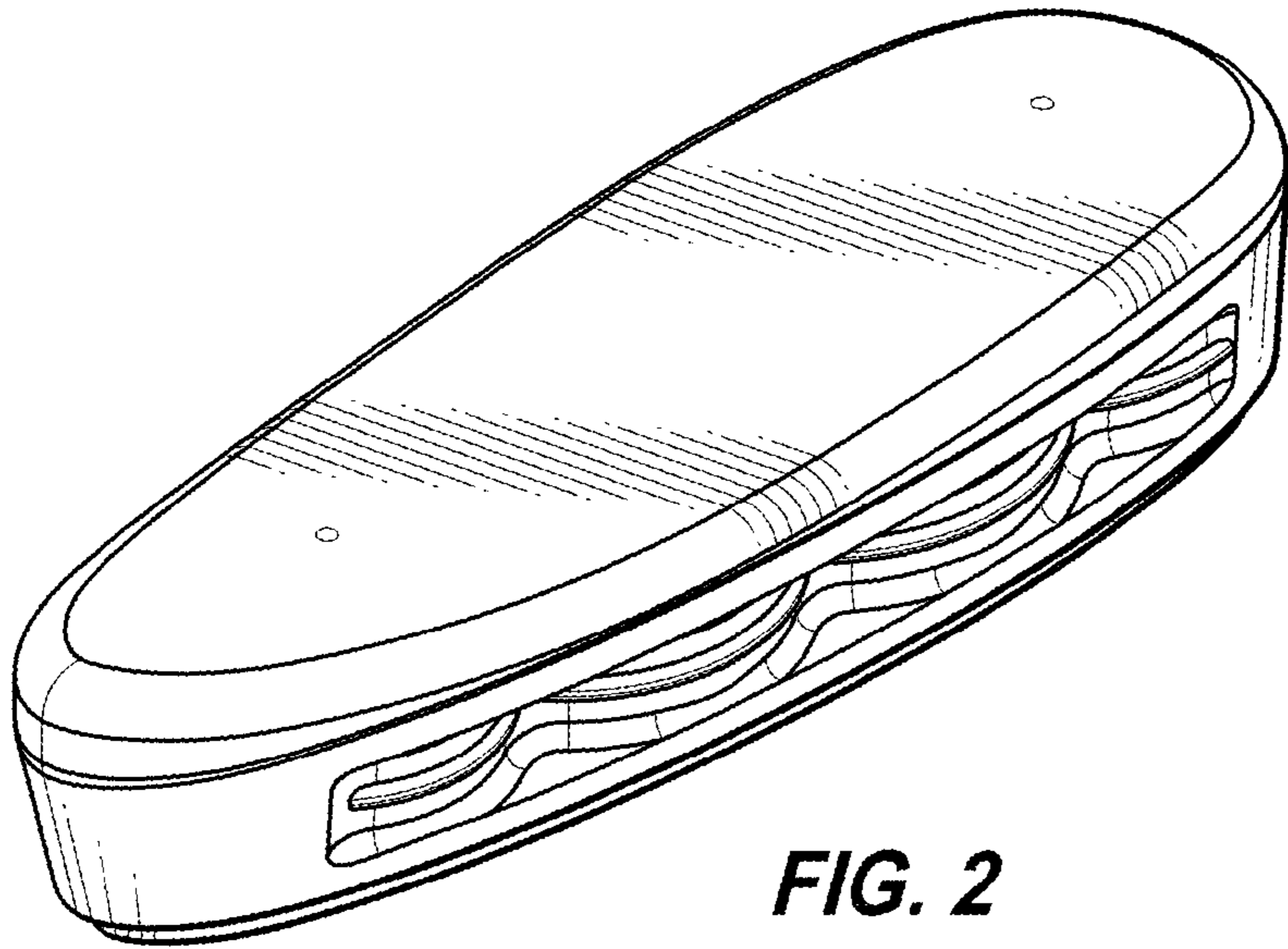
FIG. 1 is a perspective view of the recoil pad in its environment;

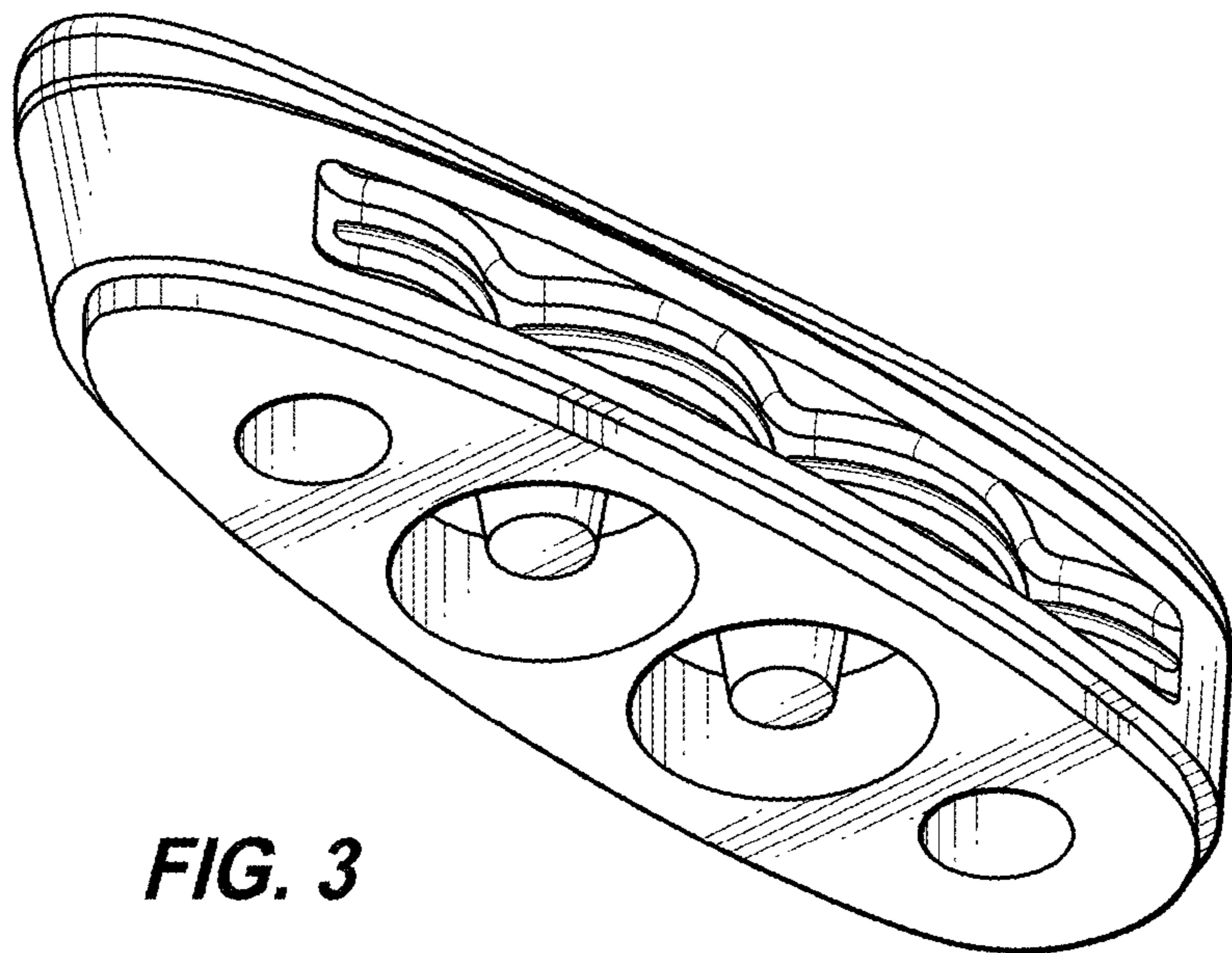




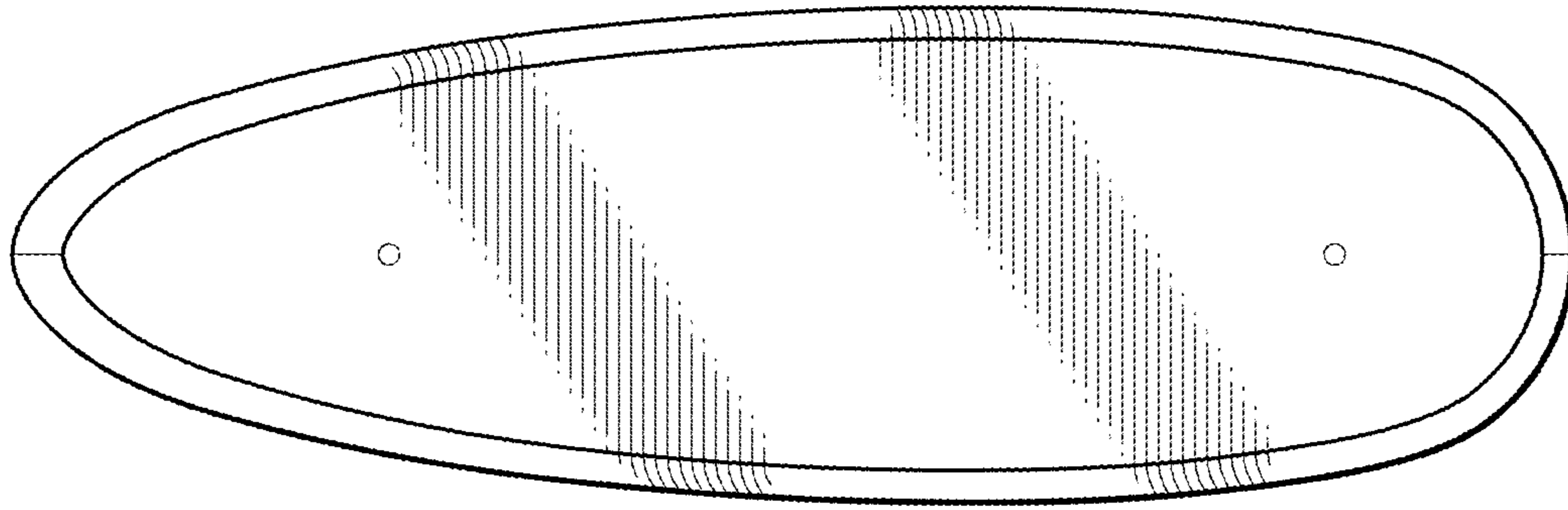

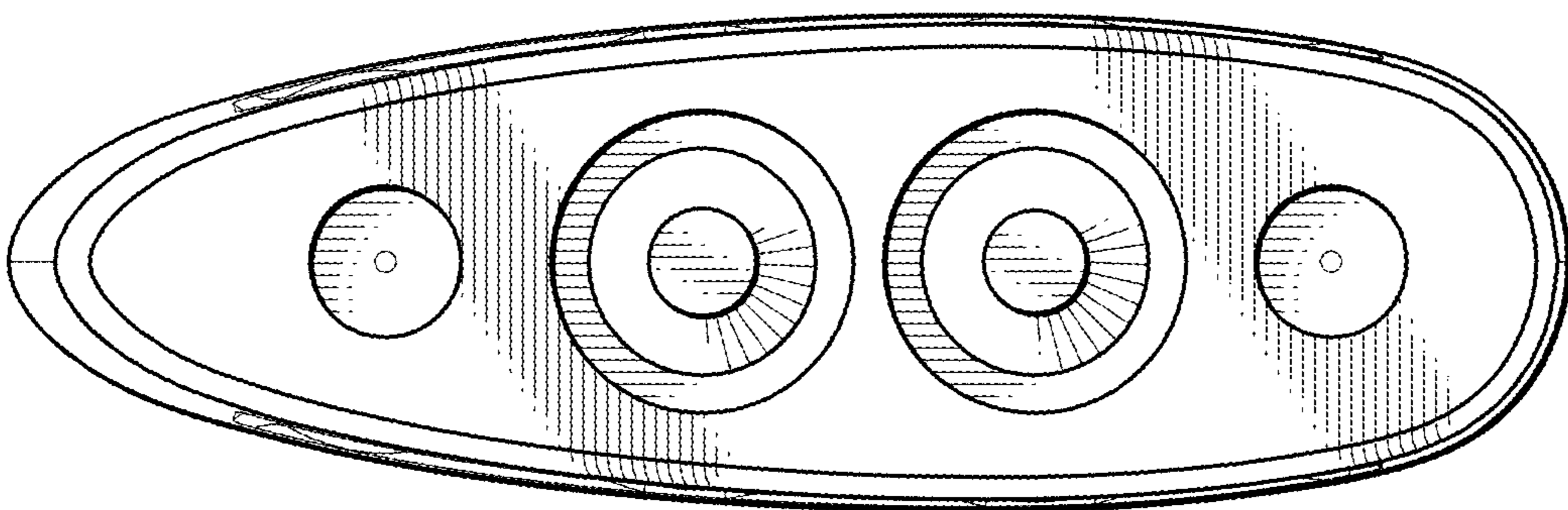

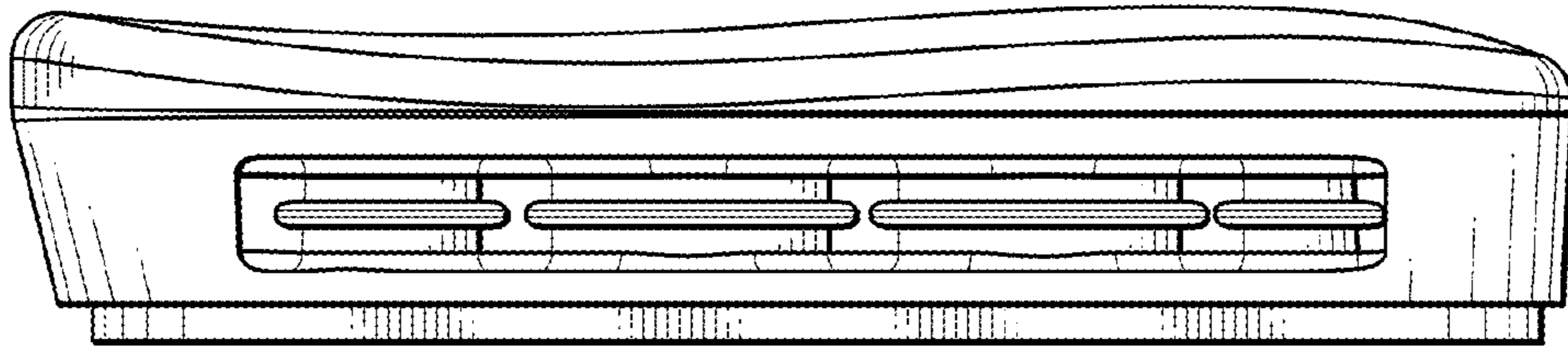

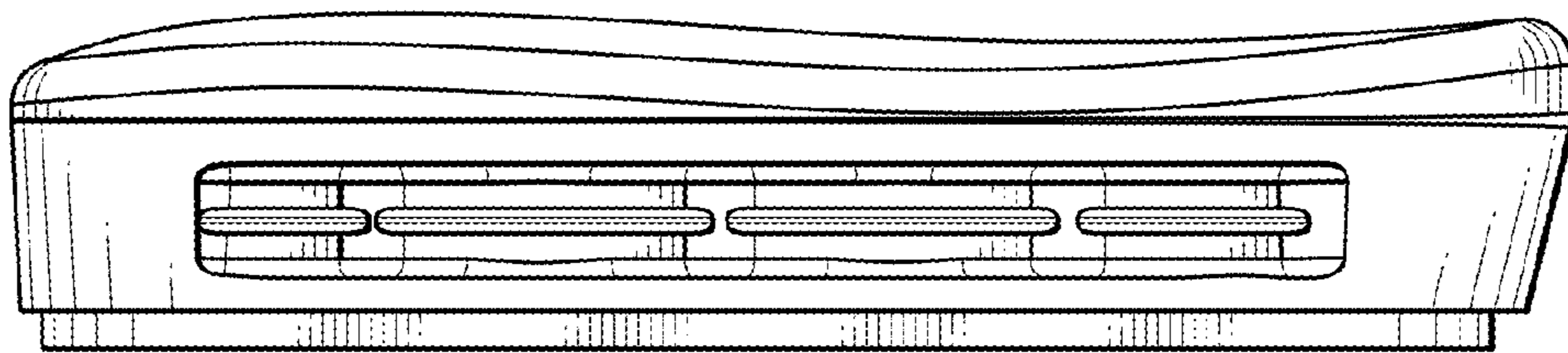

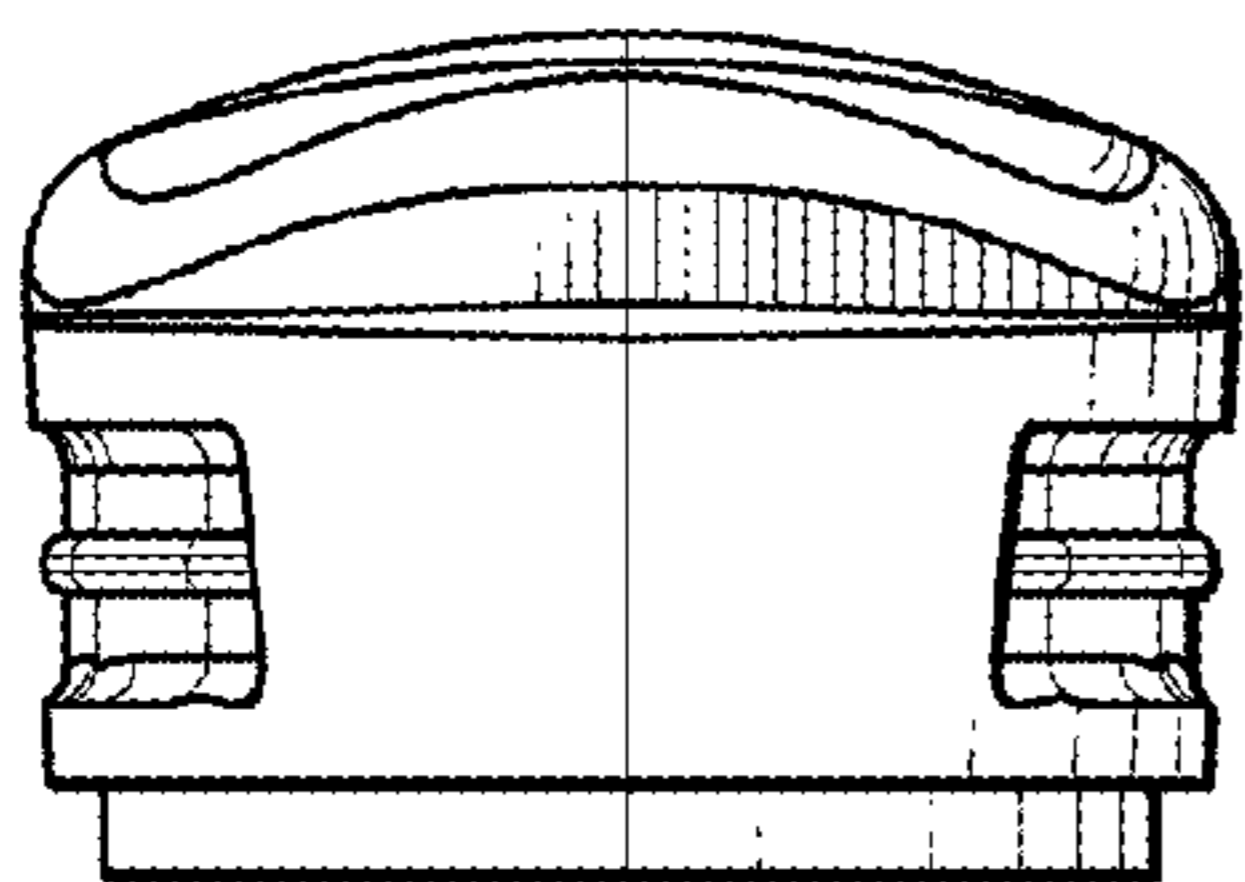

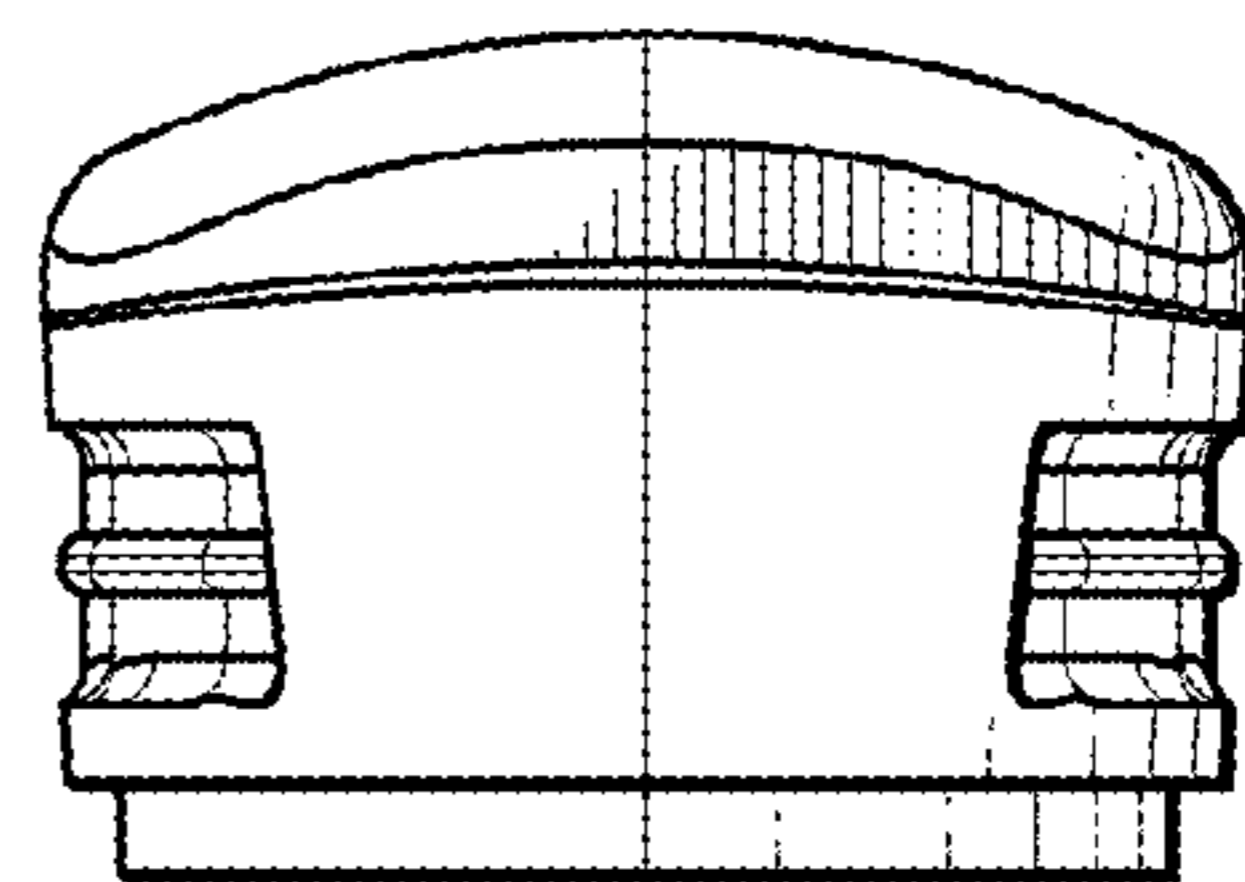
