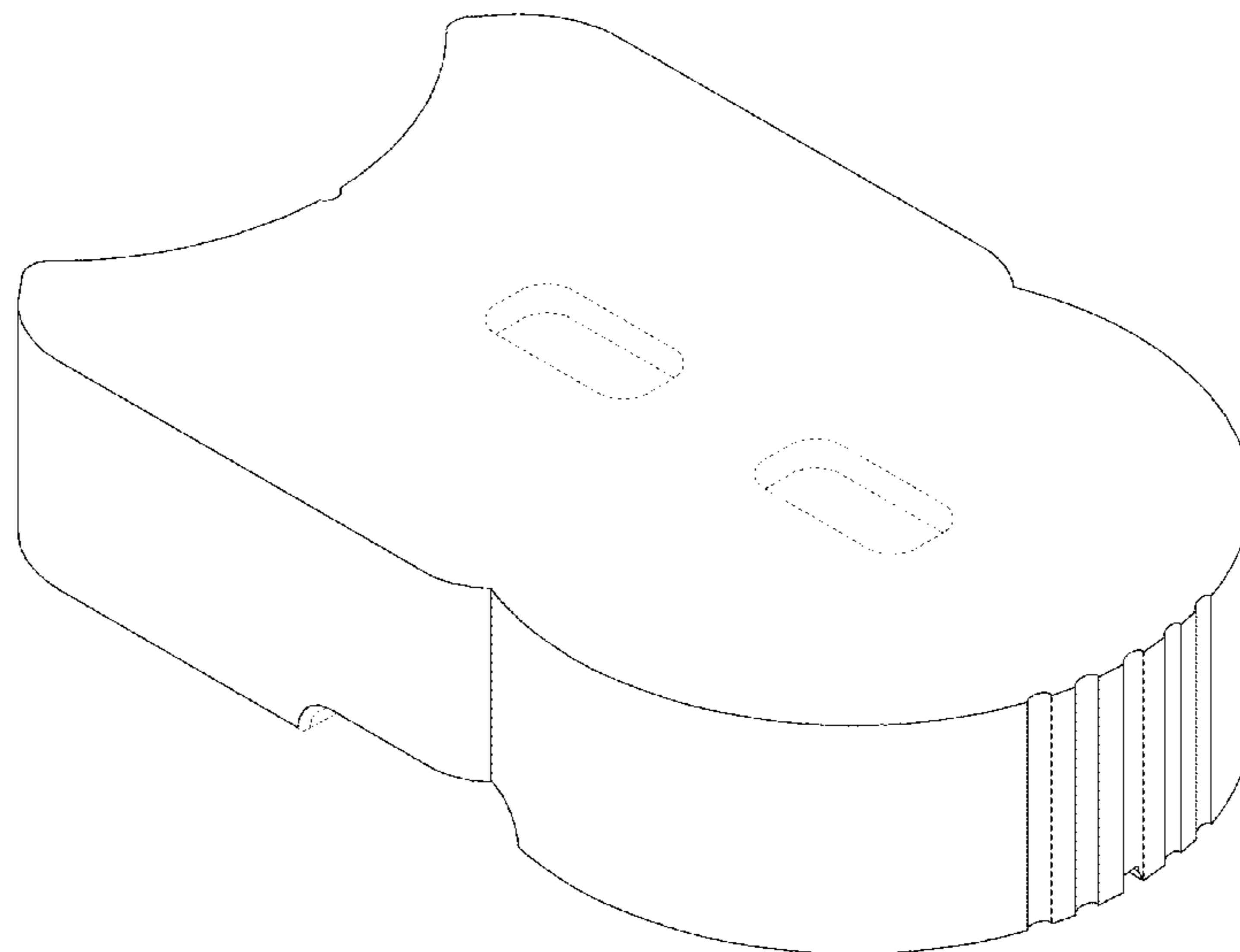
(57) **CLAIM**

The ornamental design for a concrete block, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a concrete block, according to our new design; FIG. 2 is a top plan view of the concrete block of FIG. 1; FIG. 3 is a bottom plan view of the concrete block of FIG. 1; FIG. 4 is a front elevation view of the concrete block of FIG. 1; FIG. 5 is a rear elevation view of the concrete block of FIG. 1; FIG. 6 is a right side view of the concrete block of FIG. 1; FIG. 7 is a left side view of the concrete block of FIG. 1; and, FIG. 8 is a bottom, rear, and left side perspective view of the concrete block of FIG. 1. The features depicted in broken lines form no part of the claimed design.

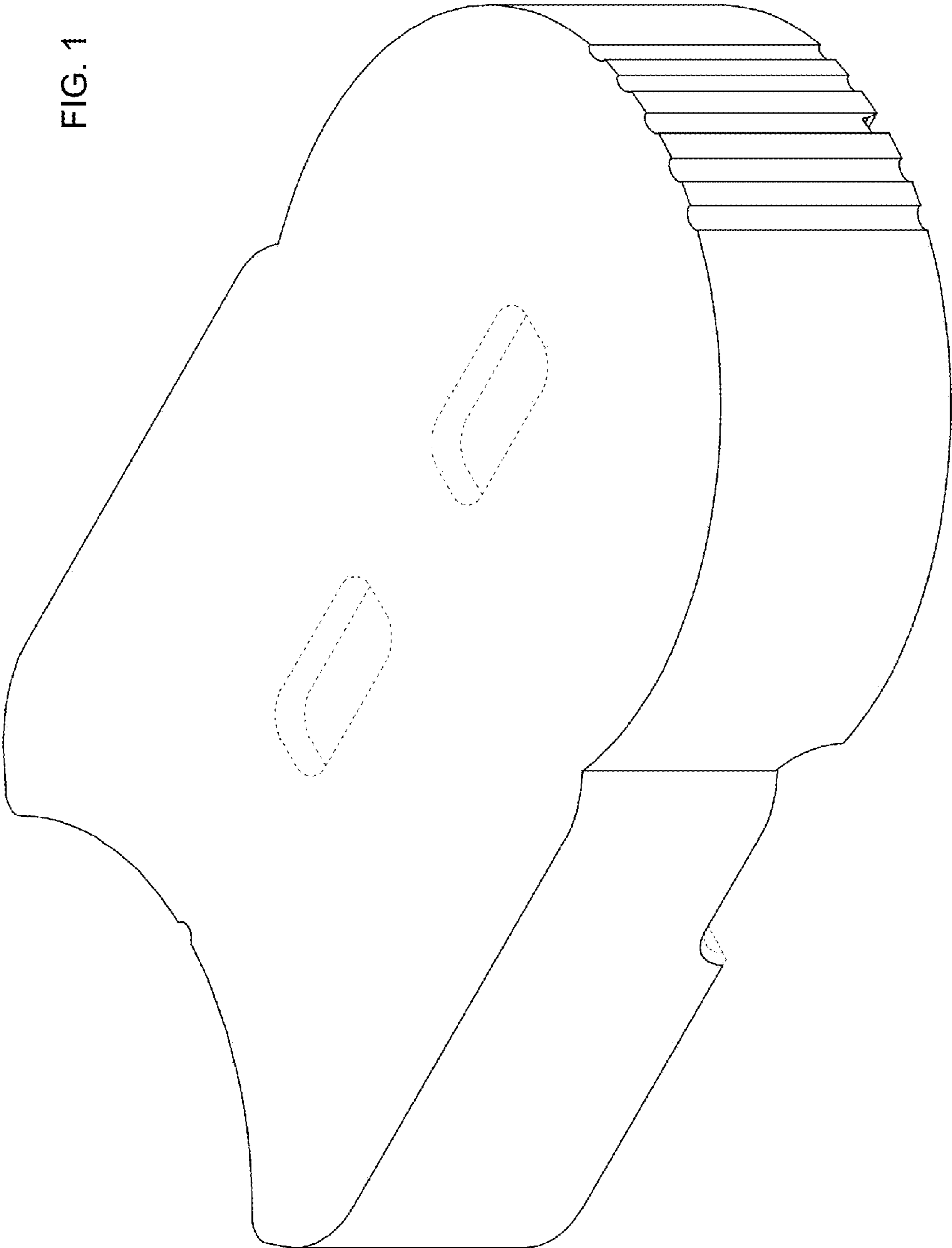

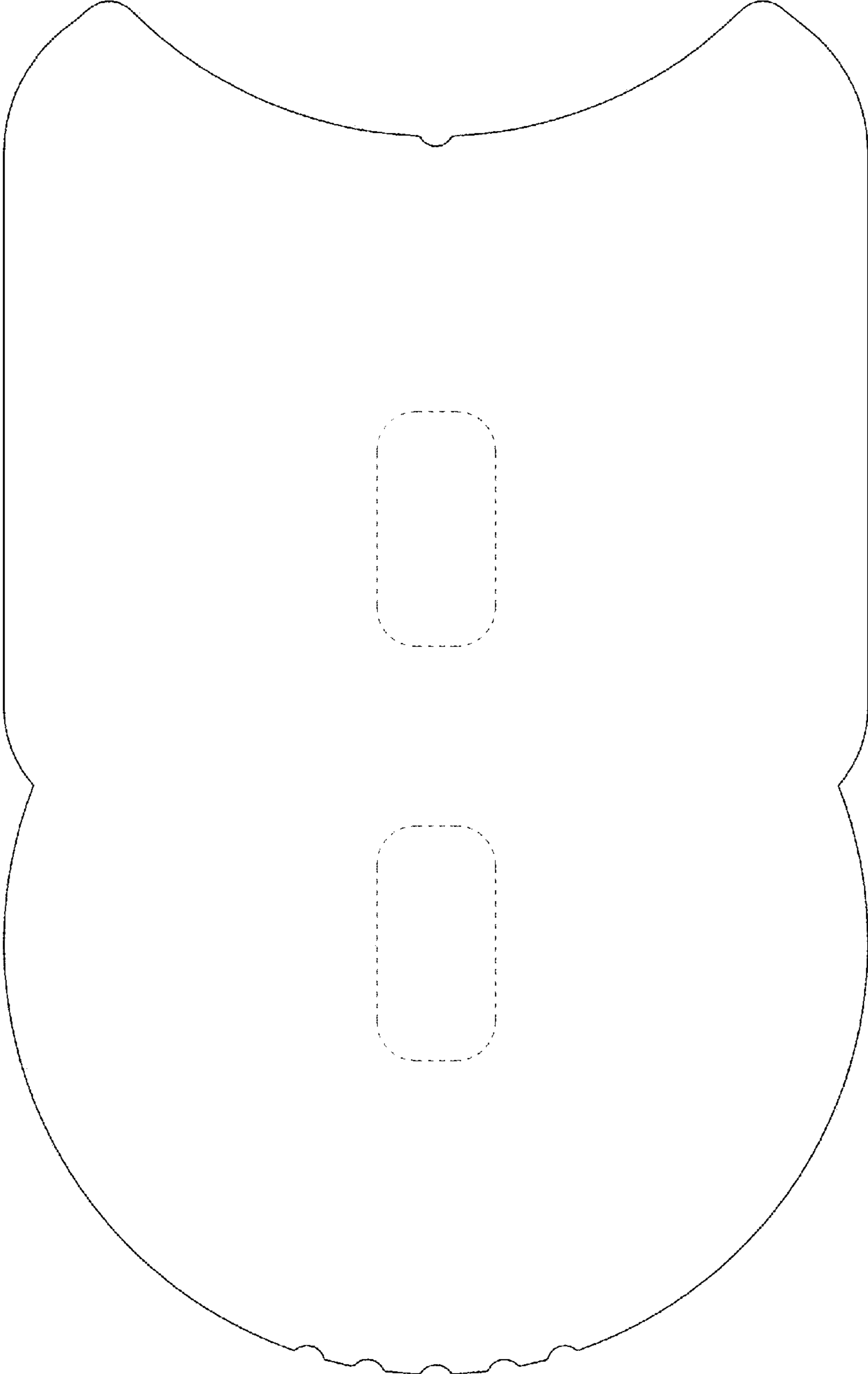

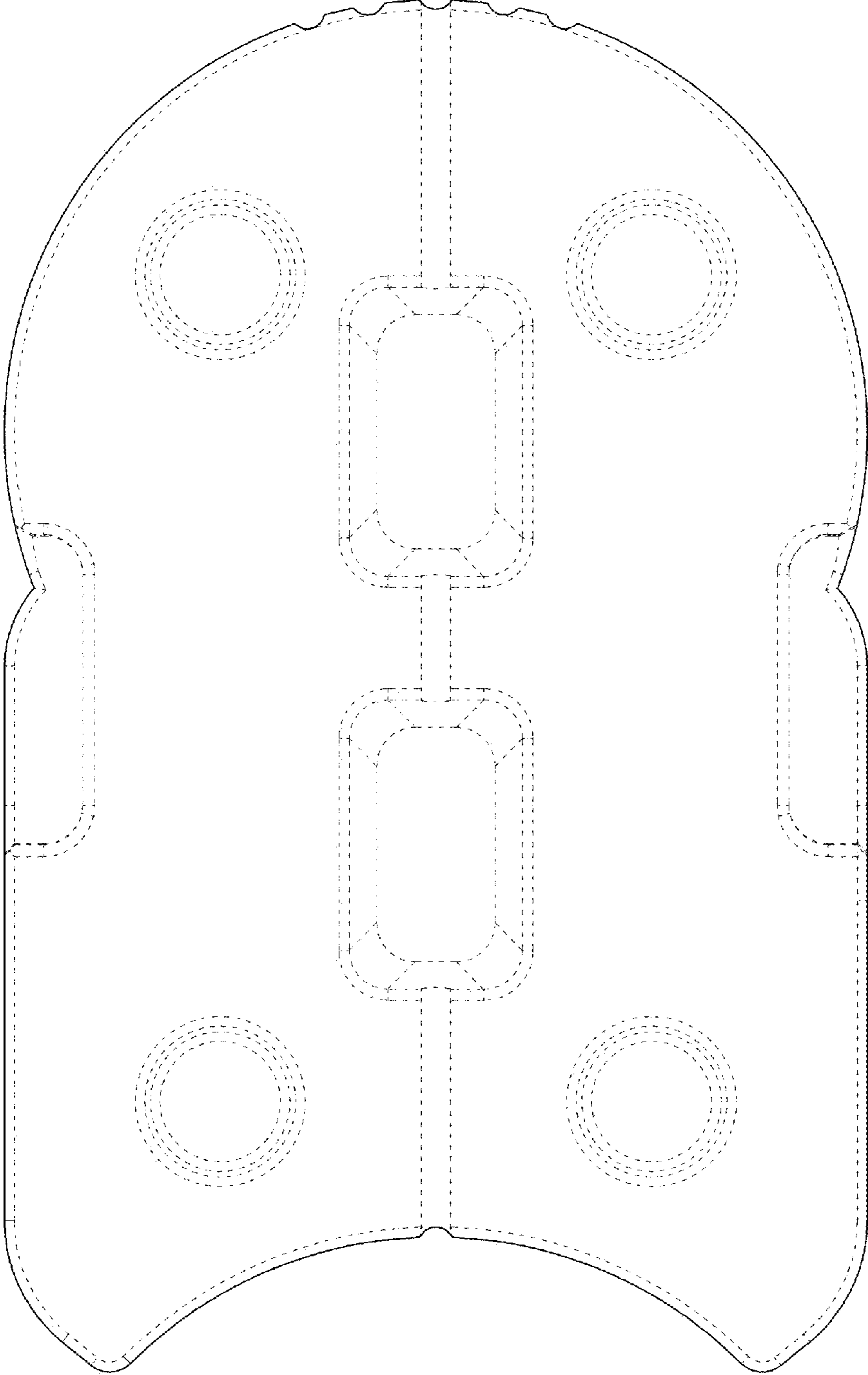

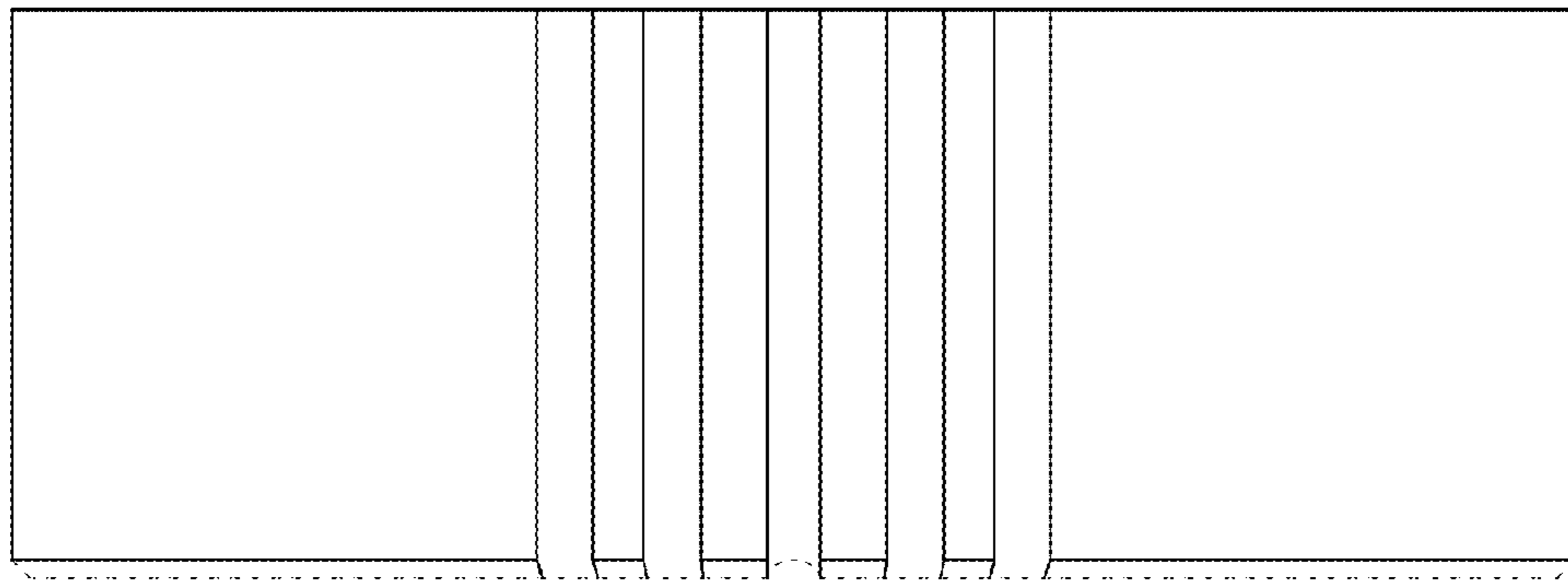

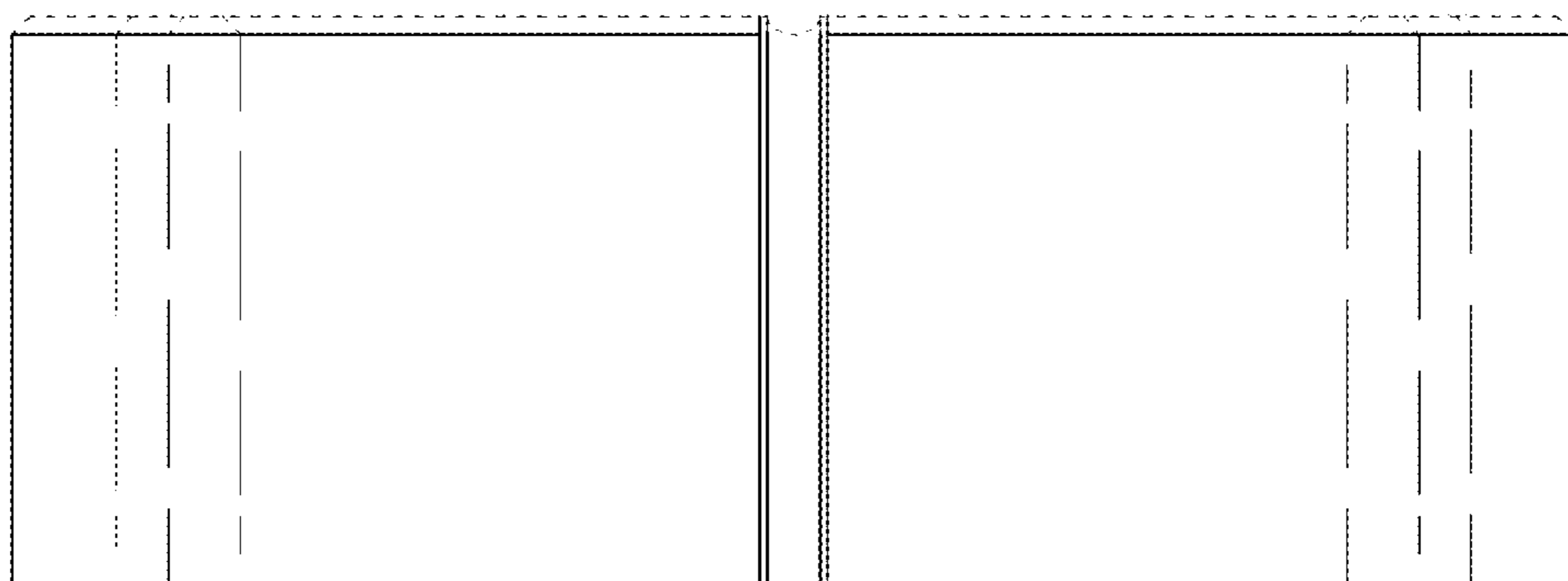

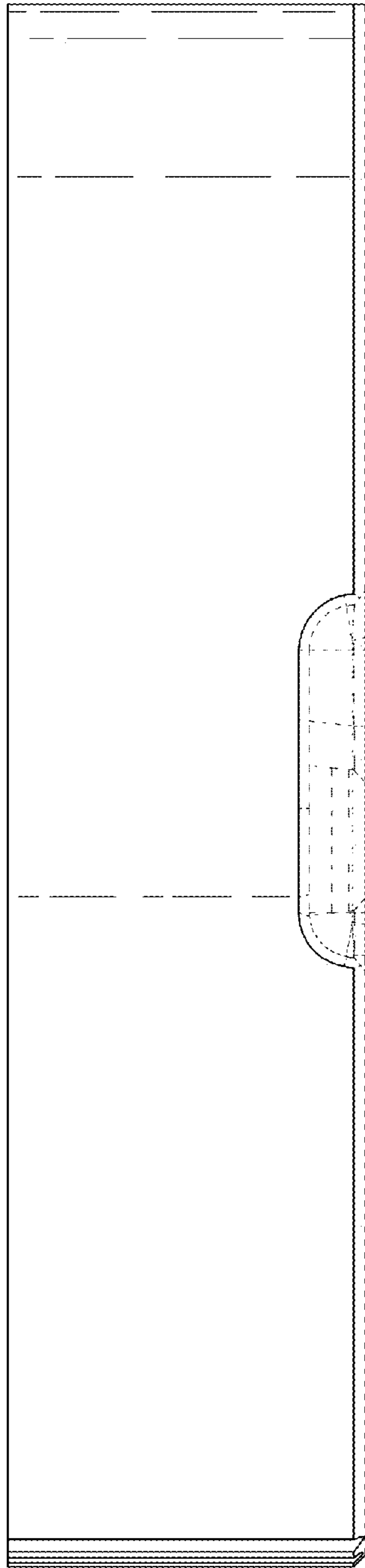

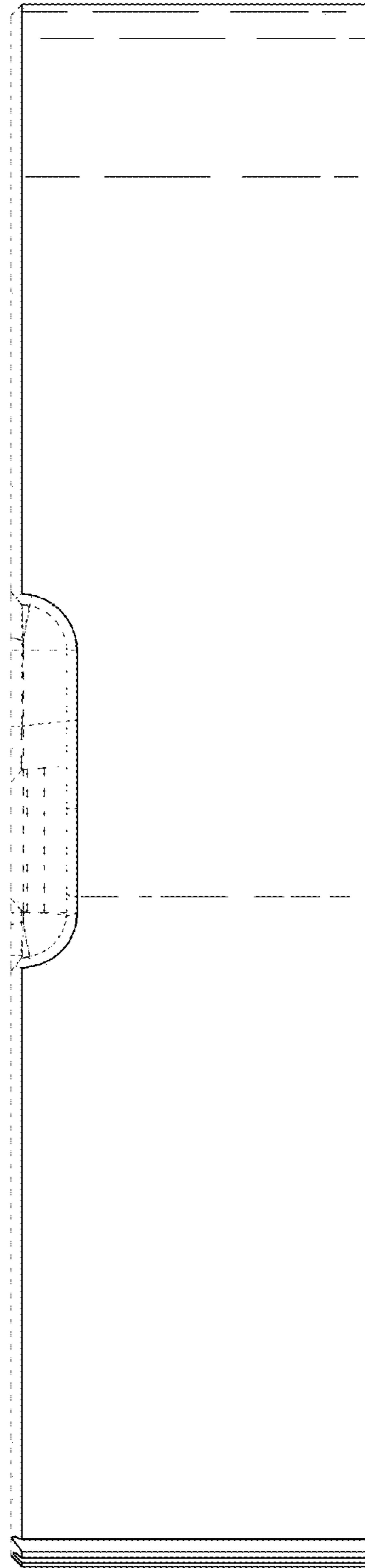
