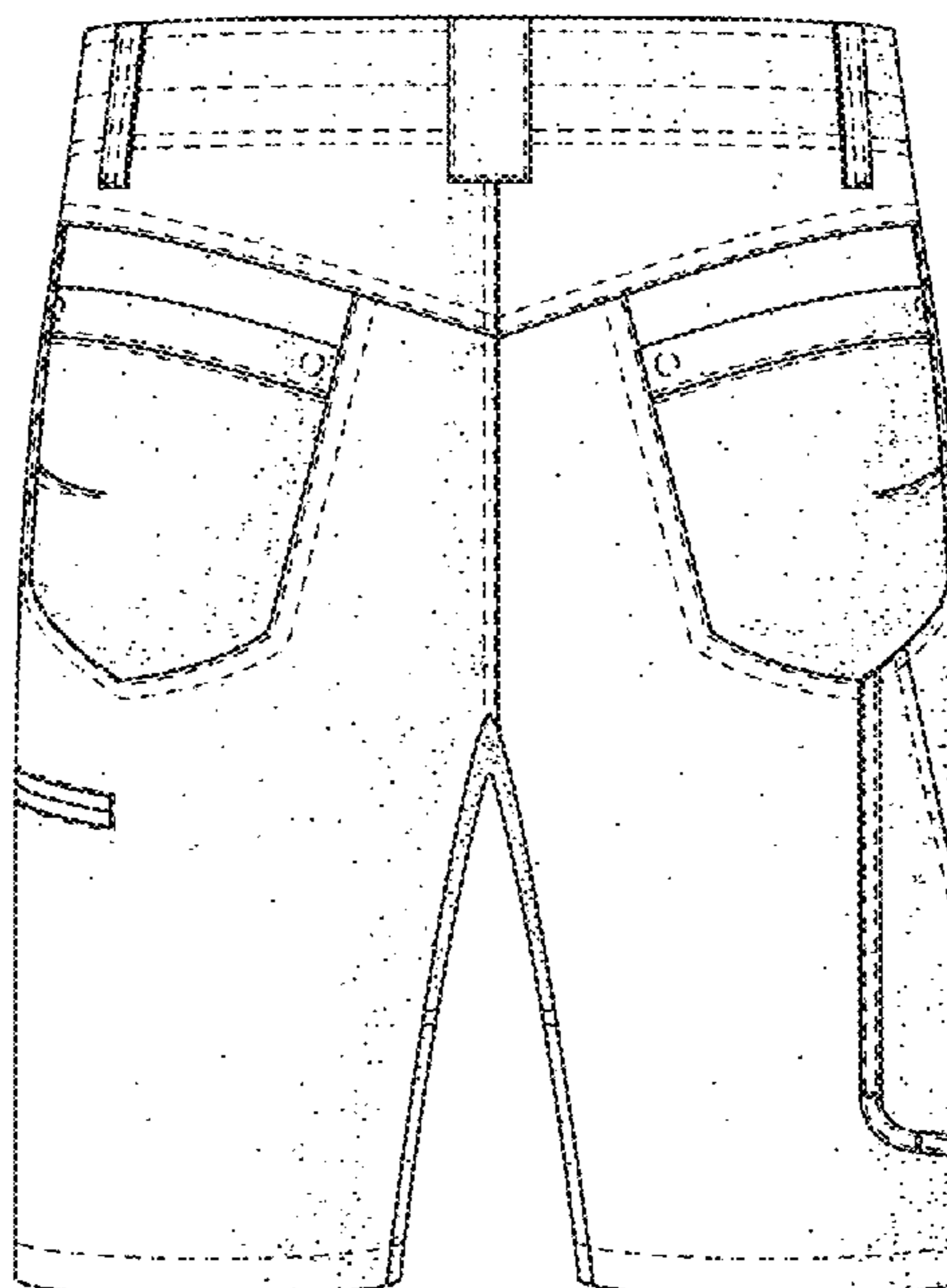
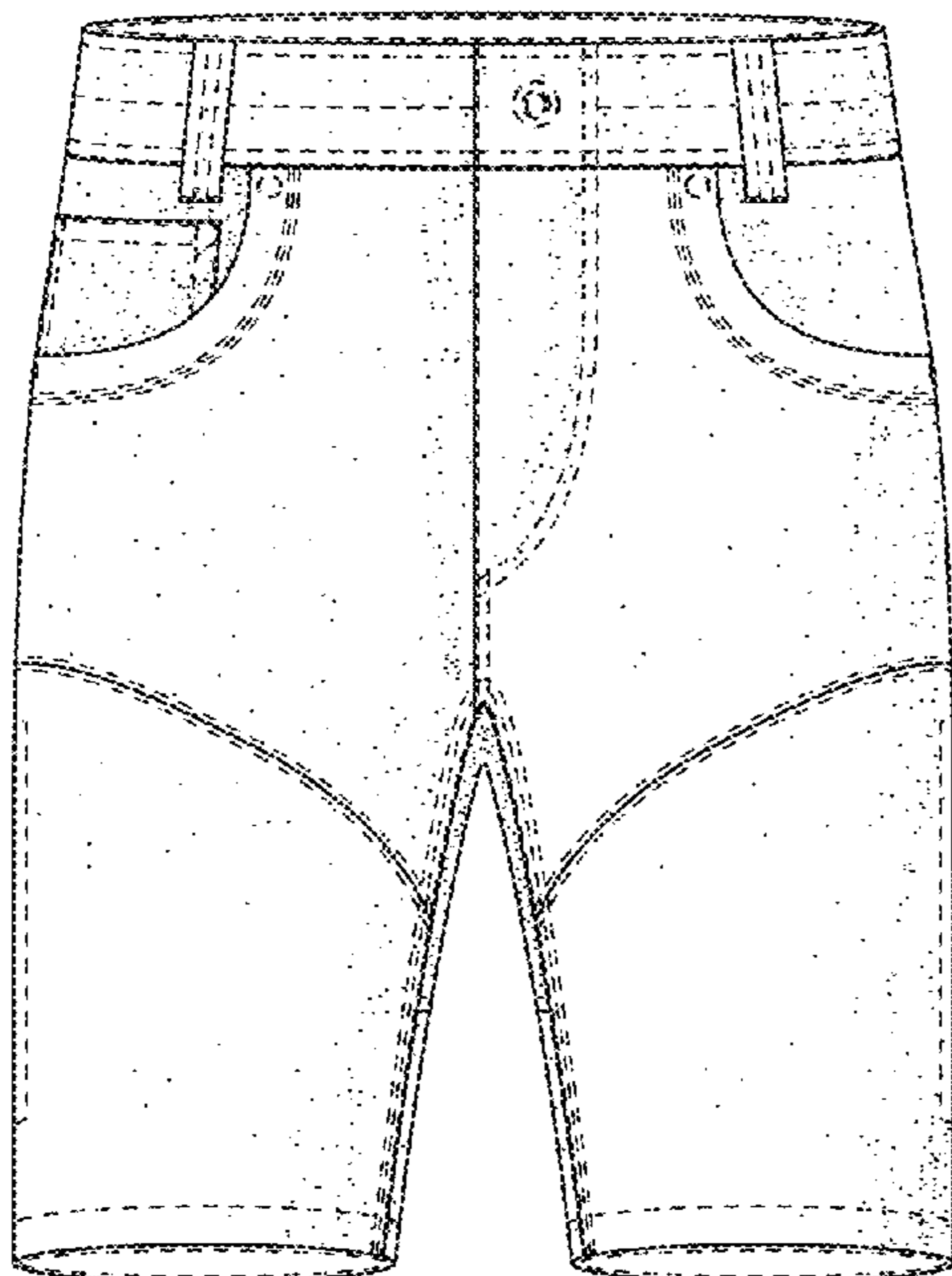
The ornamental design for vented shorts, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of vented shorts according to an embodiment of the claimed design;
FIG. 2 is a front elevational view of the vented shorts of FIG. 1;
FIG. 3 is a rear elevational view of the vented shorts of FIG. 1;
FIG. 4 is a right elevational view of the vented shorts of FIG. 1;
FIG. 5 is a left elevational view of the vented shorts of FIG. 1;
FIG. 6 is a top elevational view of the vented shorts of FIG. 1; and,
FIG. 7 is a bottom elevational view of the vented shorts of FIG. 1.

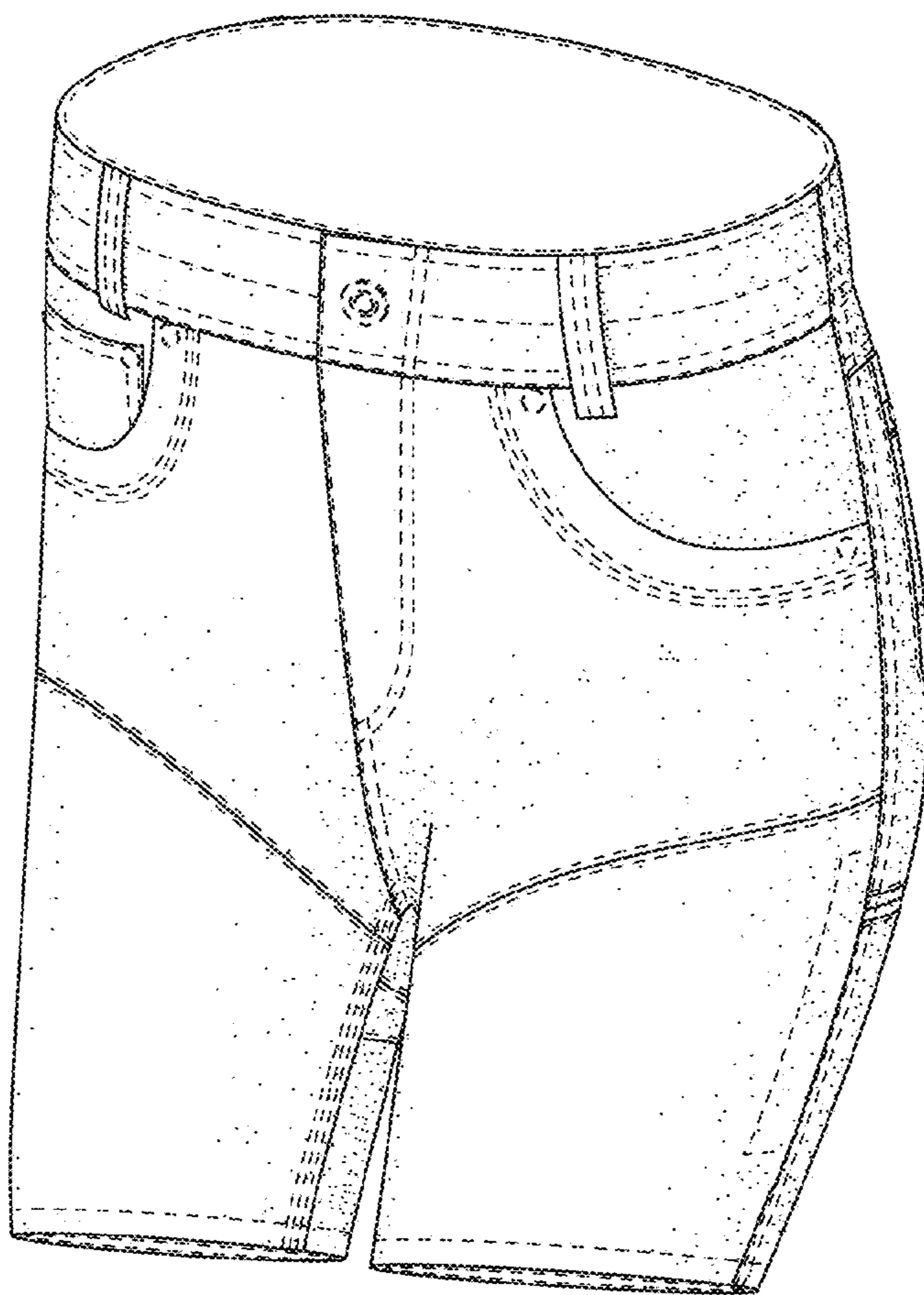

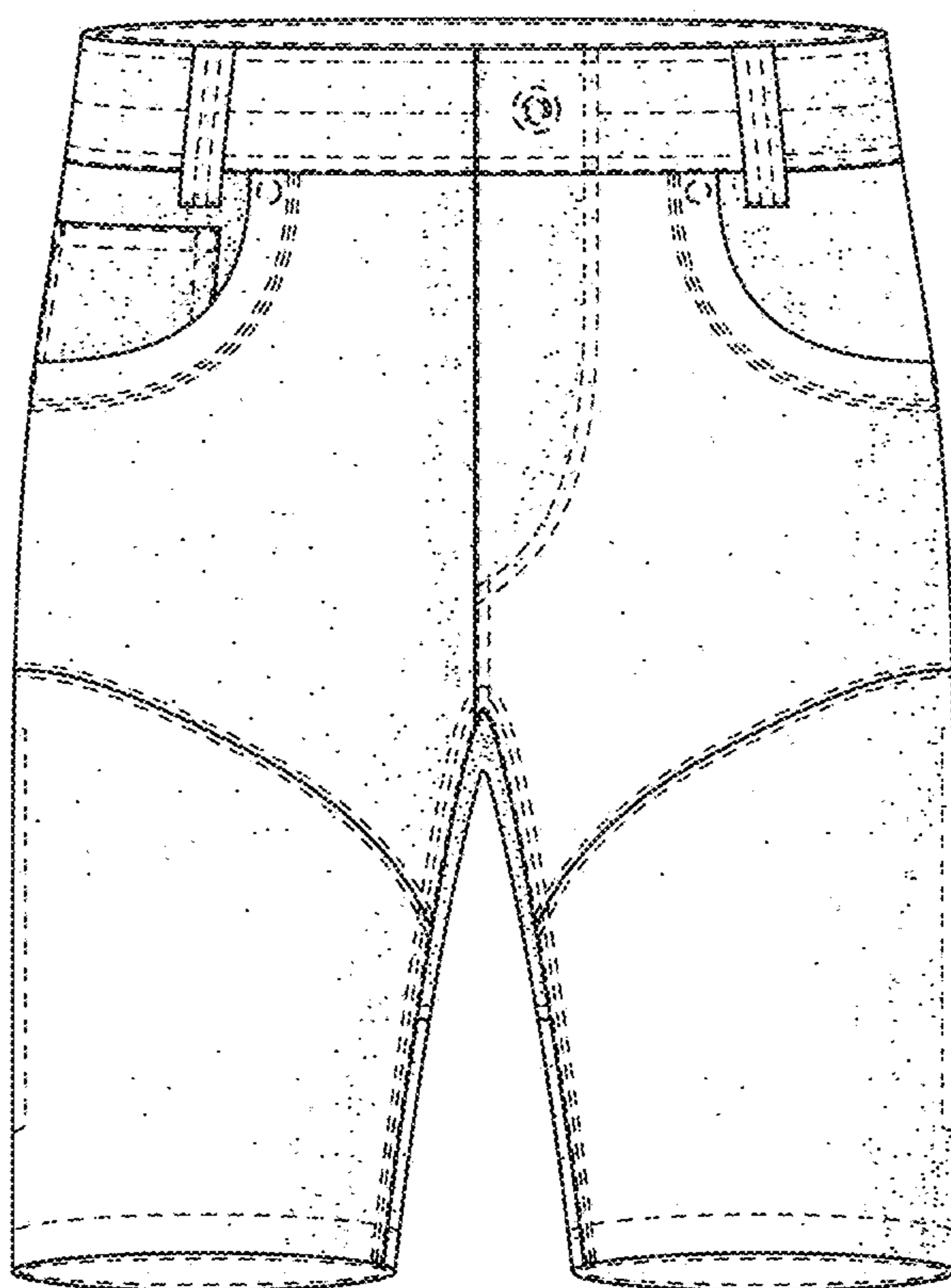

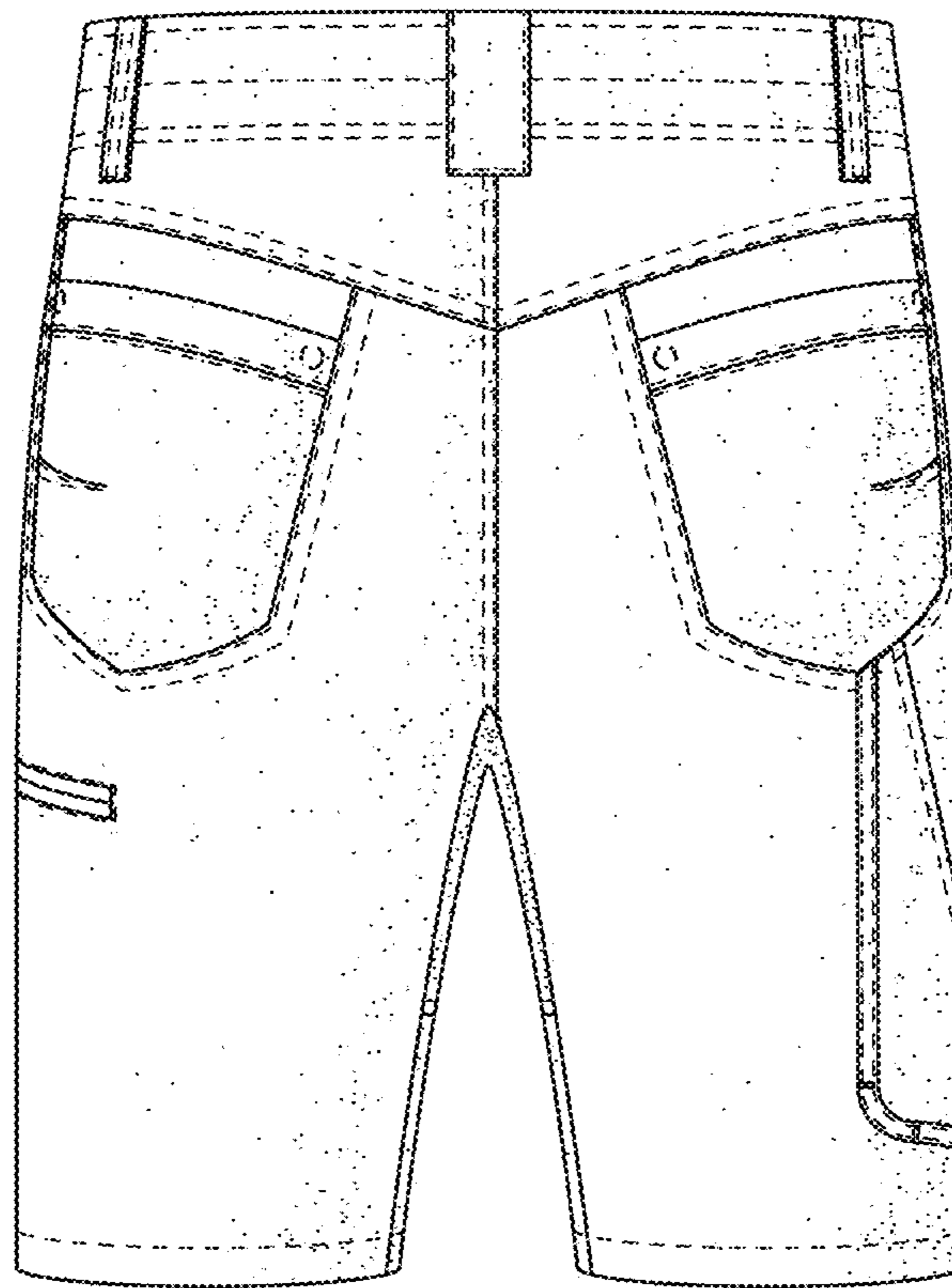

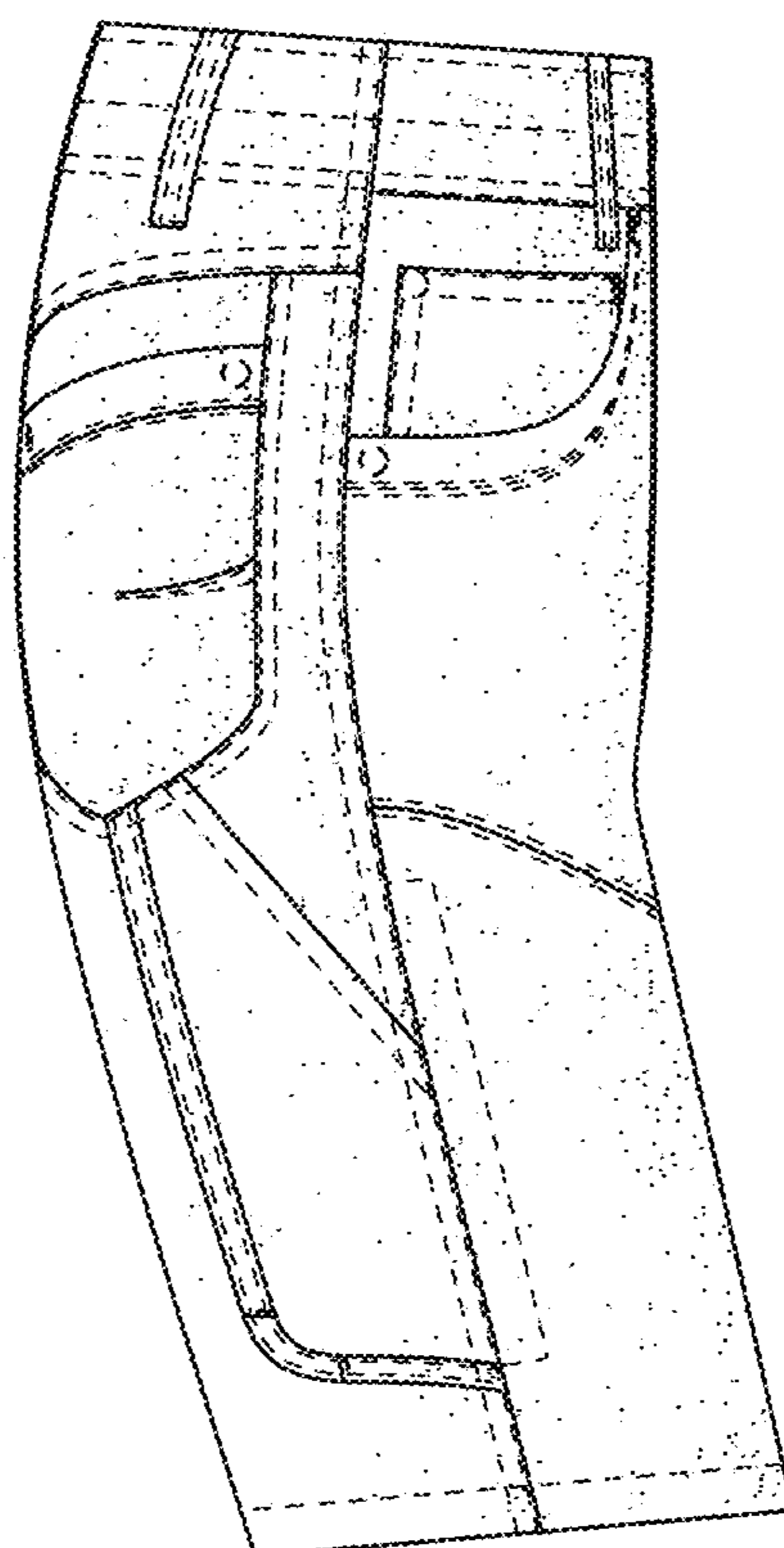

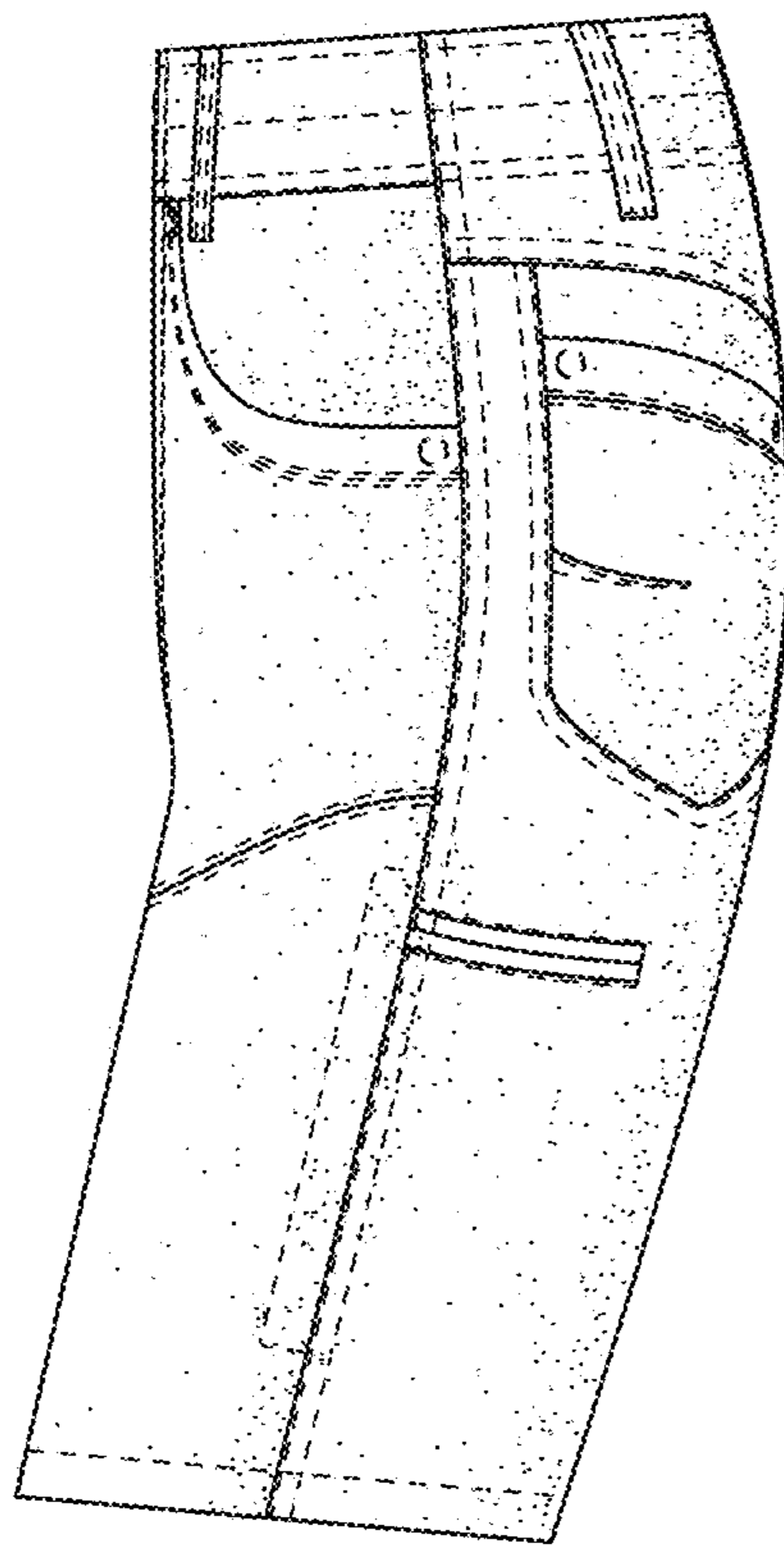

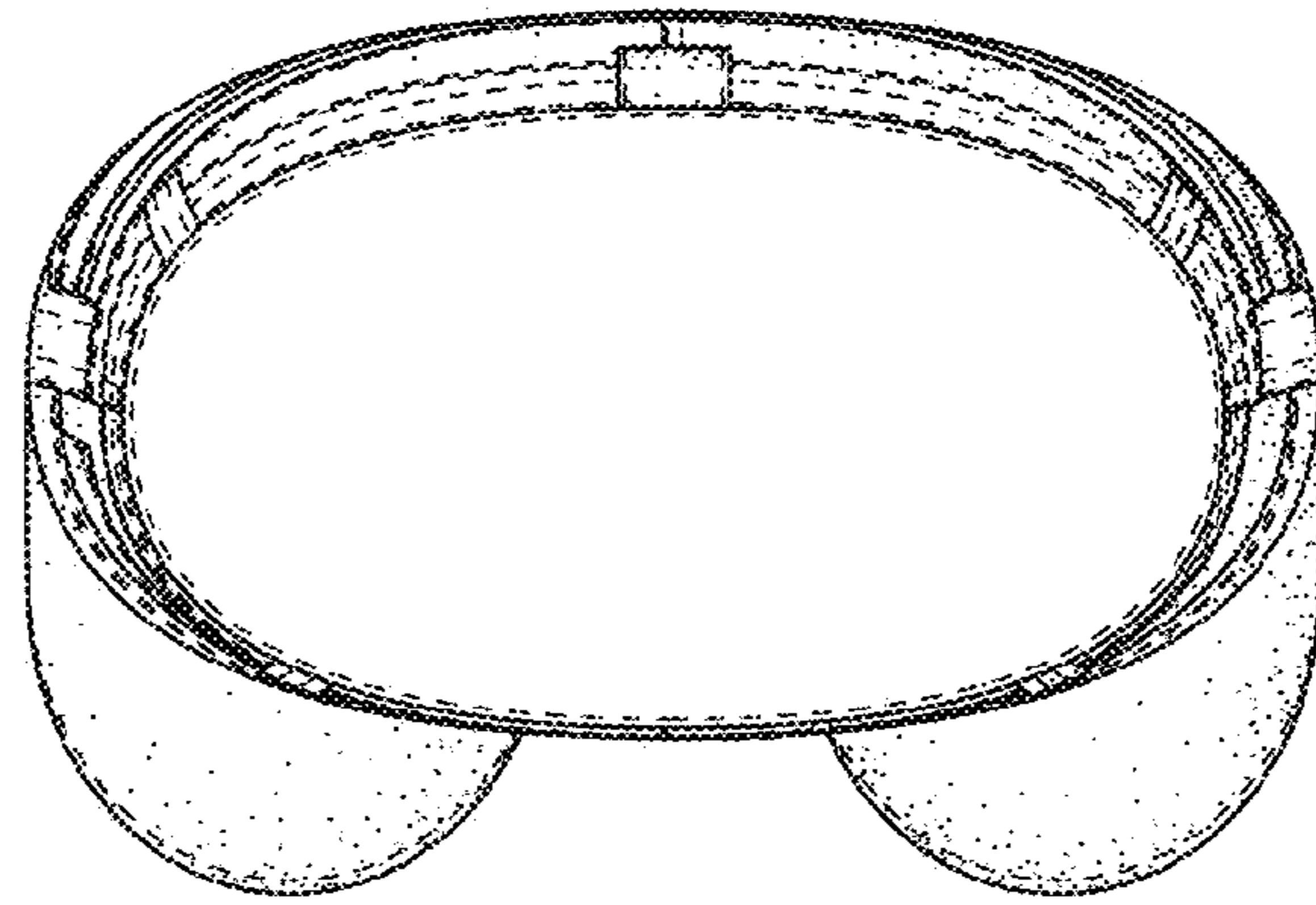

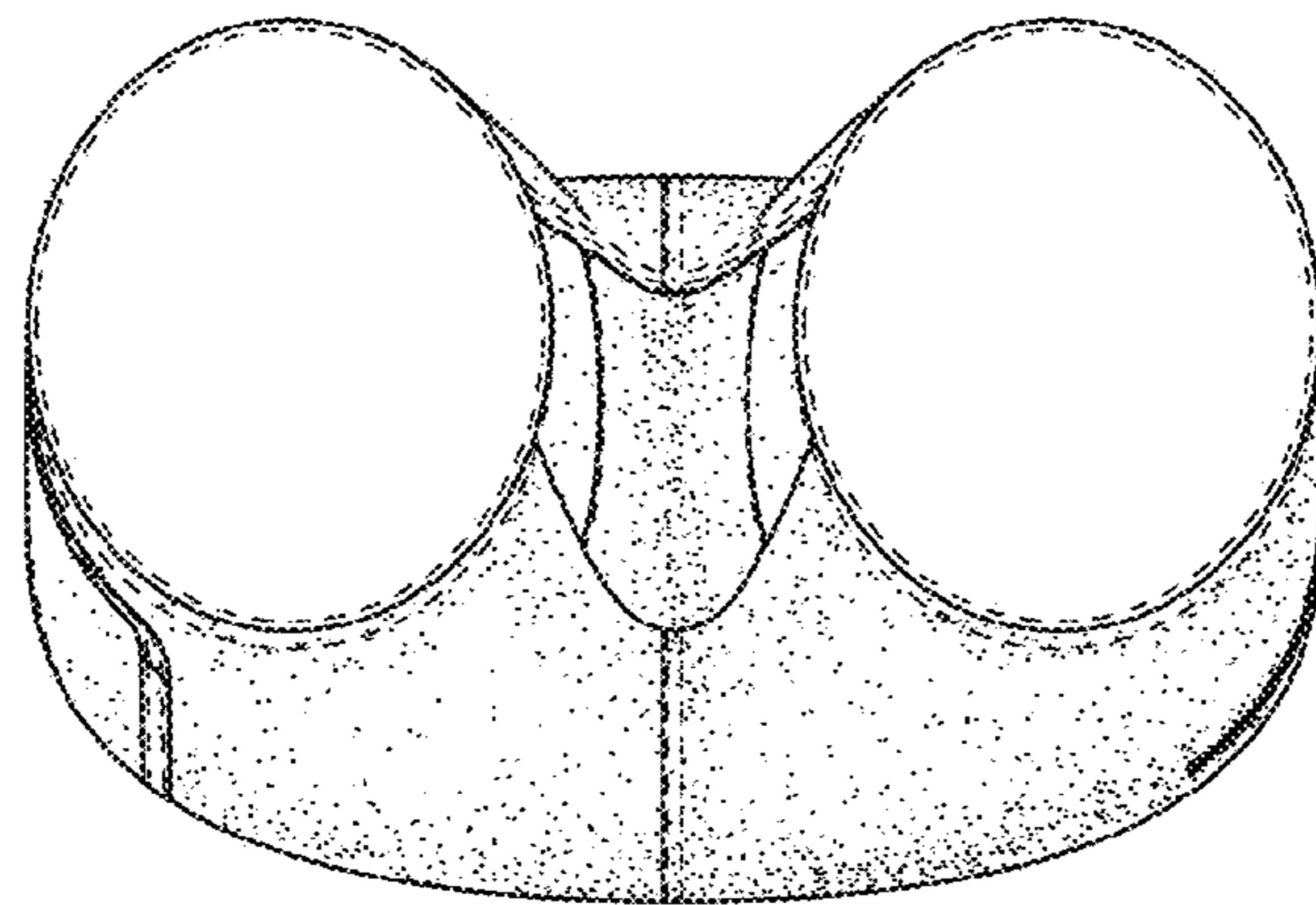
