(57) **CLAIM**

I claim the ornamental design for a jacket, as shown and described.

FIG. 10 is a front elevational view of the jacket.

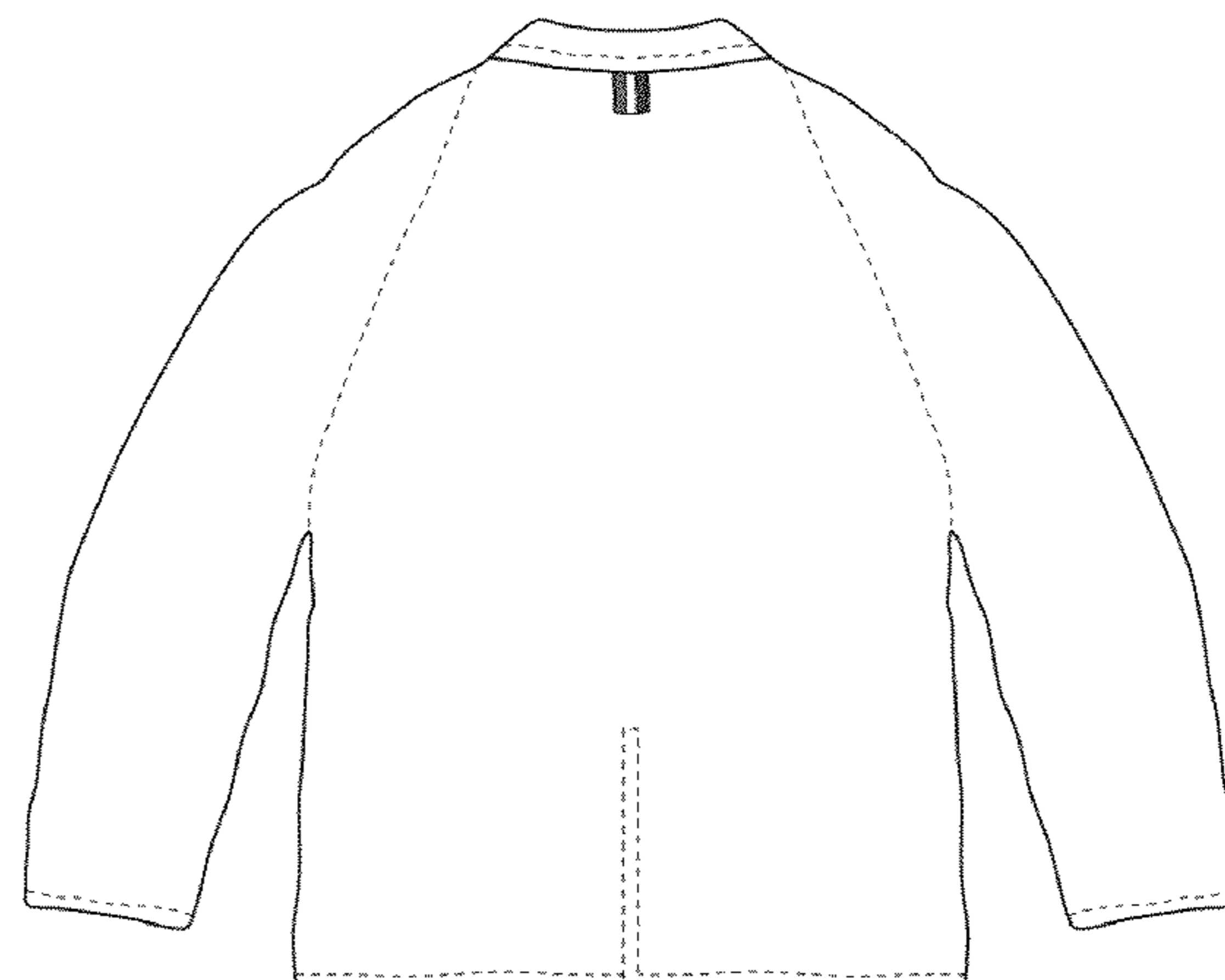
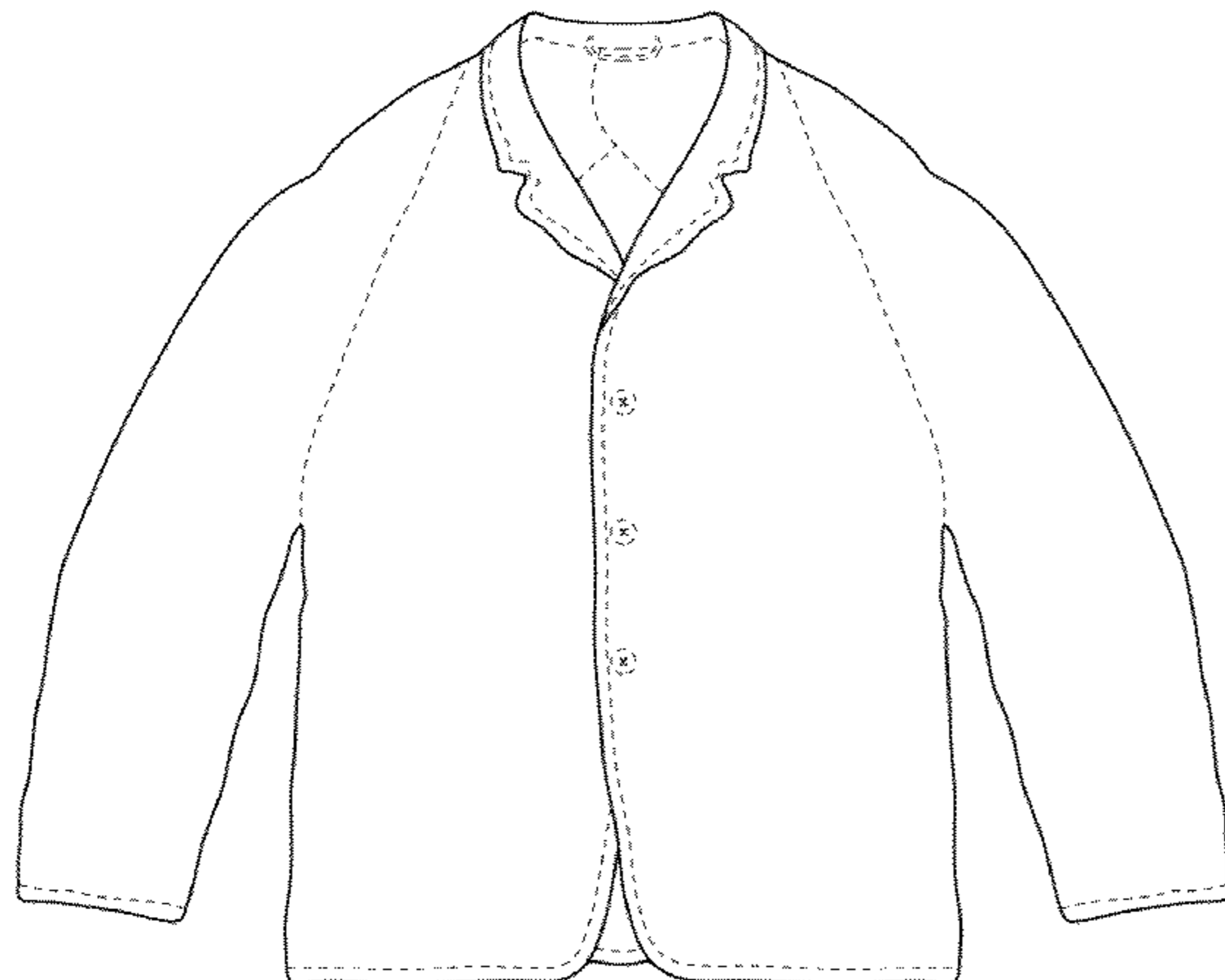
FIG. 11 is a rear elevational view of the jacket having the tricolor grosgrain loop shown in FIG. 8.

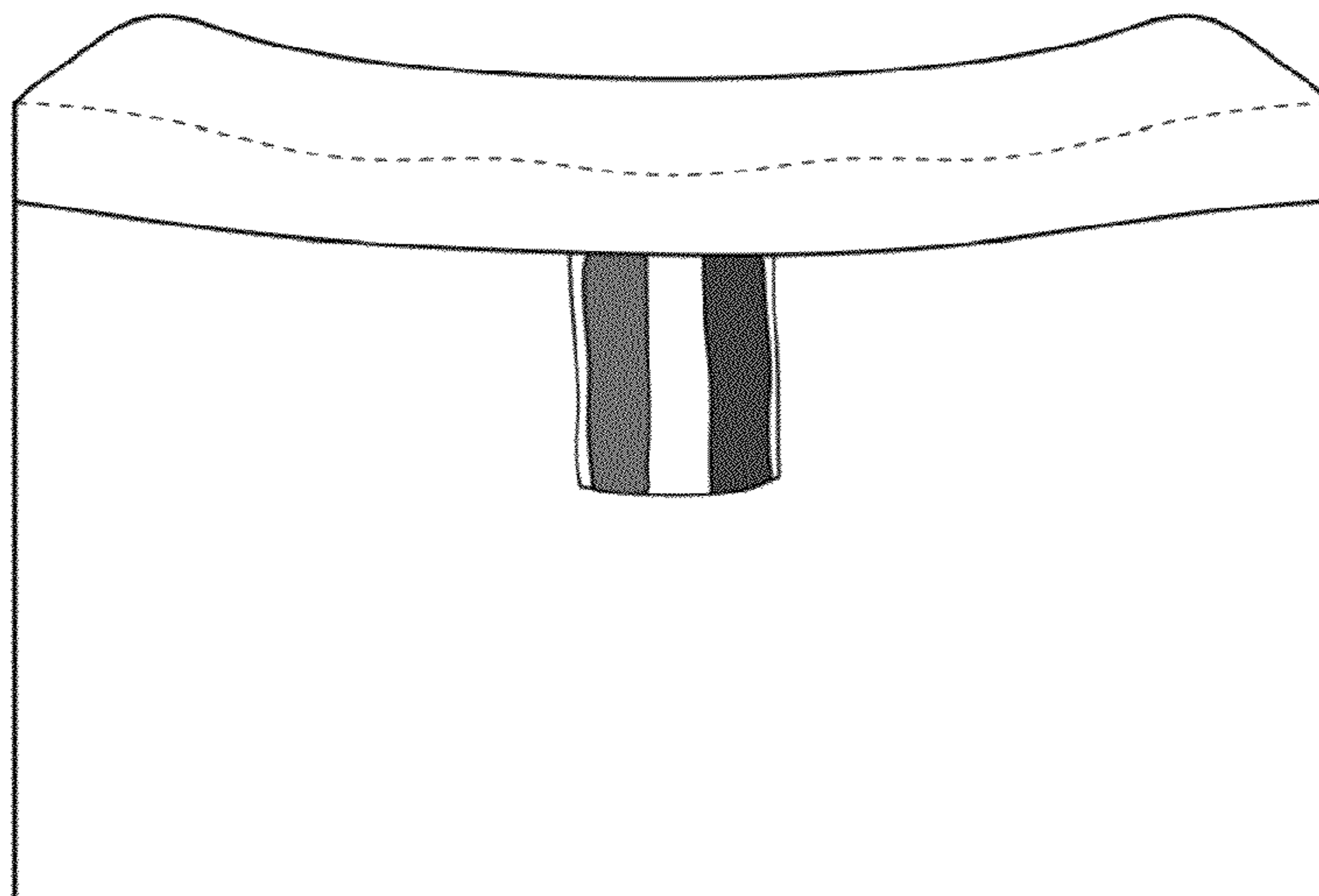

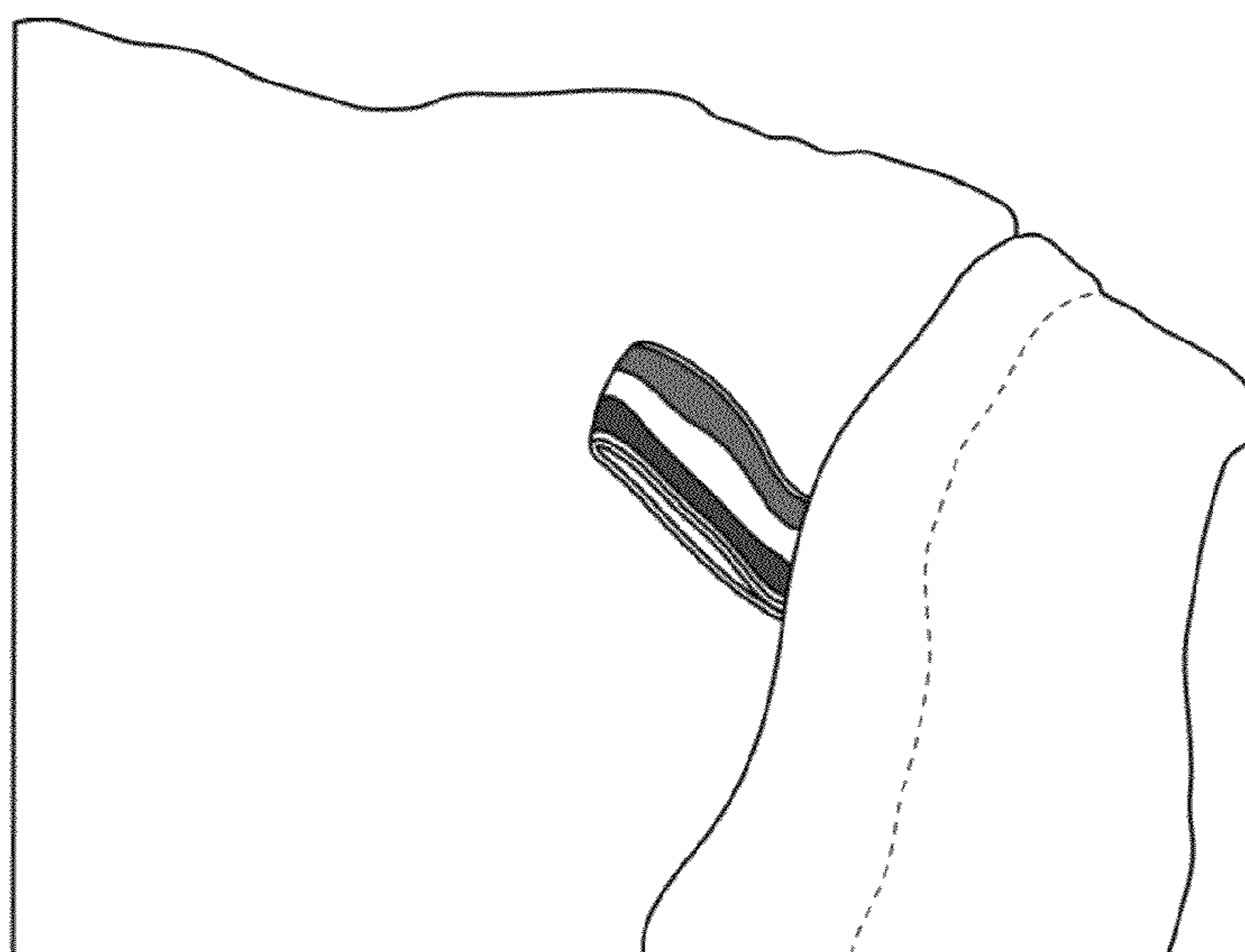

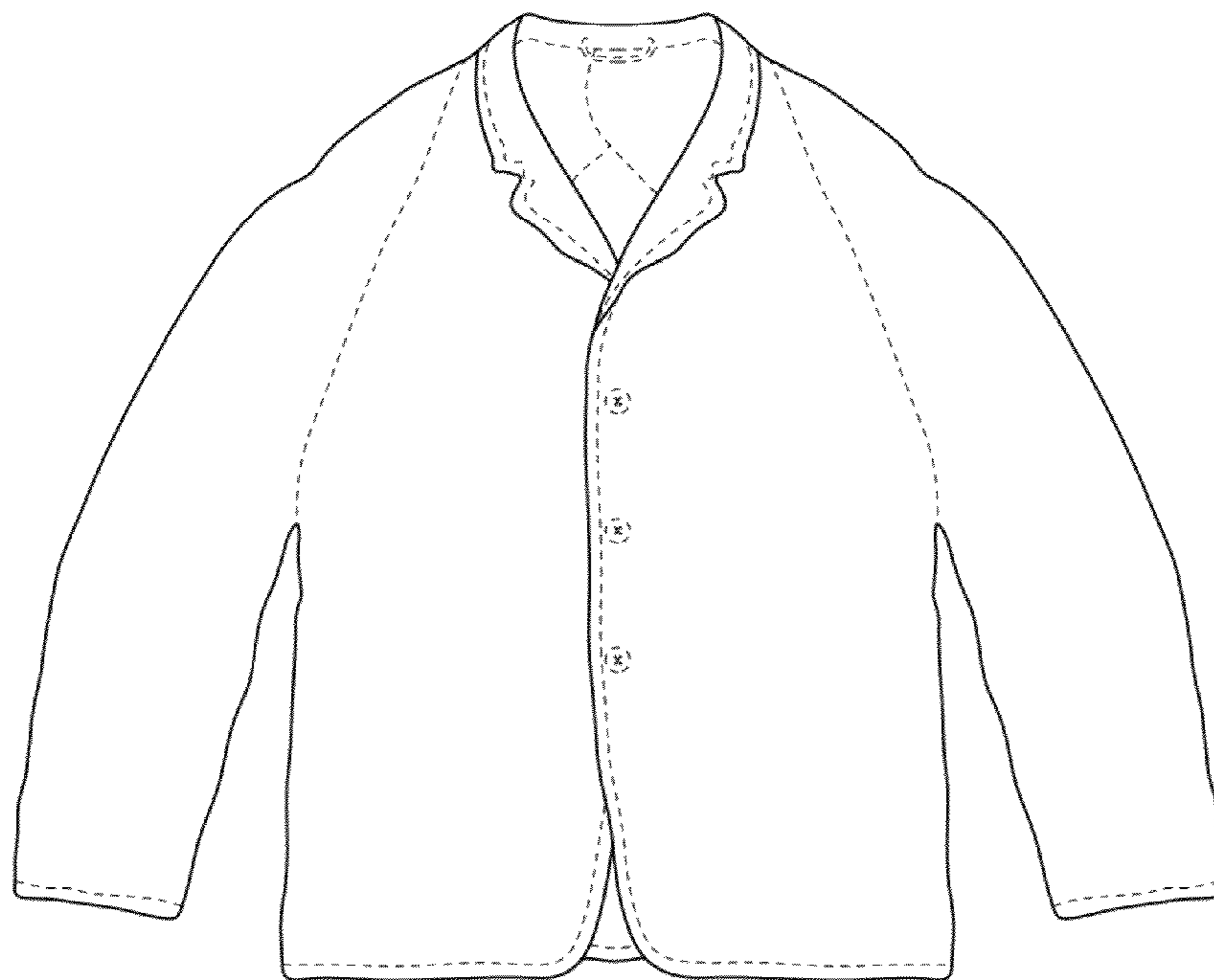

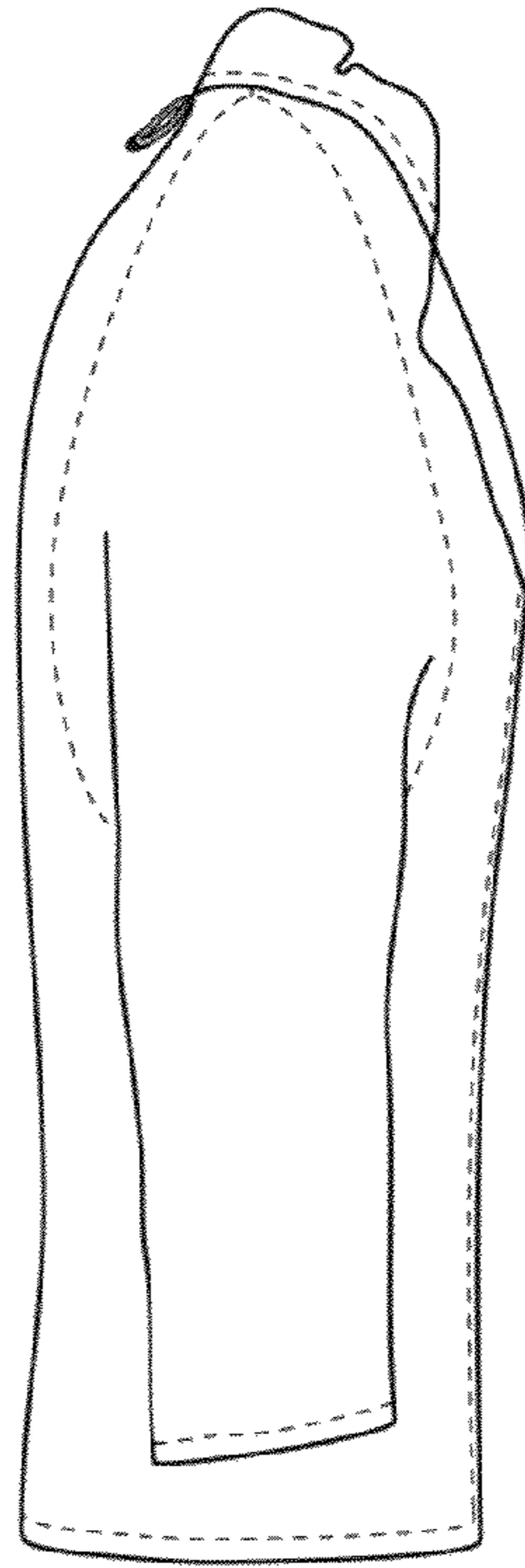

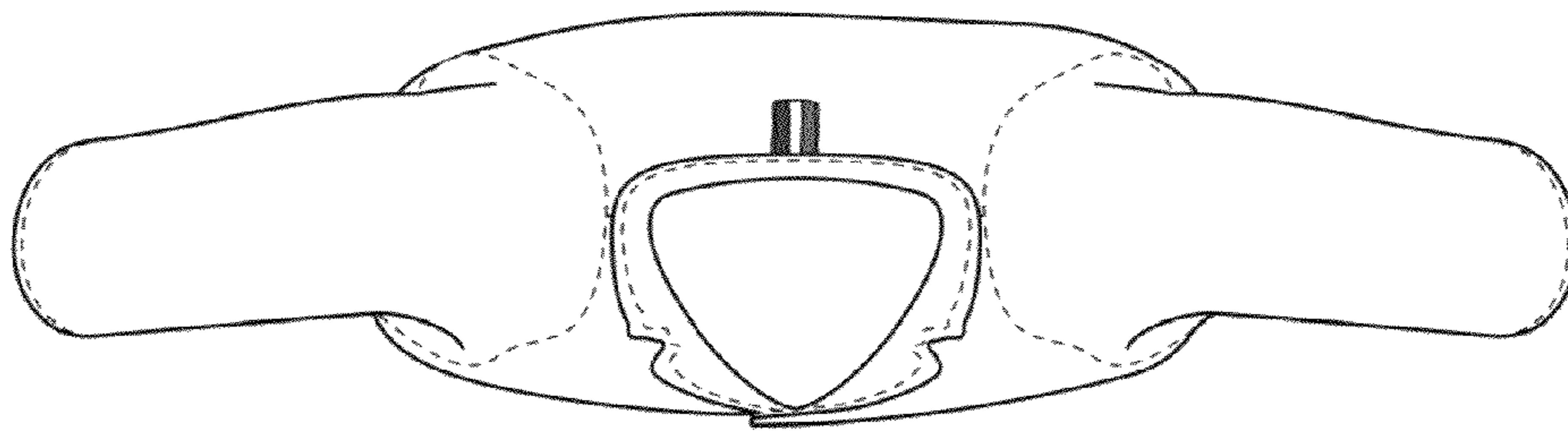

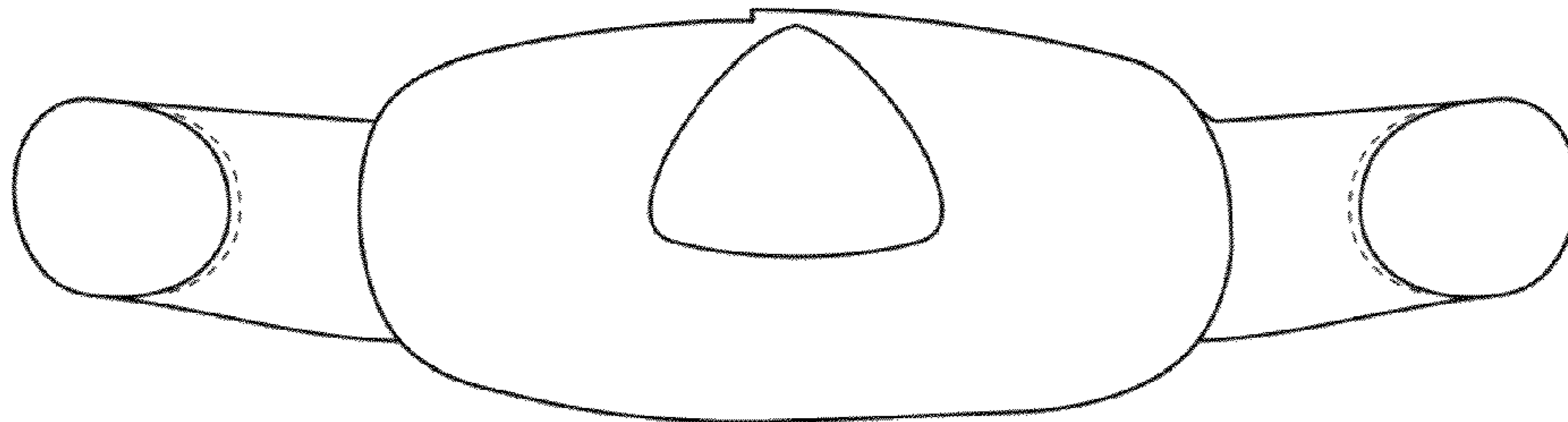

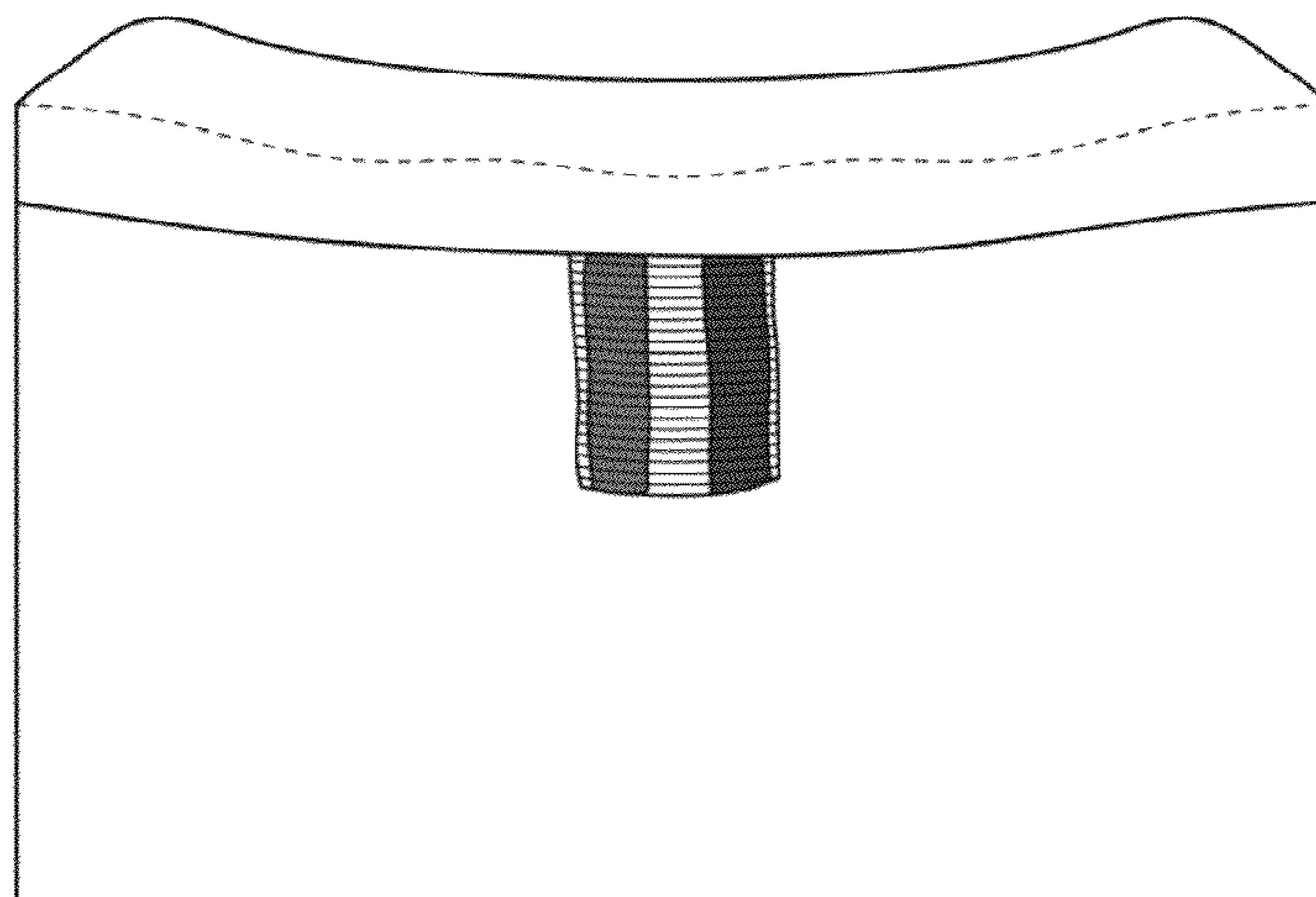

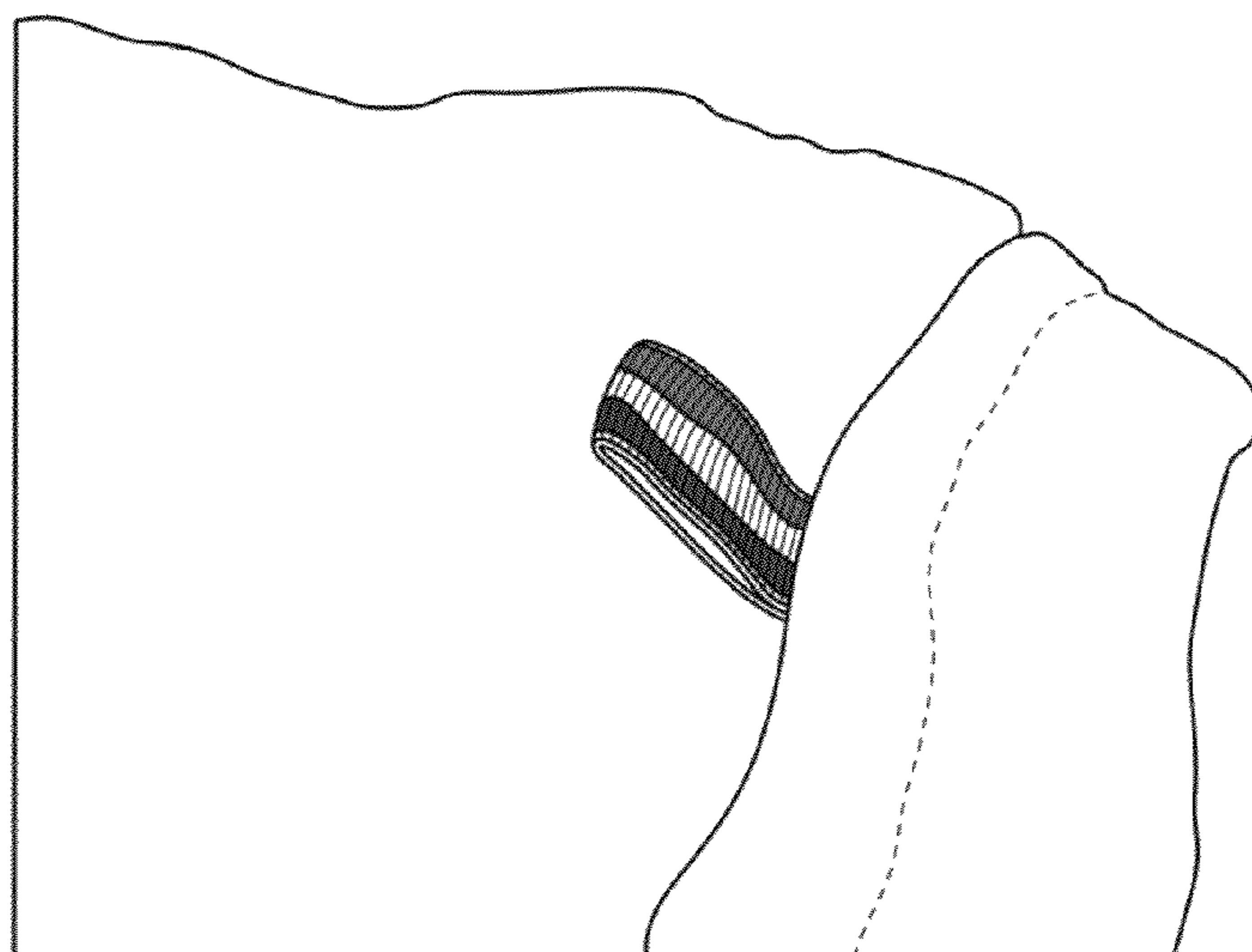

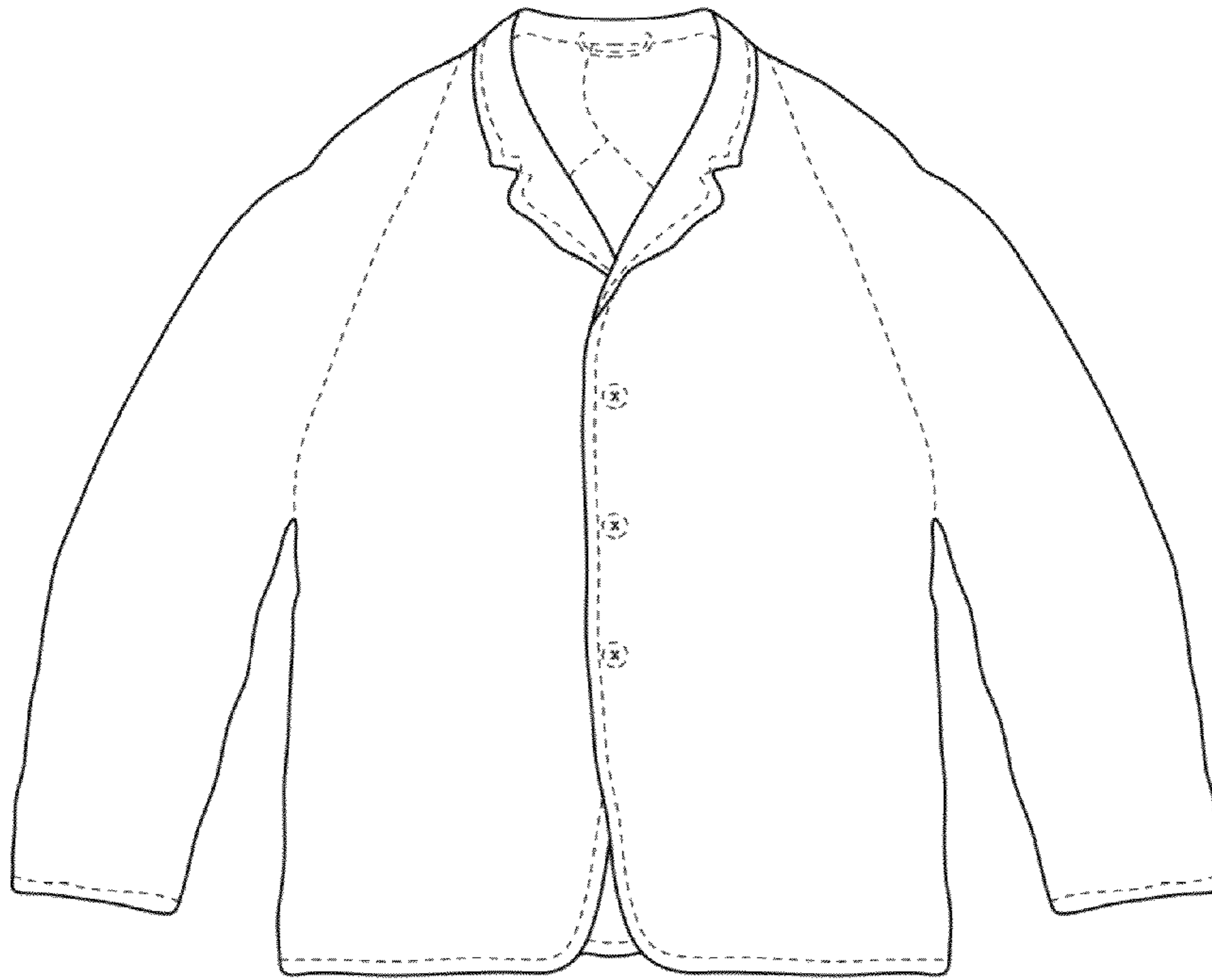

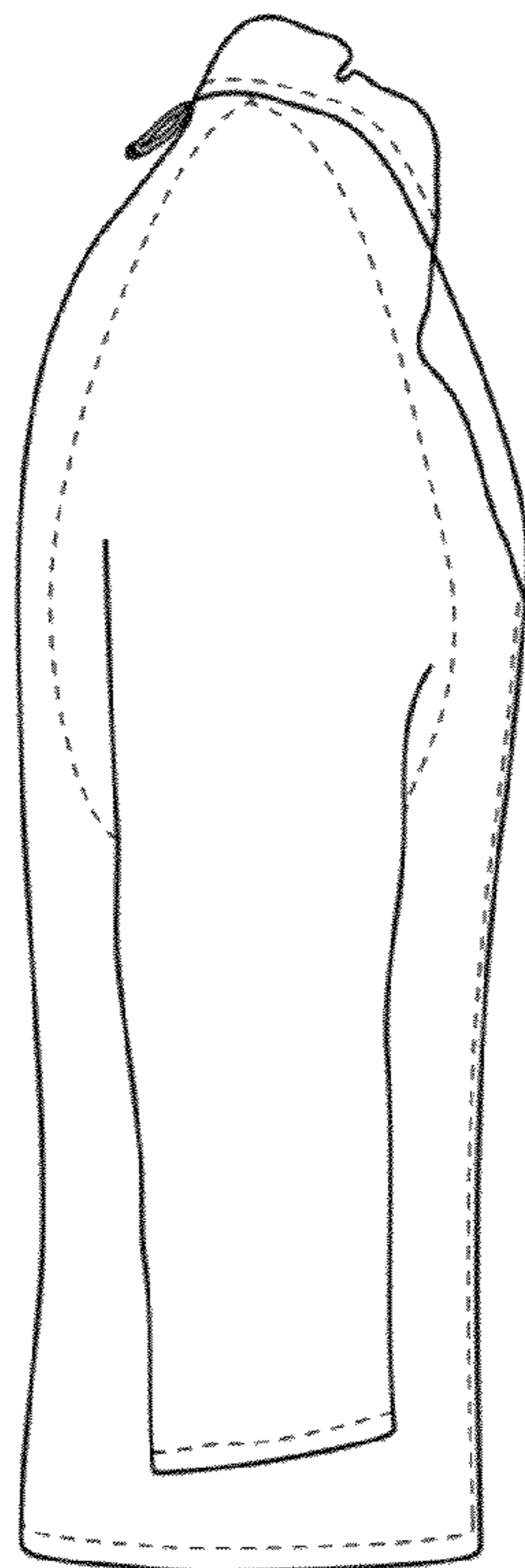

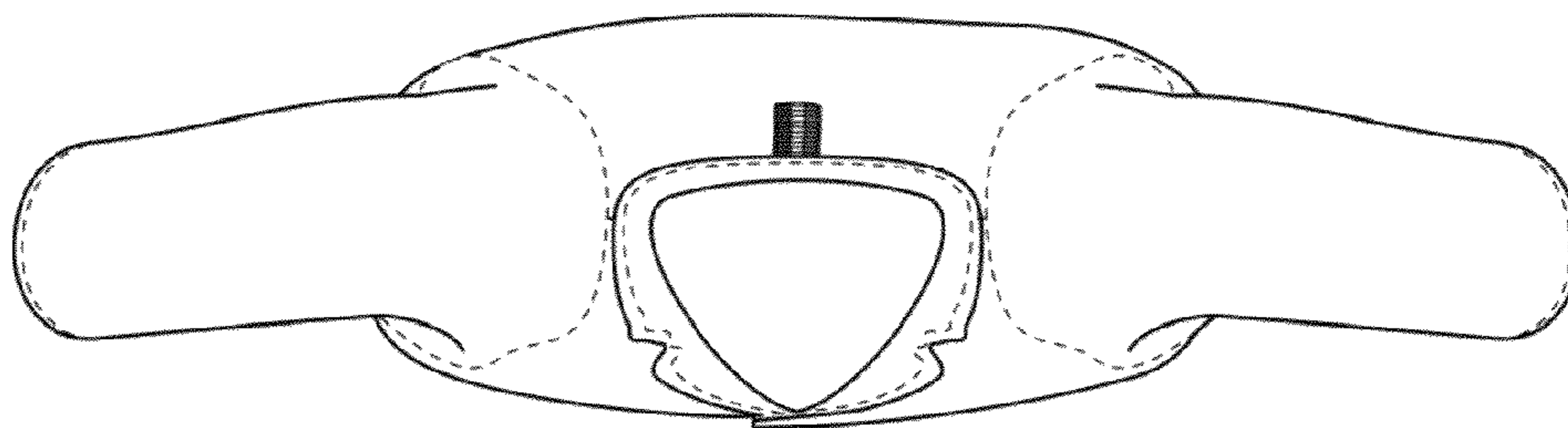

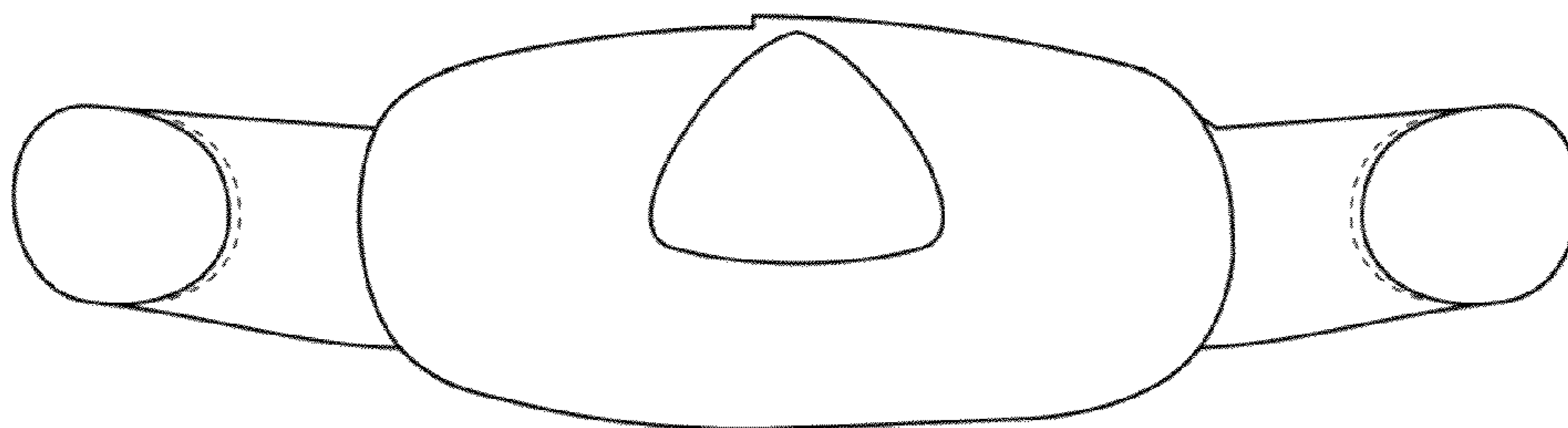
