(57) **CLAIM**

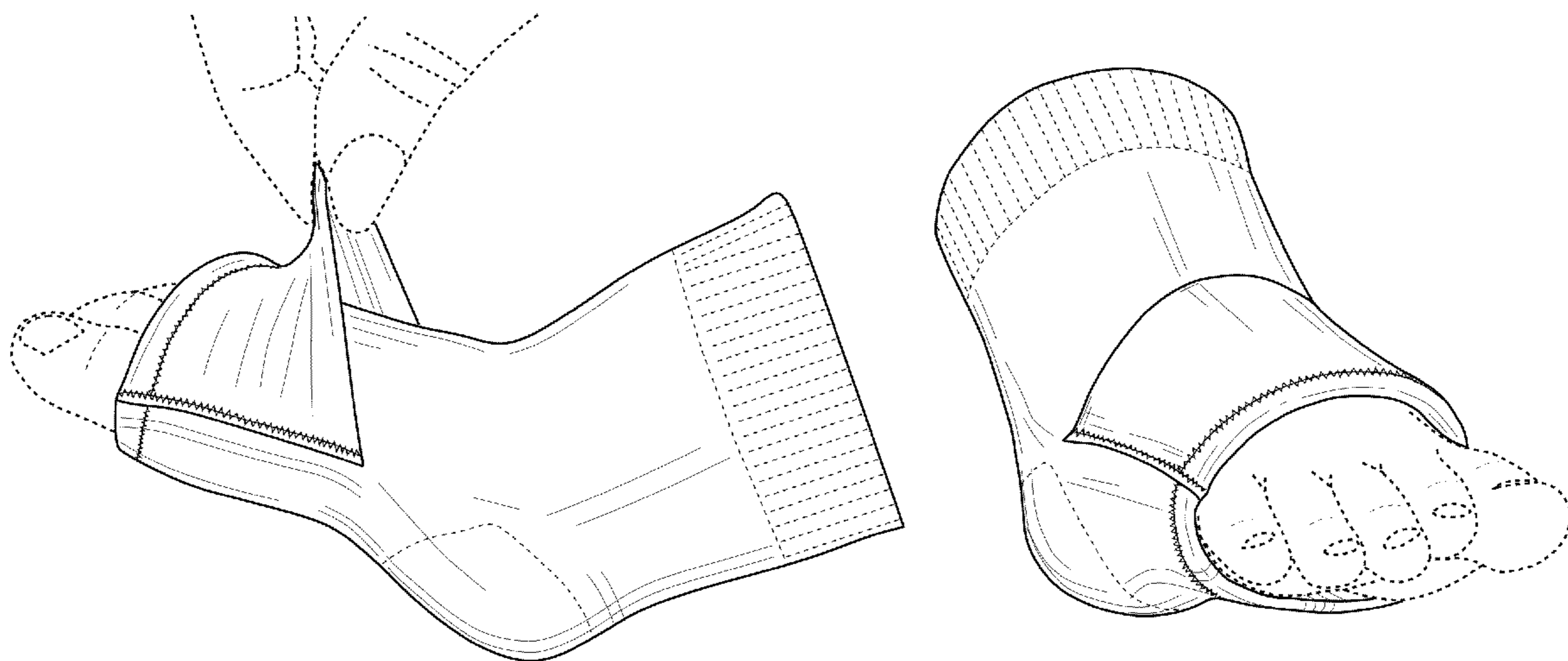
I claim ornamental design for a sock, as shown and described.

**DESCRIPTION**

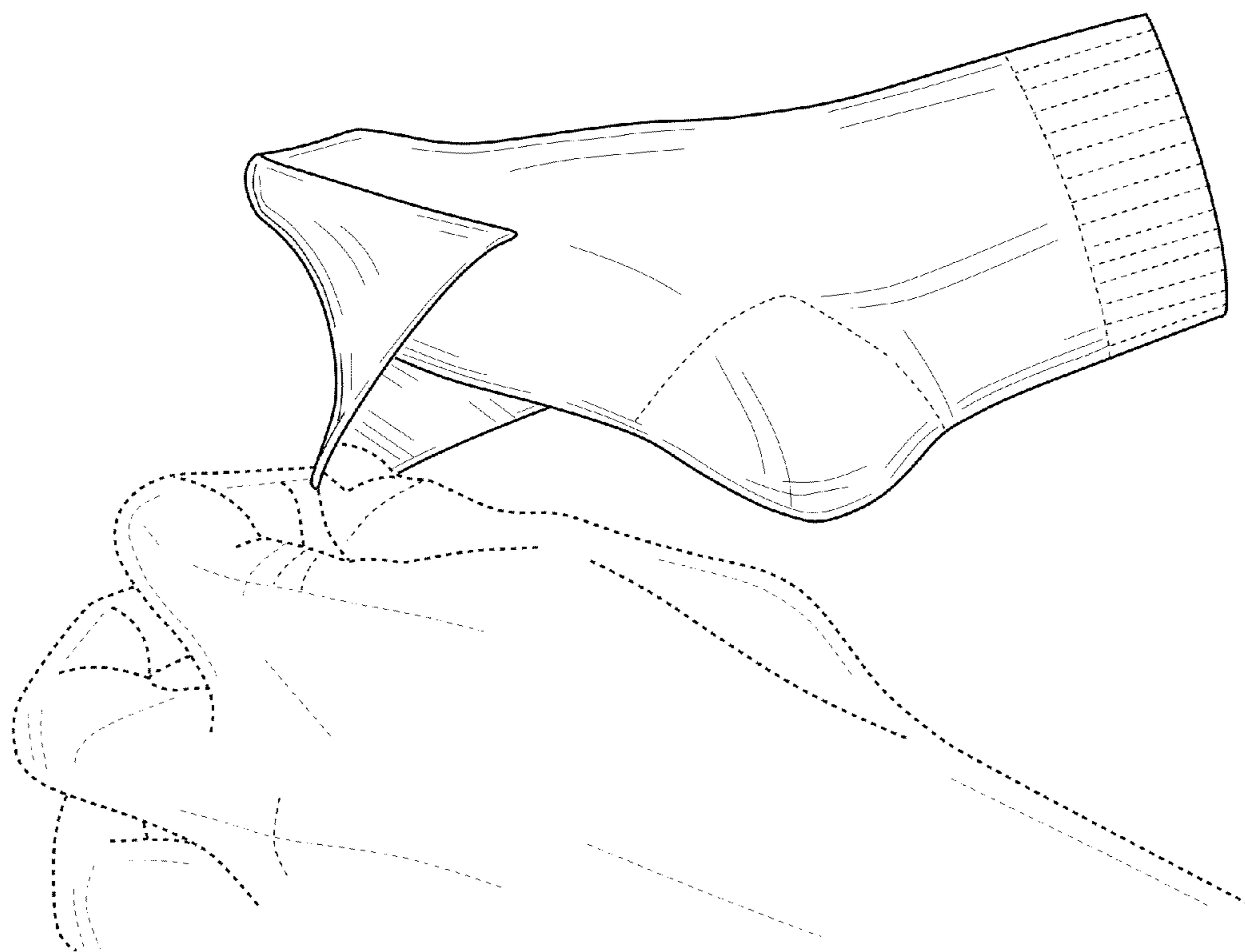

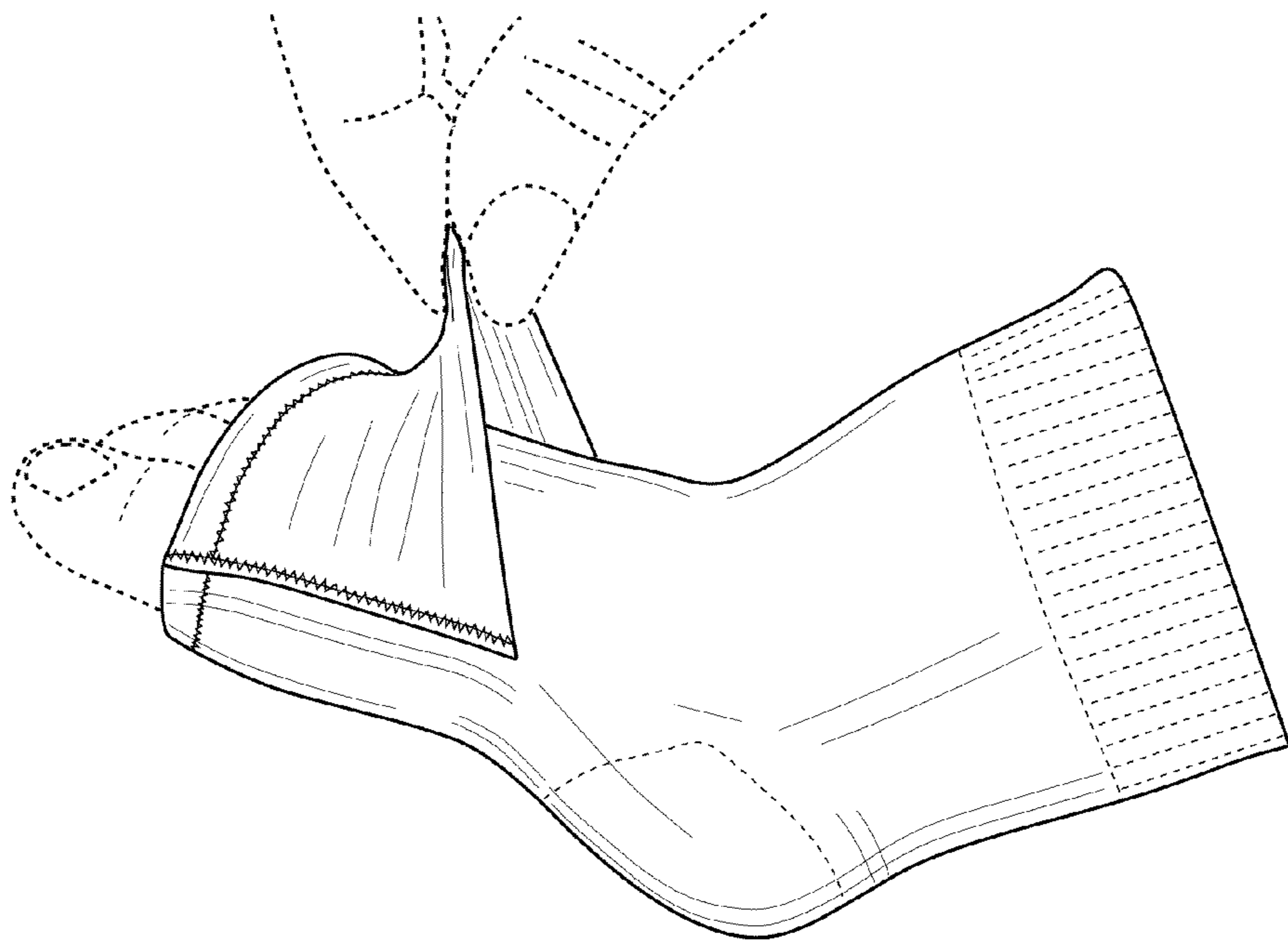

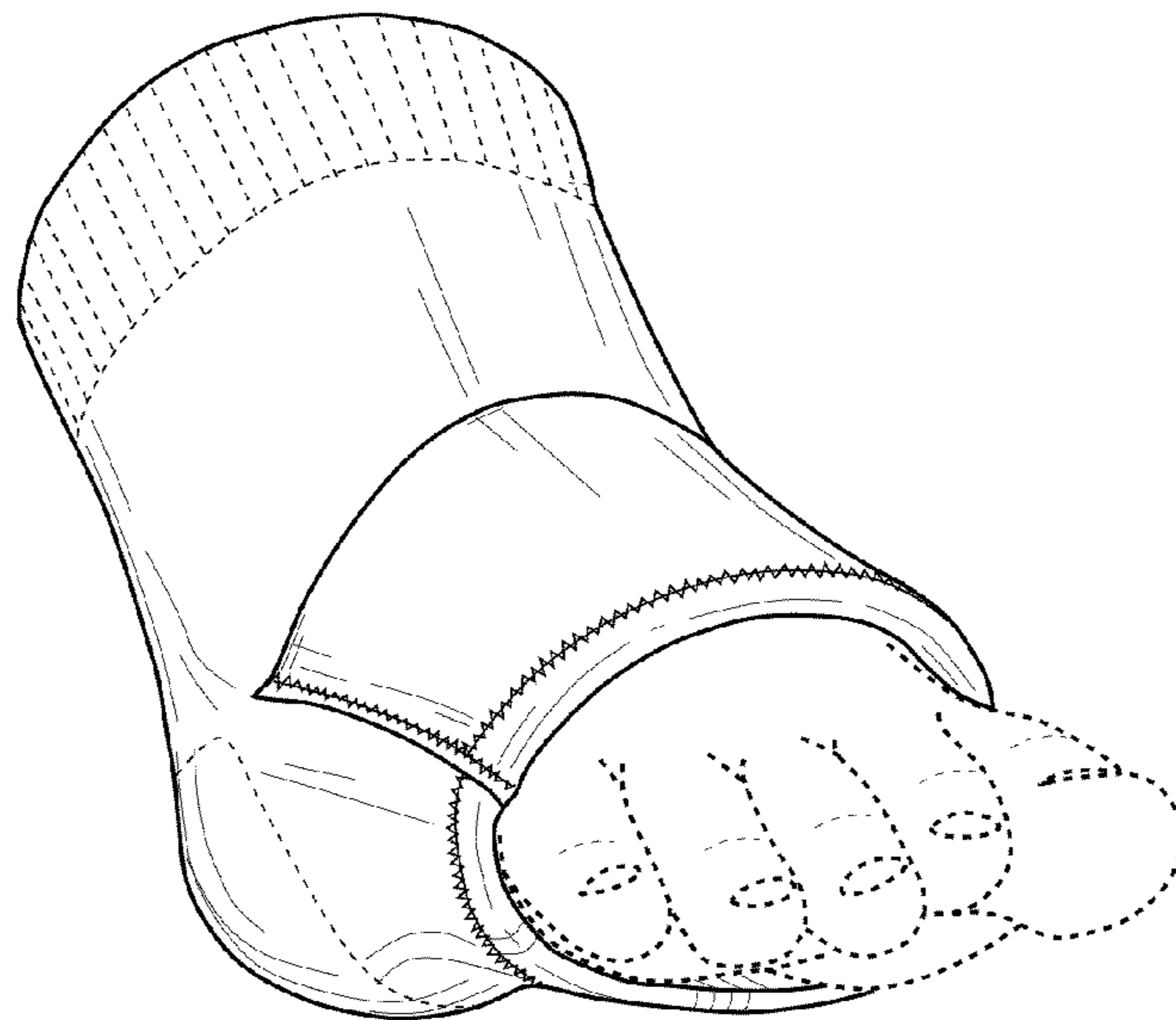

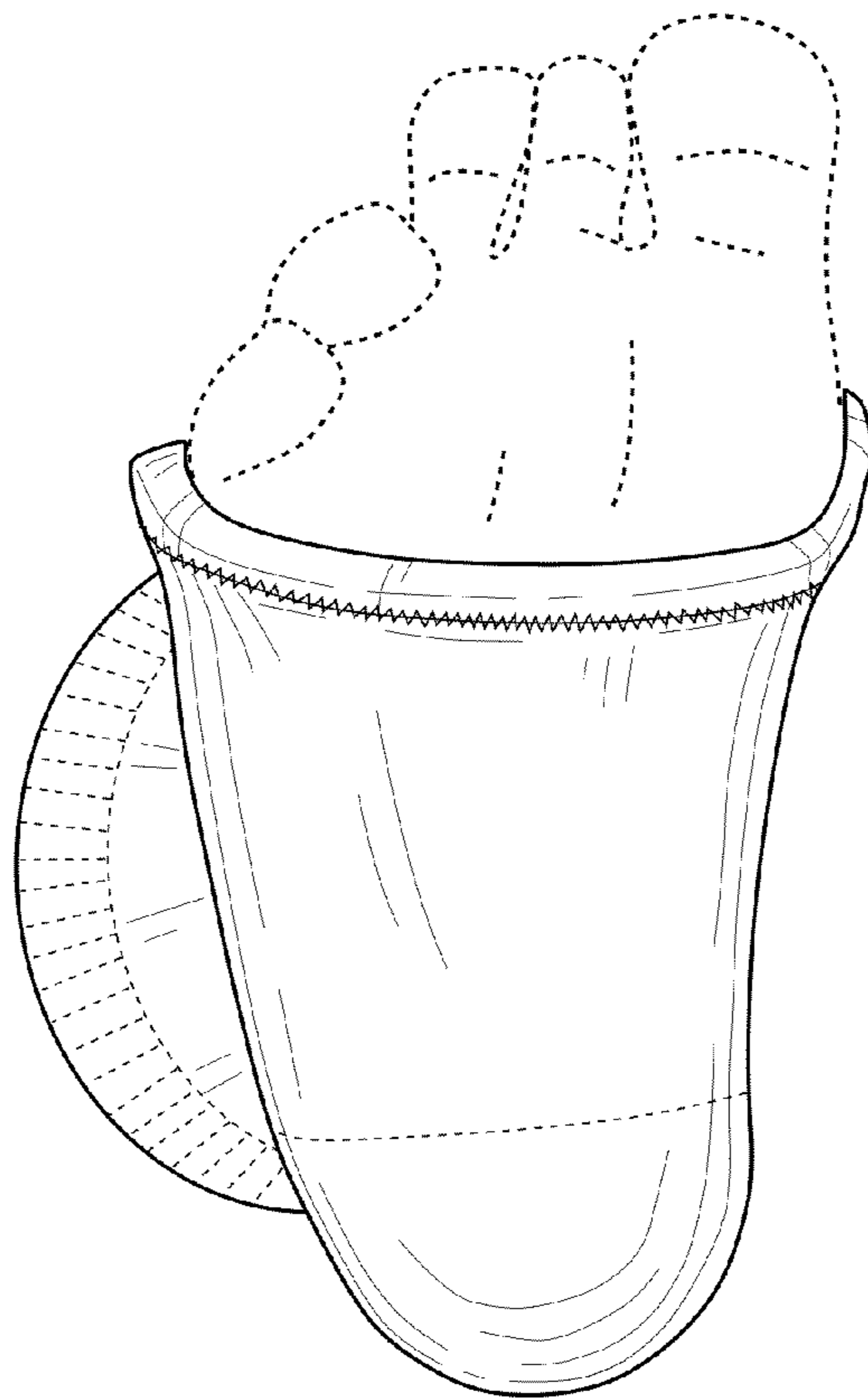

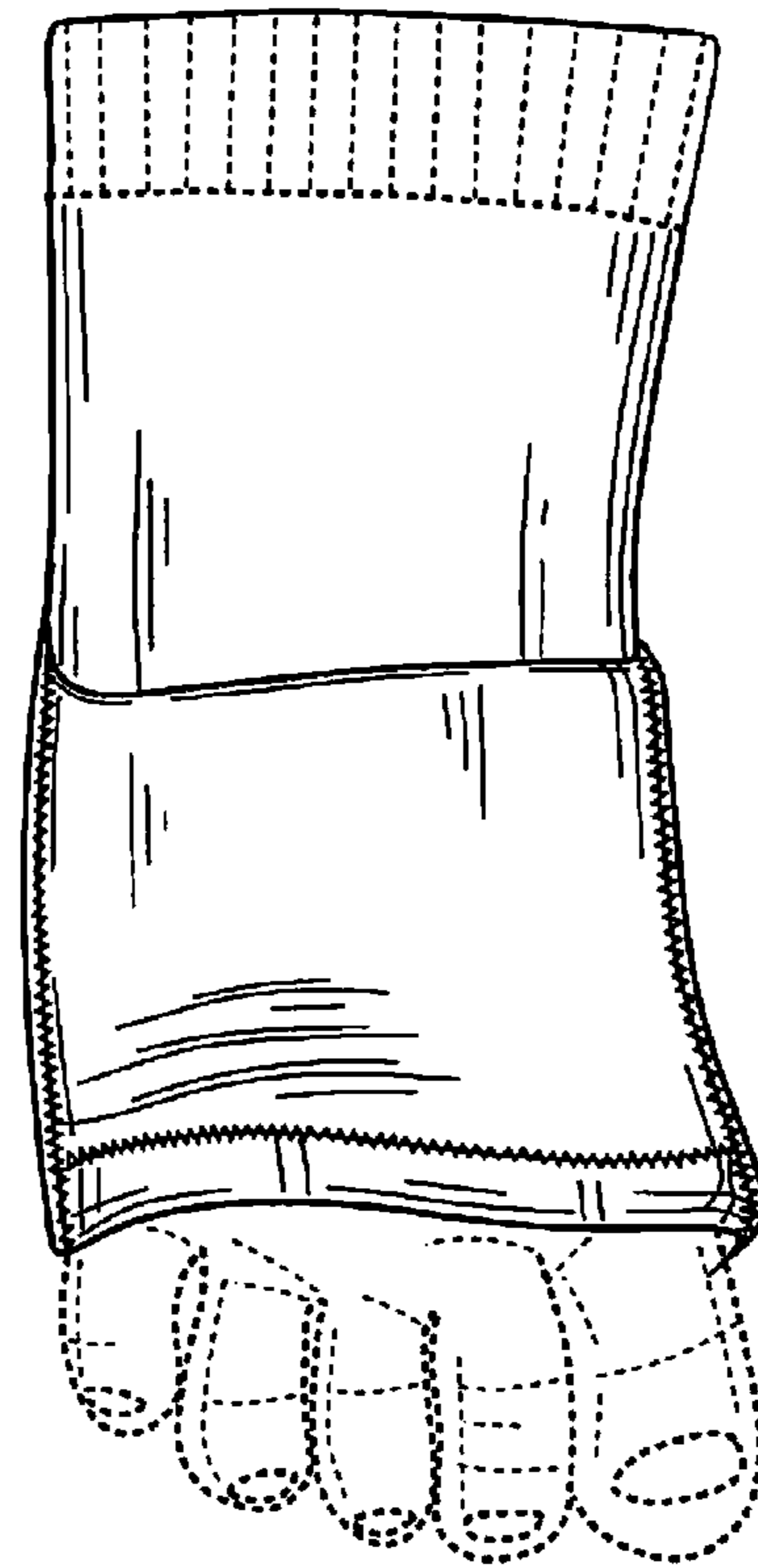

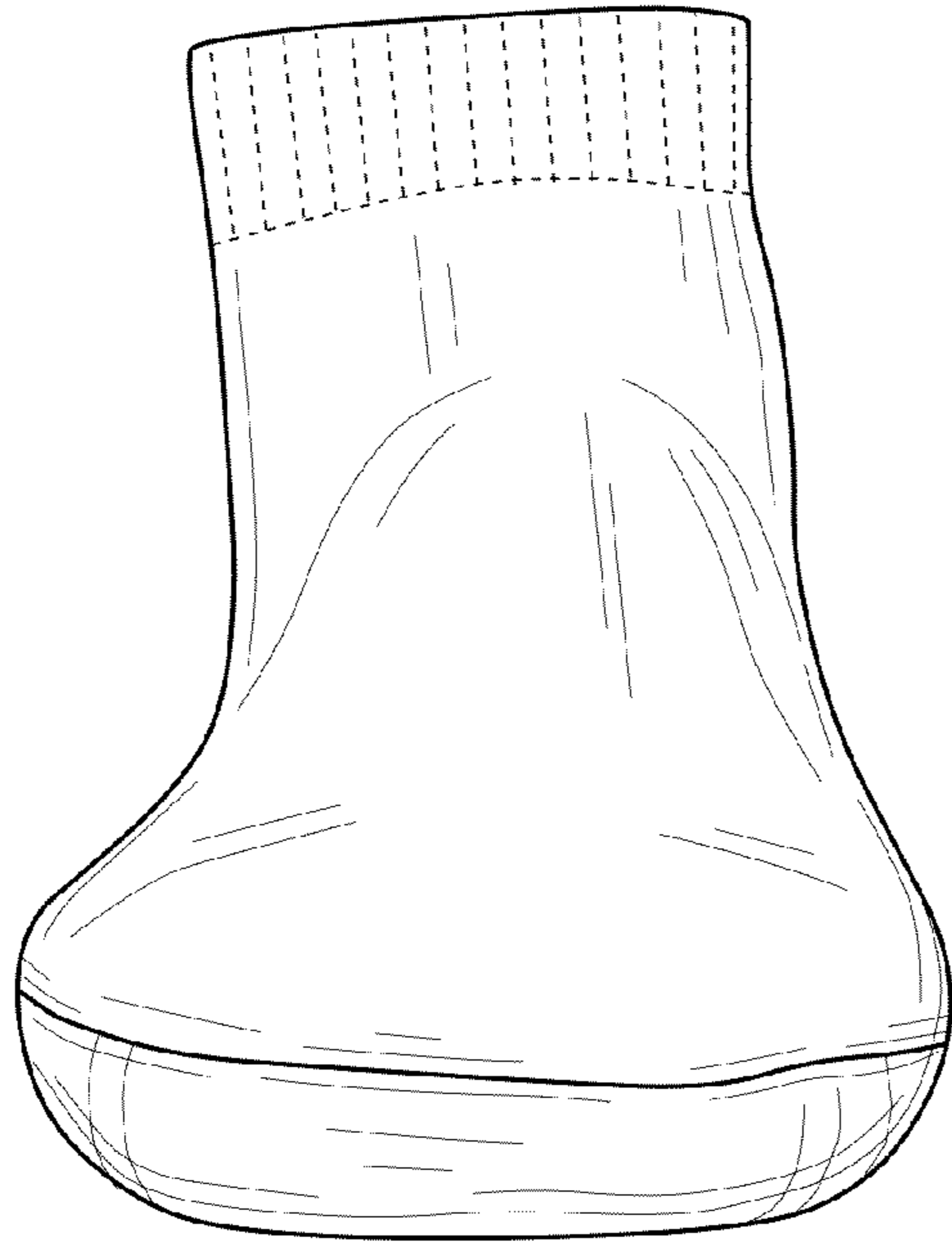

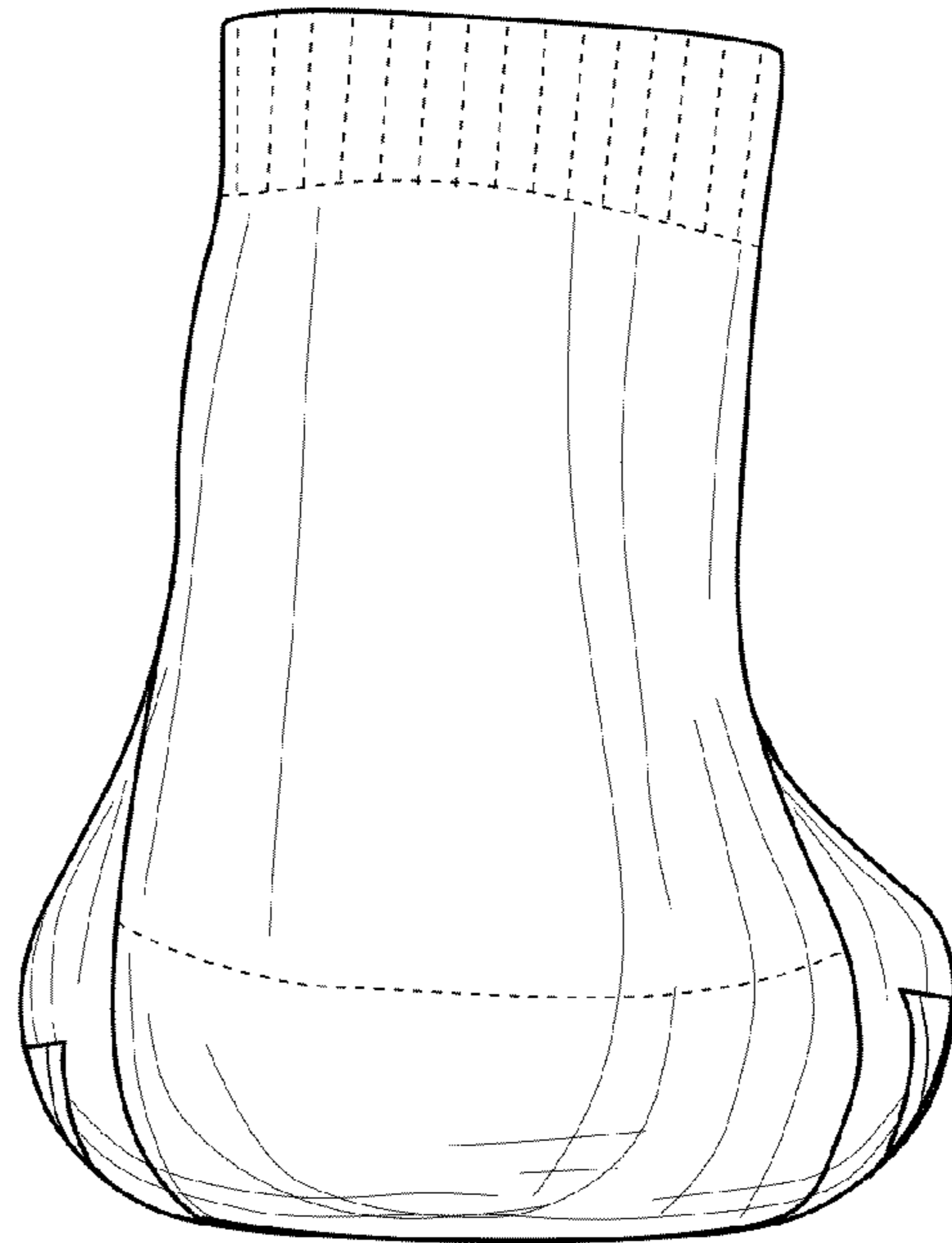

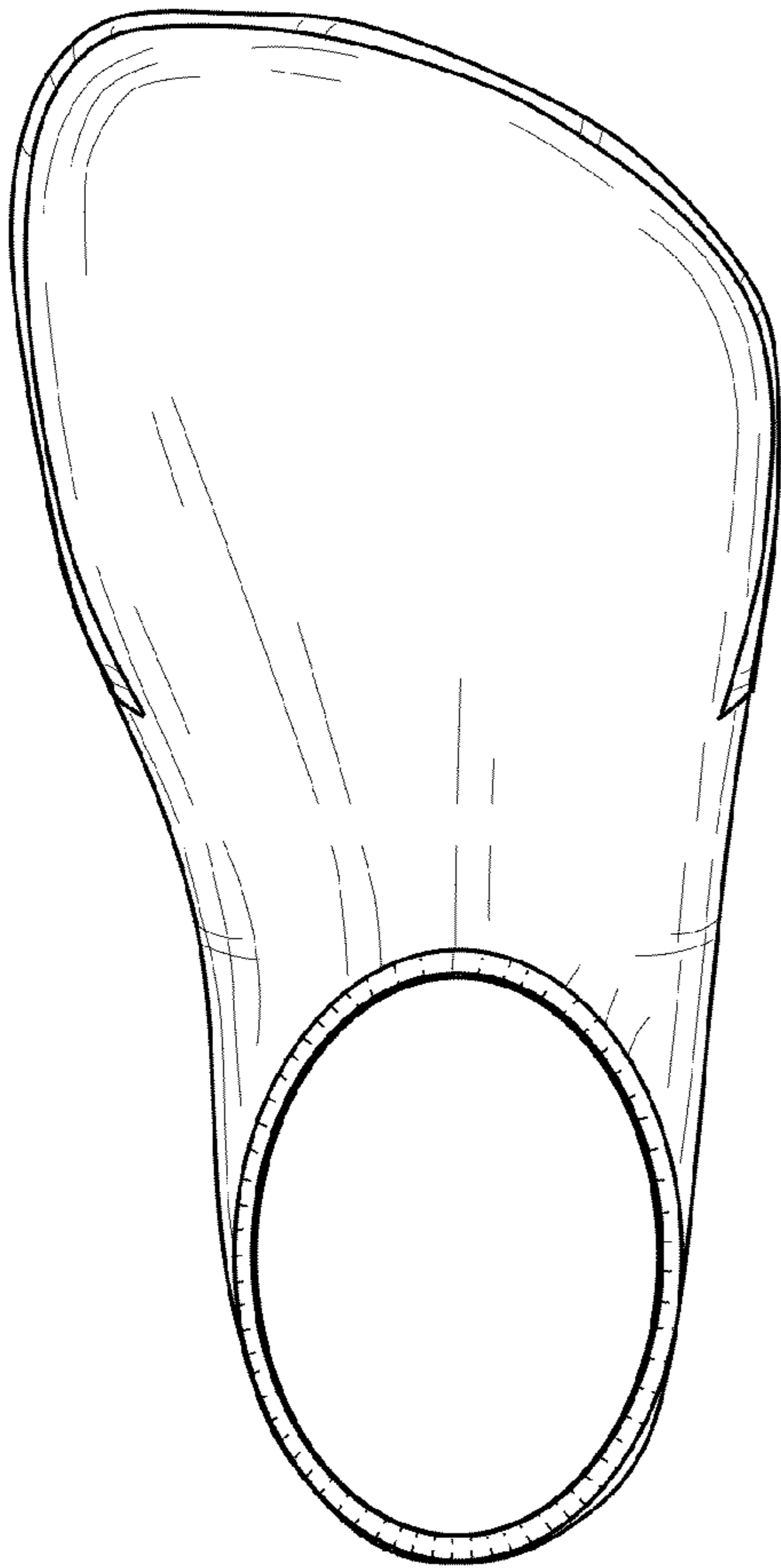




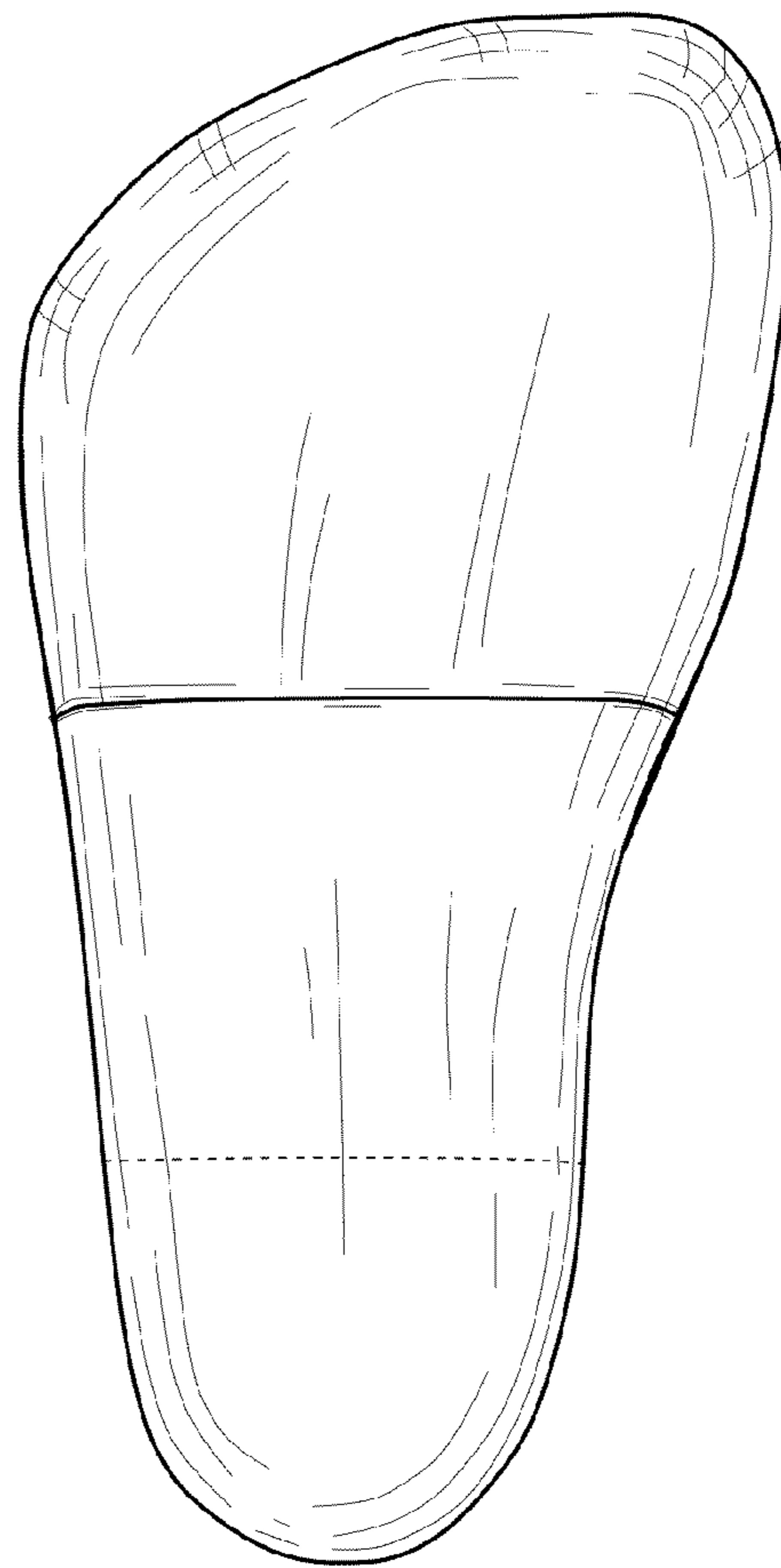
