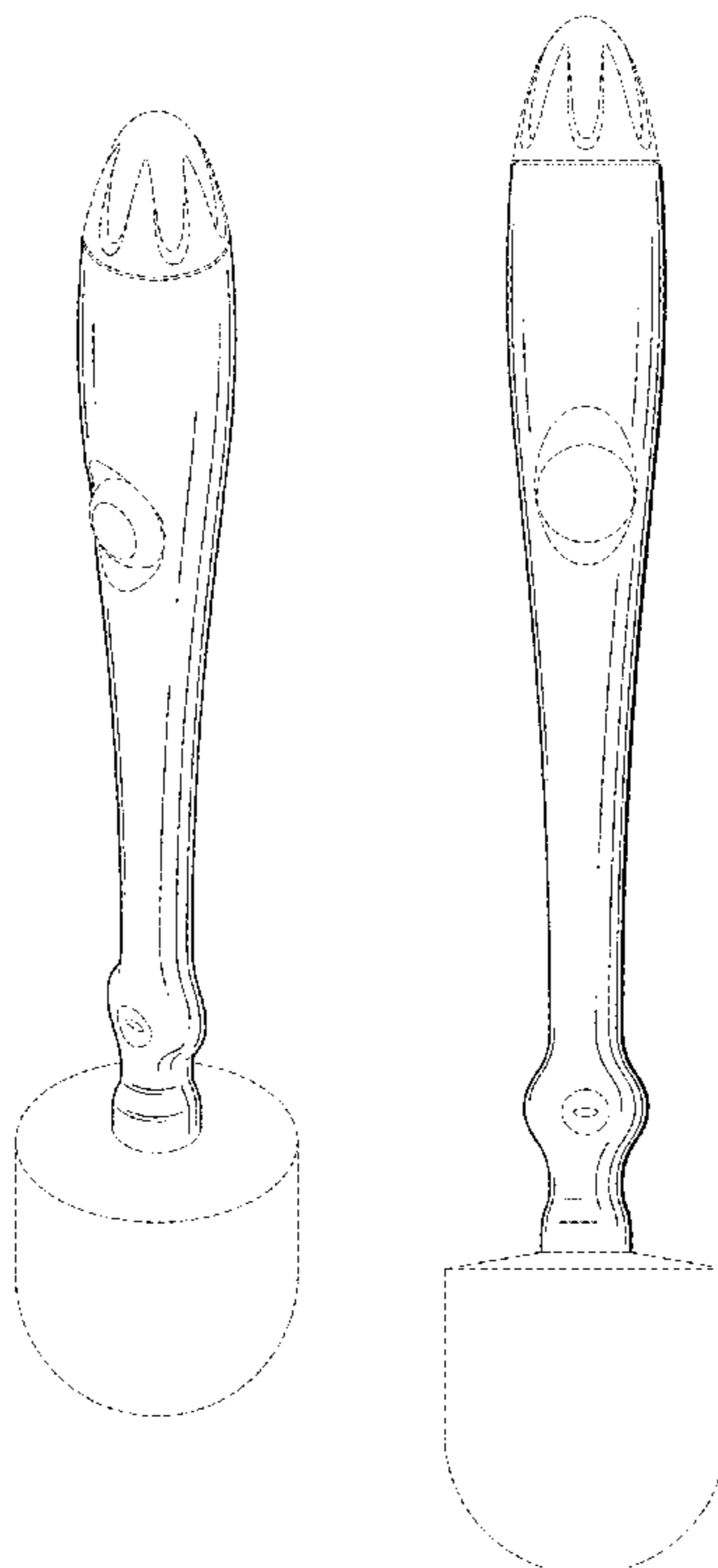

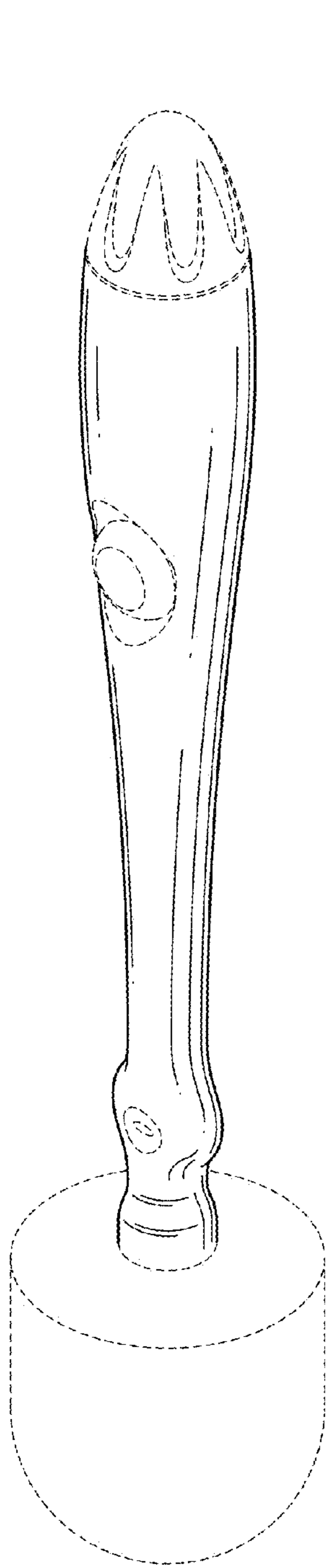
(57) **CLAIM**

**DESCRIPTION**

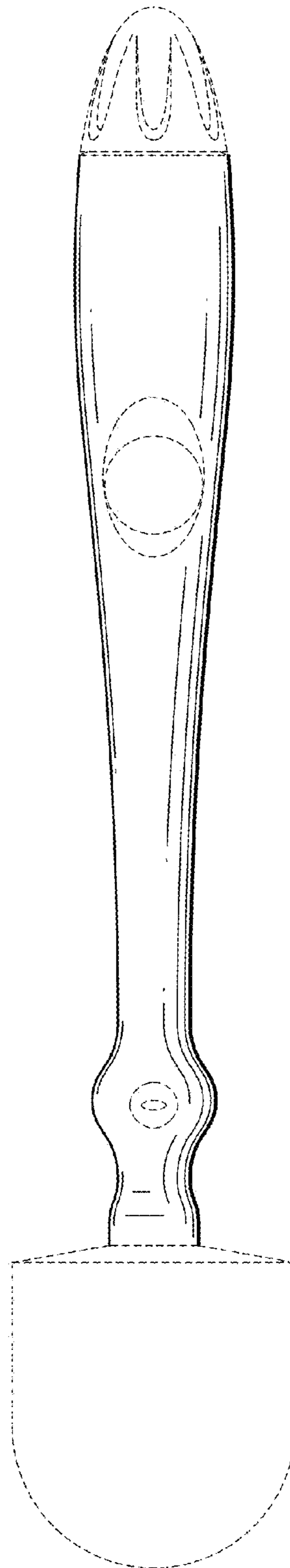
FIG. 1 is a perspective view showing the new design for a handle;

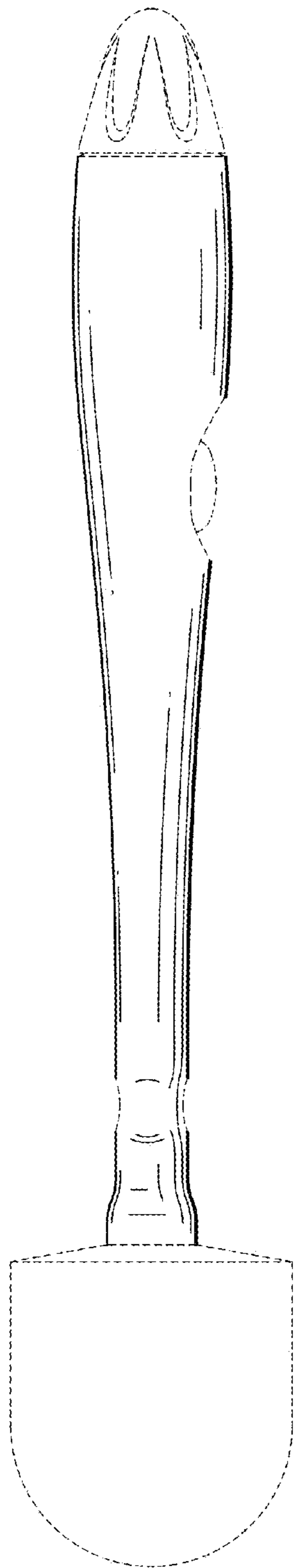

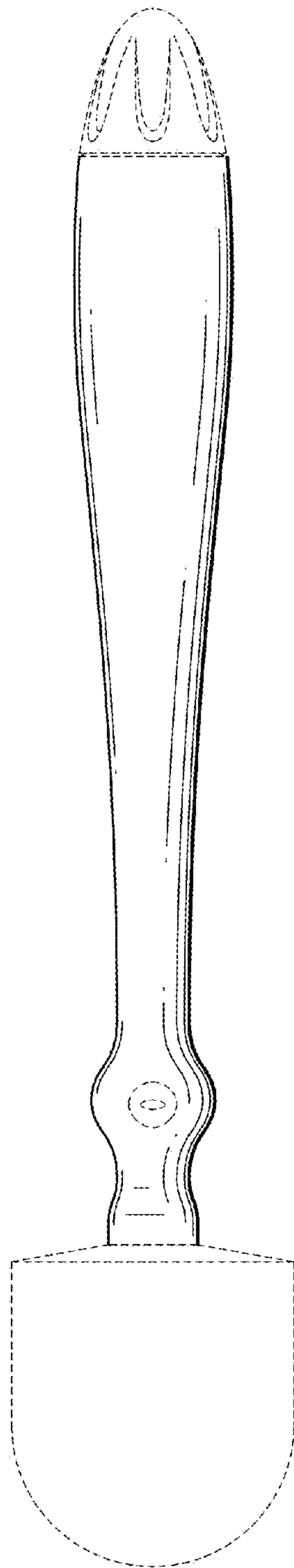

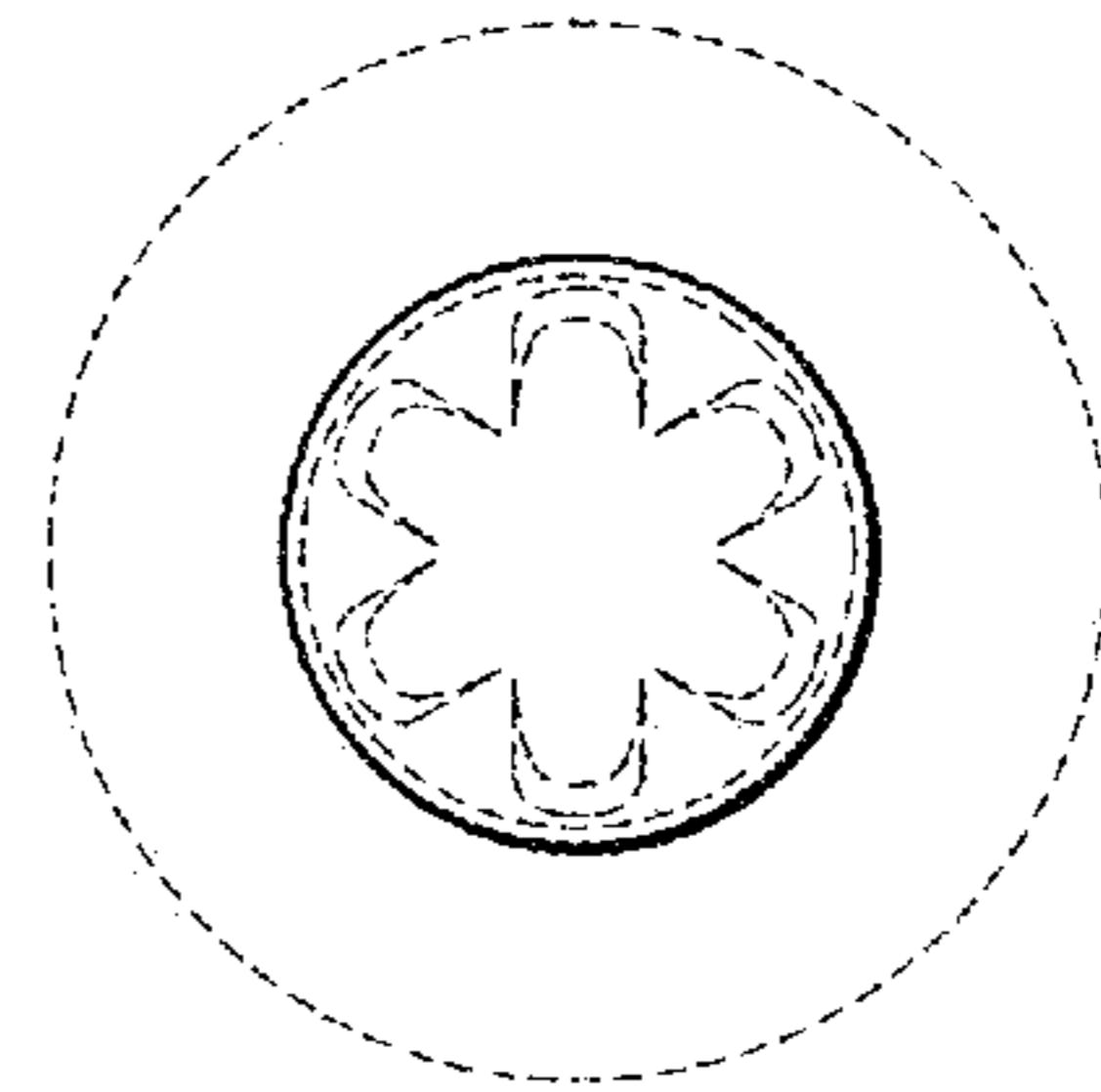

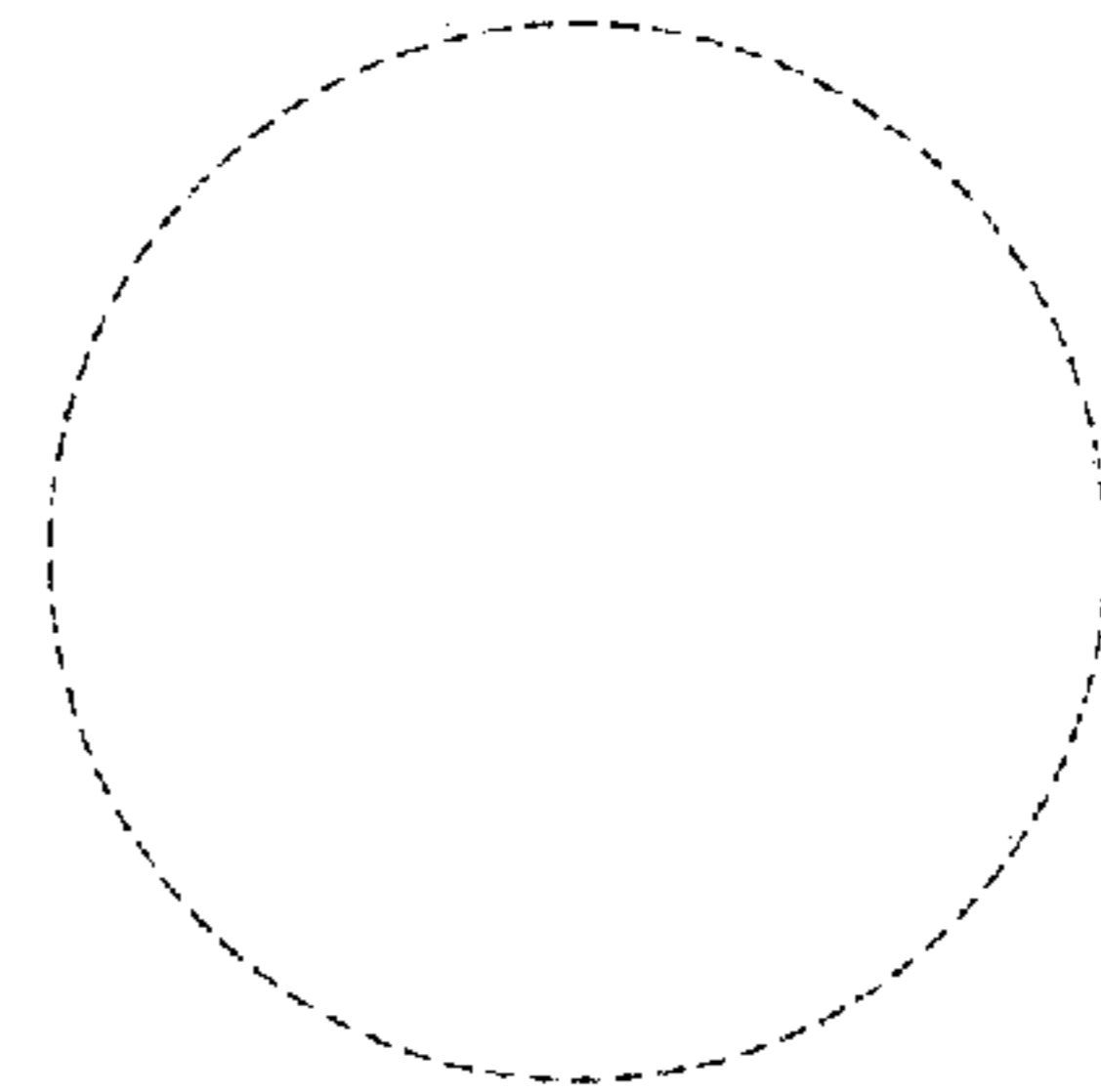
