Broken lines shown in the figures described above are for illustrative purposes only and form no part of the claimed design.

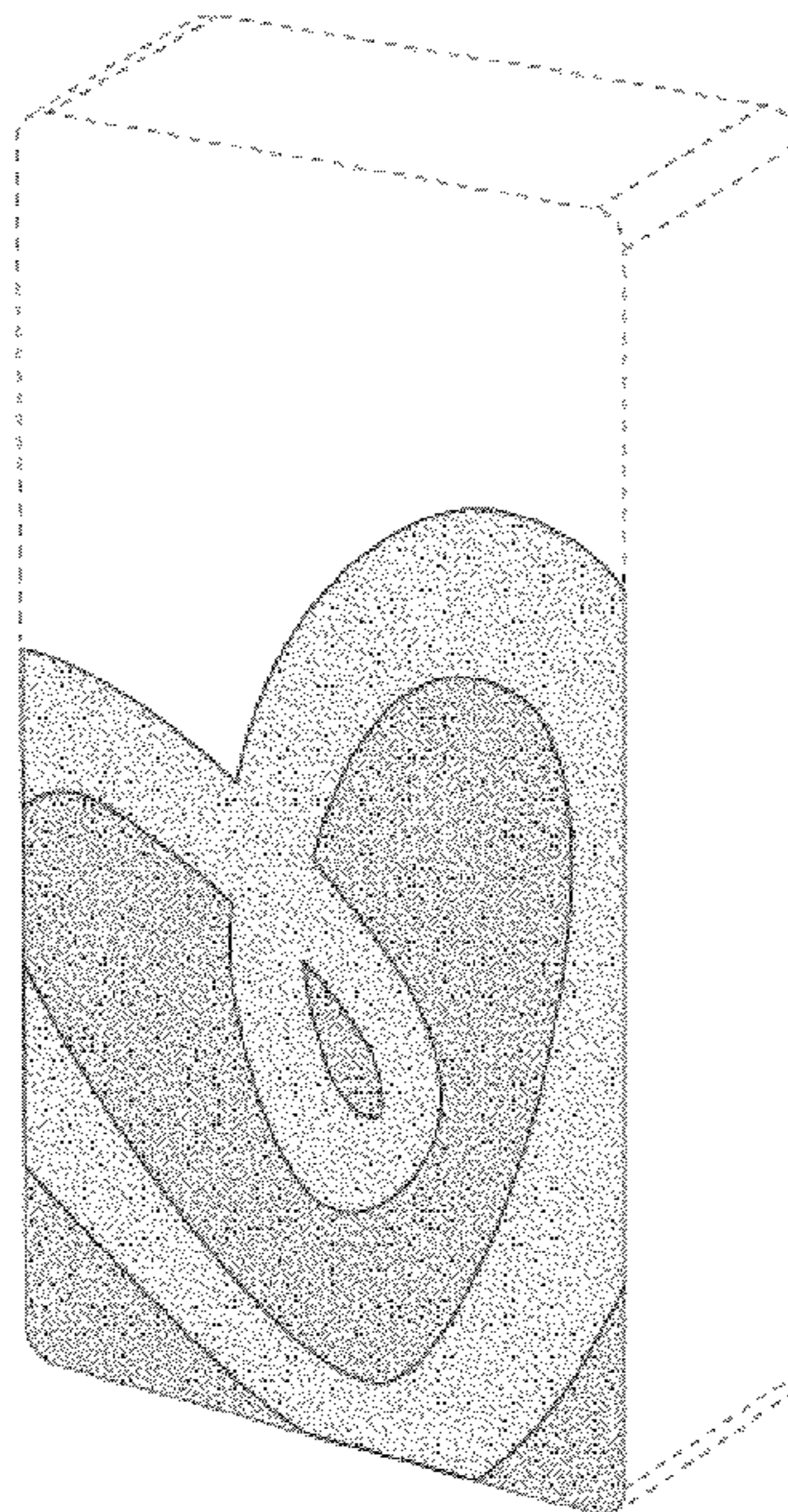

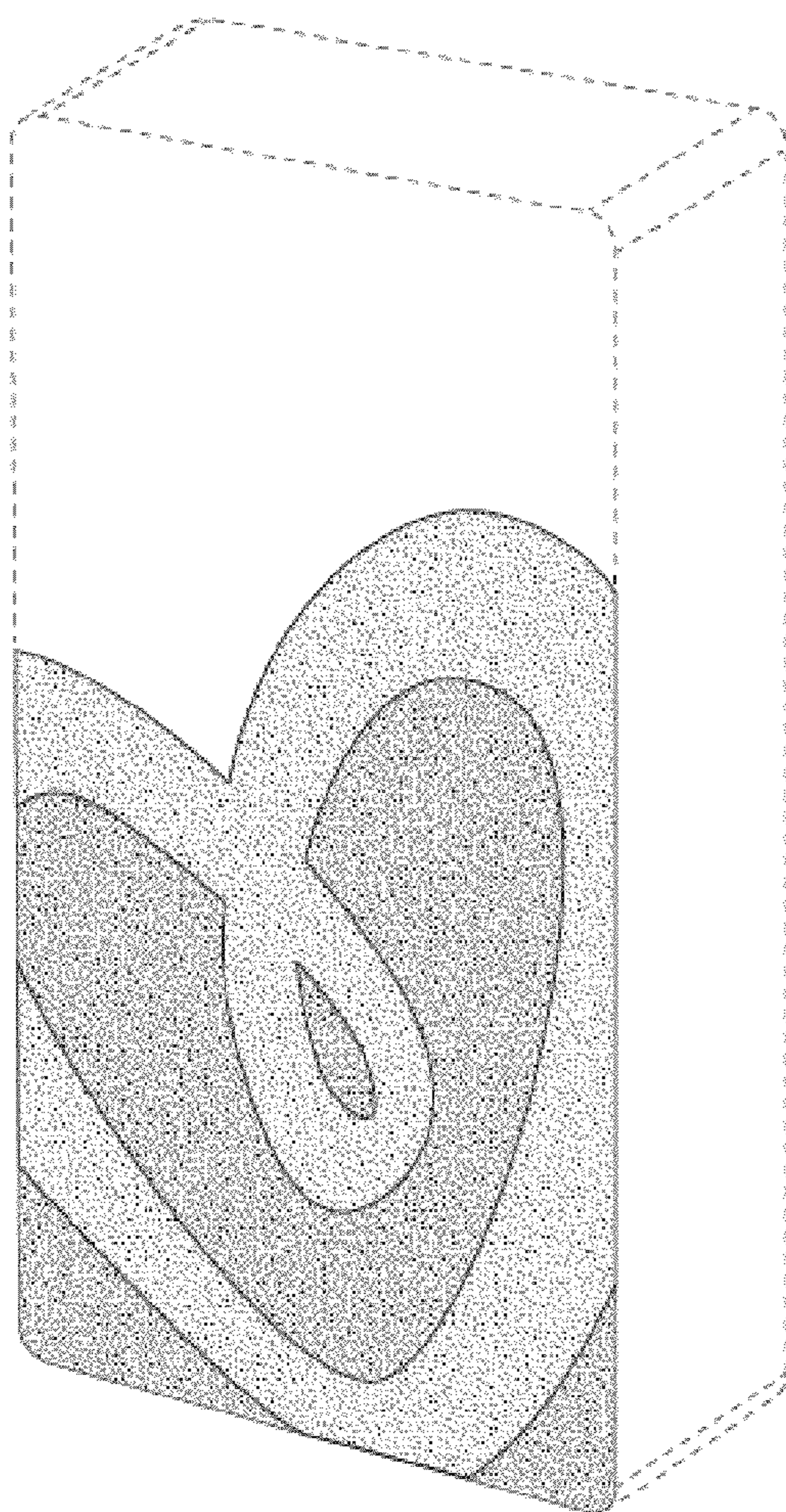

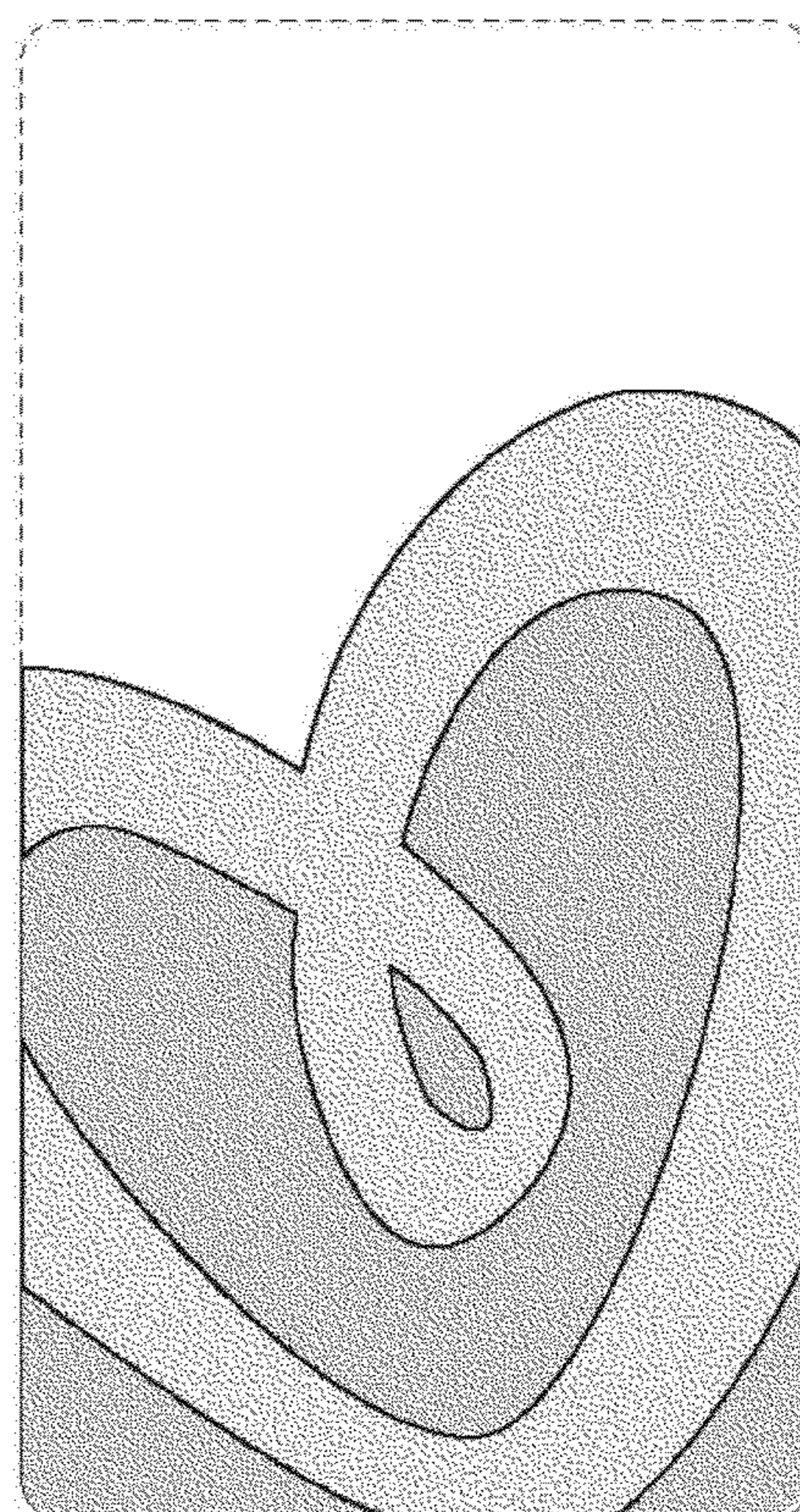

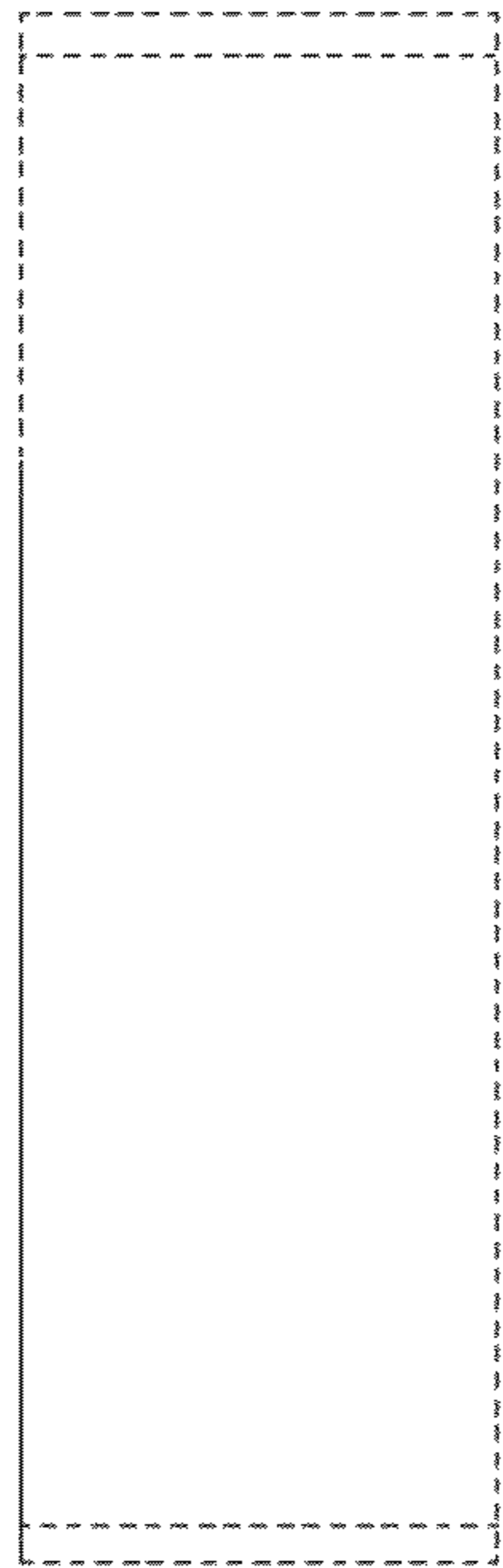

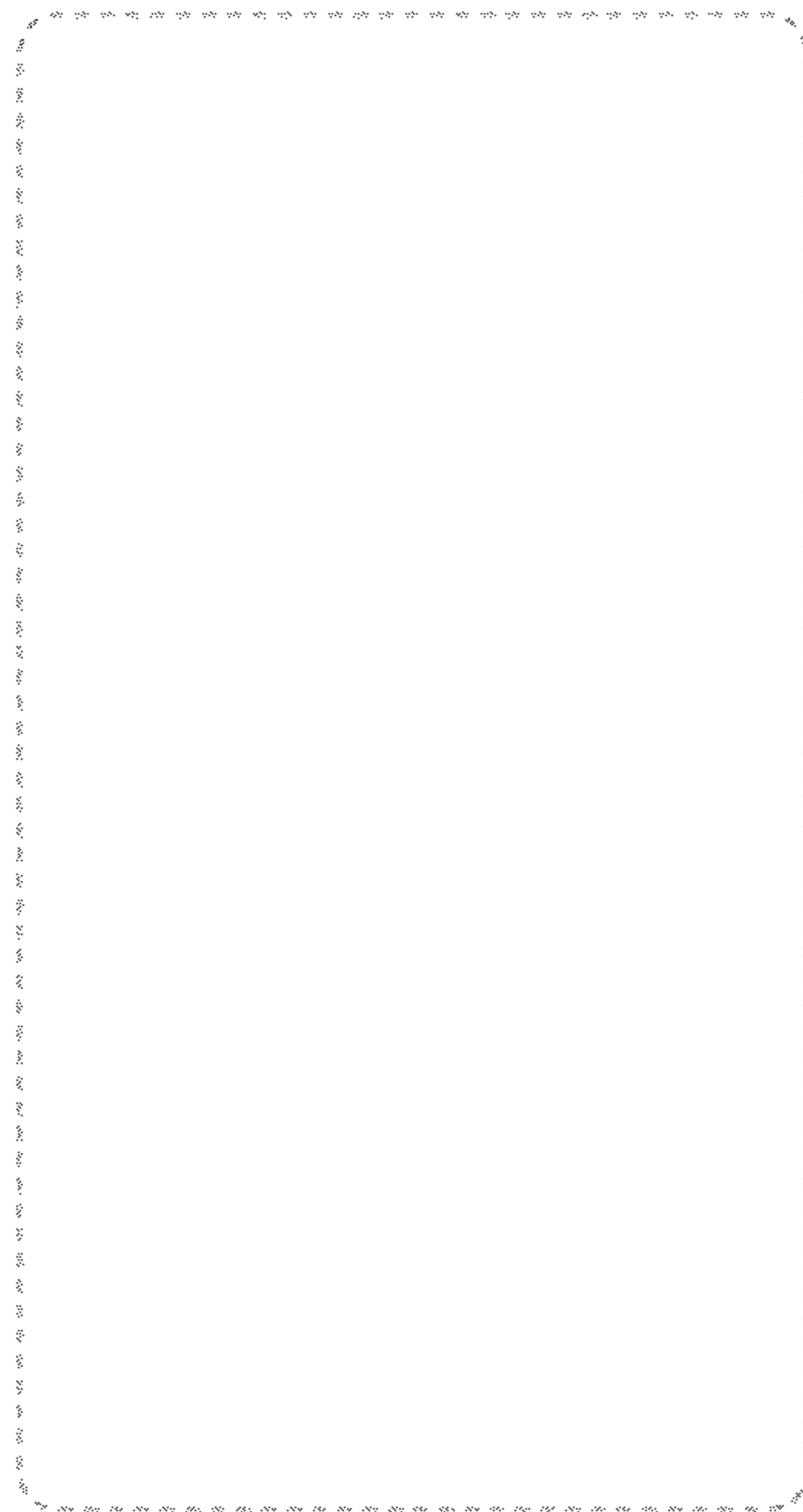

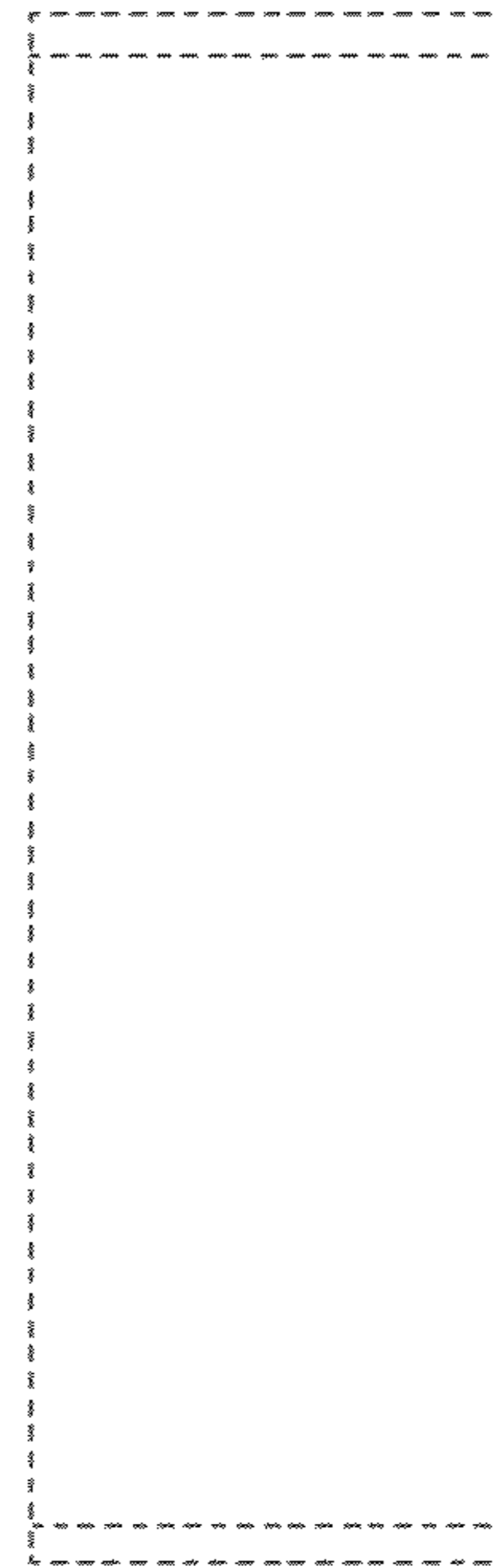

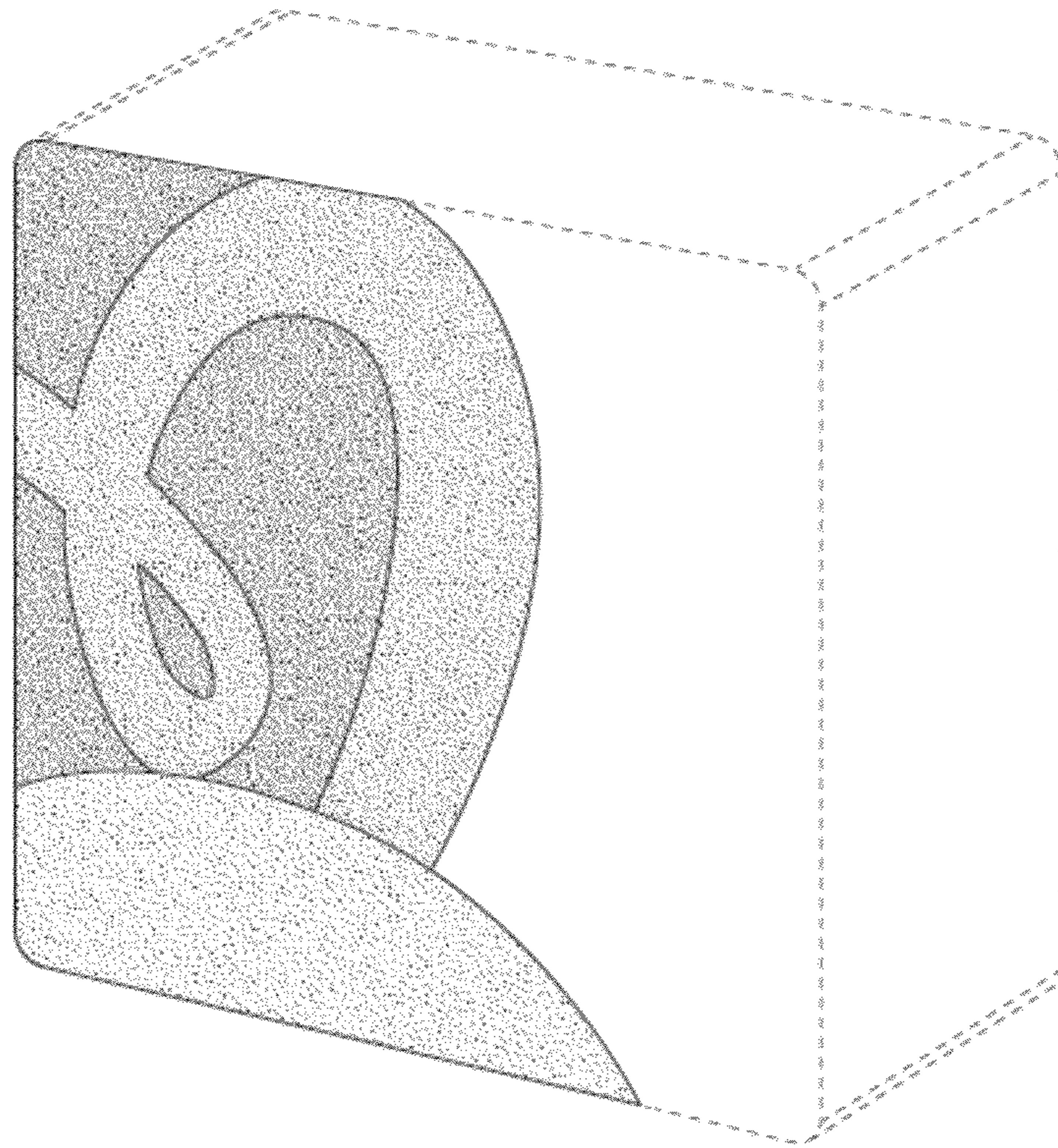

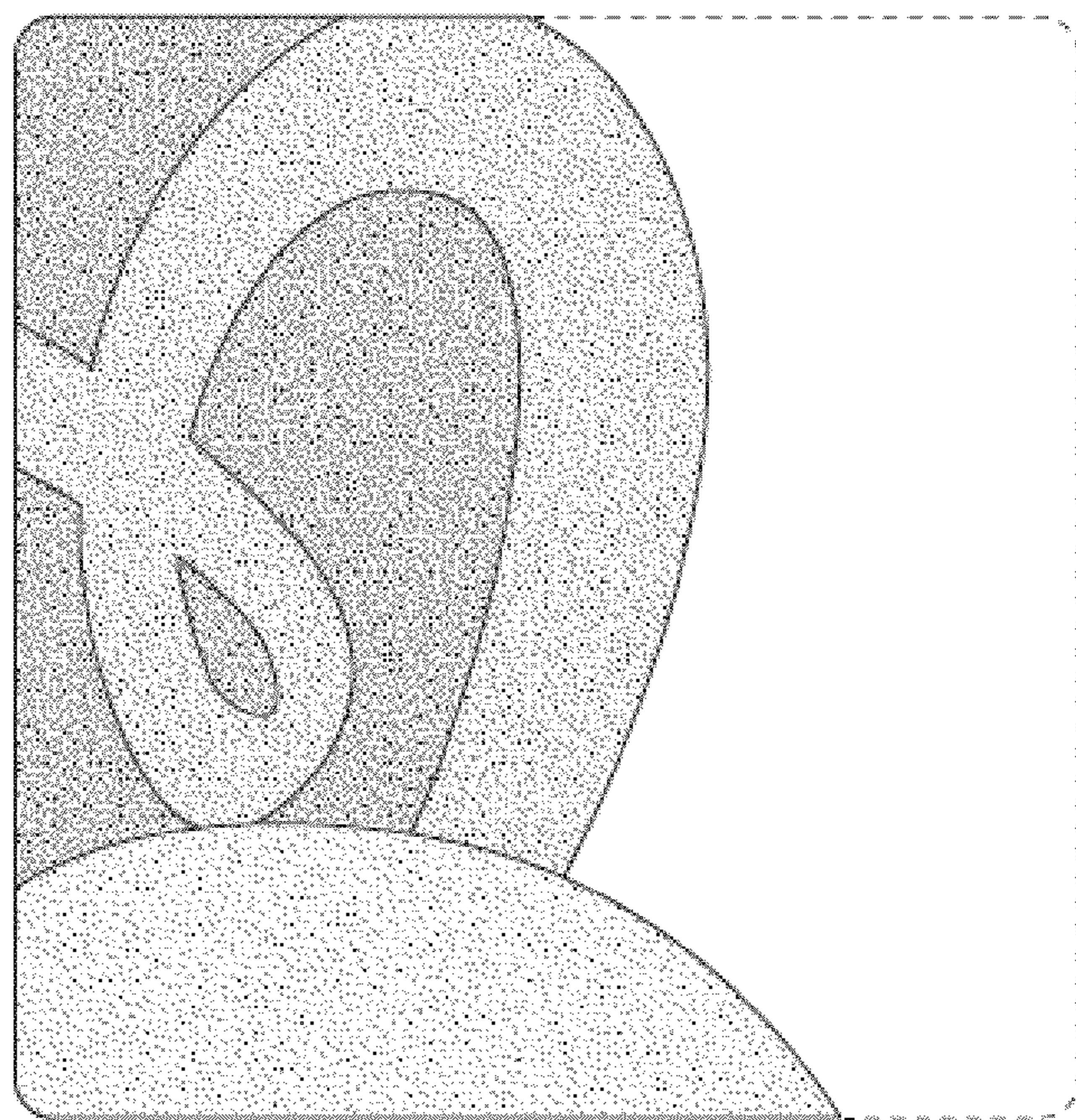

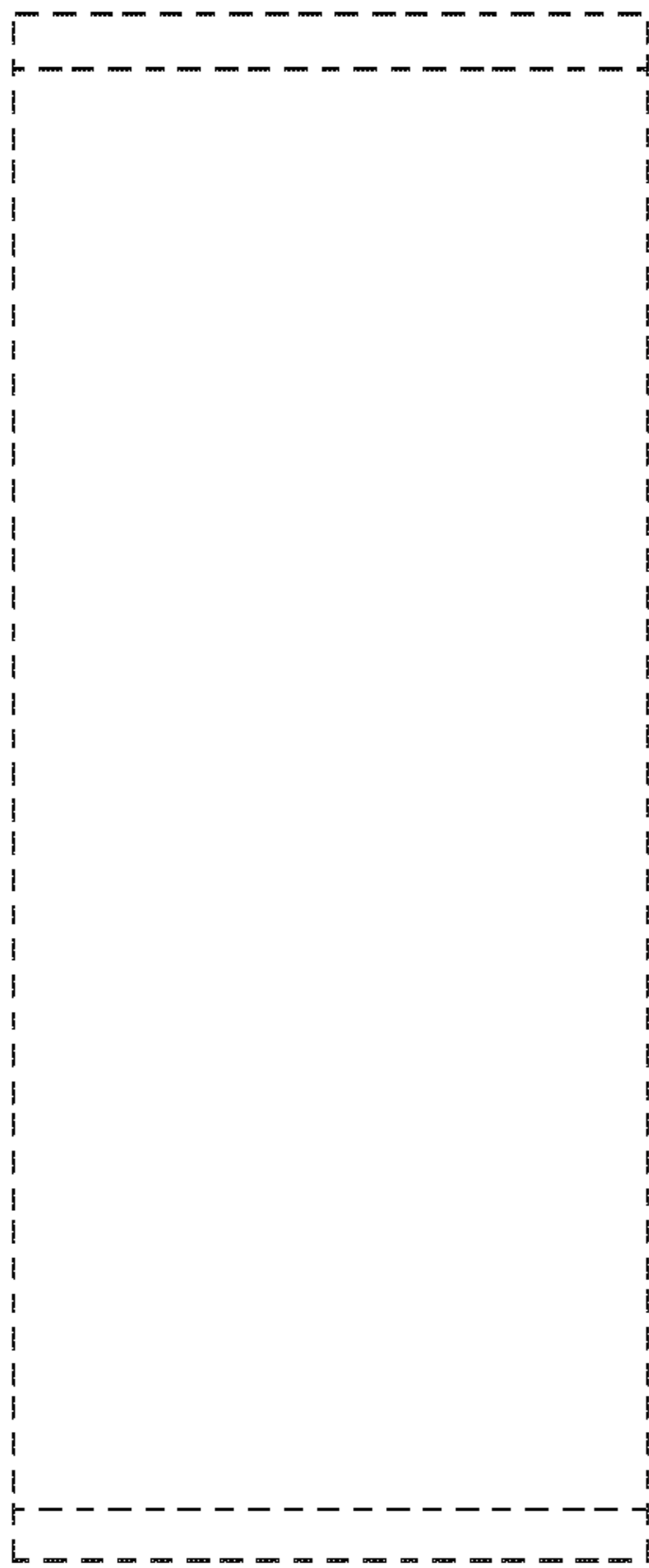

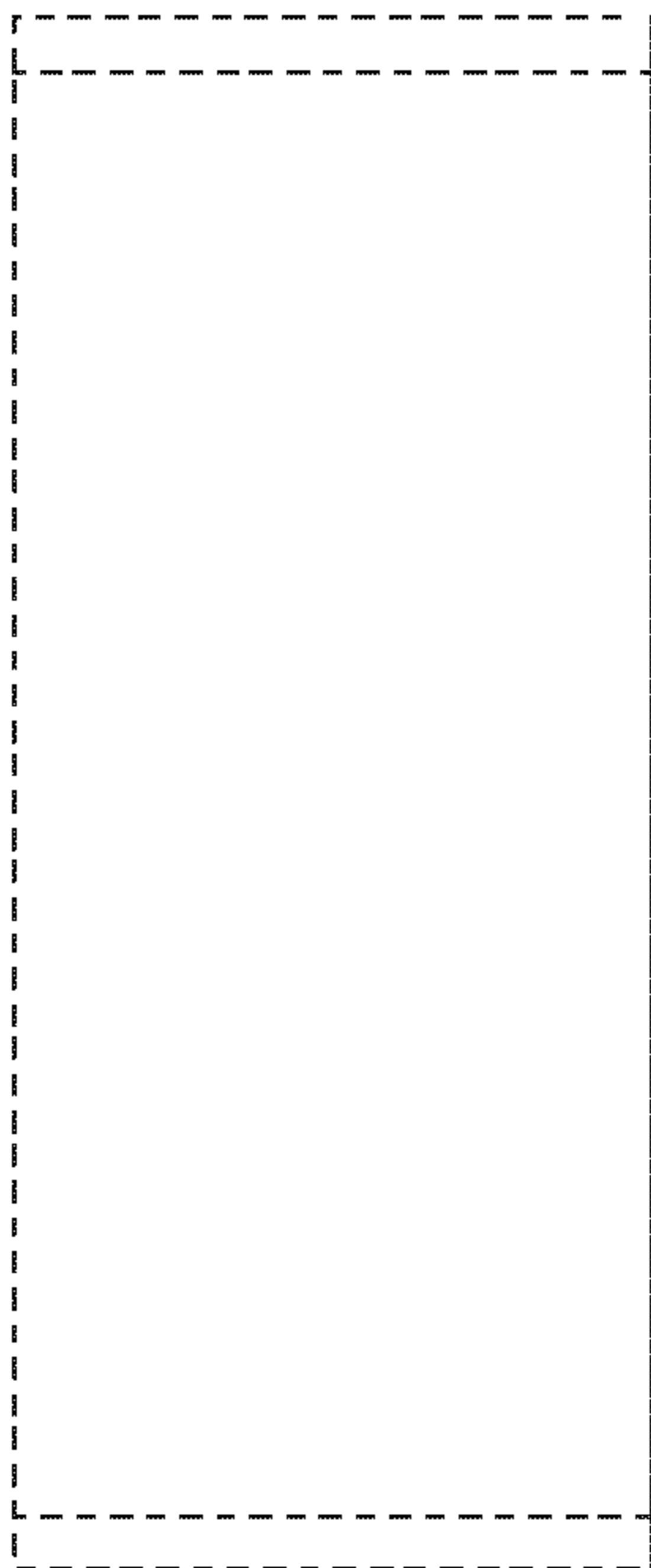
