The ornamental design for a vehicle, toy, and/or replicas thereof, as shown and described.

DESCRIPTION

FIG. 4 is a right side view thereof;

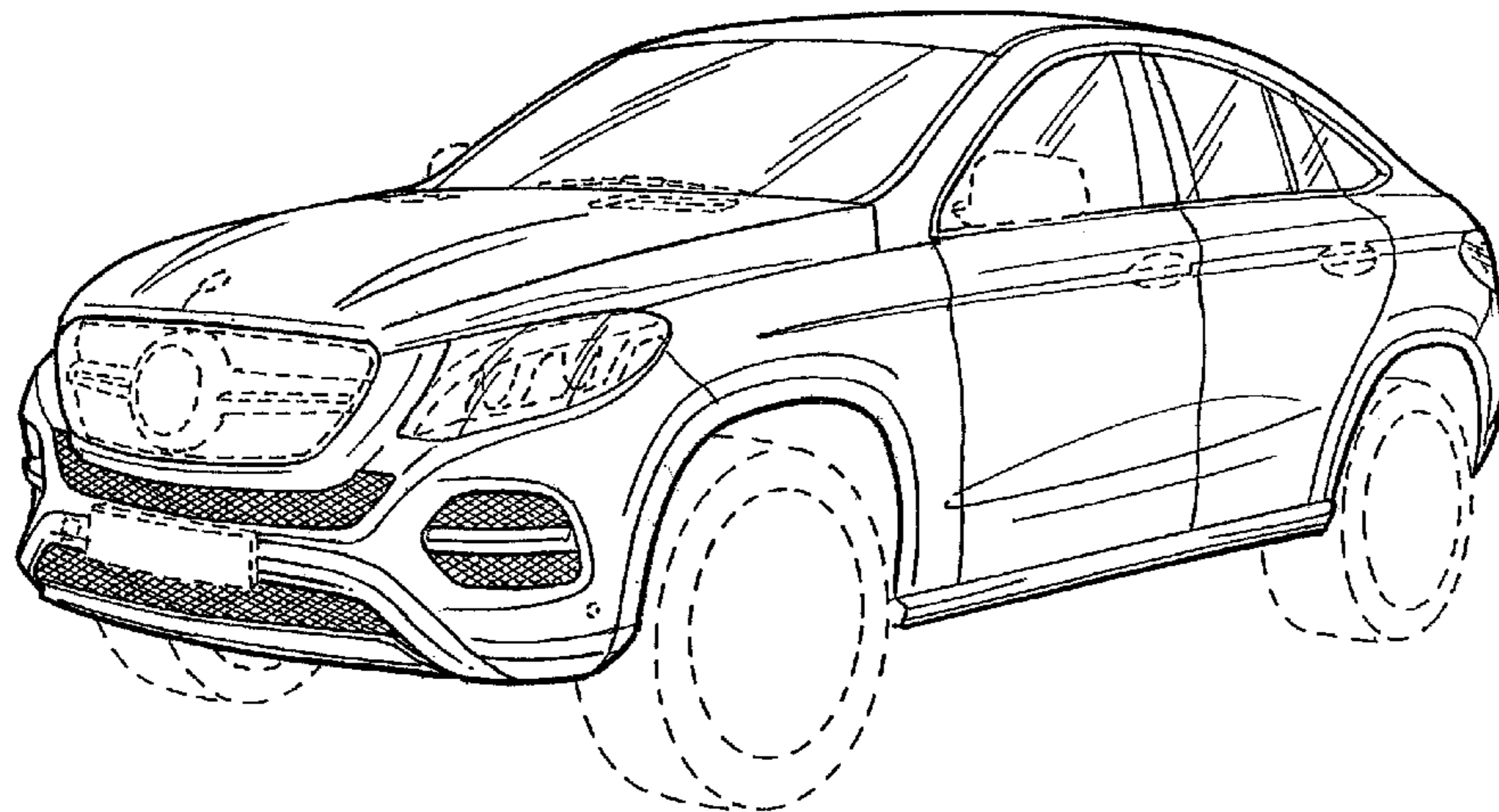
FIG. 5 is a front view thereof;

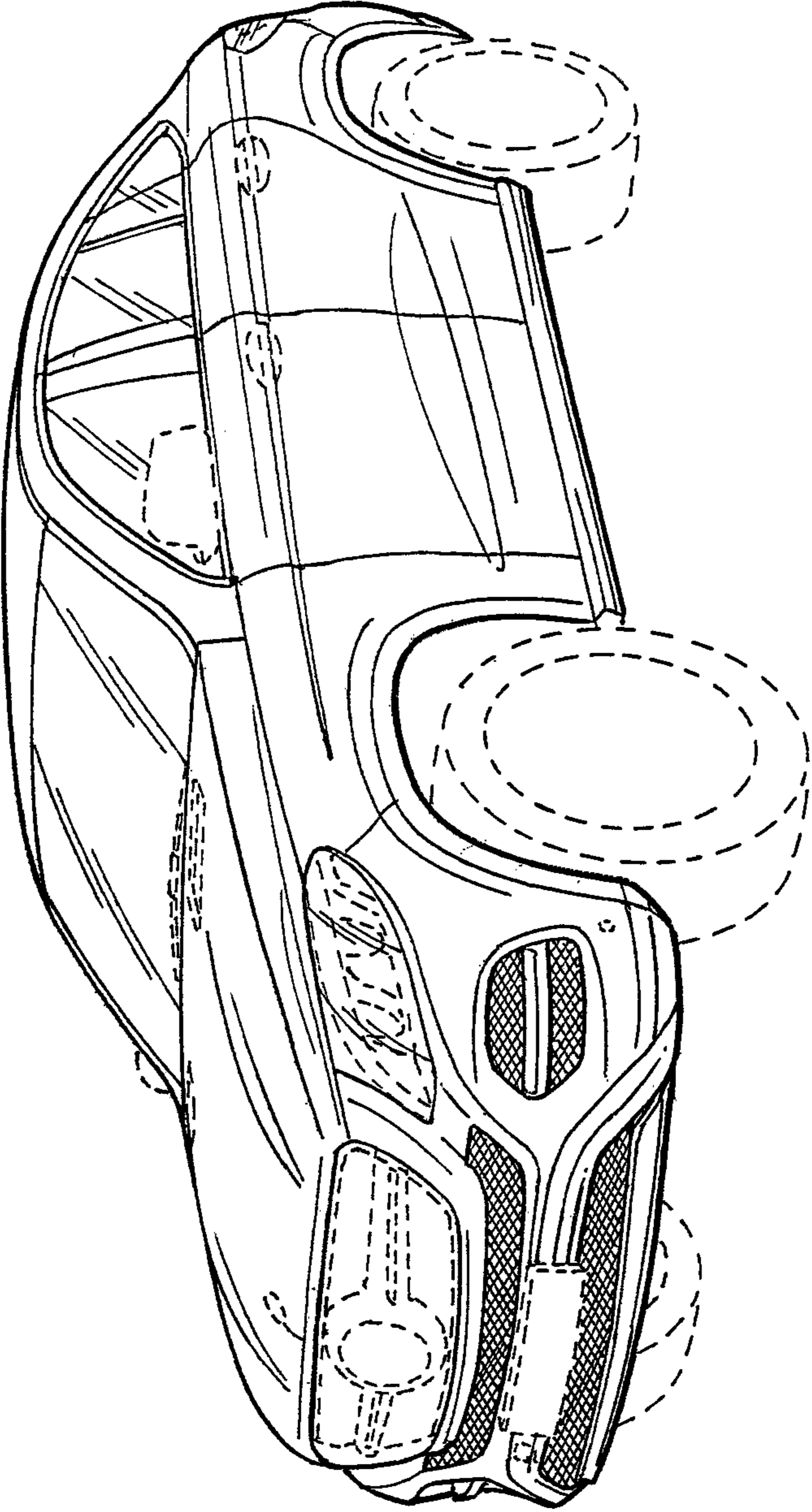

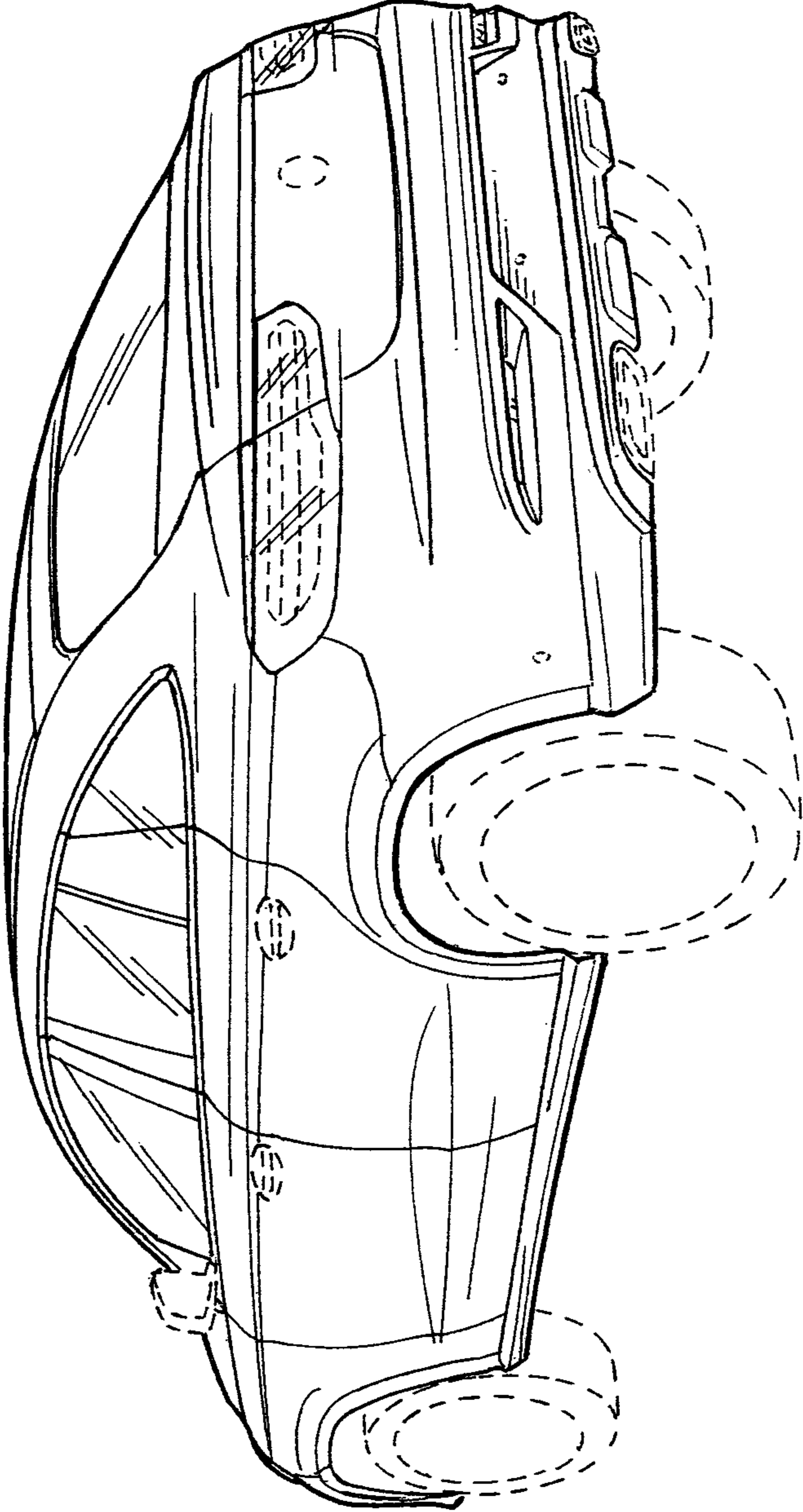

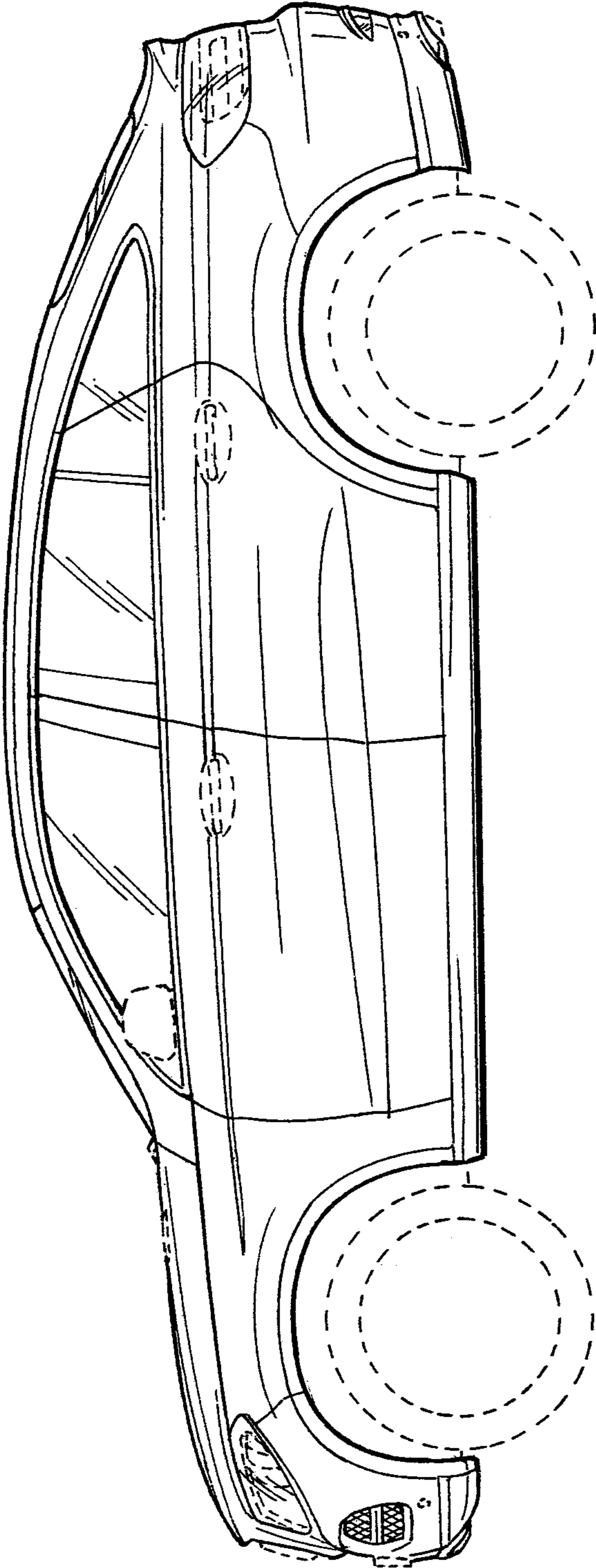

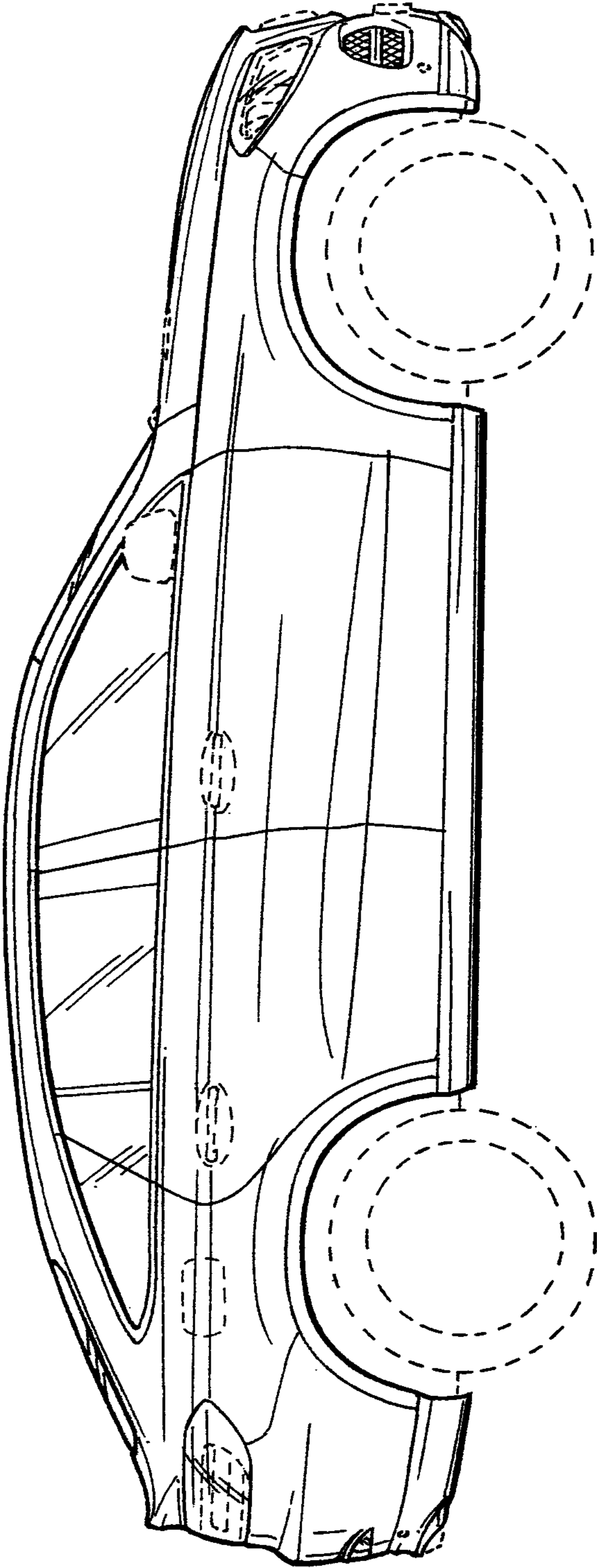

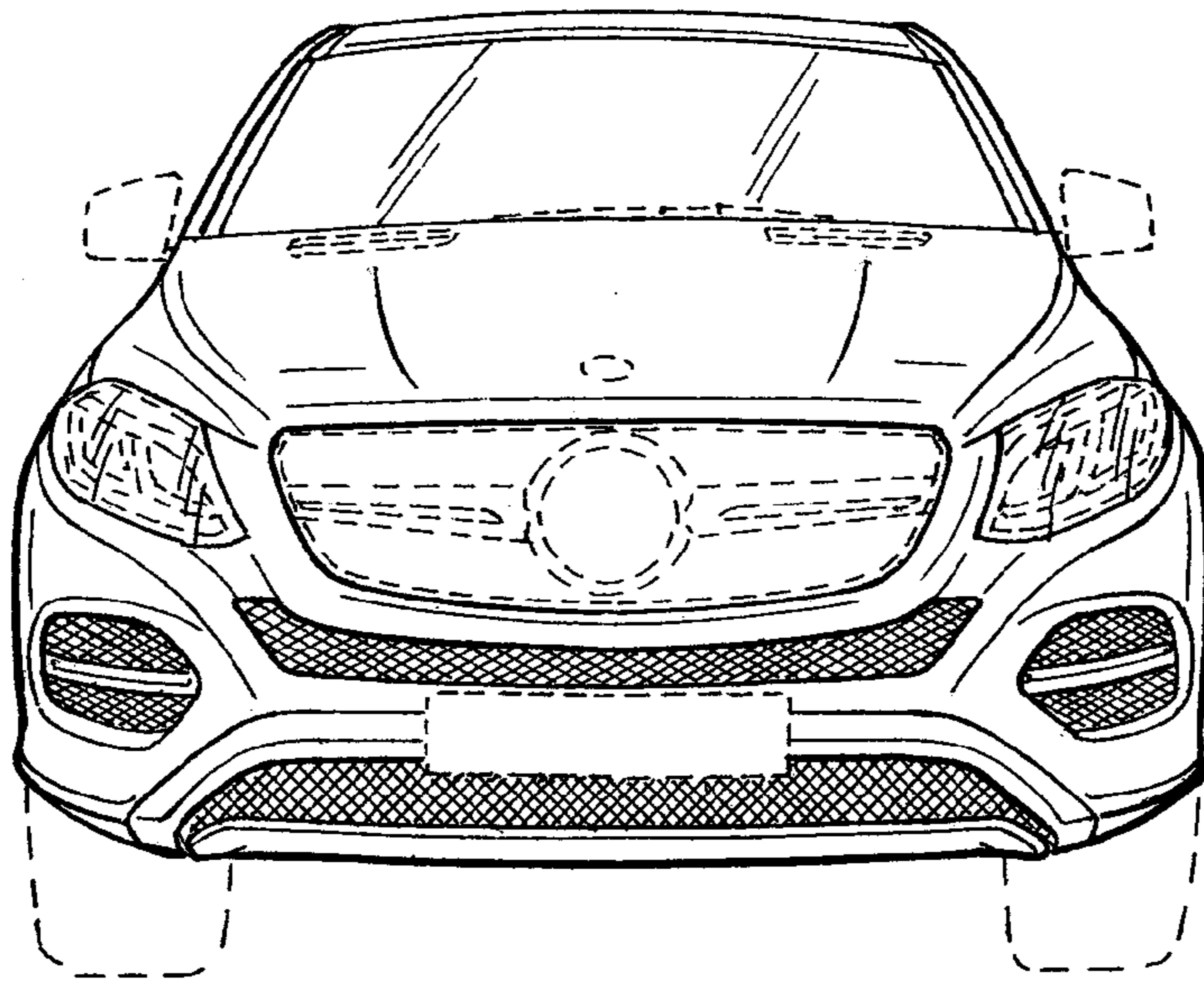

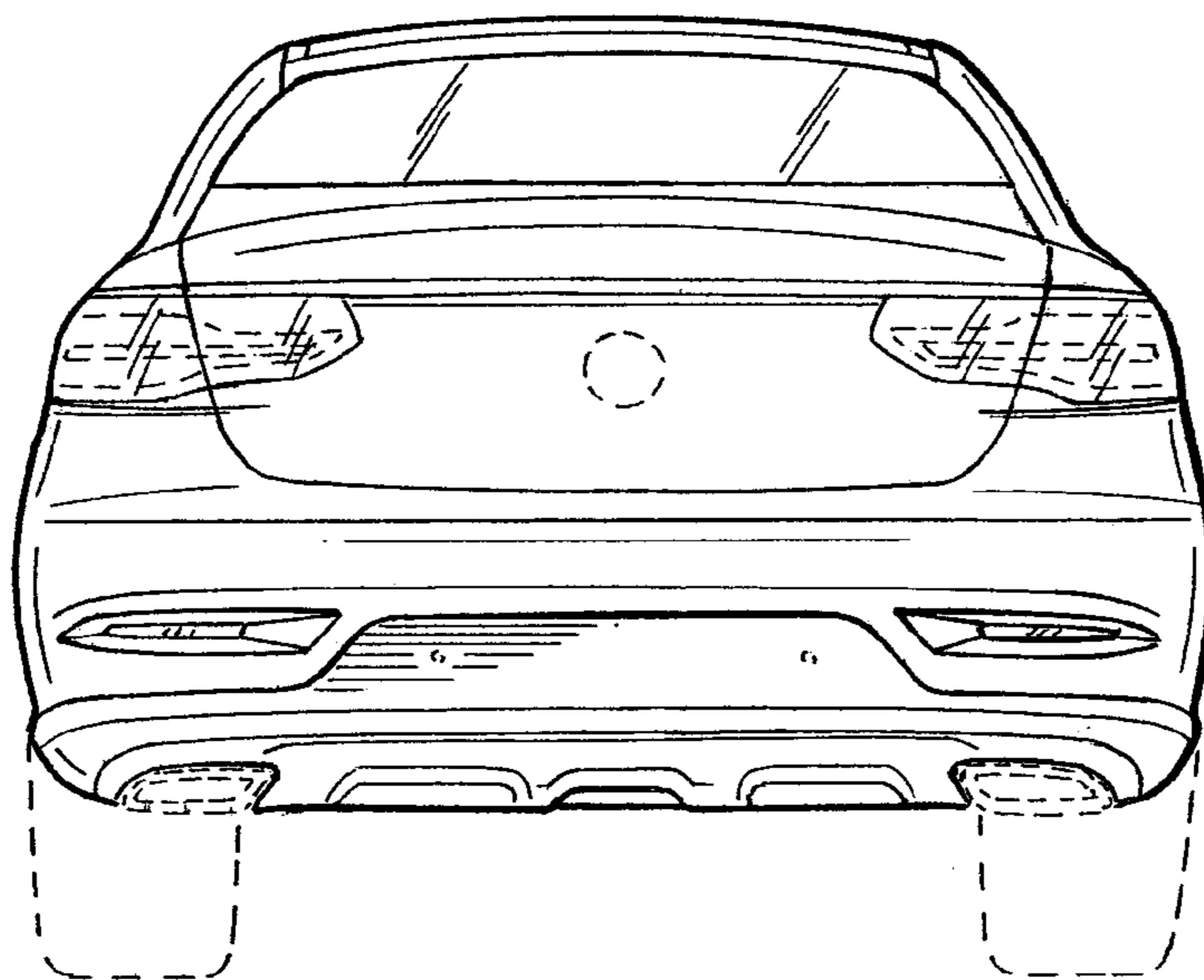

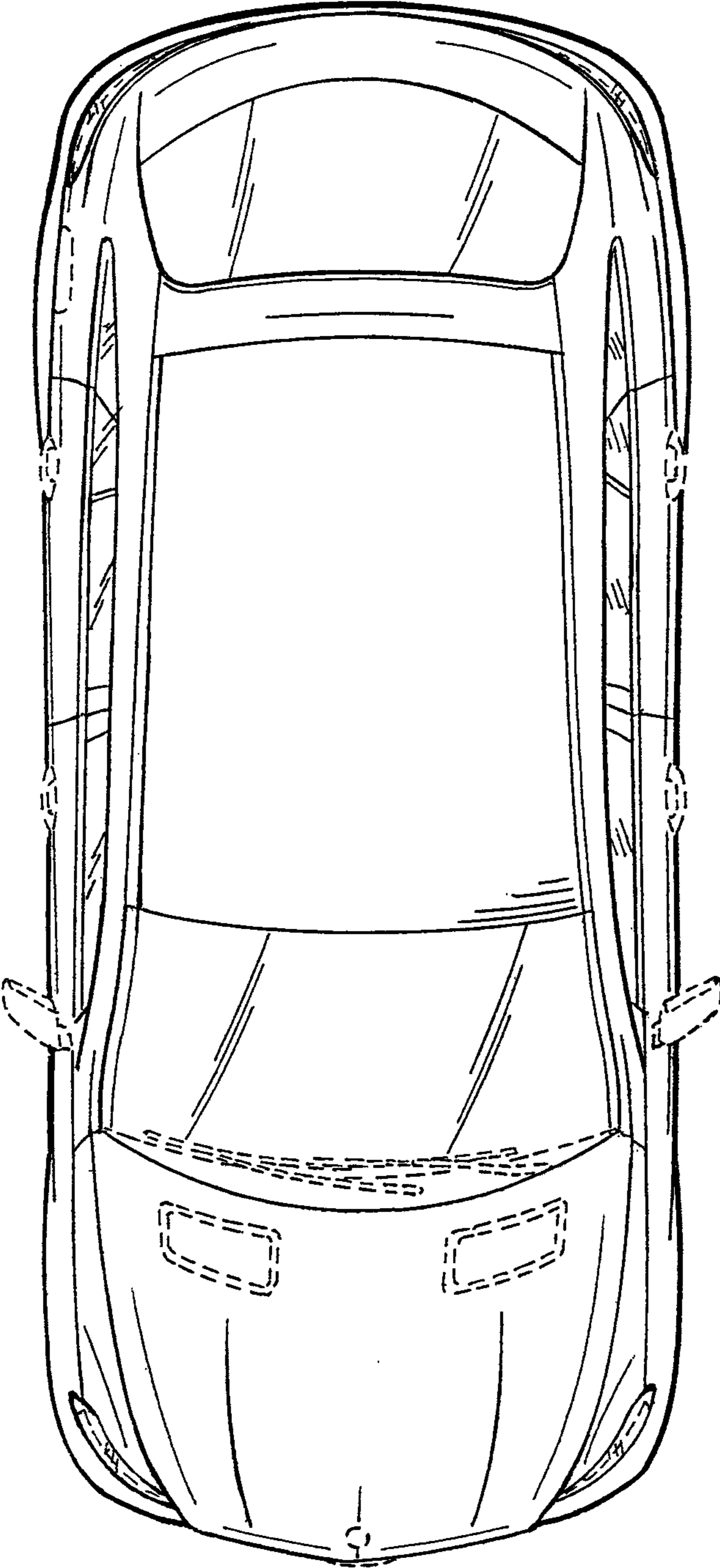
