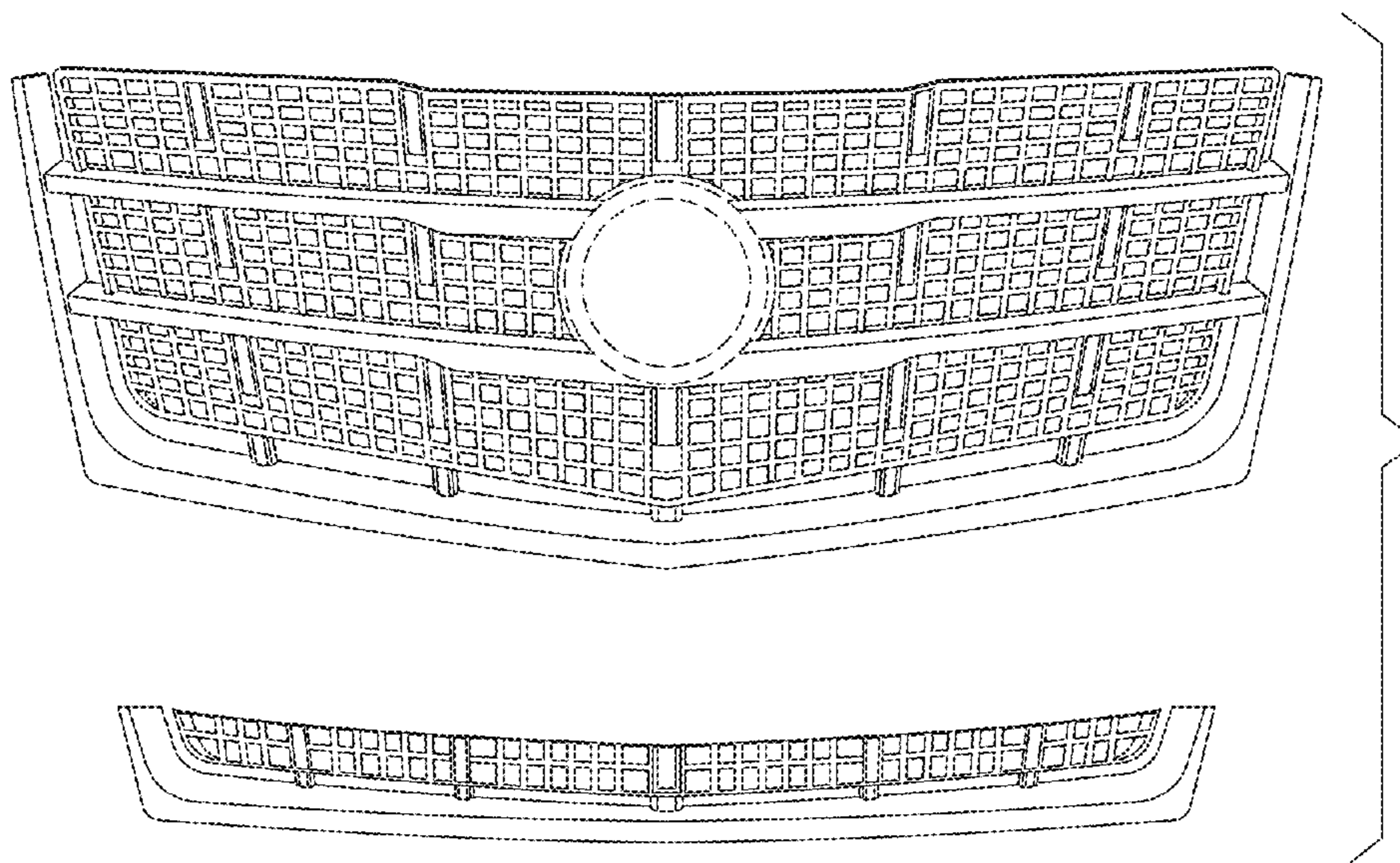
(57) **CLAIM**

The ornamental design for a vehicle grille unit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a vehicle grille unit; FIG. 2 is a perspective view of the vehicle grille unit; FIG. 3 is a top view of the vehicle grille unit; and, FIG. 4 is a side view of the vehicle grille unit. 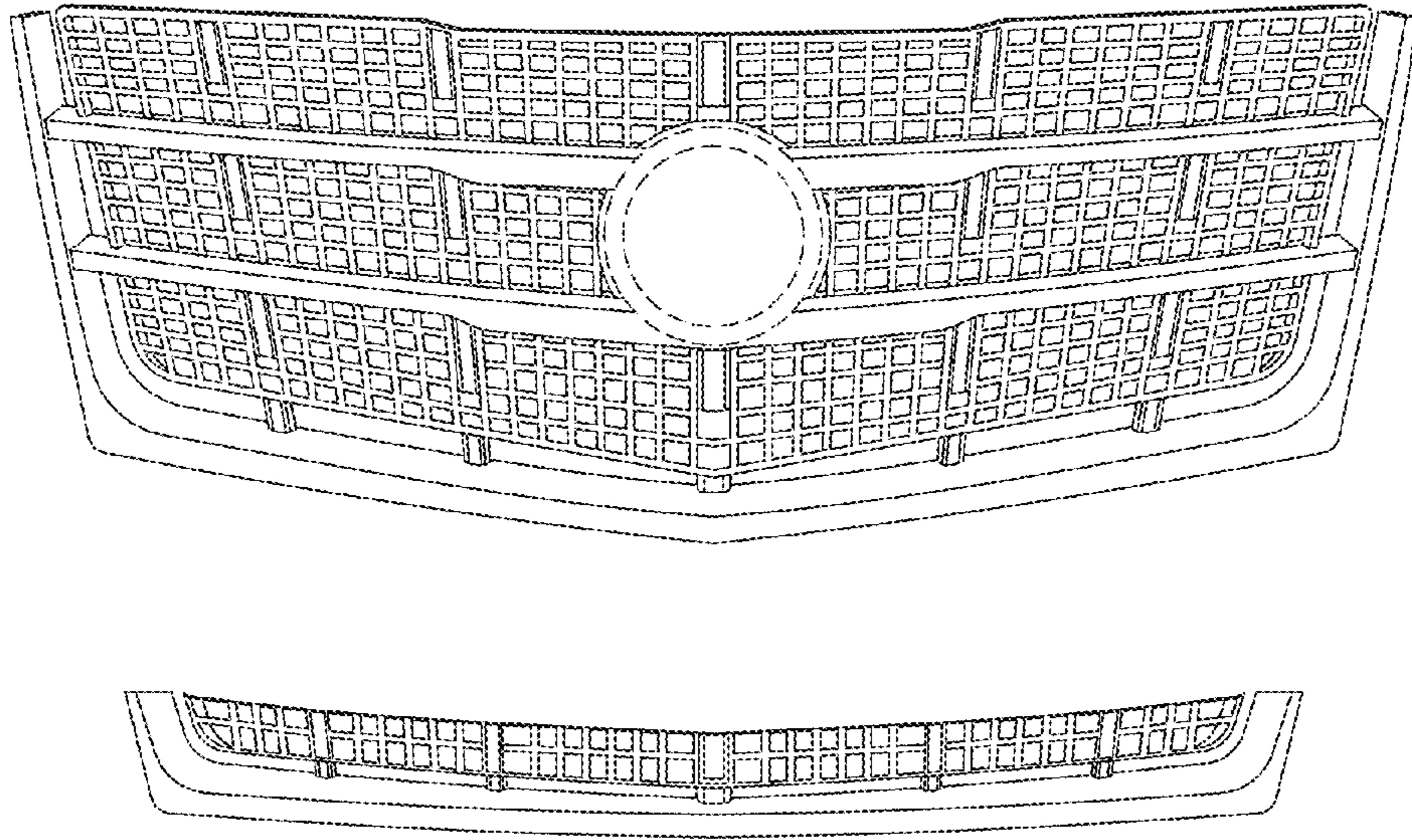

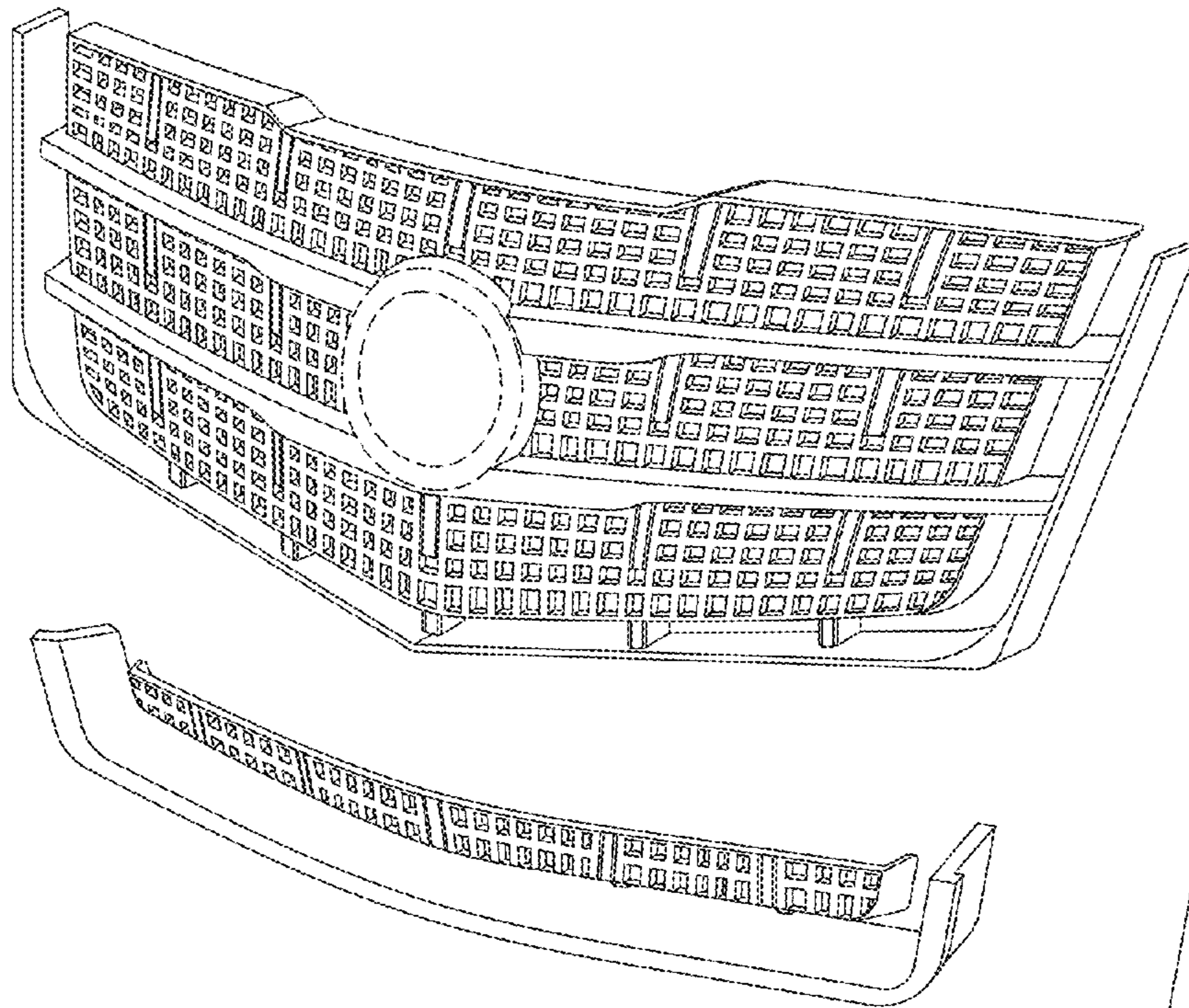

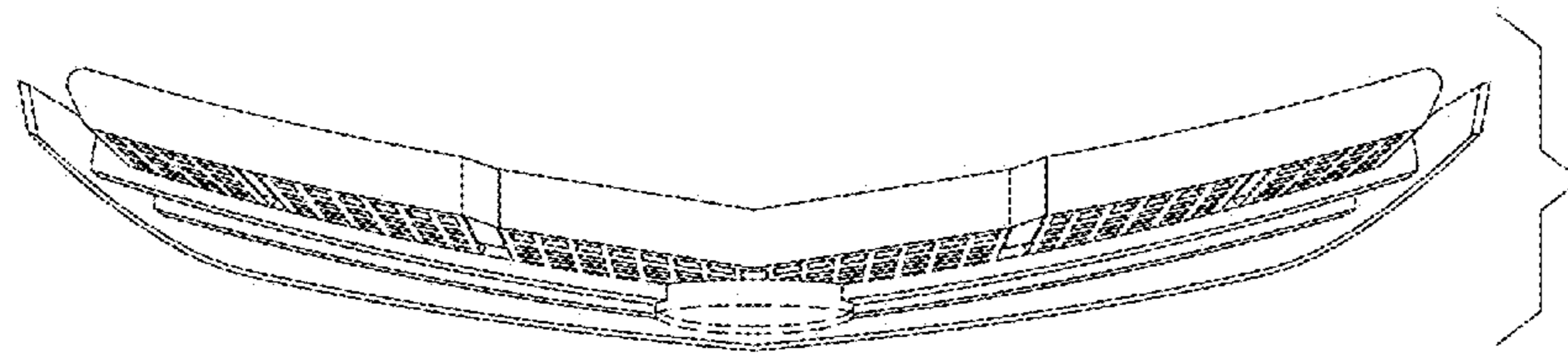

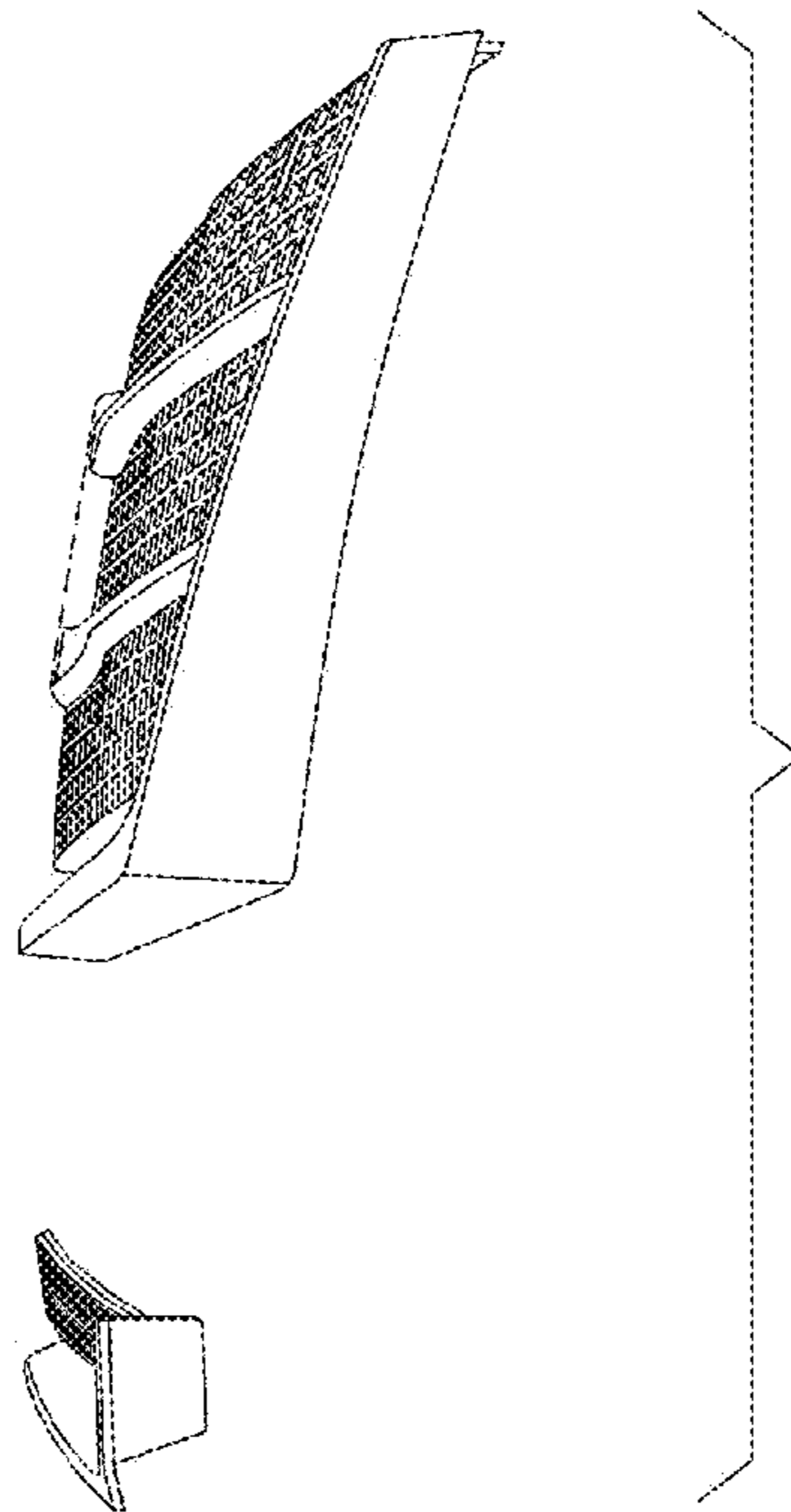
