The ornamental design for a vehicle grille insert, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a vehicle grille insert showing our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a side view thereof; and,  
FIG. 6 is an opposite side elevational view thereof.

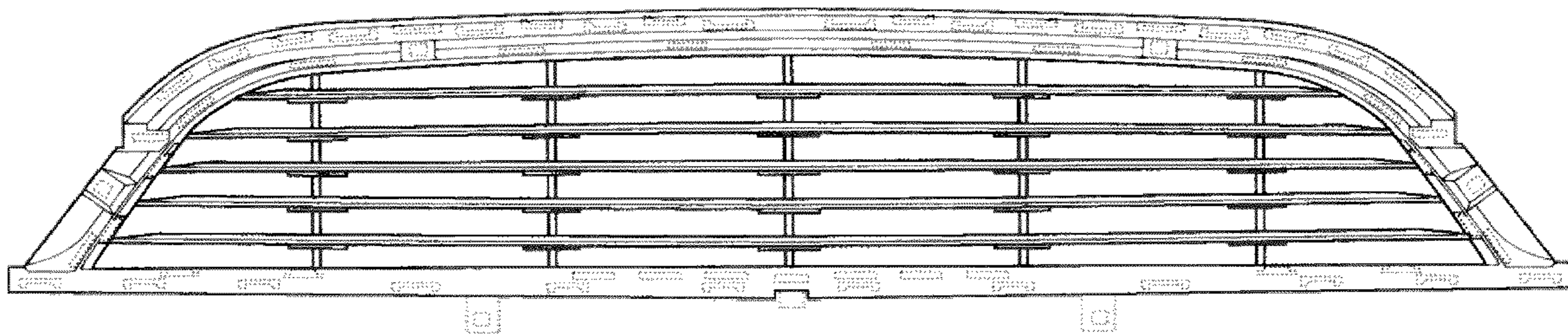

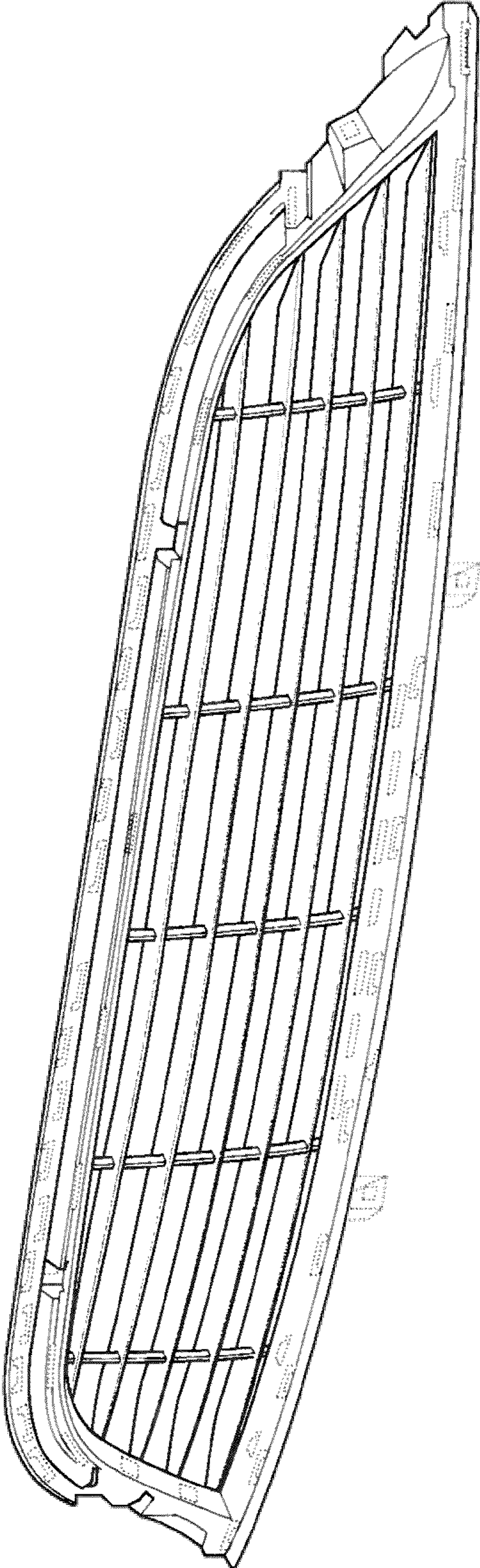

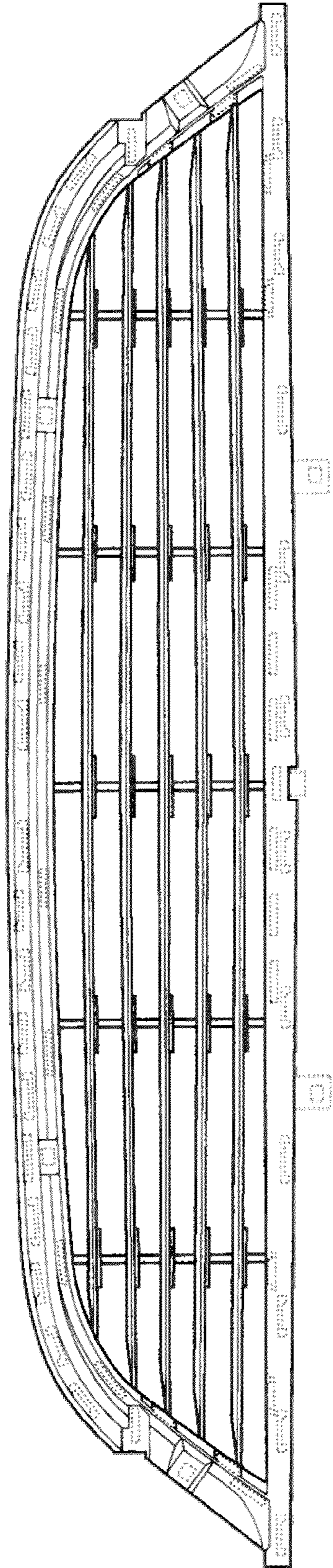

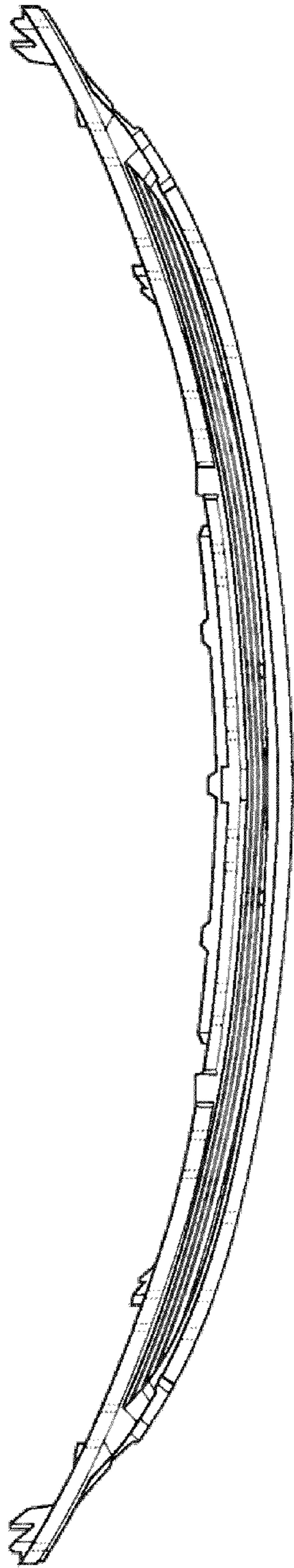

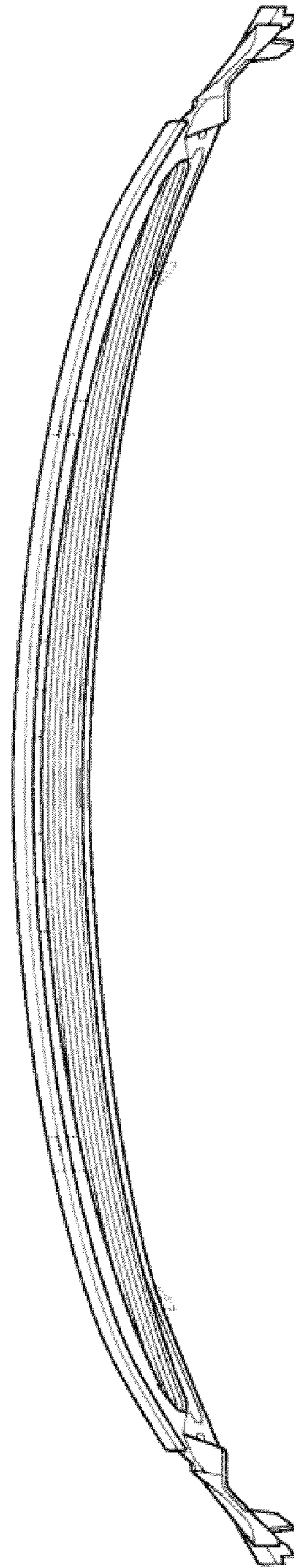
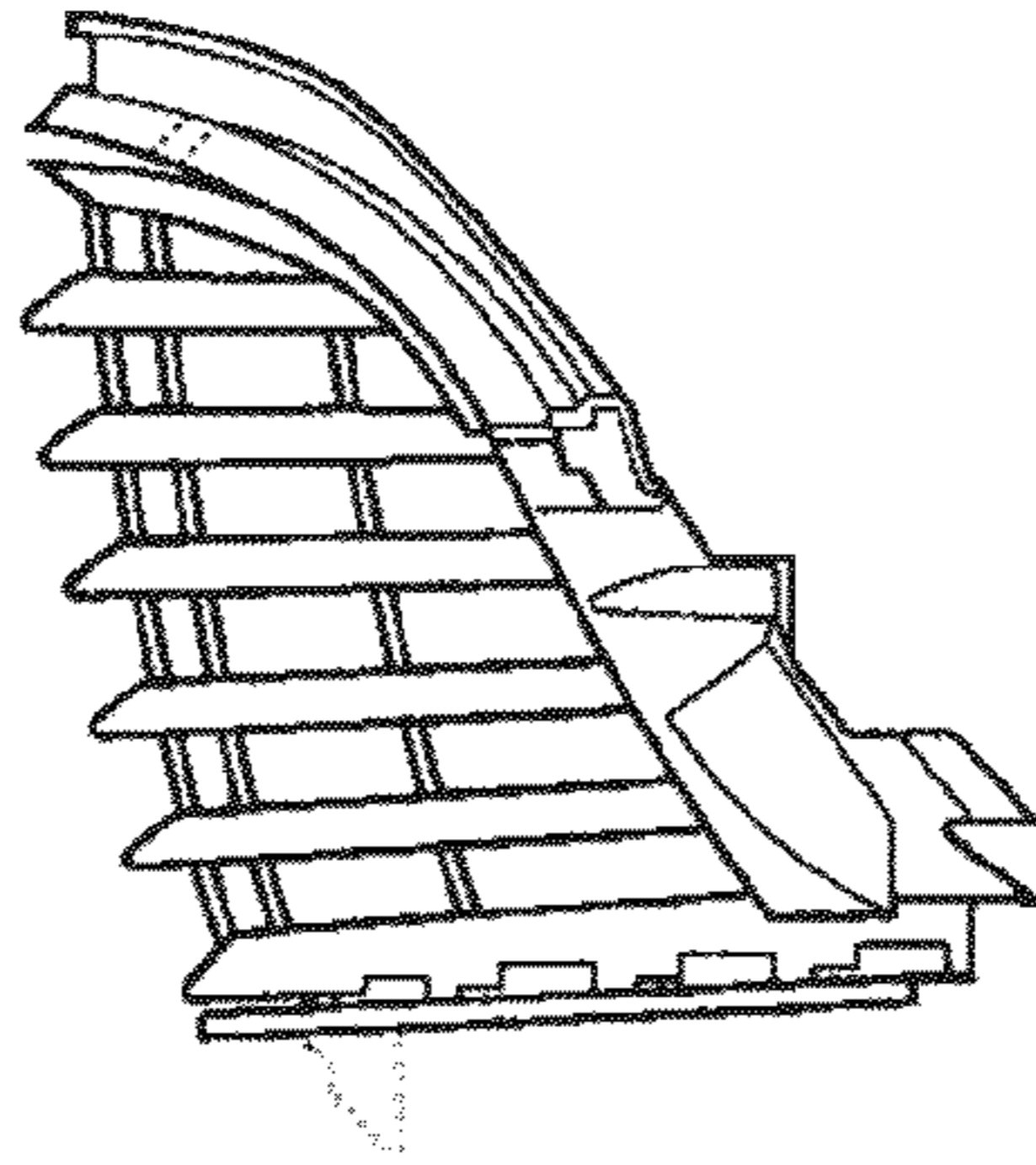
